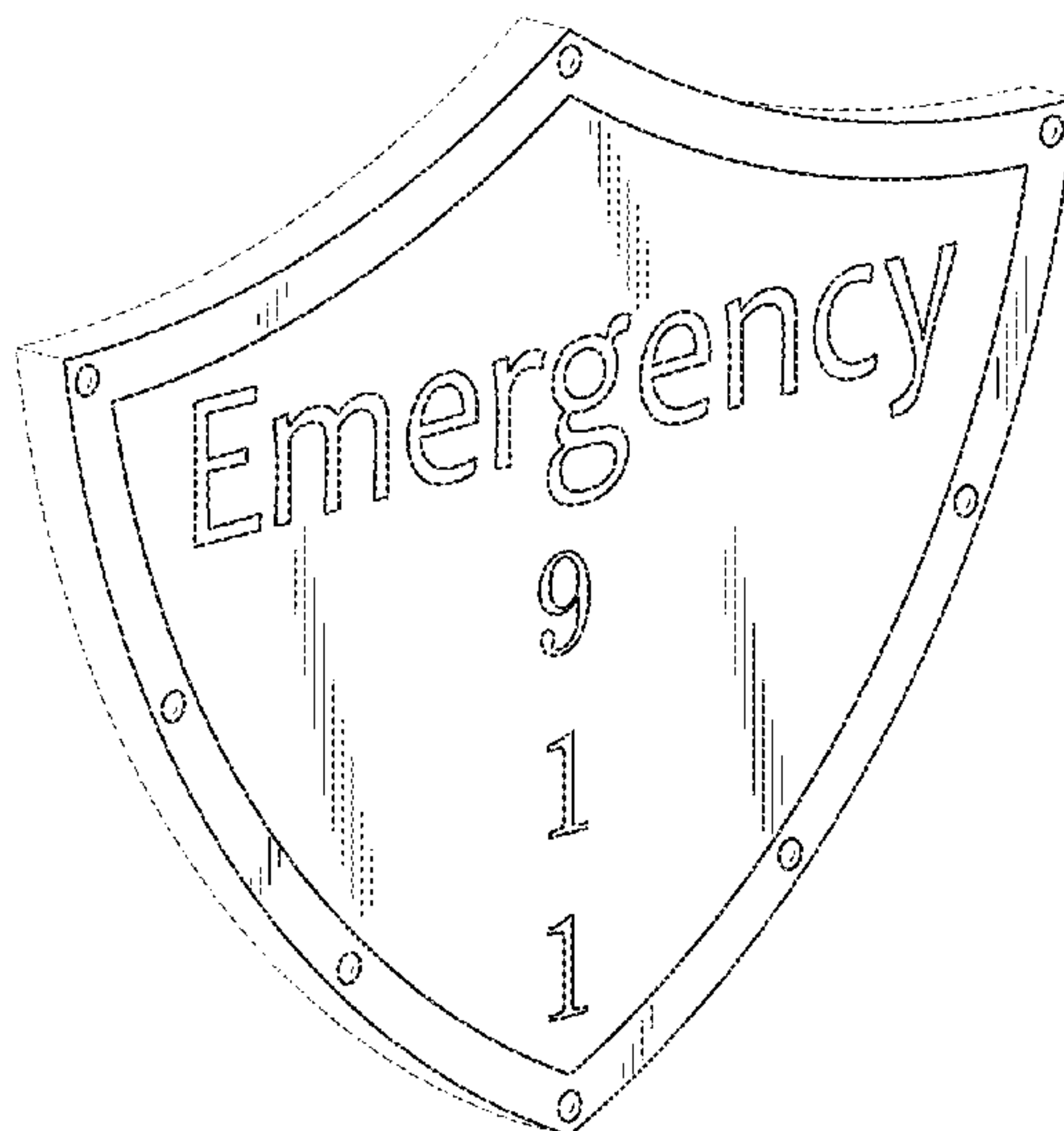
CLAIM

The ornamental design for an emergency notification sign, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an emergency notification sign showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof; and,
FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image thereof.
The broken lines shown in the drawings illustrate portions of the emergency notification sign that form no part of the claimed design.

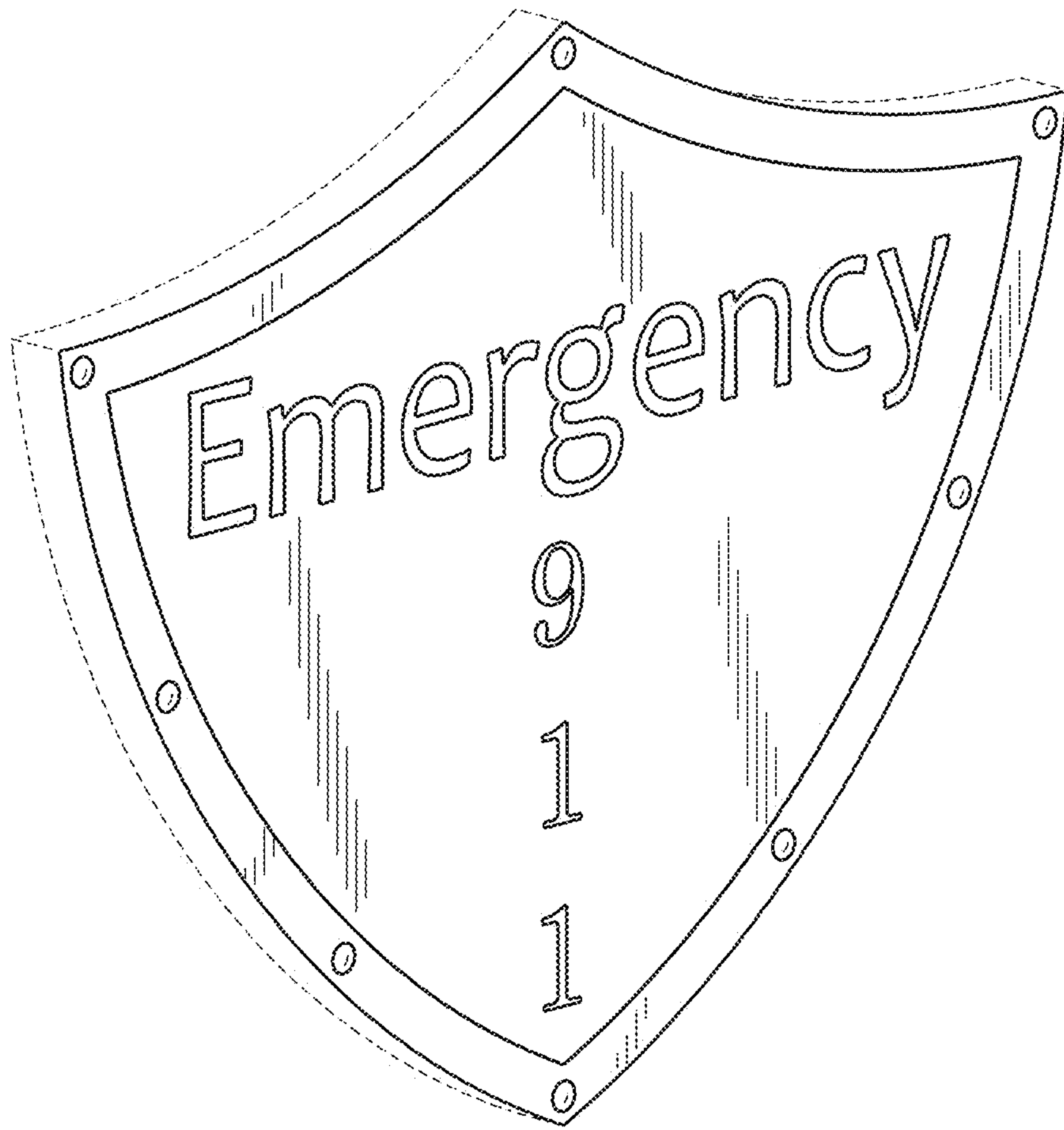

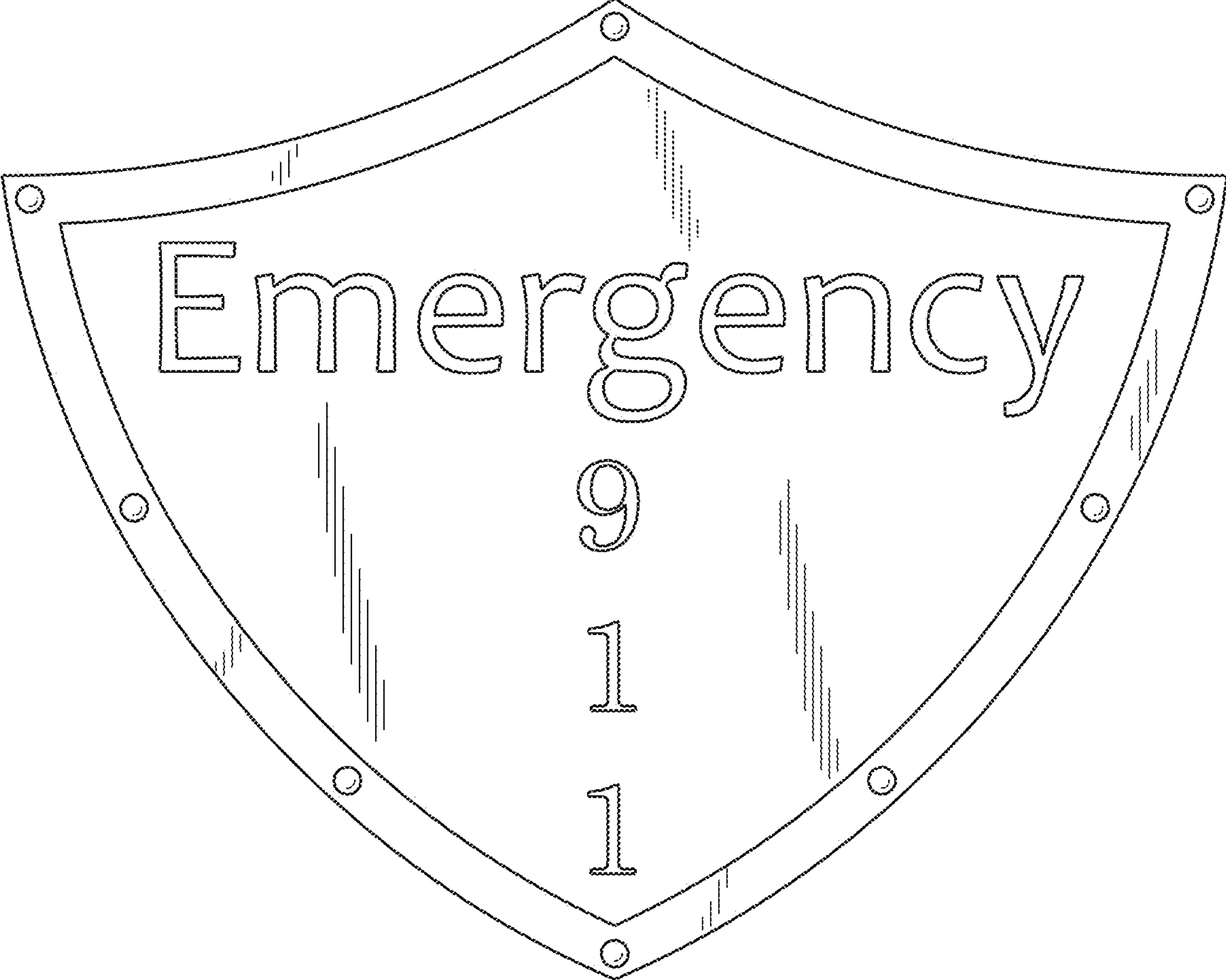

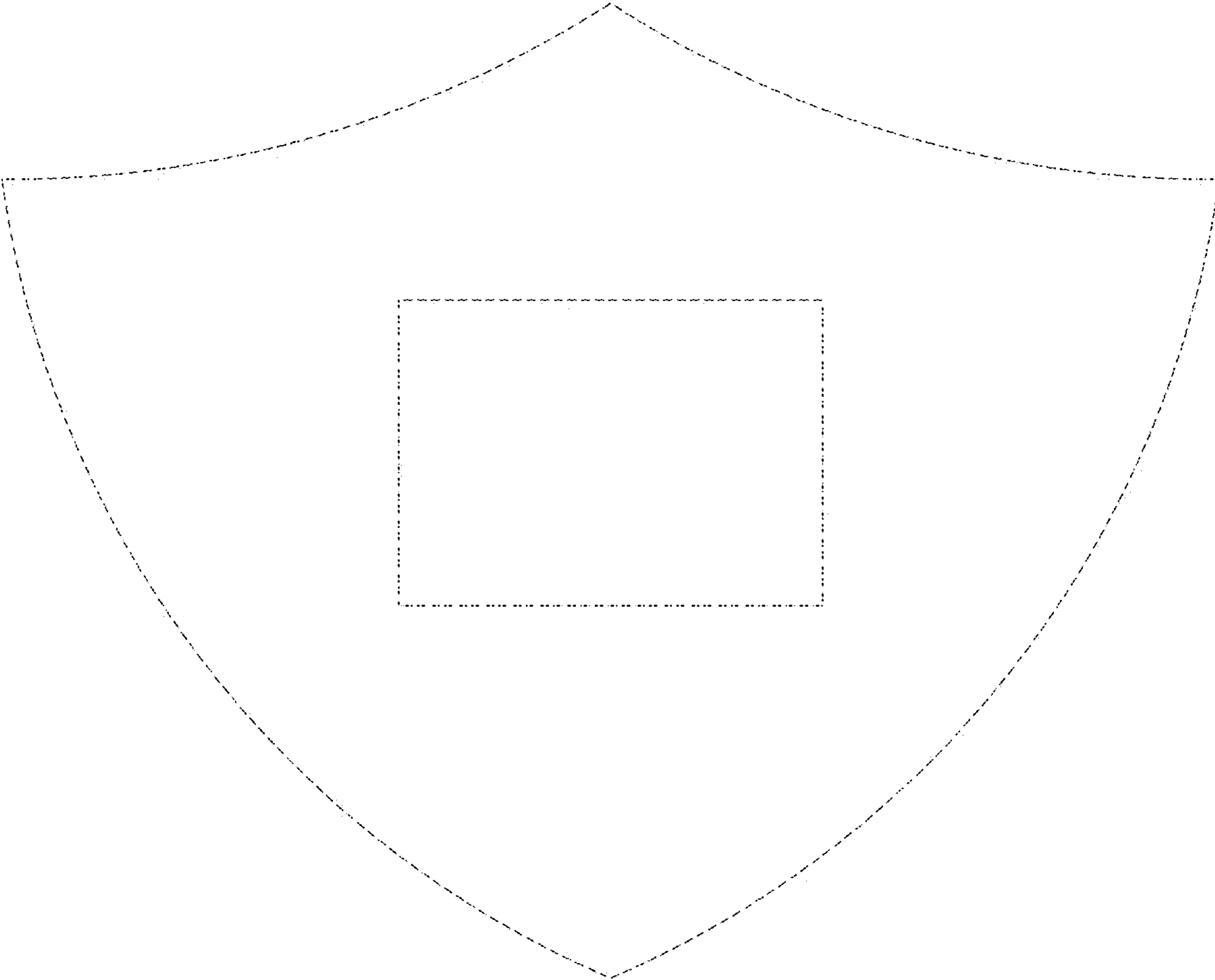

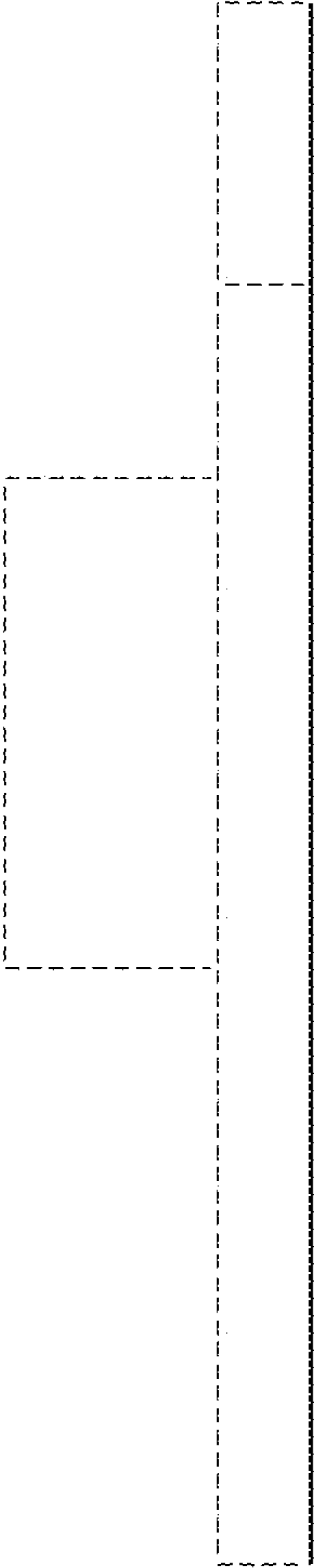

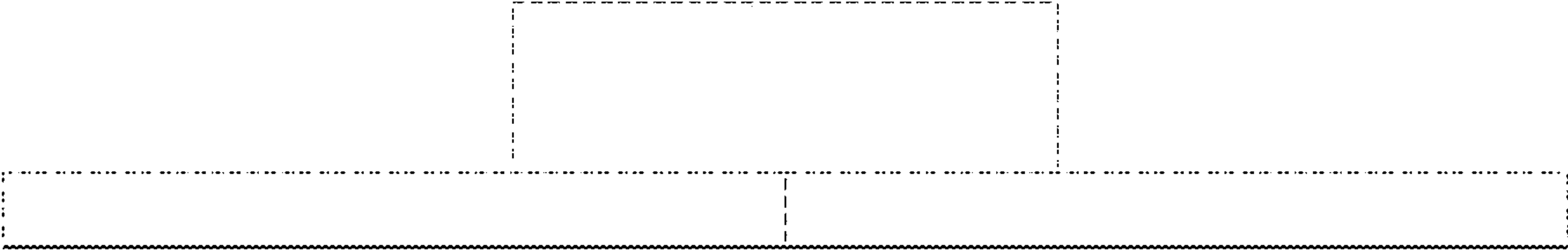
