thereof.

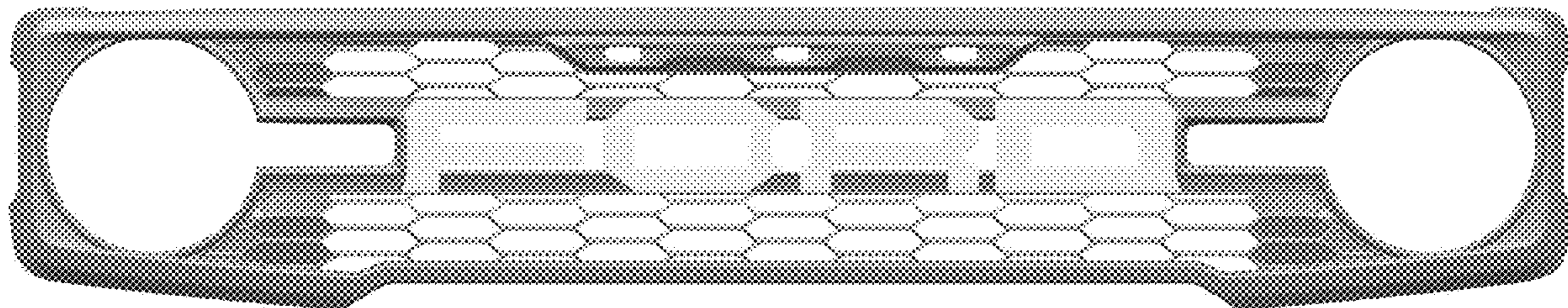
The claimed design is indicated by the relatively dark

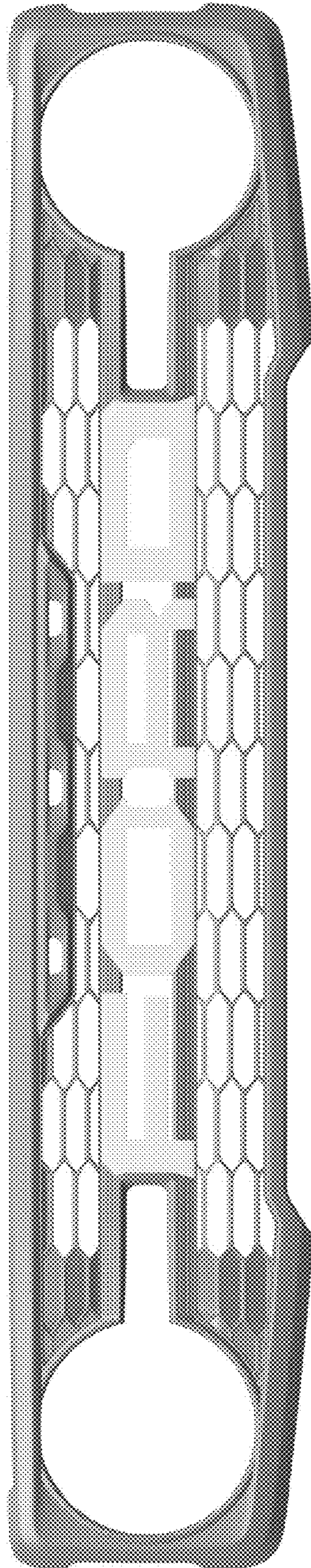

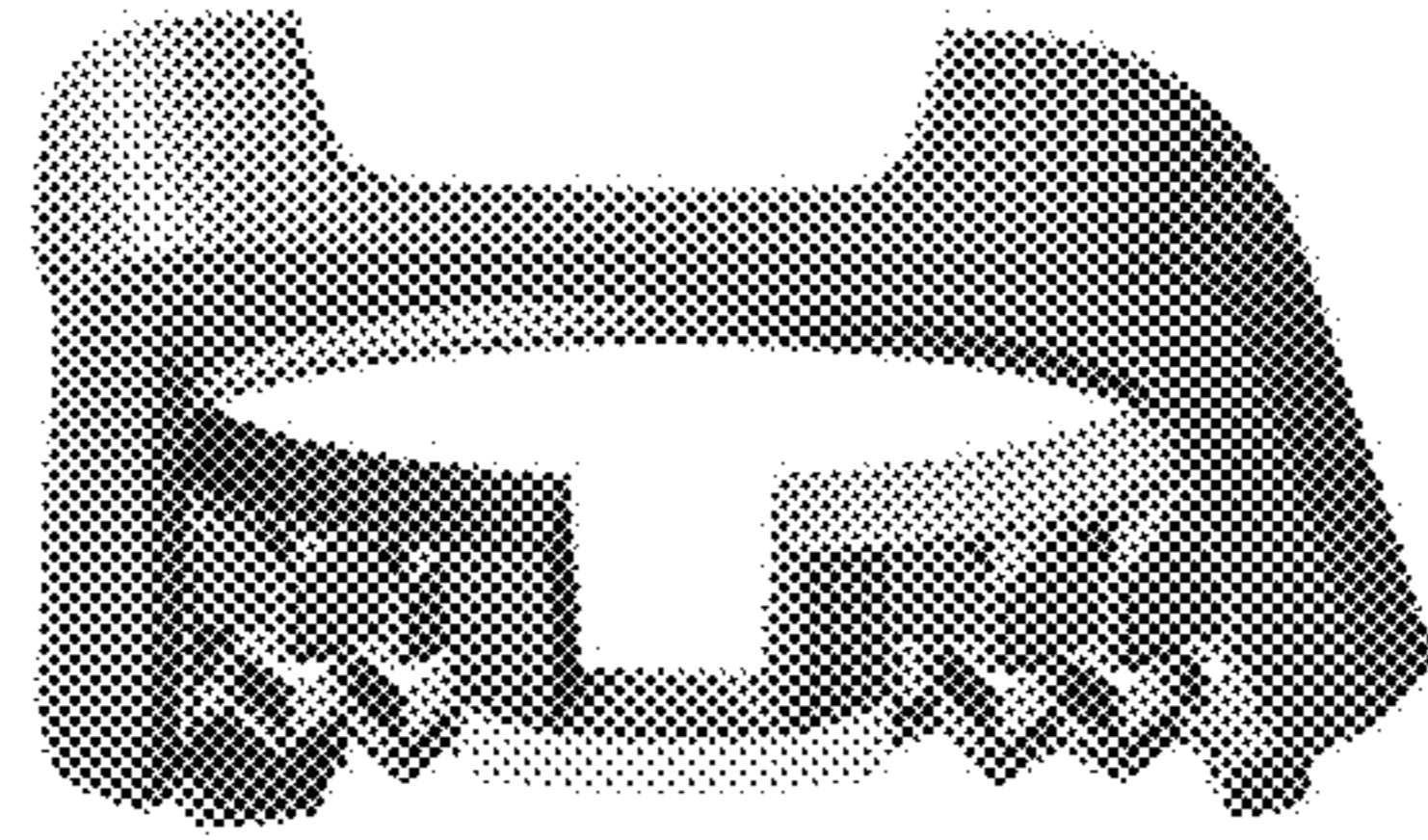

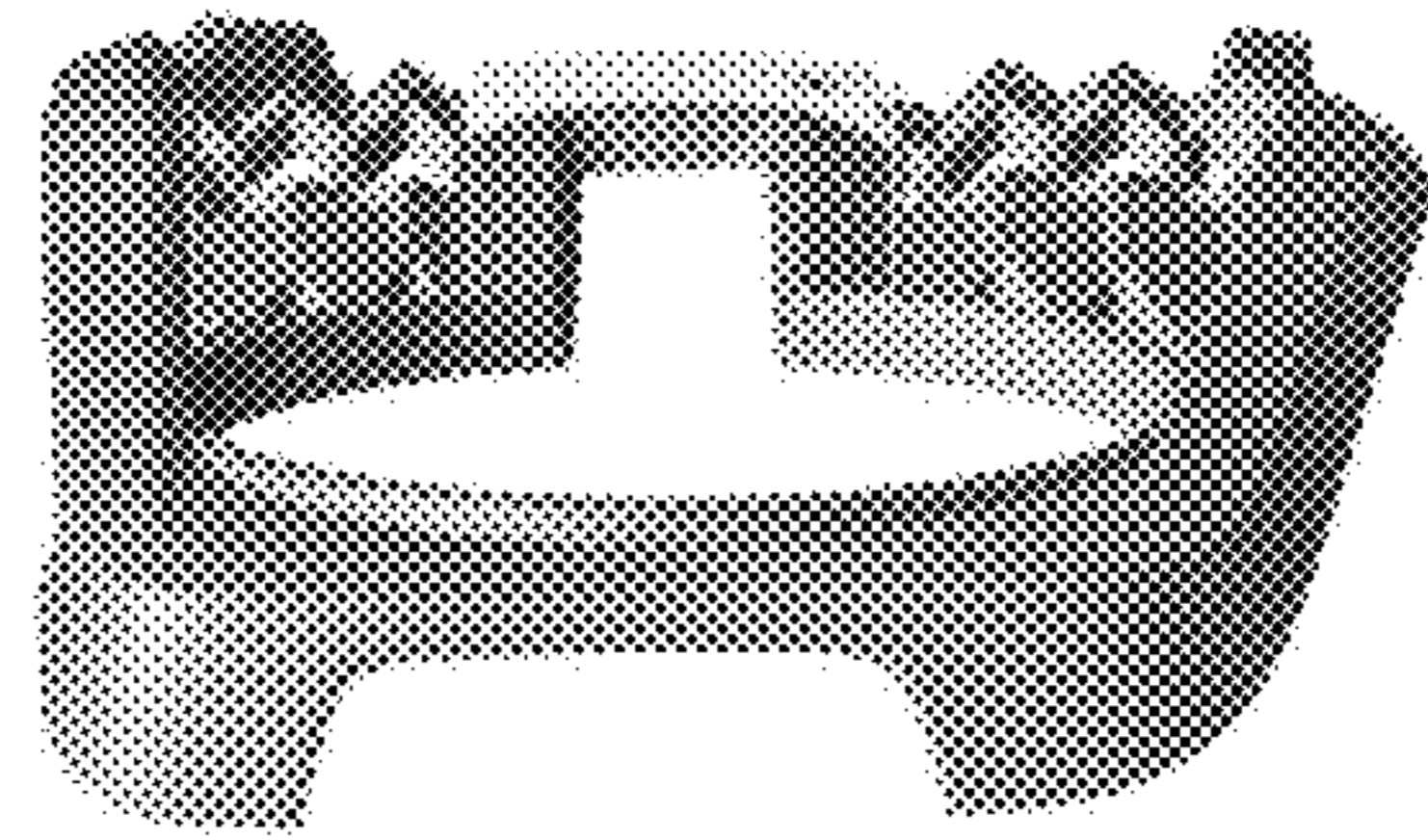

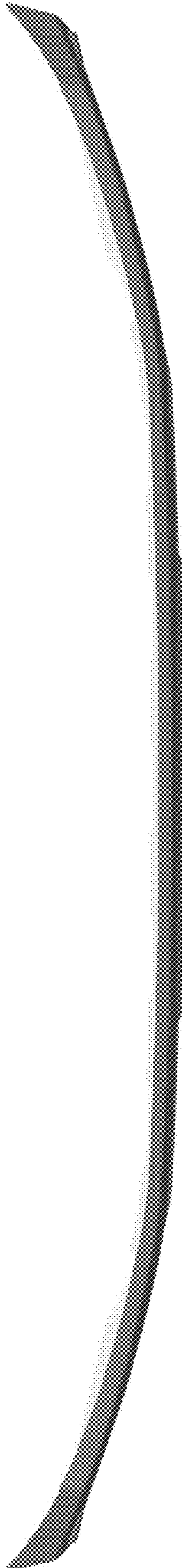

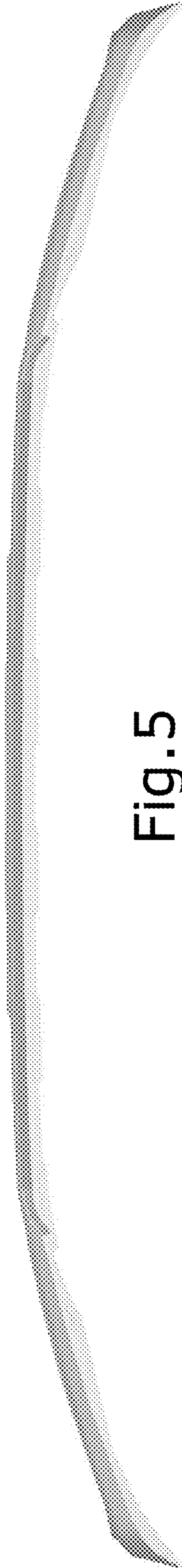

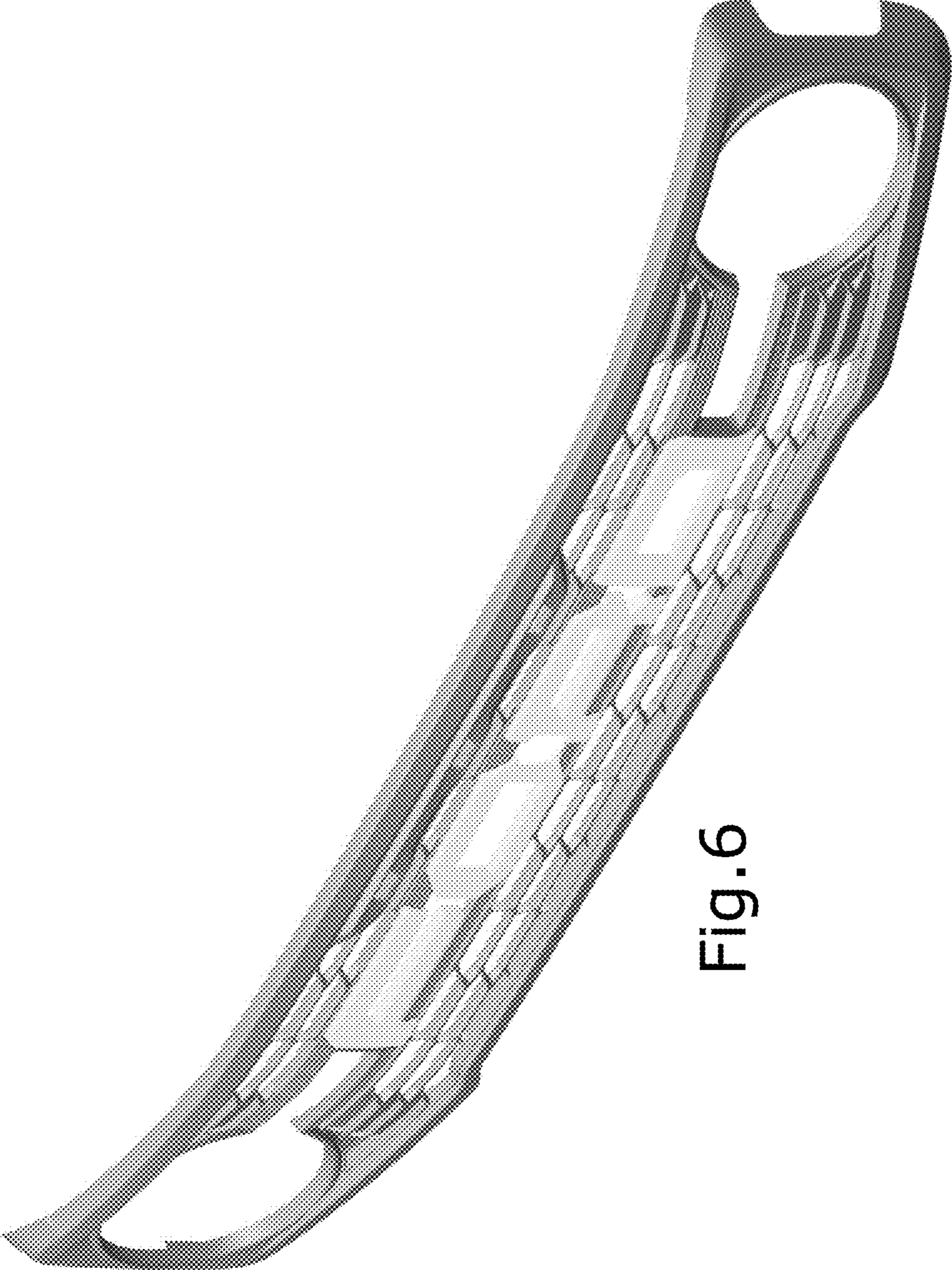

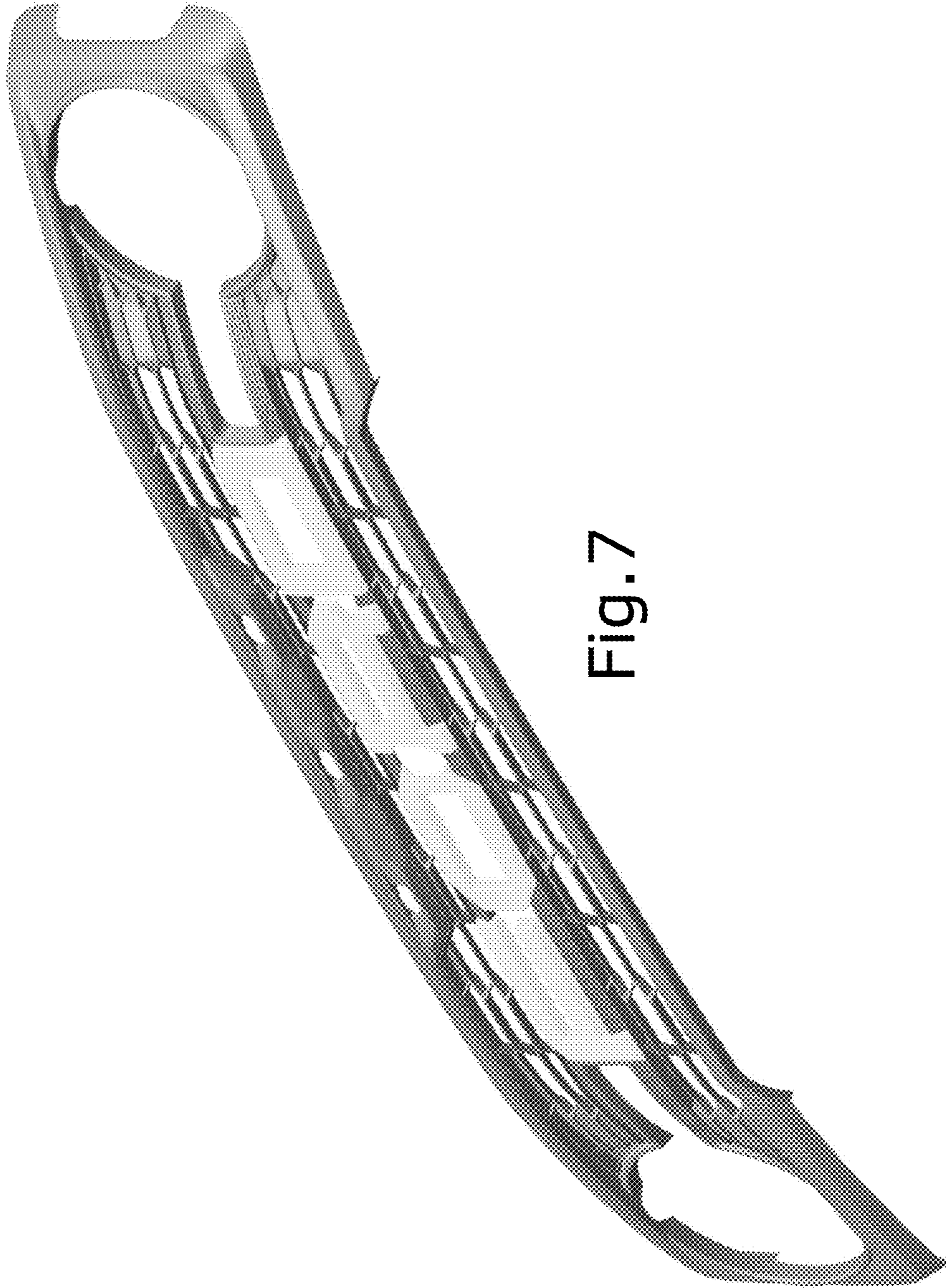
