DESCRIPTION

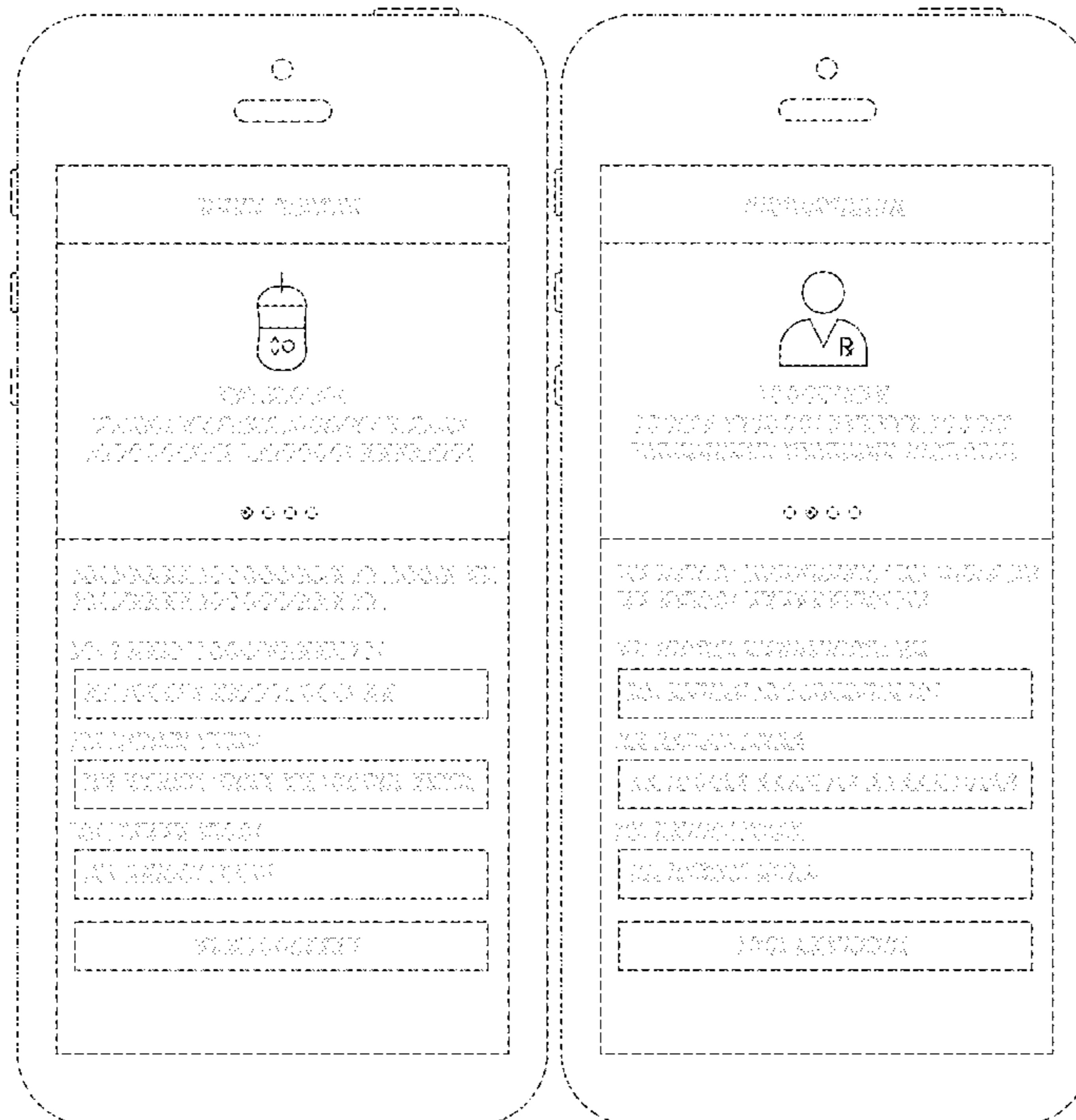
FIG. 1 illustrates a first image in a sequence for a display screen with transitional icons;
 FIG. 2 illustrates a second image in the sequence for the display screen with transitional icons;
 FIG. 3 illustrates a third image in the sequence for the display screen with transitional icons; and,
 FIG. 4 illustrates a fourth image in the sequence for the display screen with transitional icons.
 The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 through 4. The process or period forms no part of the claimed design. The broken lines showing a mobile device having a display screen form no part of the claimed design. The grayscale fill within the circles forms no part of the claimed design.

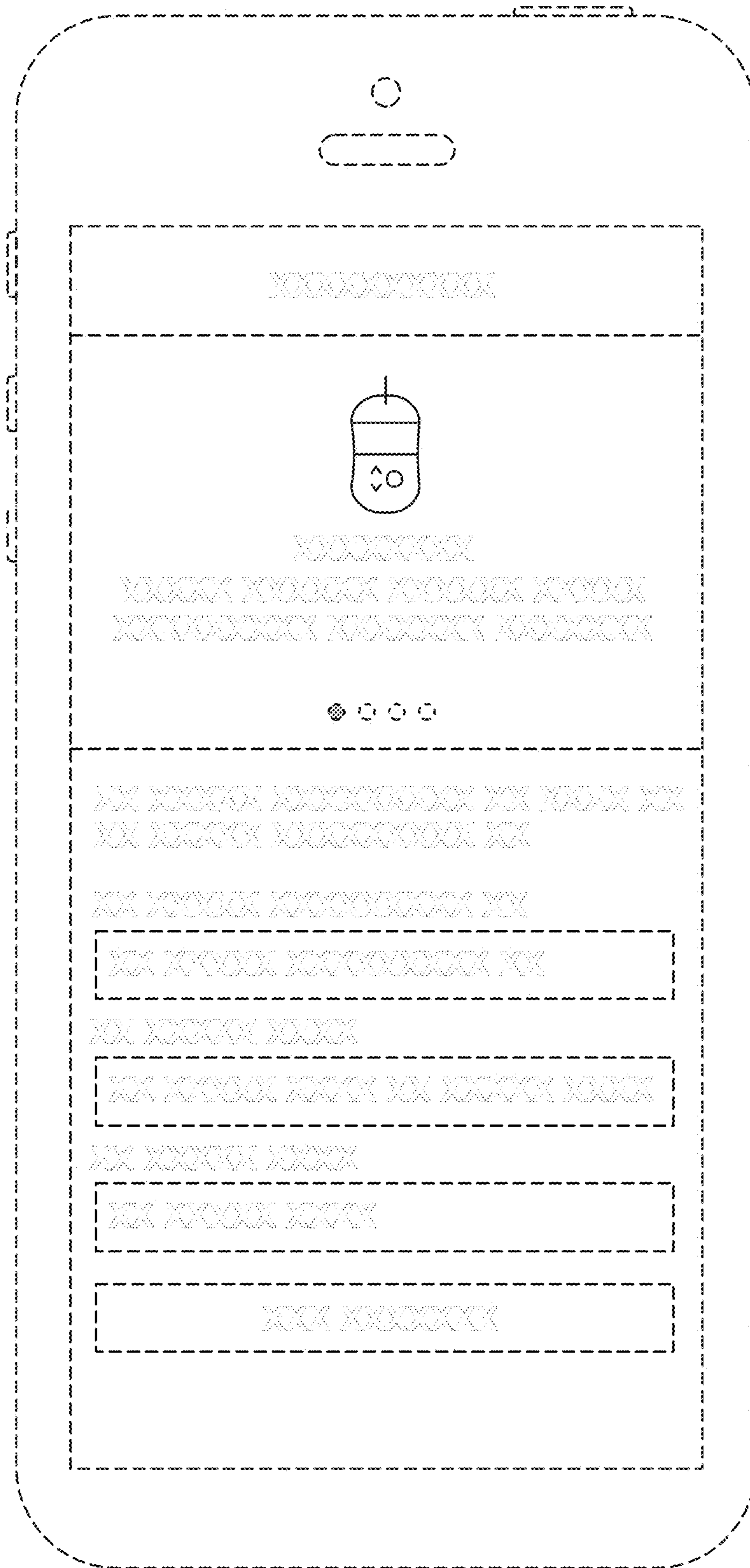

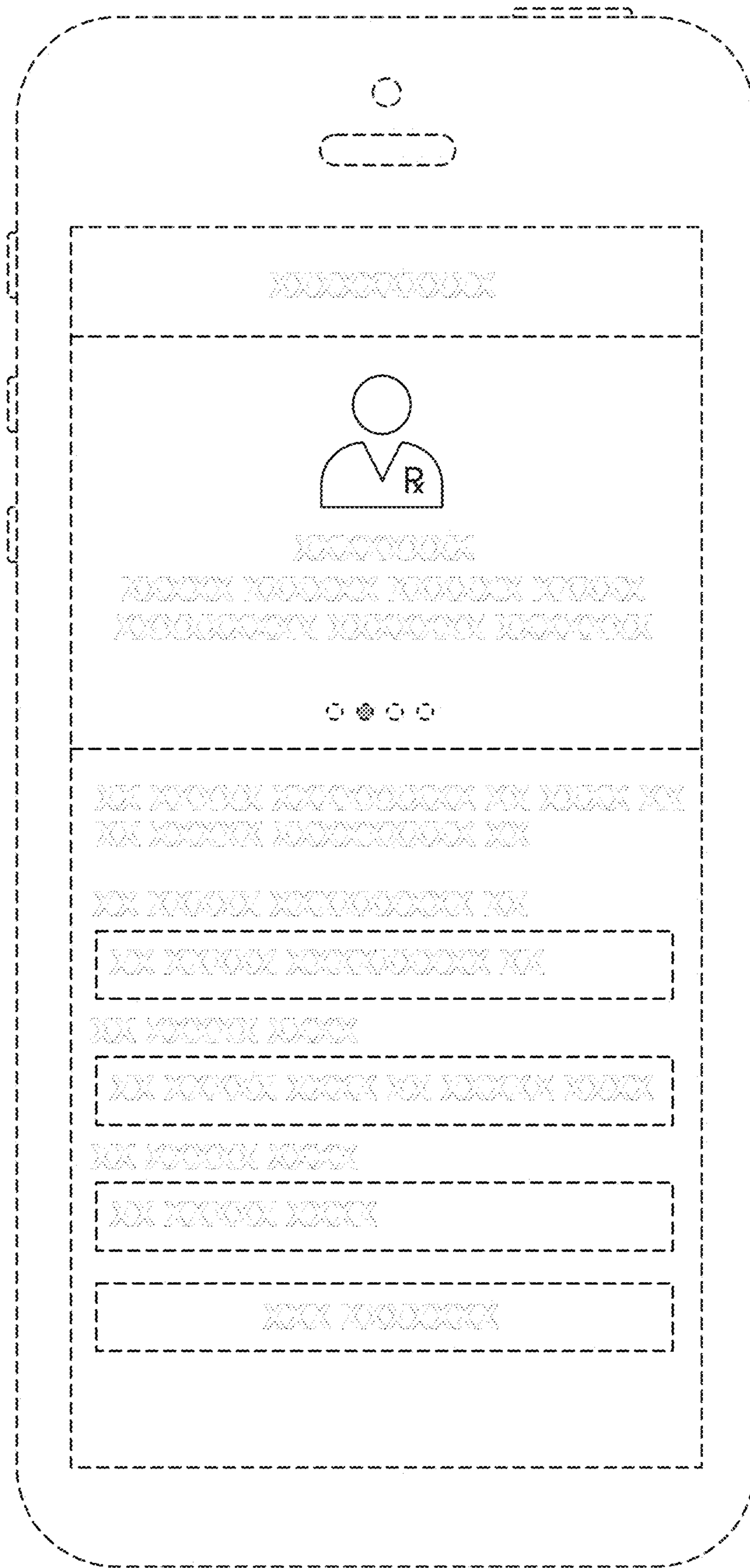

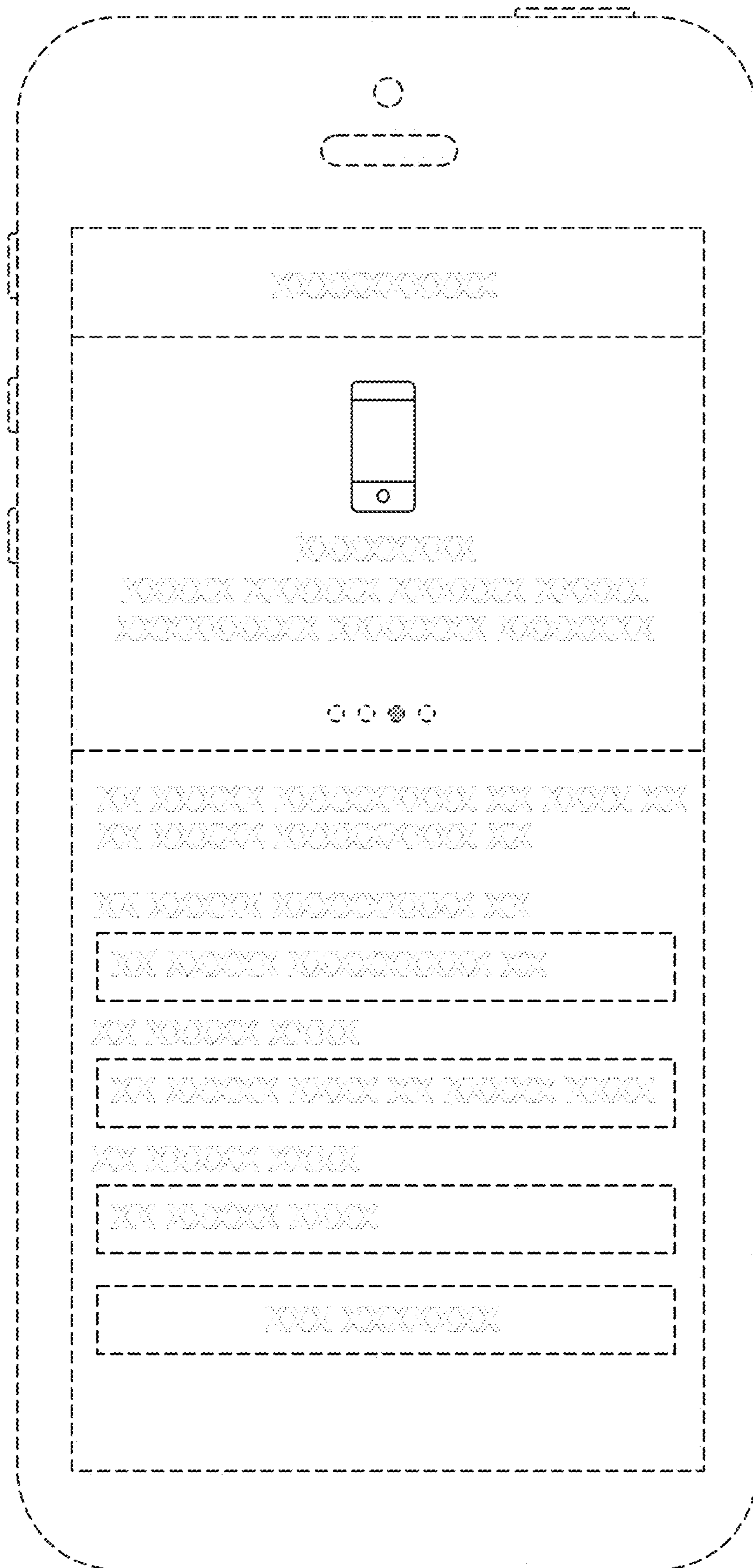

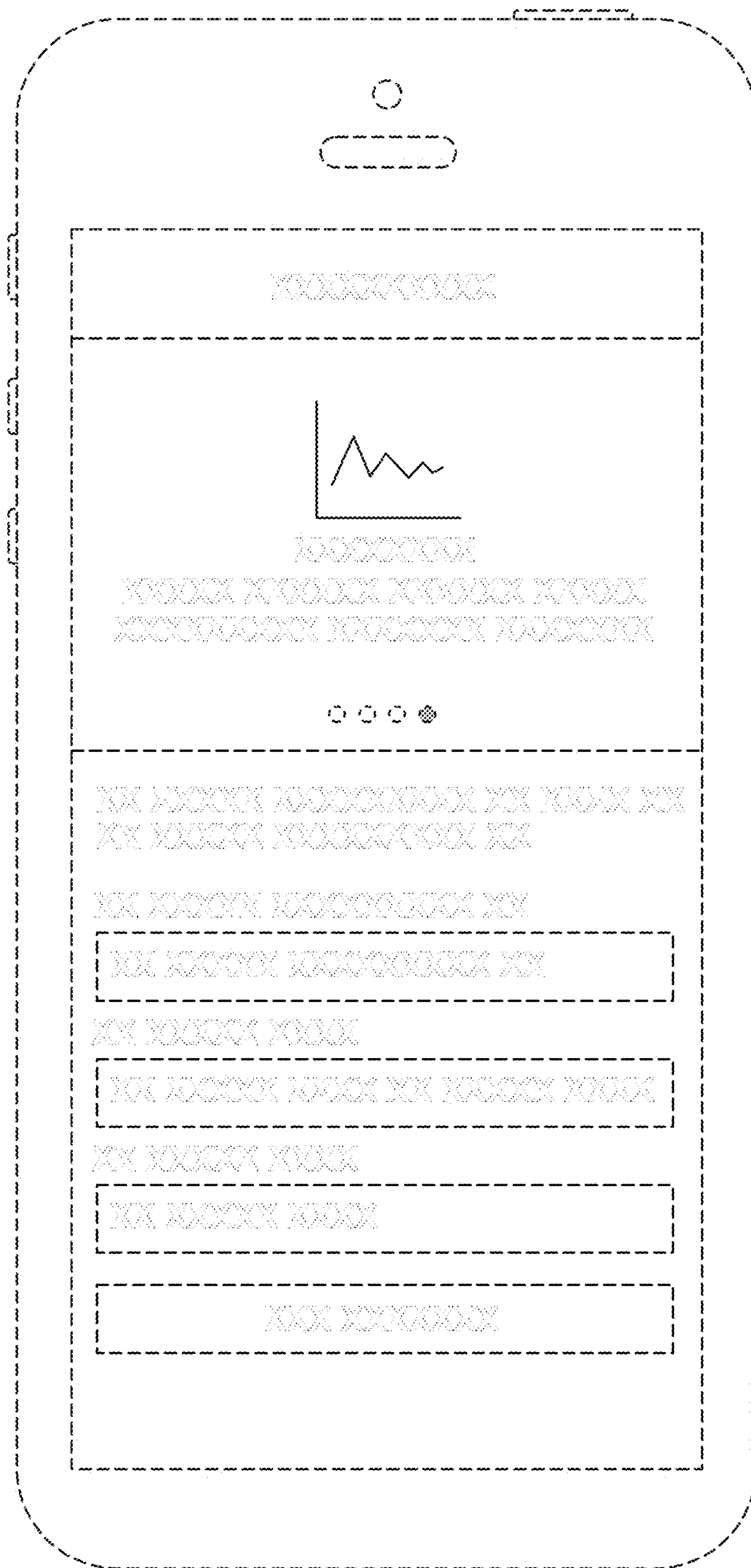
