**DESCRIPTION**

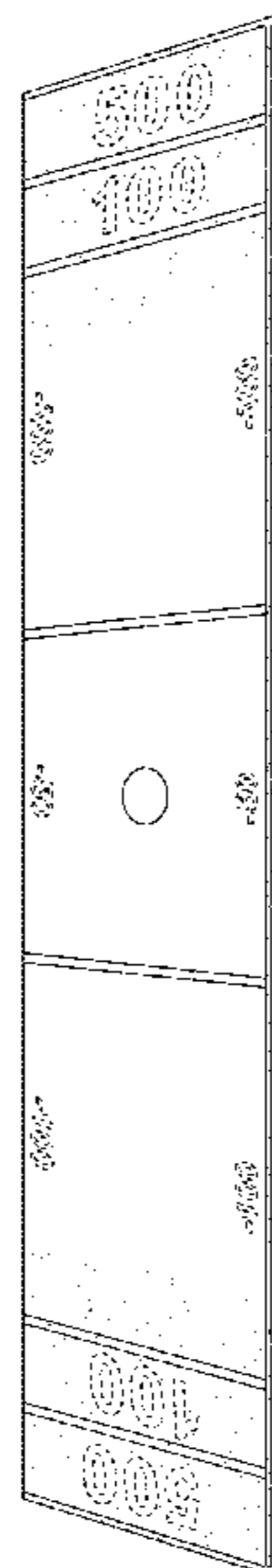
FIG. 1 is a perspective view of the putting game mat showing my new design;

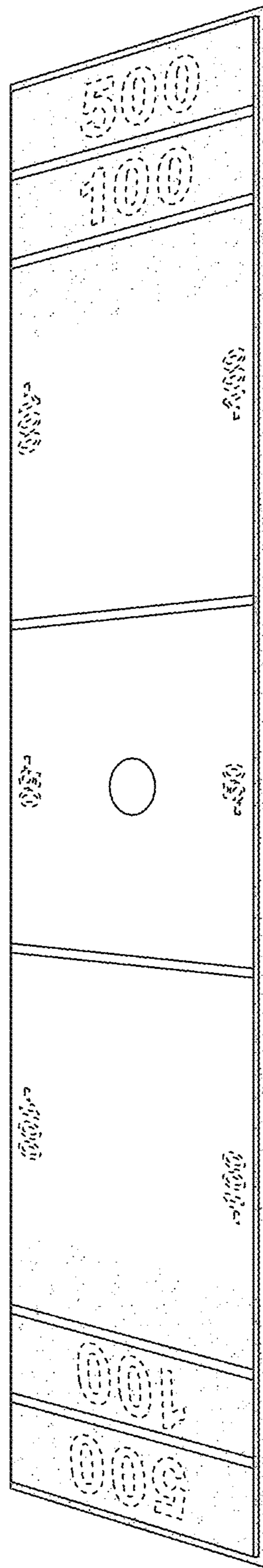

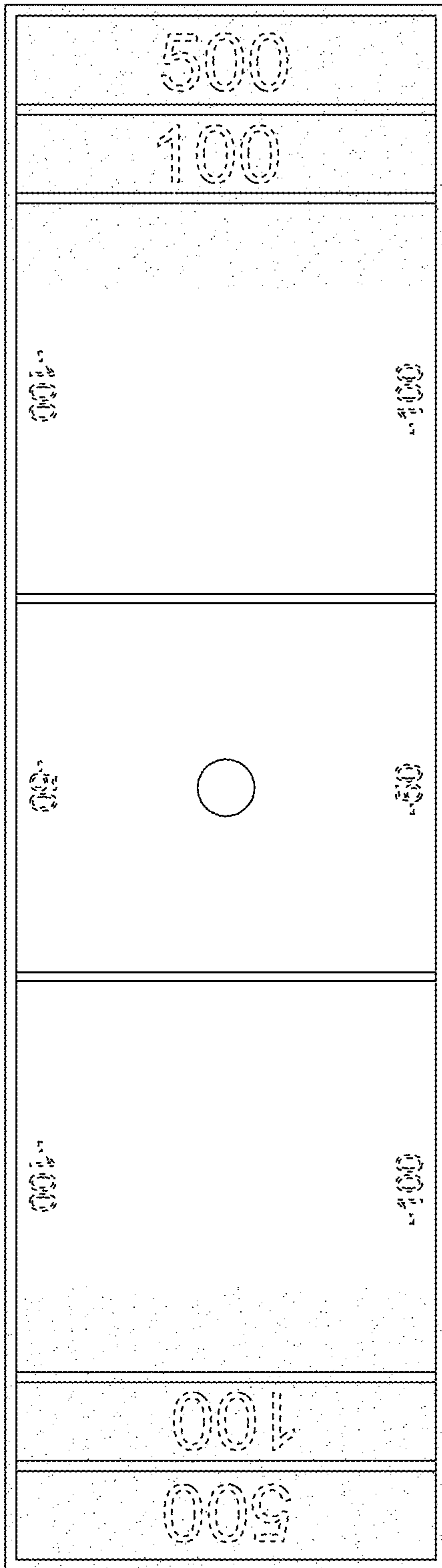

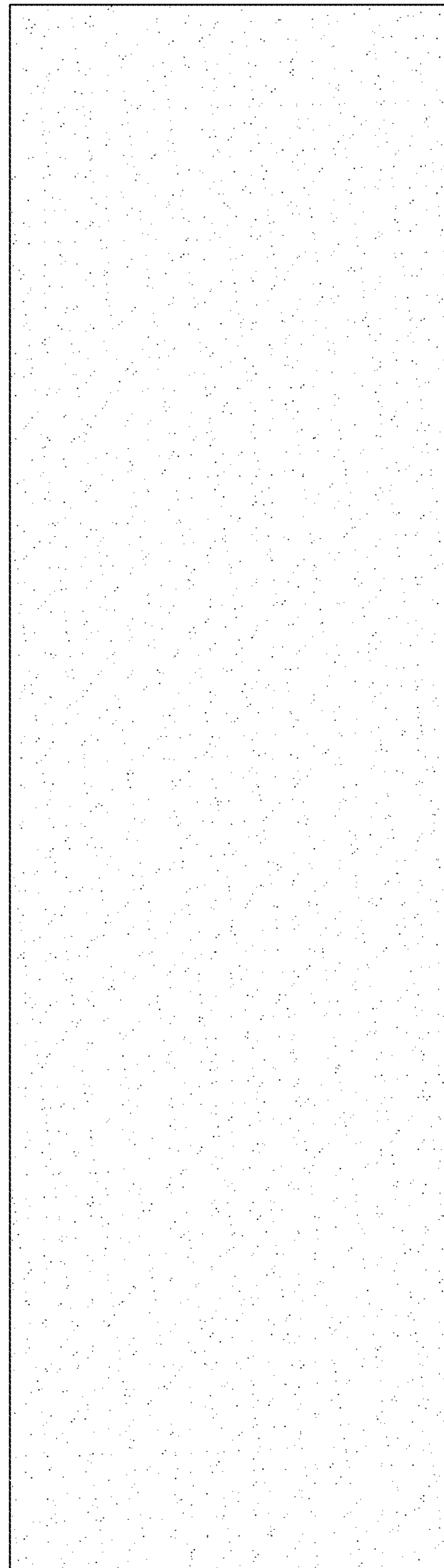

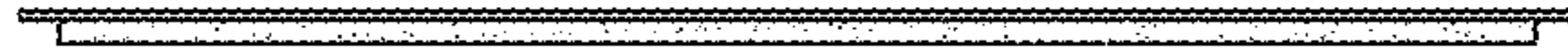

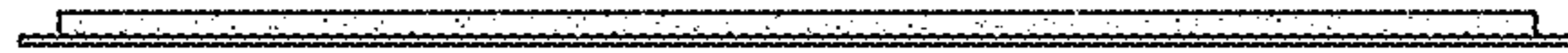
