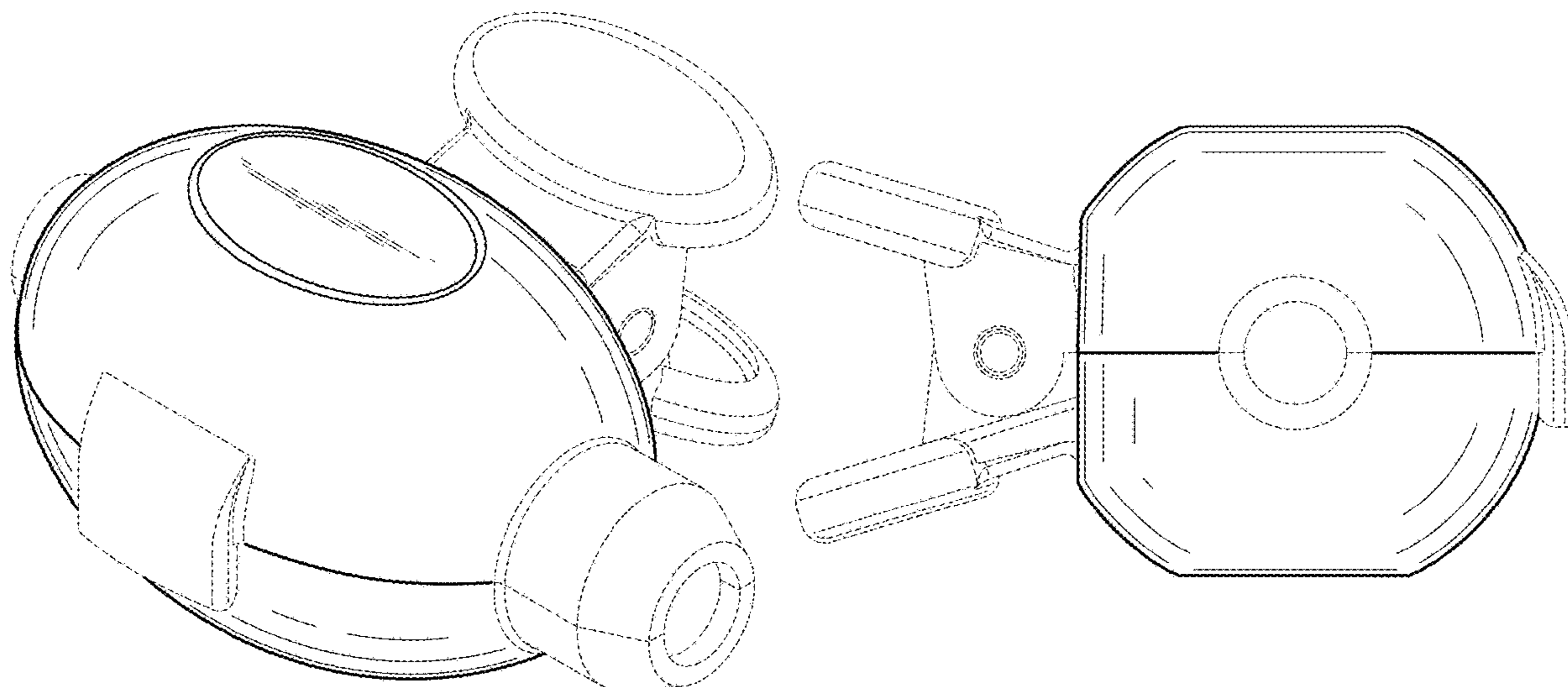
The ornamental design for a fluid line connection shell, as shown and described.

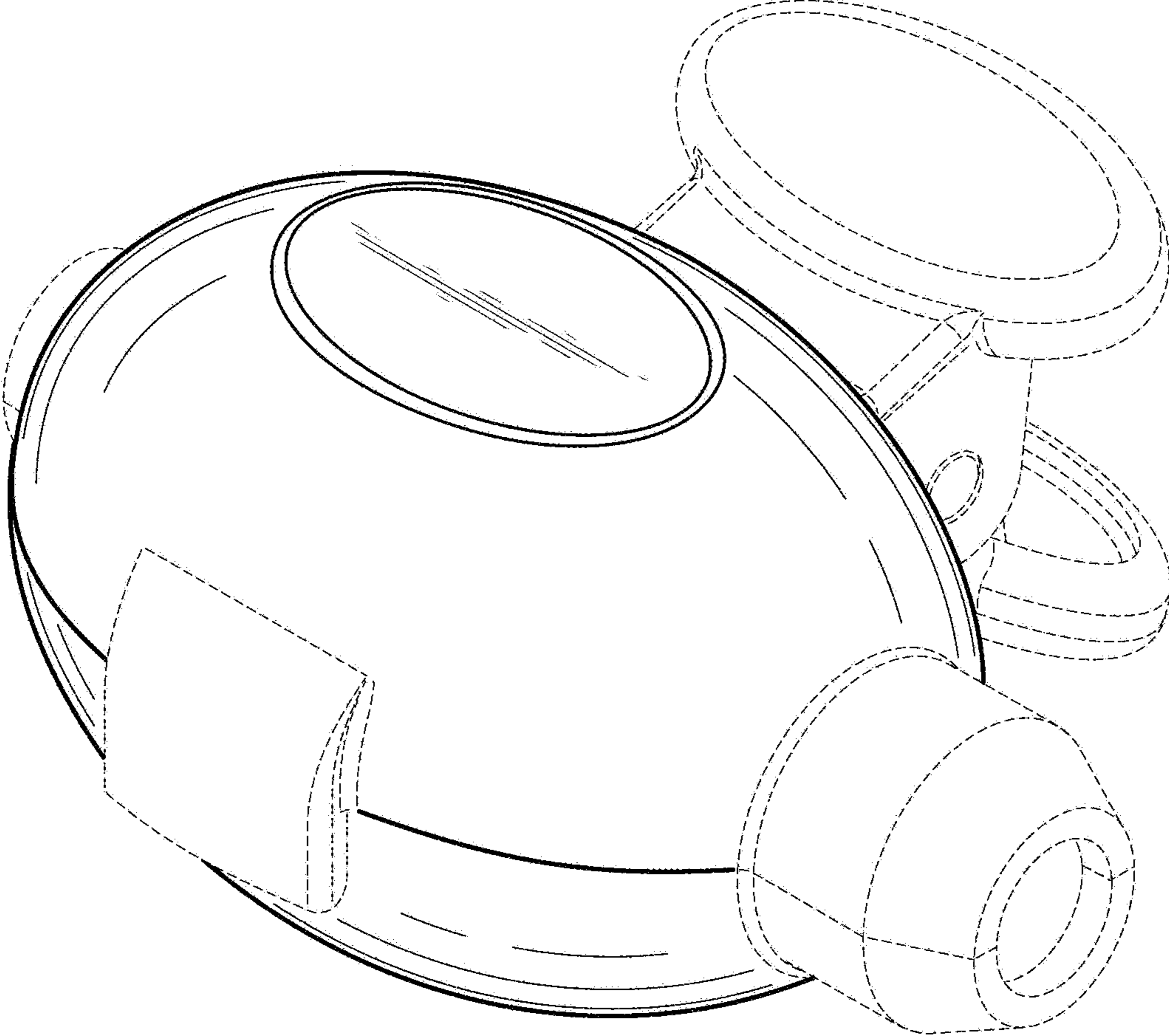
**DESCRIPTION**

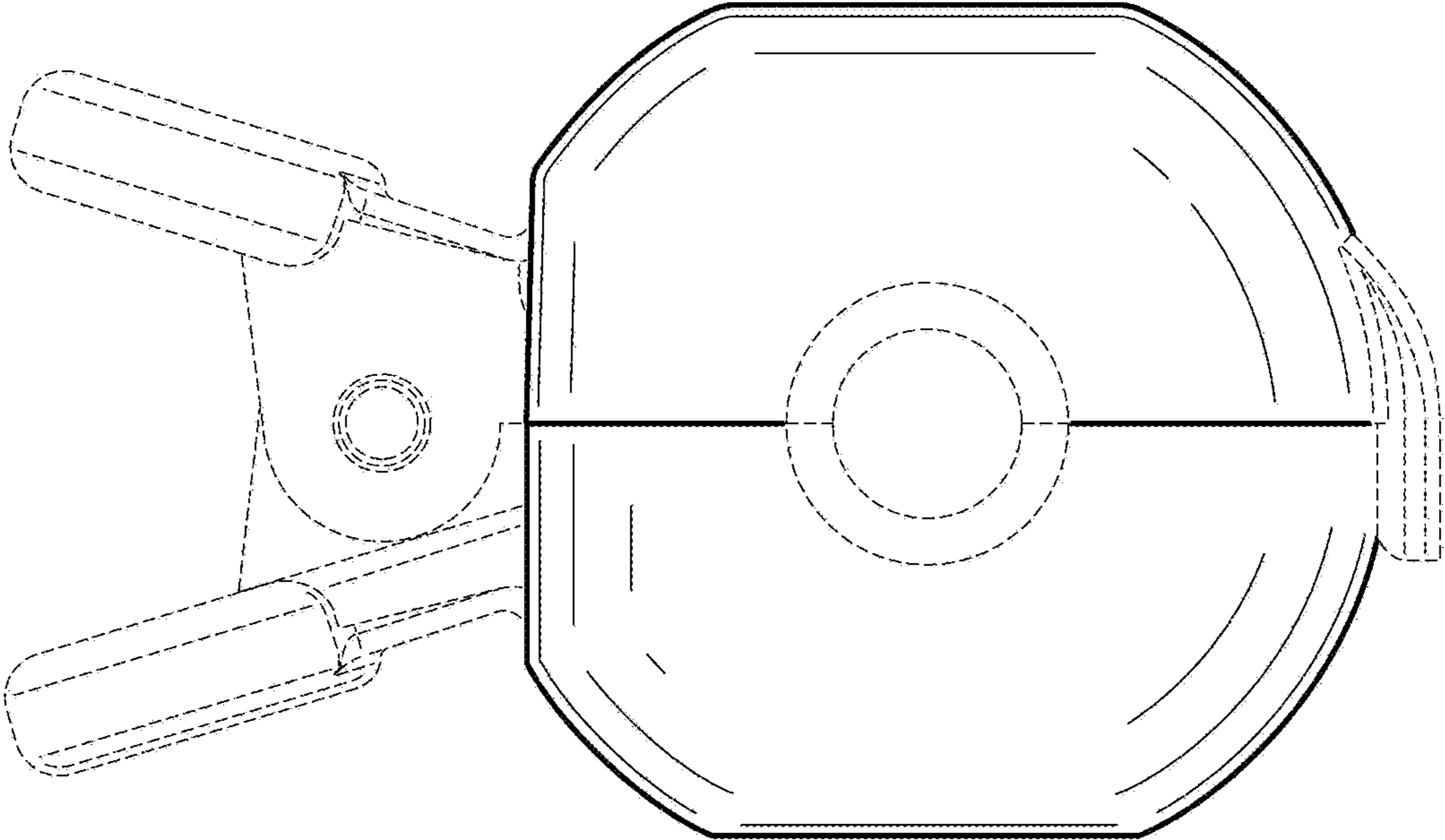
The broken lines shown represent portions of the fluid line connection shell and form no part of the claimed design.

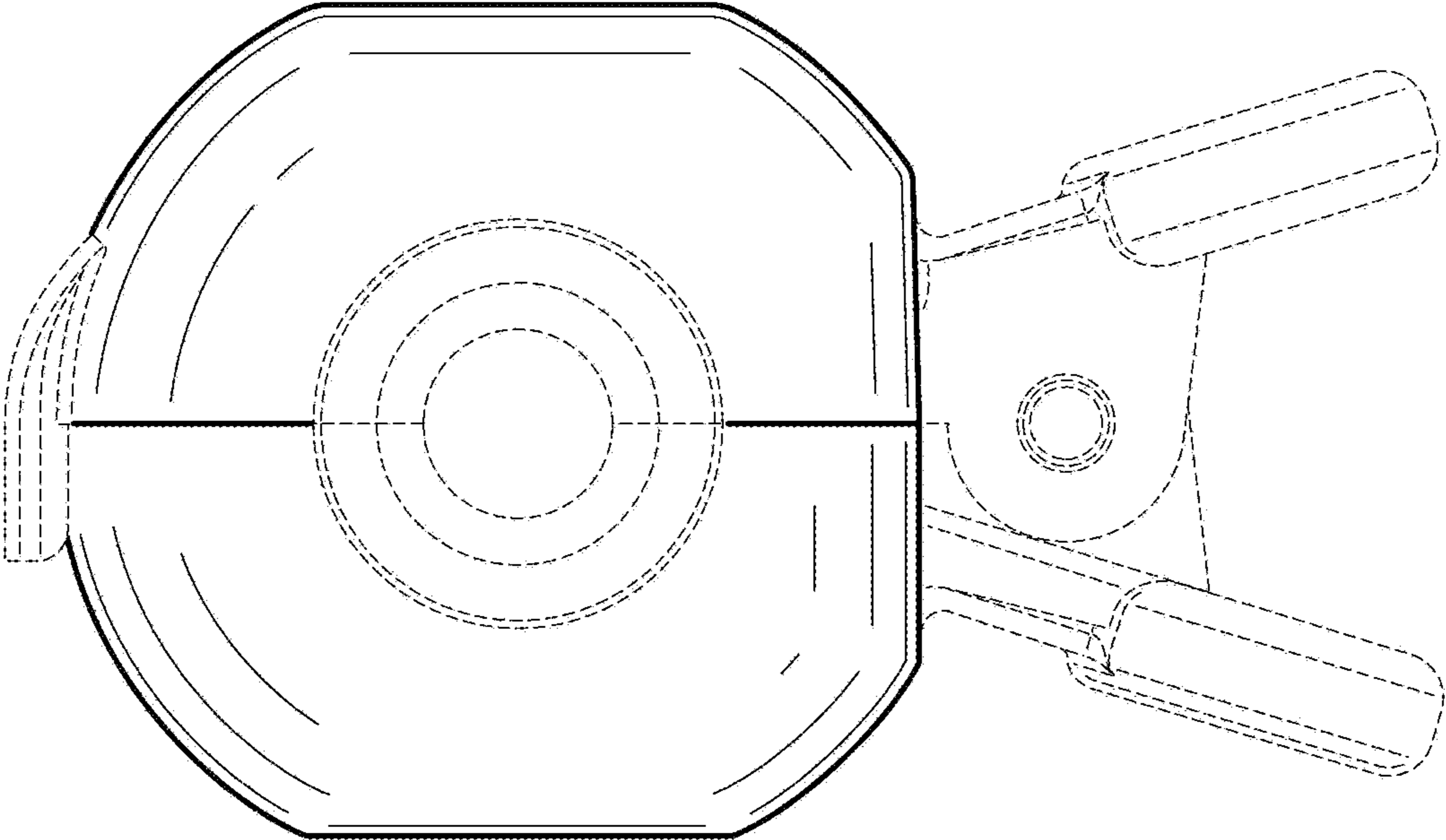

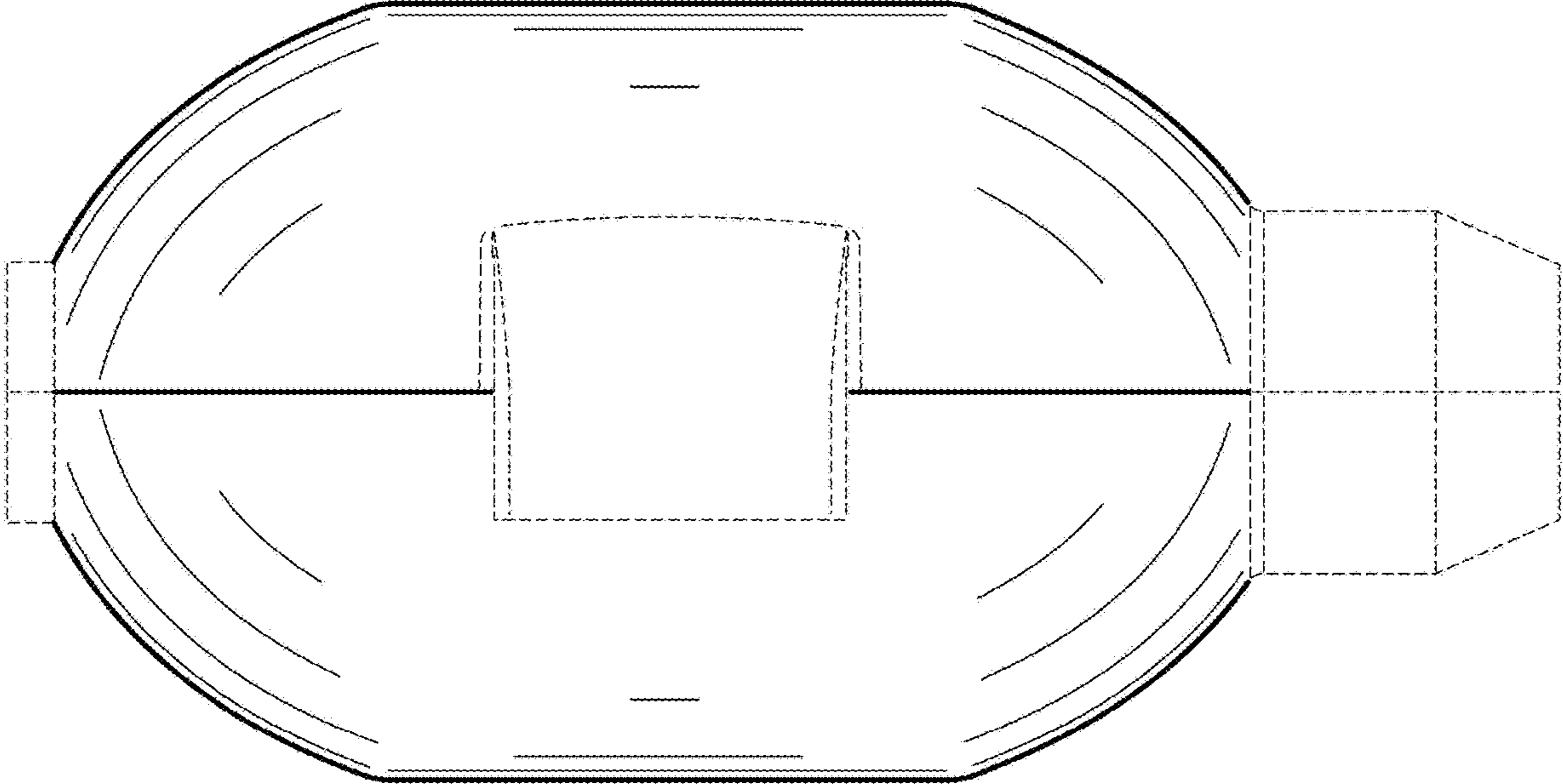

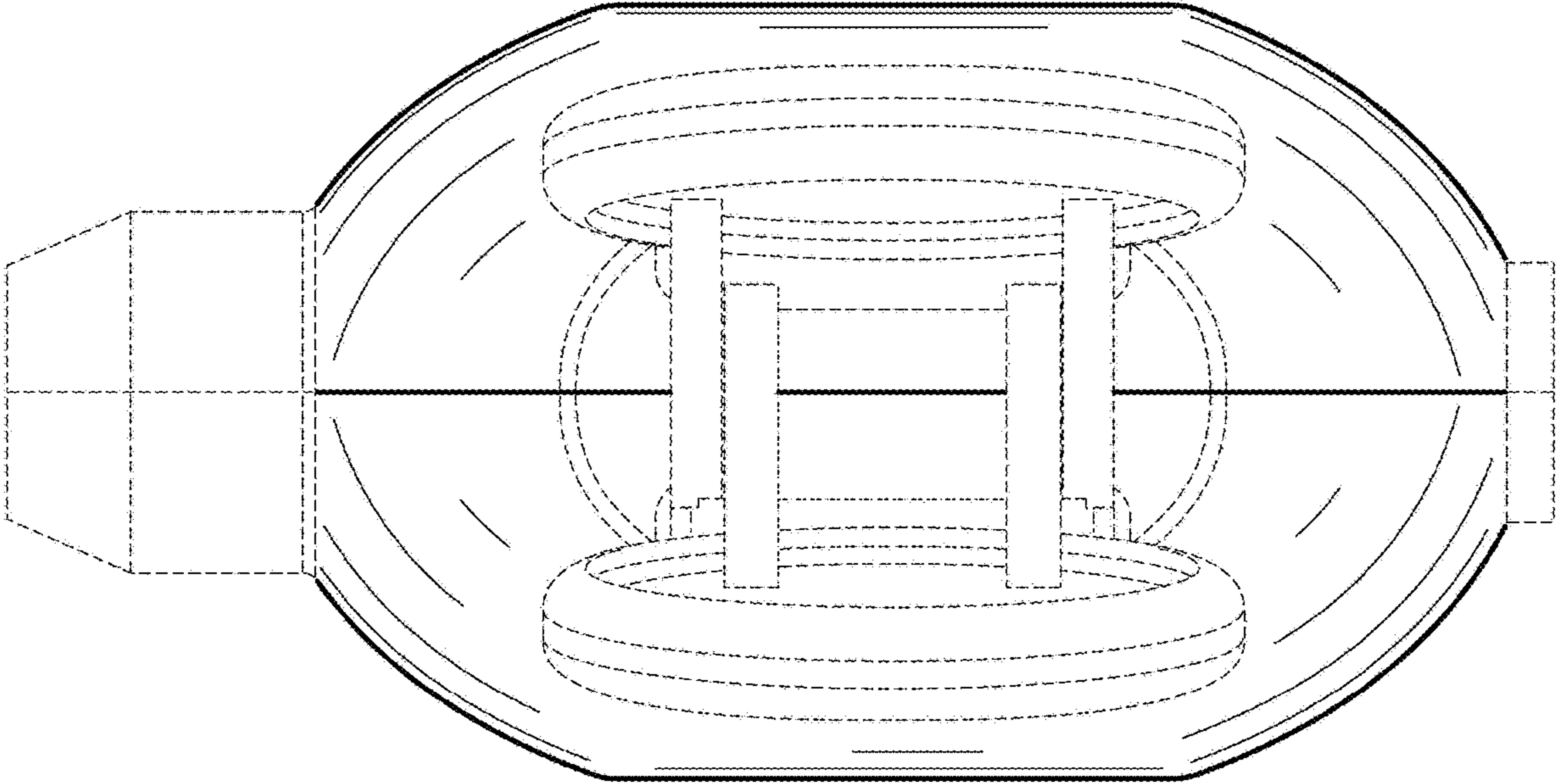
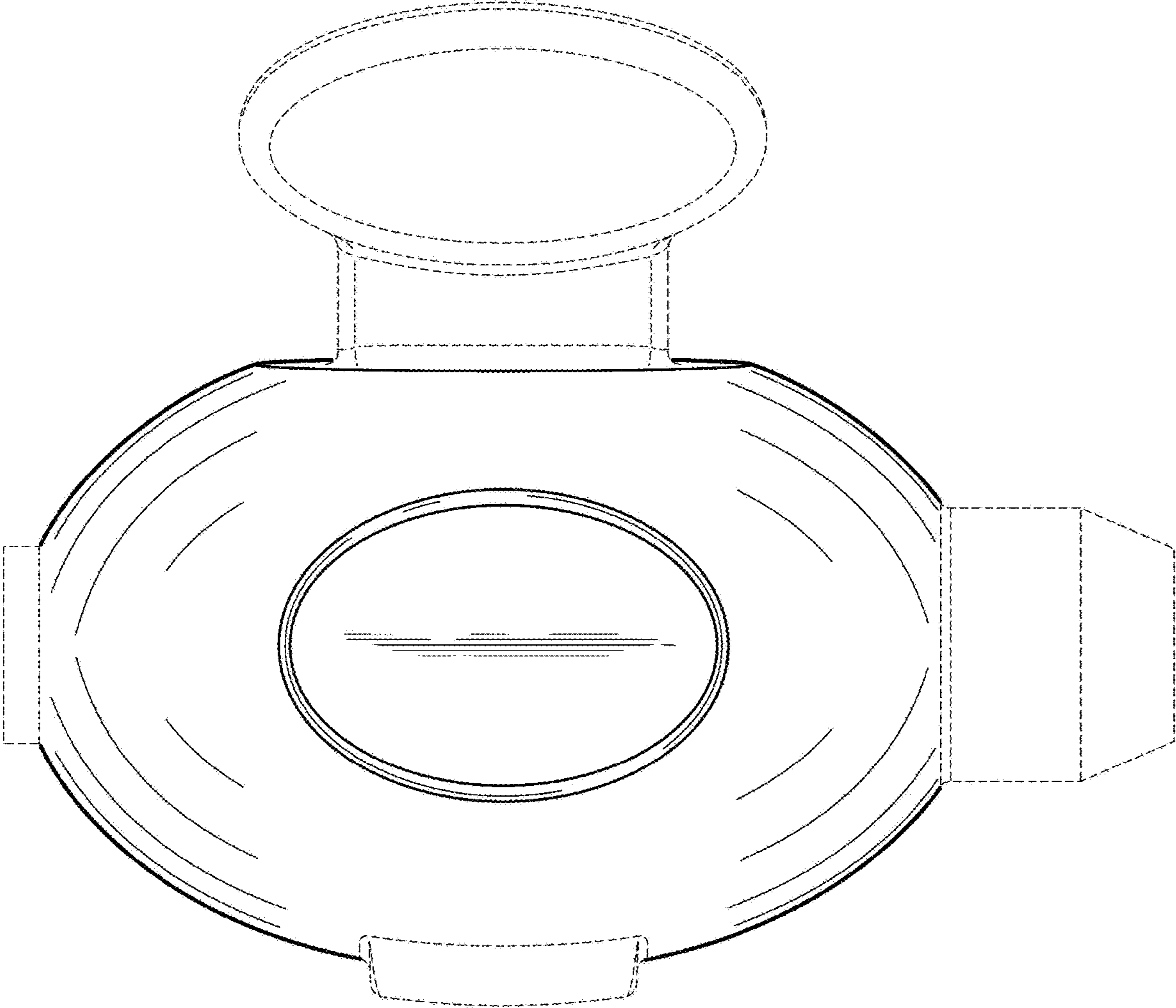
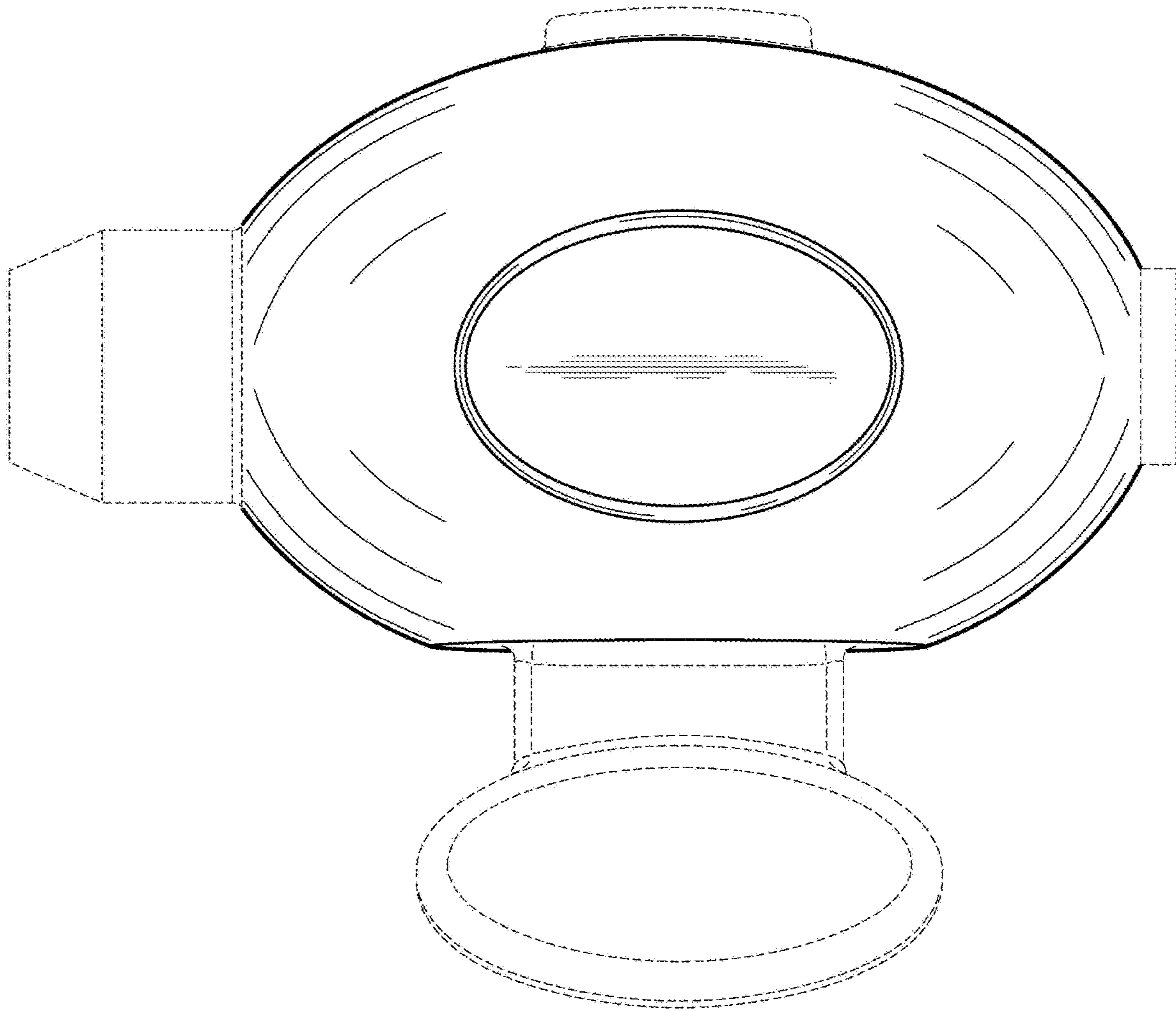
