The ornamental design for a lipstick case, as shown and described.

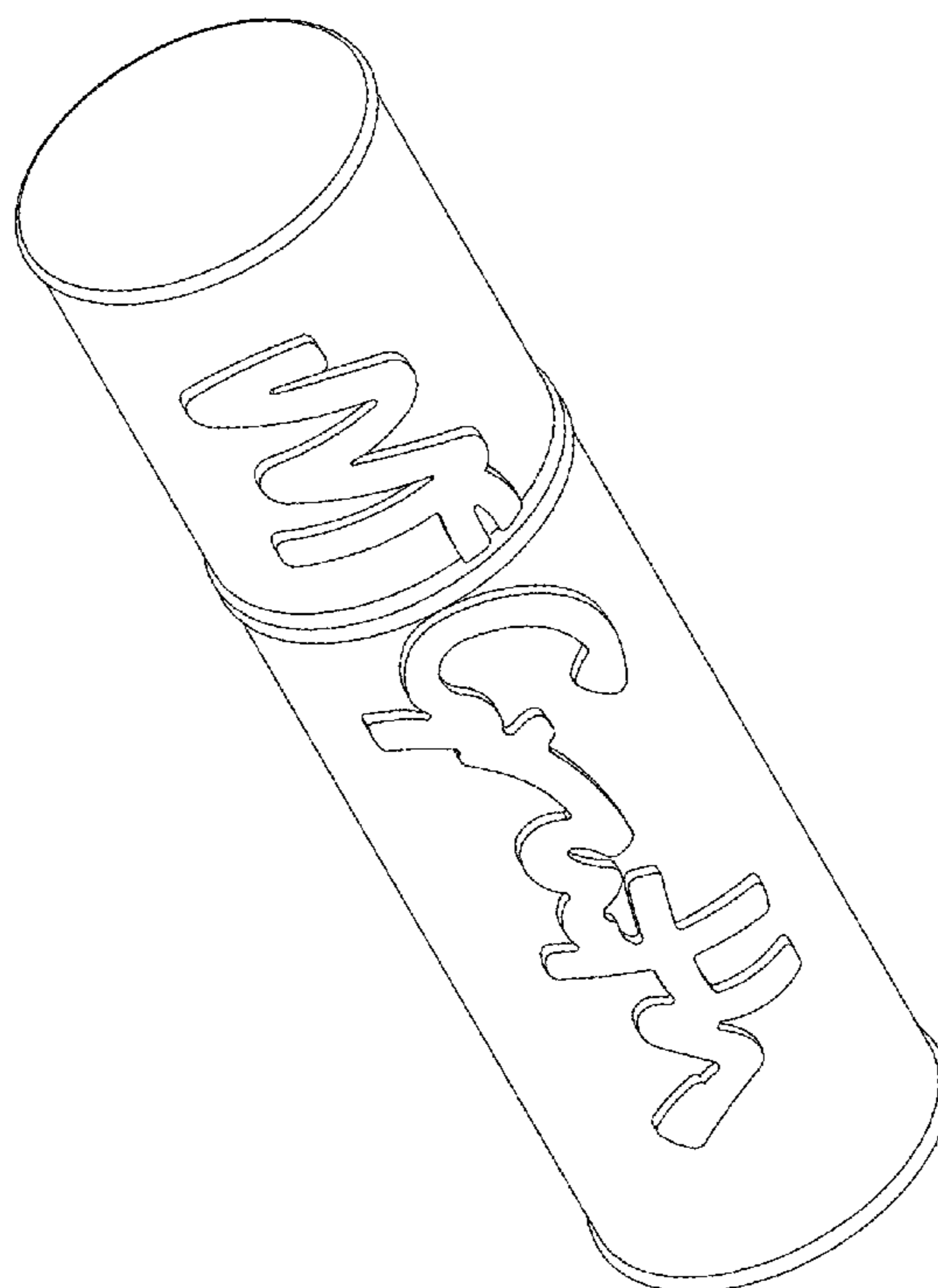
**DESCRIPTION**

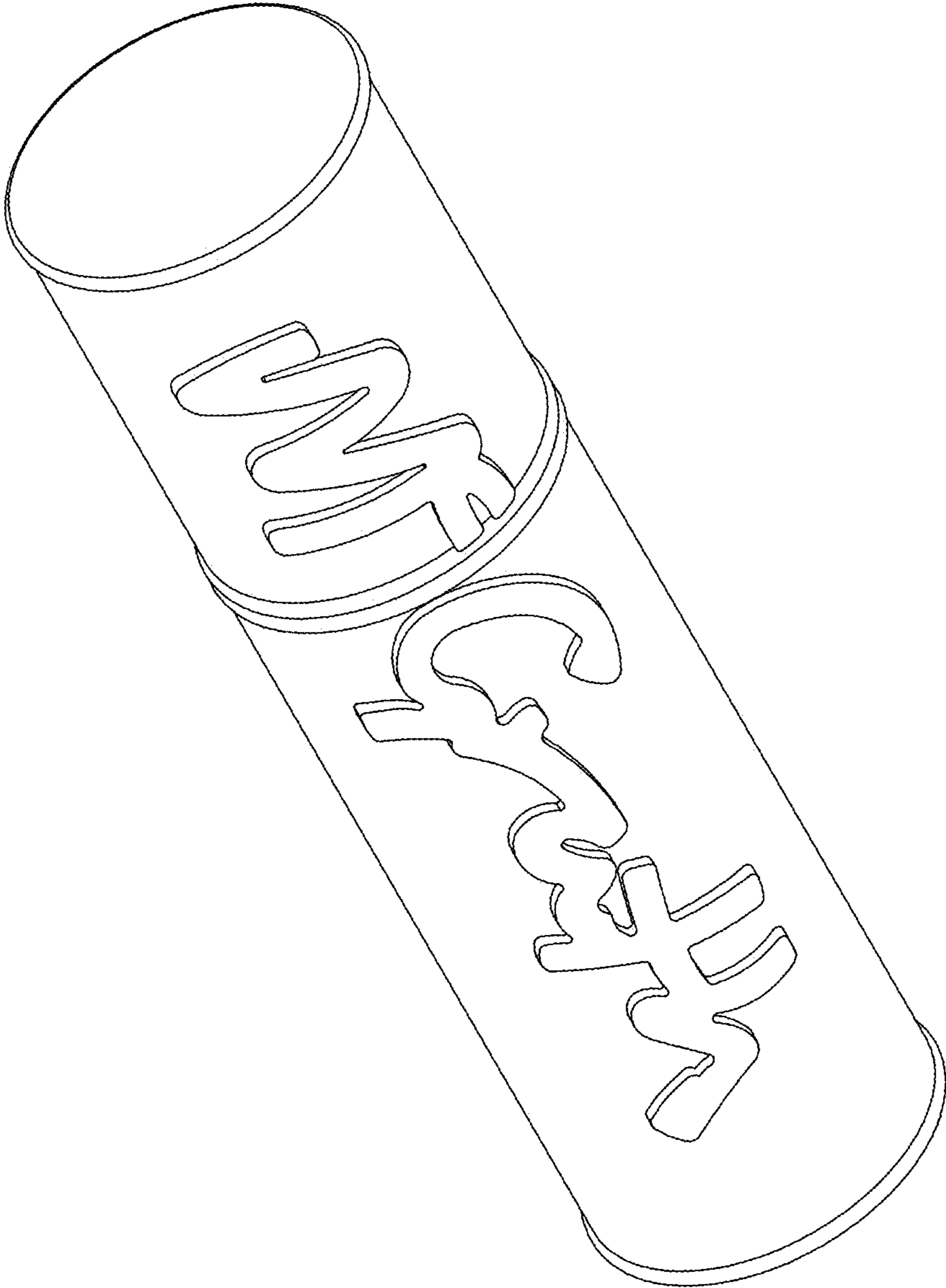

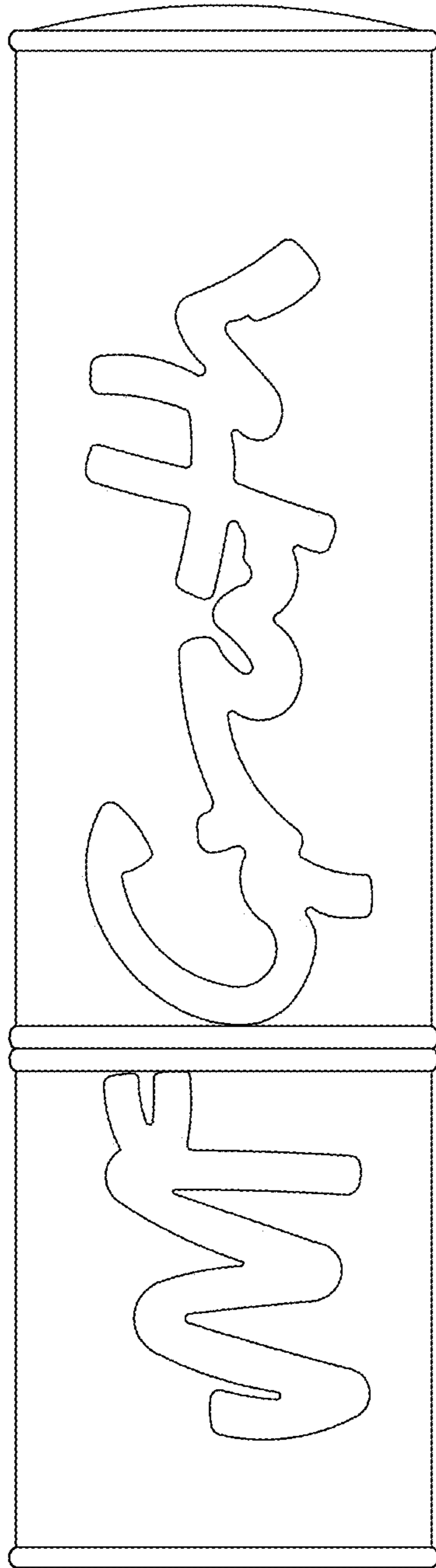

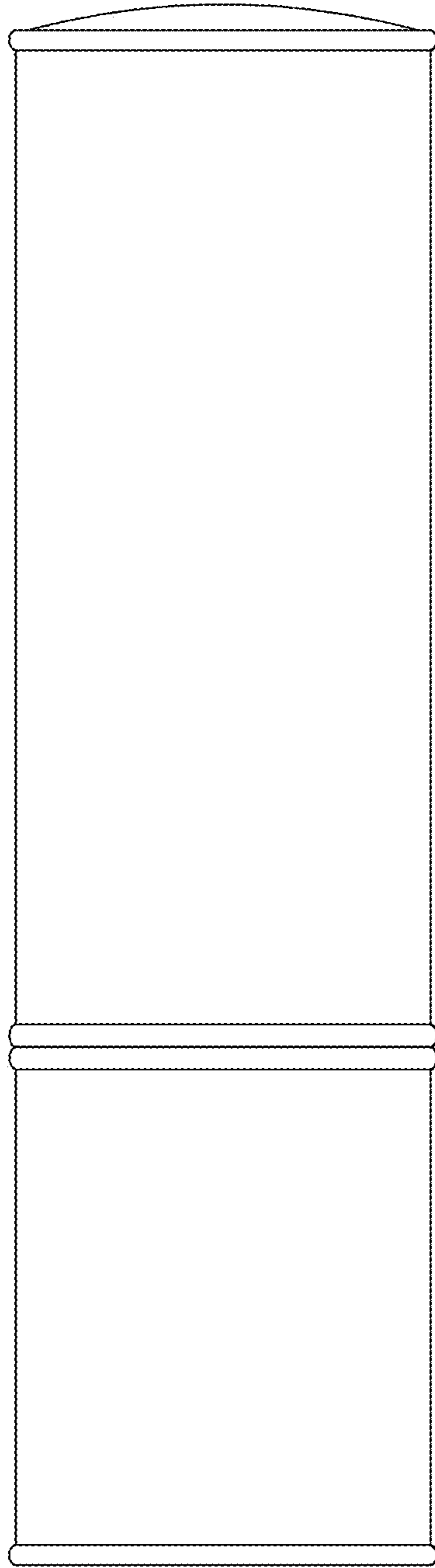

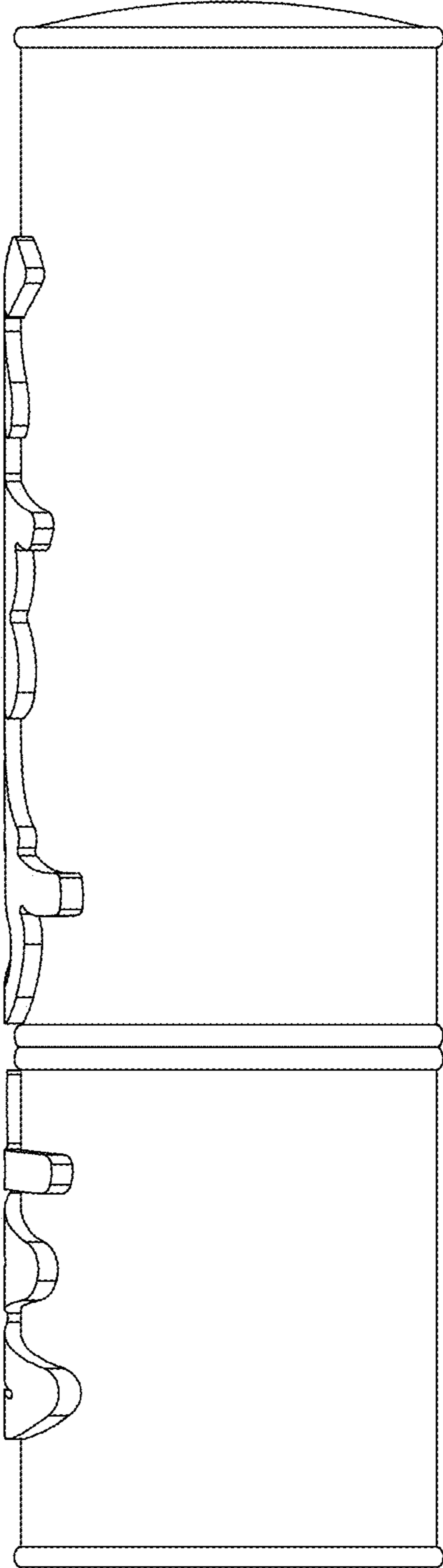

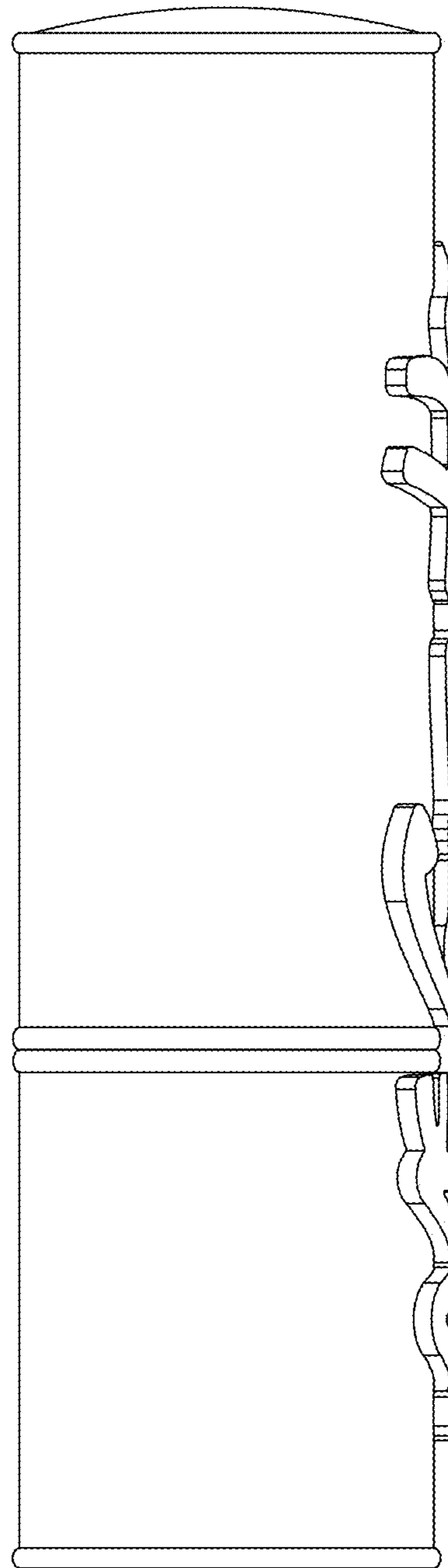
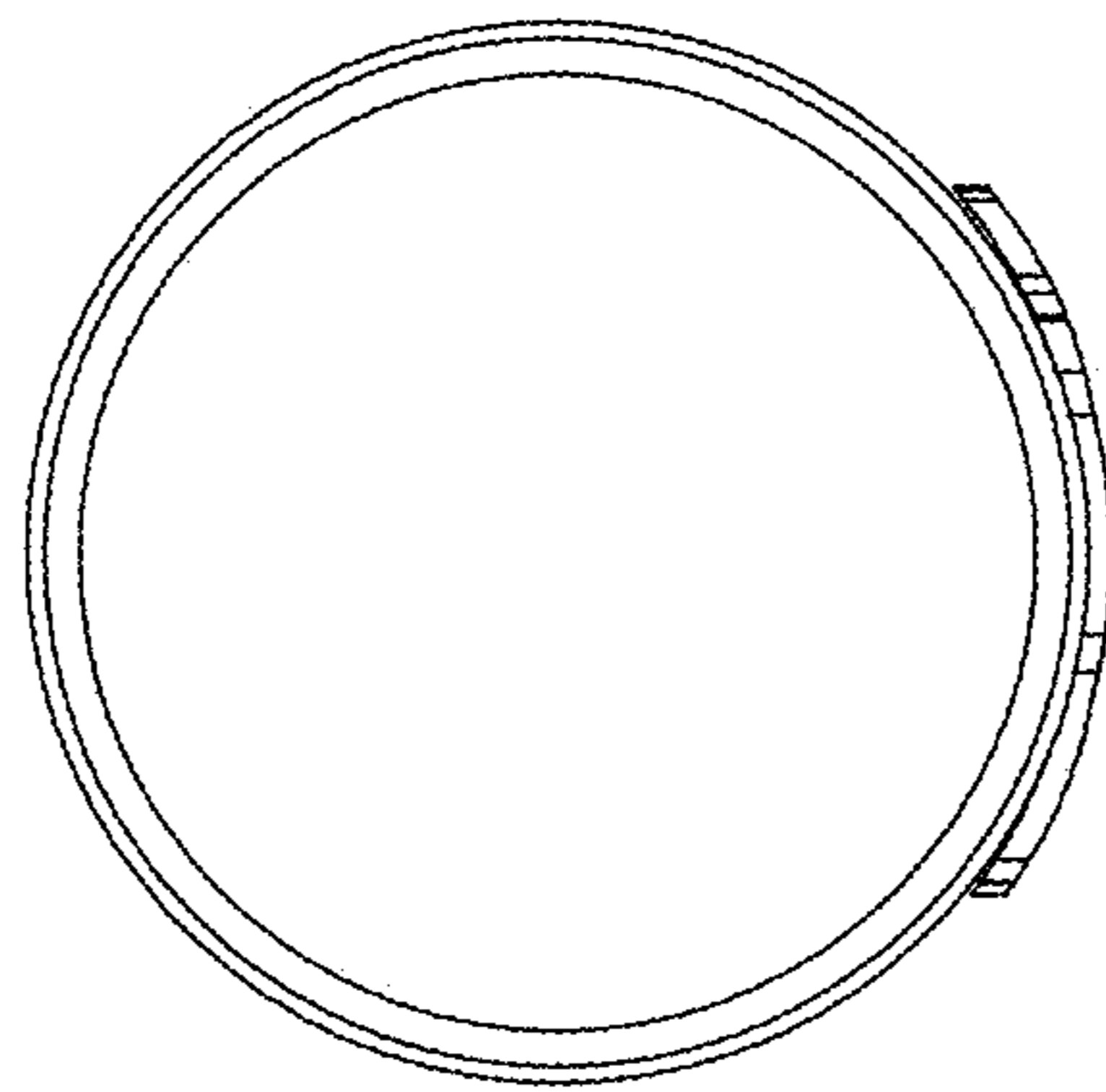
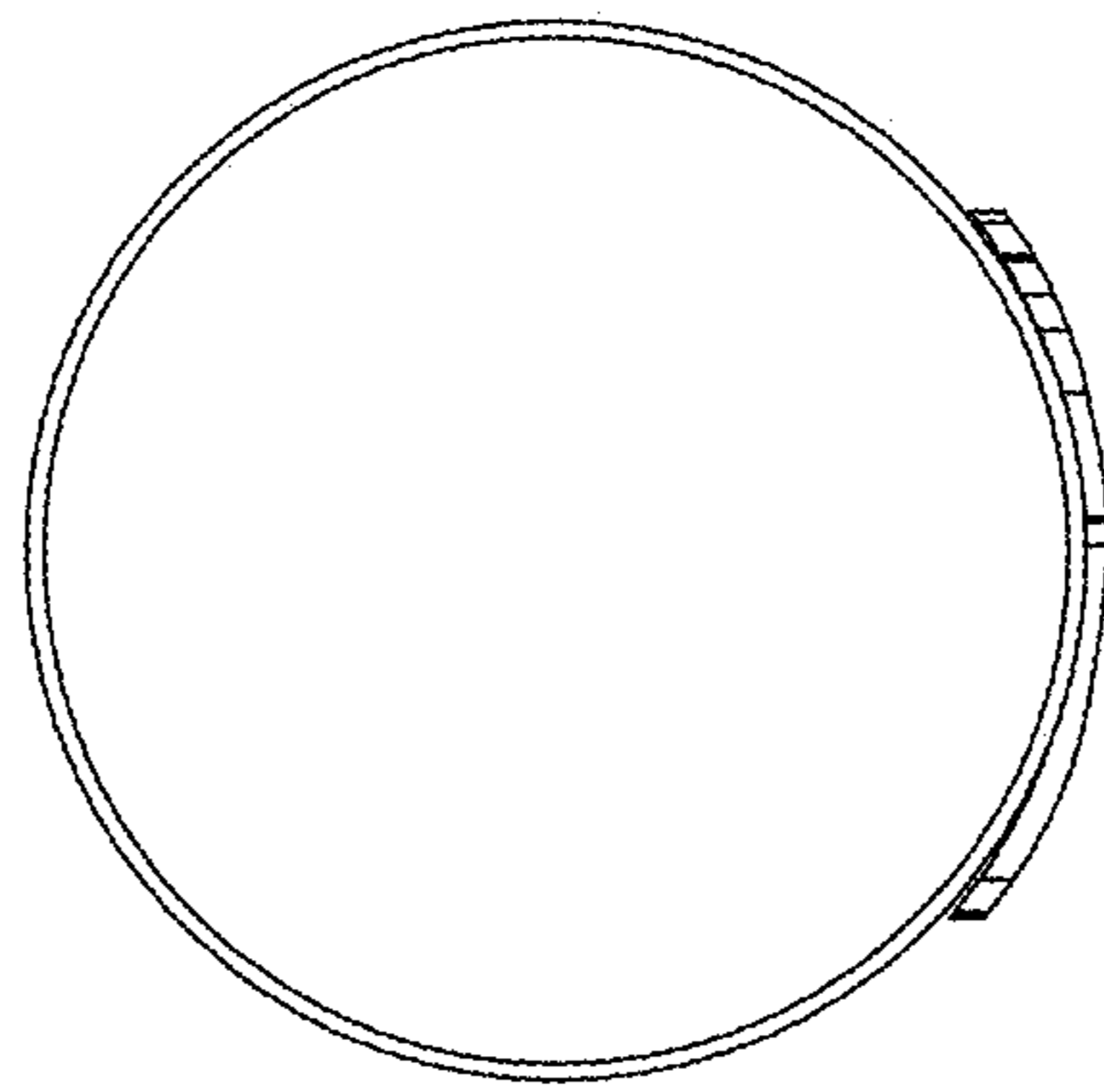
