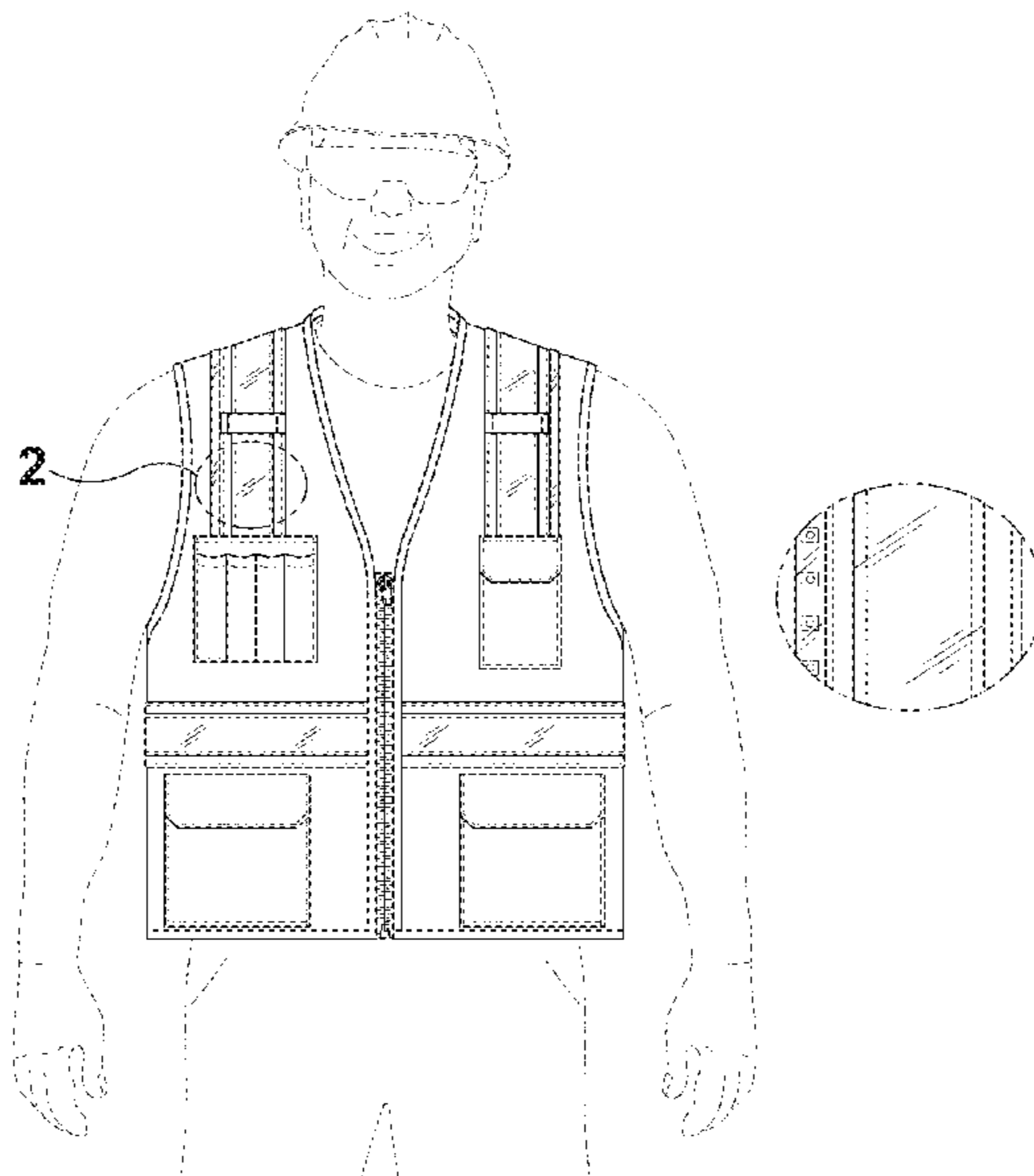
(57) **CLAIM**

The ornamental design for a safety garment with lights, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a safety garment with lights showing my new design. FIG. 2 is a detailed view of a section of the safety garment with lights shown in FIG. 1; and, FIG. 3 is a back view of FIG. 1. The broken line showing of a person with hard hat in FIGS. 1 and 3 represents environmental subject matter that forms no part of the claimed design. 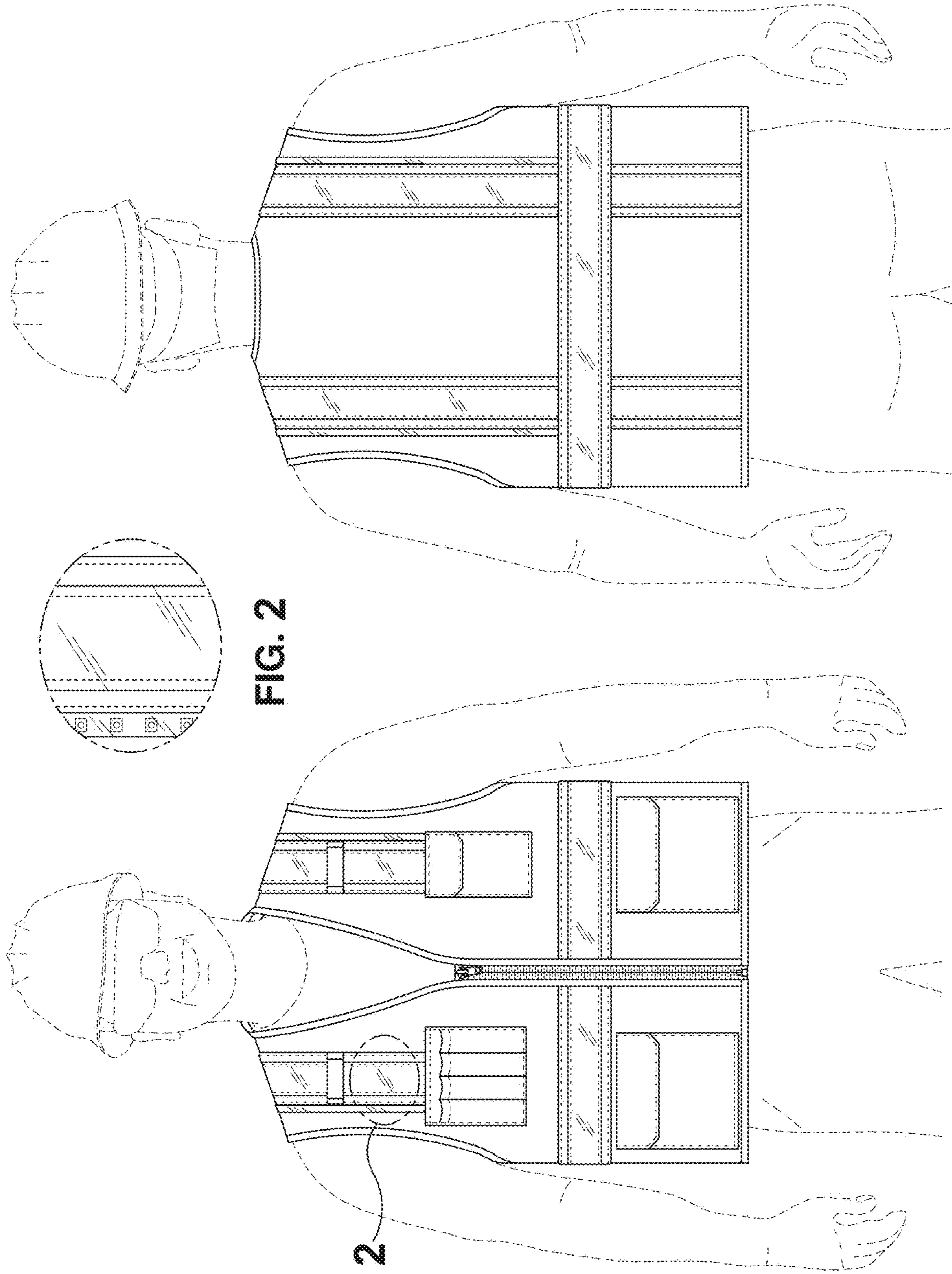
