The ornamental design for a dog's excrement collector, as shown and described.

DESCRIPTION

1. Dog's excrement collector

1.1 : Front elevation

1.2 : Back elevation

1.3 : Top plan

1.4 : Left elevation, the right elevation being a mirror image thereof

1.5 : Bottom plan

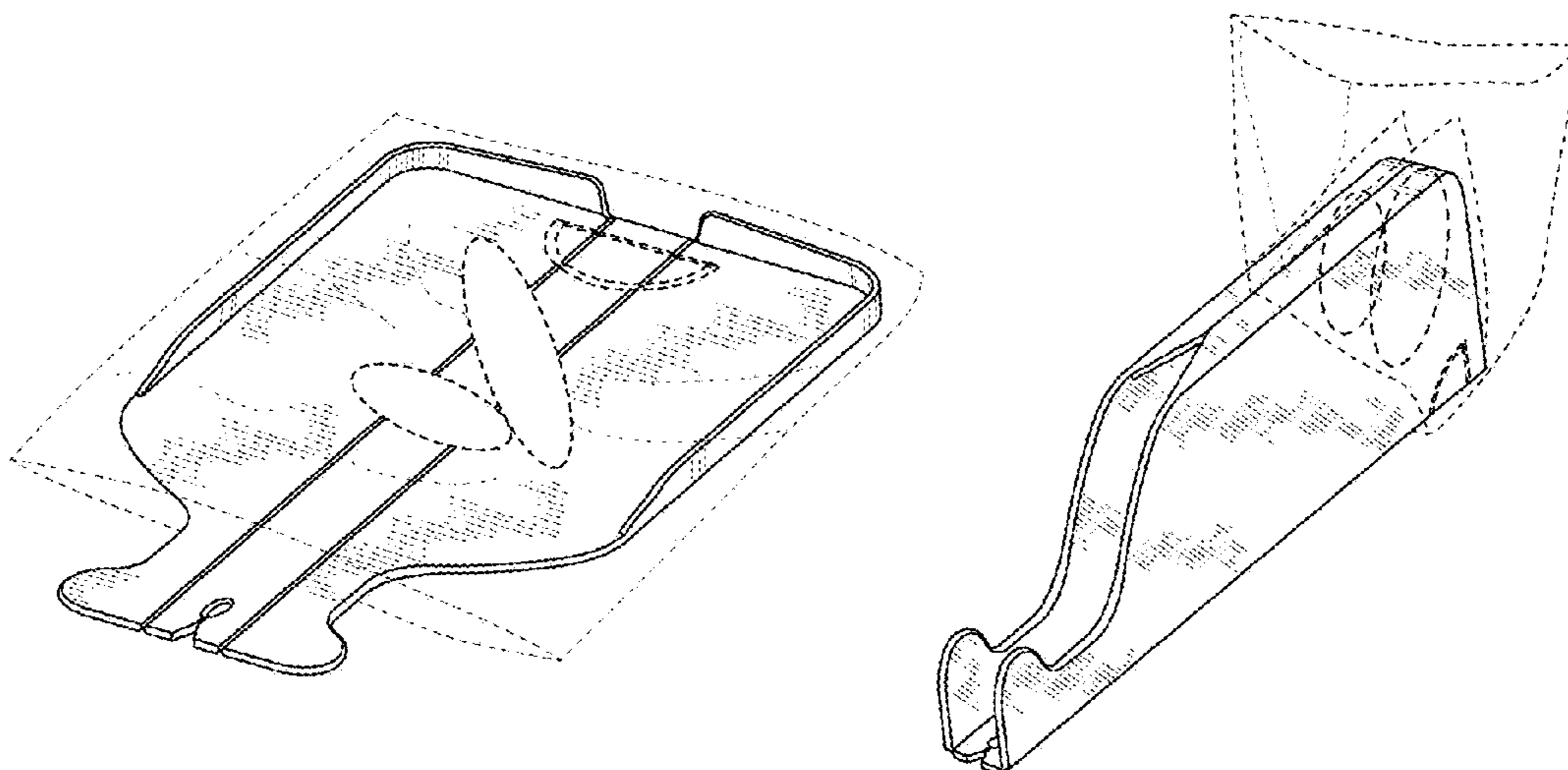
1.6: Top perspective view, shown in condition of use

1.7 : Top perspective view, shown in condition of use and in a second configuration for clarity of disclosure

A right side view is omitted because it is a mirror image of the left side view; the portions in broken lines are shown for illustrative purposes only and form no part of the claimed design.

In reproductions 1.1-1.7, the equal-length broken lines on the surface of the dog's excrement collector depict elements that form no part of the claimed design. In reproductions 1.6 and 1.7, the equal-length broken line showing of a bag and feces depicts environmental subject matter only and forms no part of the claimed design.

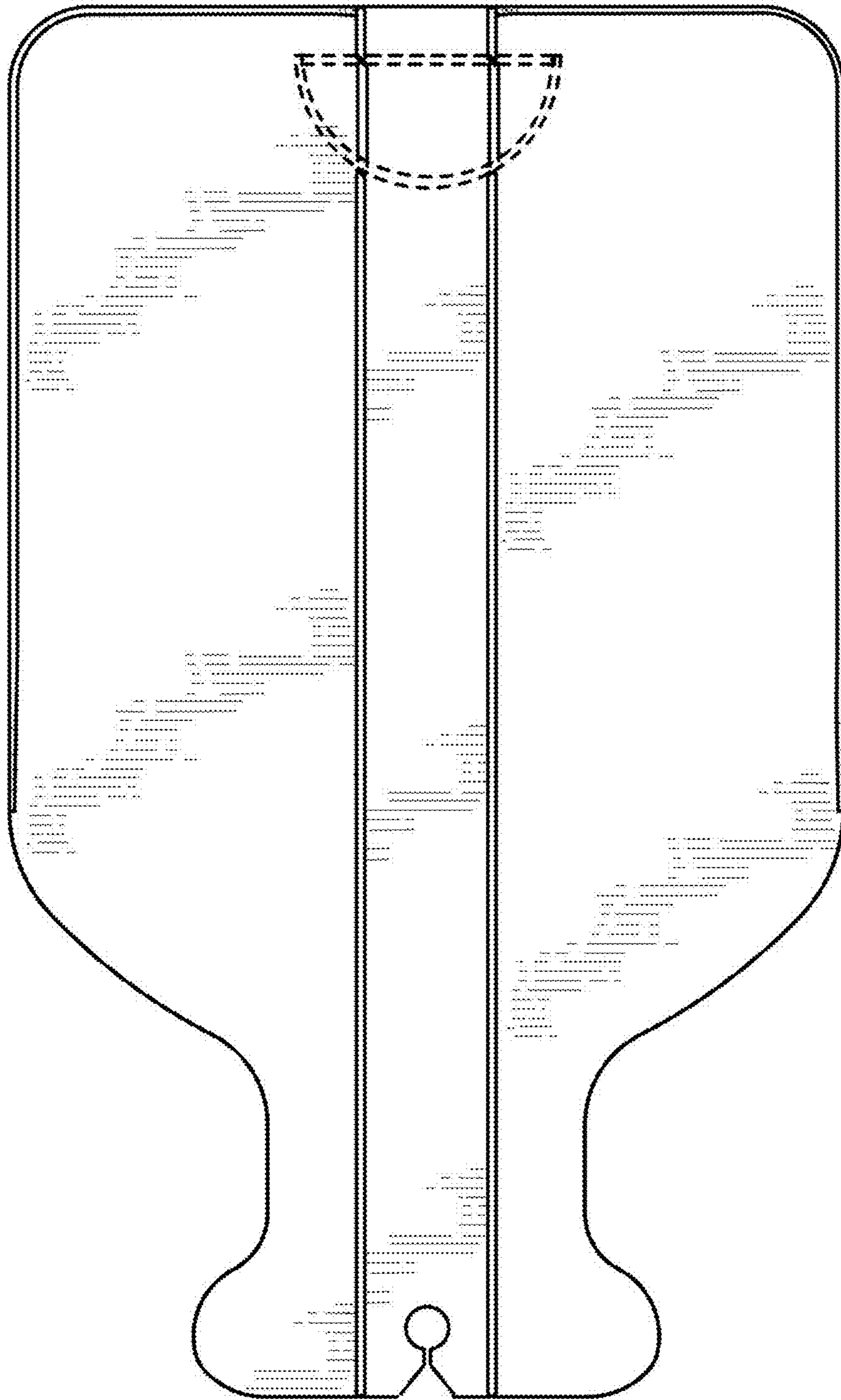

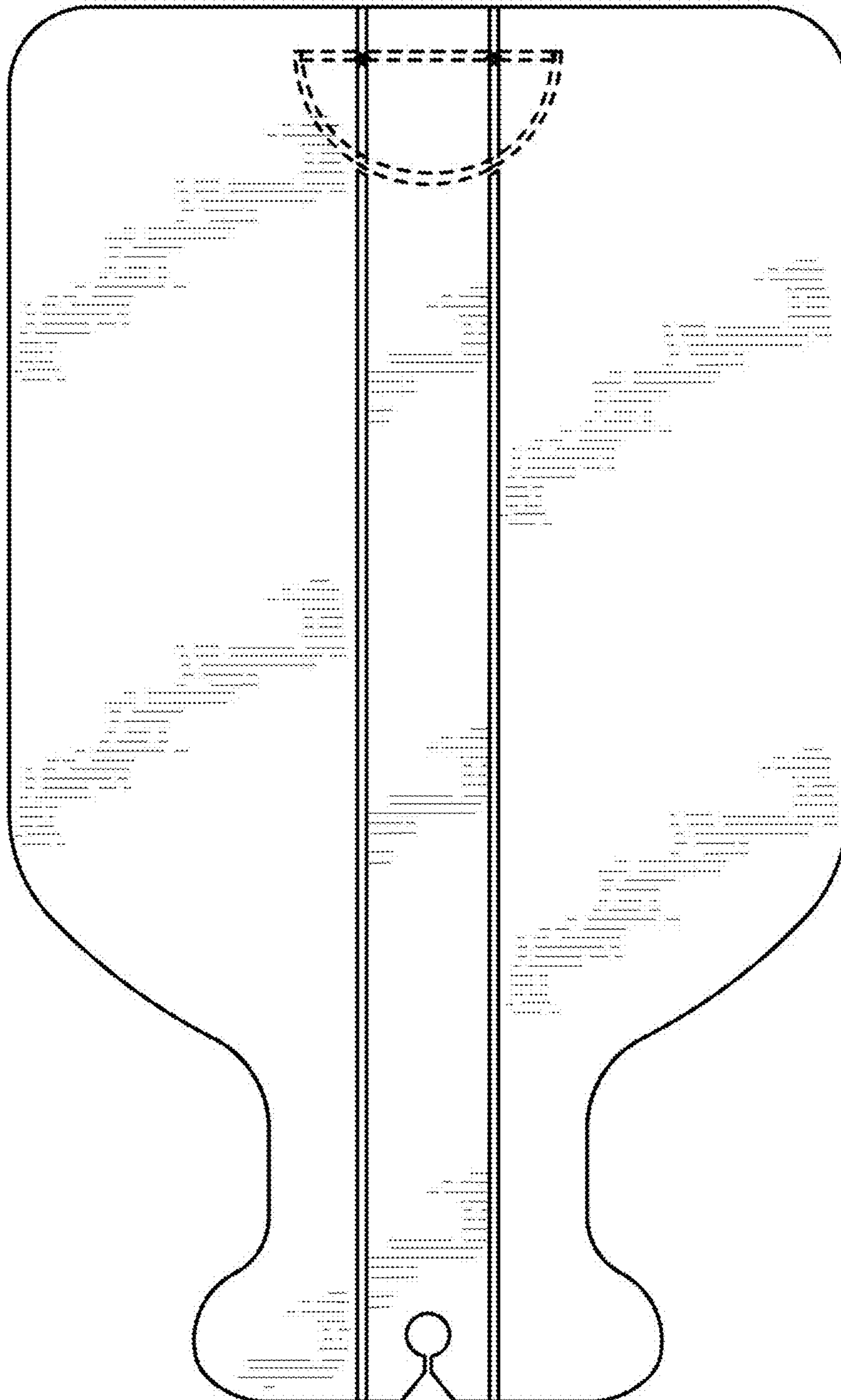

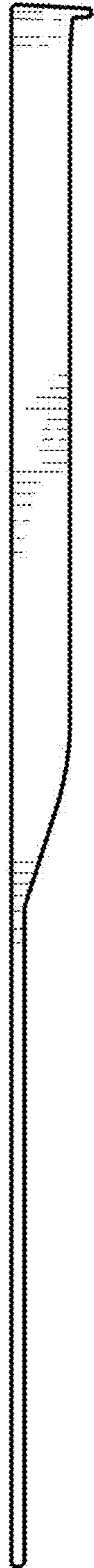

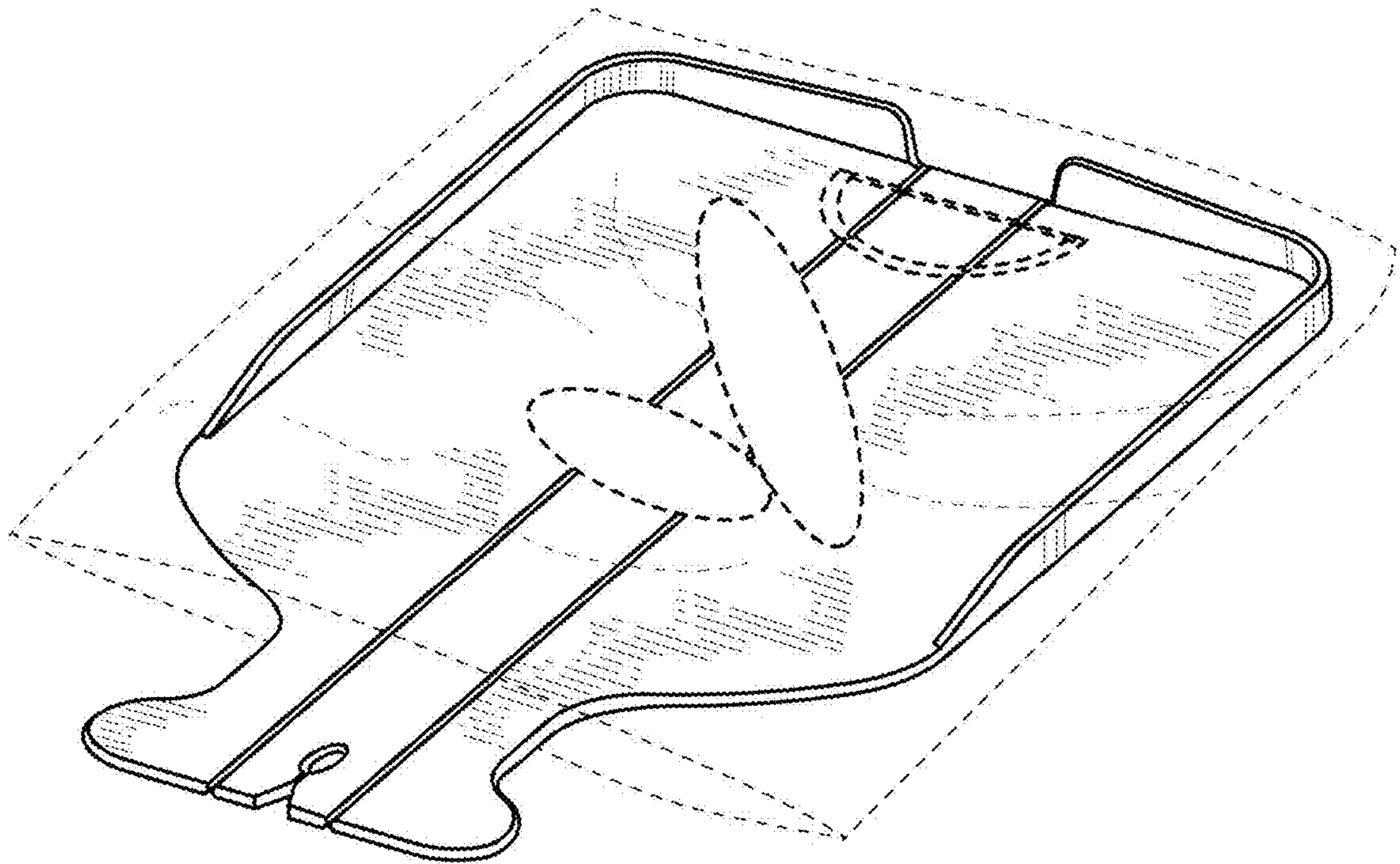
