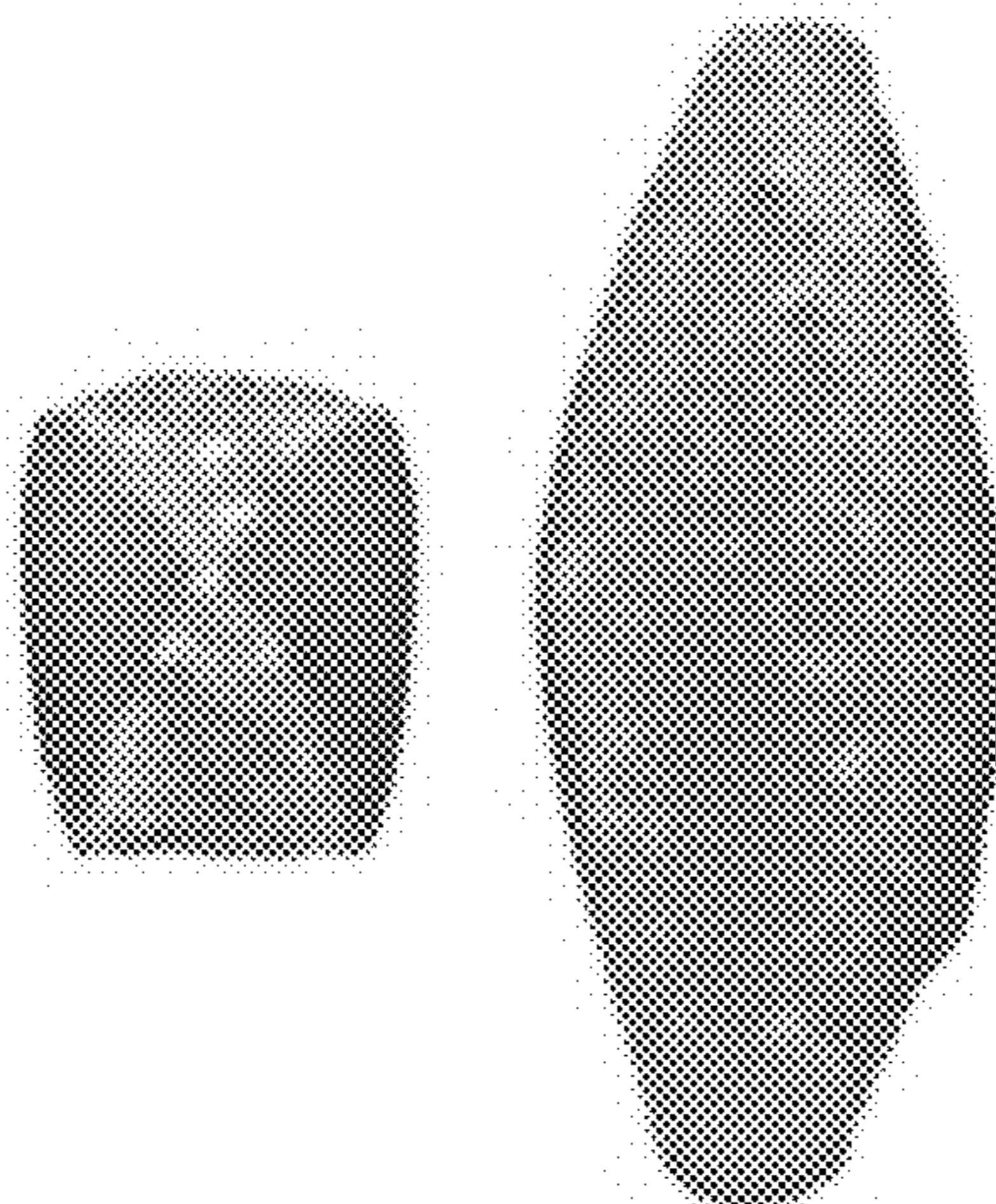


FIG. 2 is a top view thereof; and,

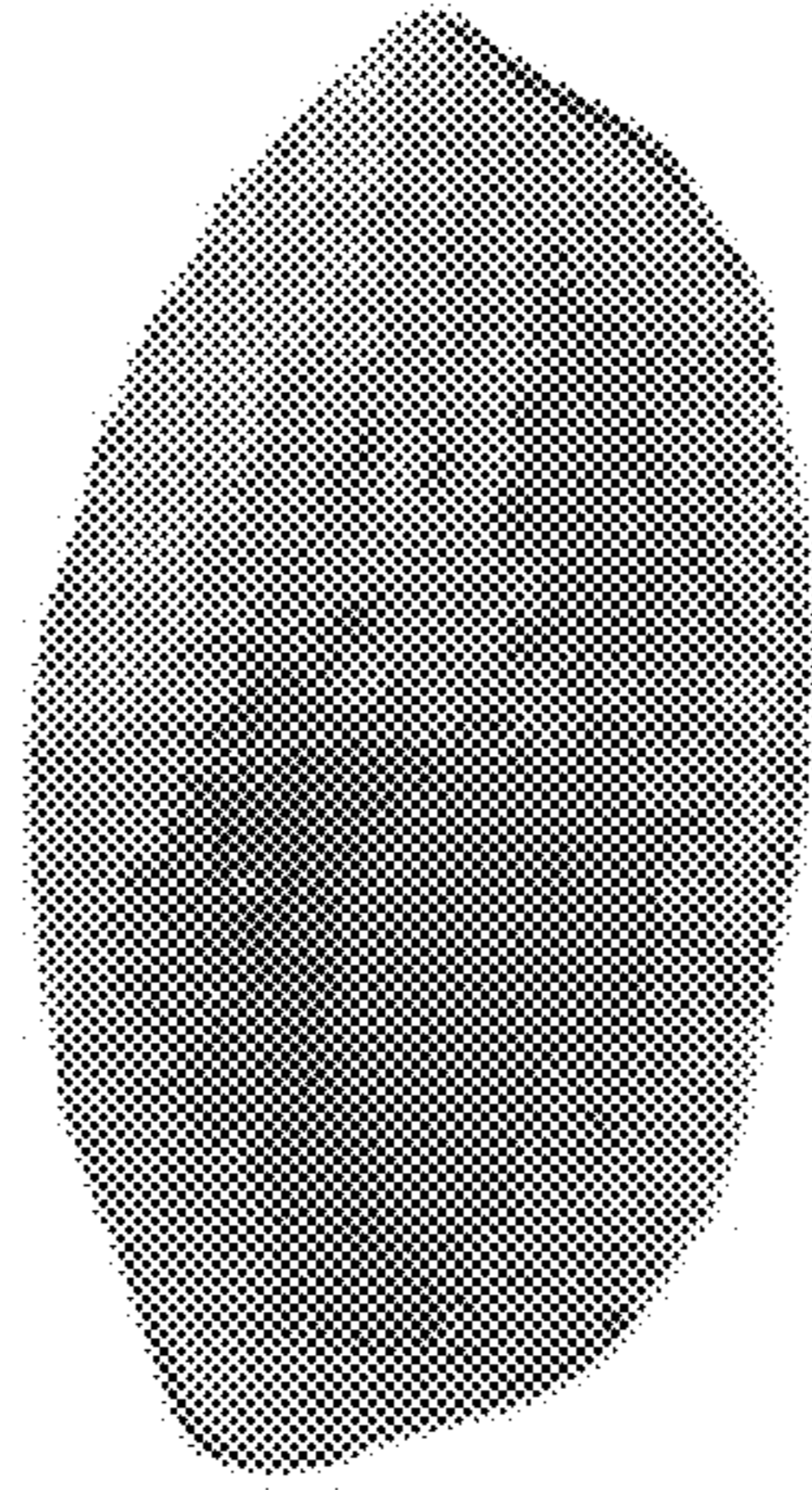
