(57) **CLAIM**

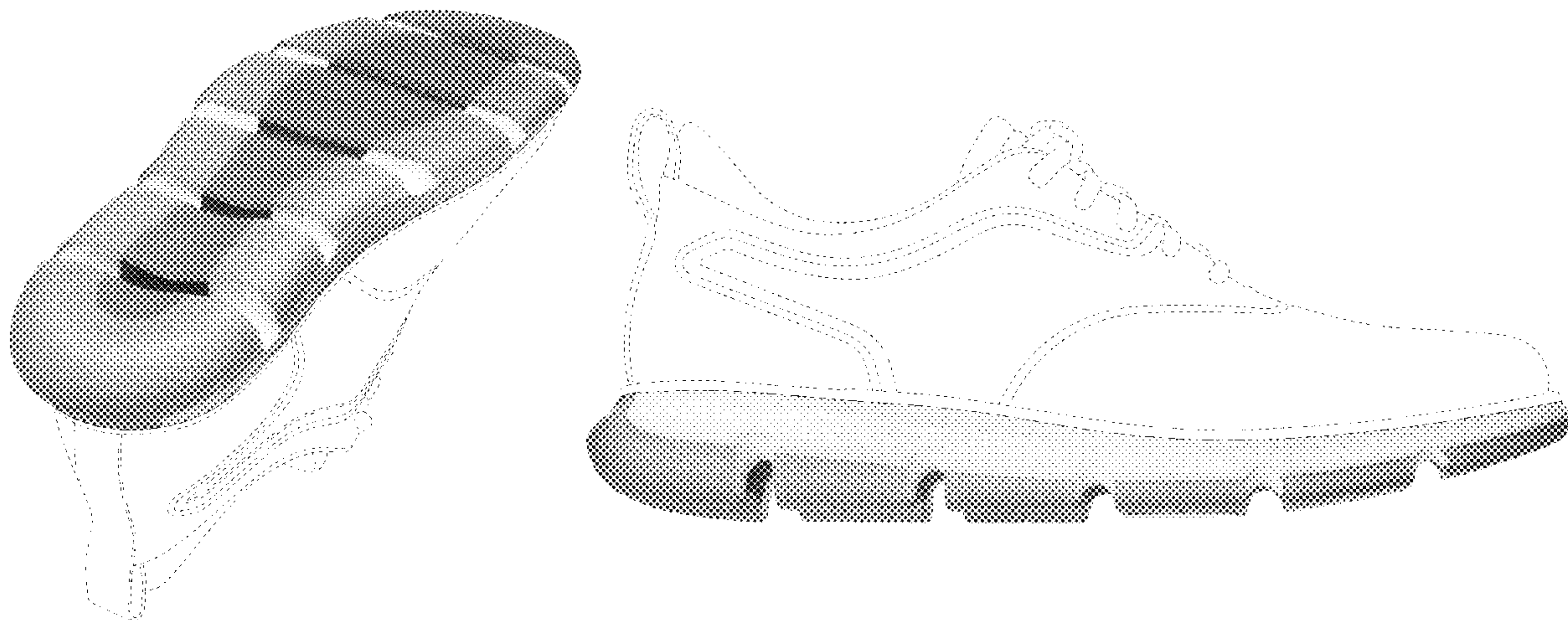
The ornamental design for a shoe with translucent outsole, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a shoe with translucent outsole showing our new design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof; and,

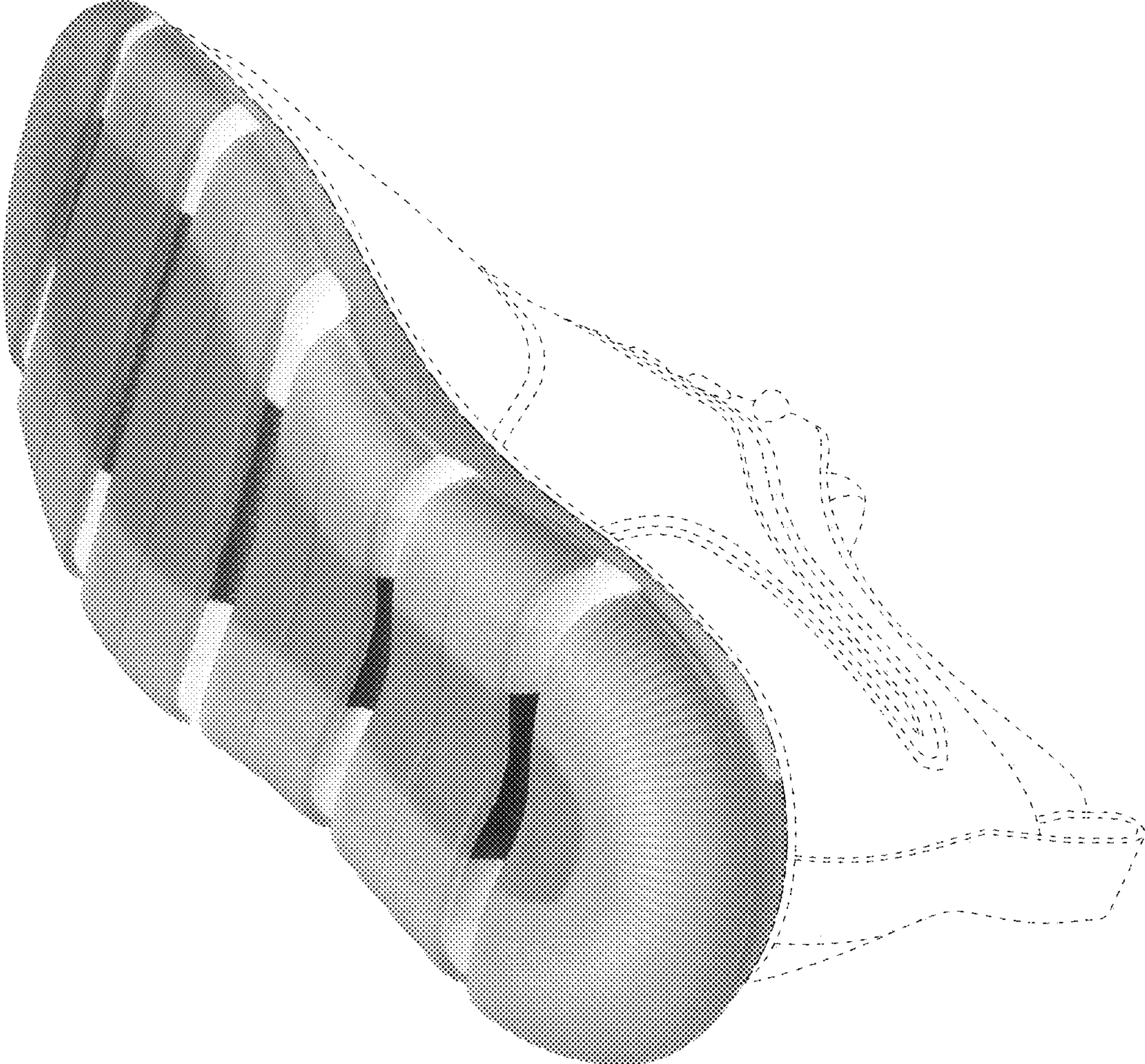

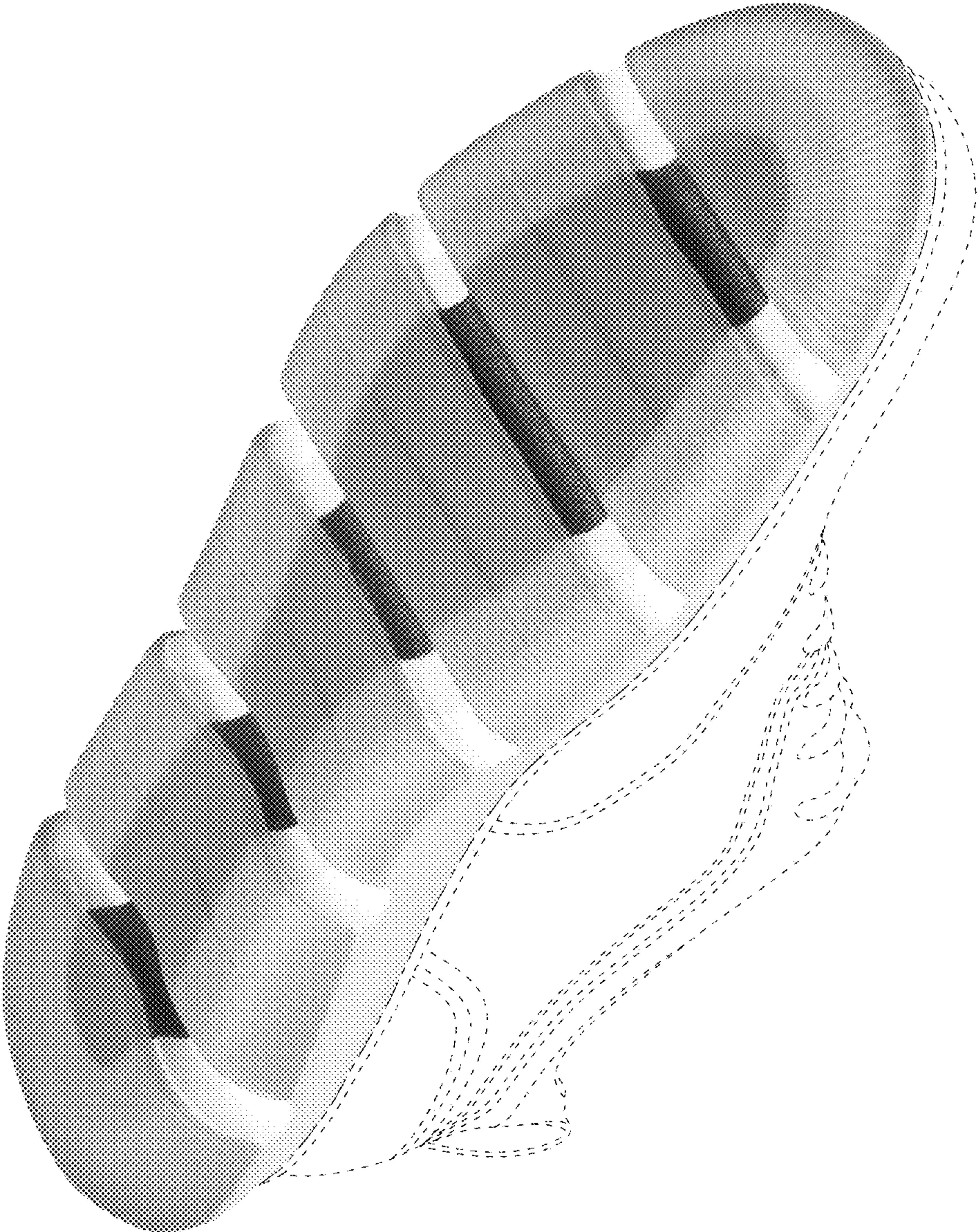

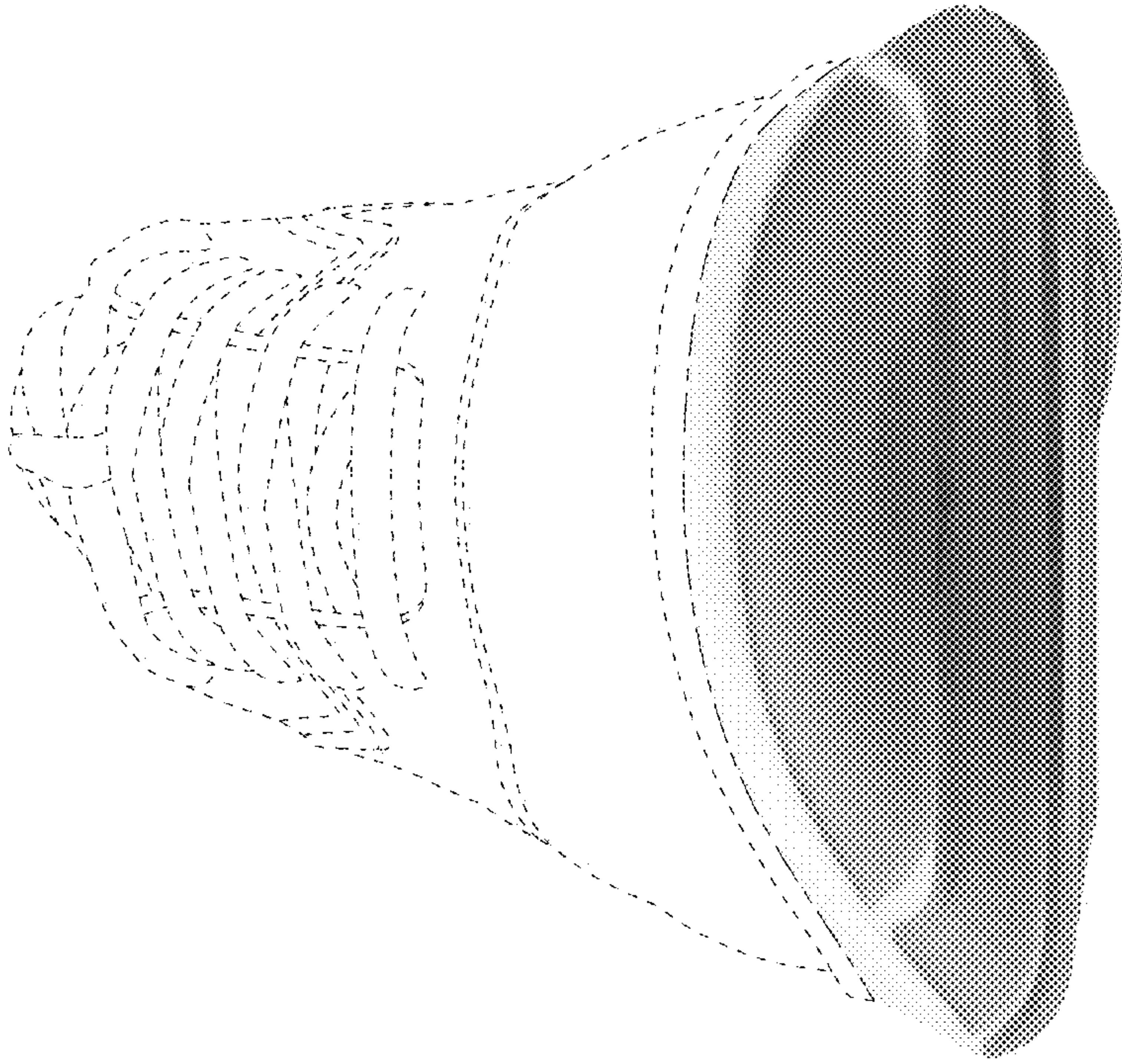

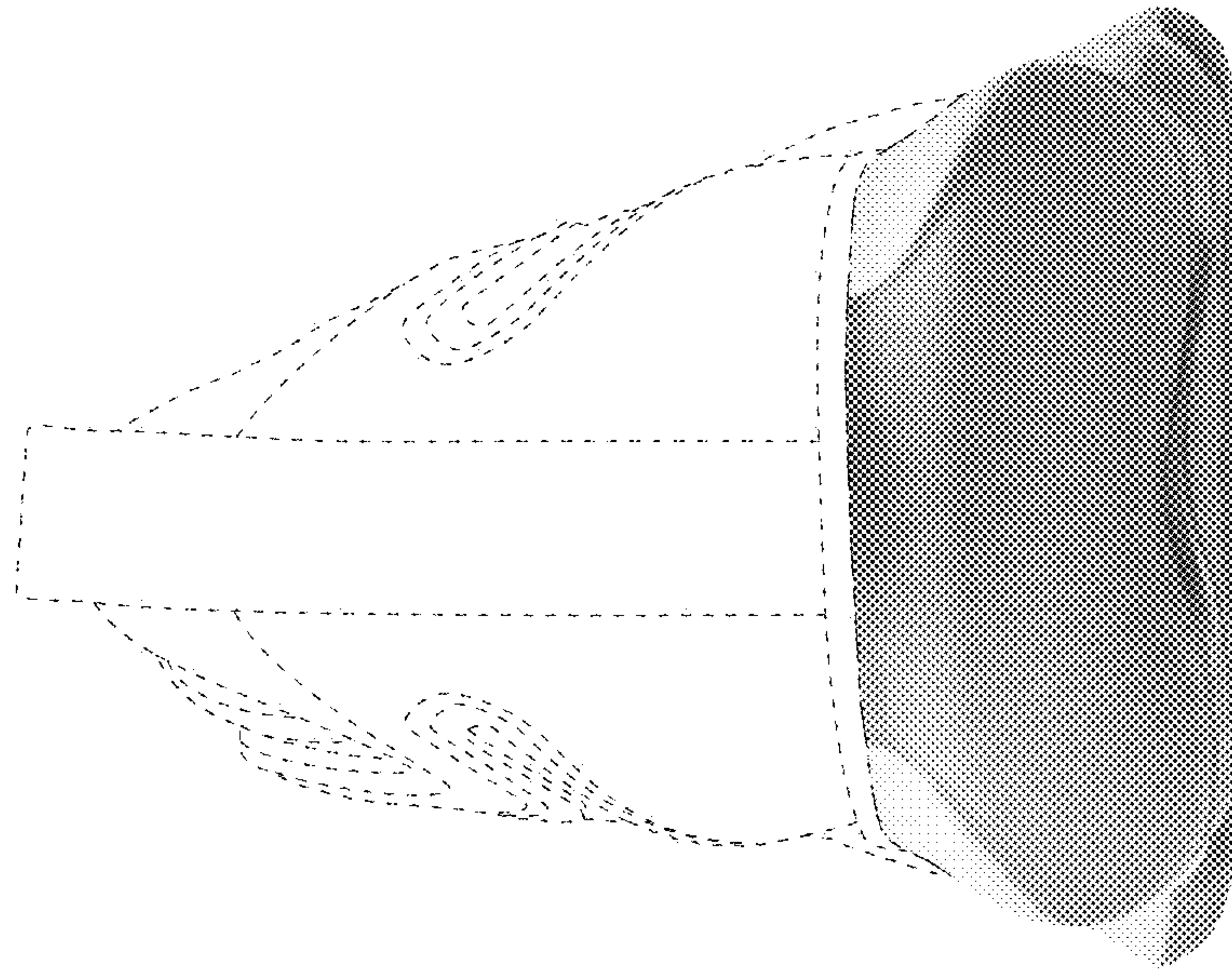

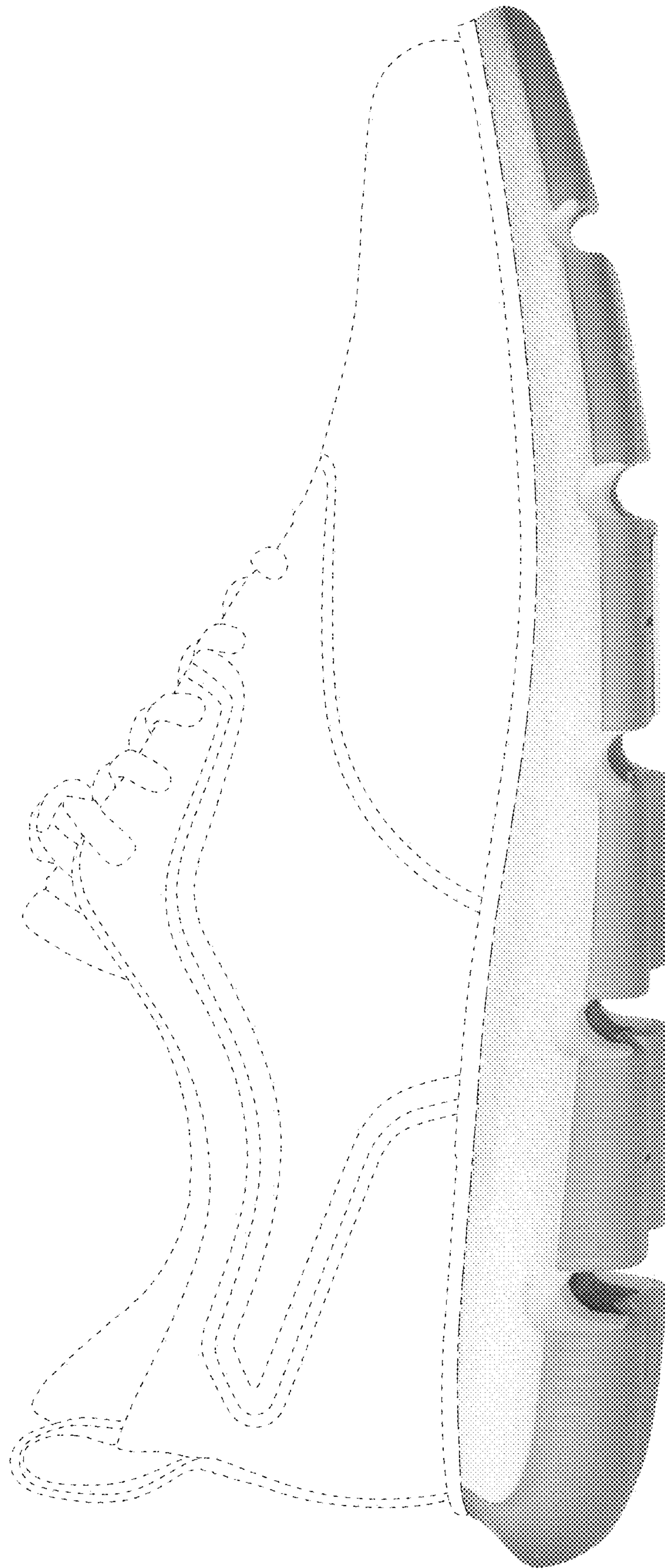

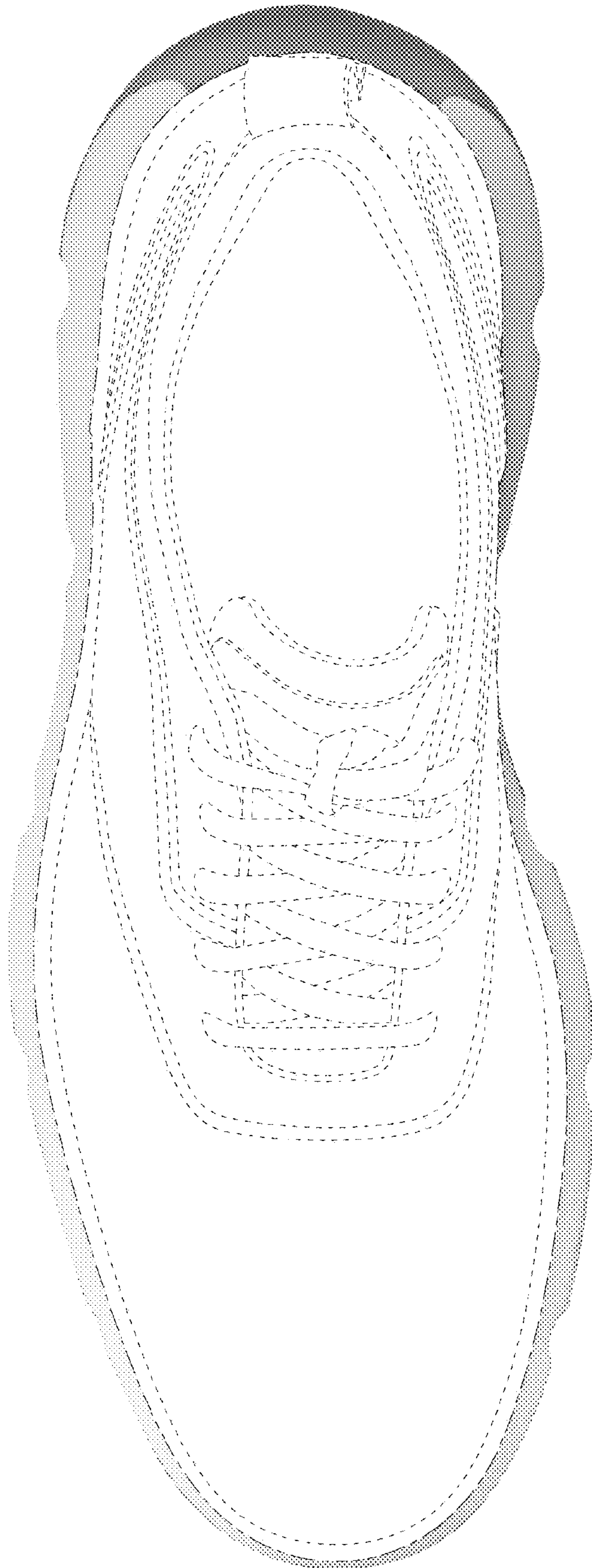

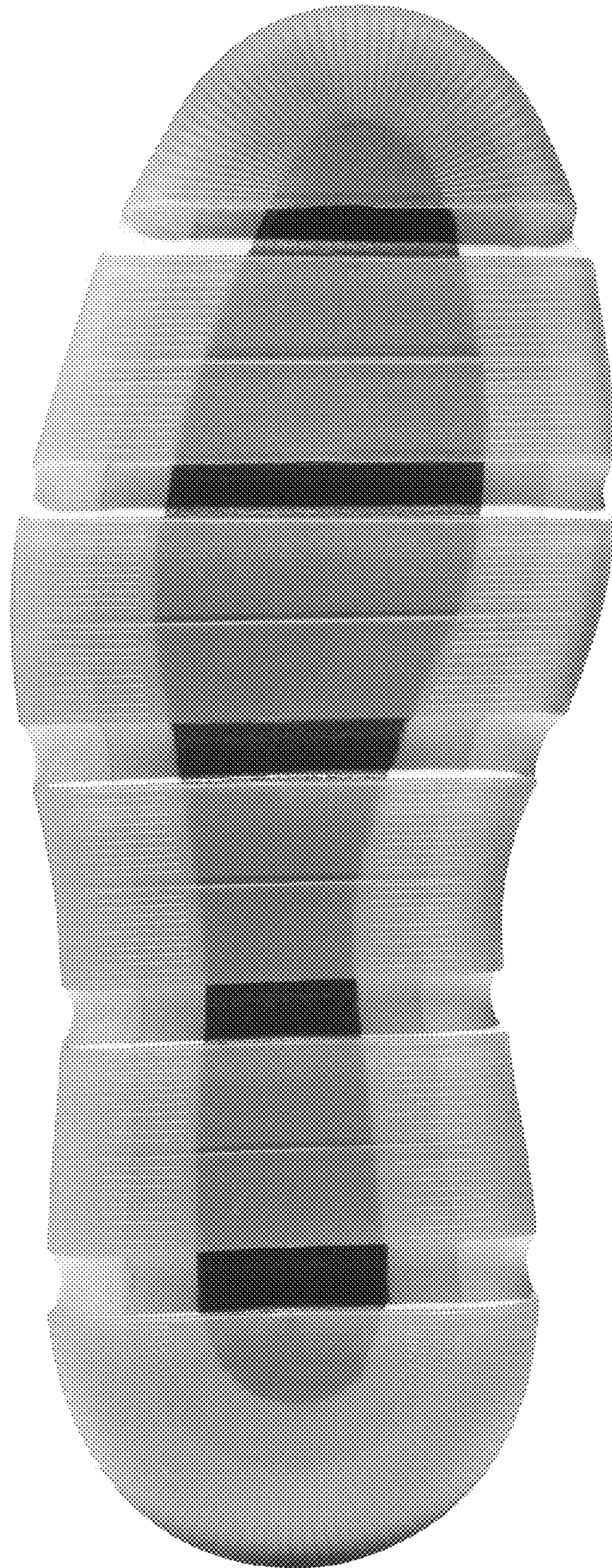
