DESCRIPTION

FIG. 9 is cross-sectional view taken along line 9-9 in FIG. 6.

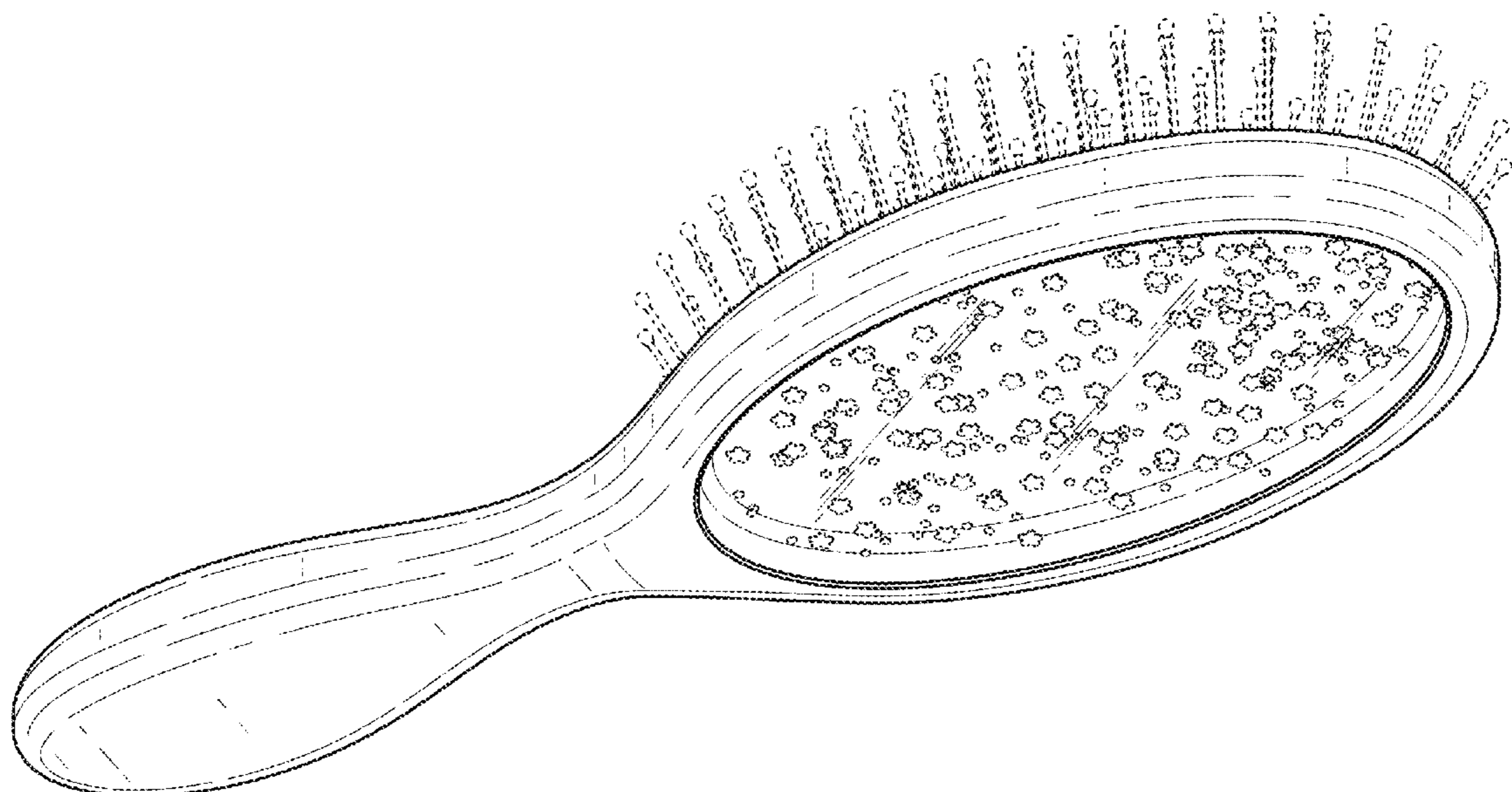
The broken-line showing of brush tips and specks illustrates environmental structure that forms no part of the claimed design.

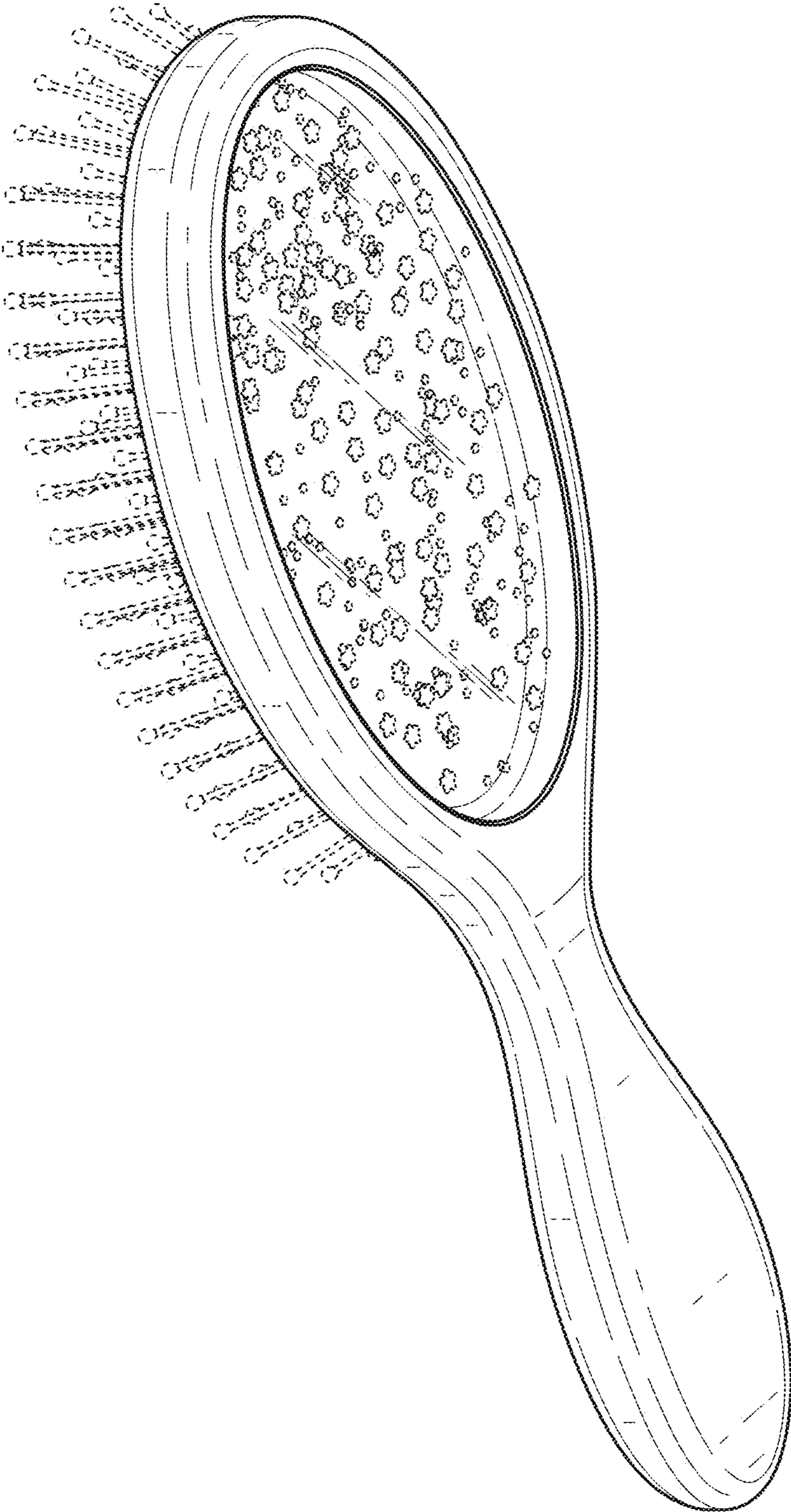

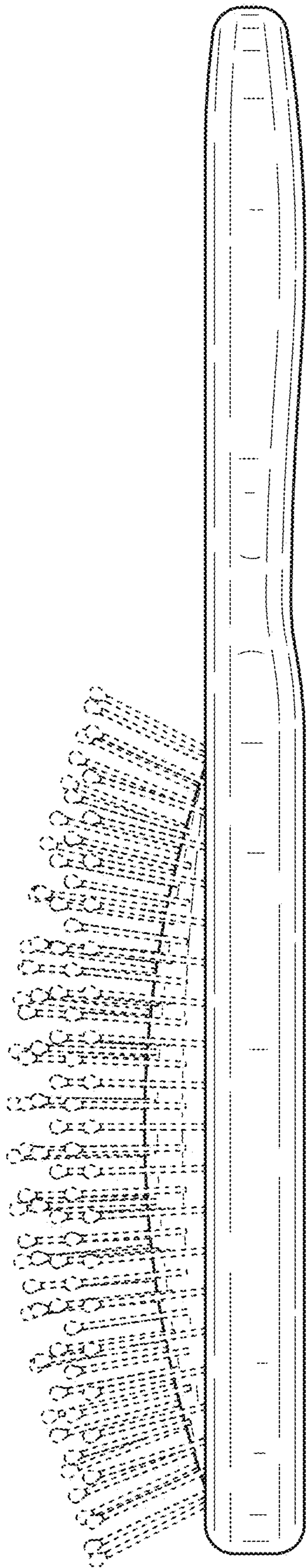

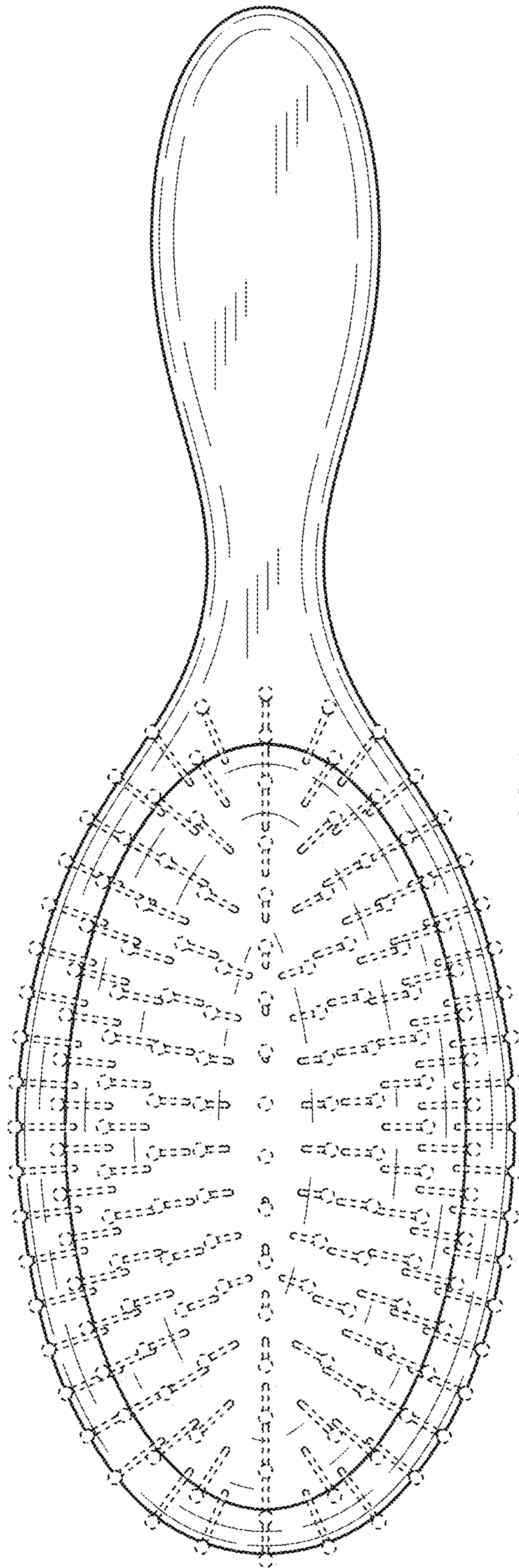

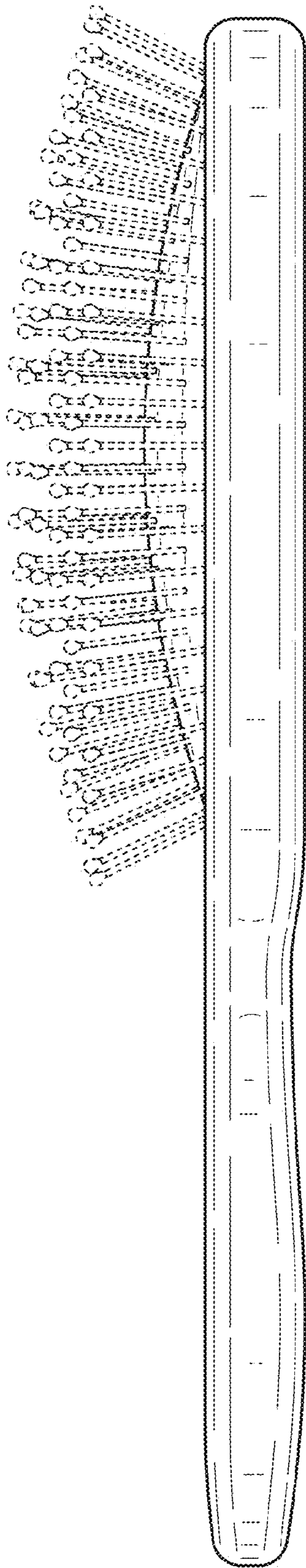

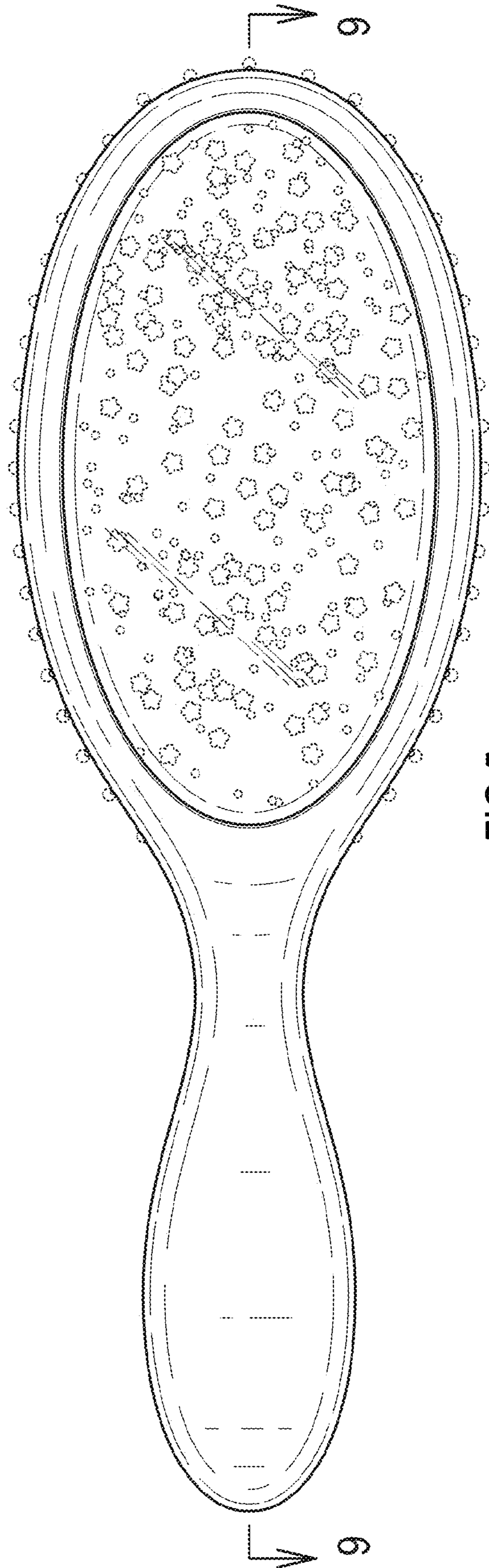

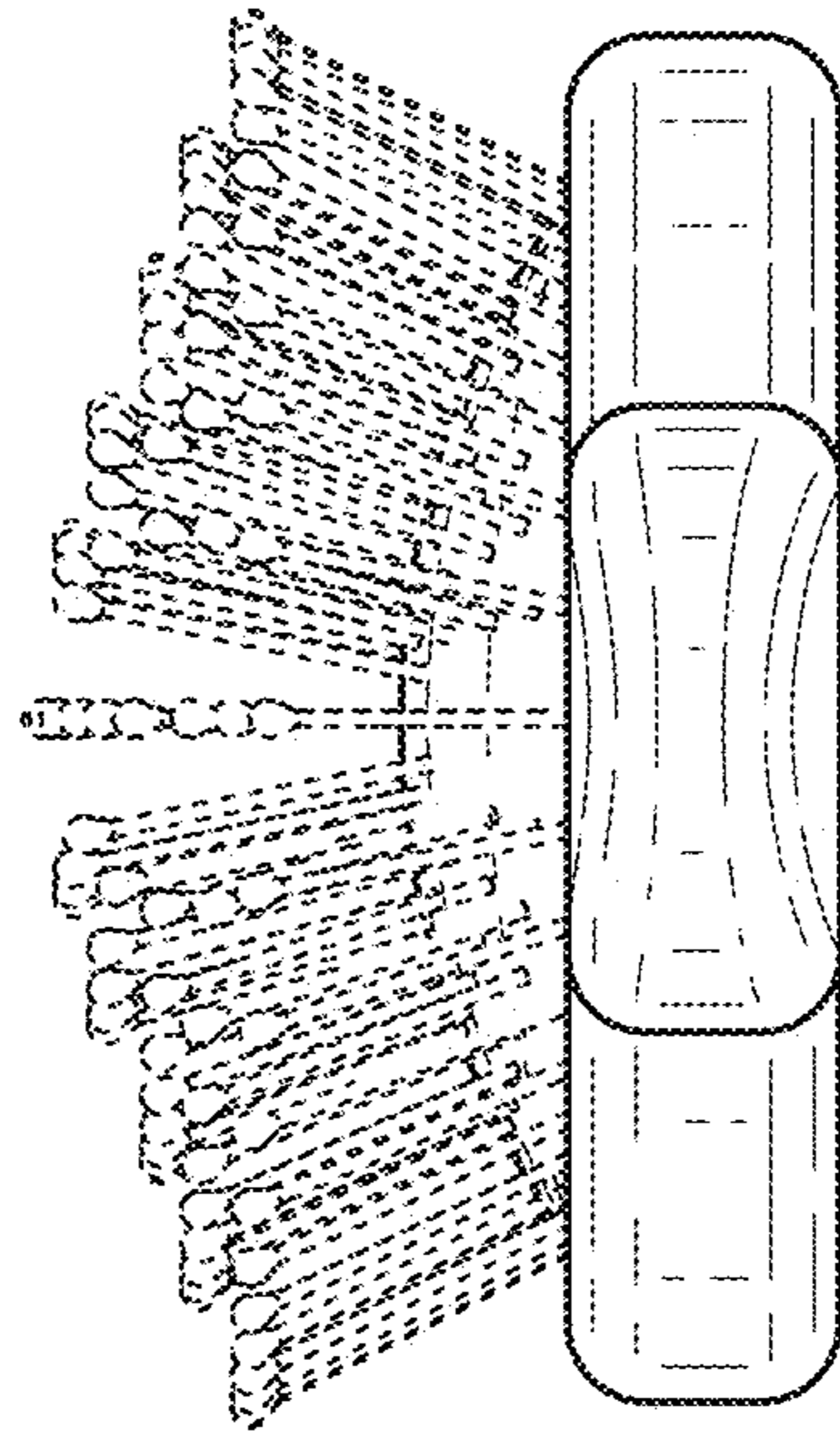

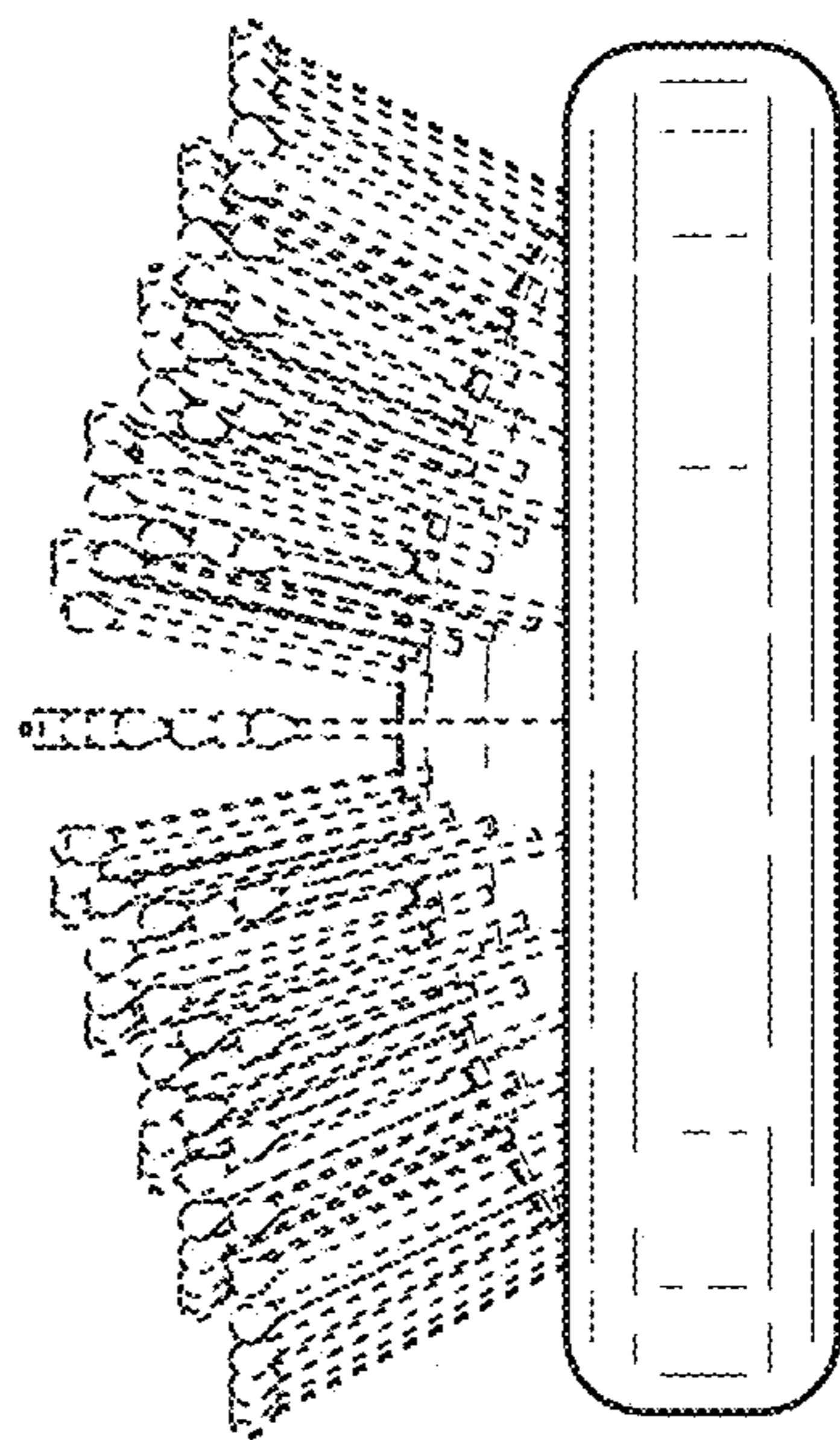

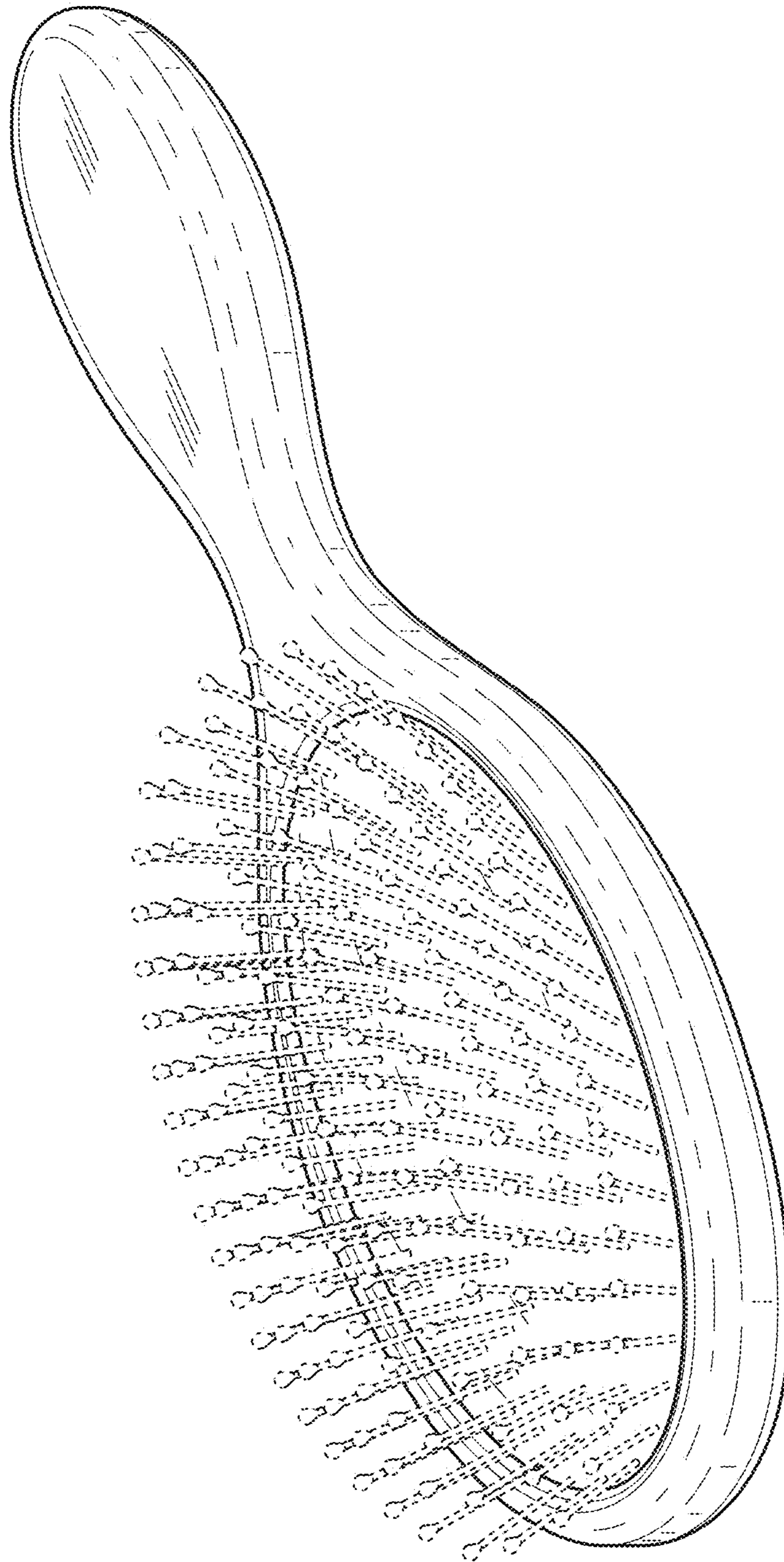

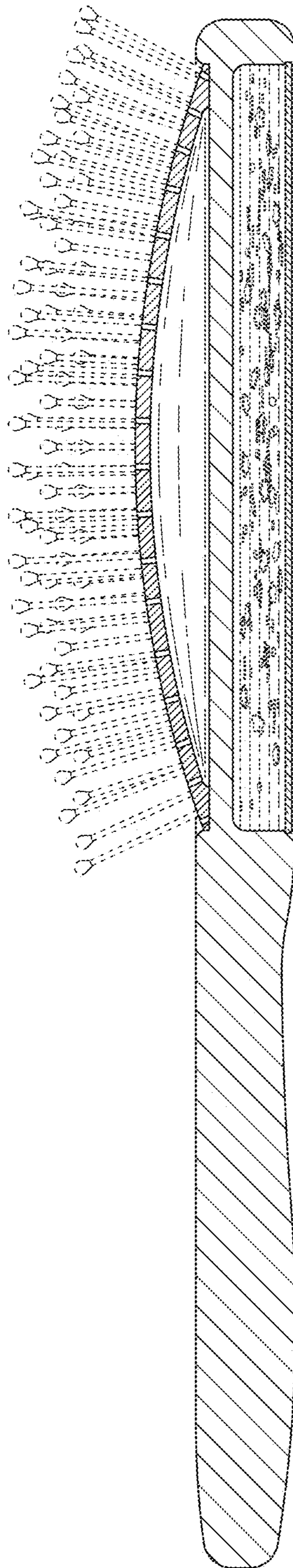
