(57) **CLAIM**

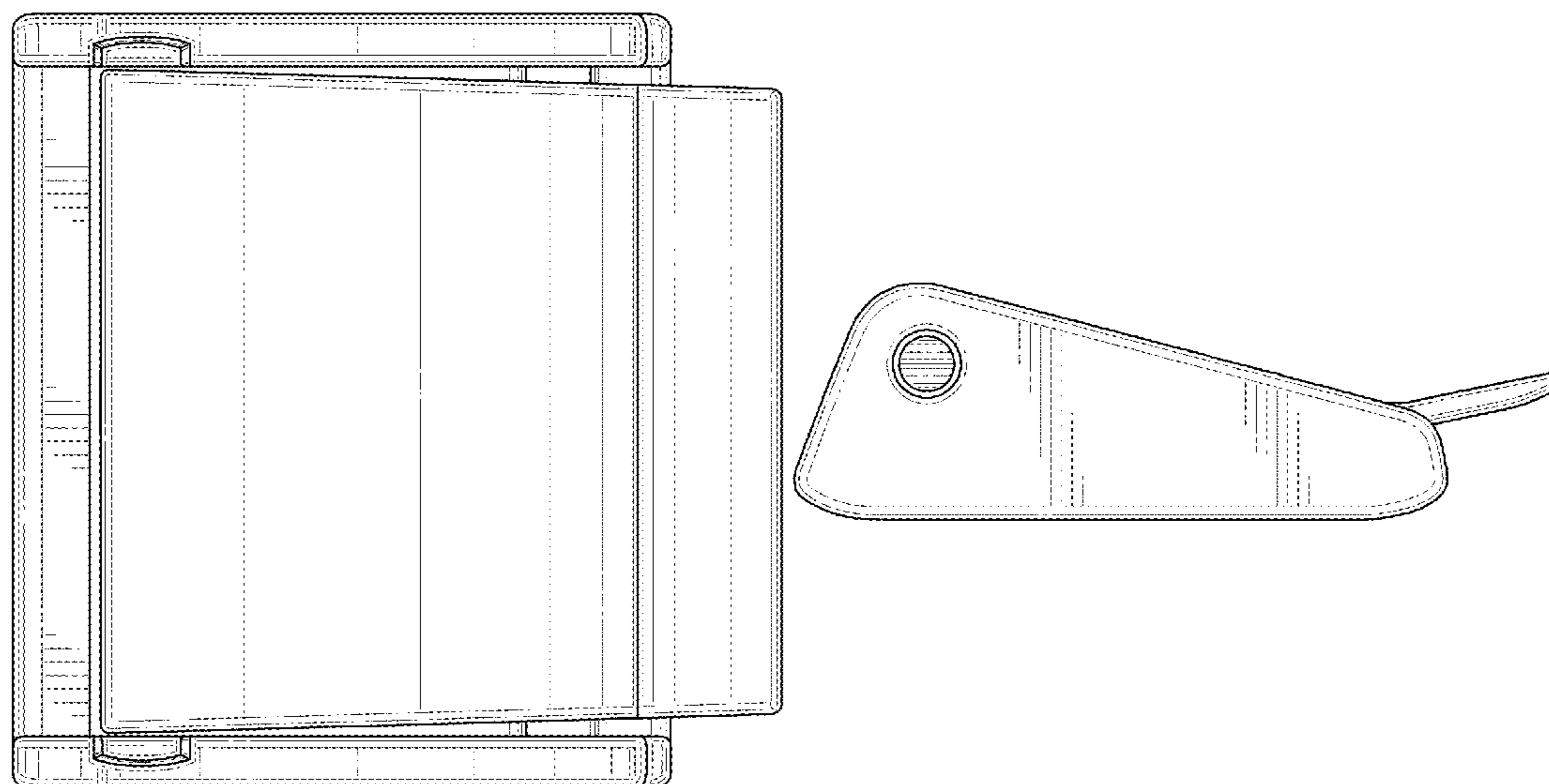
The ornamental design for a beveled buckle, as shown and described.

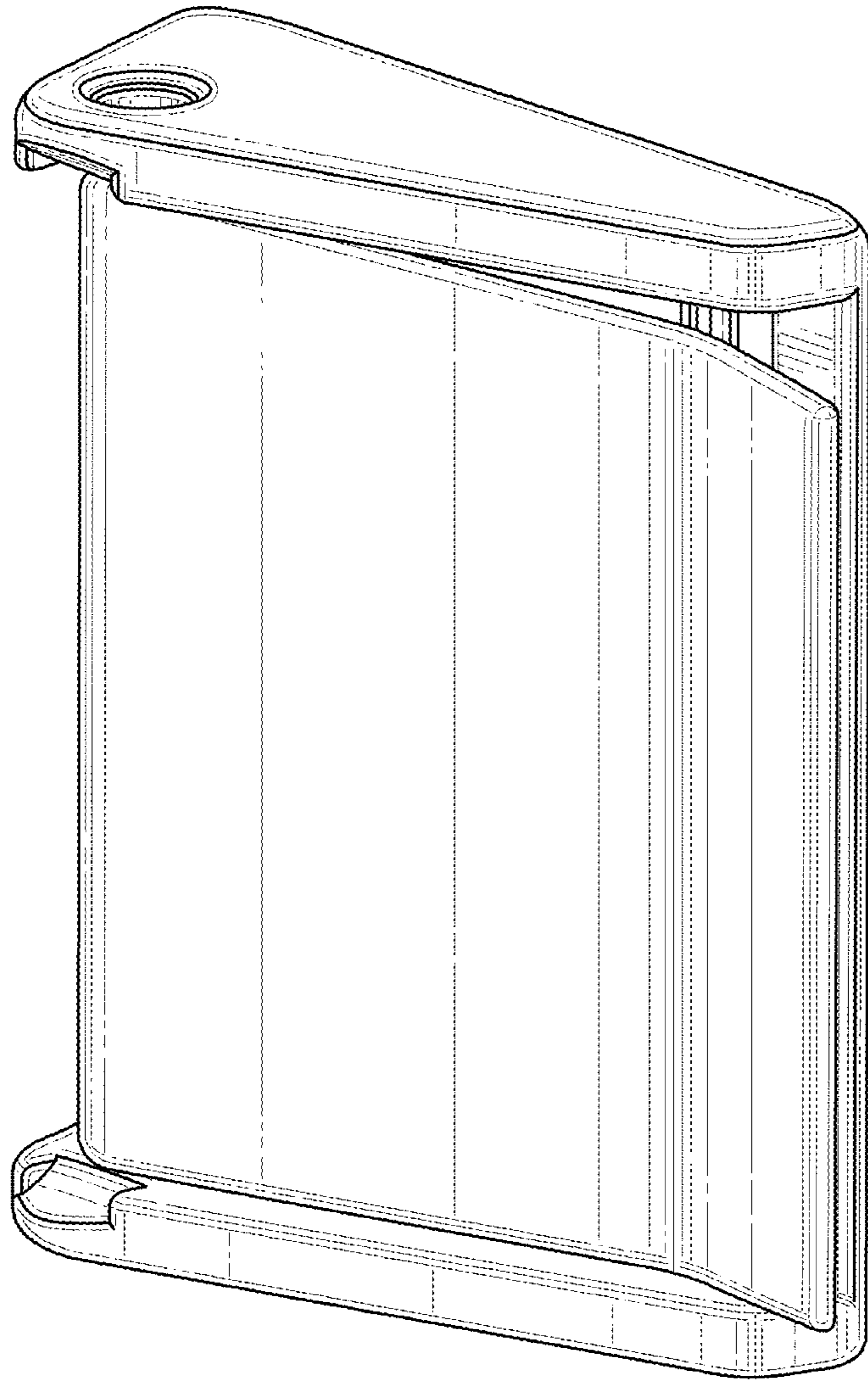

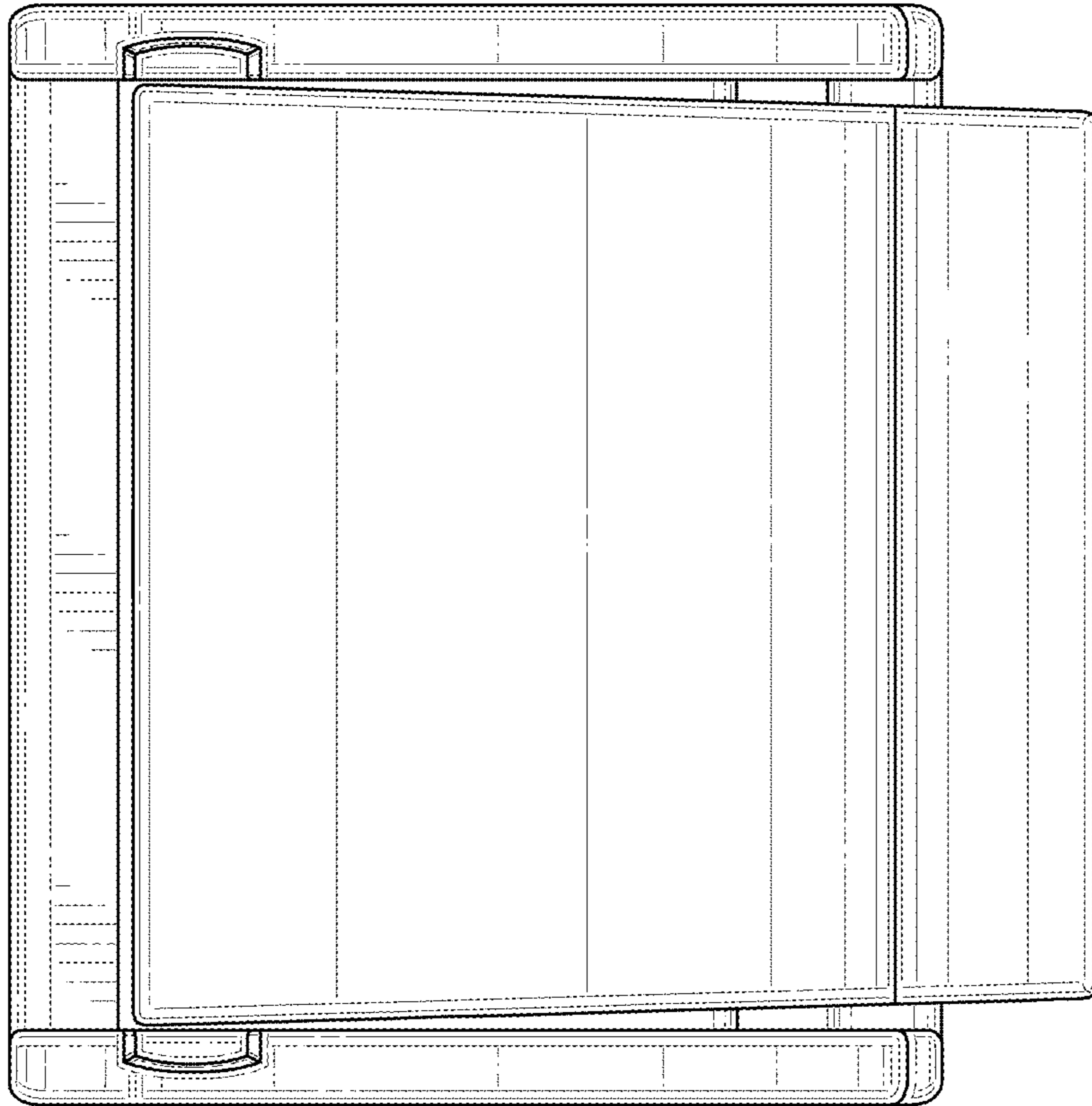

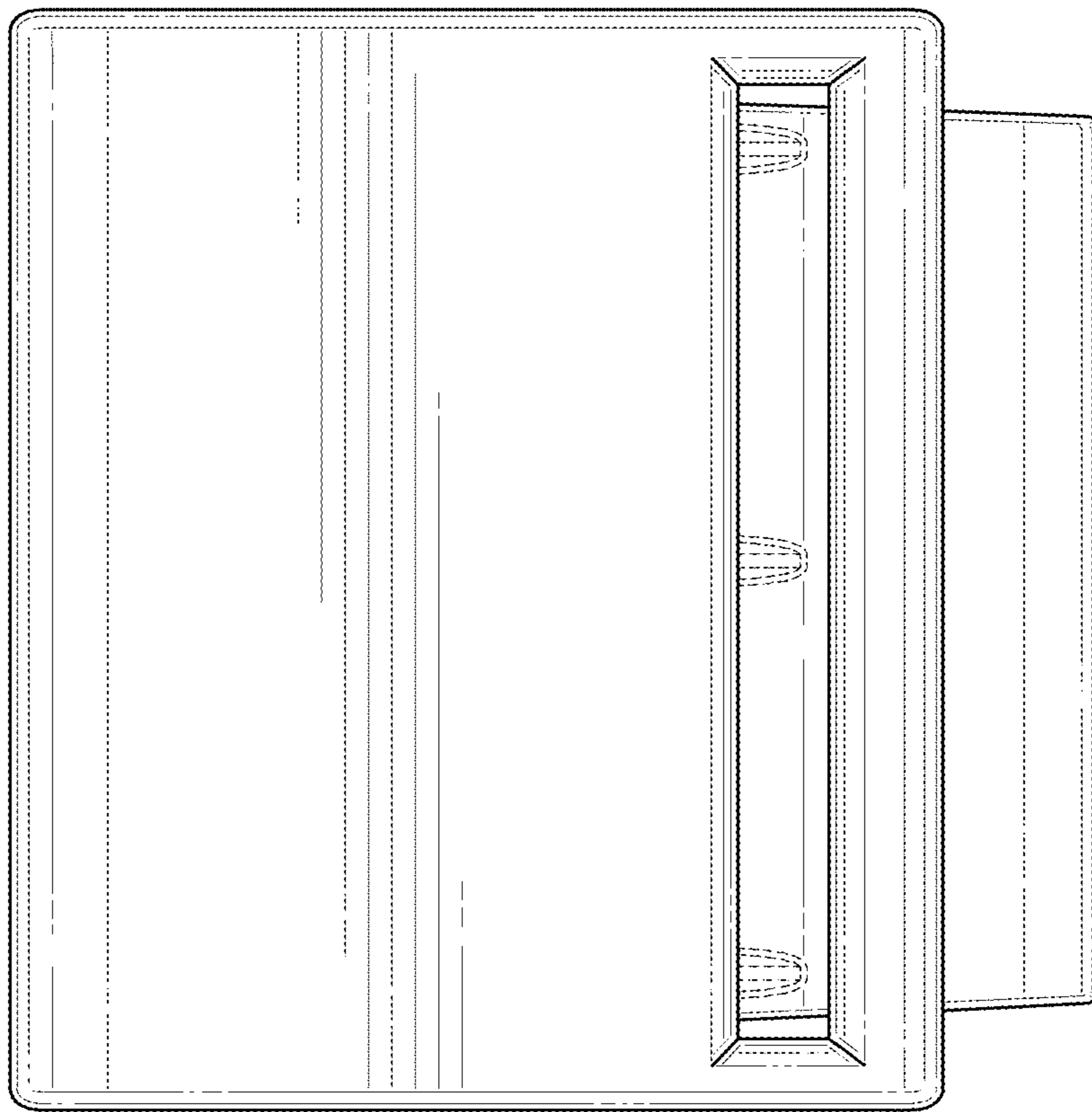
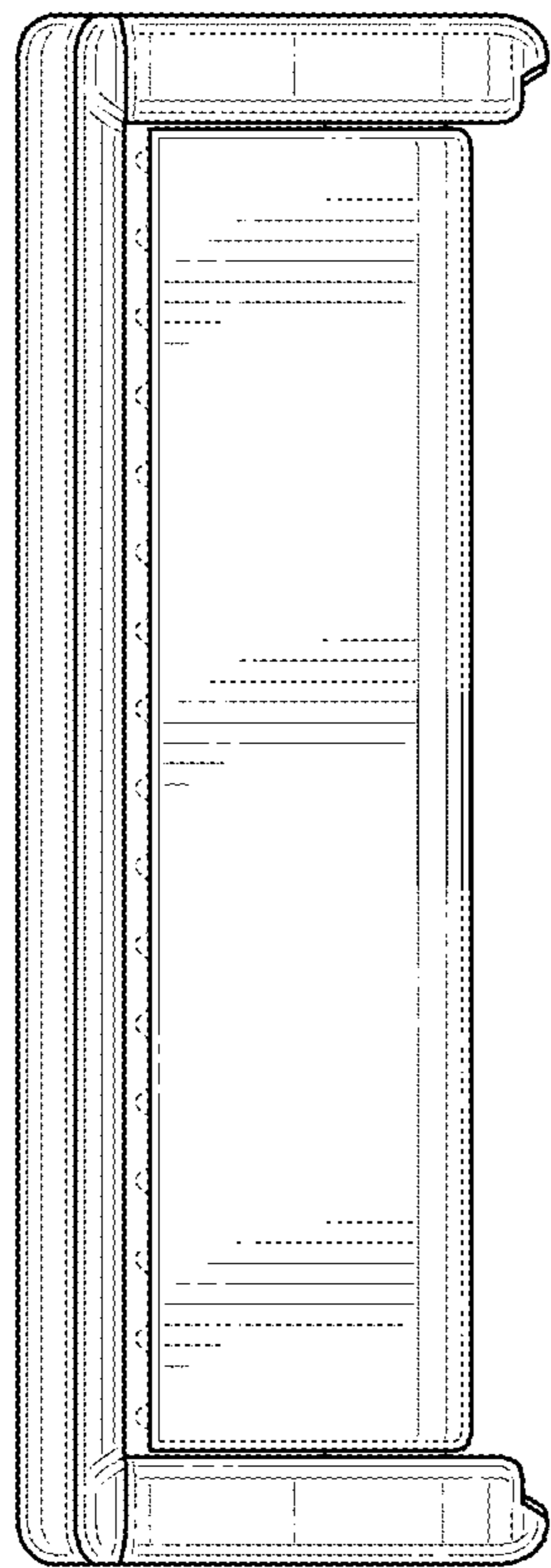
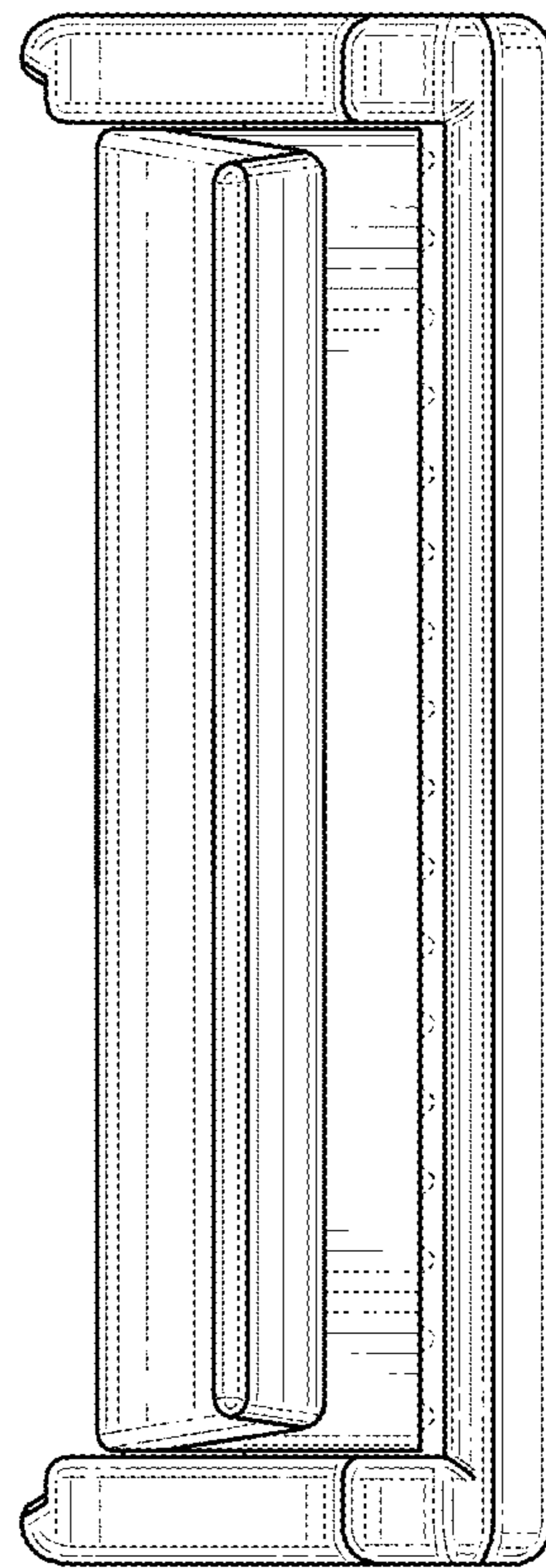


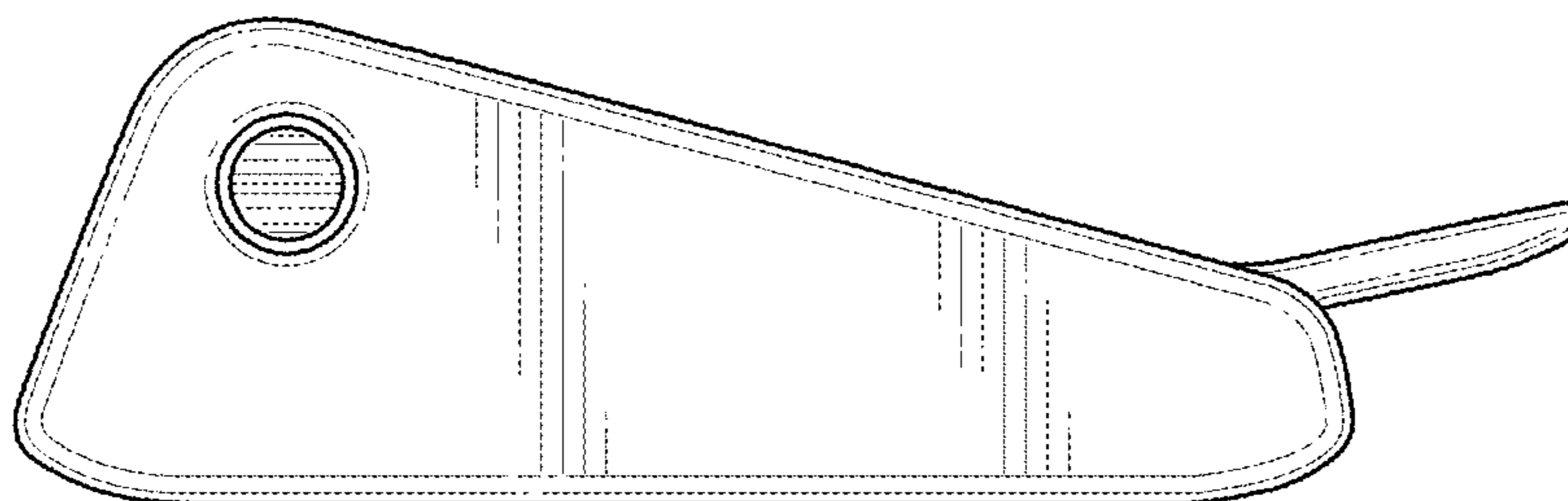

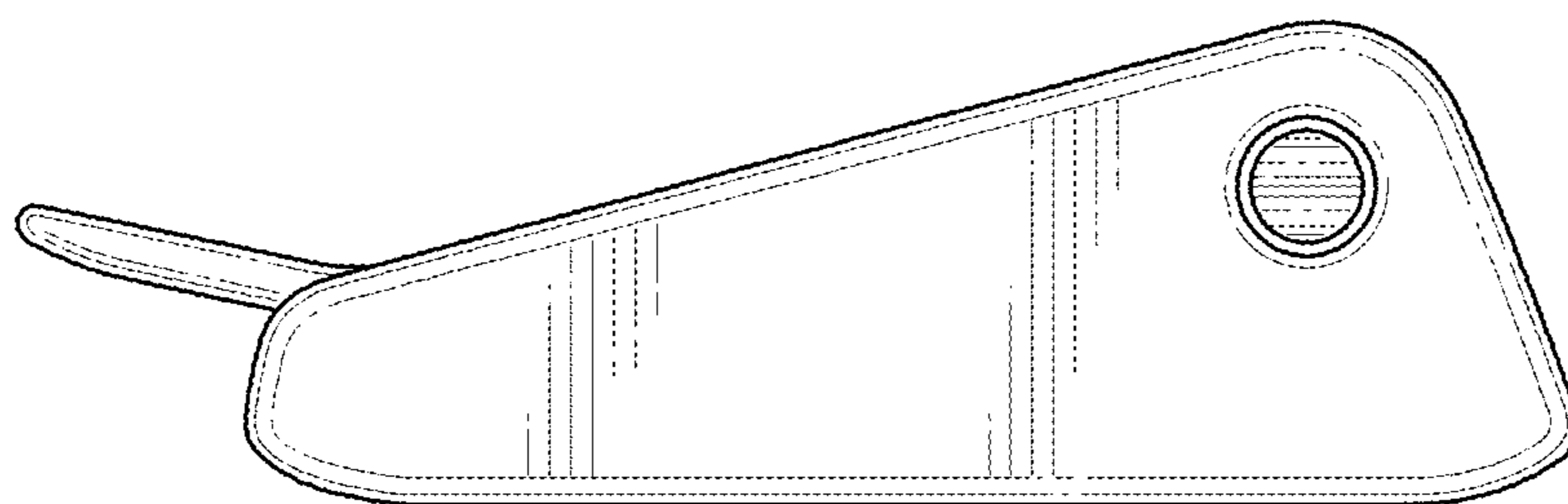
