1.2 : Top

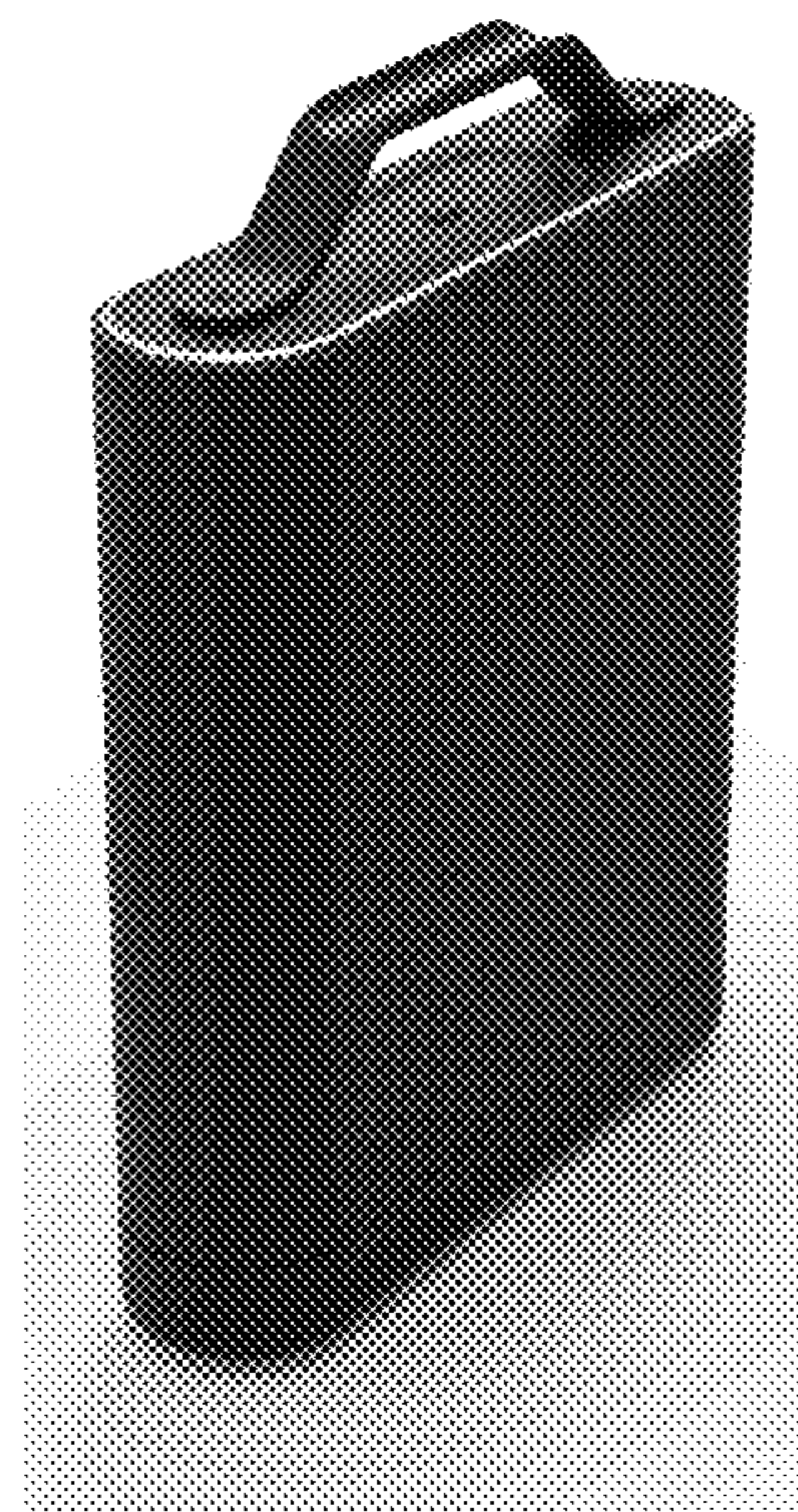
1.3 : Perspective

1.4 : Side

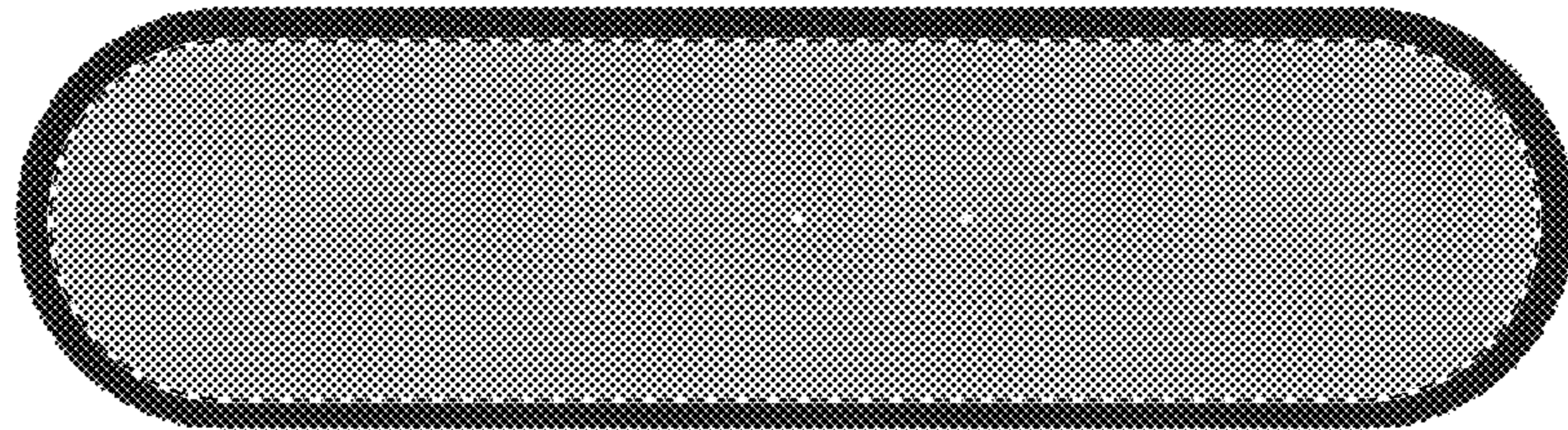
1.5 : Front

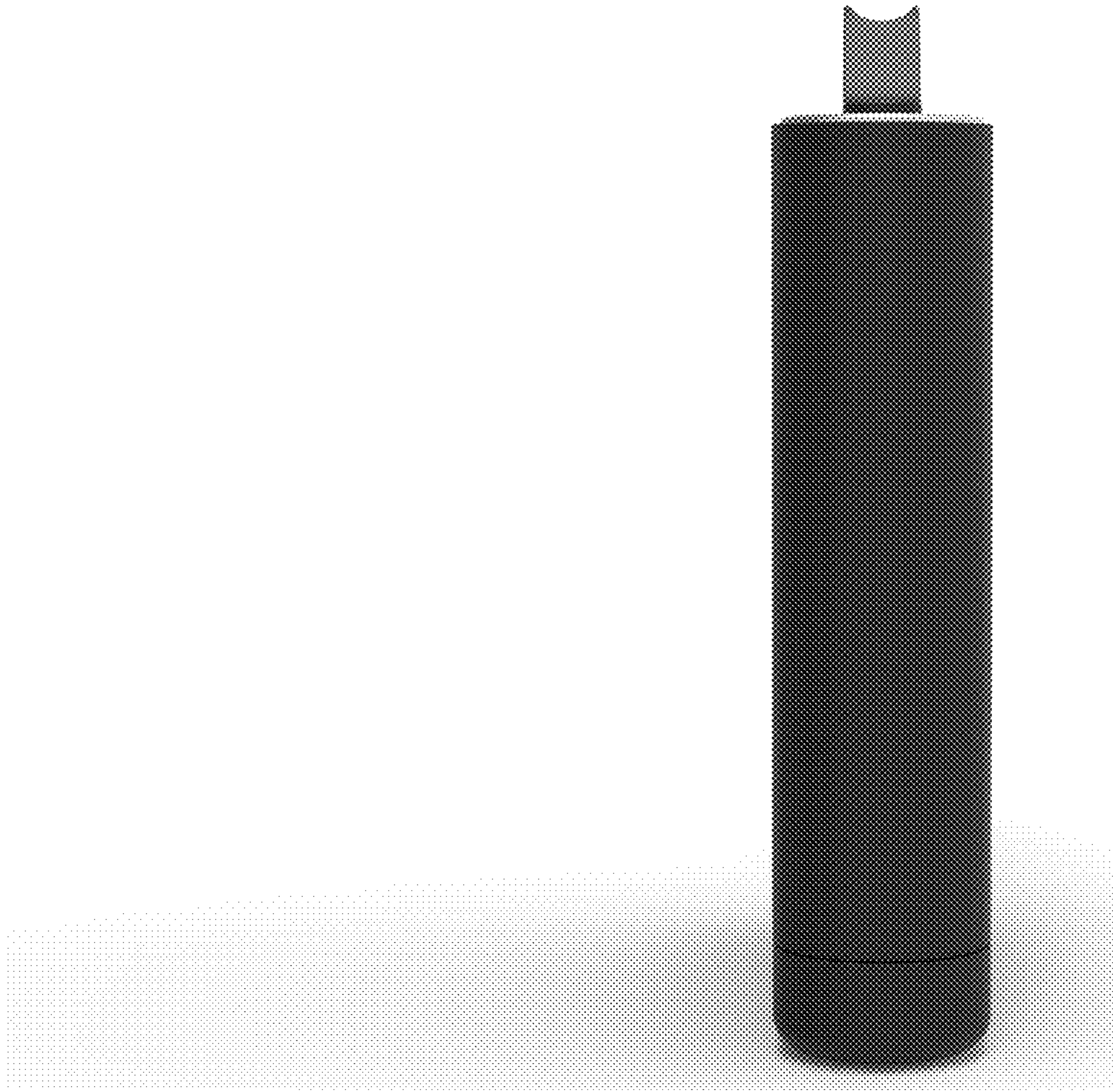
