(57) **CLAIM**

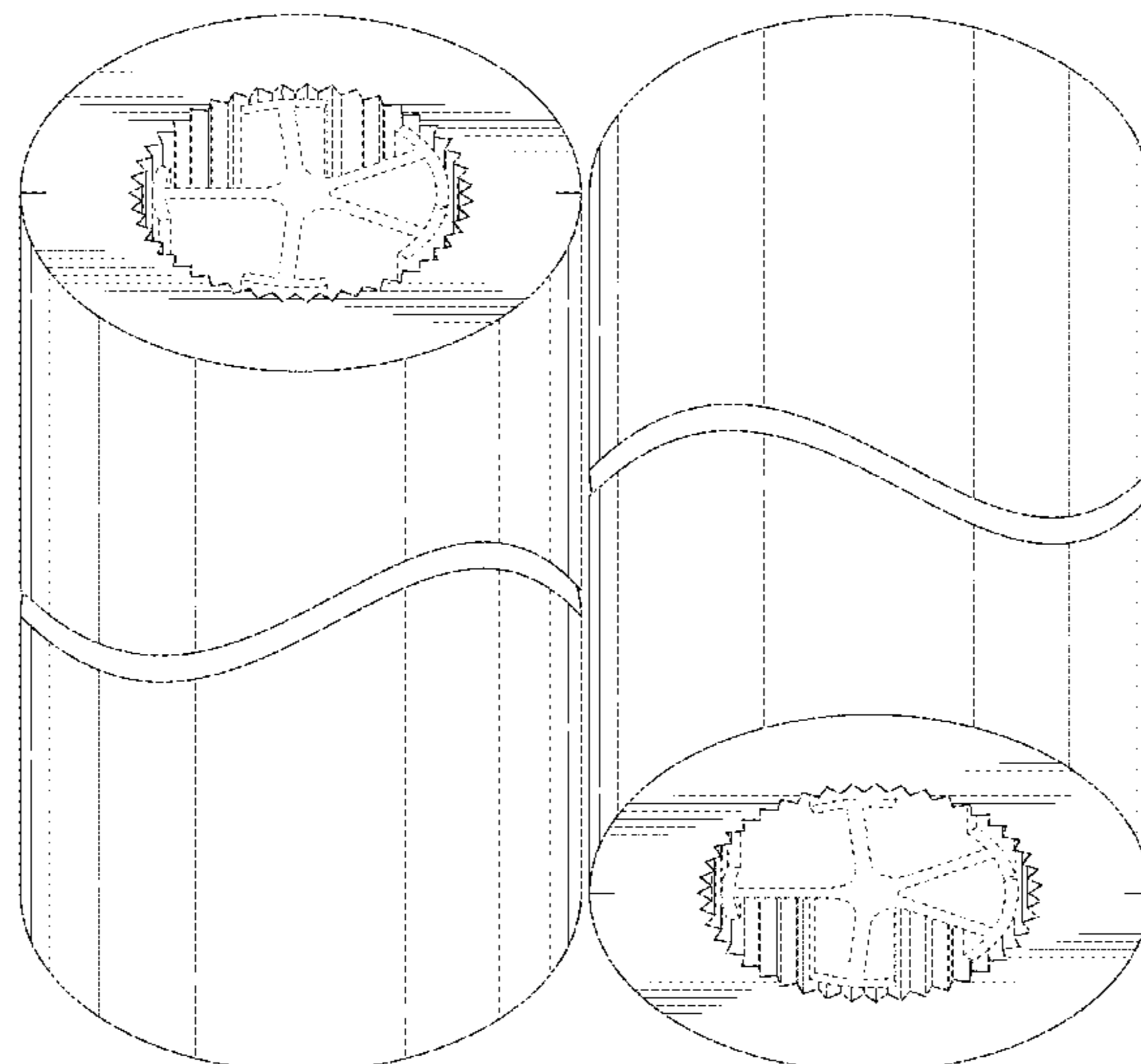
The ornamental design for a cable jacket, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cable jacket of my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left-side elevation view thereof;
FIG. 6 is a right-side elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

The broken lines in the drawings are for the purpose of illustrating environmental subject matter that forms no part of the claim. The cable jacket is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

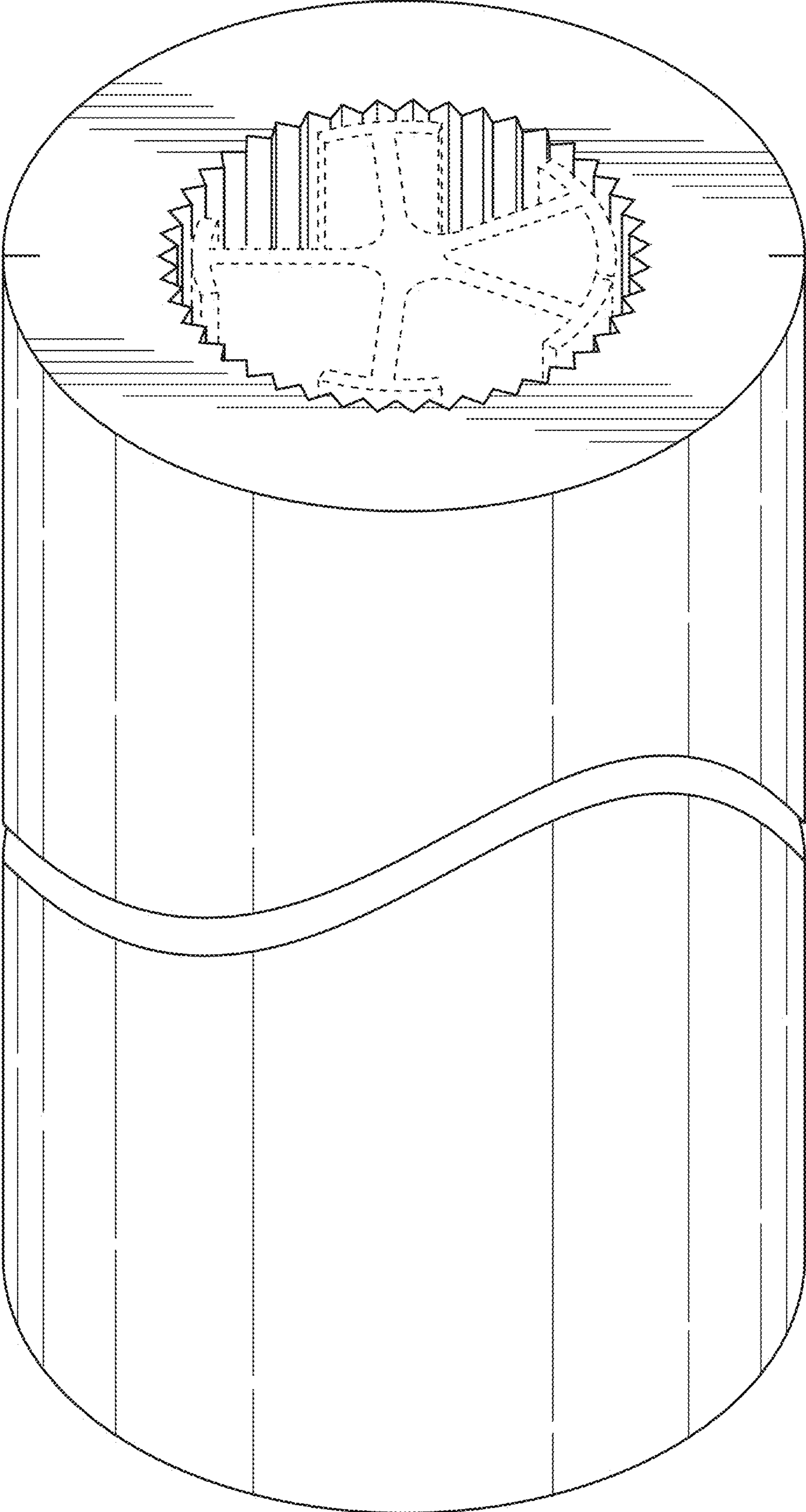

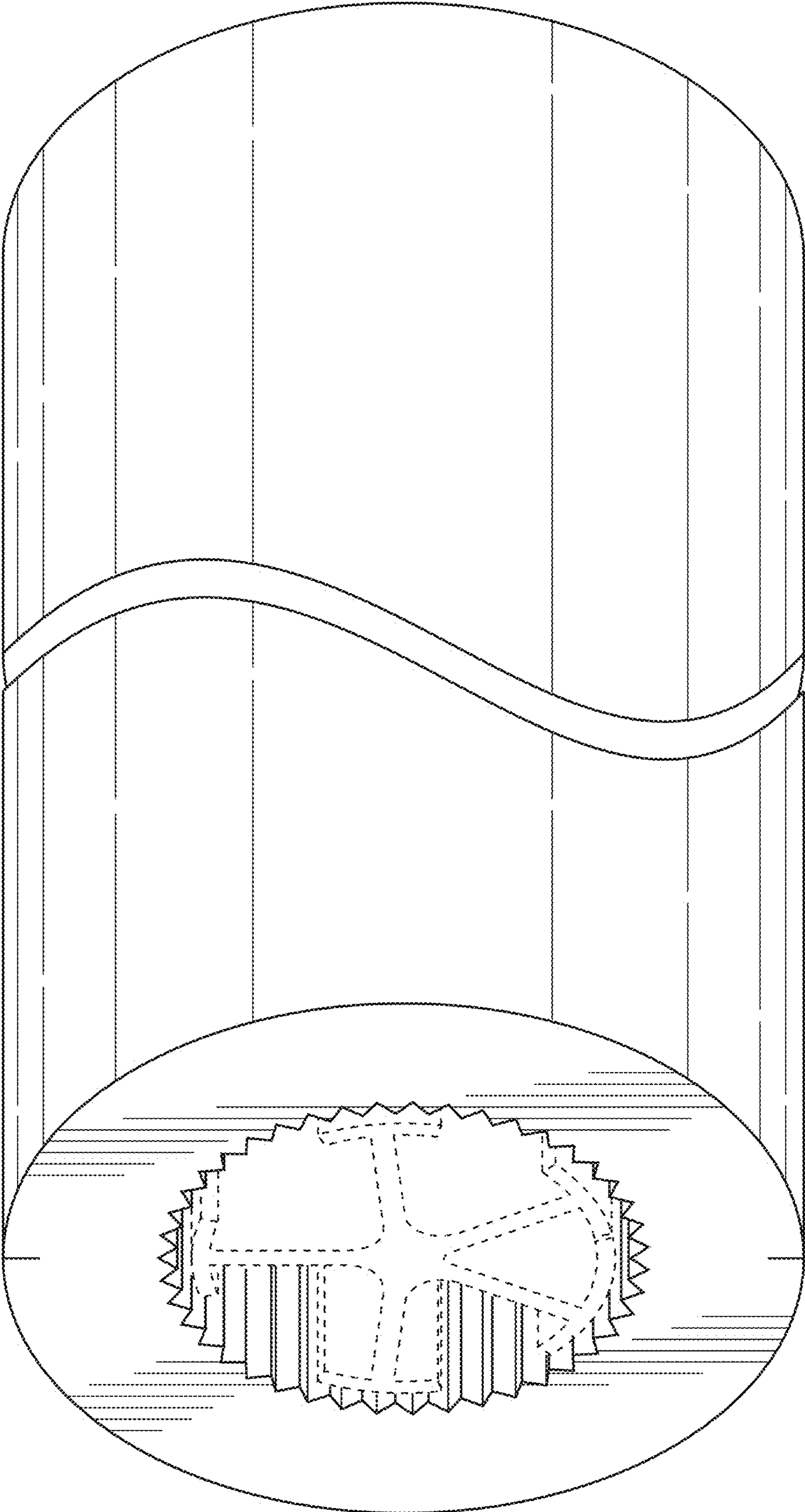

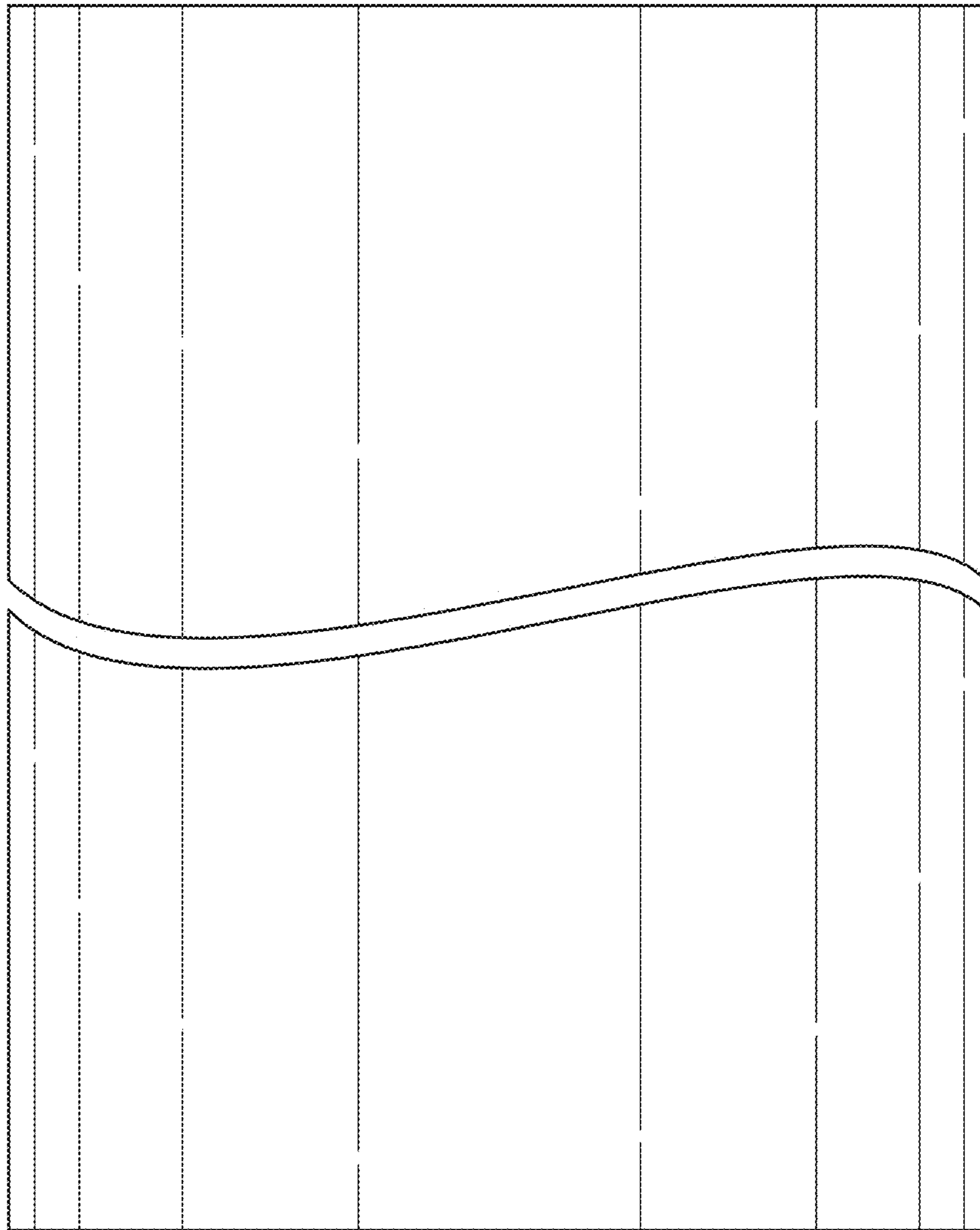

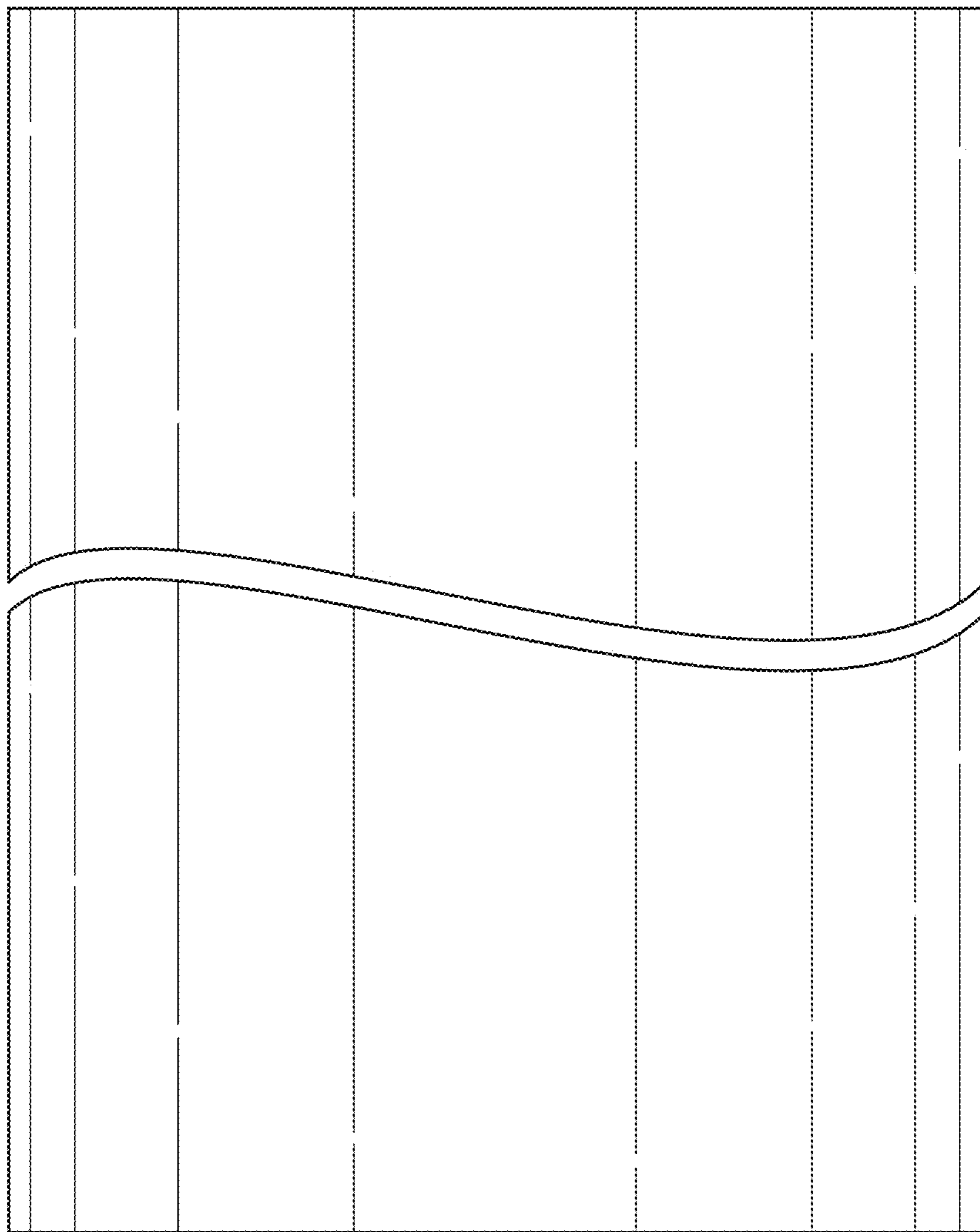

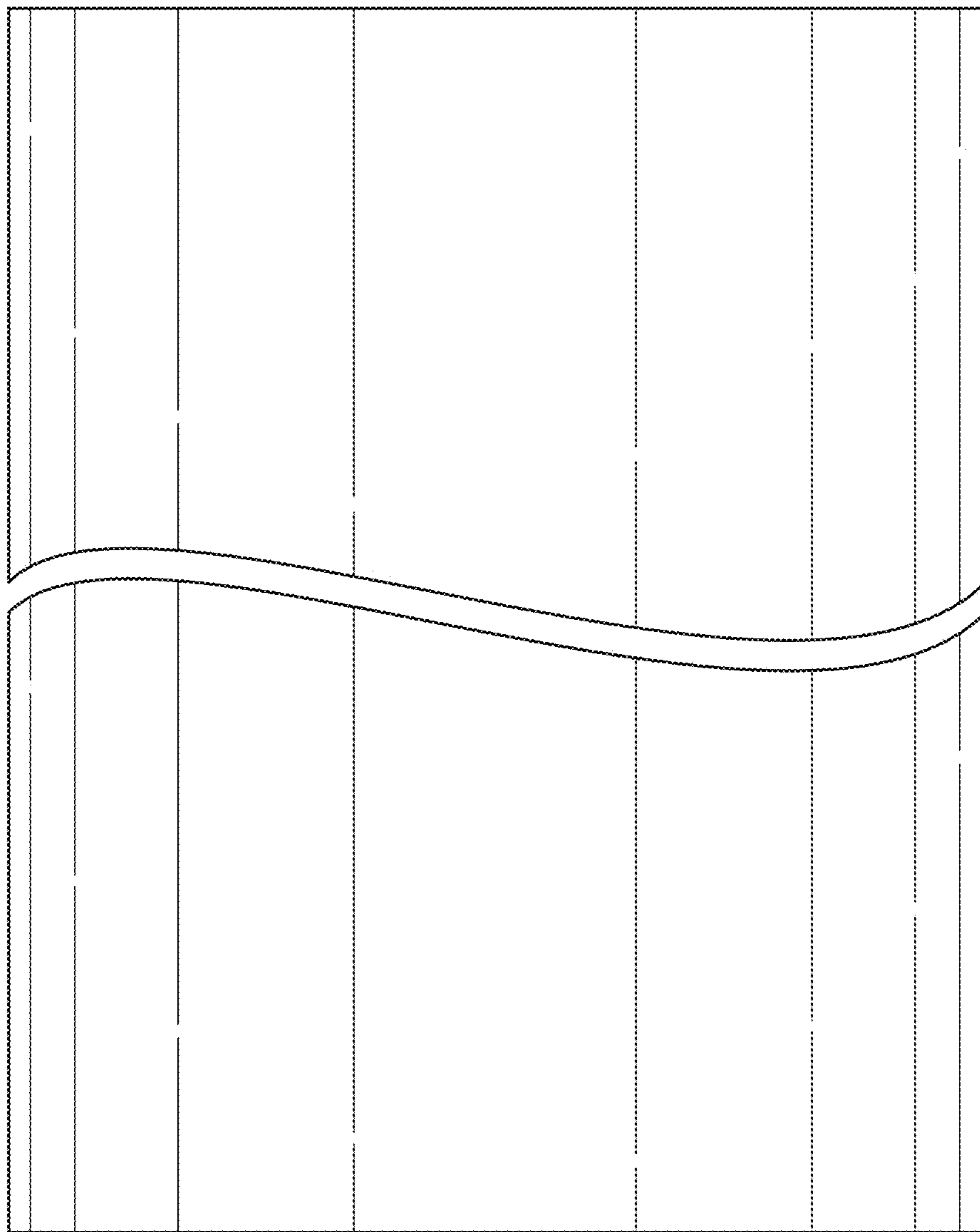

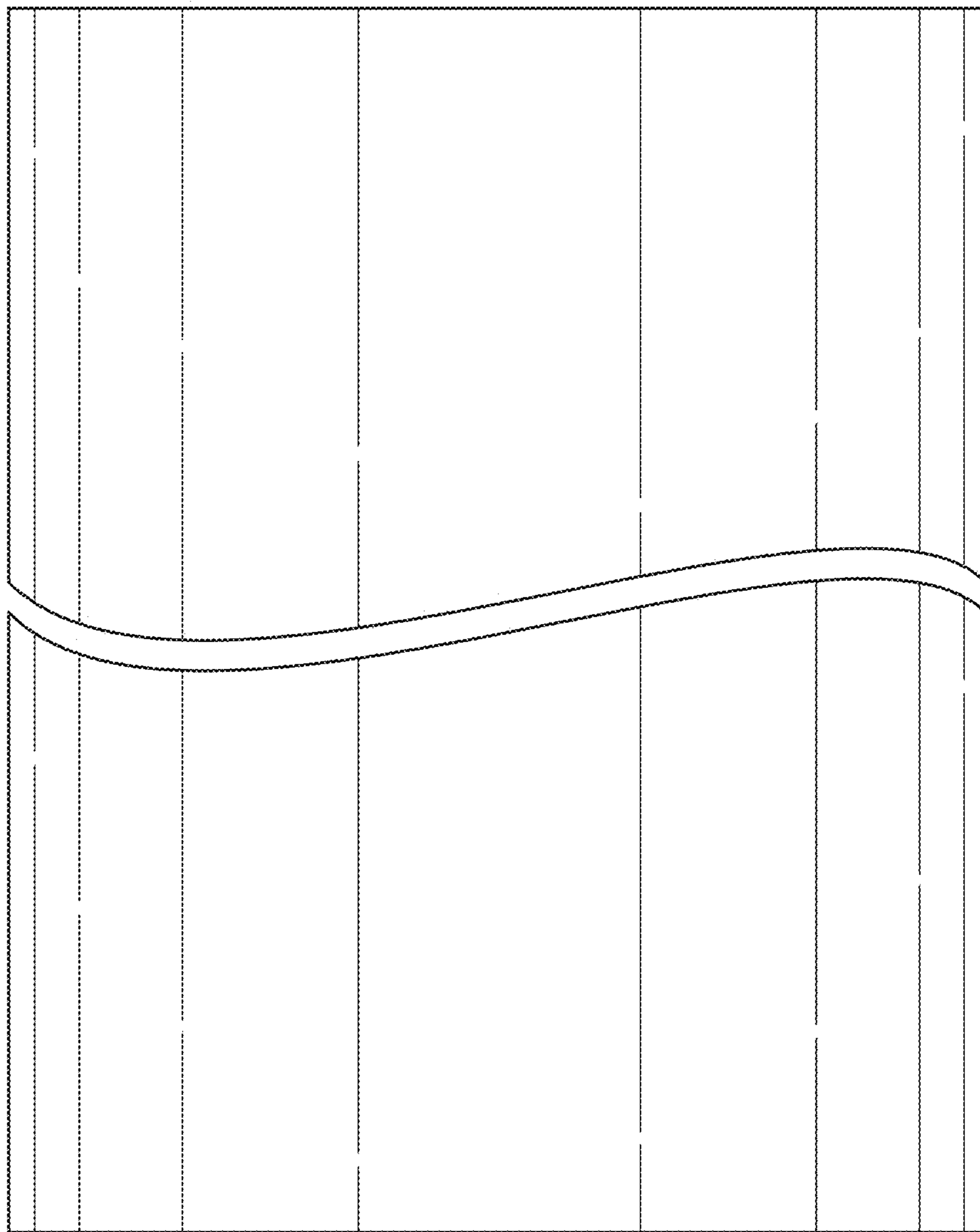

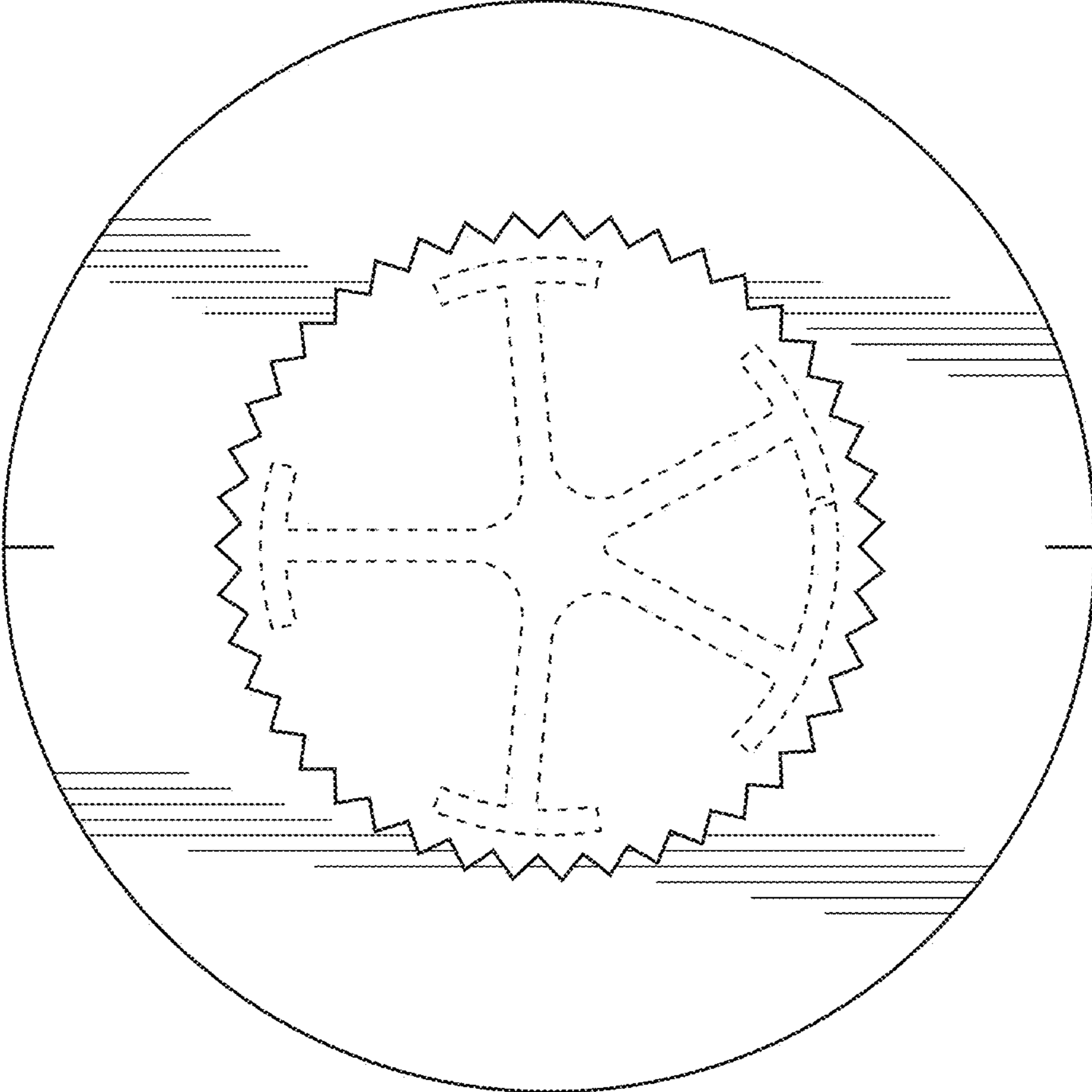

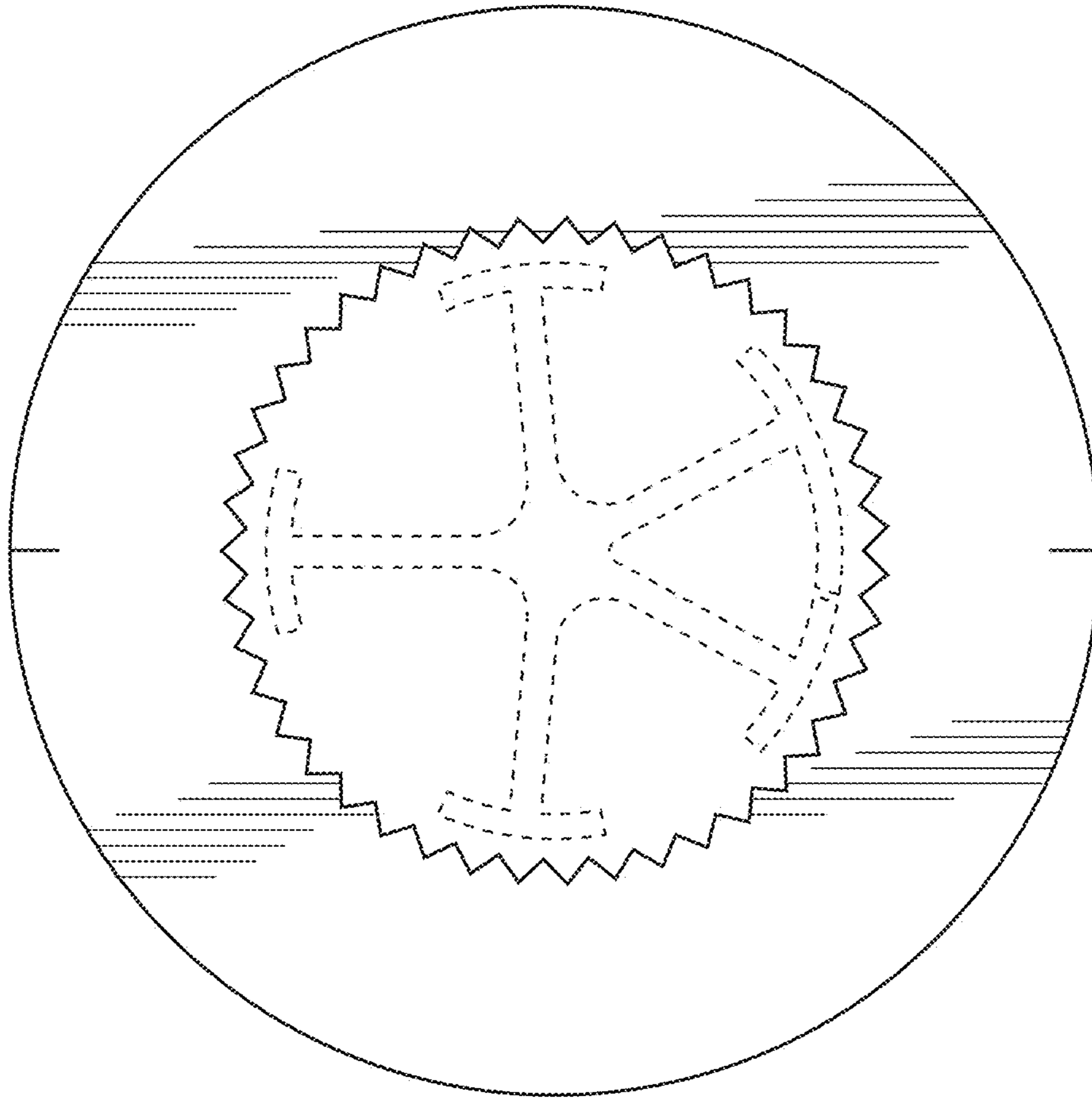
