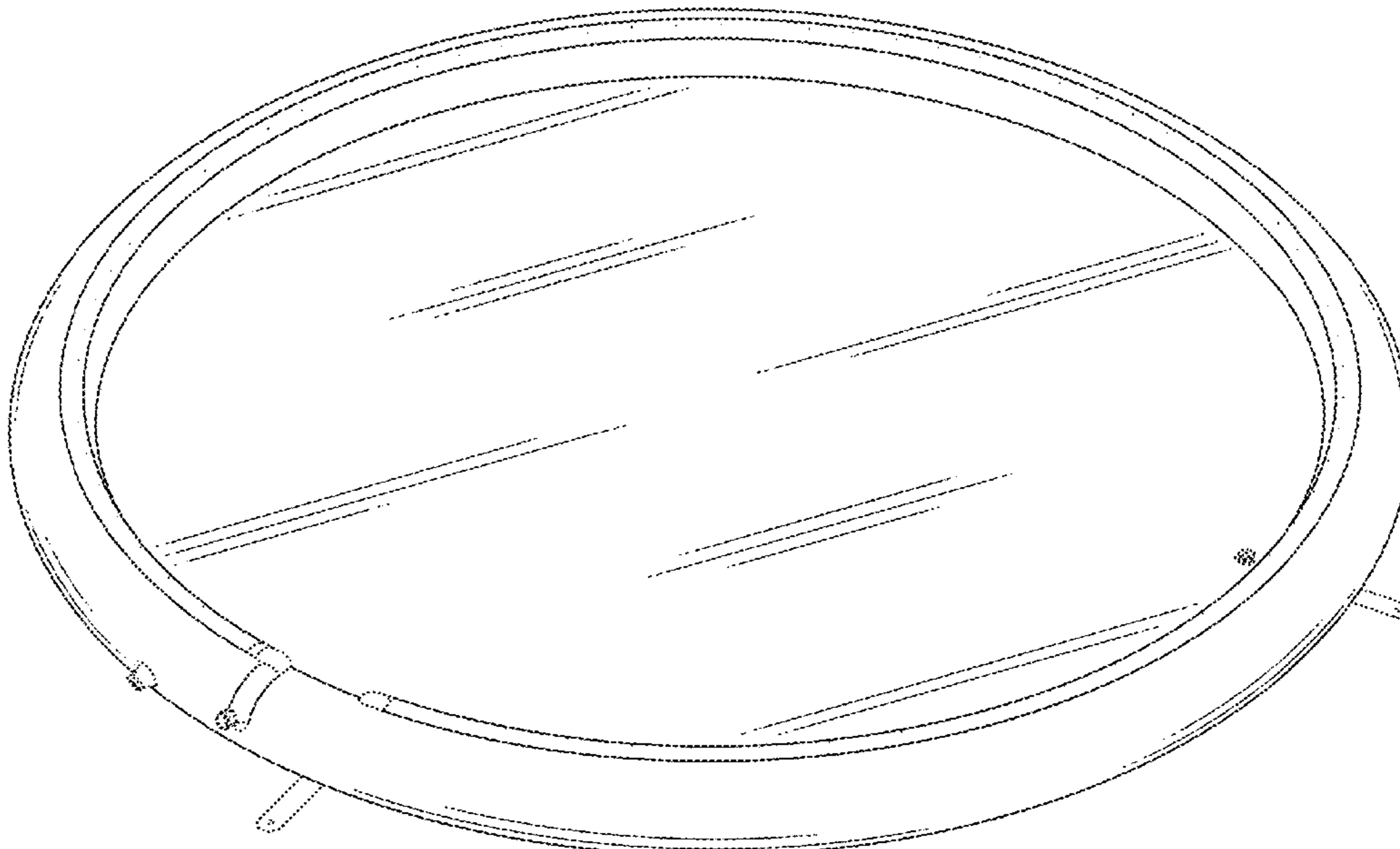
(57) **CLAIM**

The ornamental design for a recreational pad for spraying water, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a rear elevation view thereof; FIG. 8 is a partial perspective view thereof; and, FIG. 9 is a partial perspective view thereof. The broken lines showing portions of the water supply hose of FIGS. 1-9 form no part of the claimed design. The broken lines showing a water supply connector of FIGS. 1-9 form no part of the claimed design. The broken lines showing an air valve of FIGS. 1-9 form no part of the claimed design. The broken lines showing straps of FIGS. 1-9 form no part of the claimed design. The broken lines showing a drain of FIGS. 1-9 form no part of the claimed design.

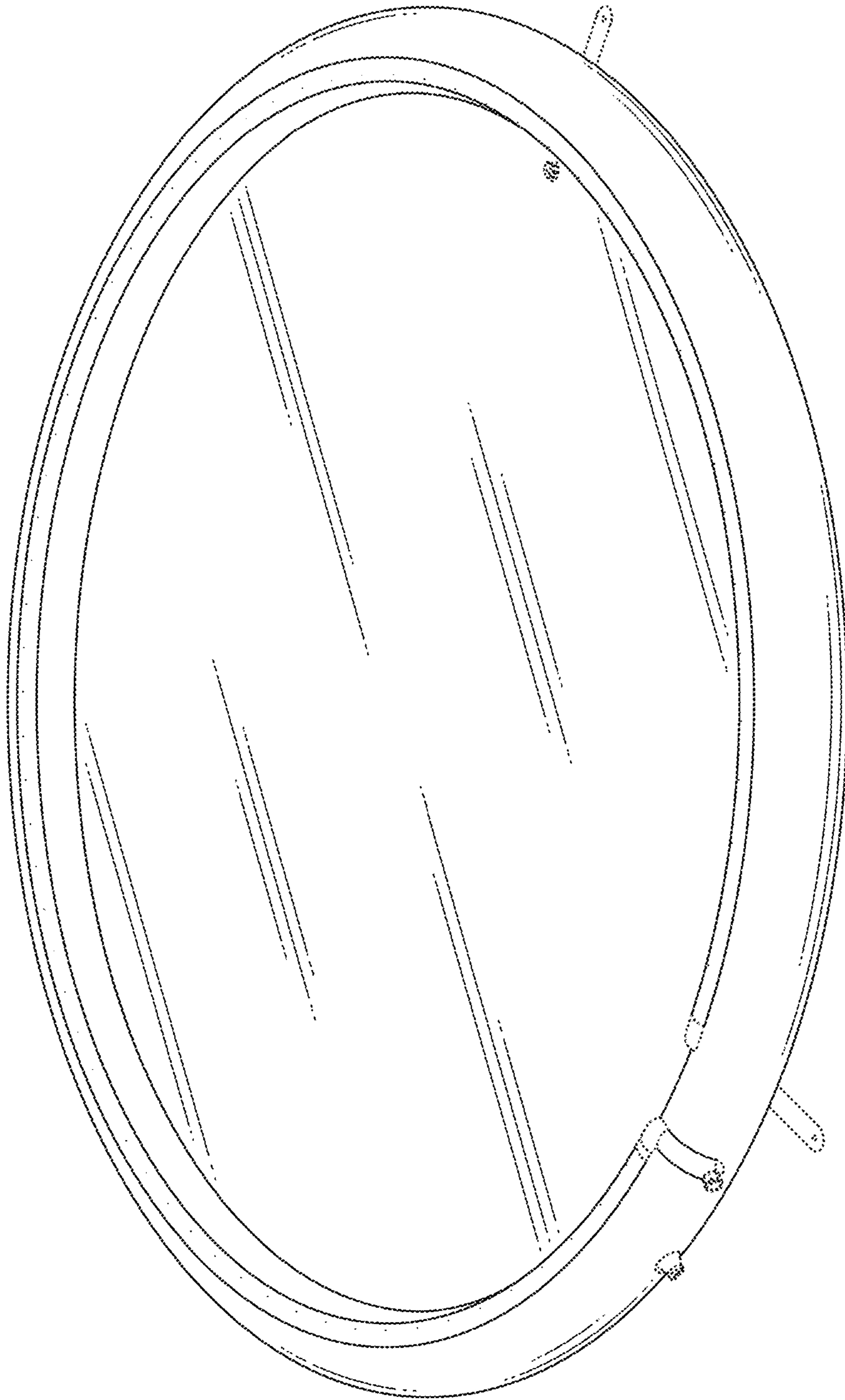

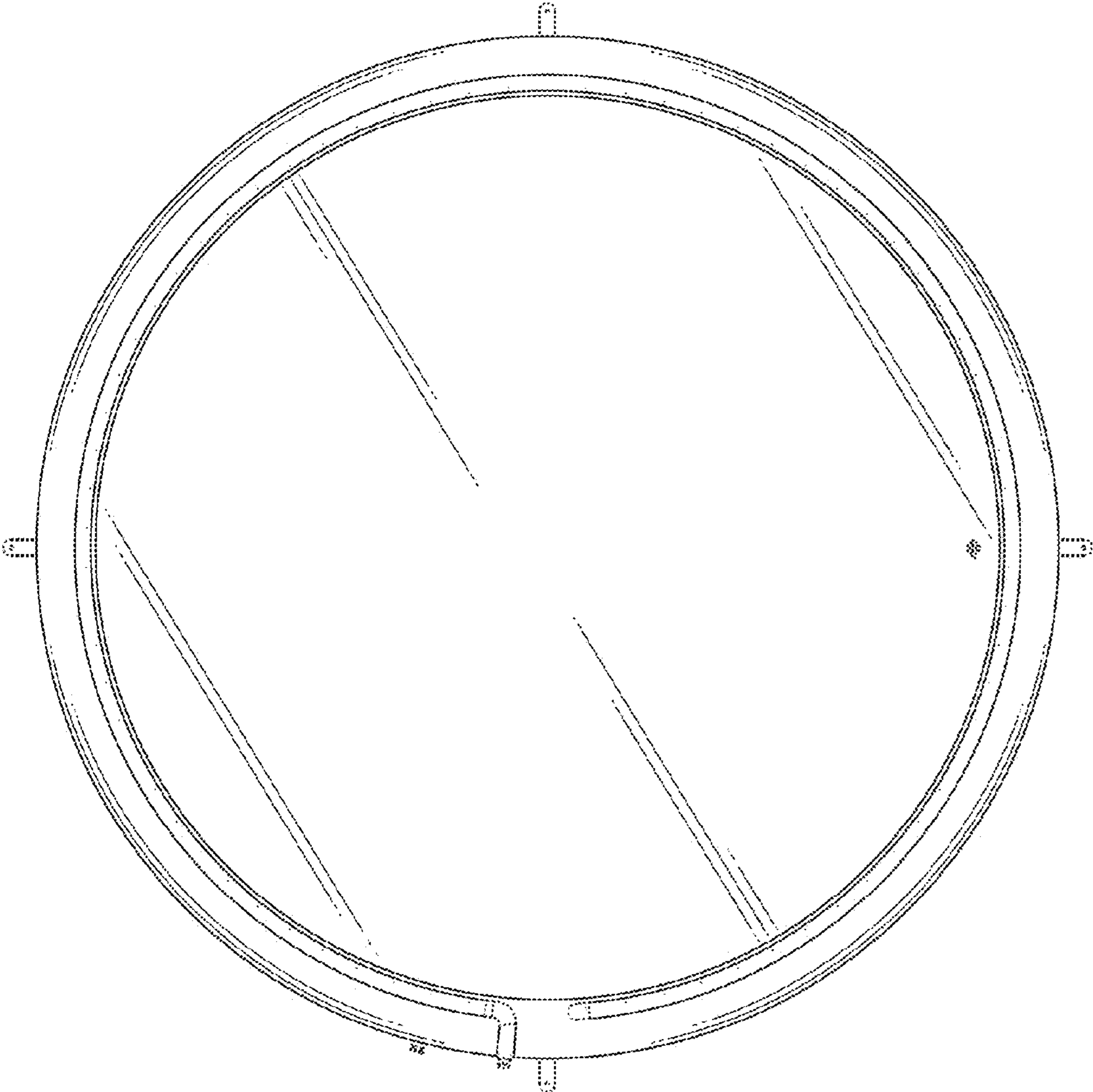

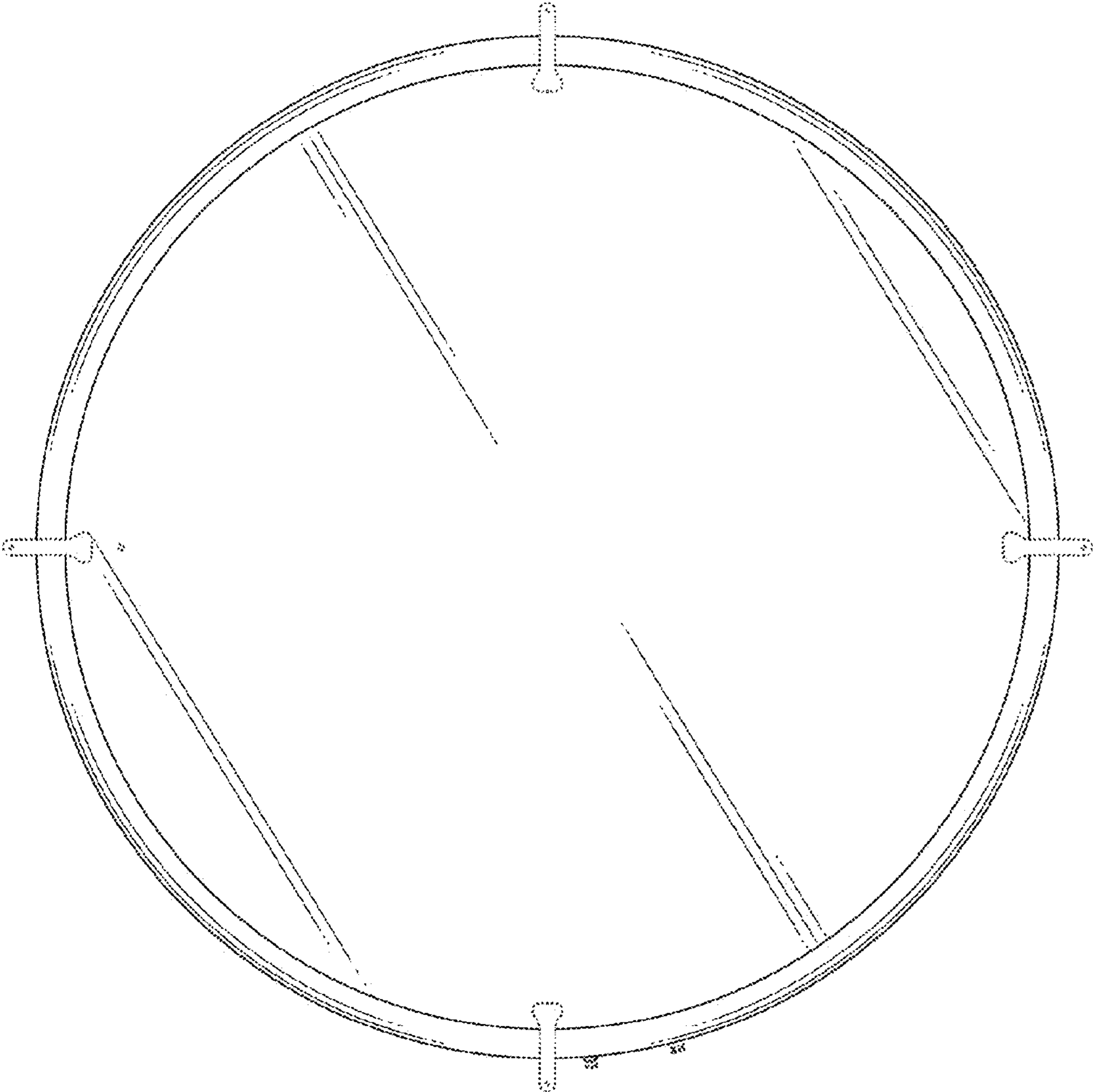

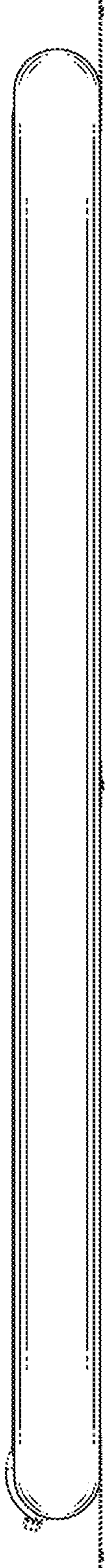

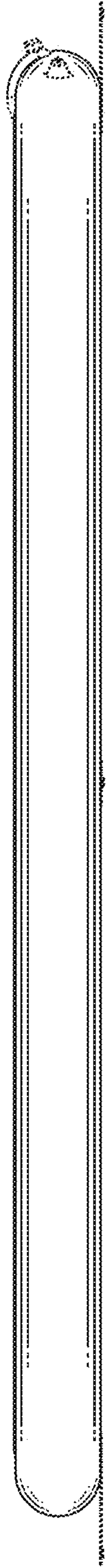

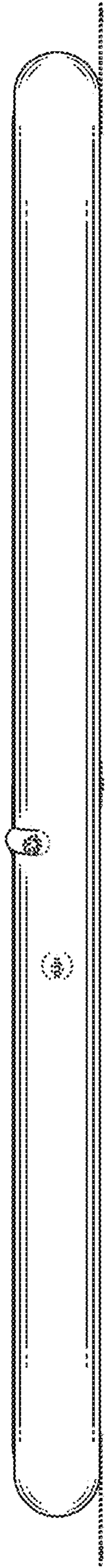

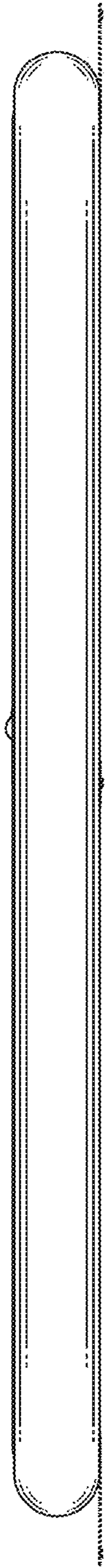

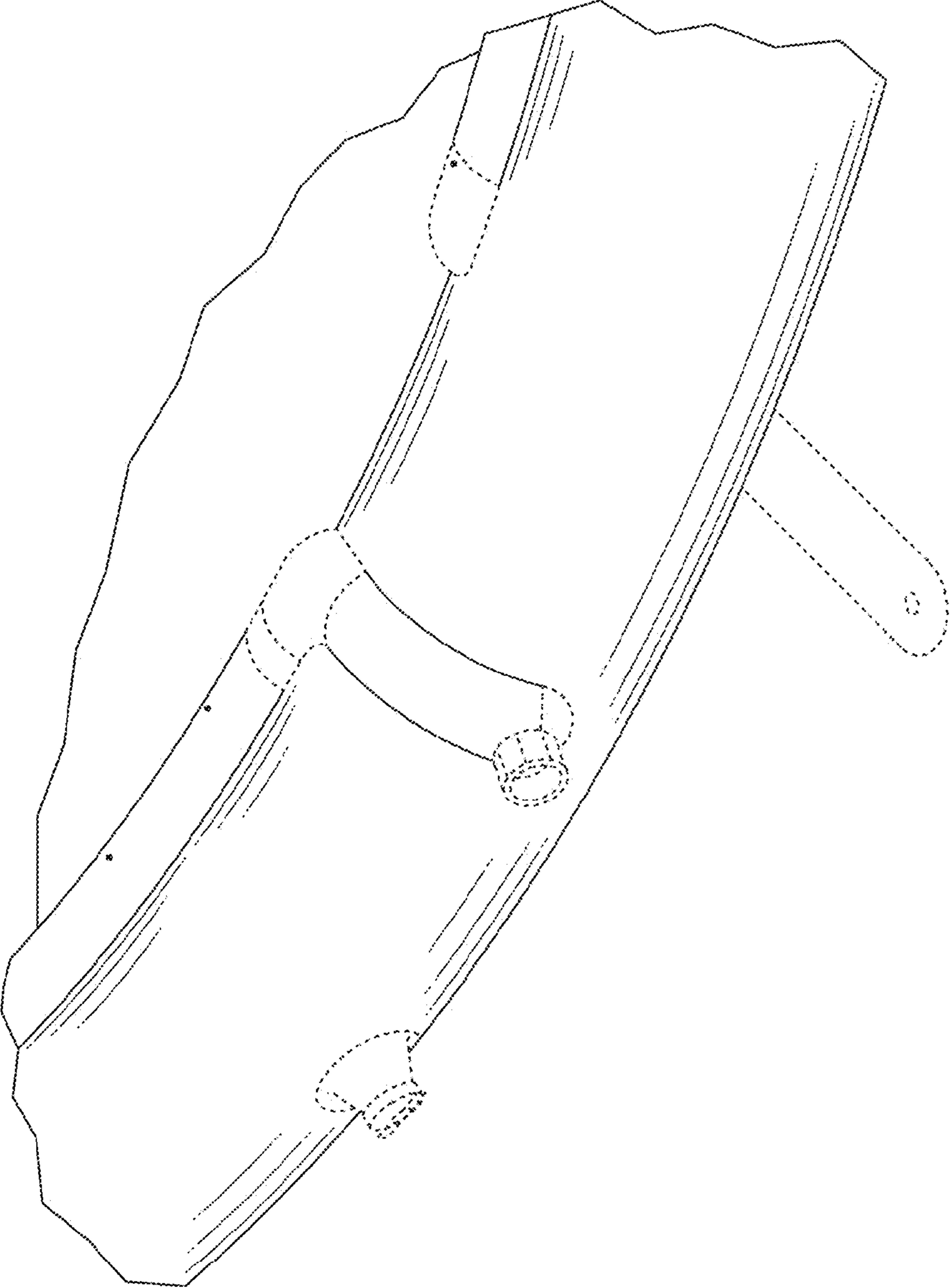

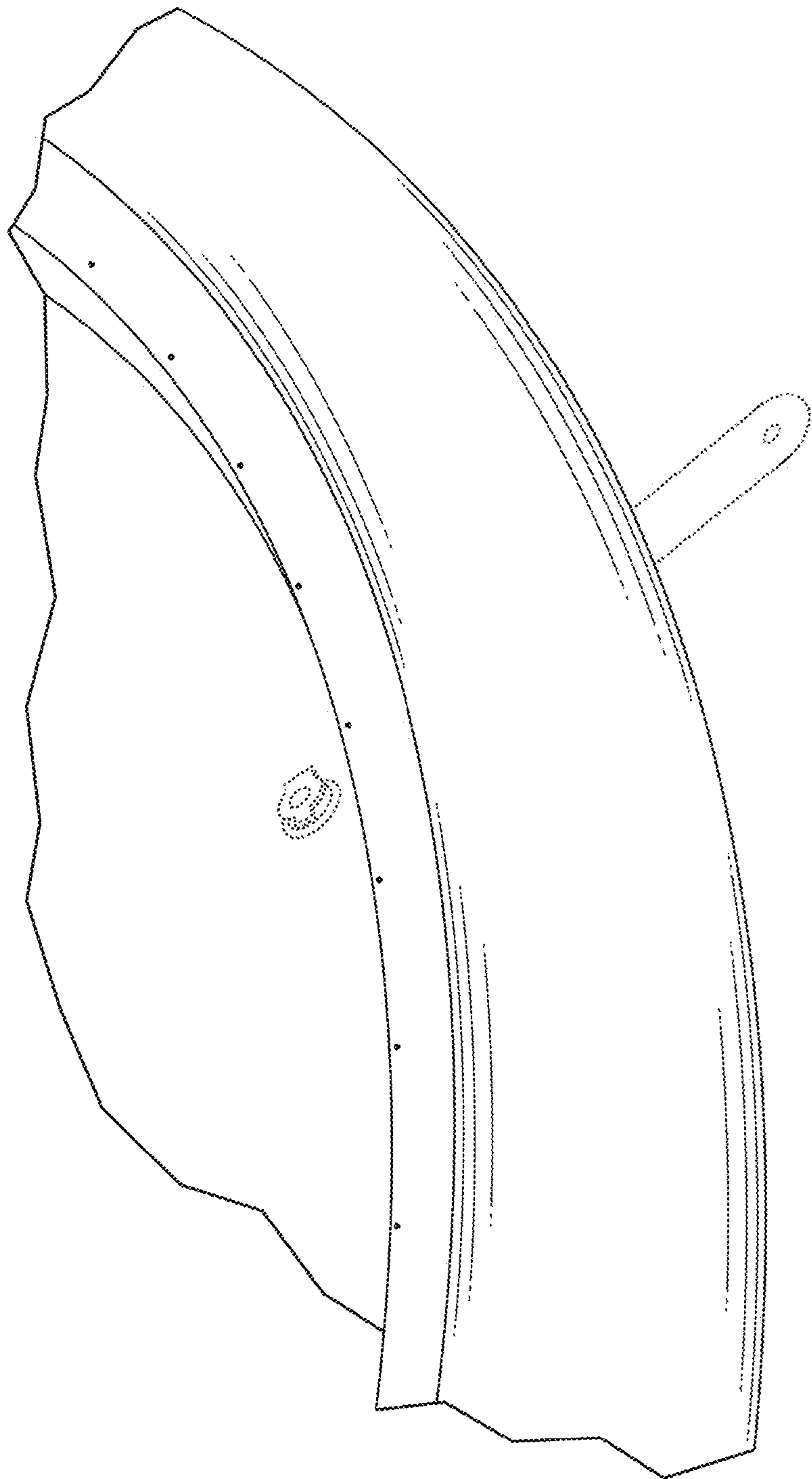
