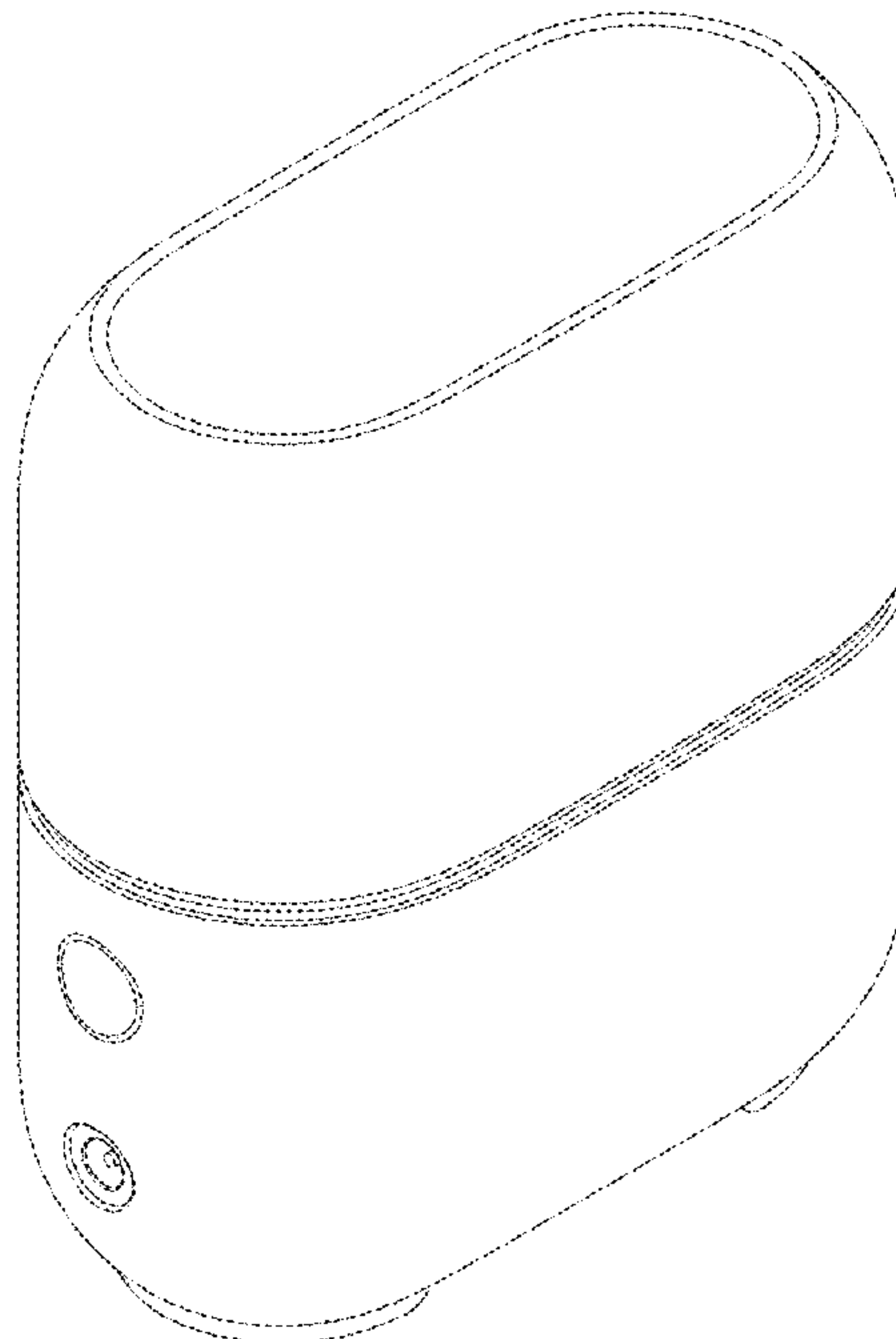

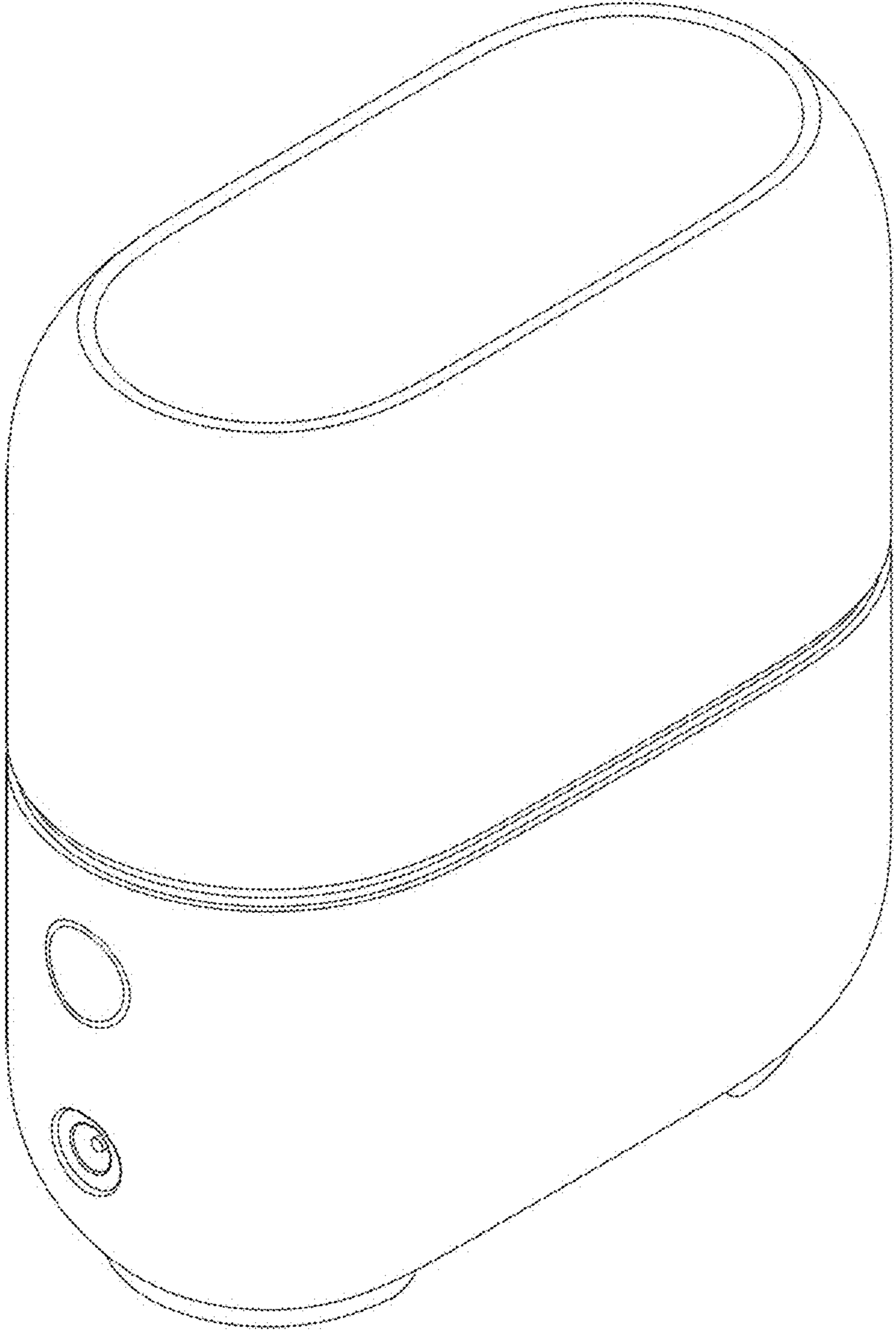
The broken lines in the drawings illustrate portions of the air humidifier that form no part of the claimed design.

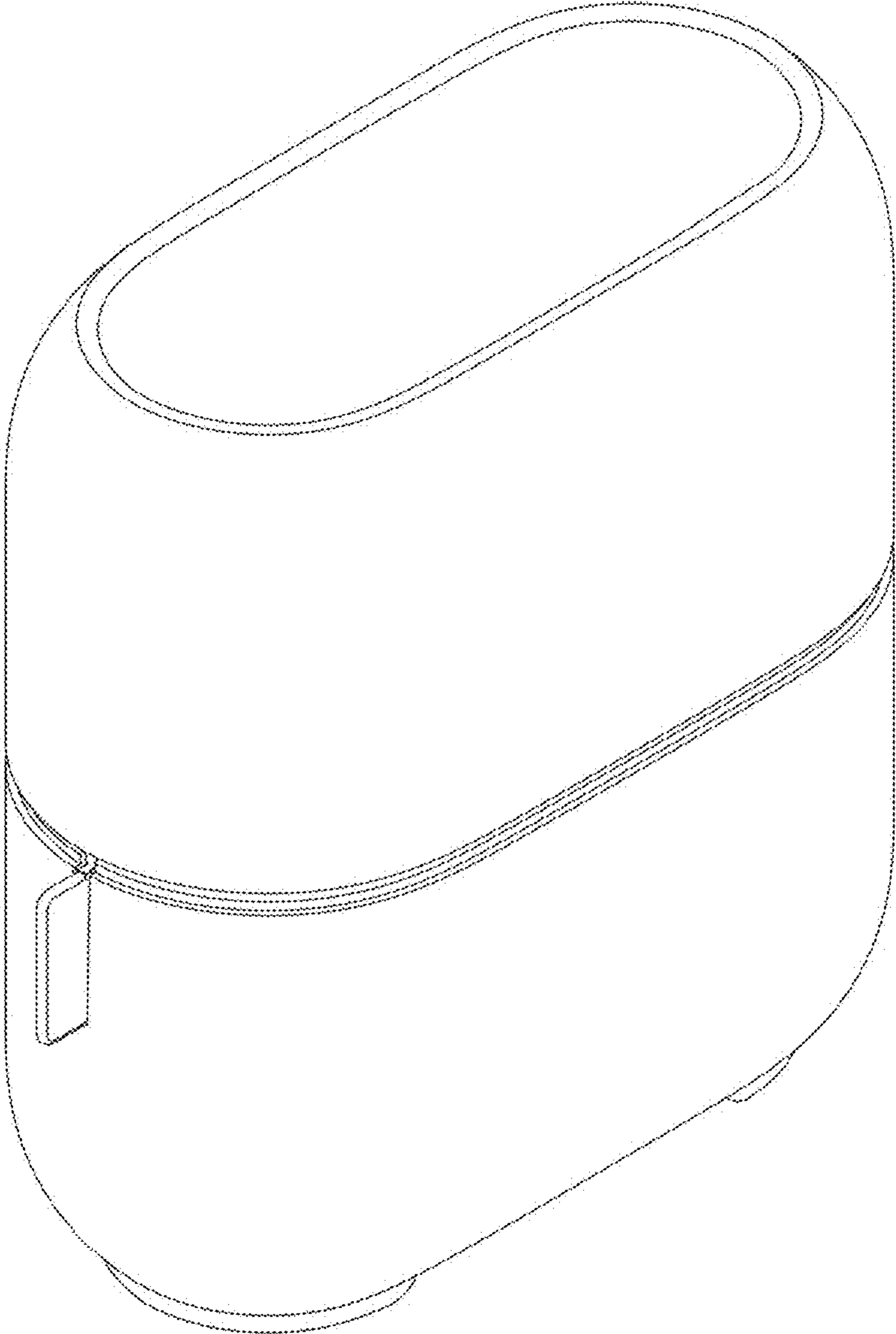

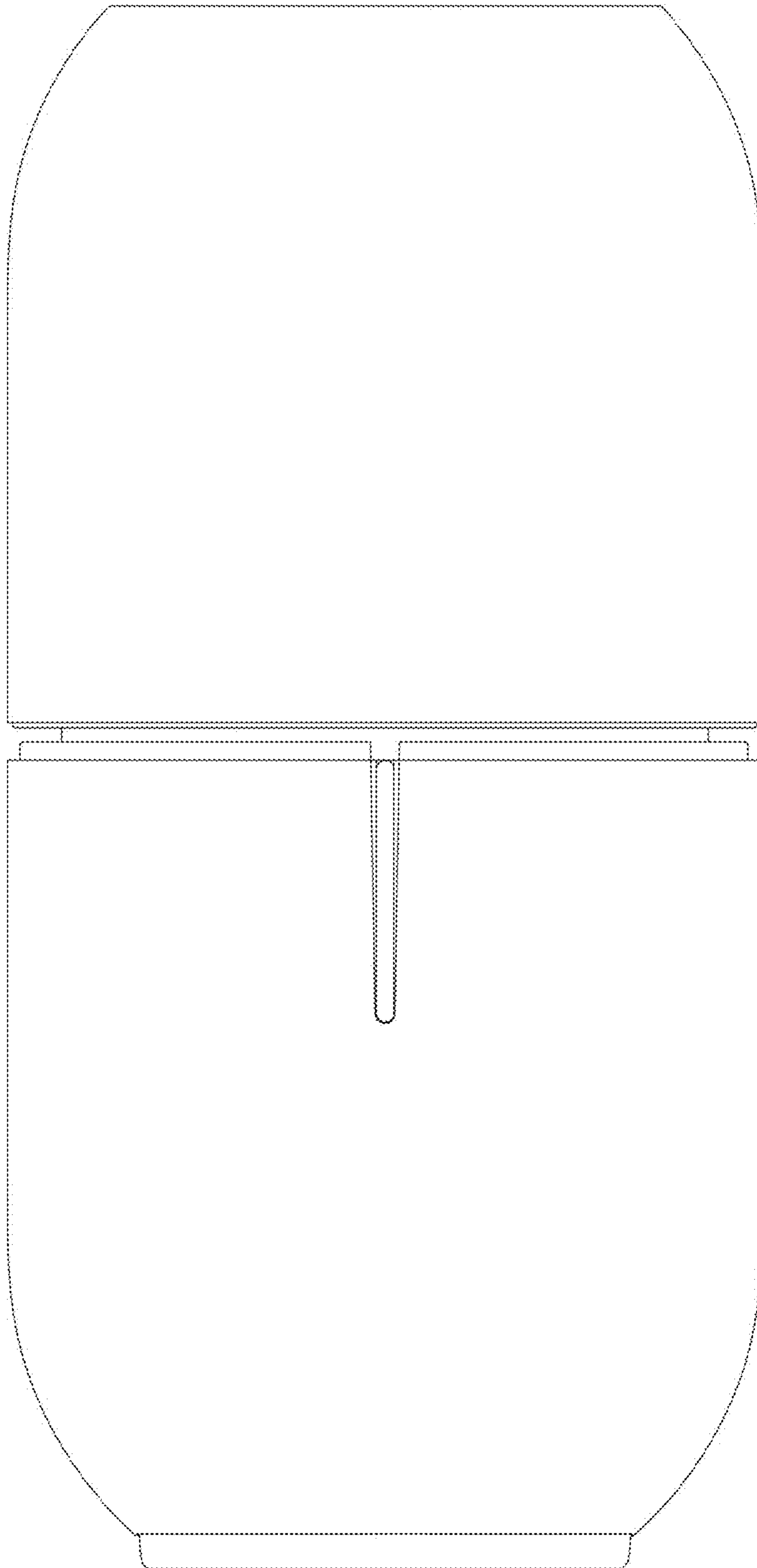

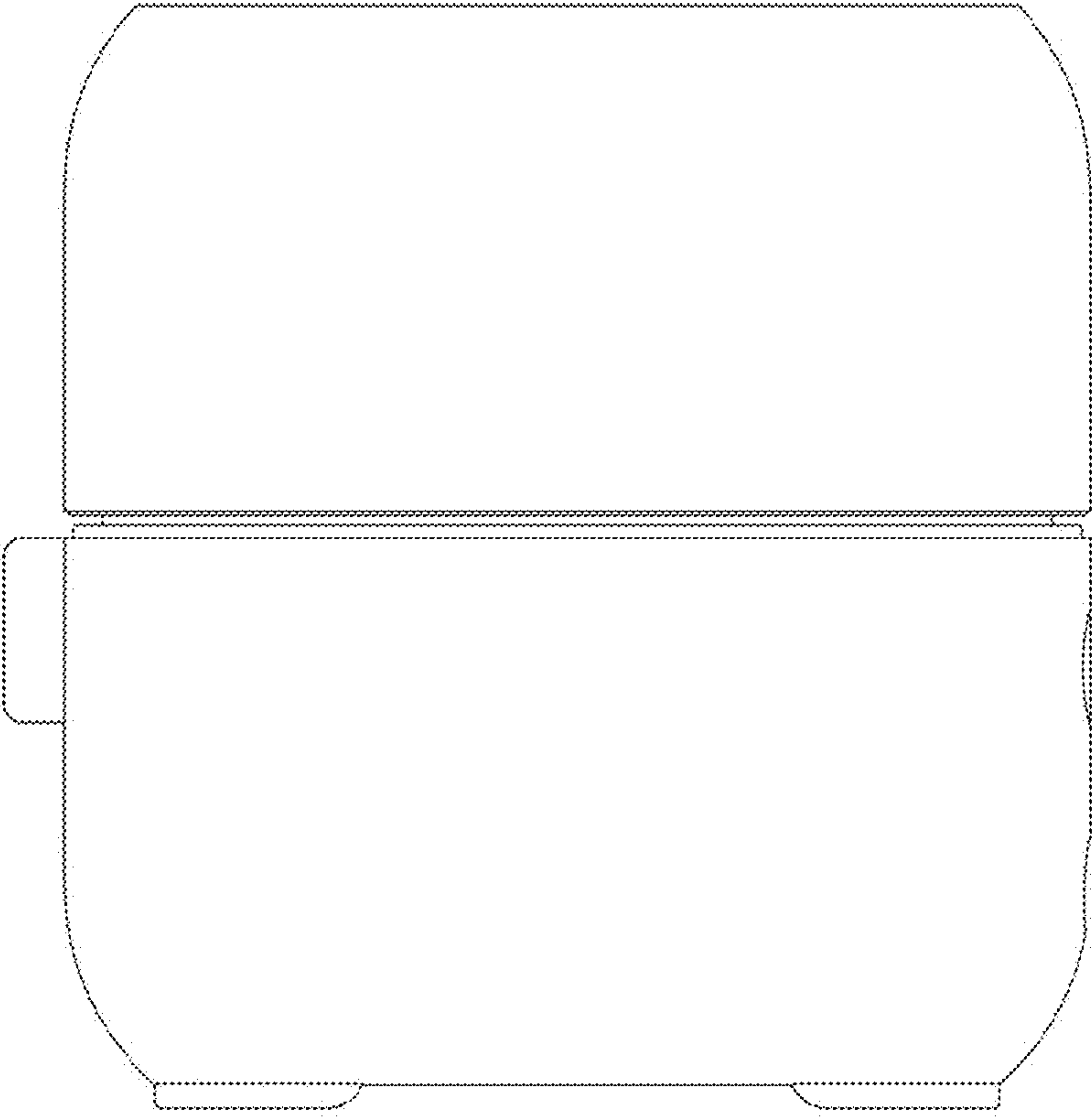

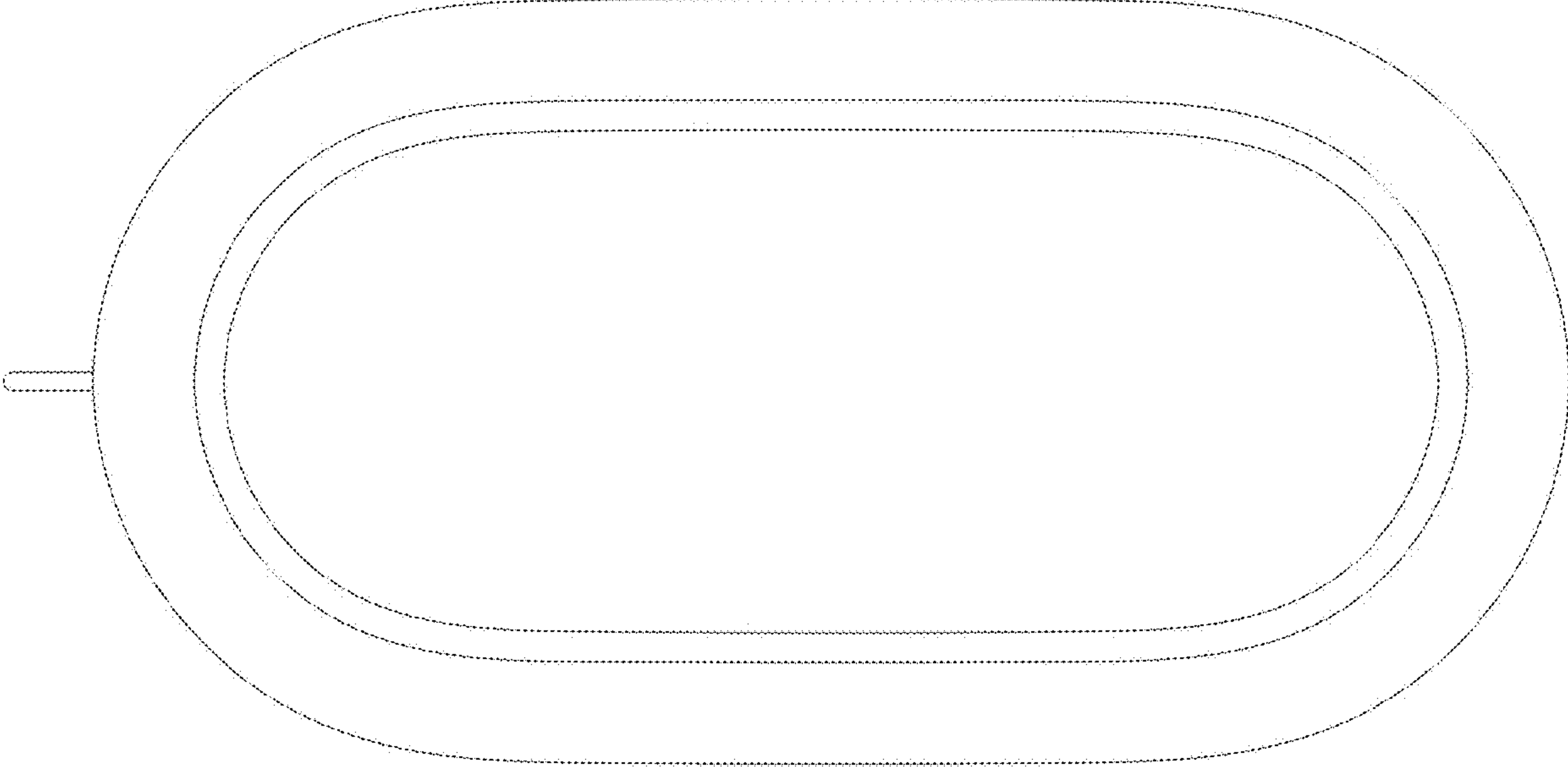

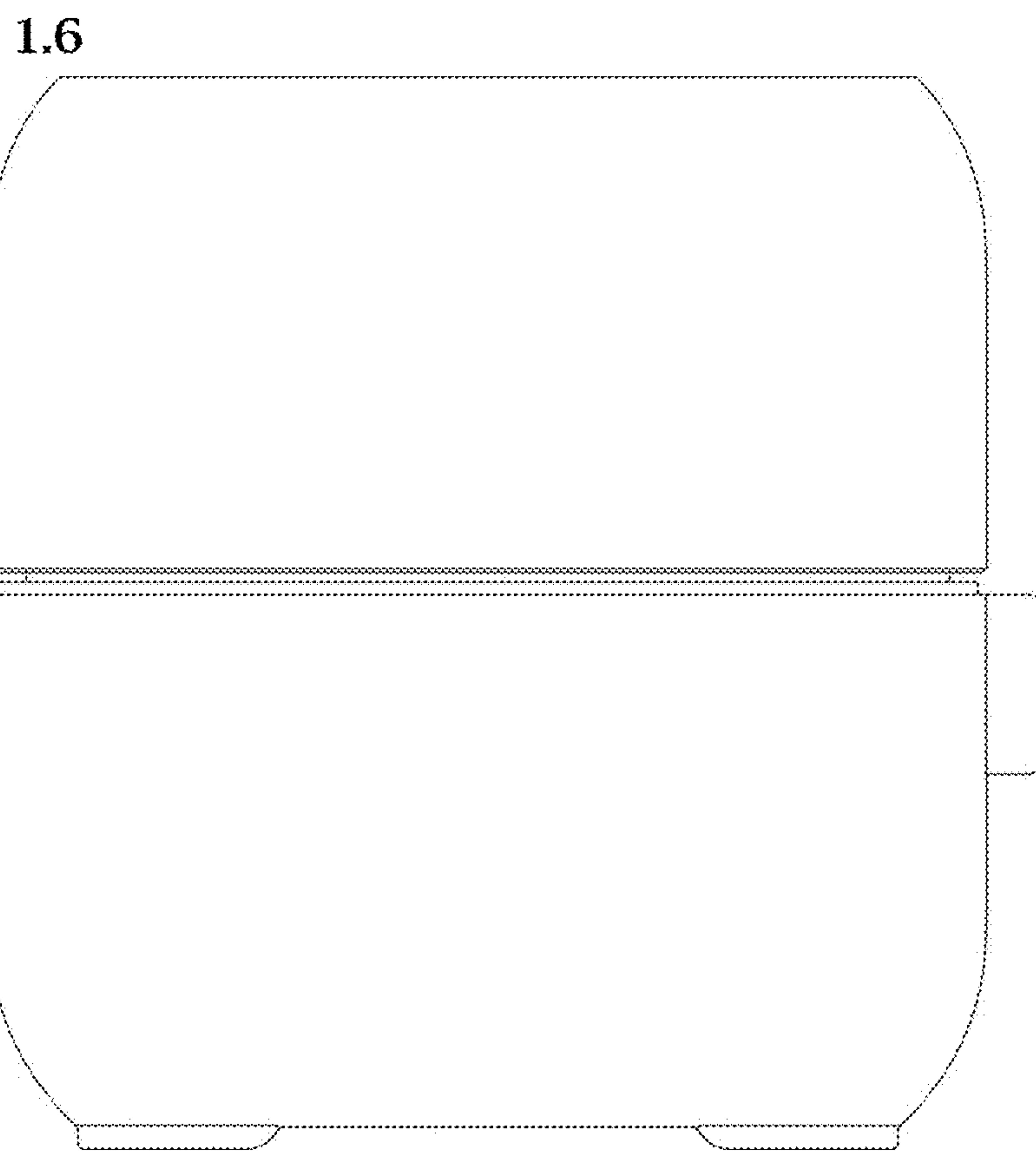


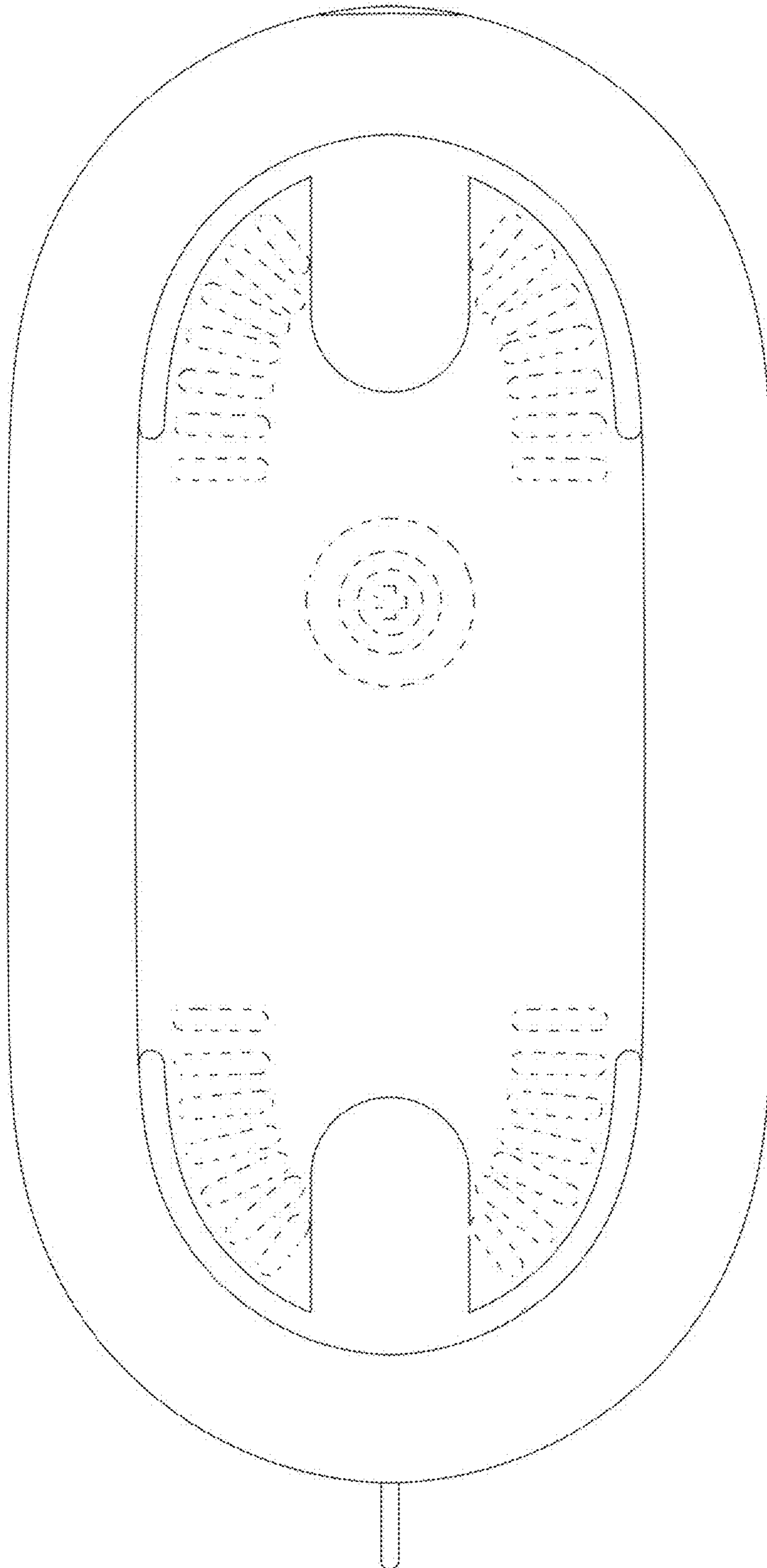
