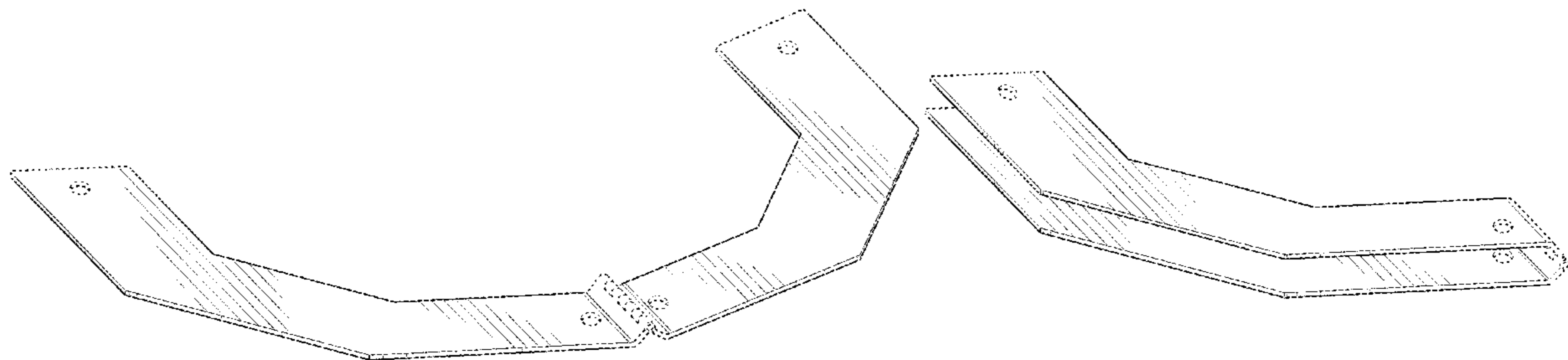
(57) **CLAIM**

The ornamental design for a hinged kiln brick protective collar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hinged kiln brick protective collar showing my design;
 FIG. 2 is a perspective view of the hinged kiln brick protective collar showing the hinged kiln brick protective collar partially folded;
 FIG. 3 is a perspective view of the hinged kiln brick protective collar showing the hinged kiln brick protective collar fully folded;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a front elevation view thereof;
 FIG. 7 is a rear elevation view thereof;
 FIG. 8 is a right side elevation view thereof;

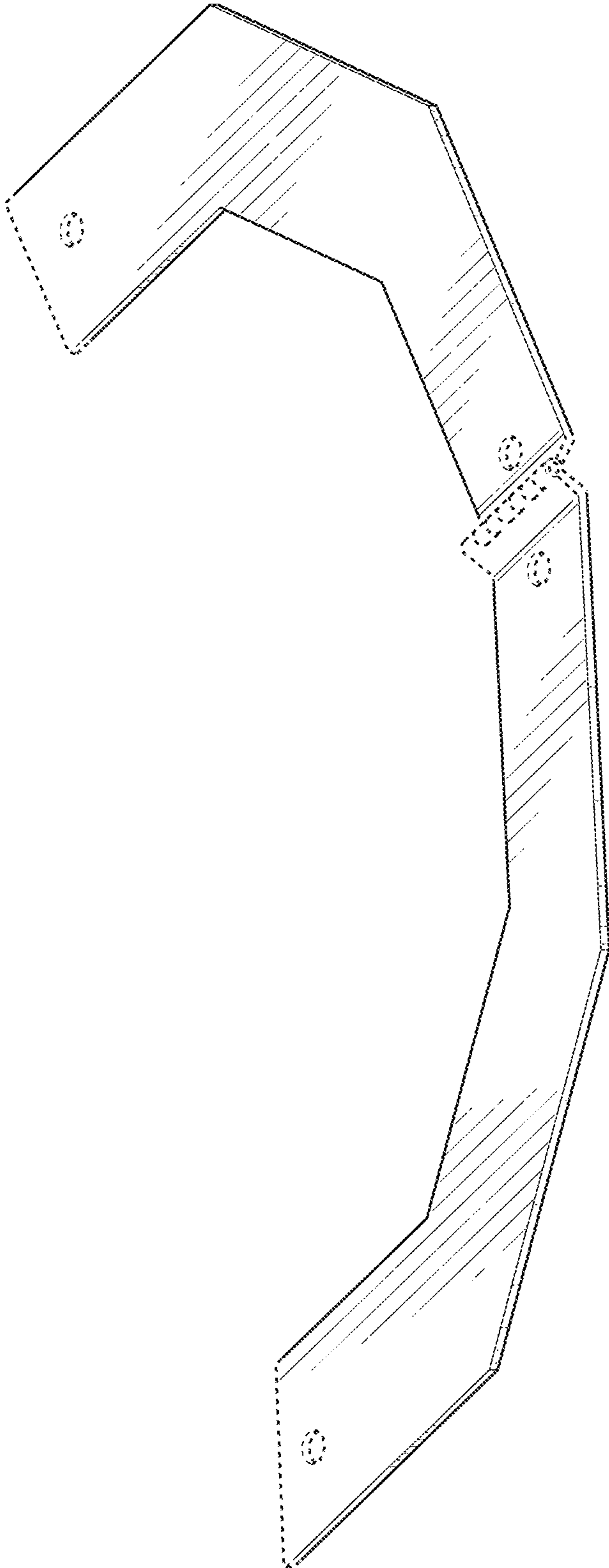

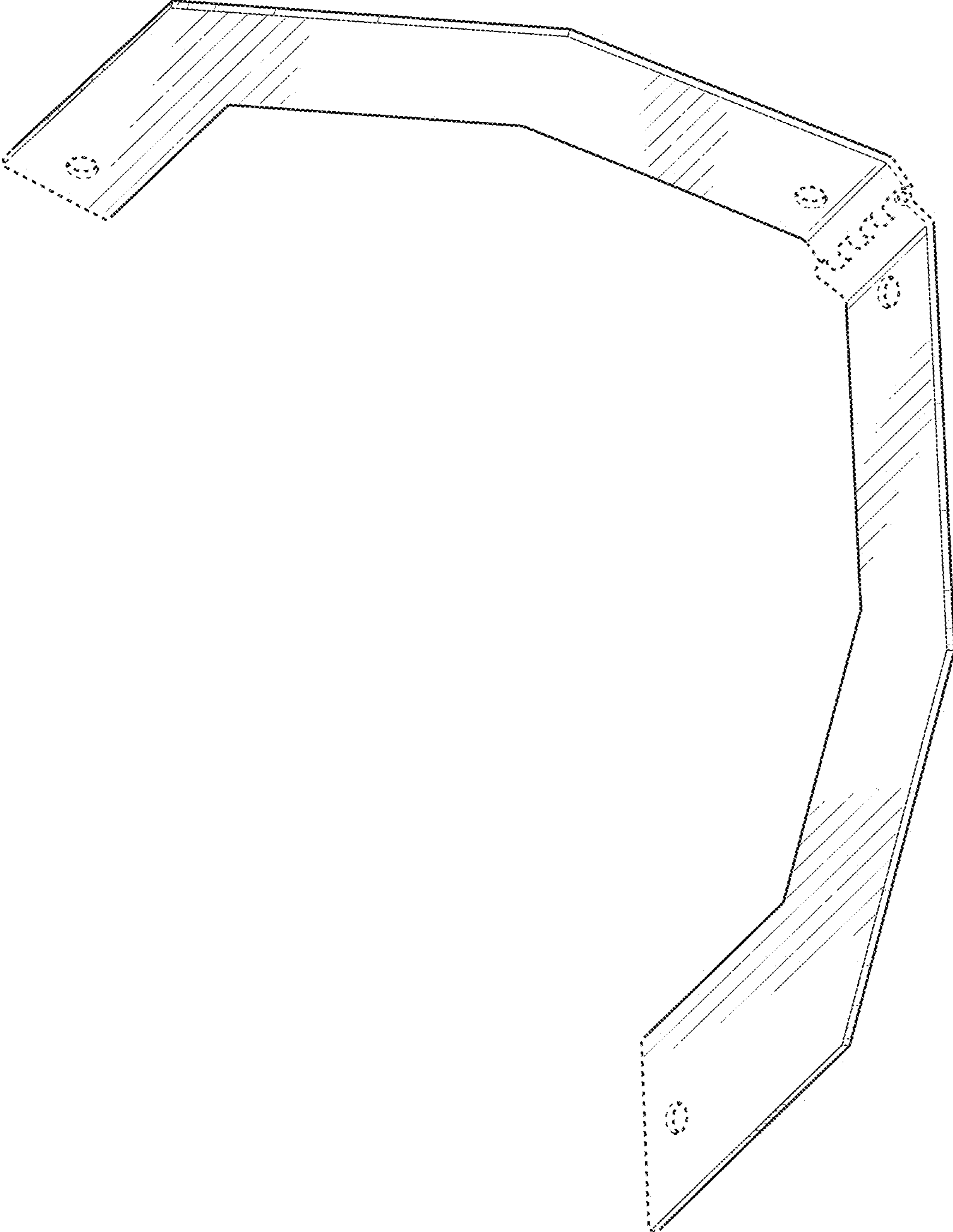

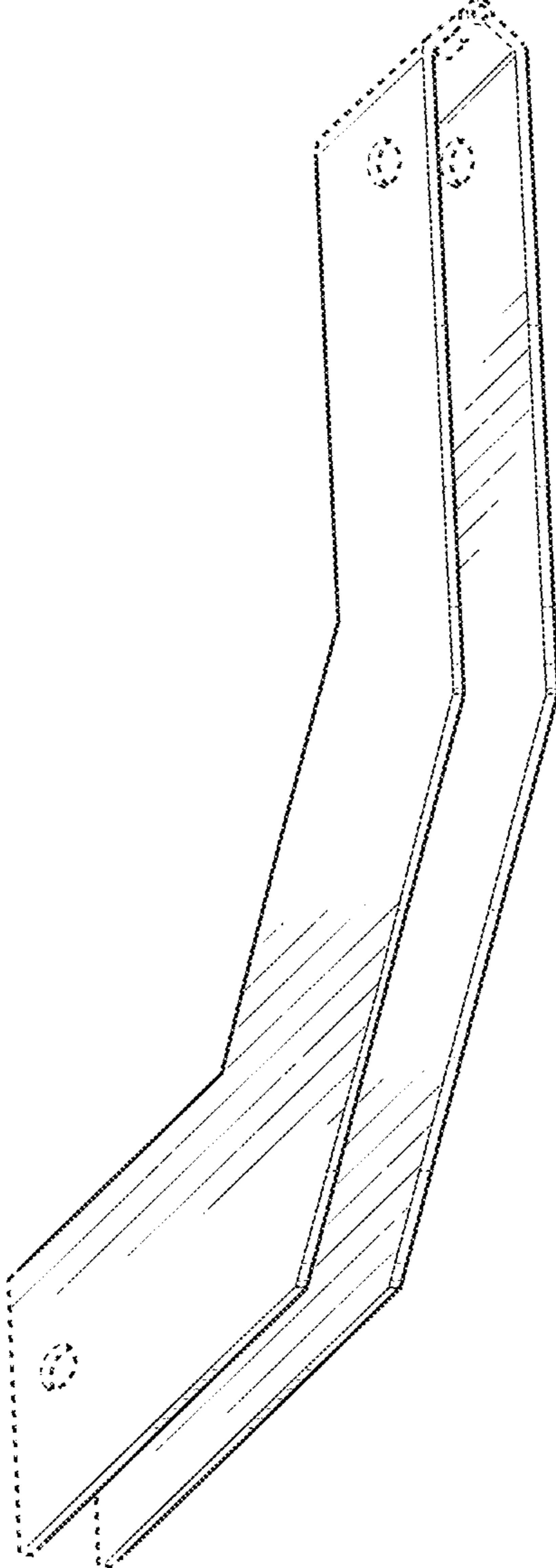

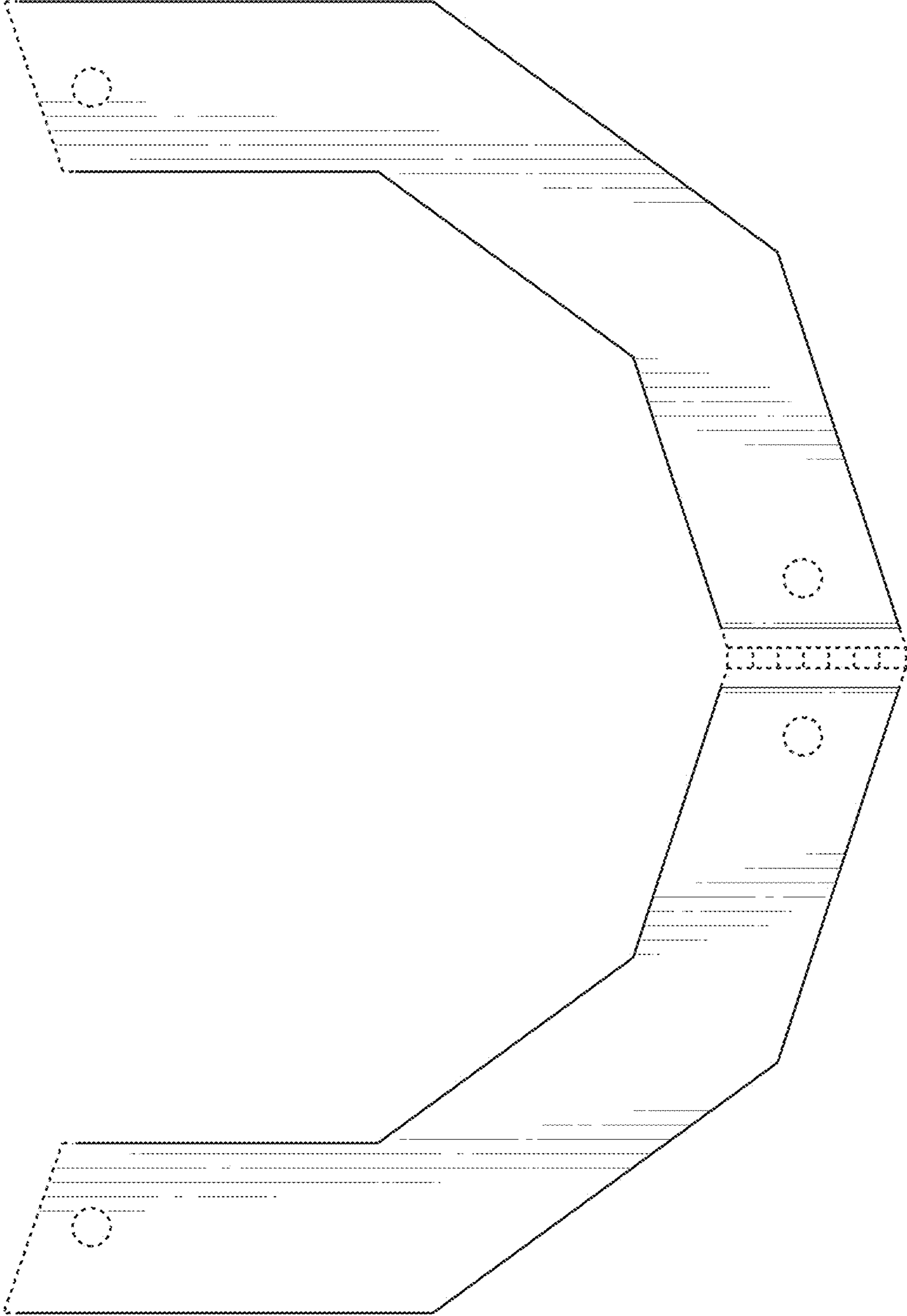

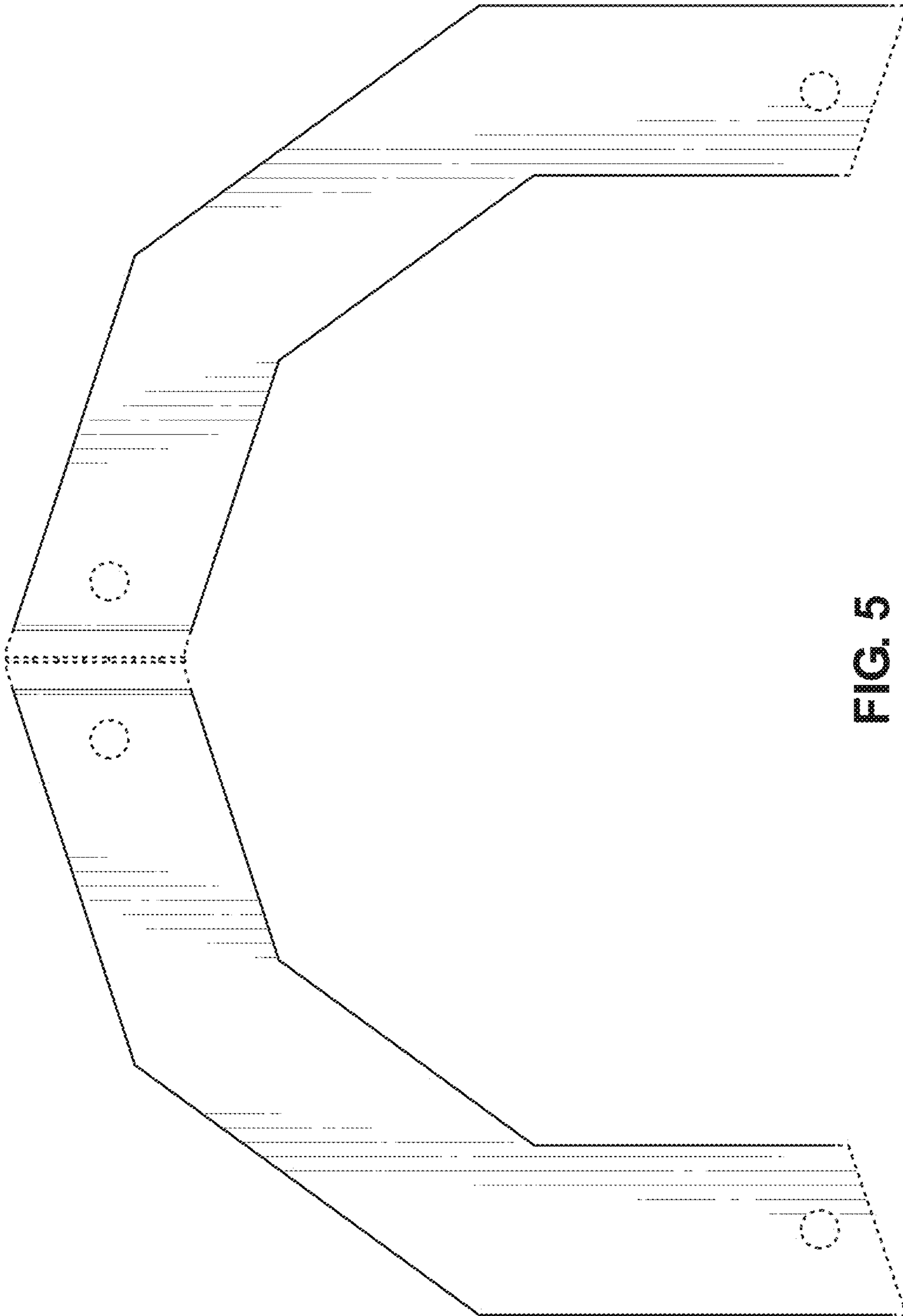

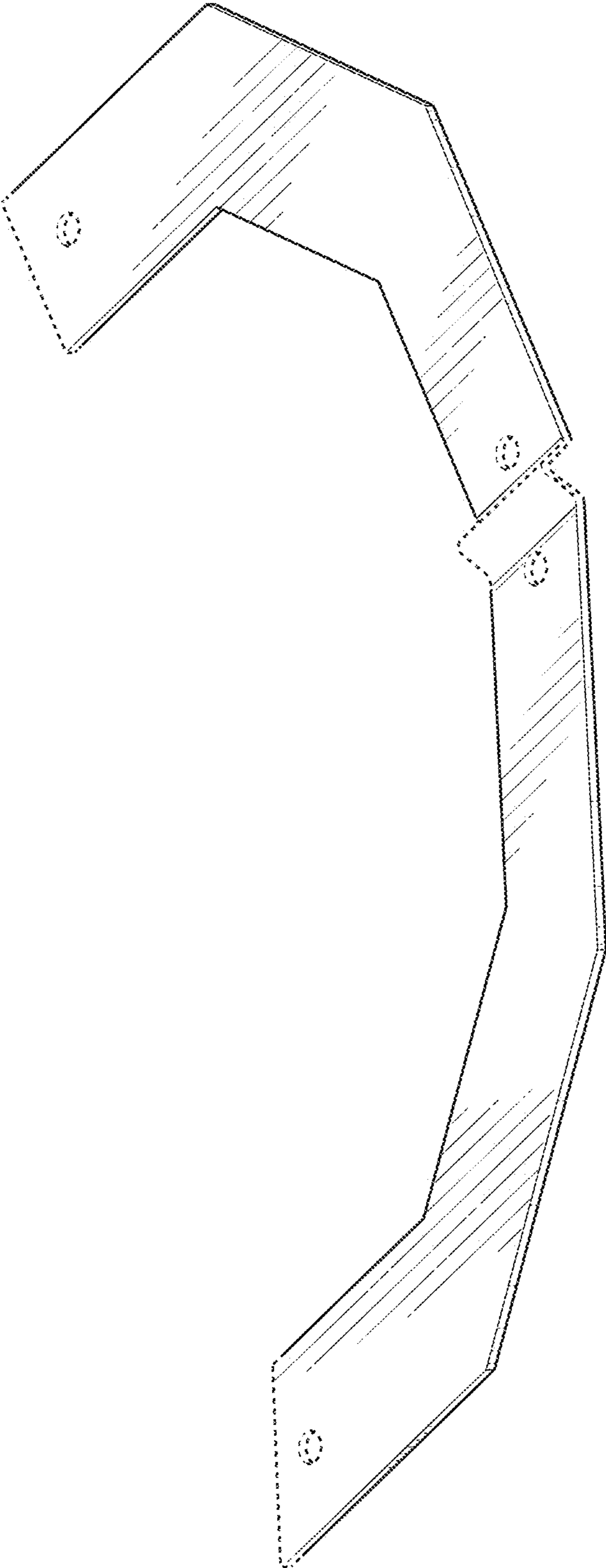

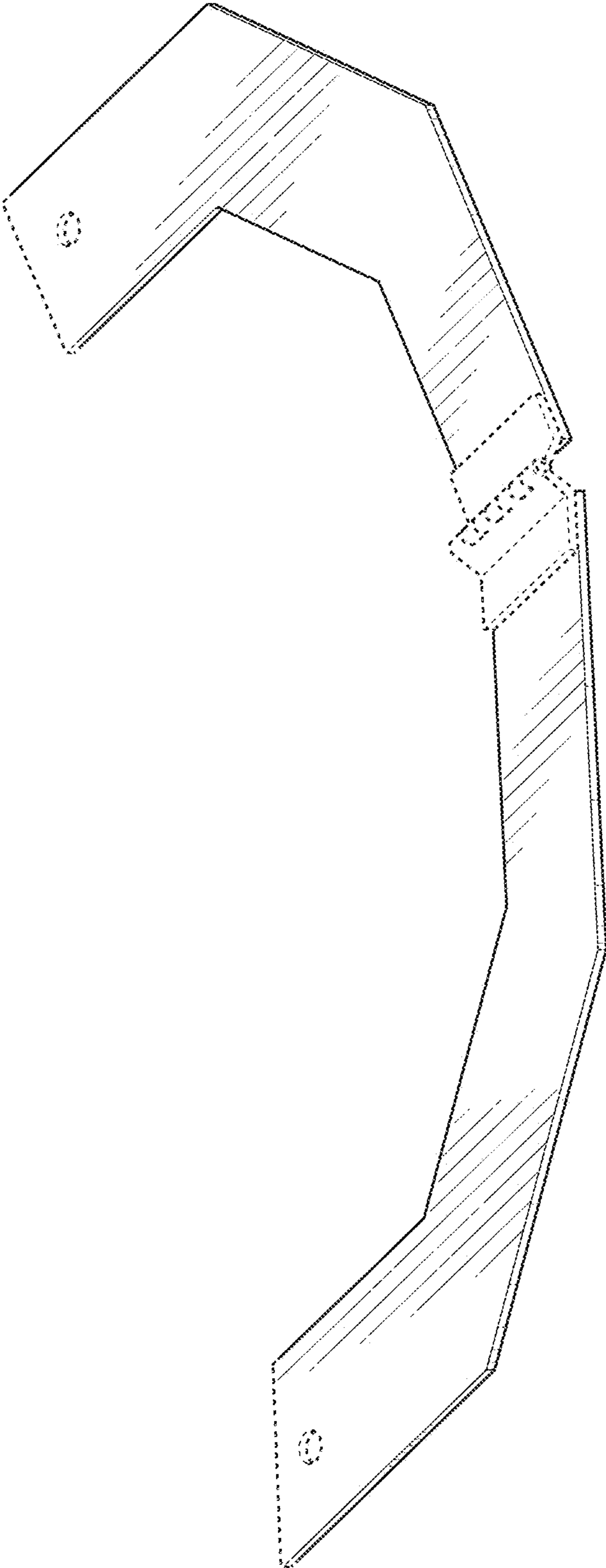
