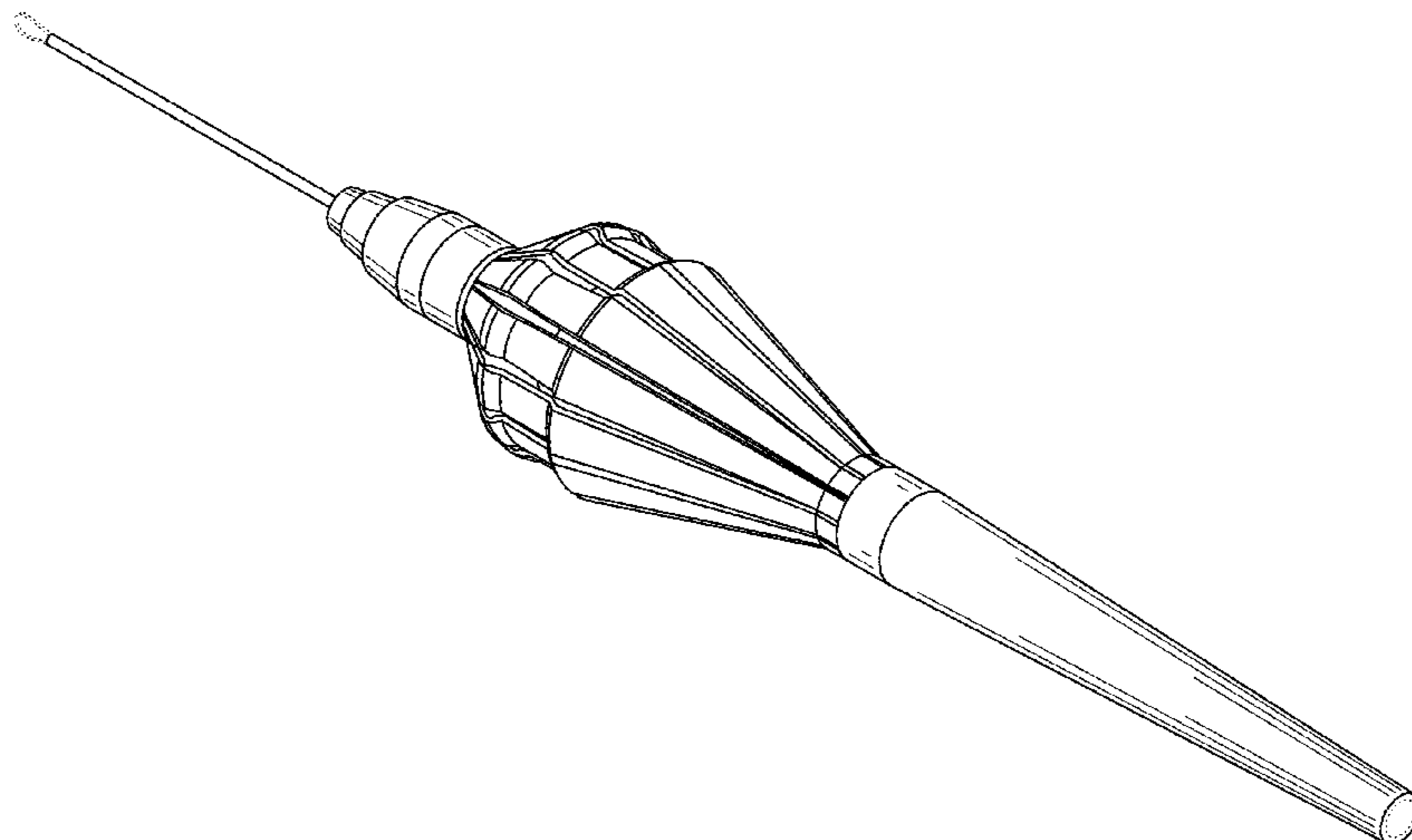
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a 360 degree actuation handle showing my new design;

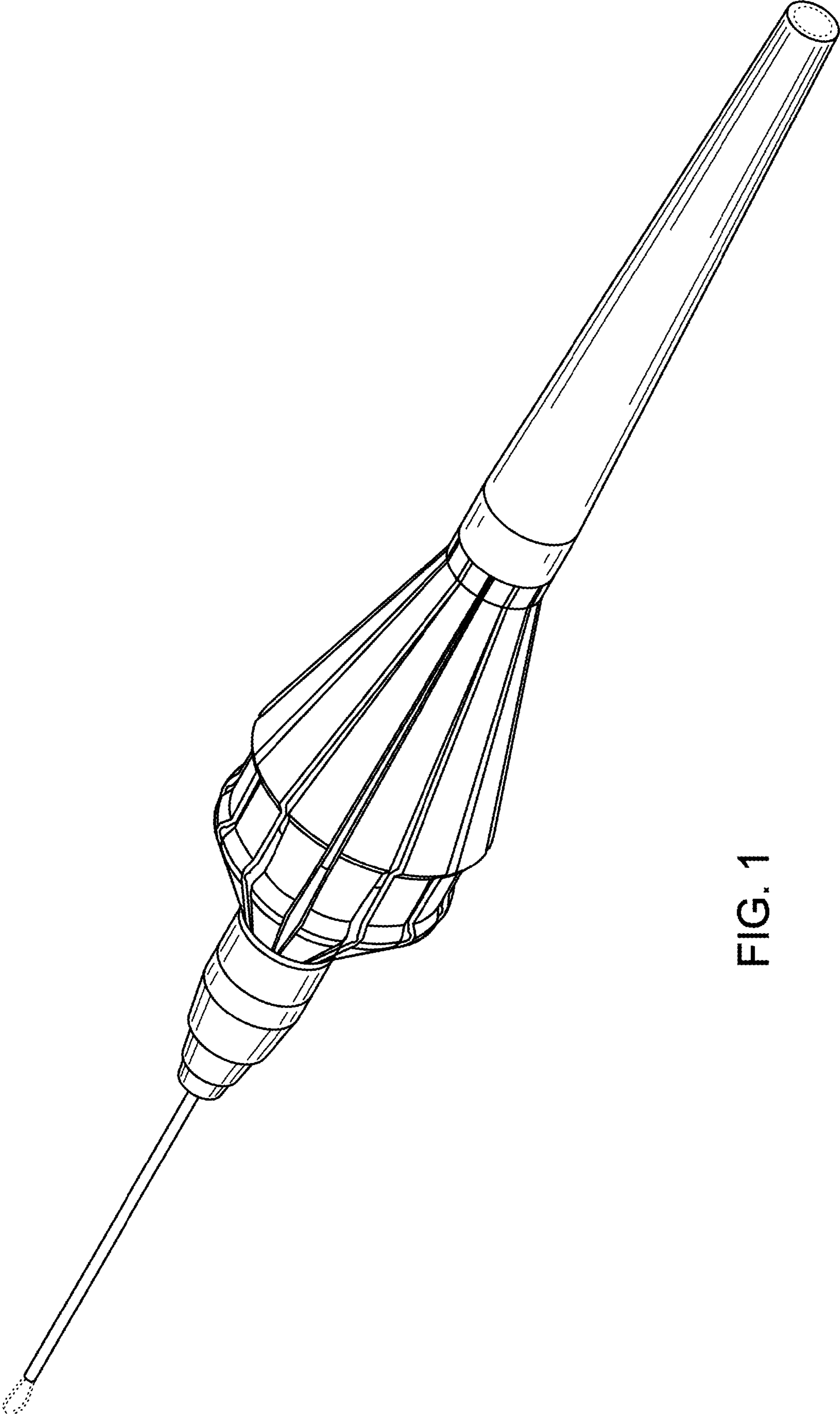

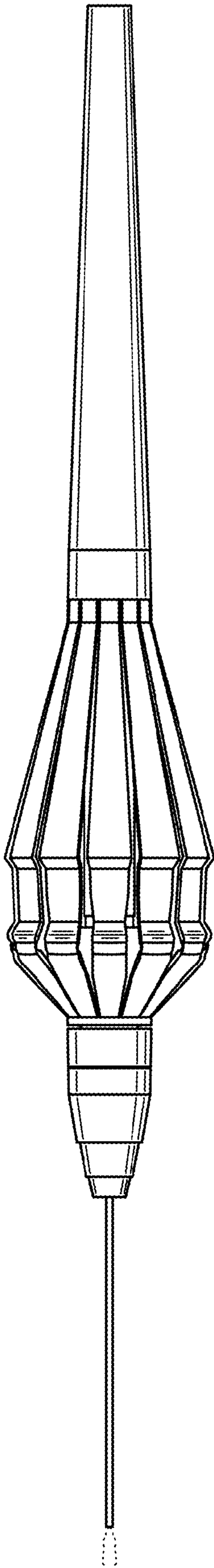

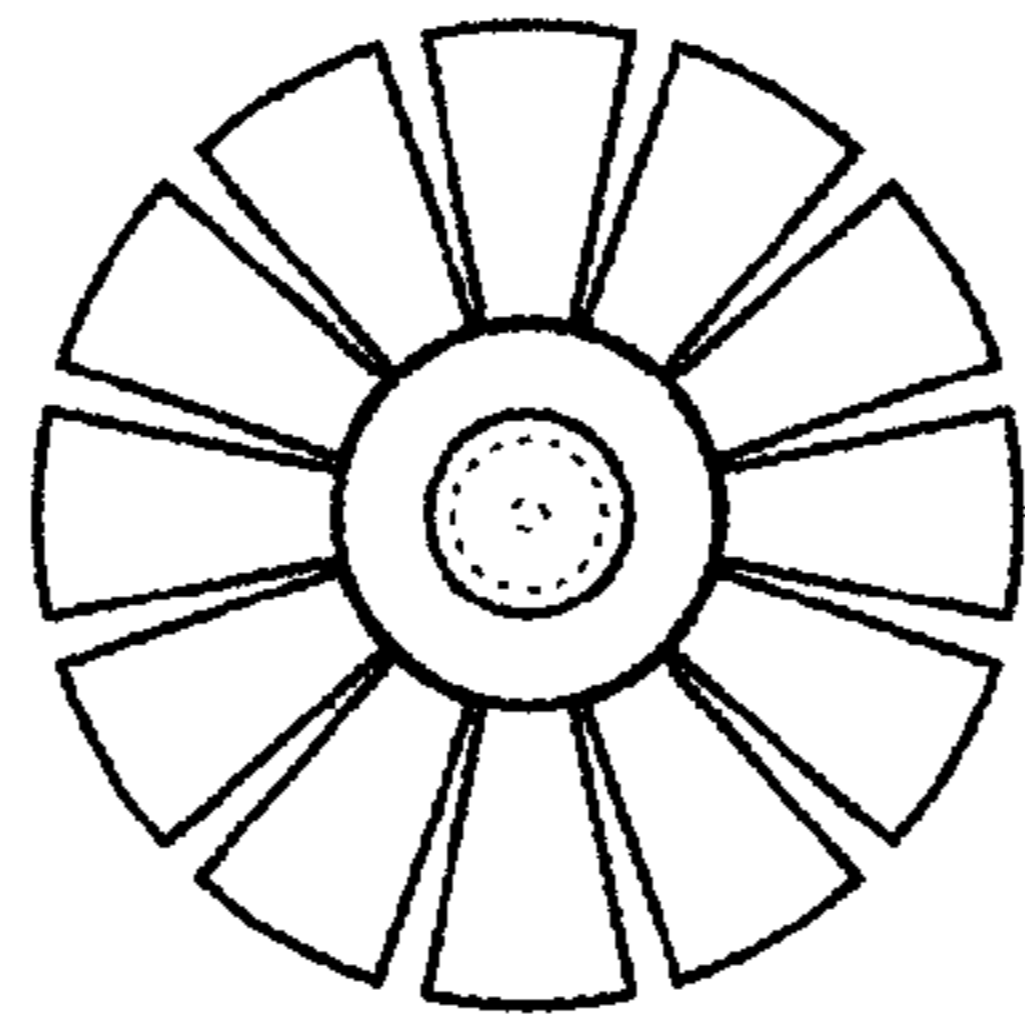

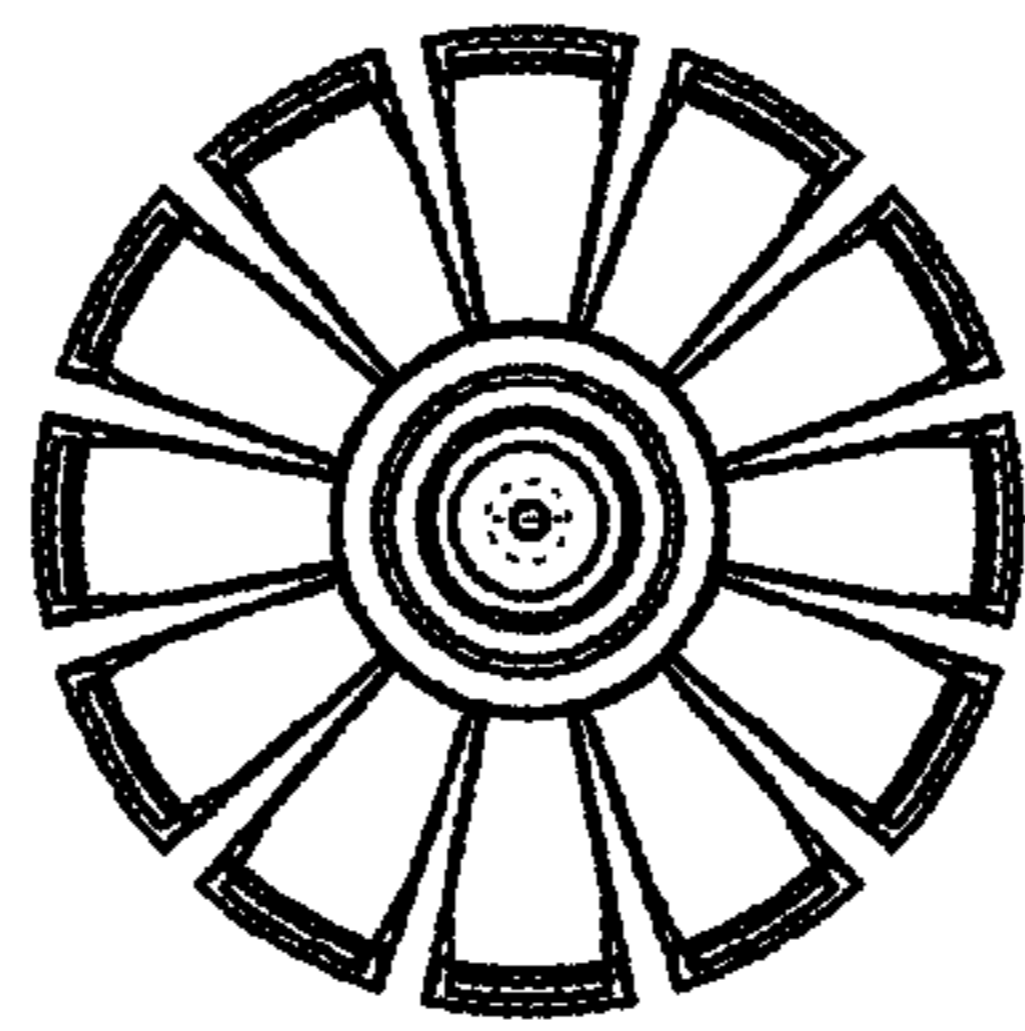

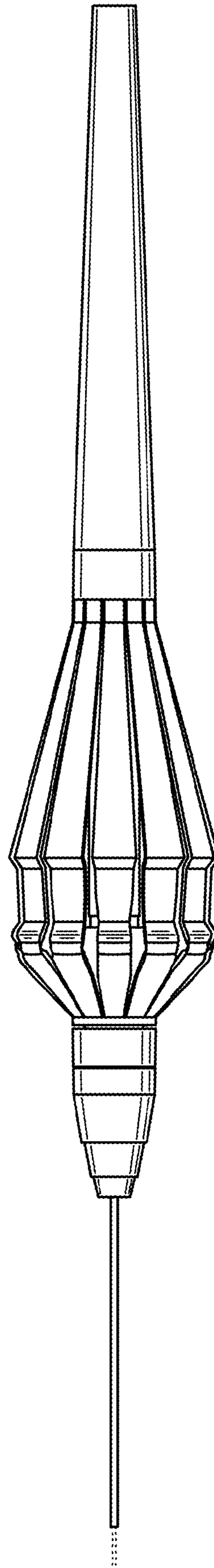

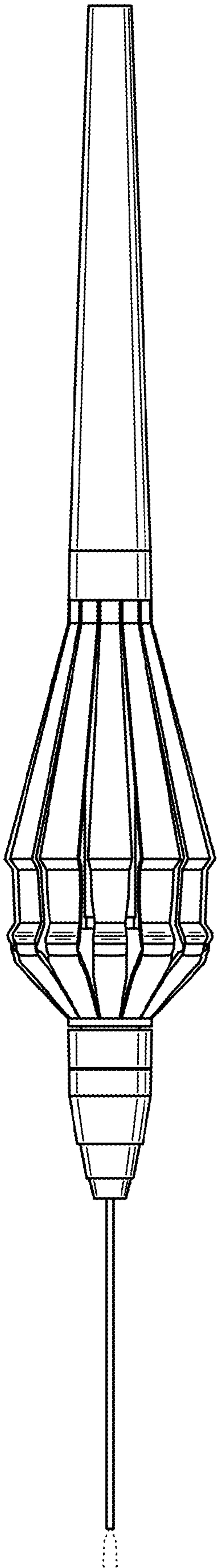

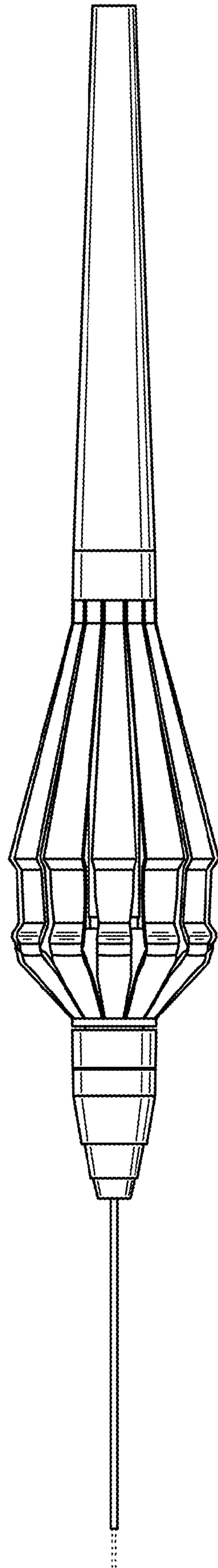
