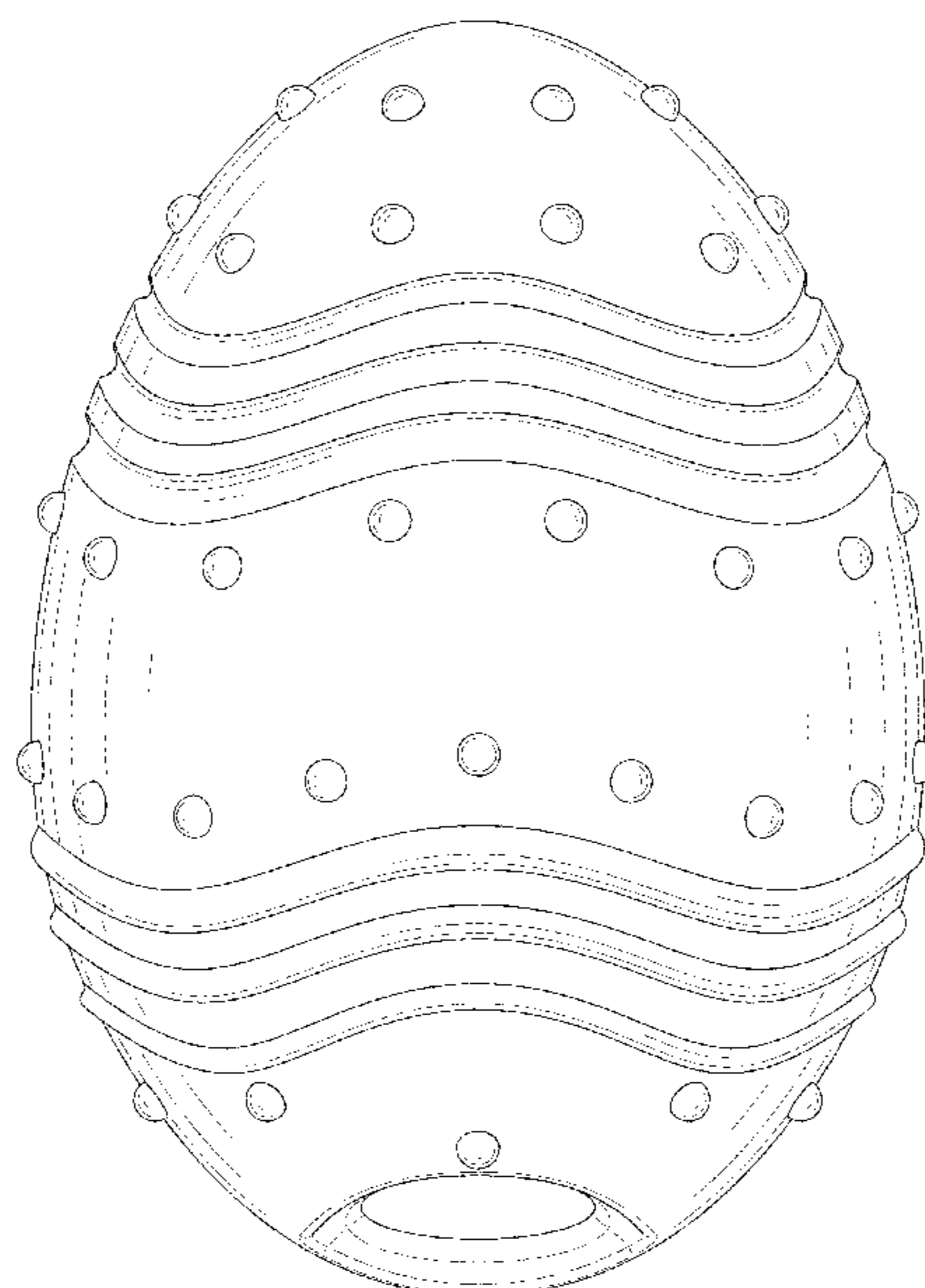
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a teether, showing my new design;
FIG. 2 is a bottom, rear, left view thereof;

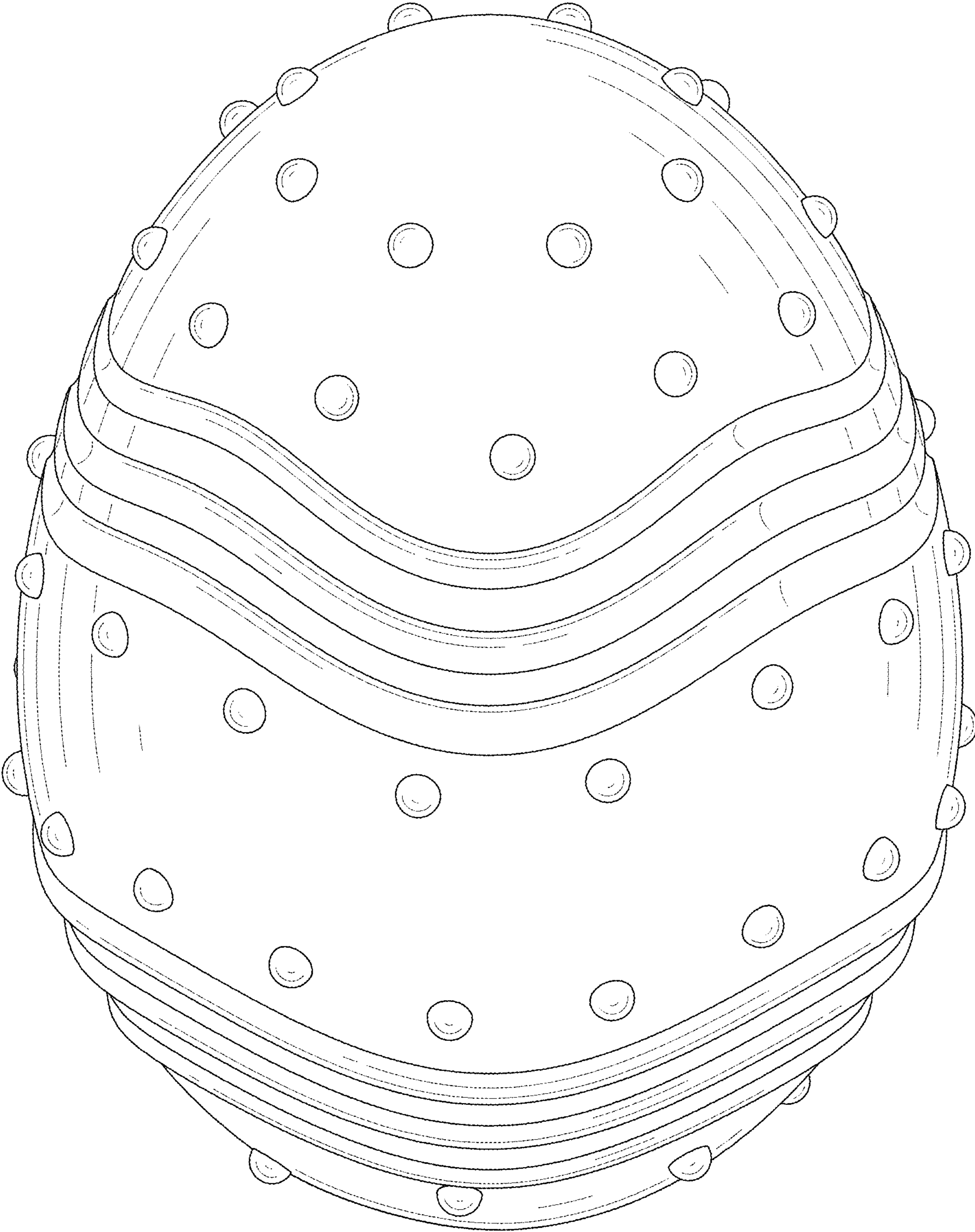

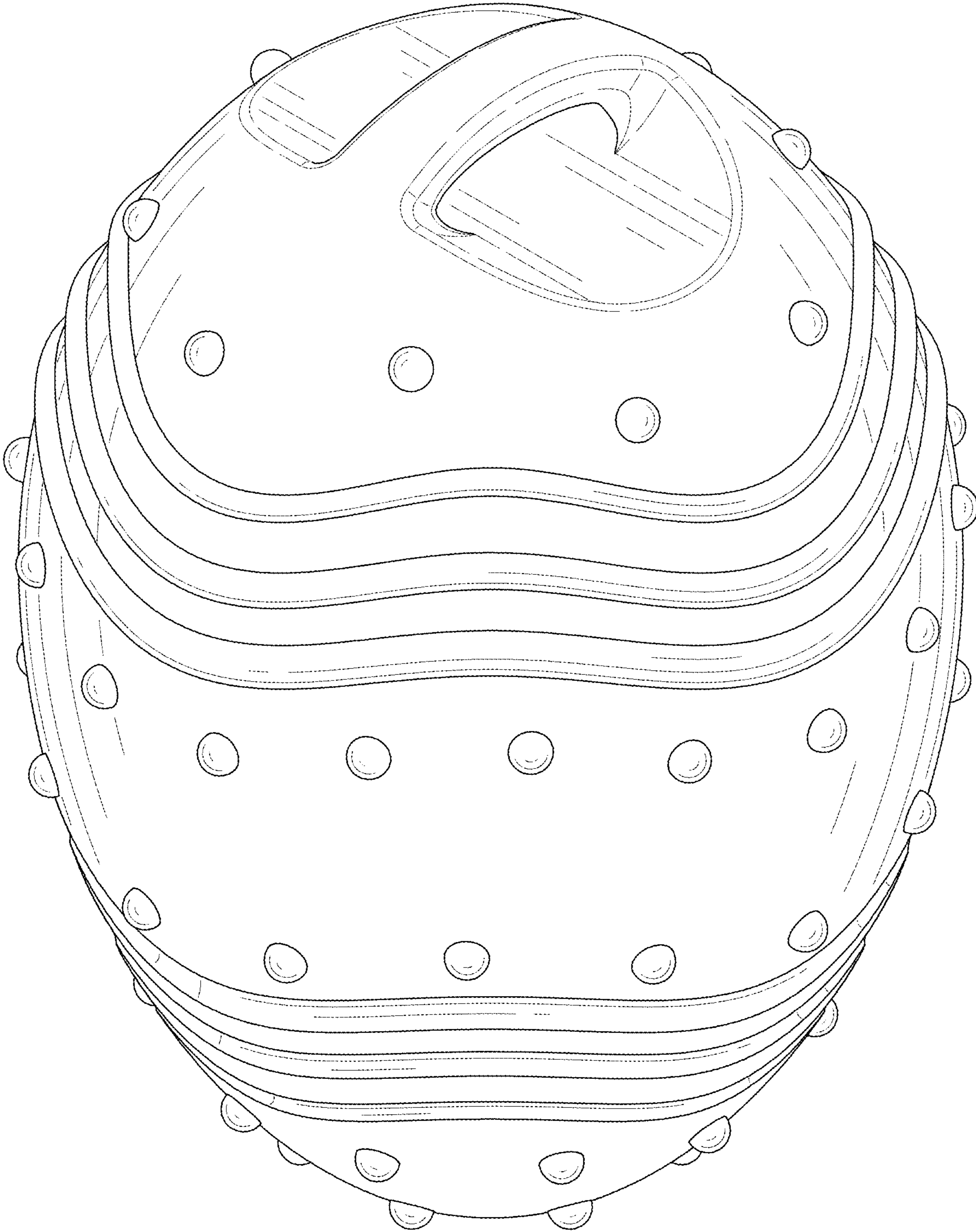

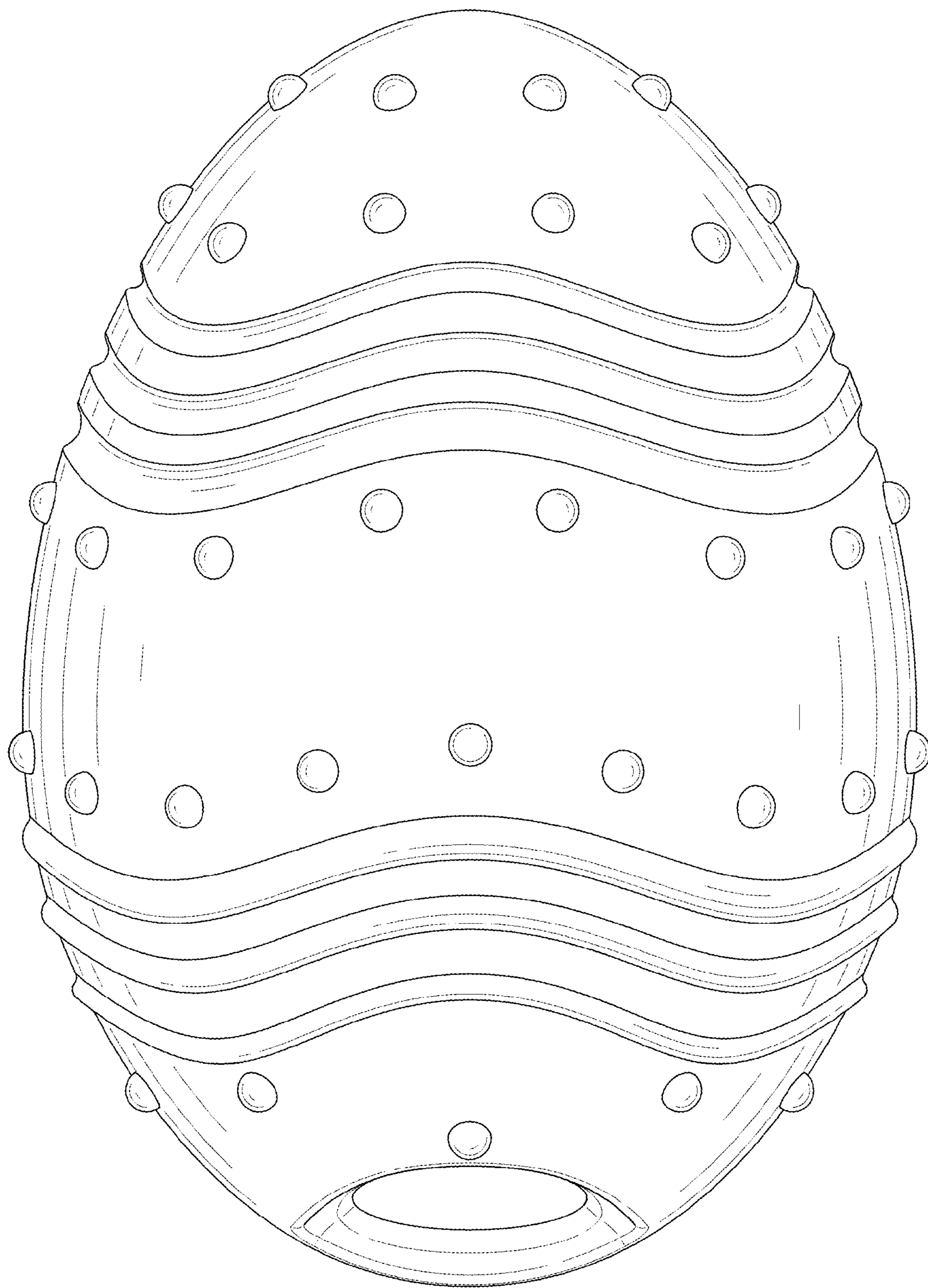

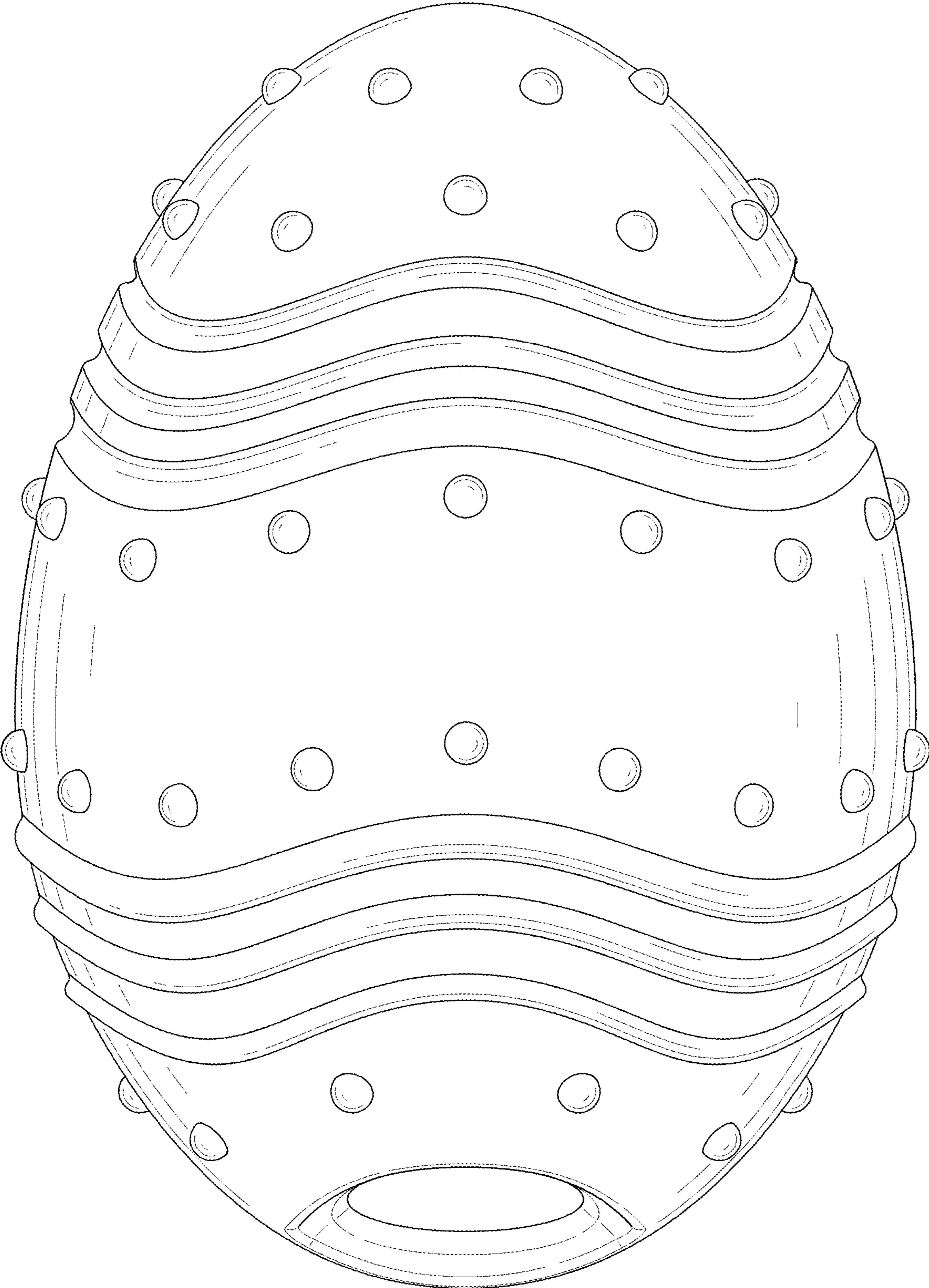

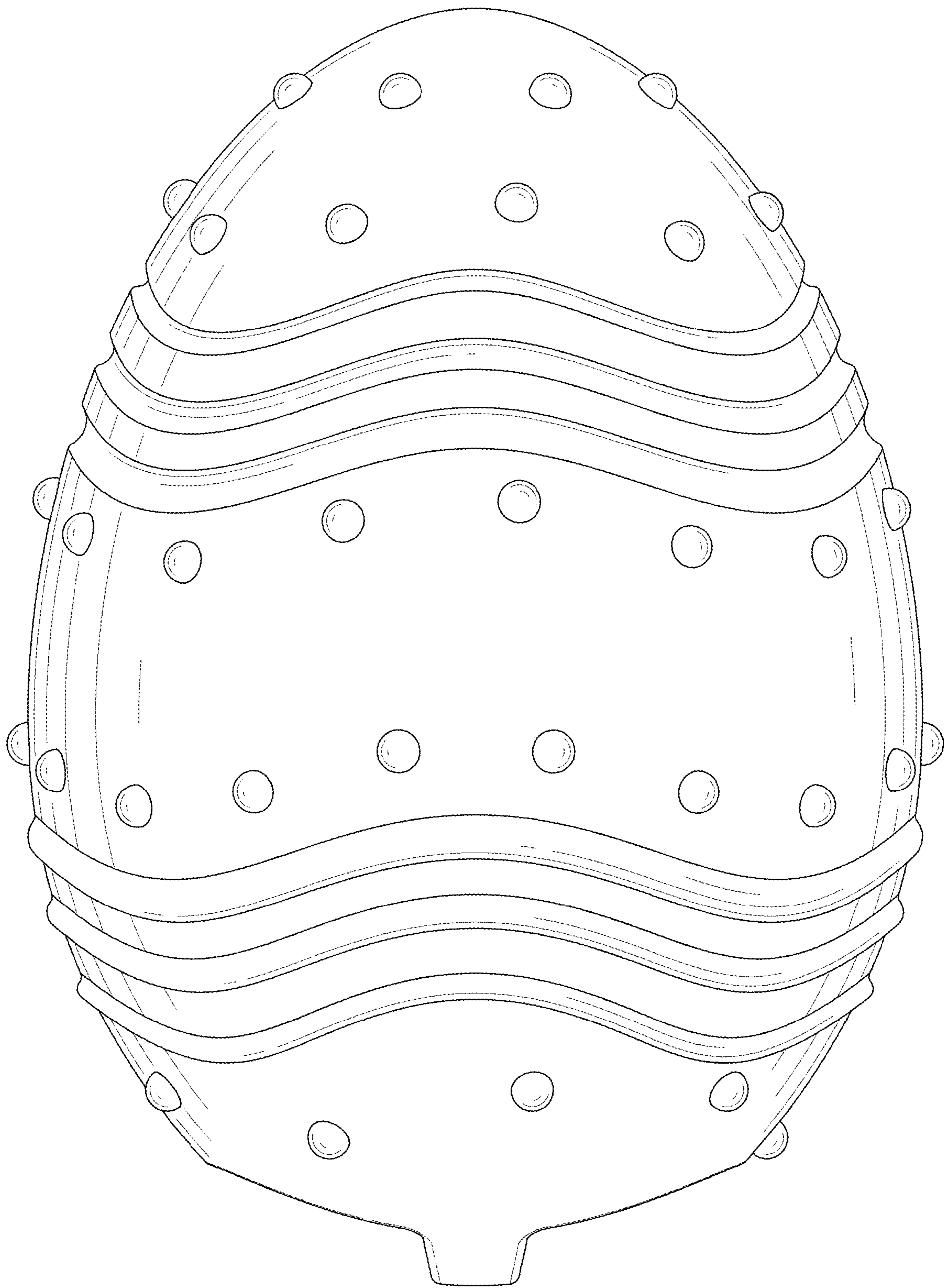

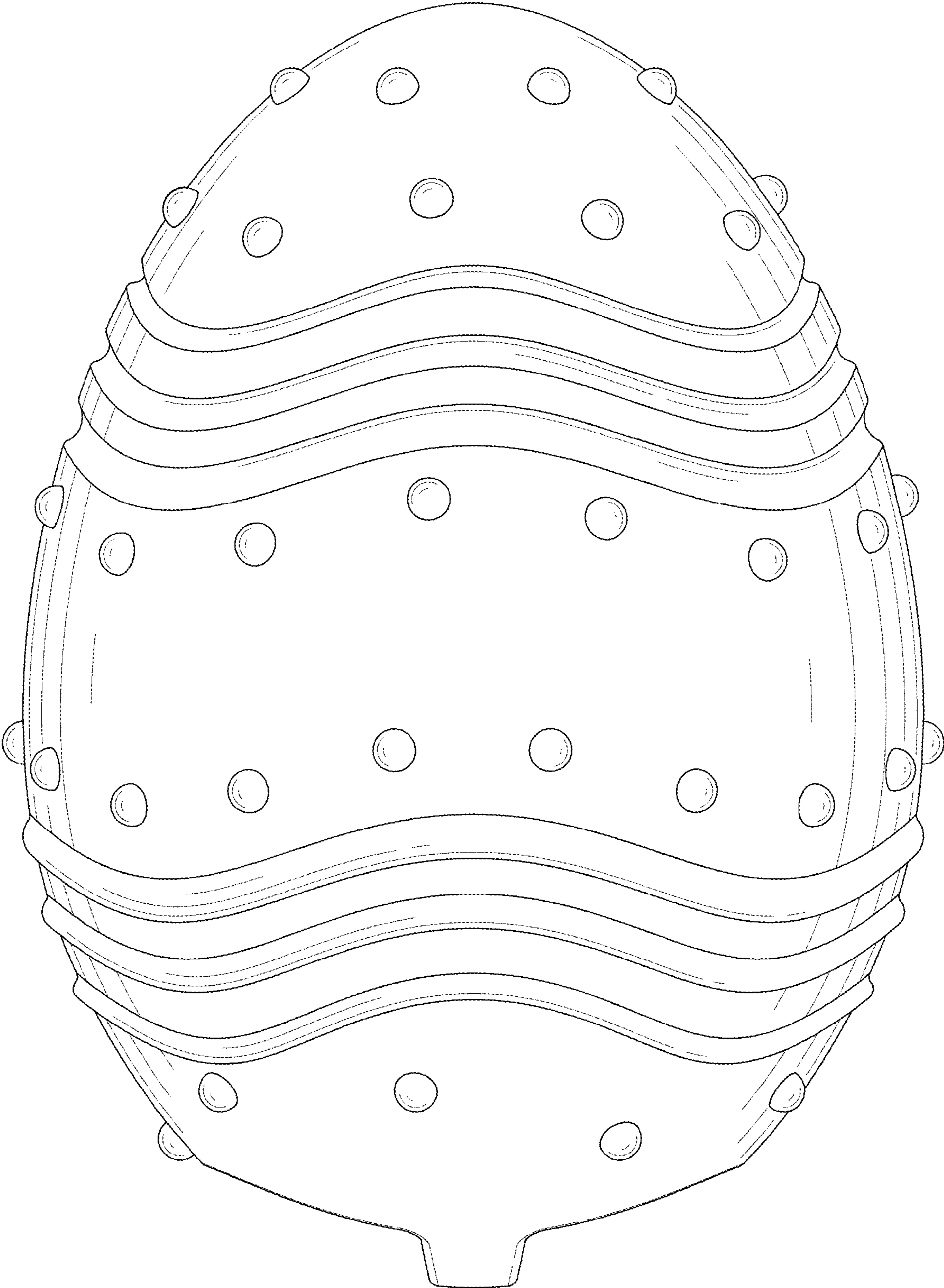

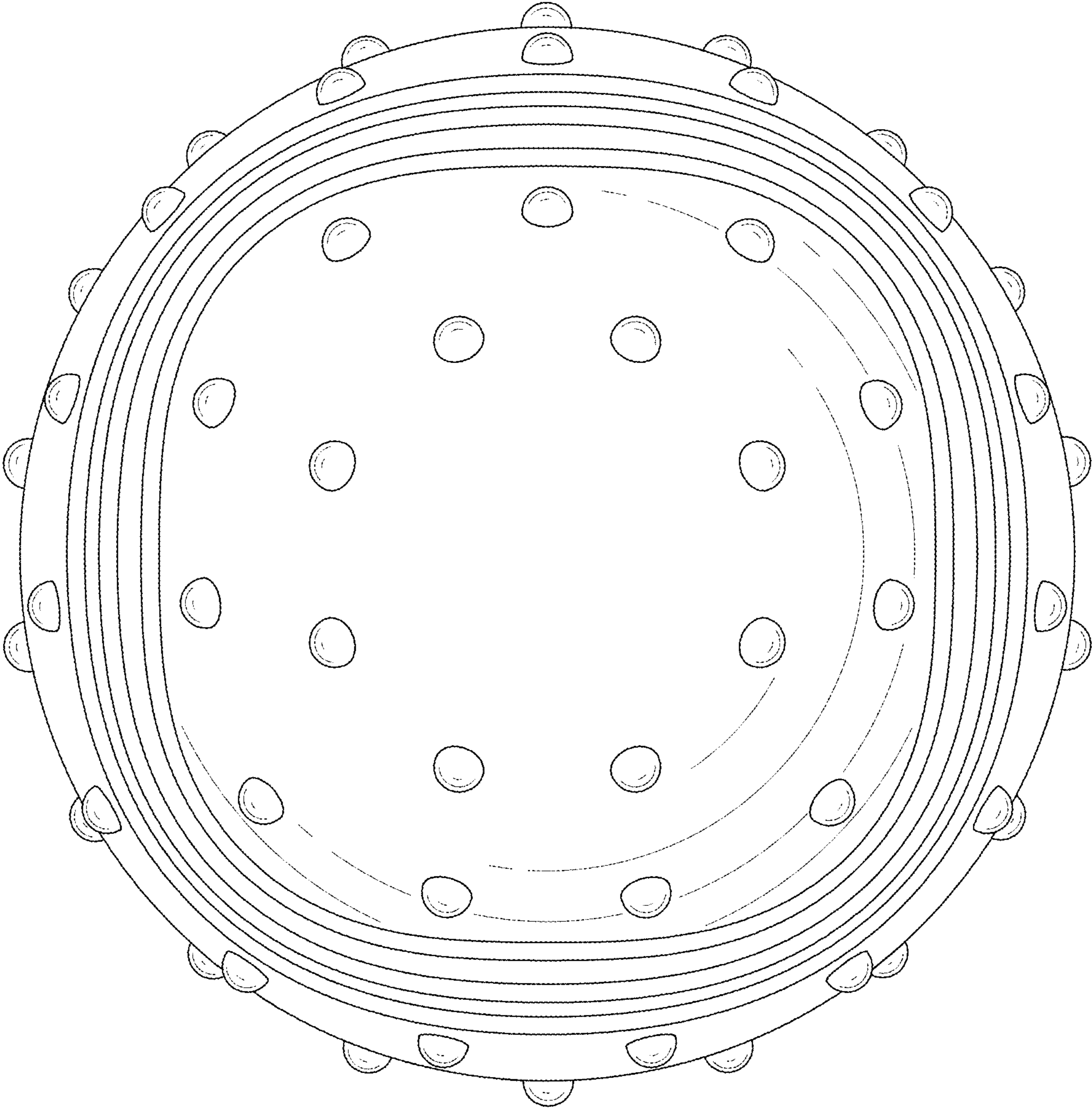

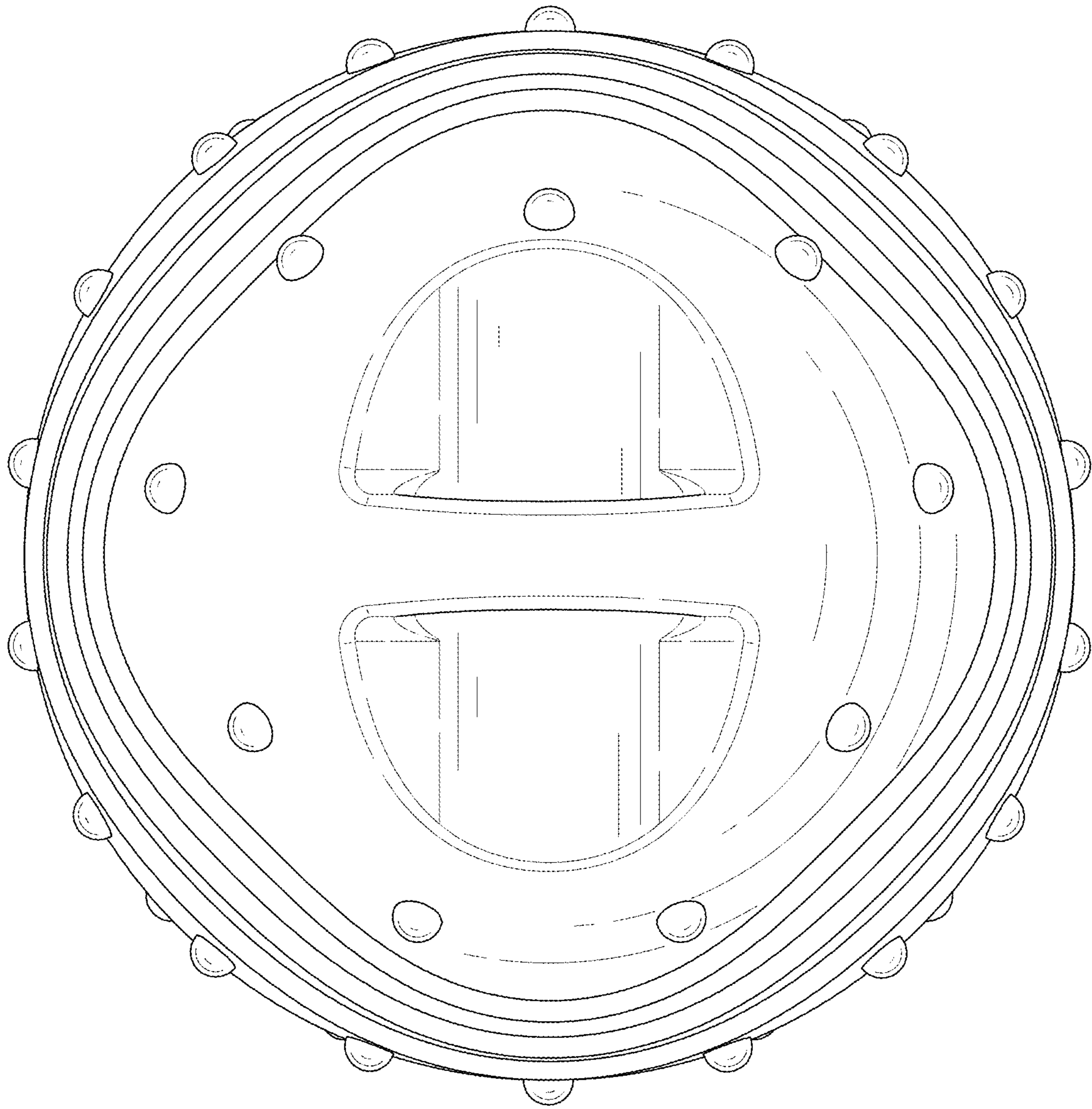
