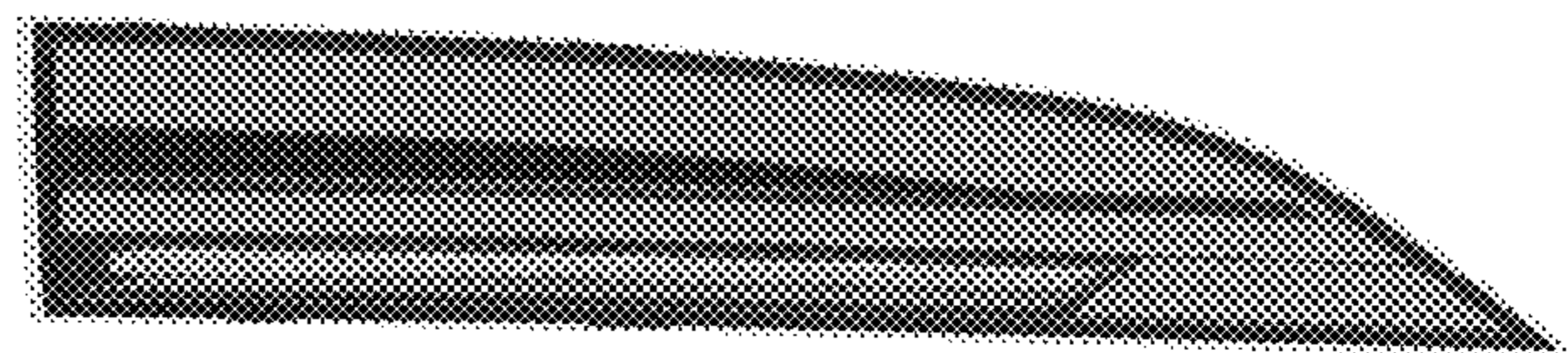
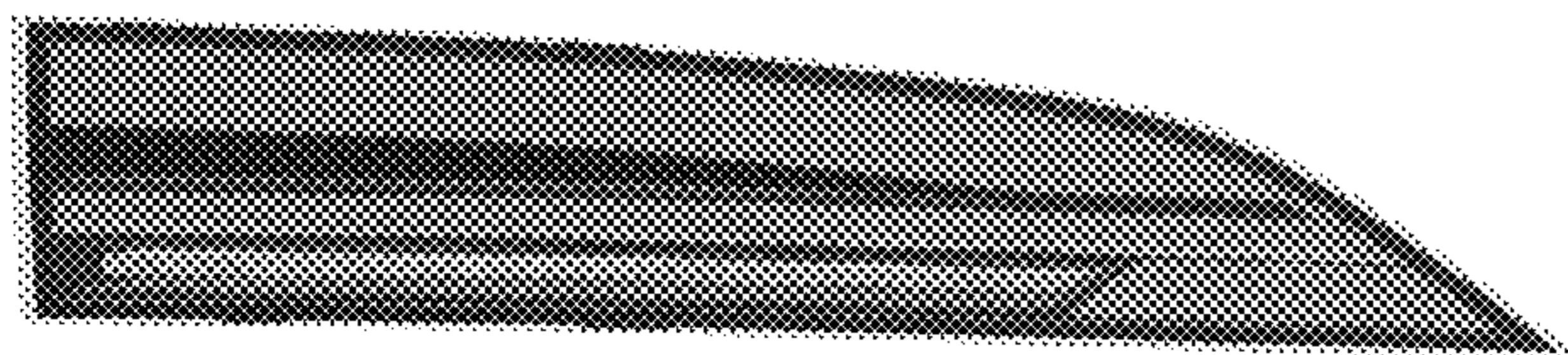
The ornamental designs for a tail light for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a tail light for a vehicle, showing a first embodiment of our new design; FIG. 2 is a front left perspective view thereof; FIG. 3 is a rear right perspective view thereof; FIG. 4 is a rear left perspective view thereof; FIG. 5 is a front view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a right side view thereof; FIG. 8 is a left side view thereof; FIG. 9 is a top view thereof; FIG. 10 is a bottom view thereof; FIG. 11 is a front view thereof, shown within an environment of use; FIG. 12 is a front right perspective view of a tail light for a vehicle, showing a second embodiment of our new design; FIG. 13 is a front left perspective view of the tail light of FIG. 12; FIG. 14 is a rear right perspective view of the tail light of FIG. 12; FIG. 15 is a front view of the tail light of FIG. 12; FIG. 16 is a right side view of the tail light of FIG. 12; FIG. 17 is a top view of the tail light of FIG. 12; and, FIG. 18 is a front view of the tail light of FIG. 12, shown within an environment of use.

The broken lines depict boundaries and form no part of the claimed designs. The depiction of a vehicle shown de-emphasized in half-tones in FIGS. 11 and 18 represents environmental subject matter that forms no part of the claimed designs.

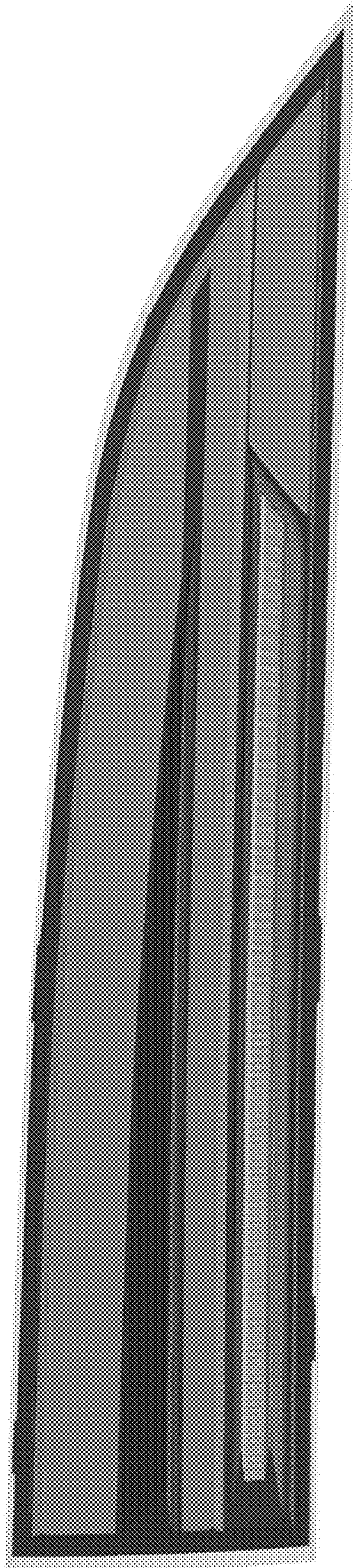

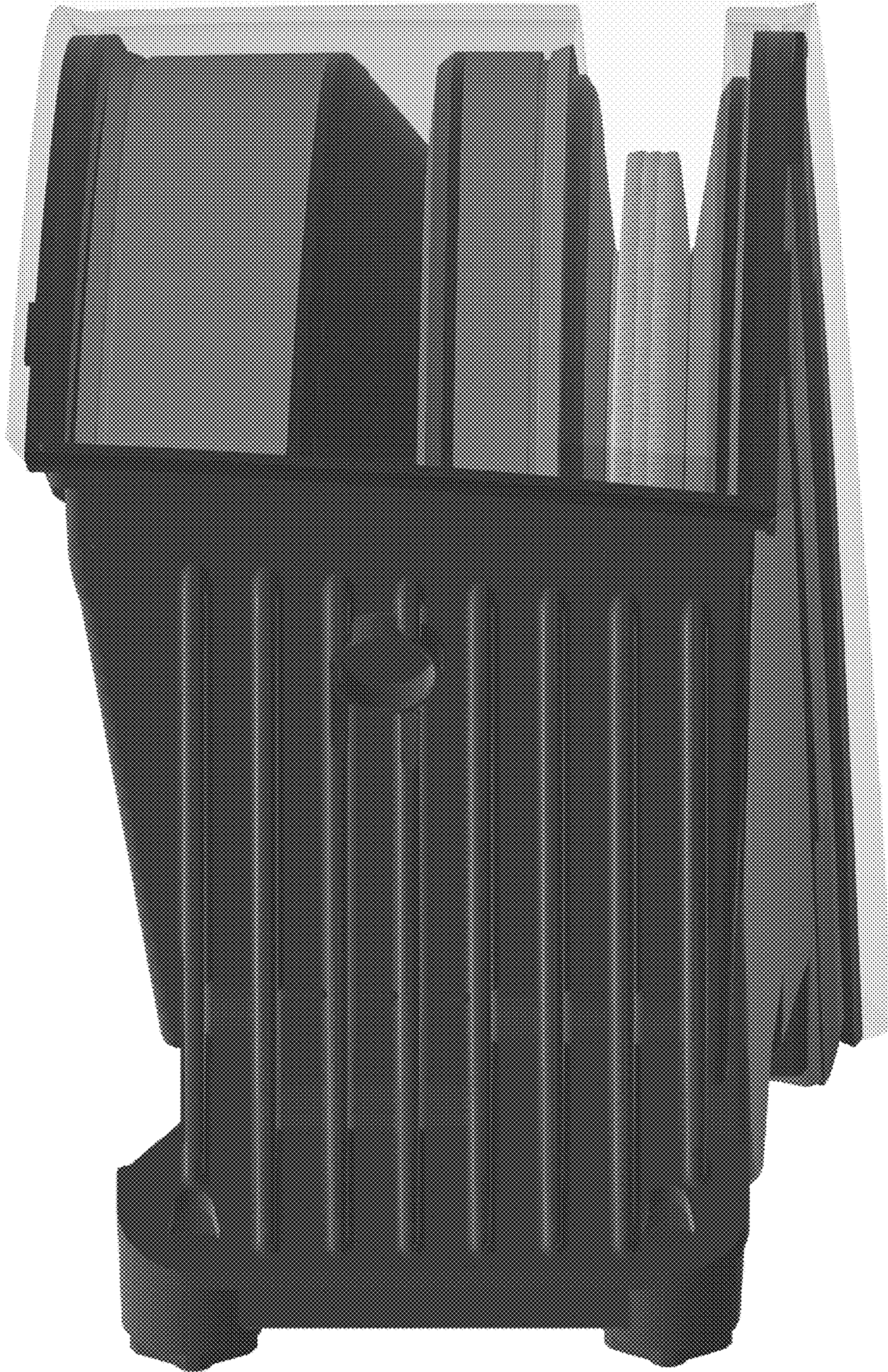

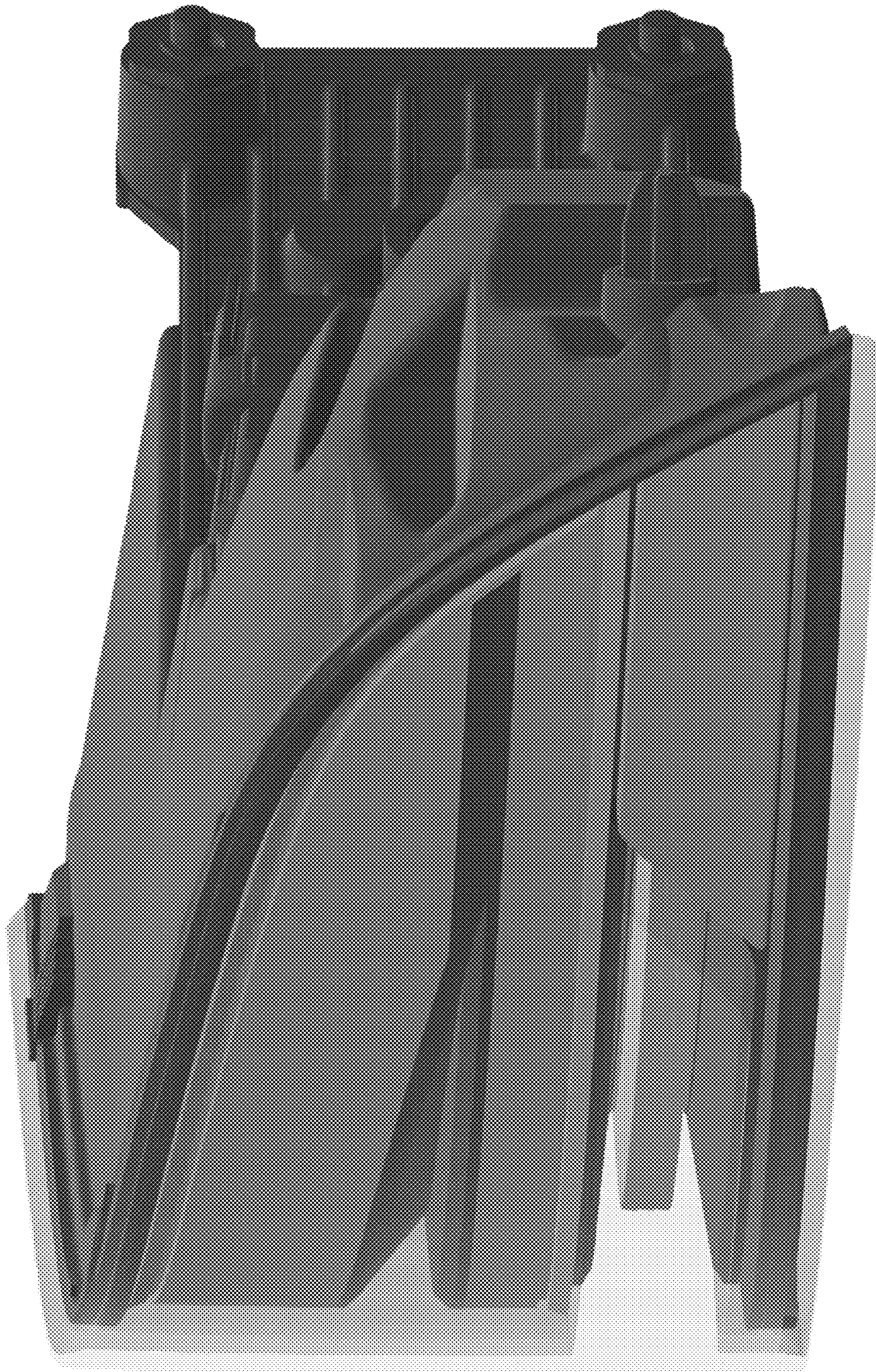

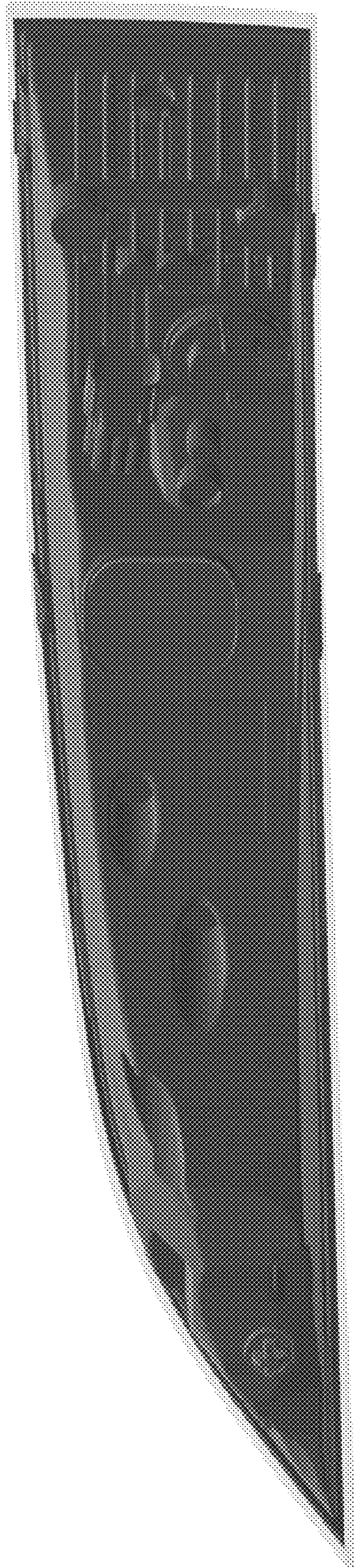

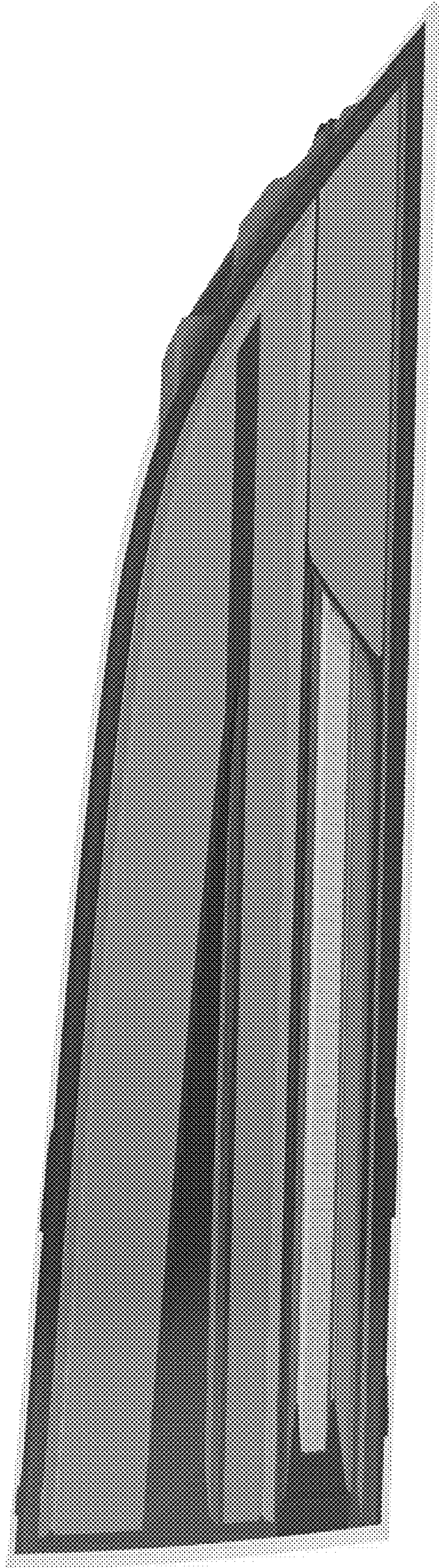

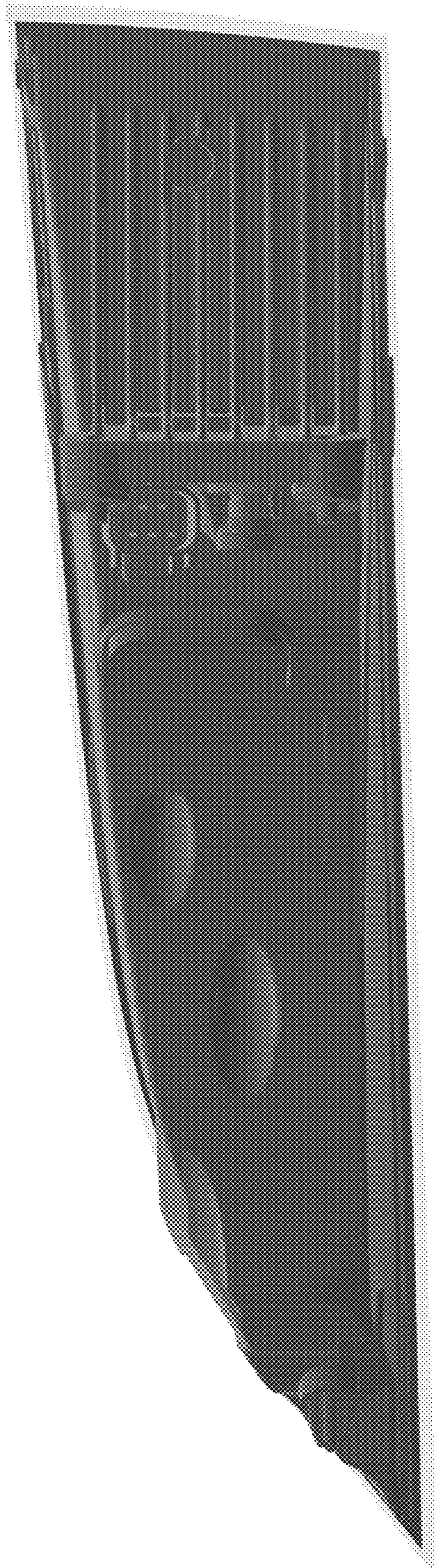

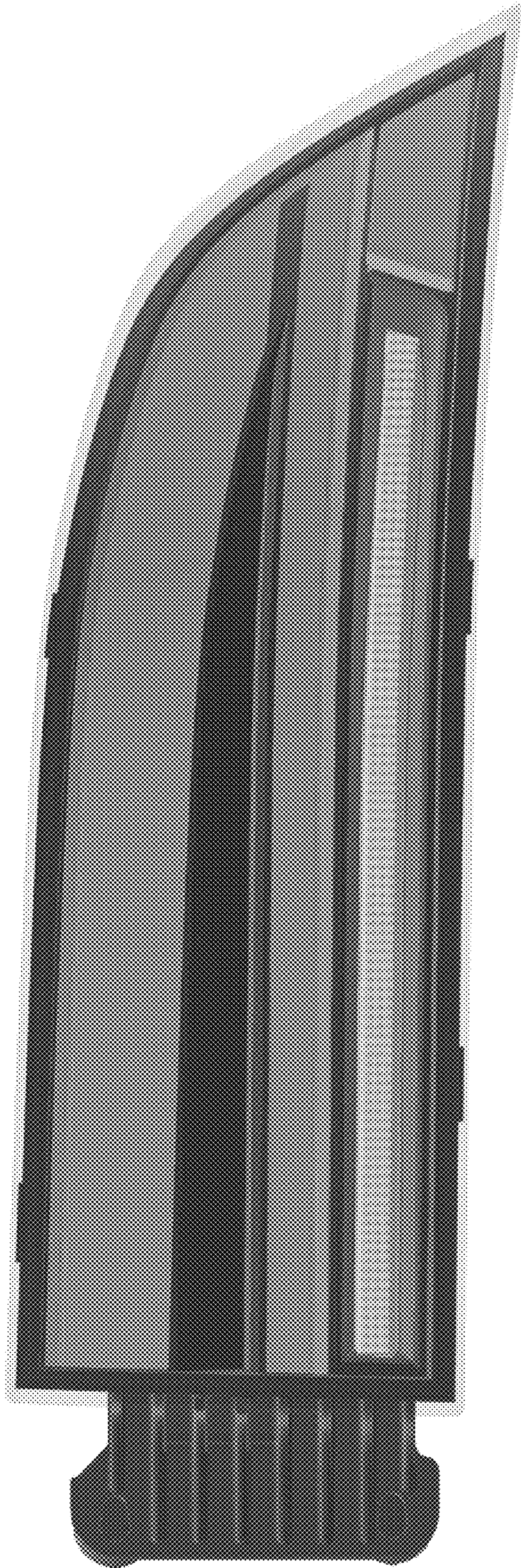

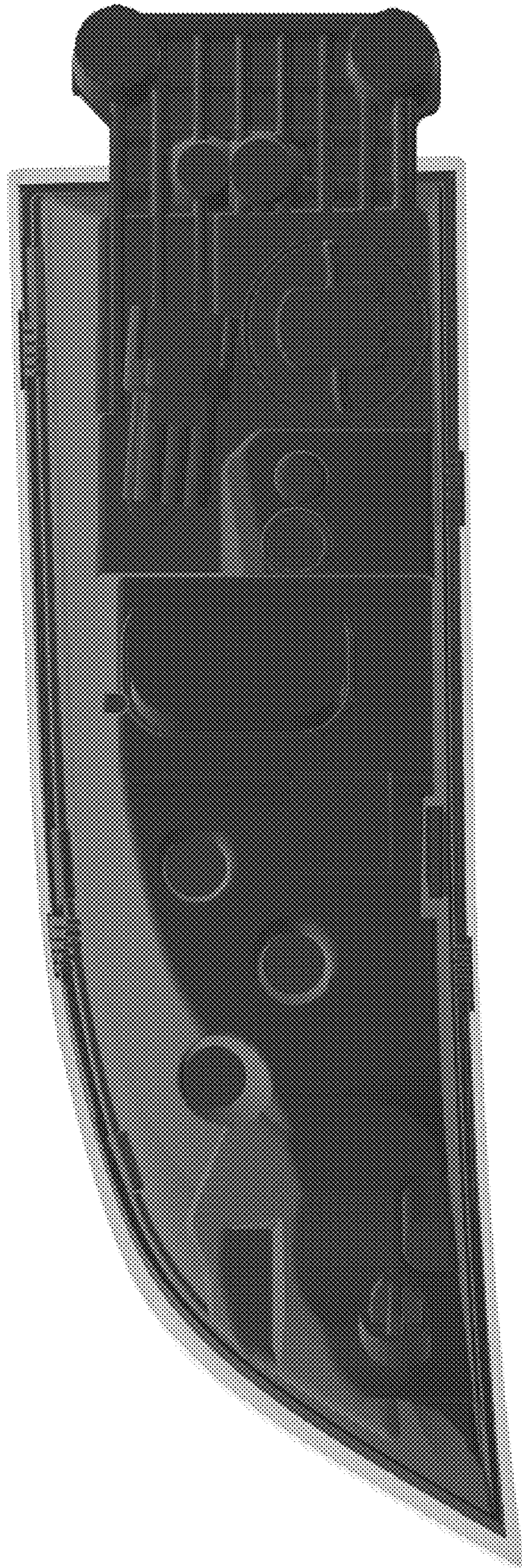

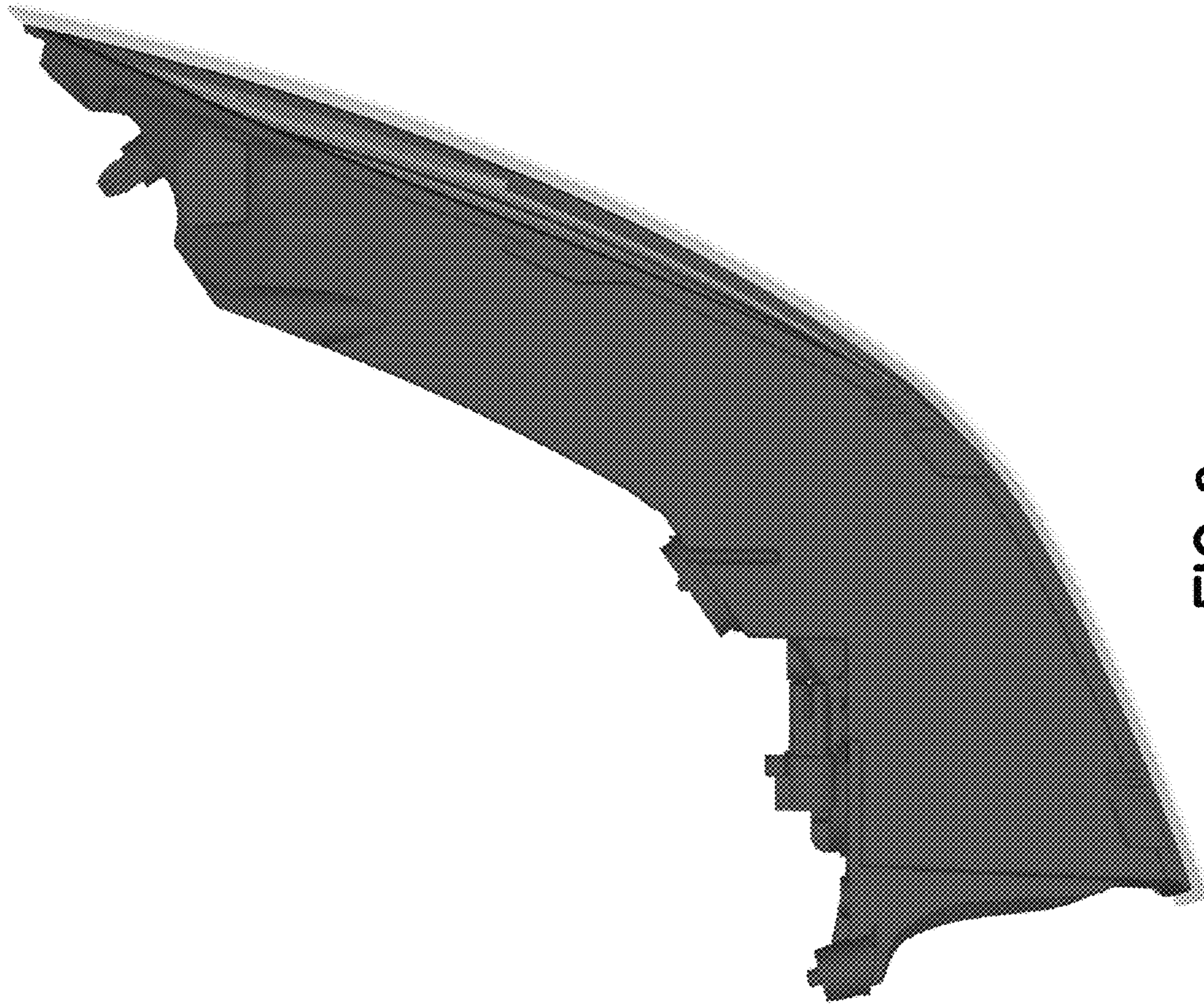

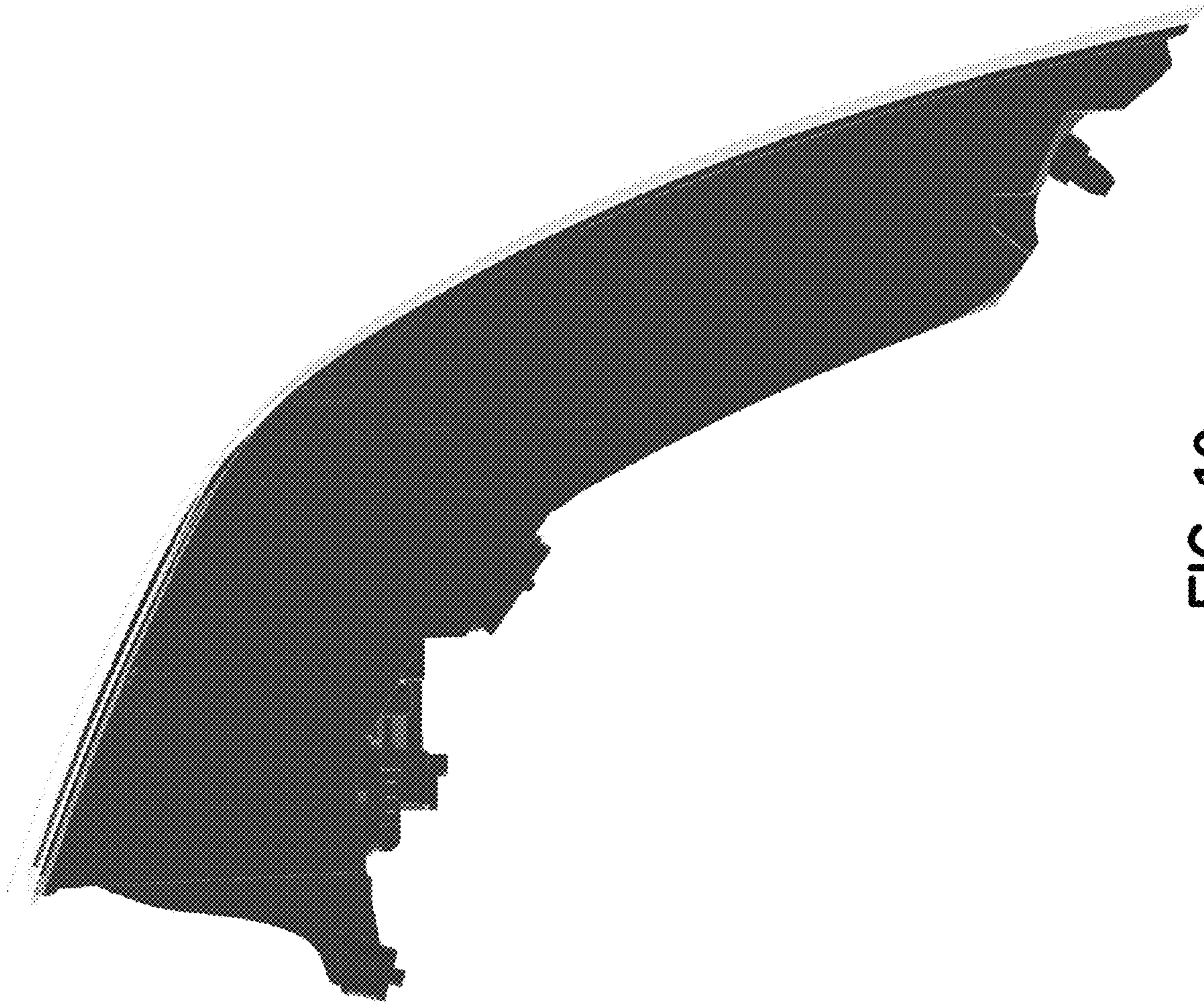

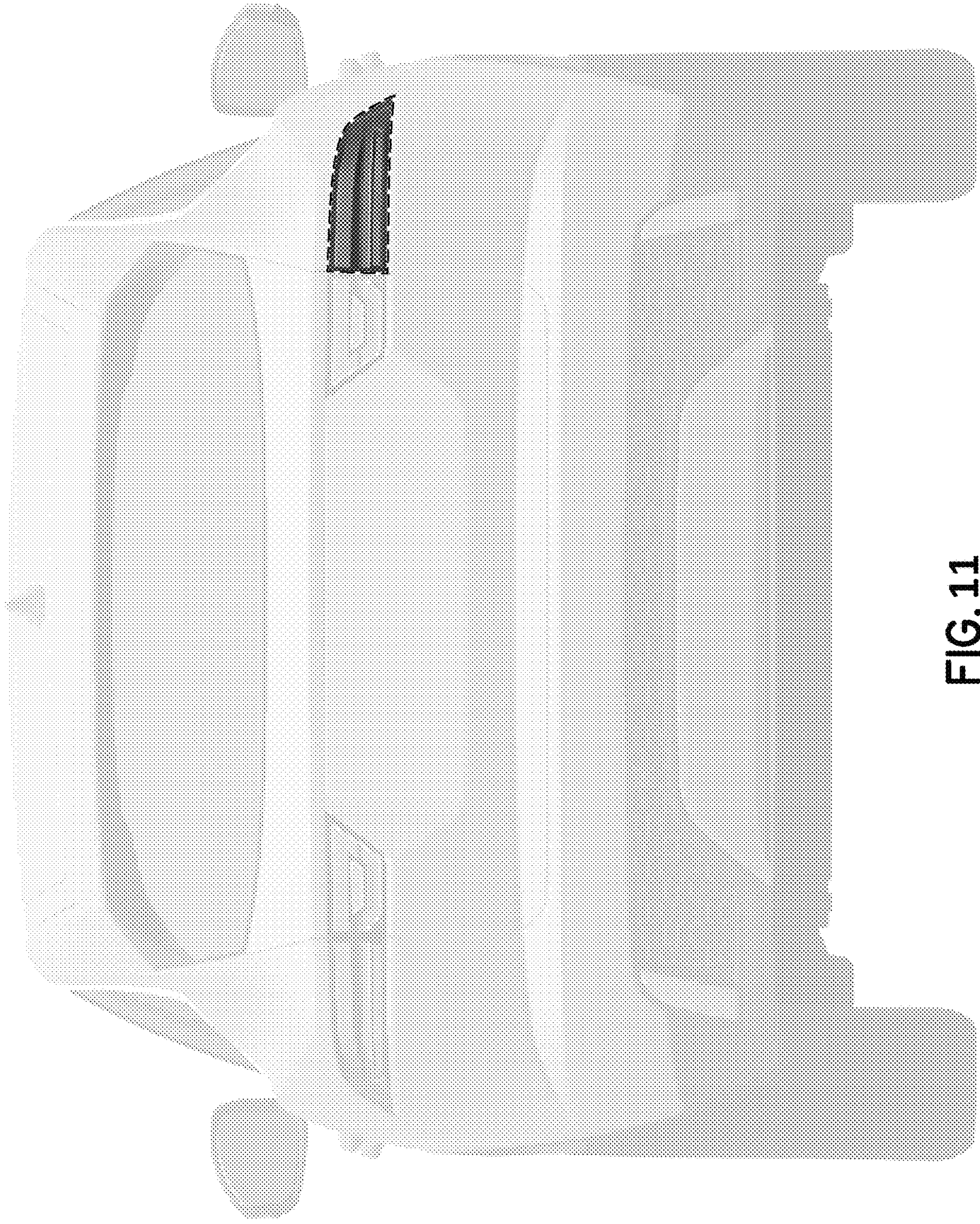

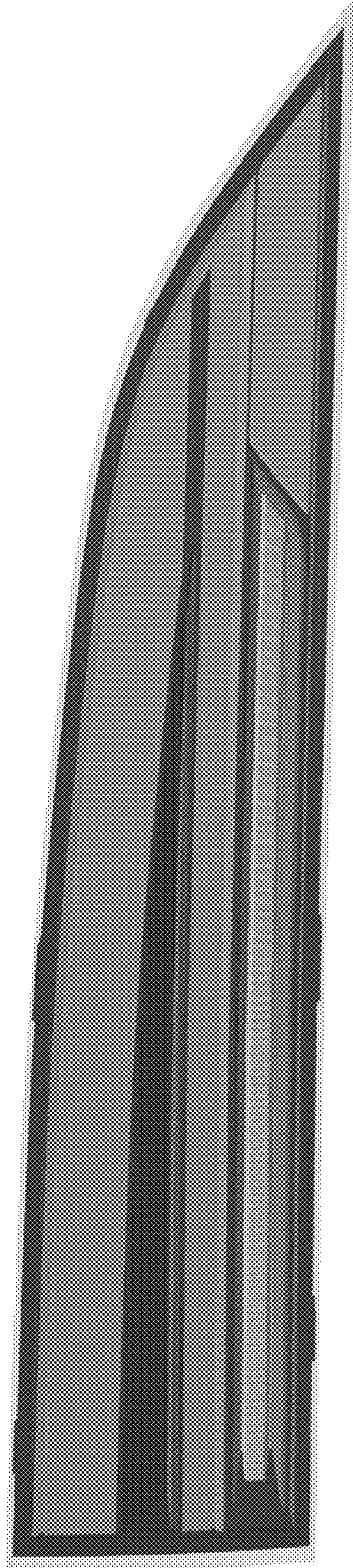

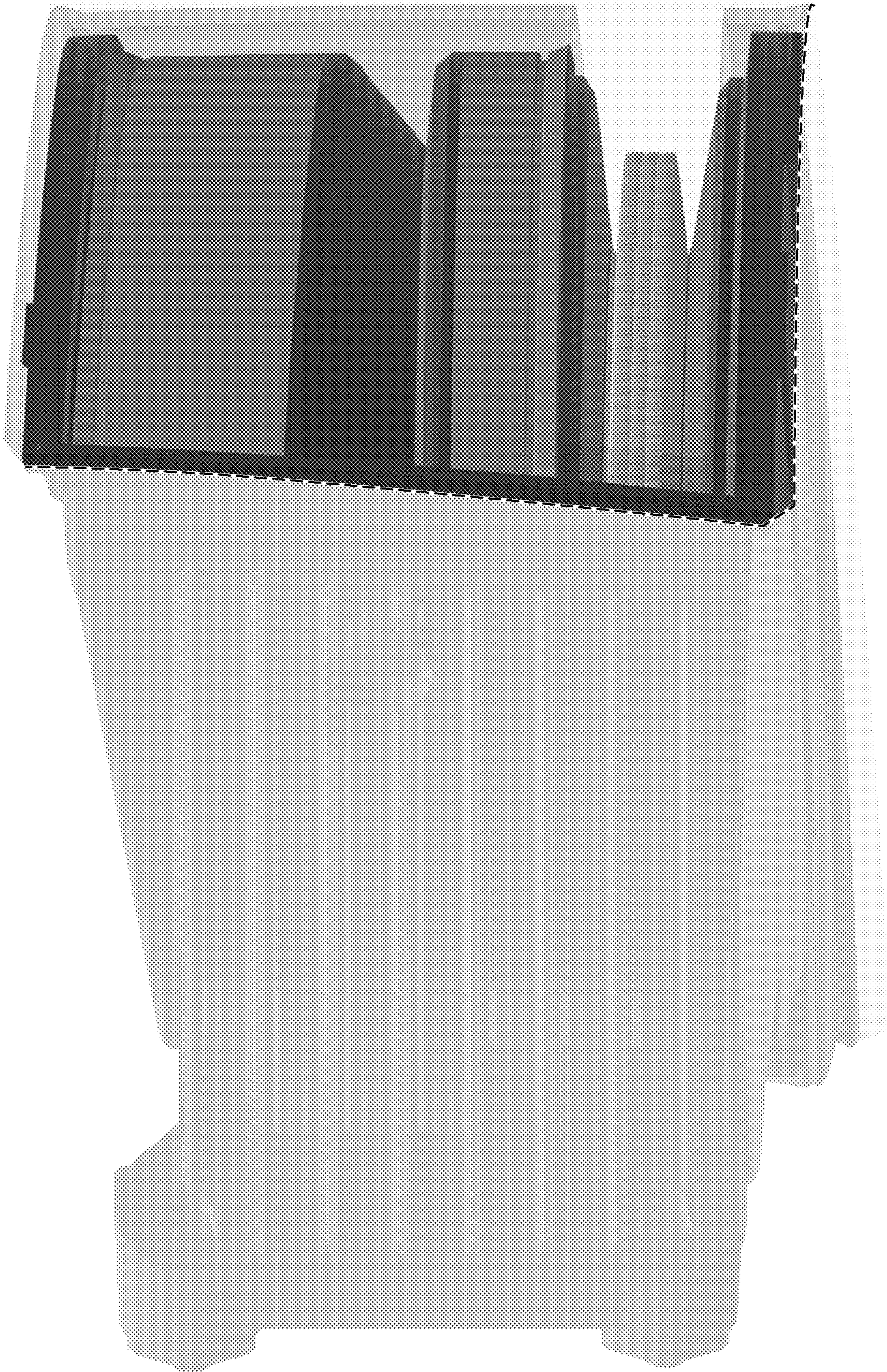

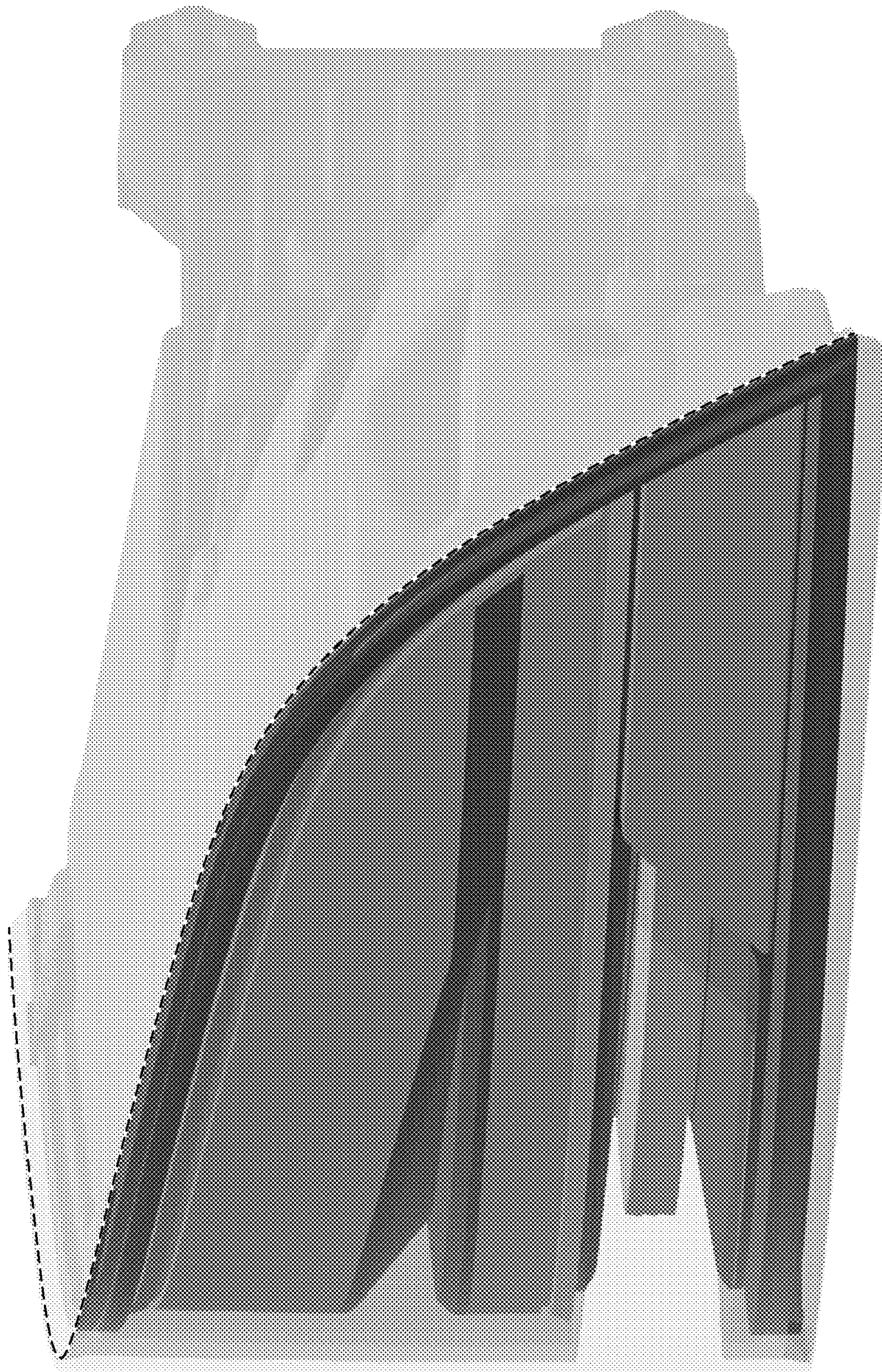

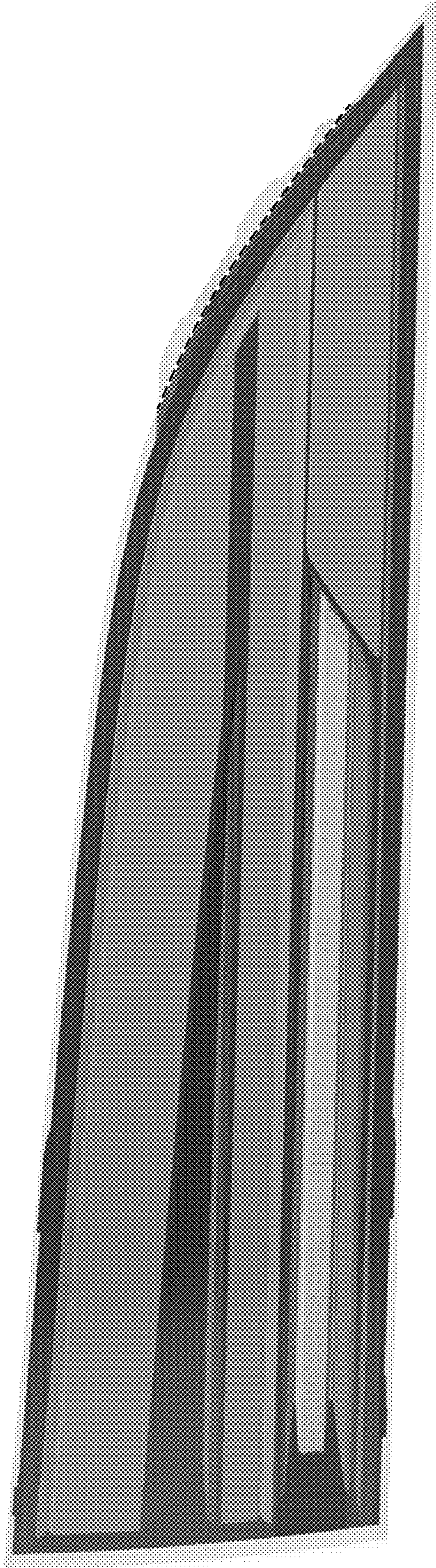

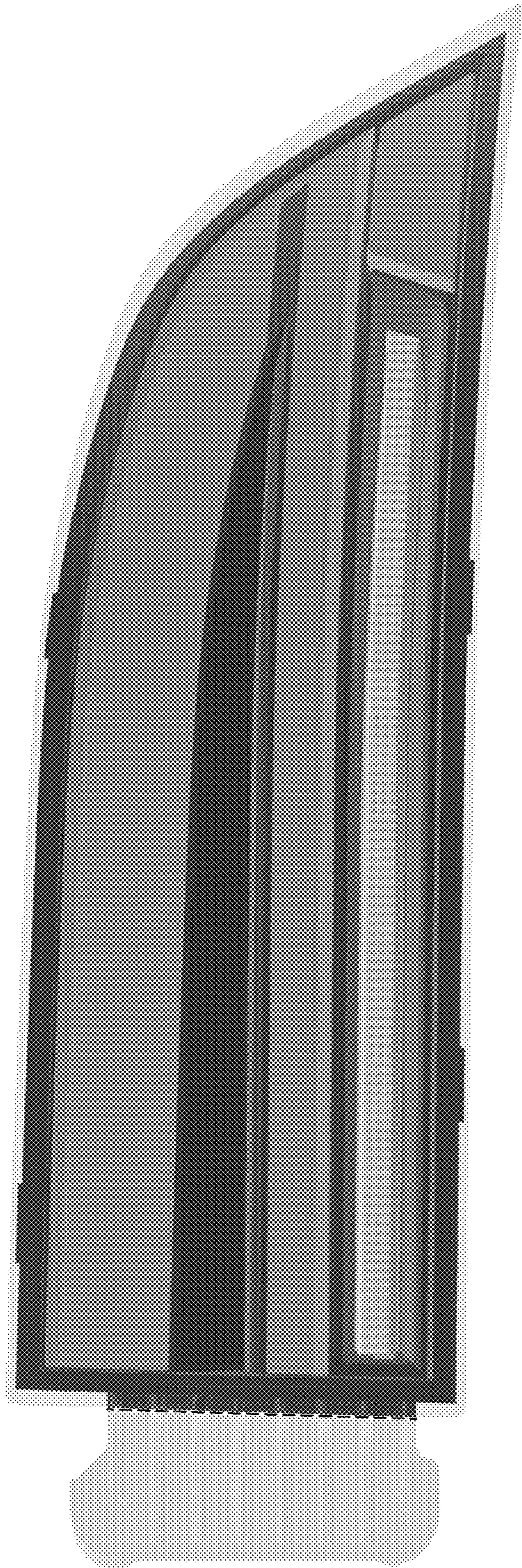

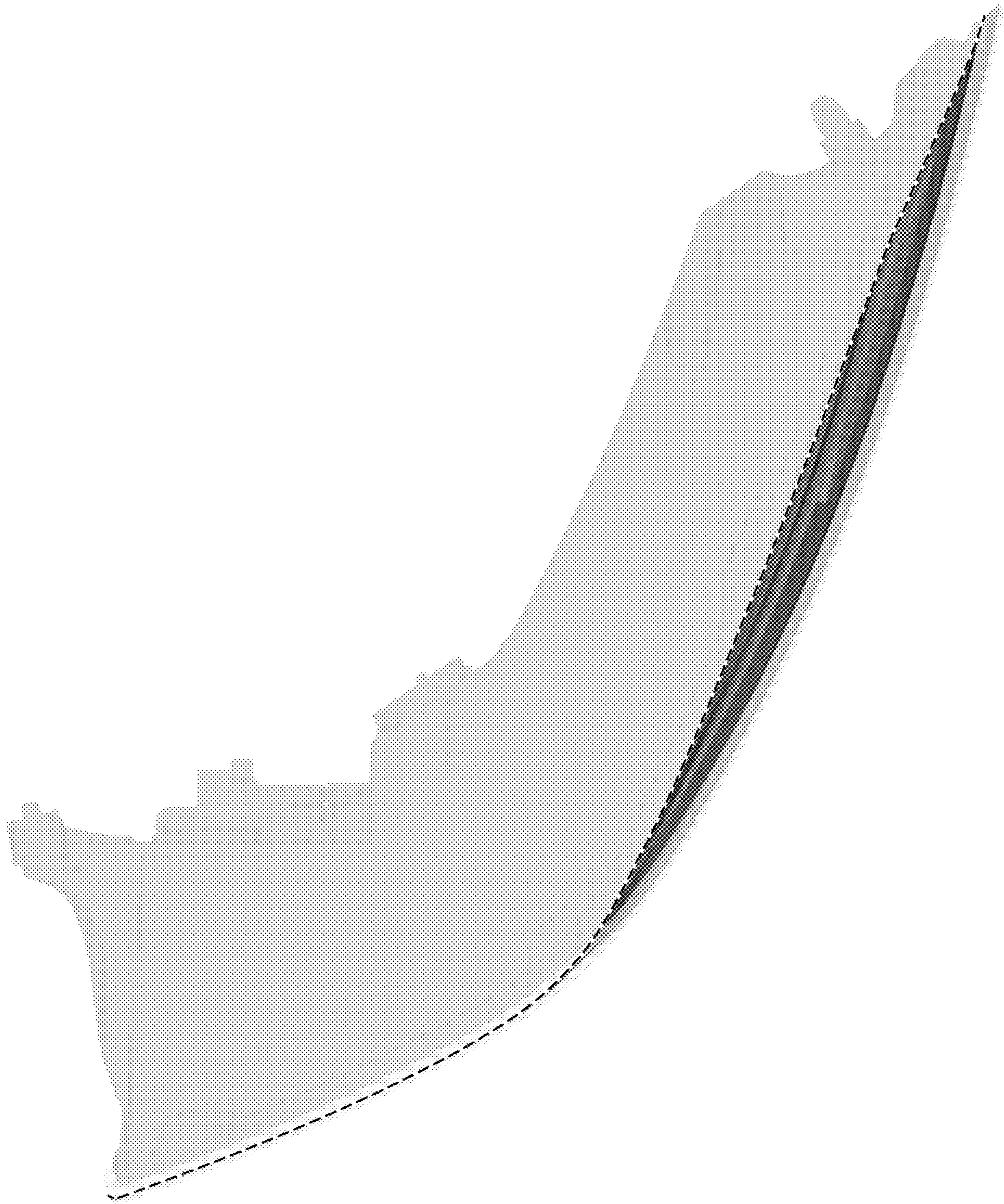

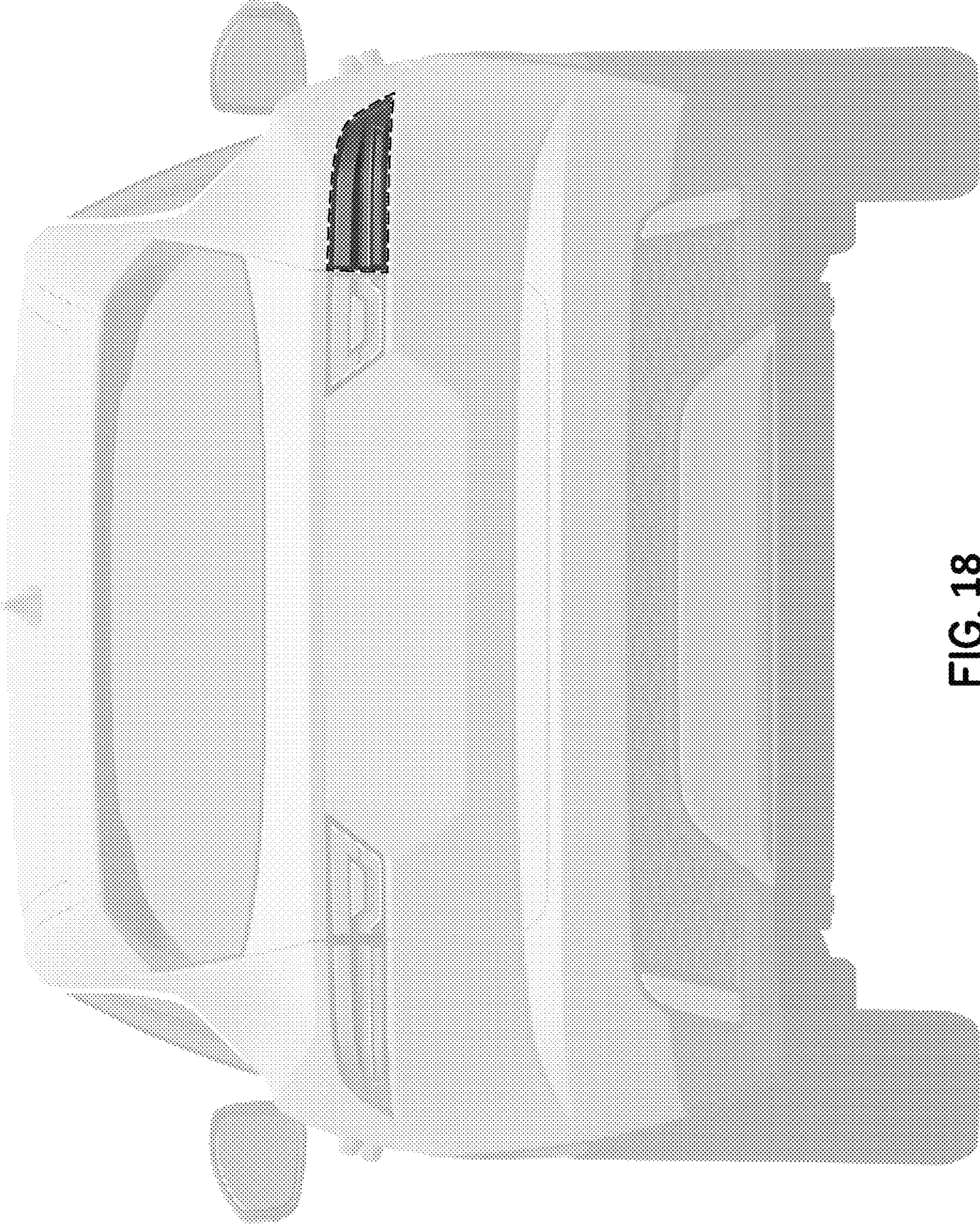
