Fig. 2.3 is rear view thereof;

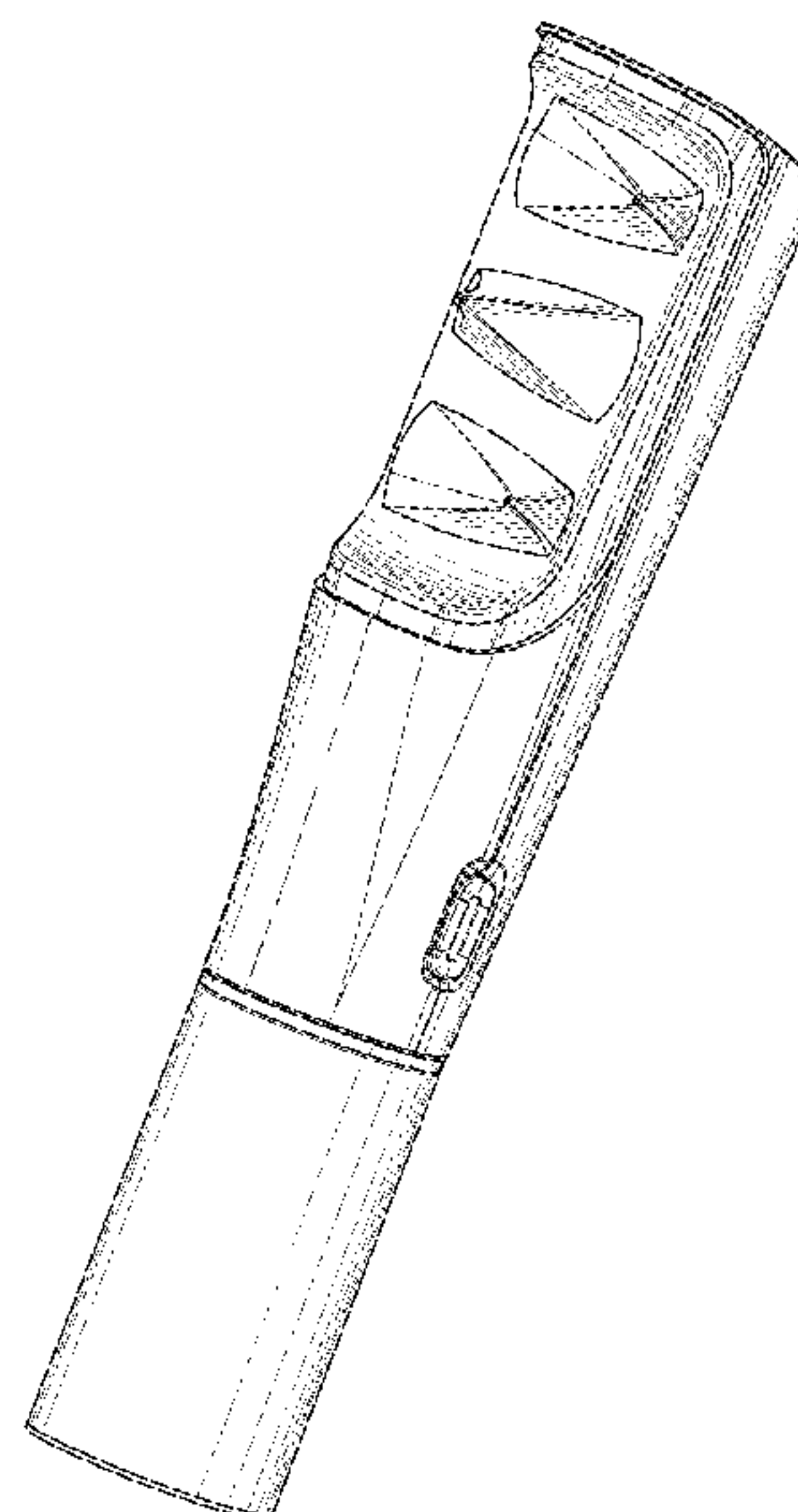
Fig. 2.4 is a front perspective view thereof;

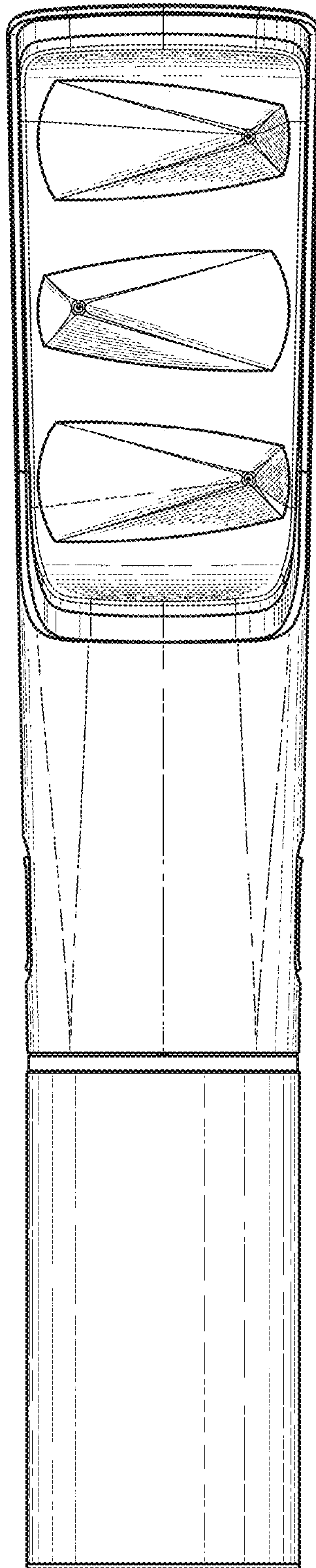

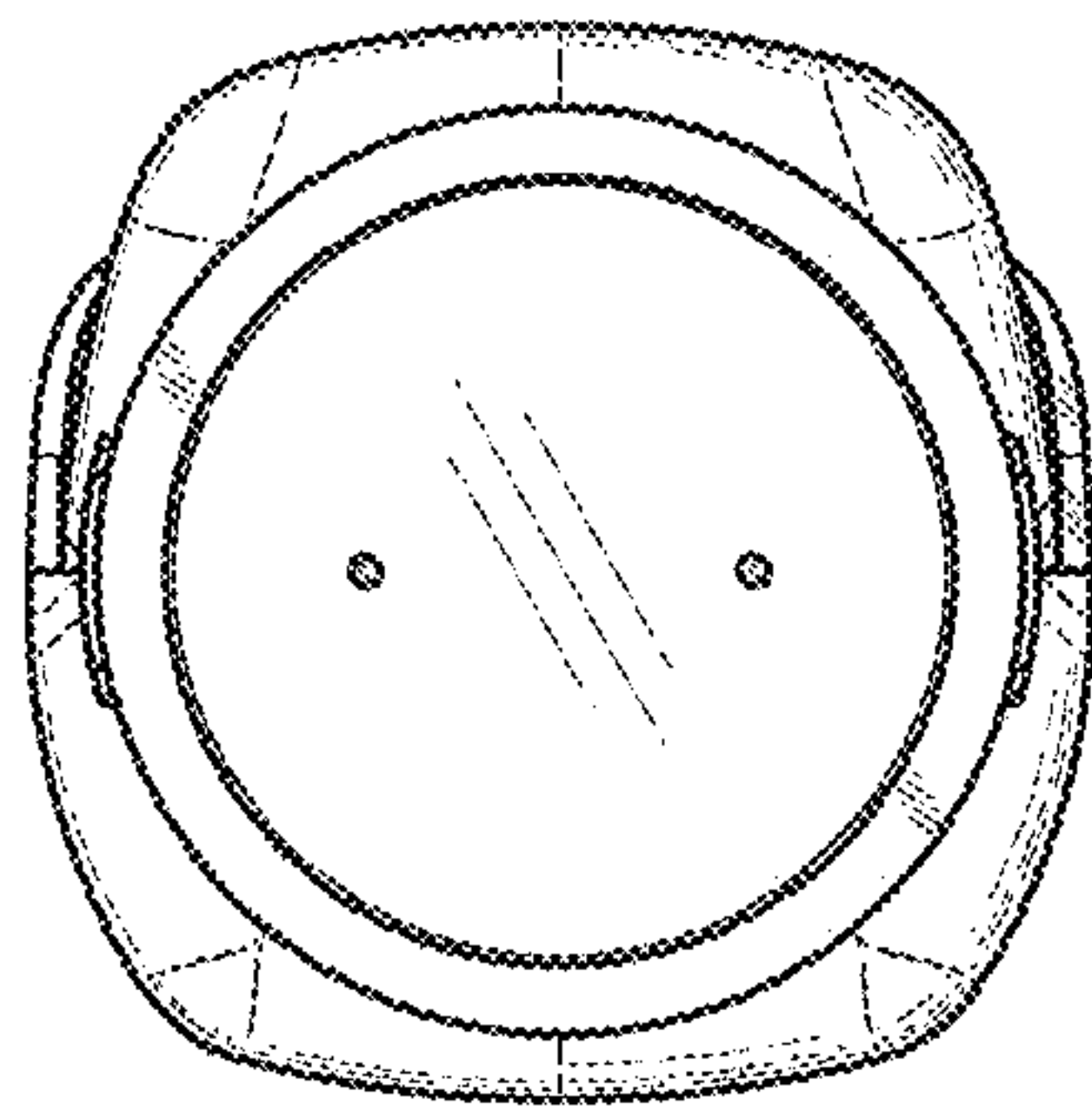

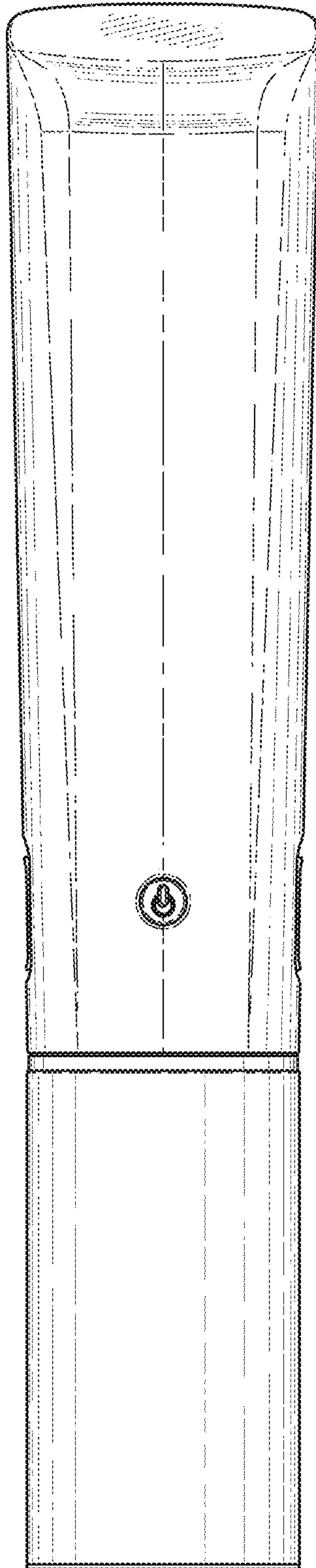

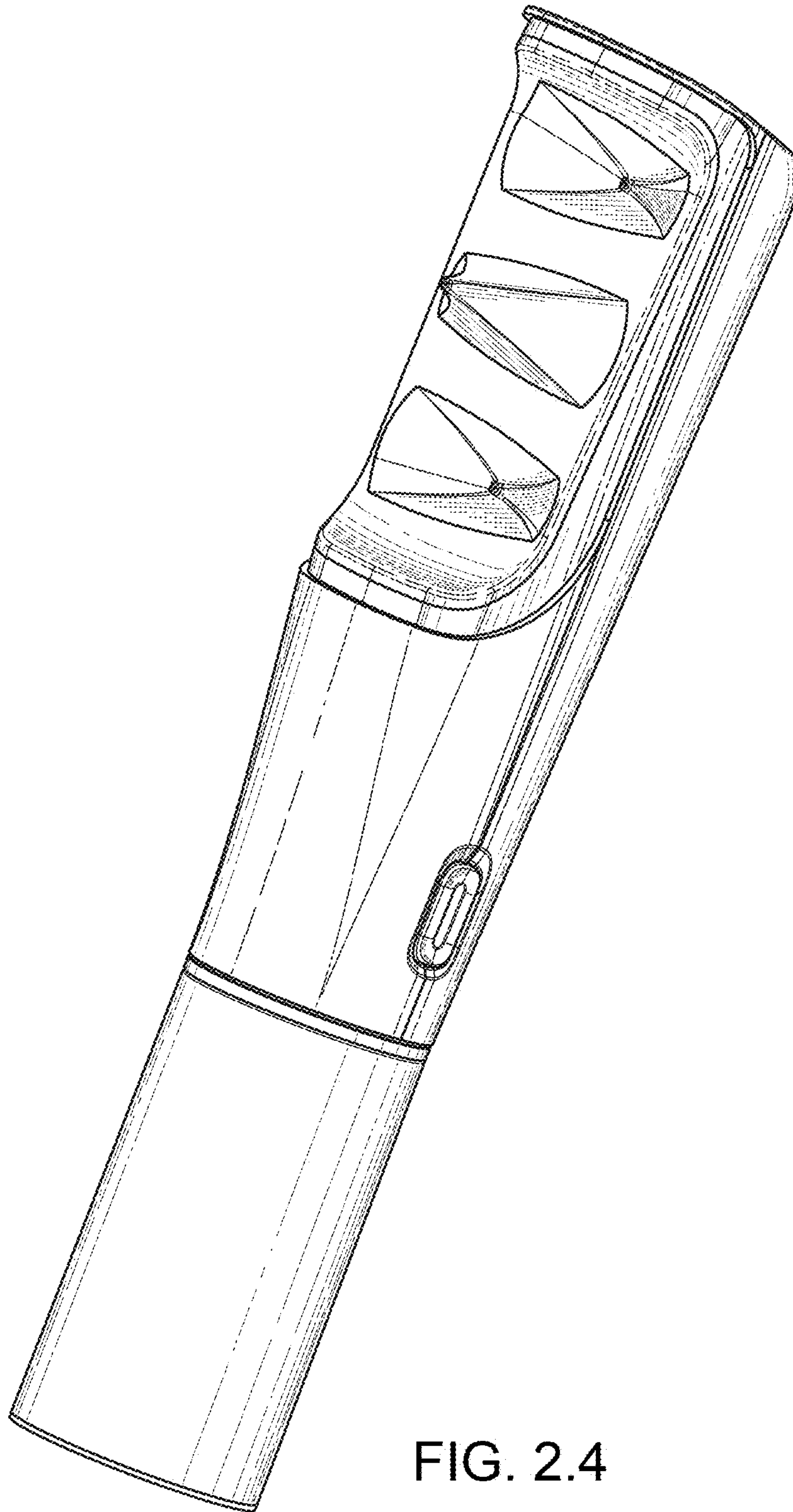

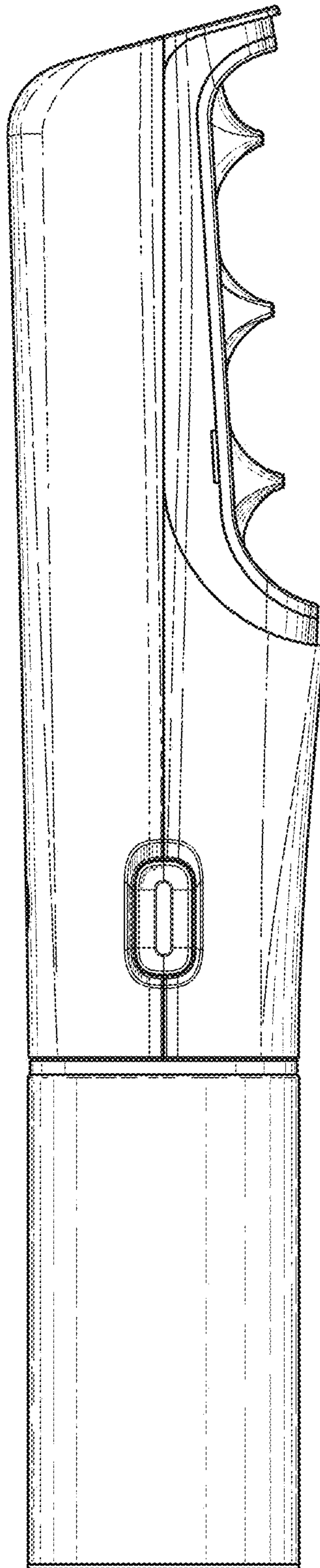

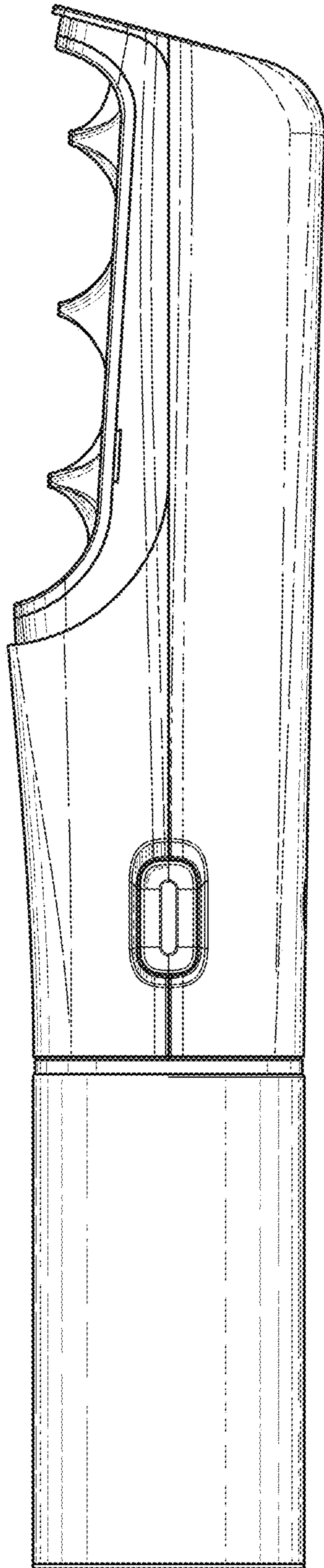

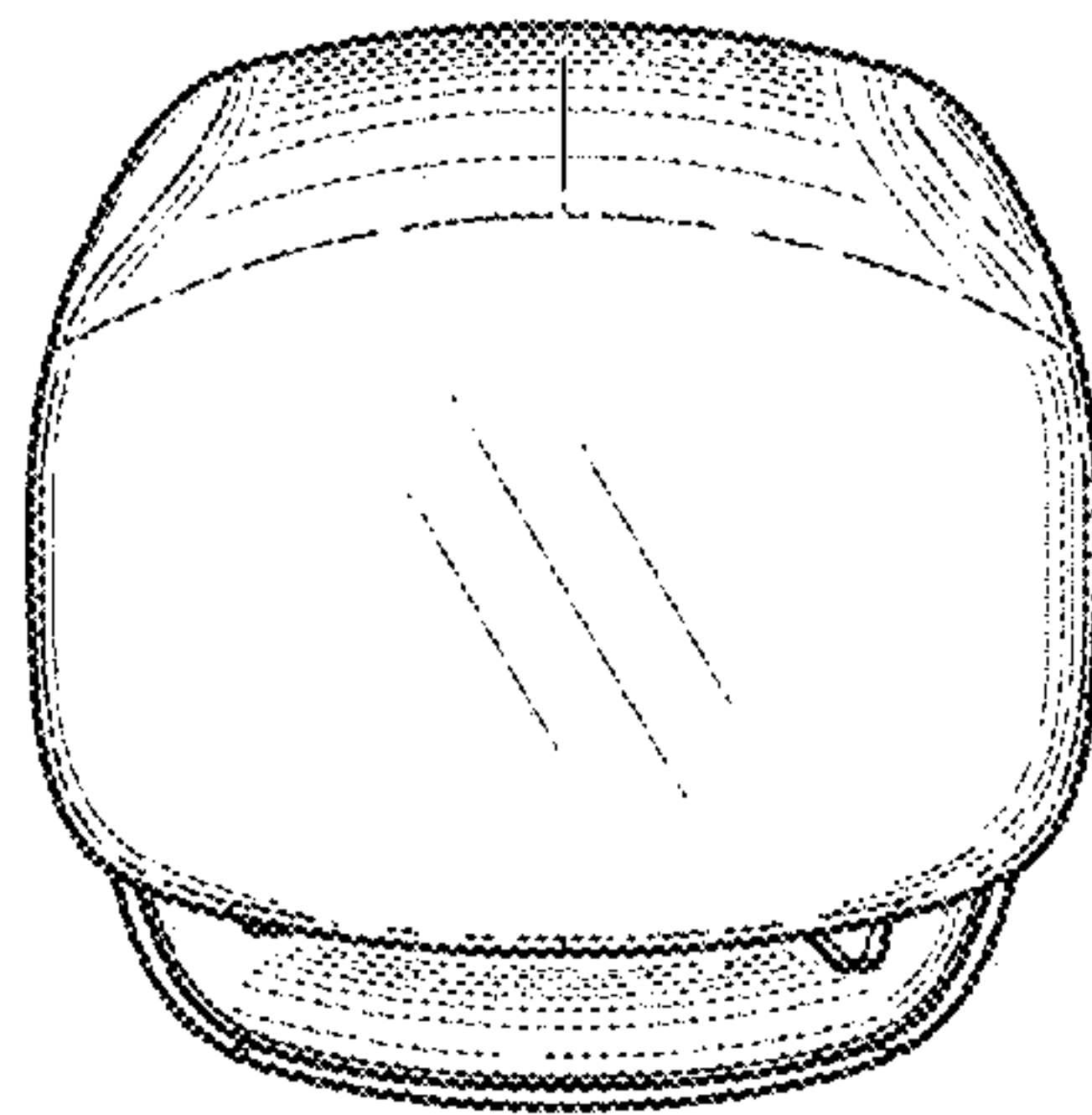
