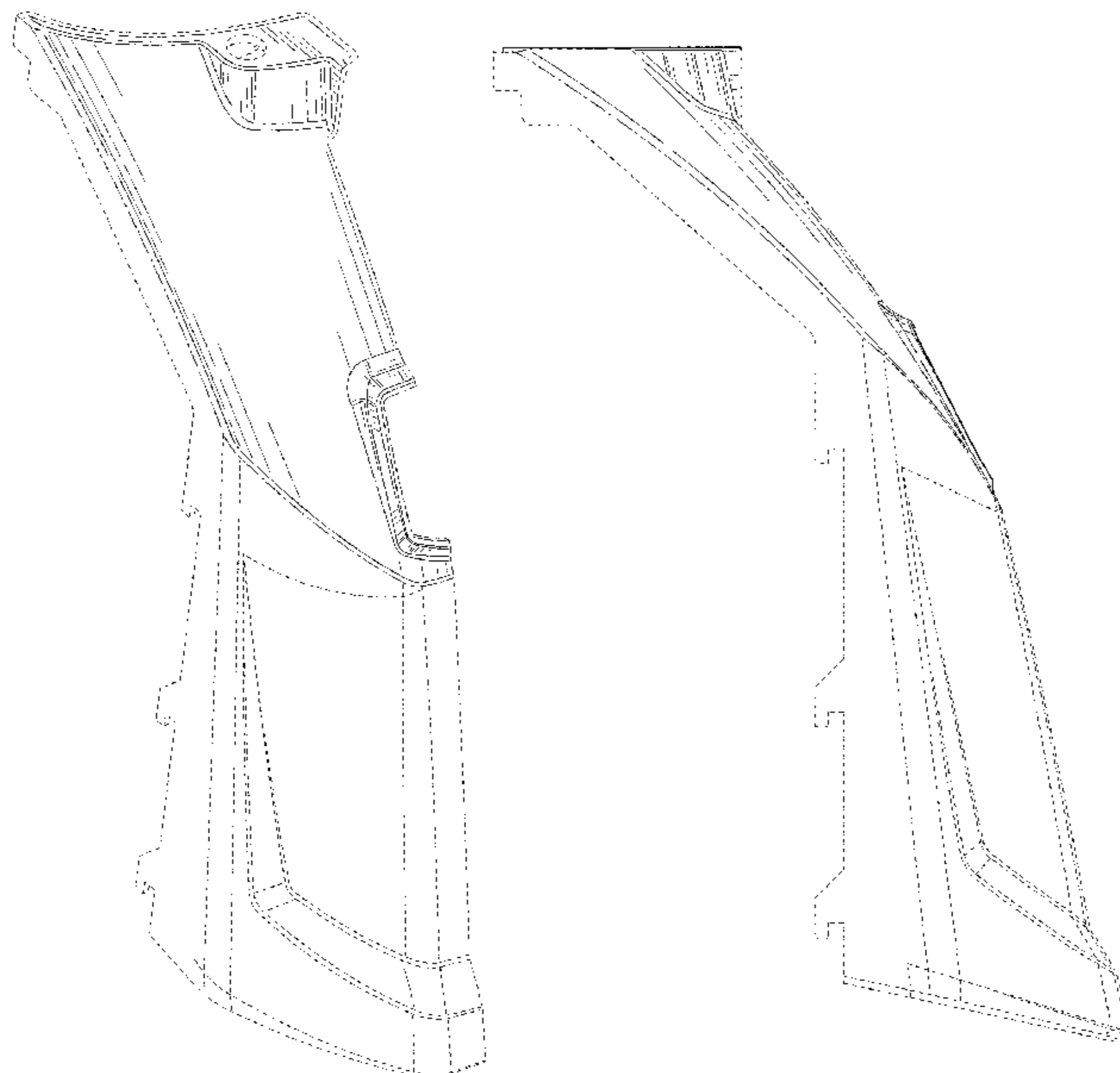
(57) **CLAIM**

The ornamental design for a vehicle cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, and front isometric view of an ornamental design for a vehicle cover;
FIG. 2 is a left side elevational view of the vehicle cover of FIG. 1;
FIG. 3 is a front elevational view of the vehicle cover of FIG. 1; and,
FIG. 4 is a top plan view of the vehicle cover of FIG. 1.
The dash-dash-dash lines are included for the purpose of illustrating portions of the vehicle cover that form no part of the claimed design. The dash-dot-dash broken lines depict boundary lines and form no part of the claimed design.

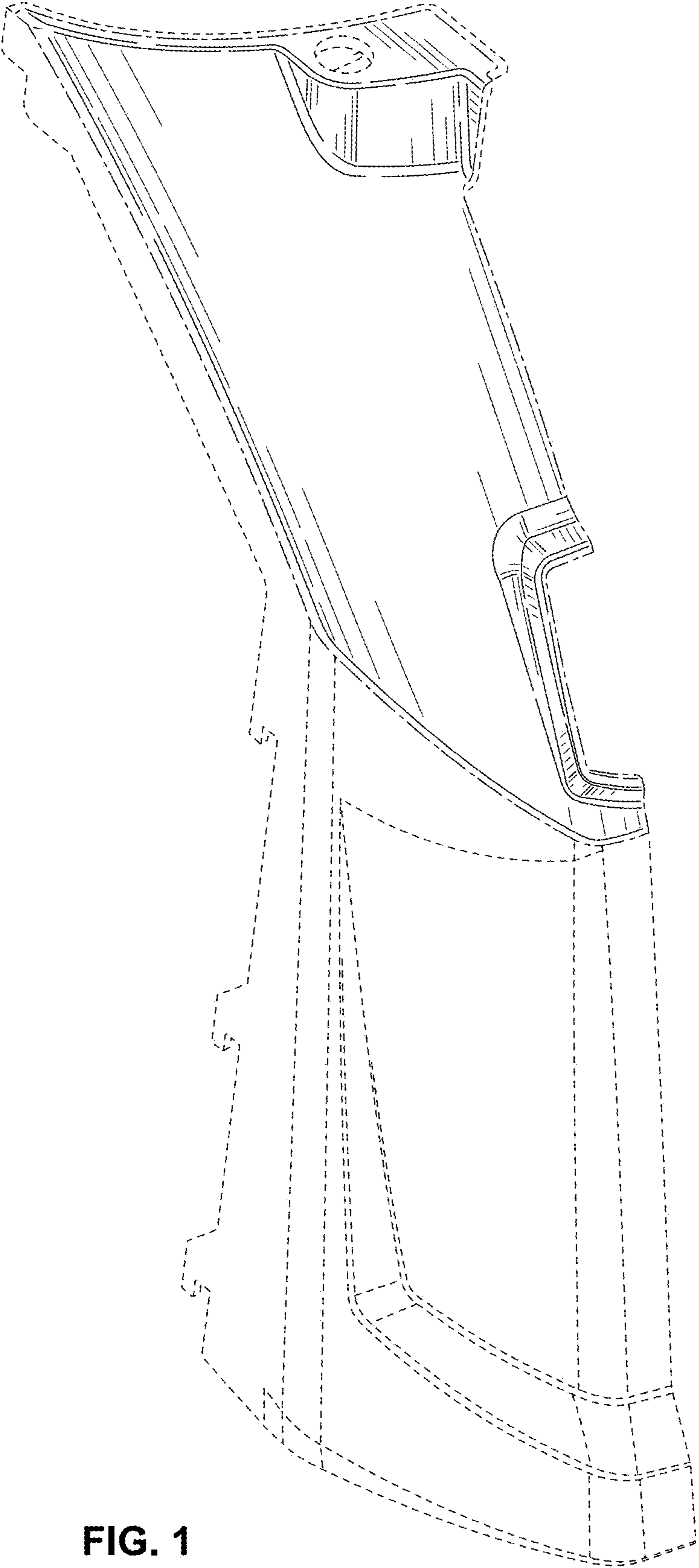

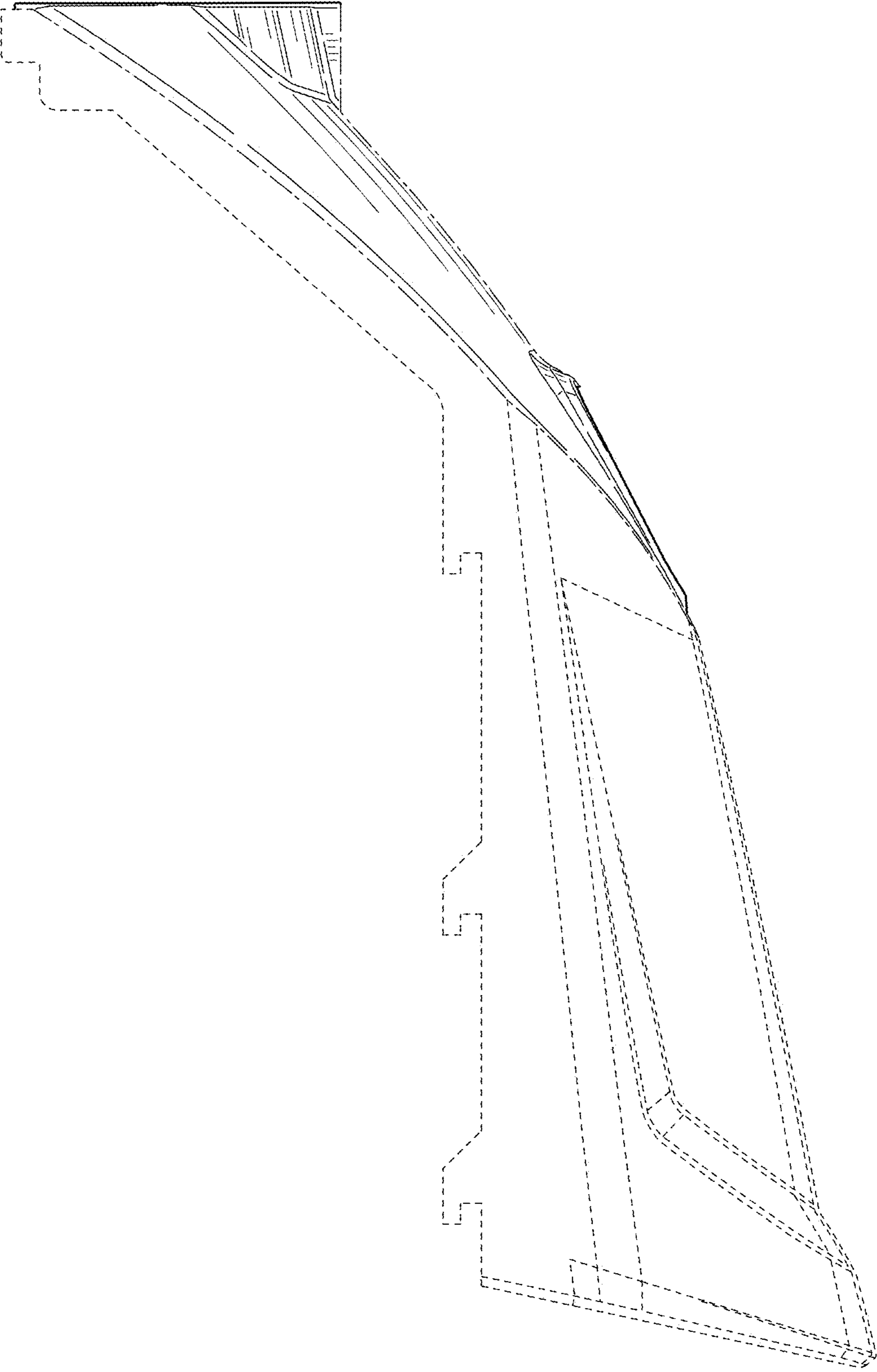

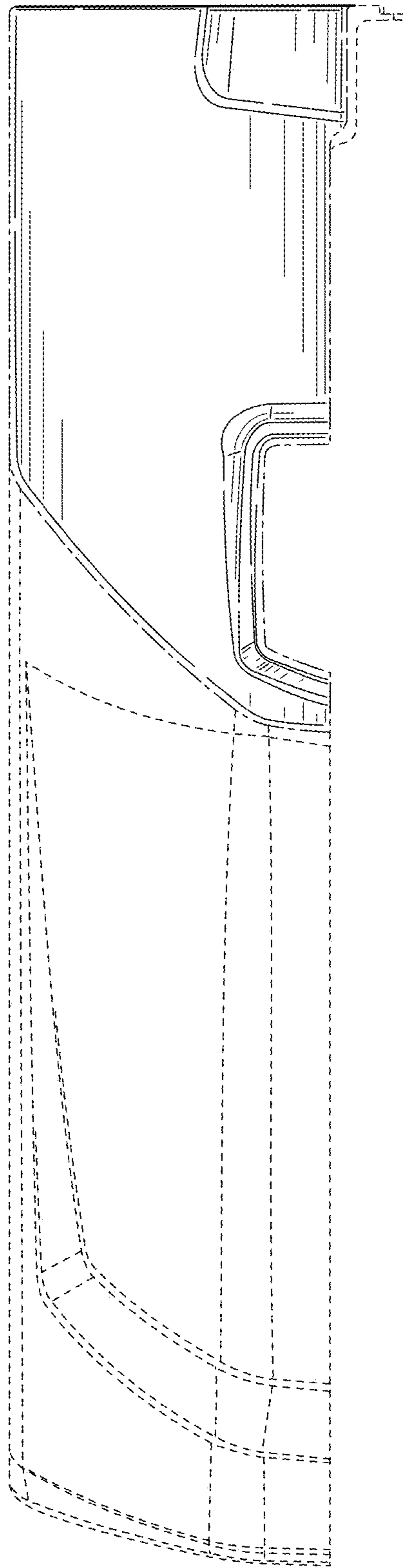

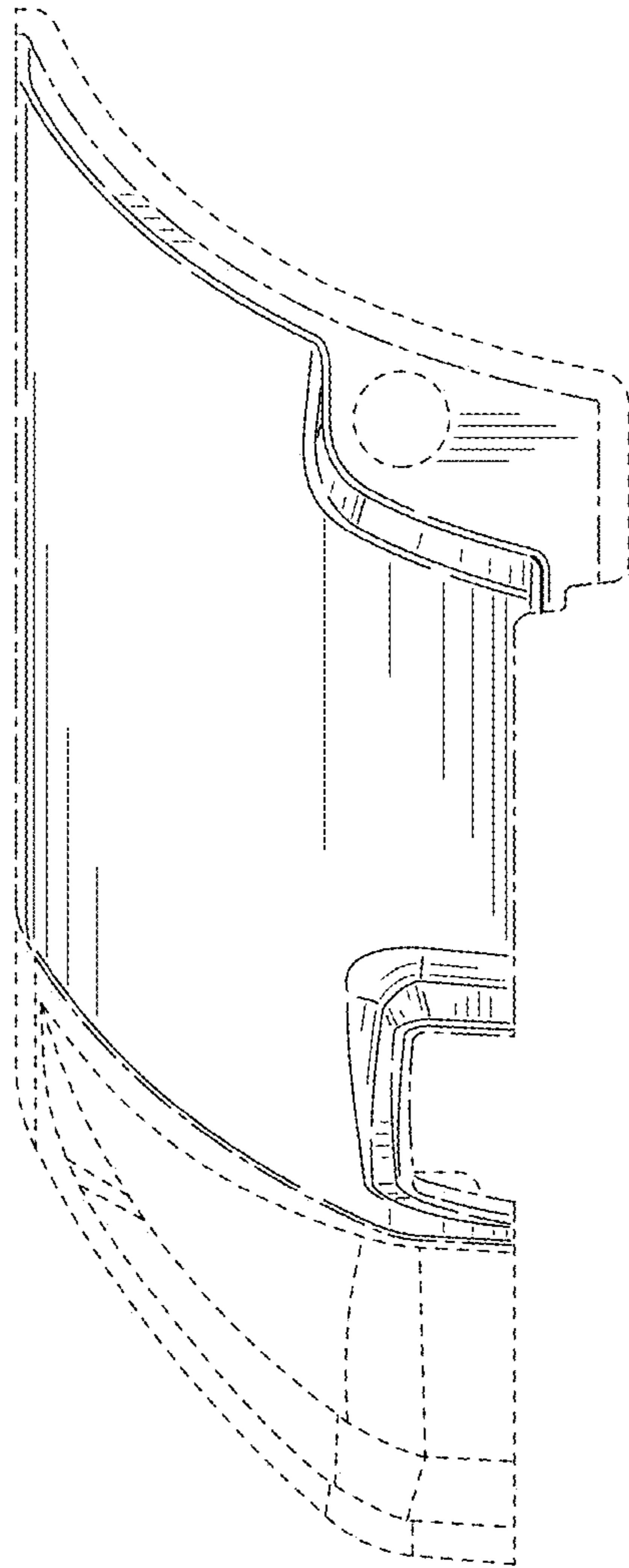
