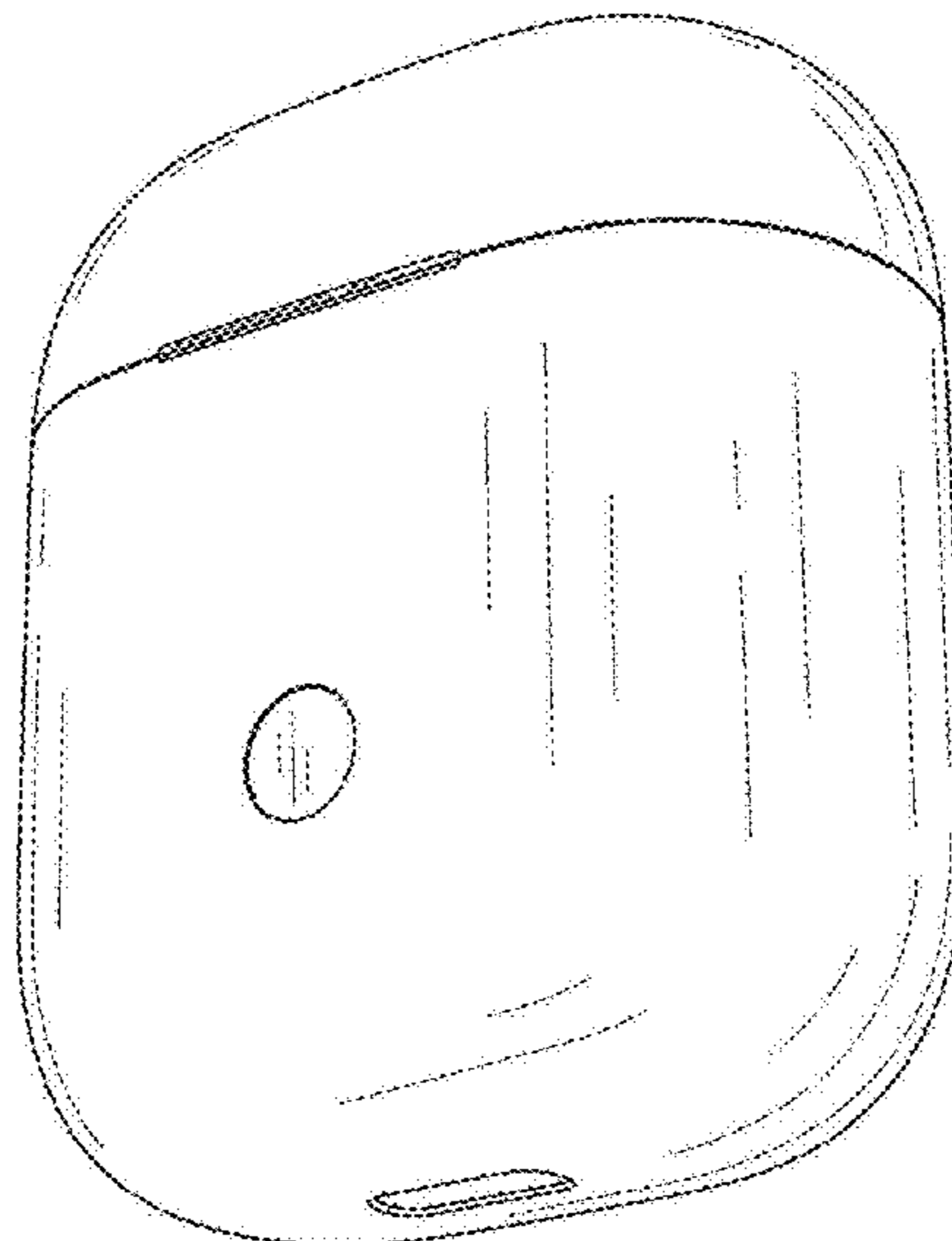

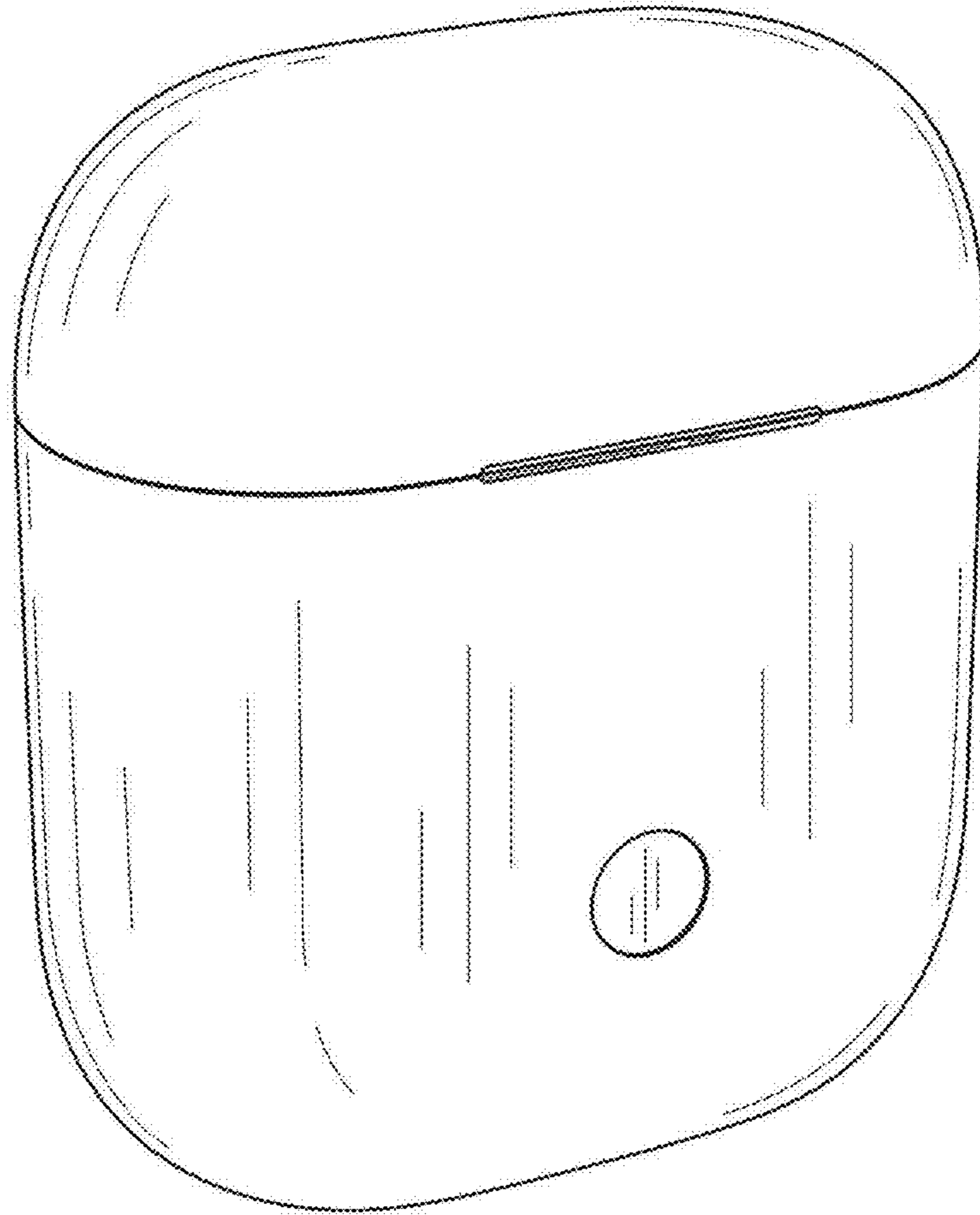
The ornamental design for a case for earphone, as shown and described.

**DESCRIPTION**

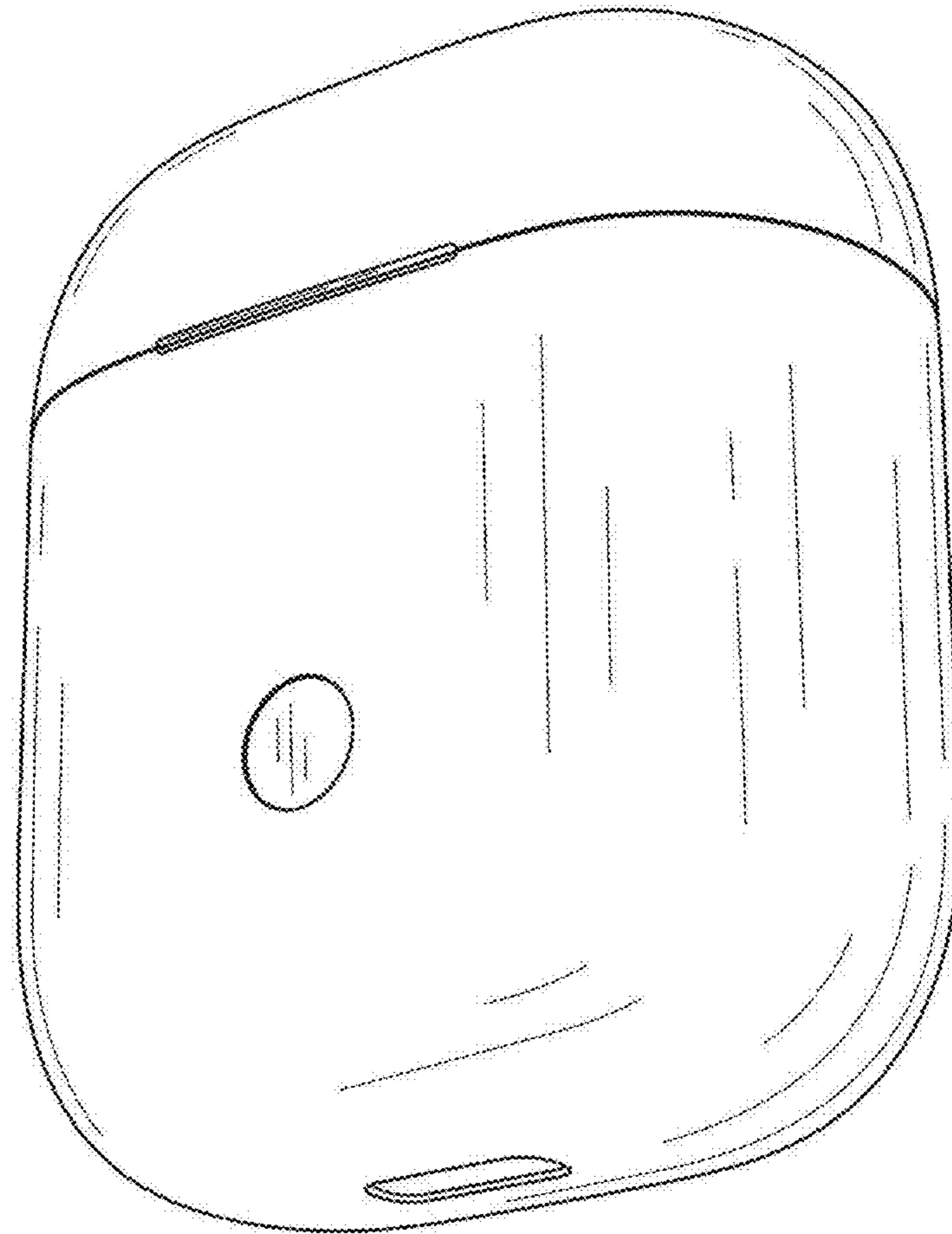
FIG. 1 is a front, left perspective view of a case for earphone showing our new design;

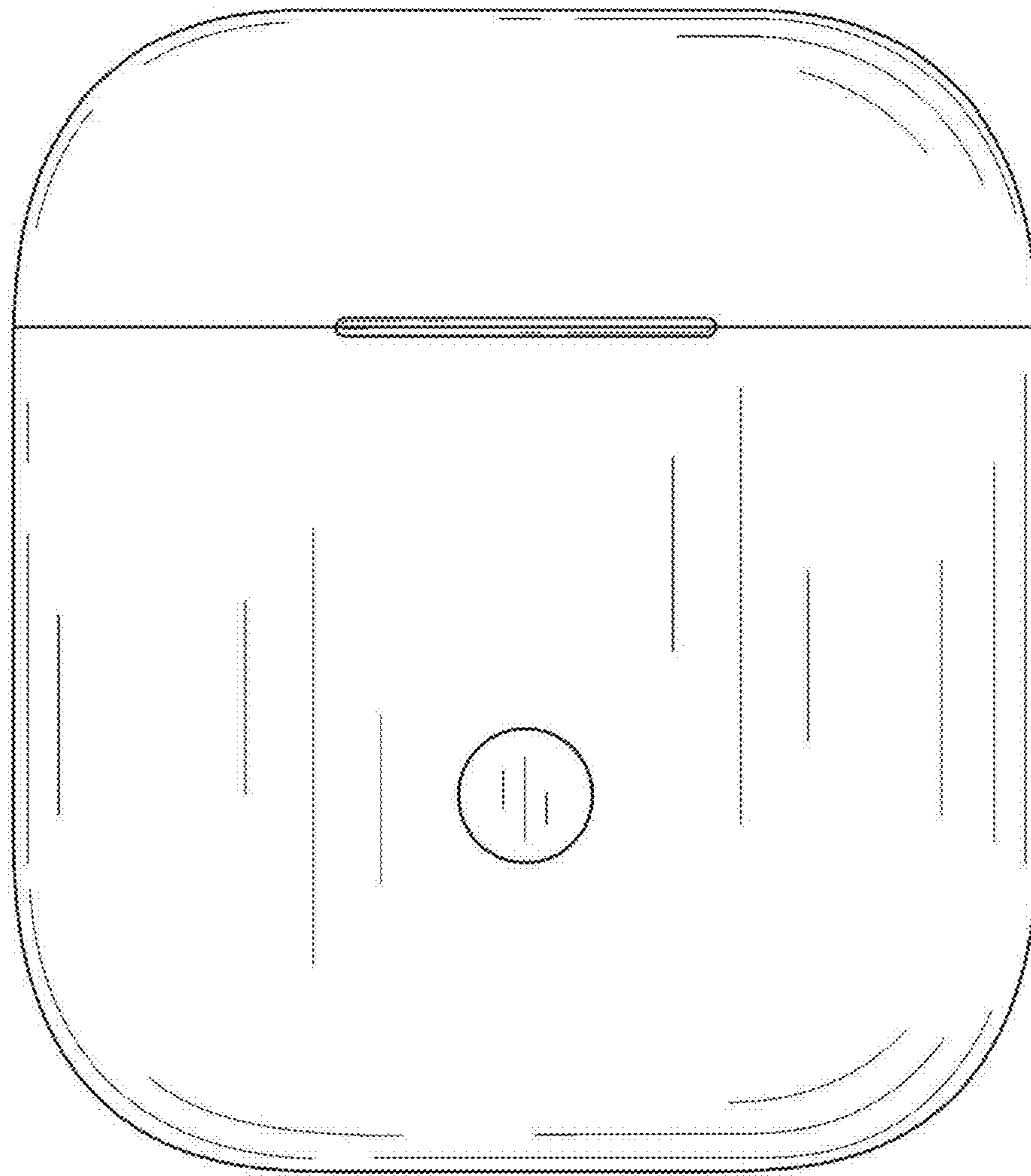




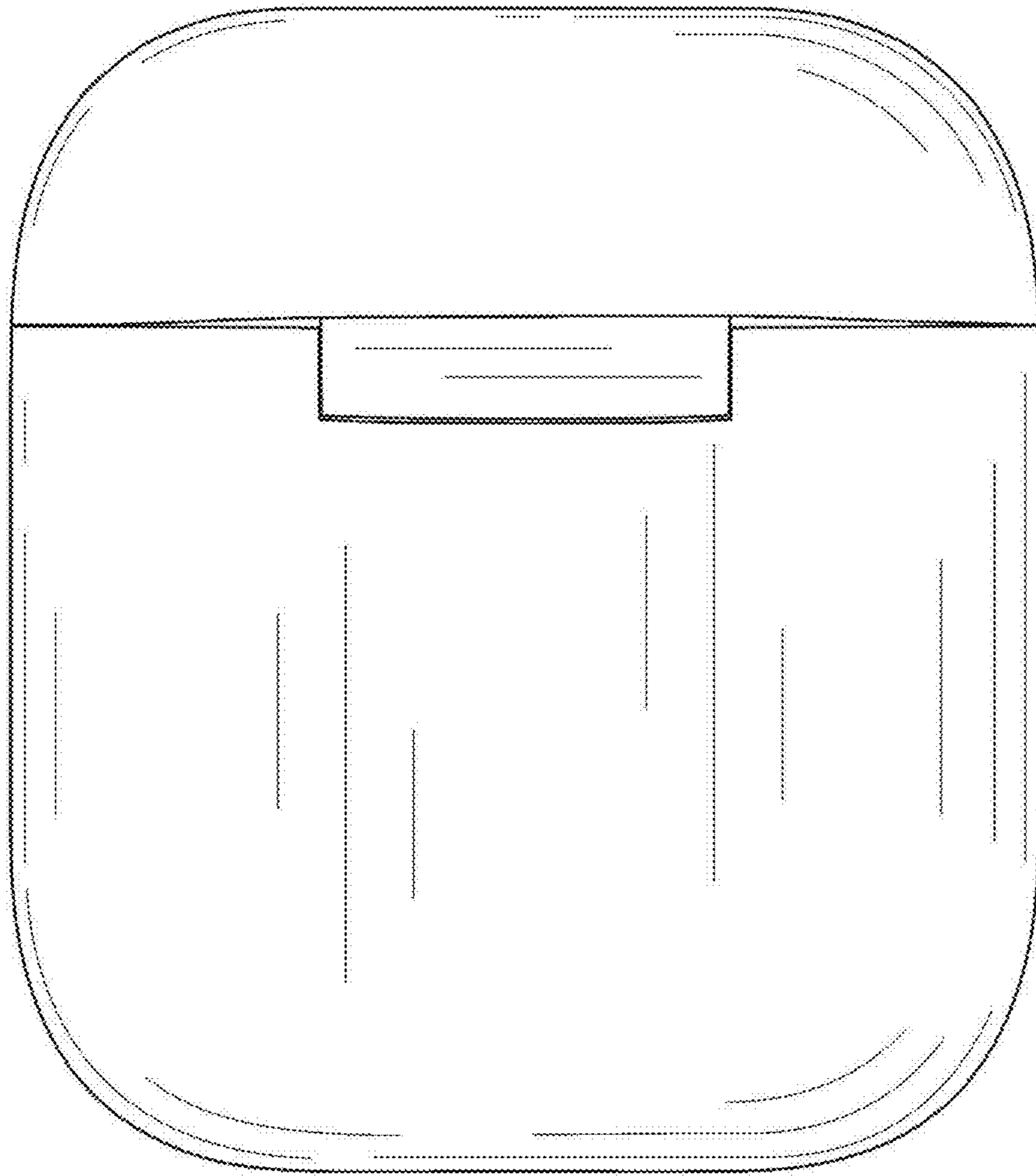

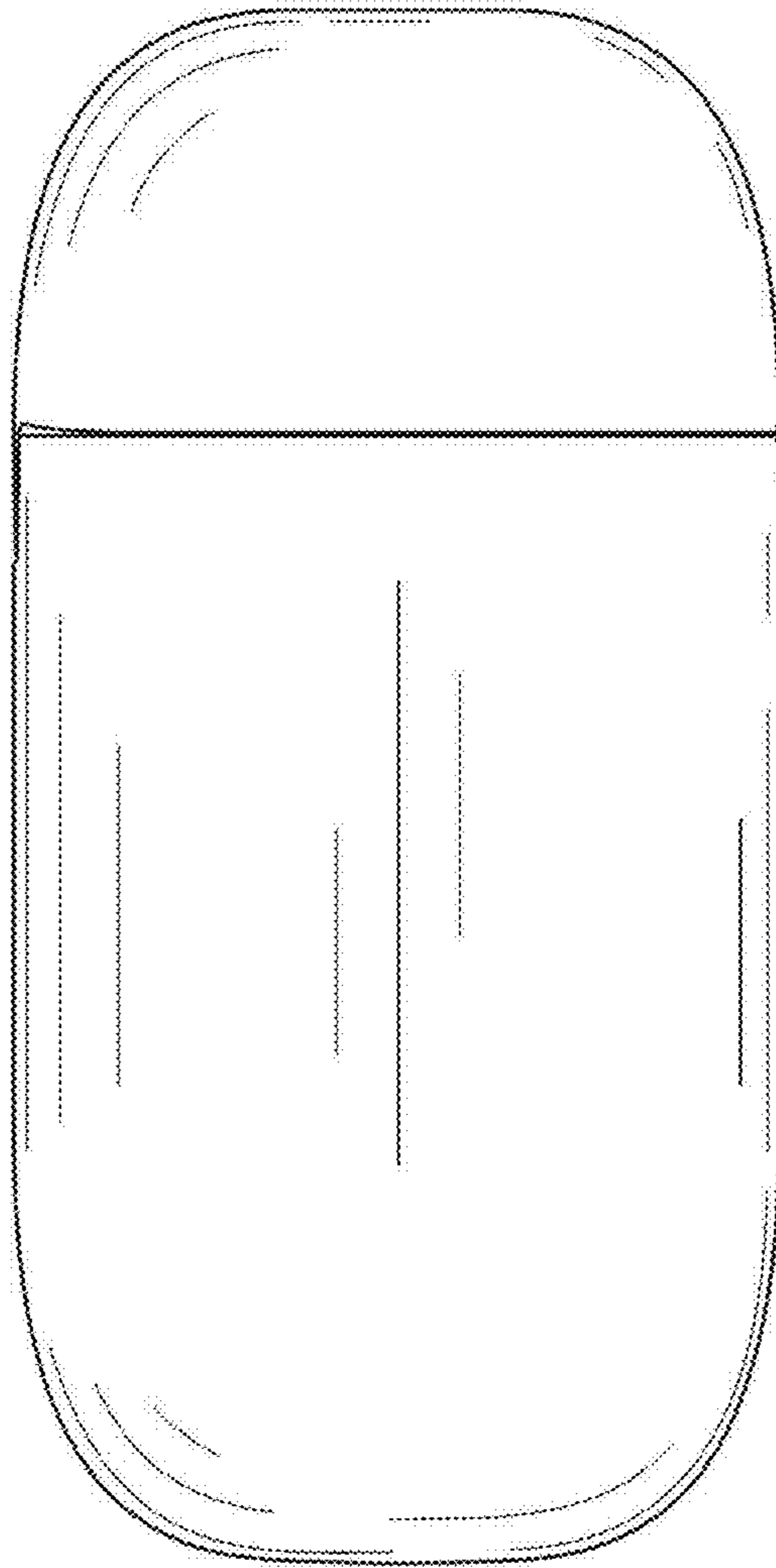

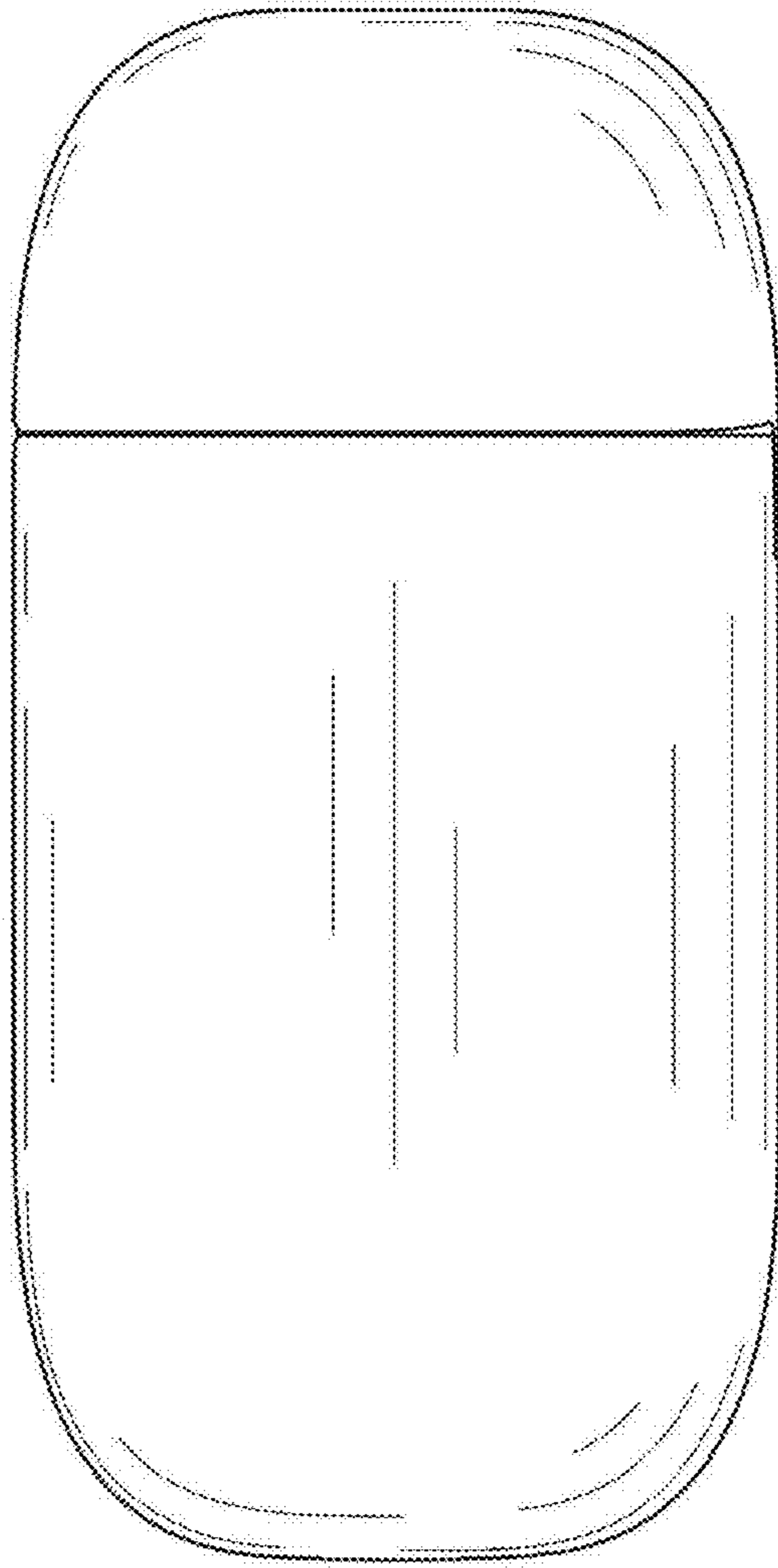

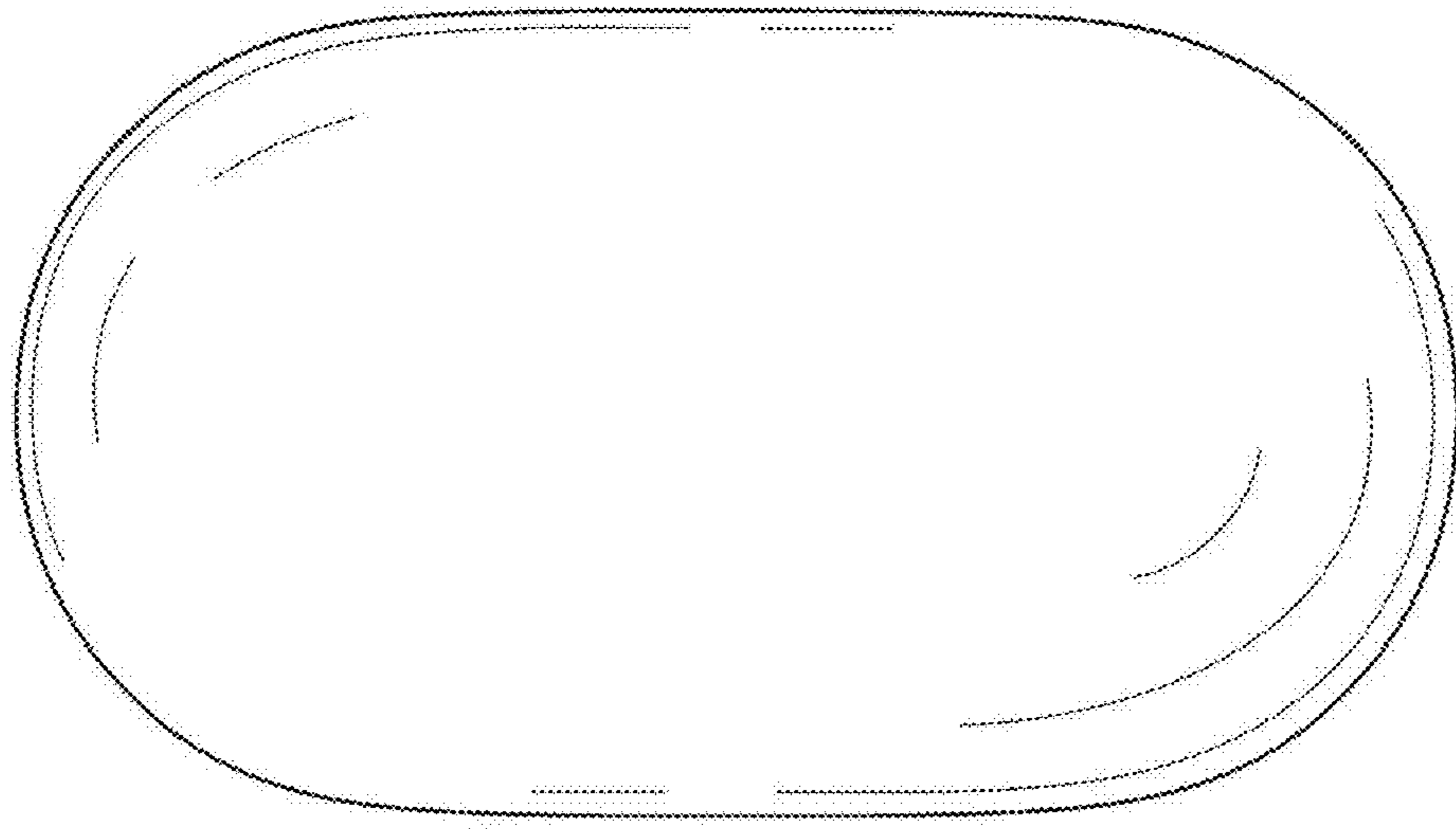

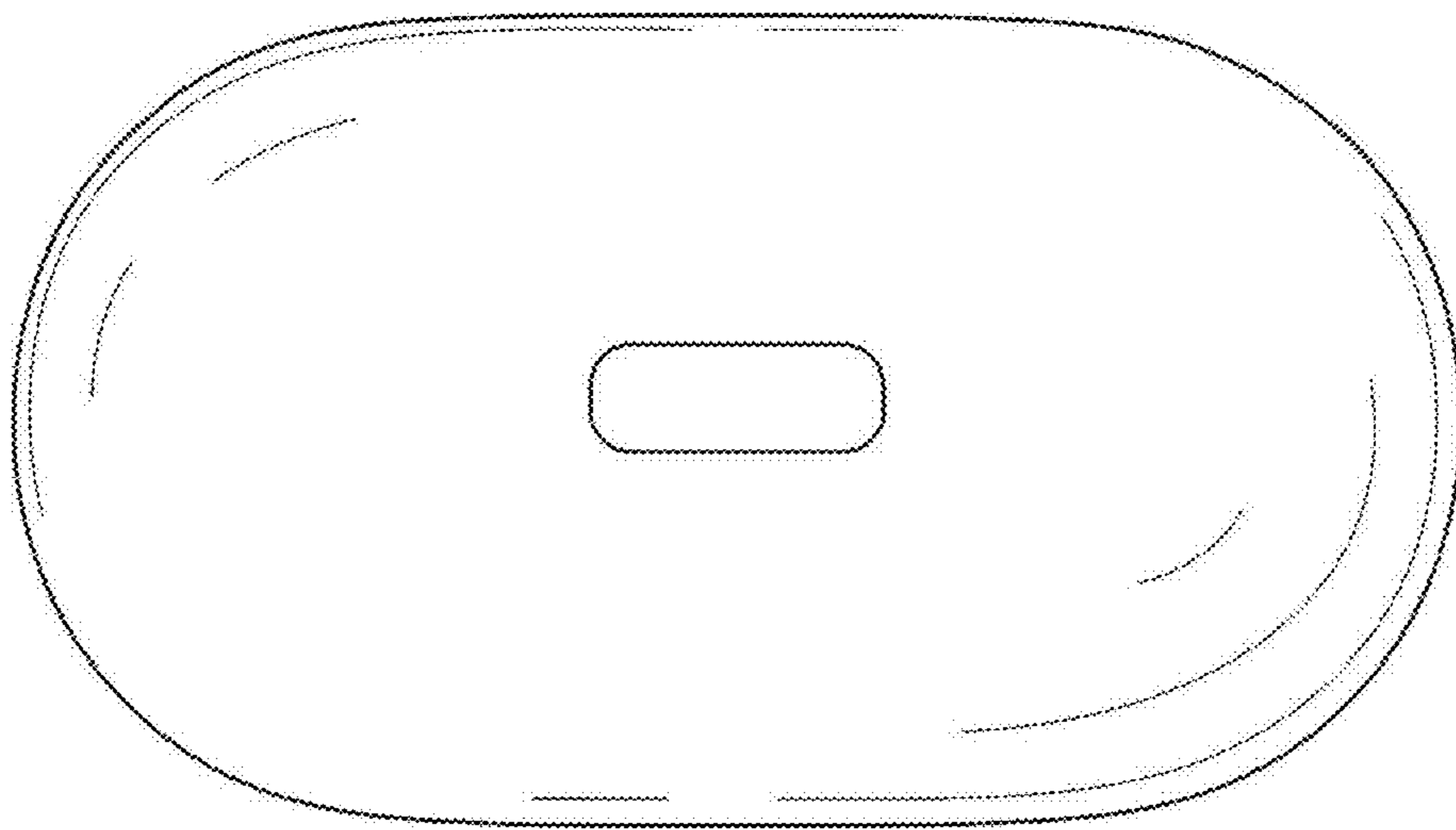
