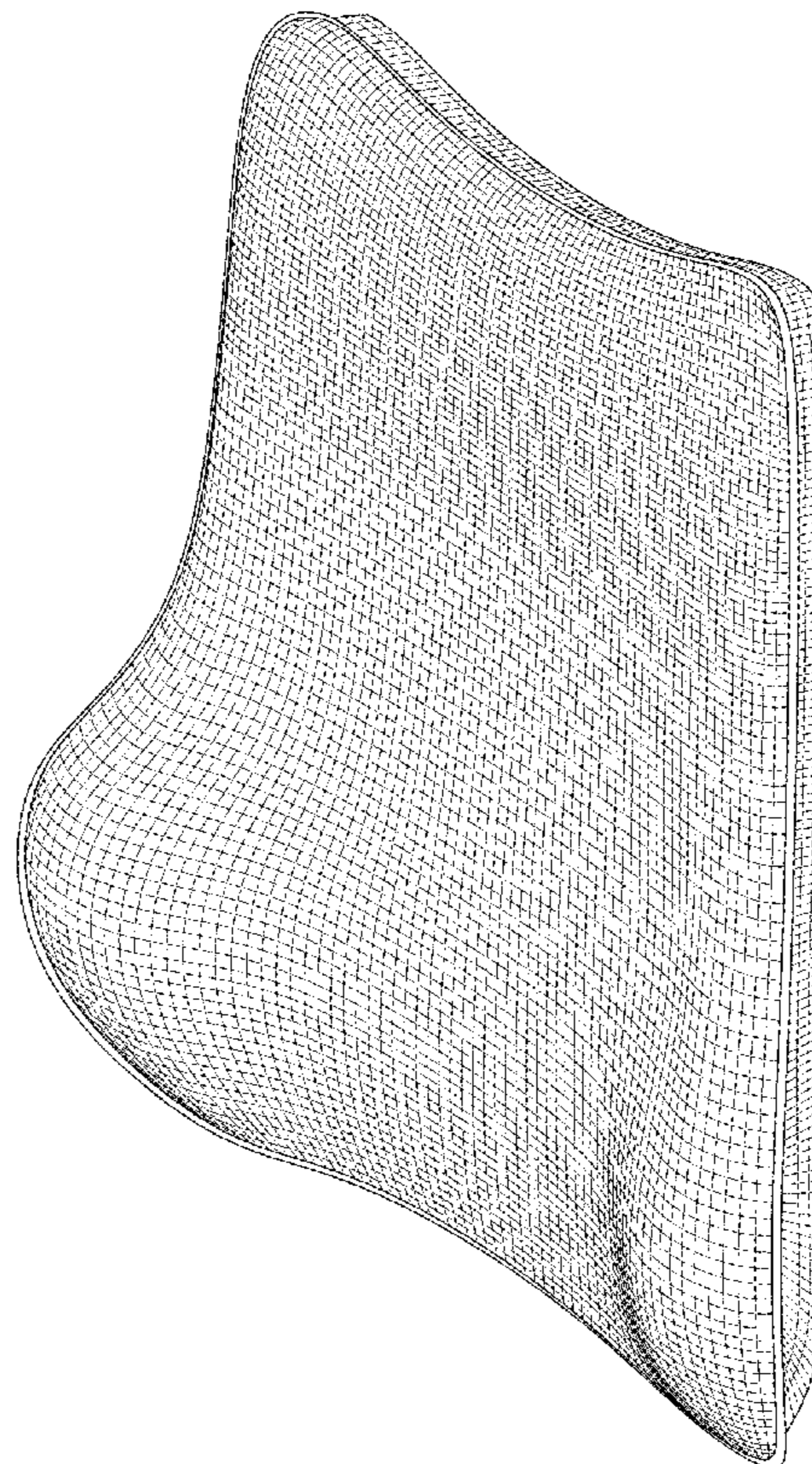

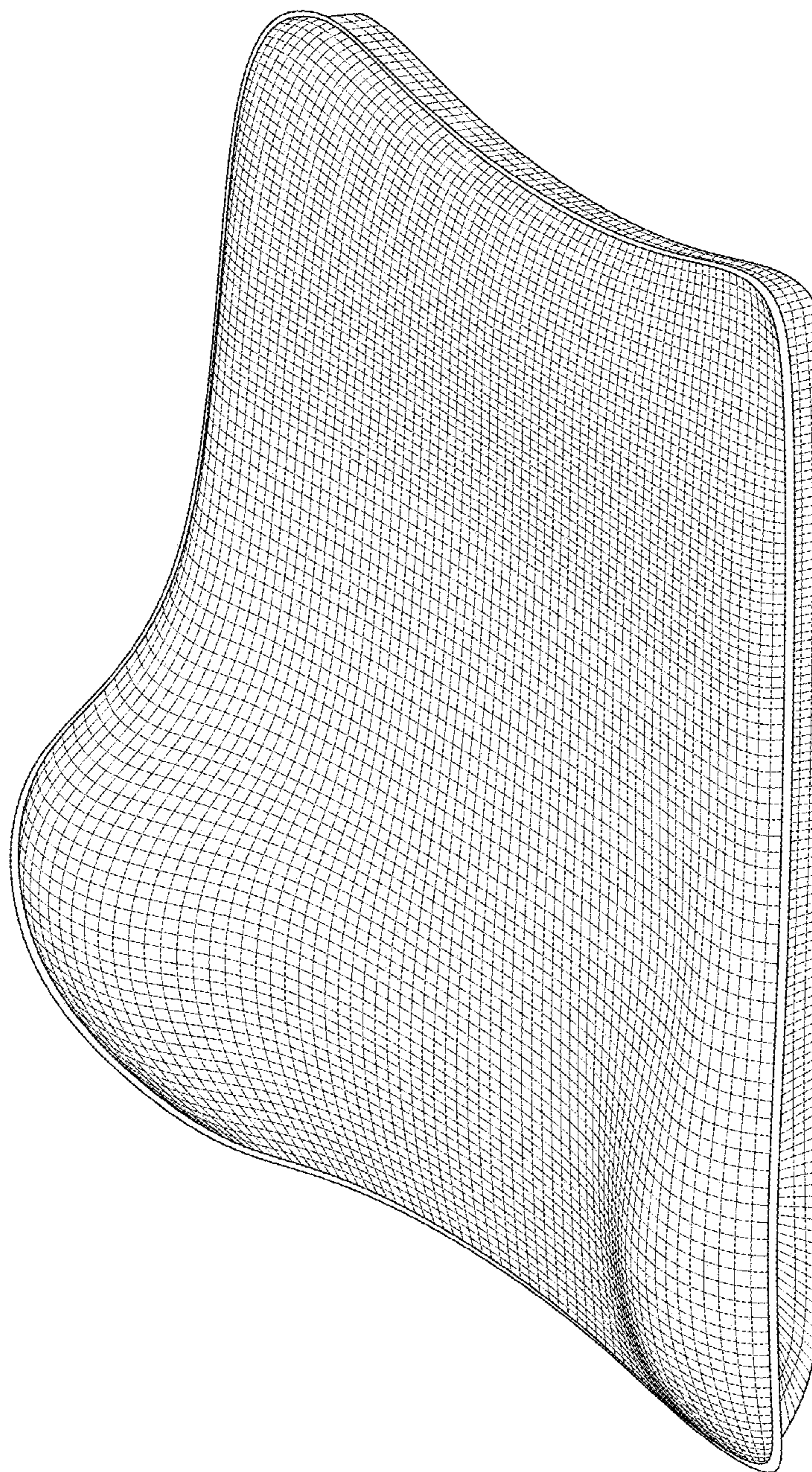
FIG. 1 is a front perspective view of a lumbar pillow, showing my design.

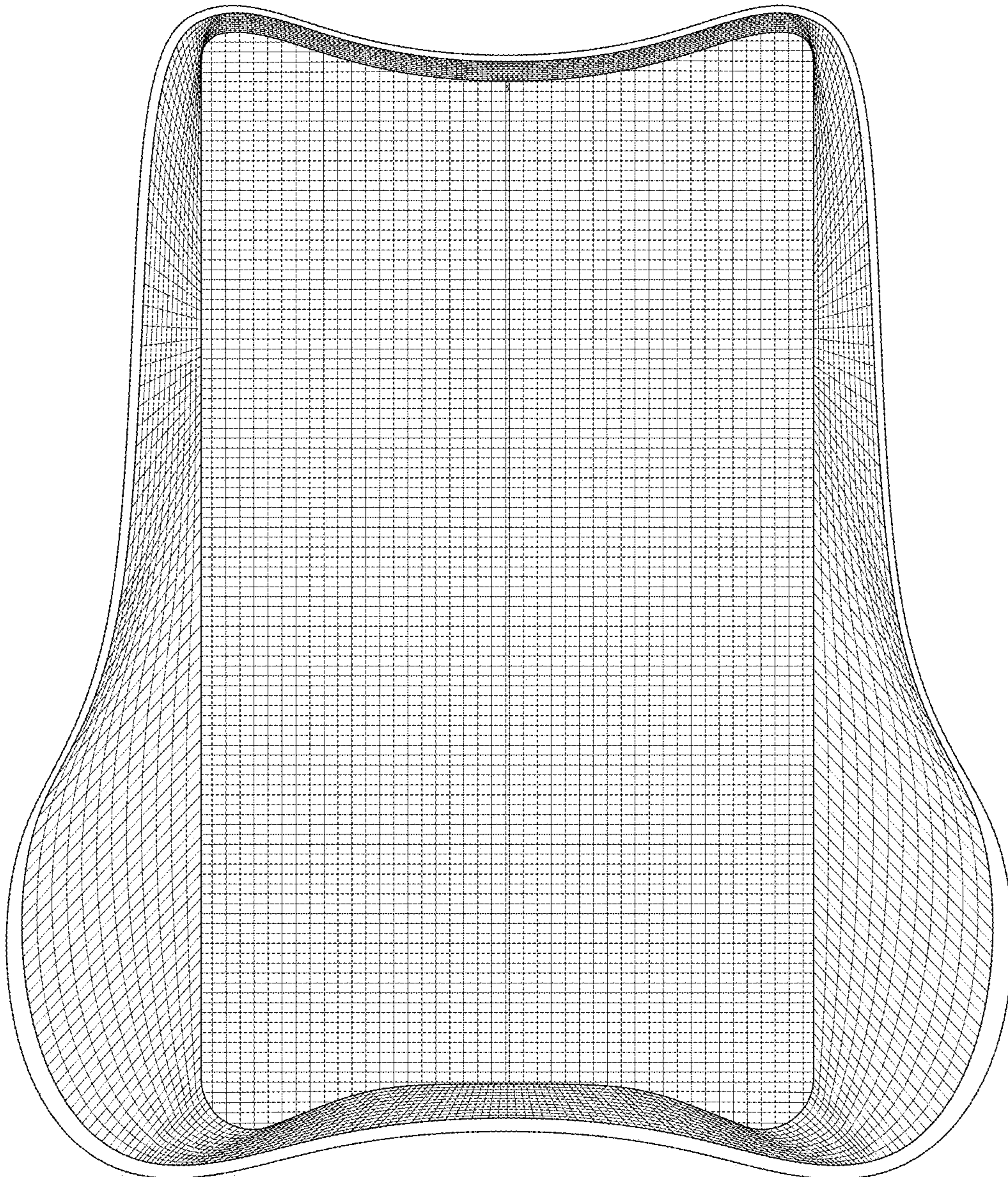




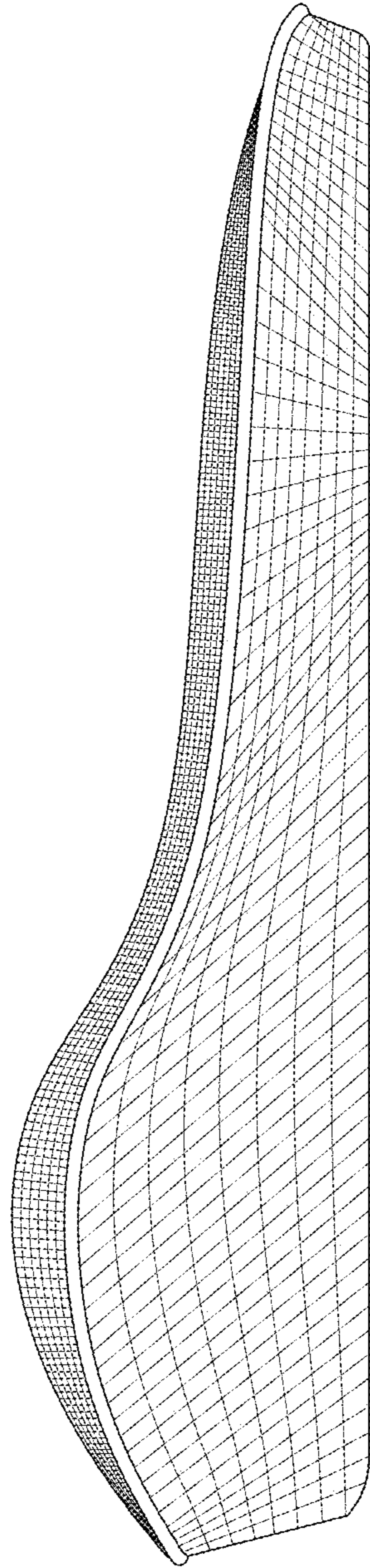

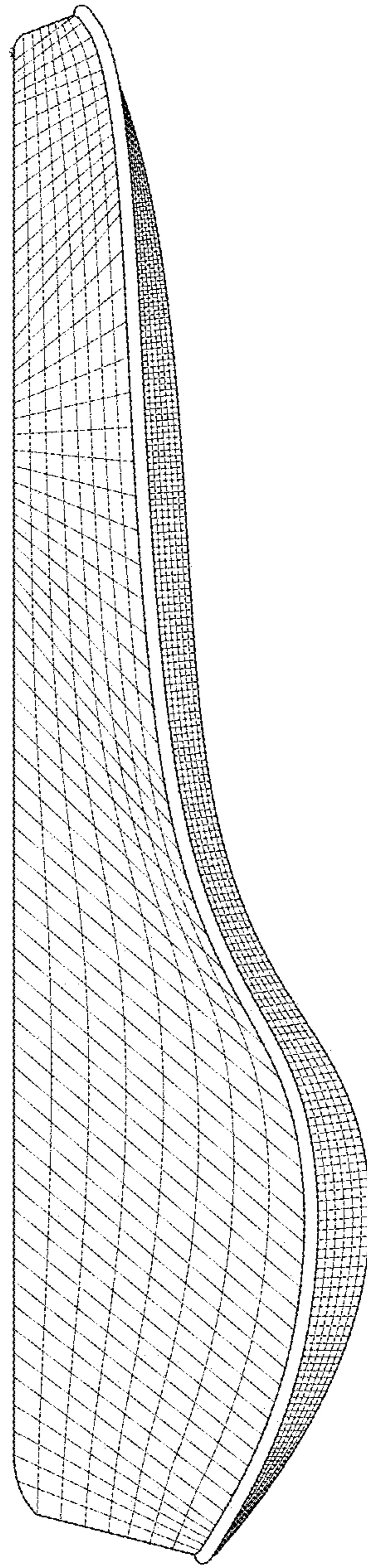

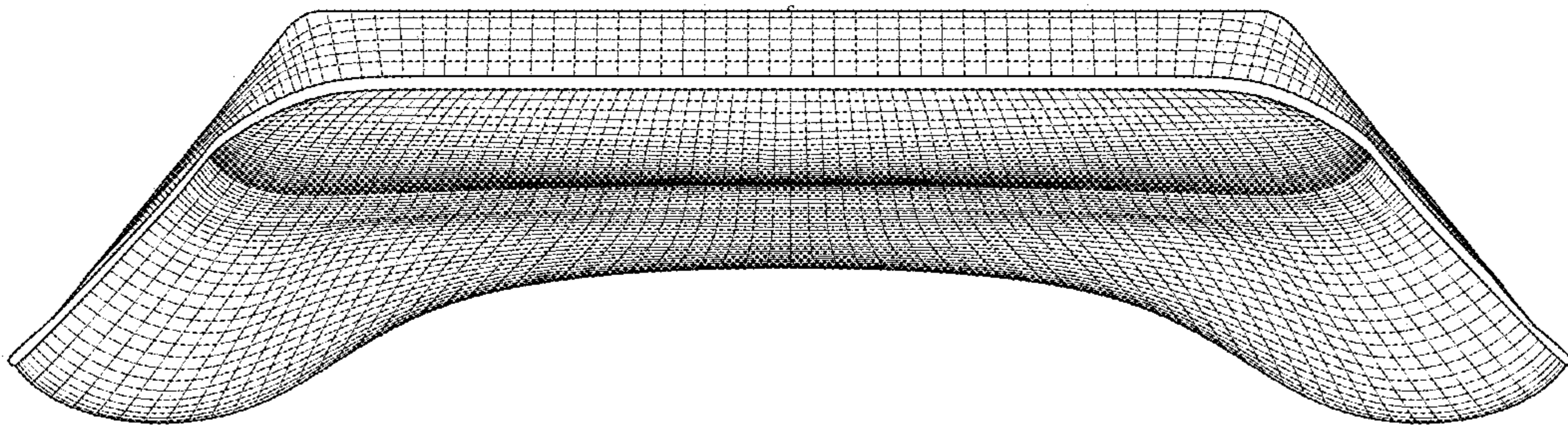

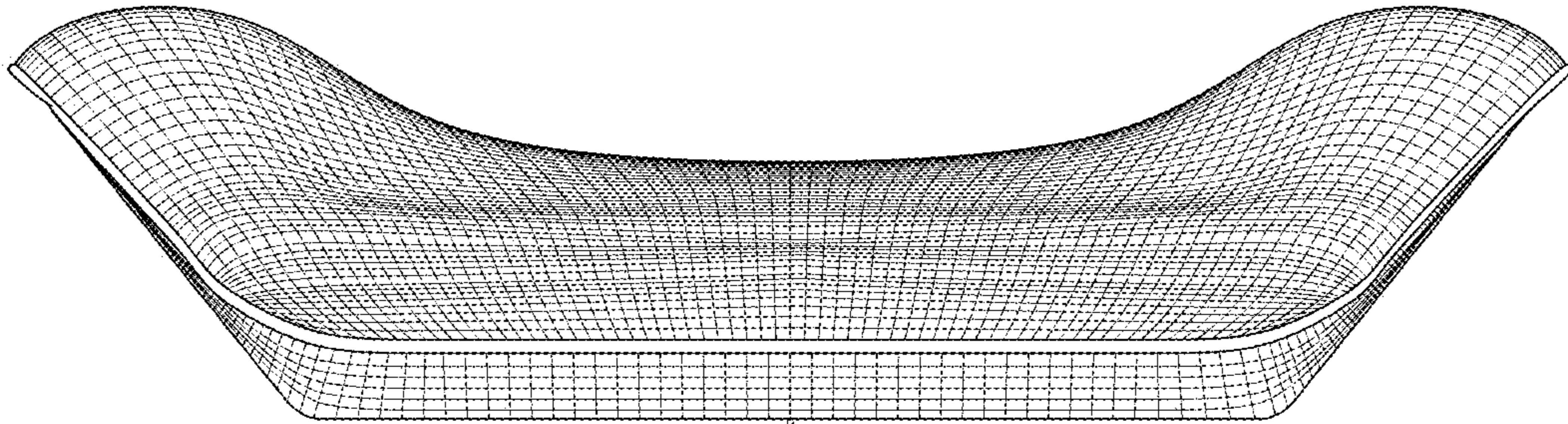
