DESCRIPTION

FIG. 1 is a front perspective view of a caulk plug, showing my new design;
FIG. 2 is a front elevation view thereof;

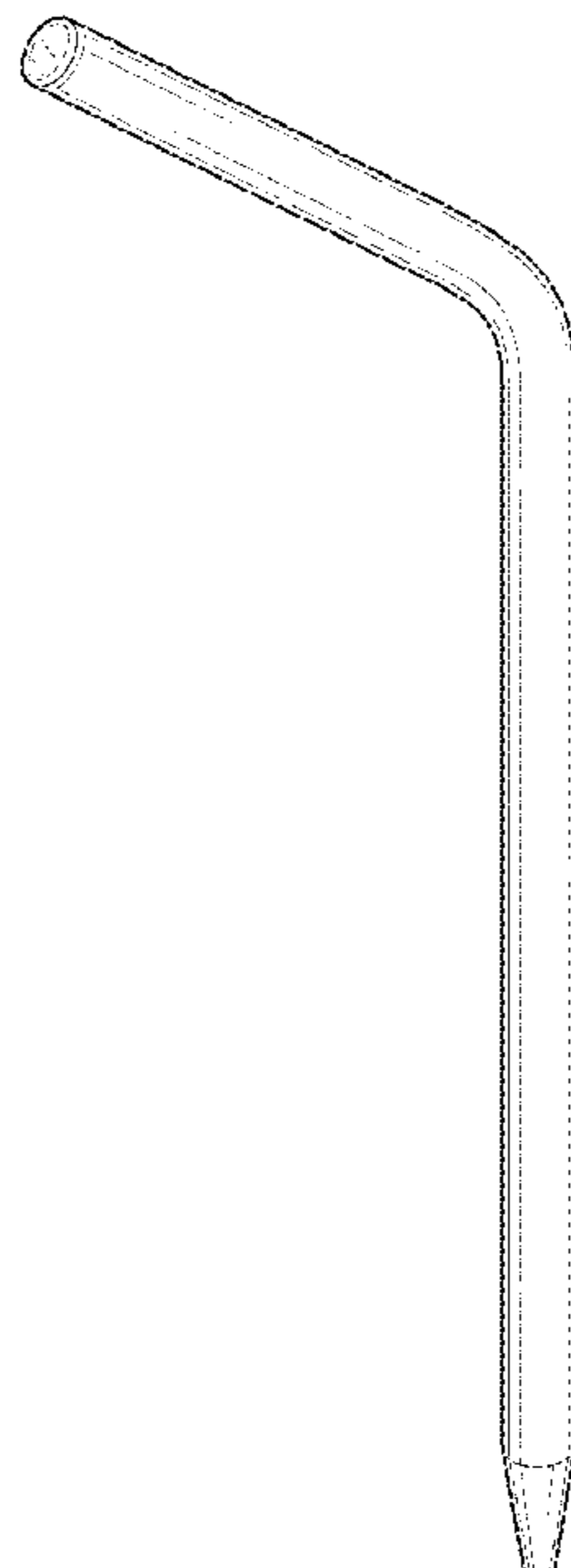

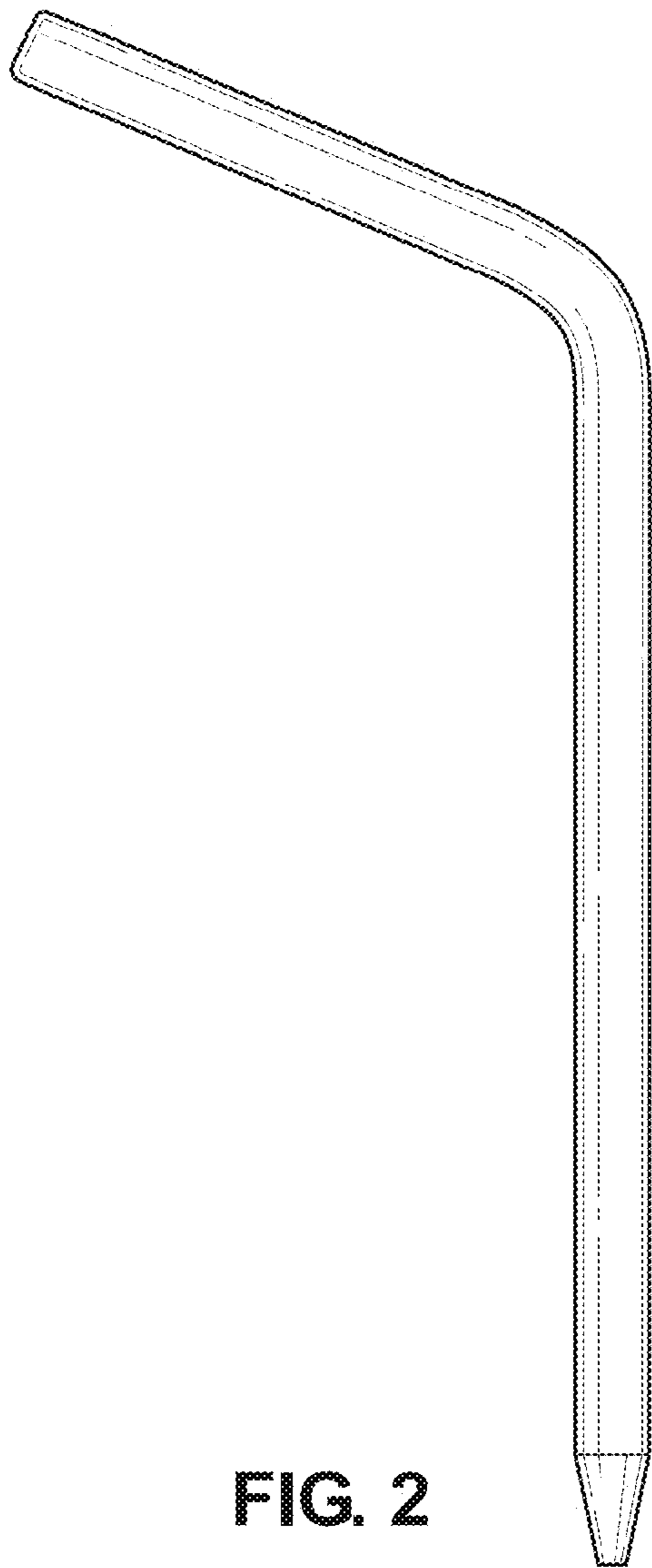

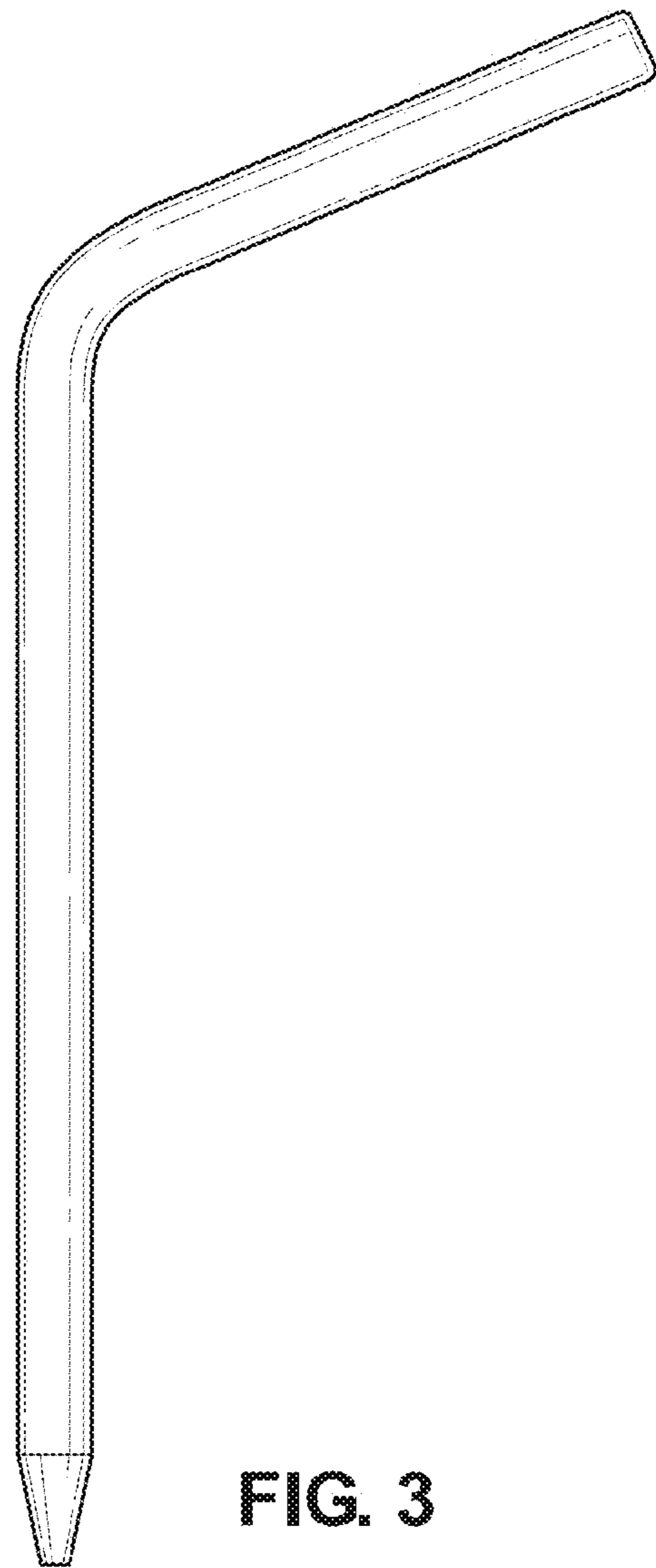

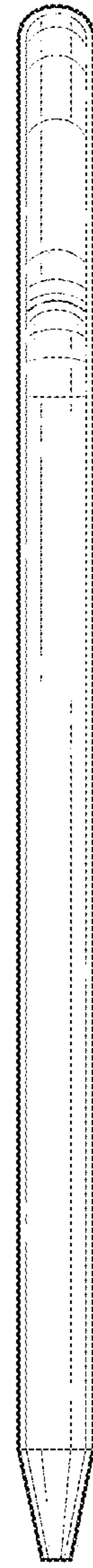

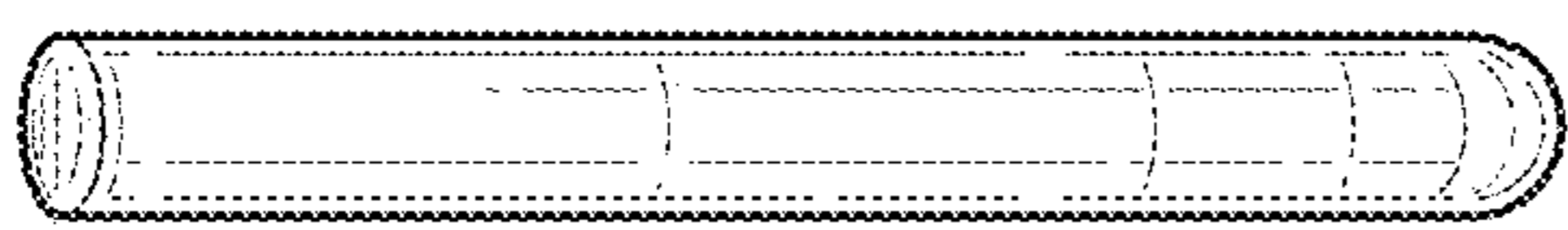

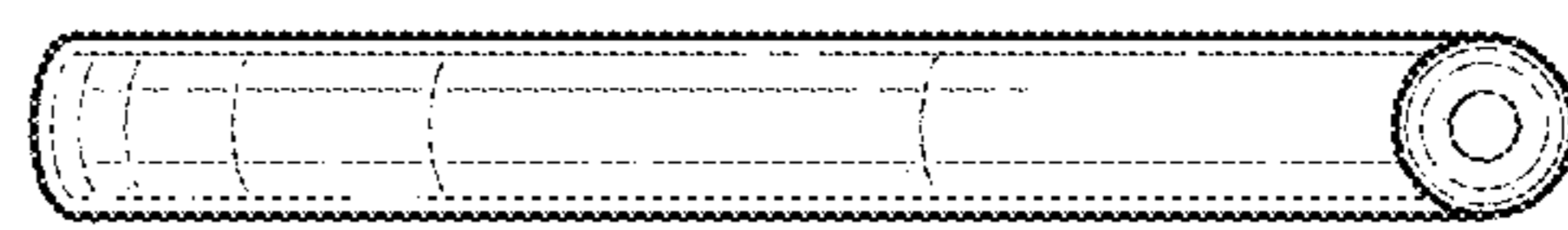
