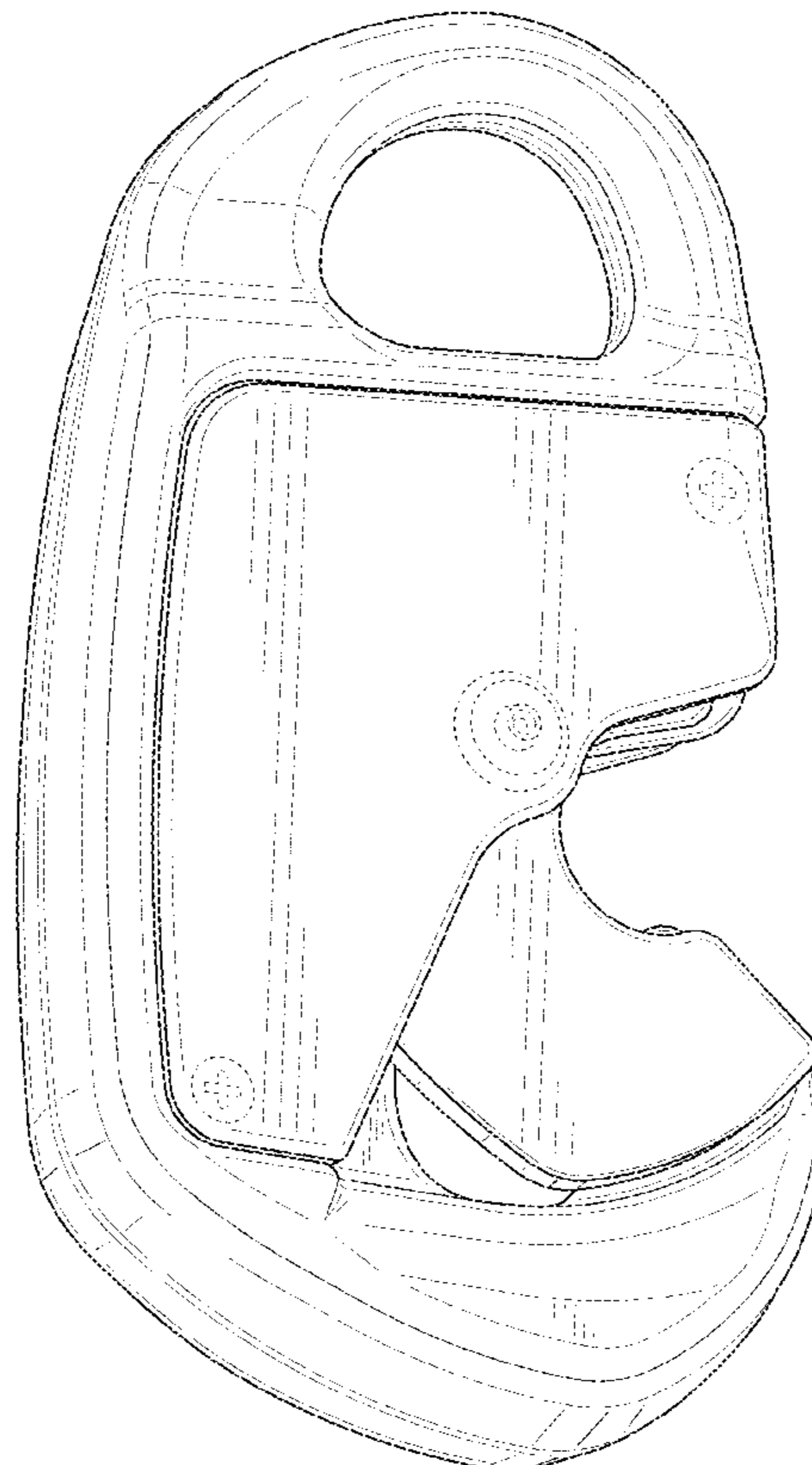
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear, left-side, bottom perspective view of the climbing apparatus;

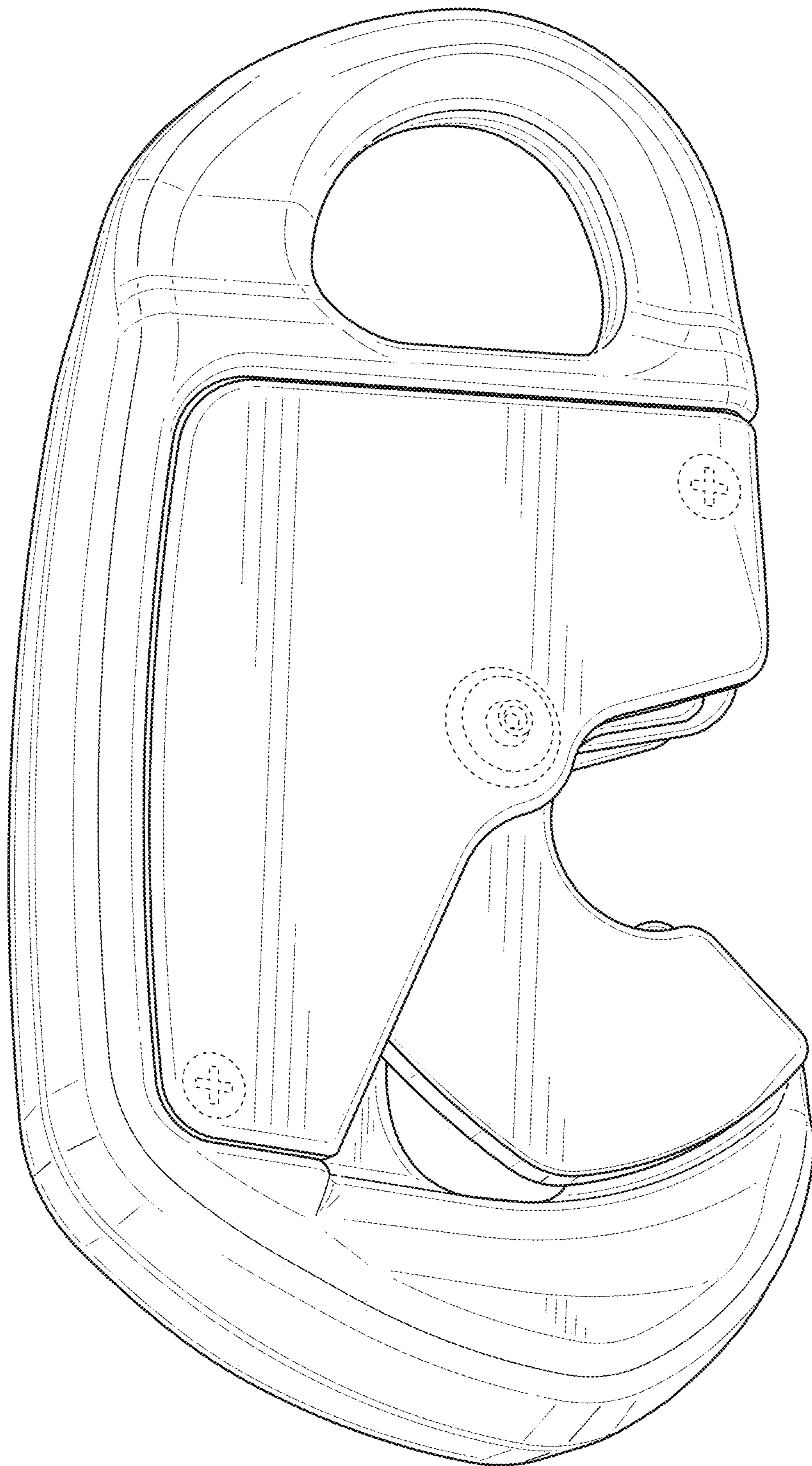

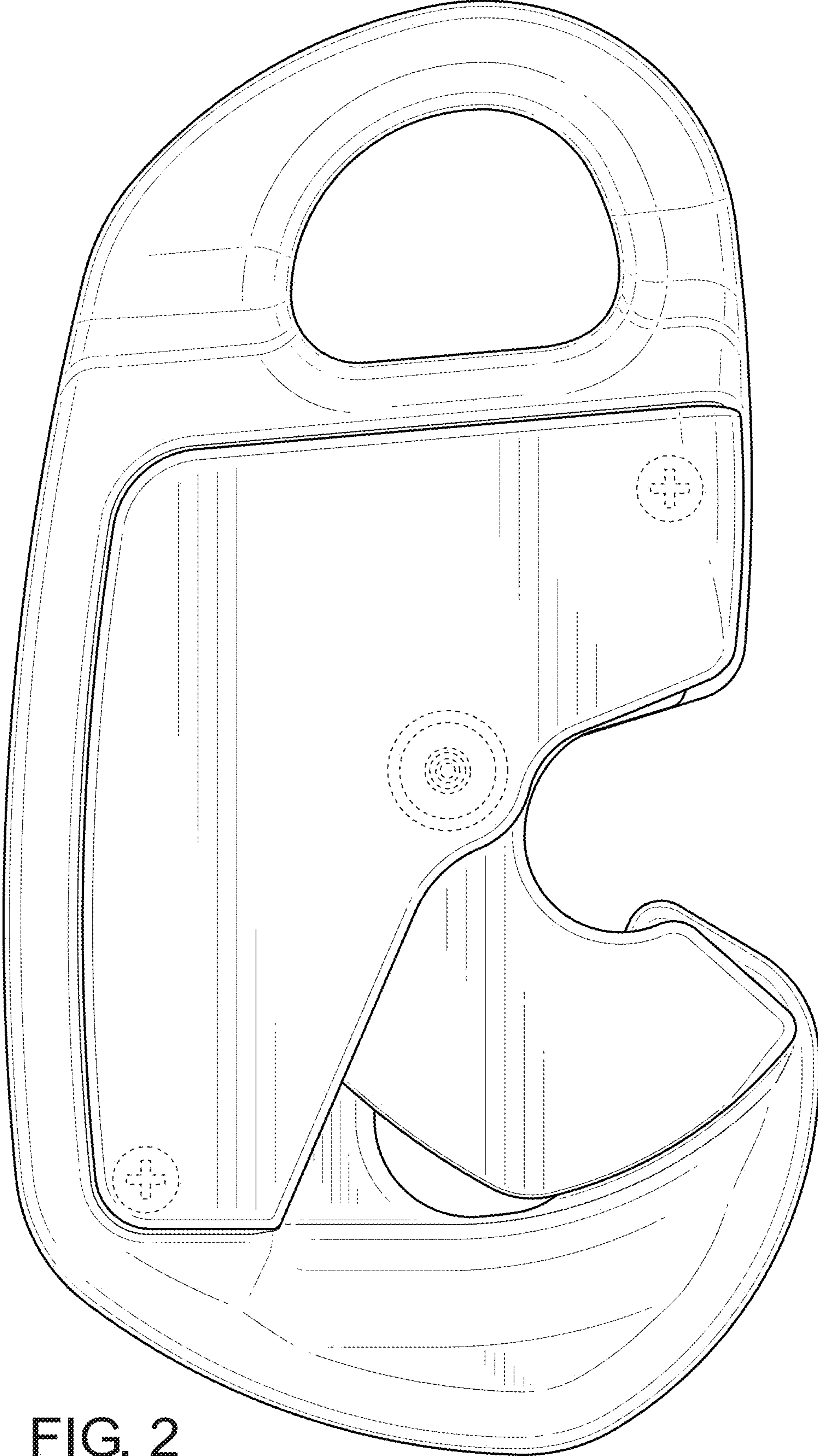

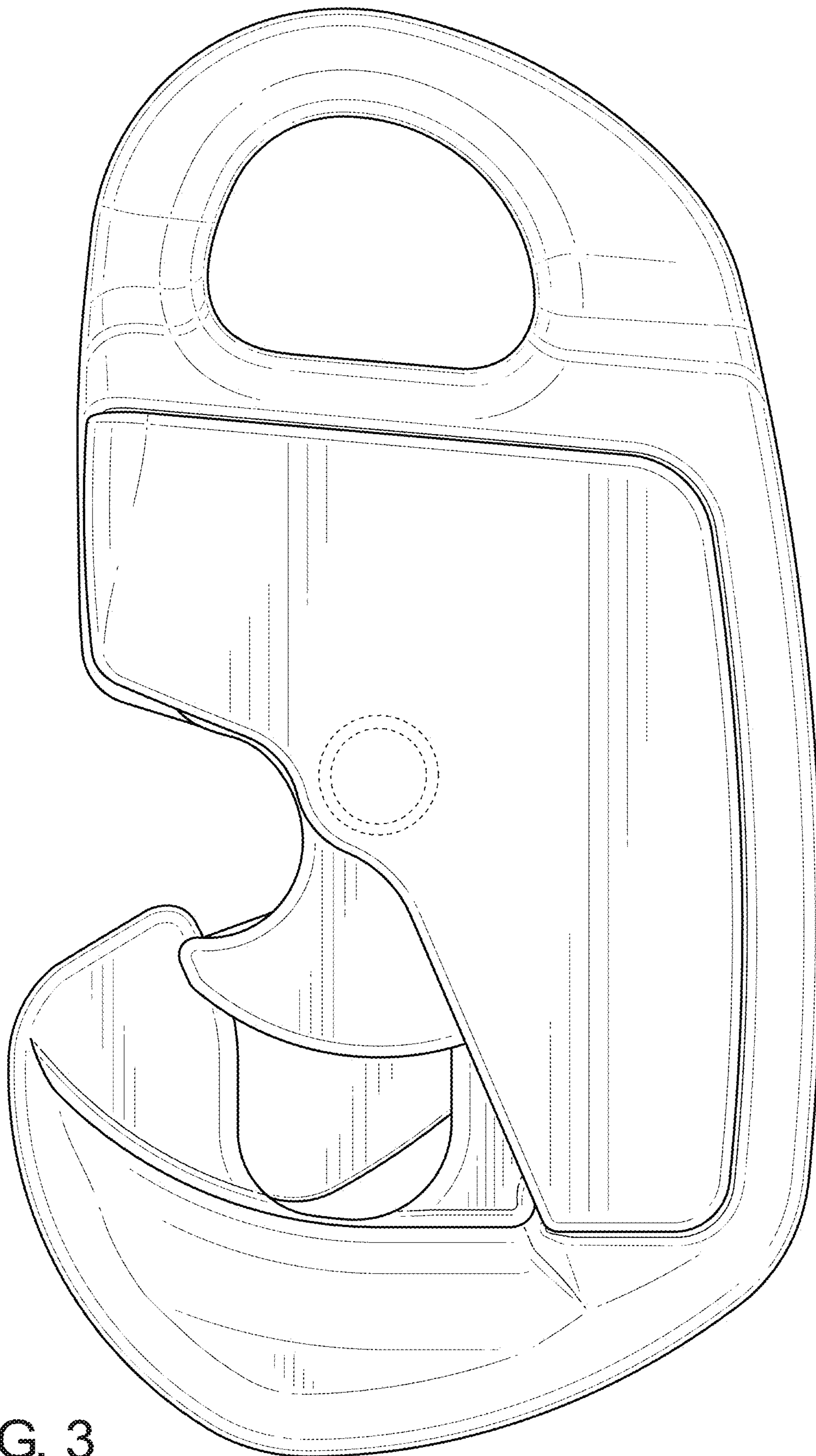

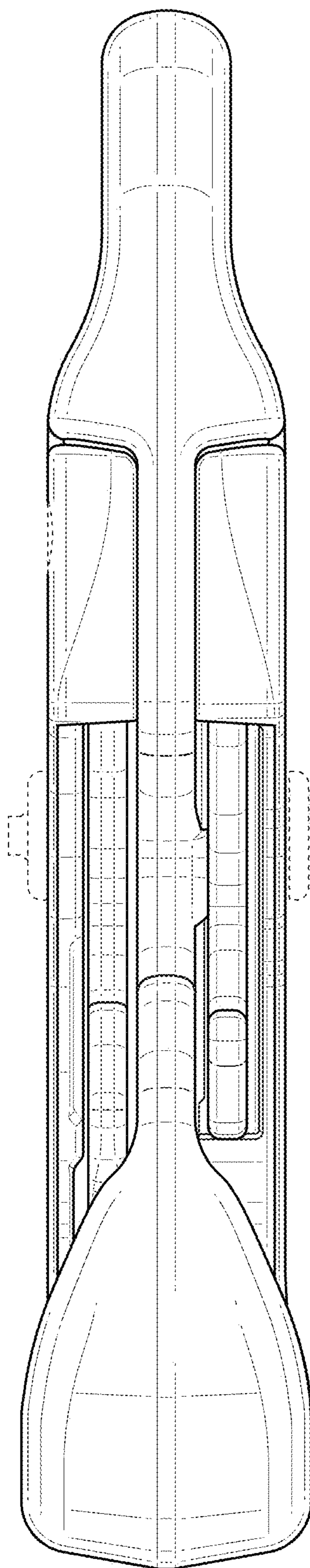

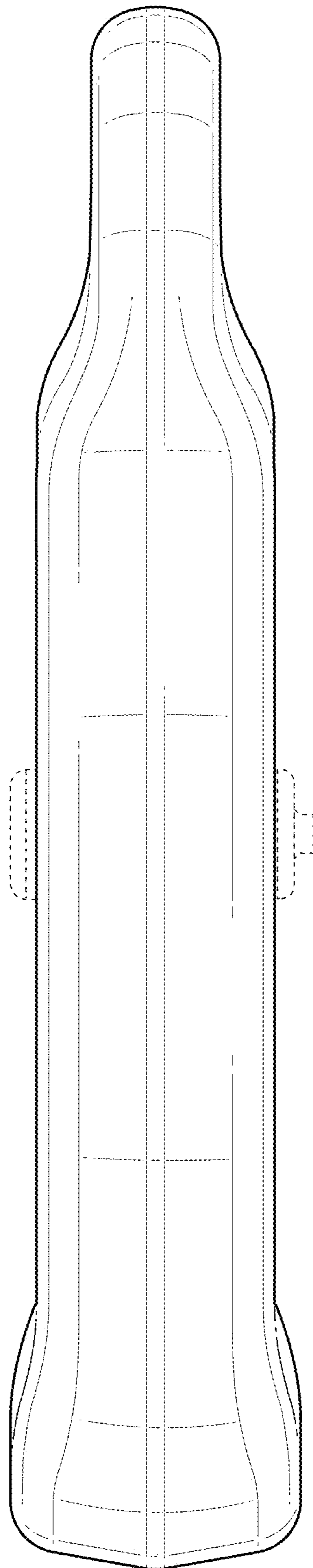

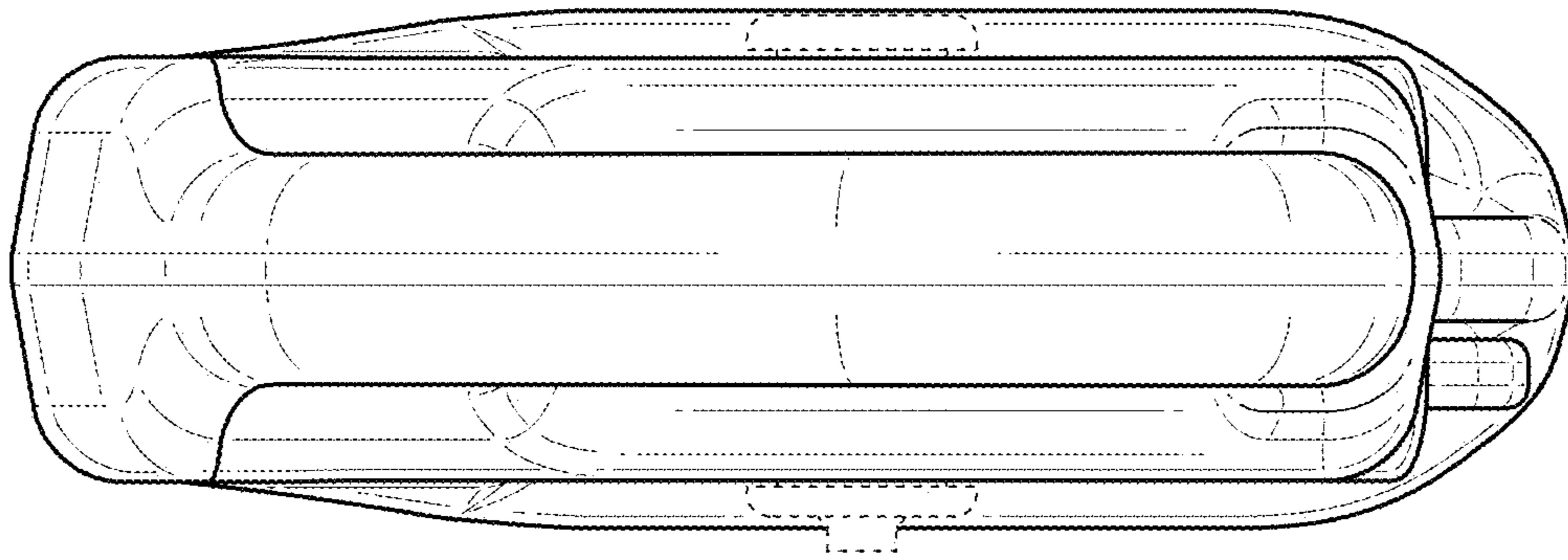

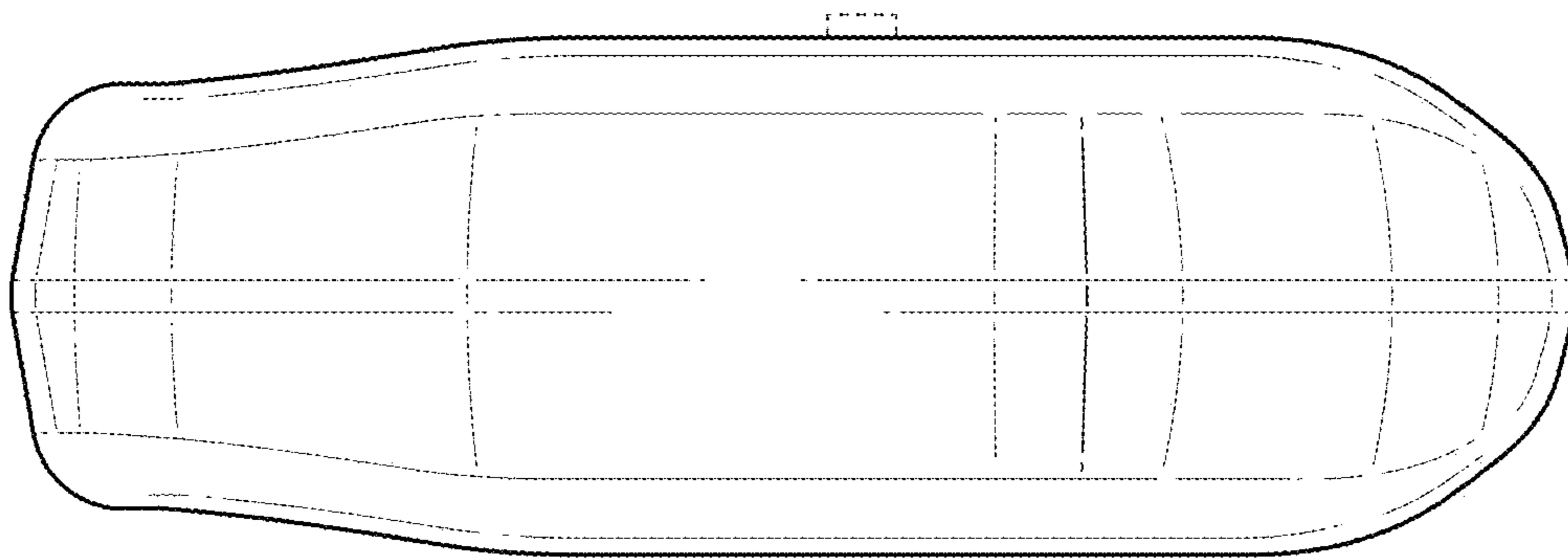

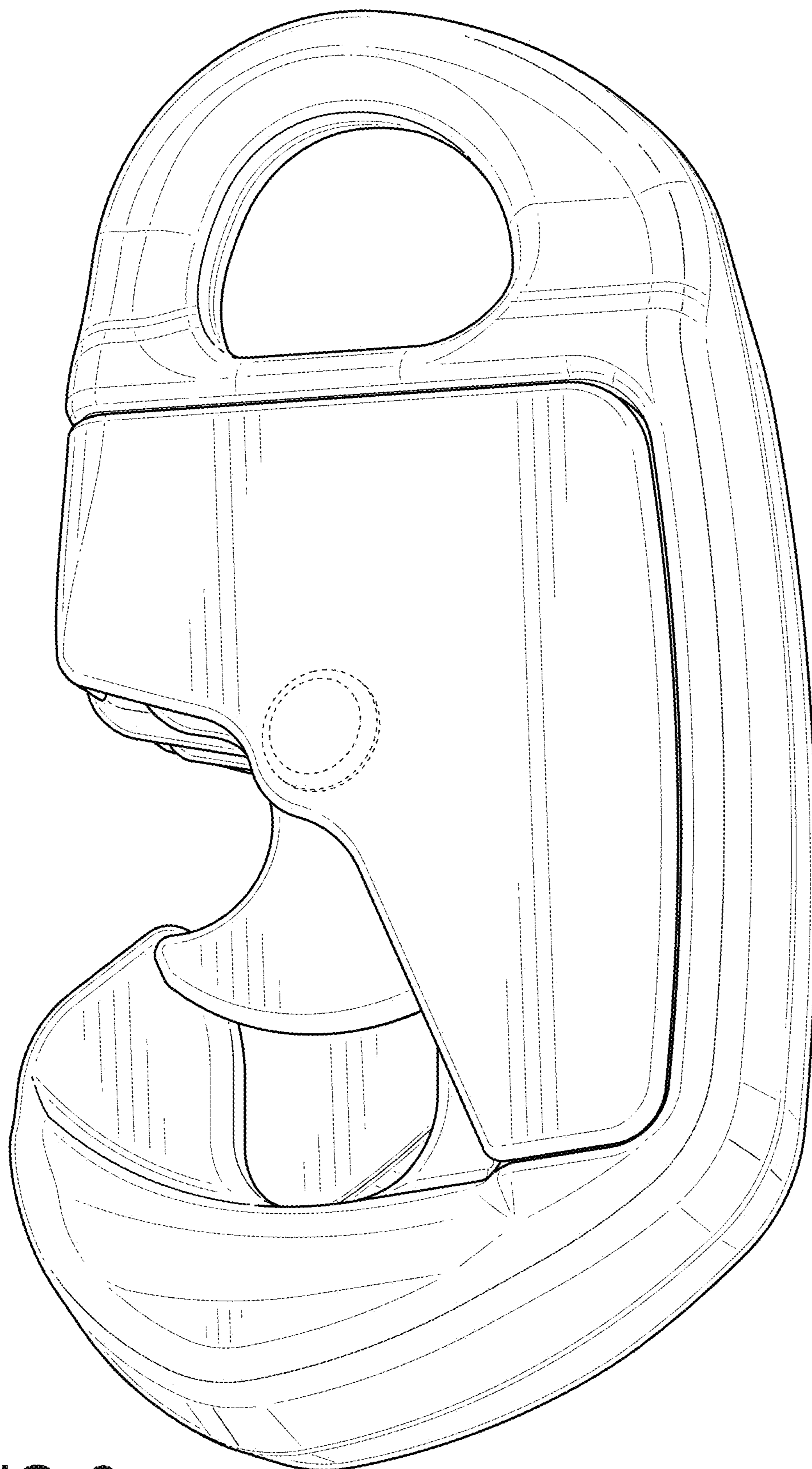
