DESCRIPTION

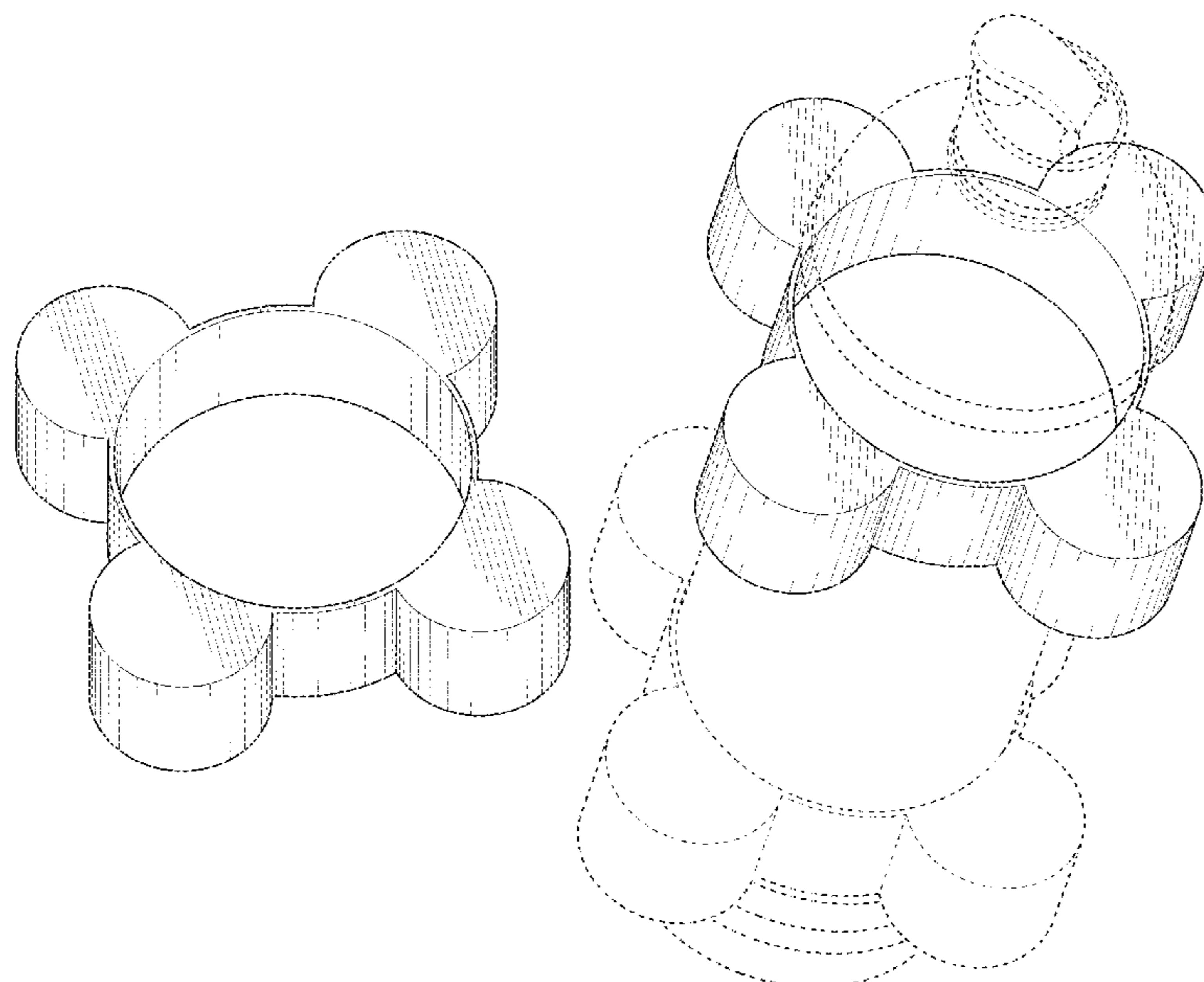
FIG. 1 is a perspective view of a bottle holder of the present invention;

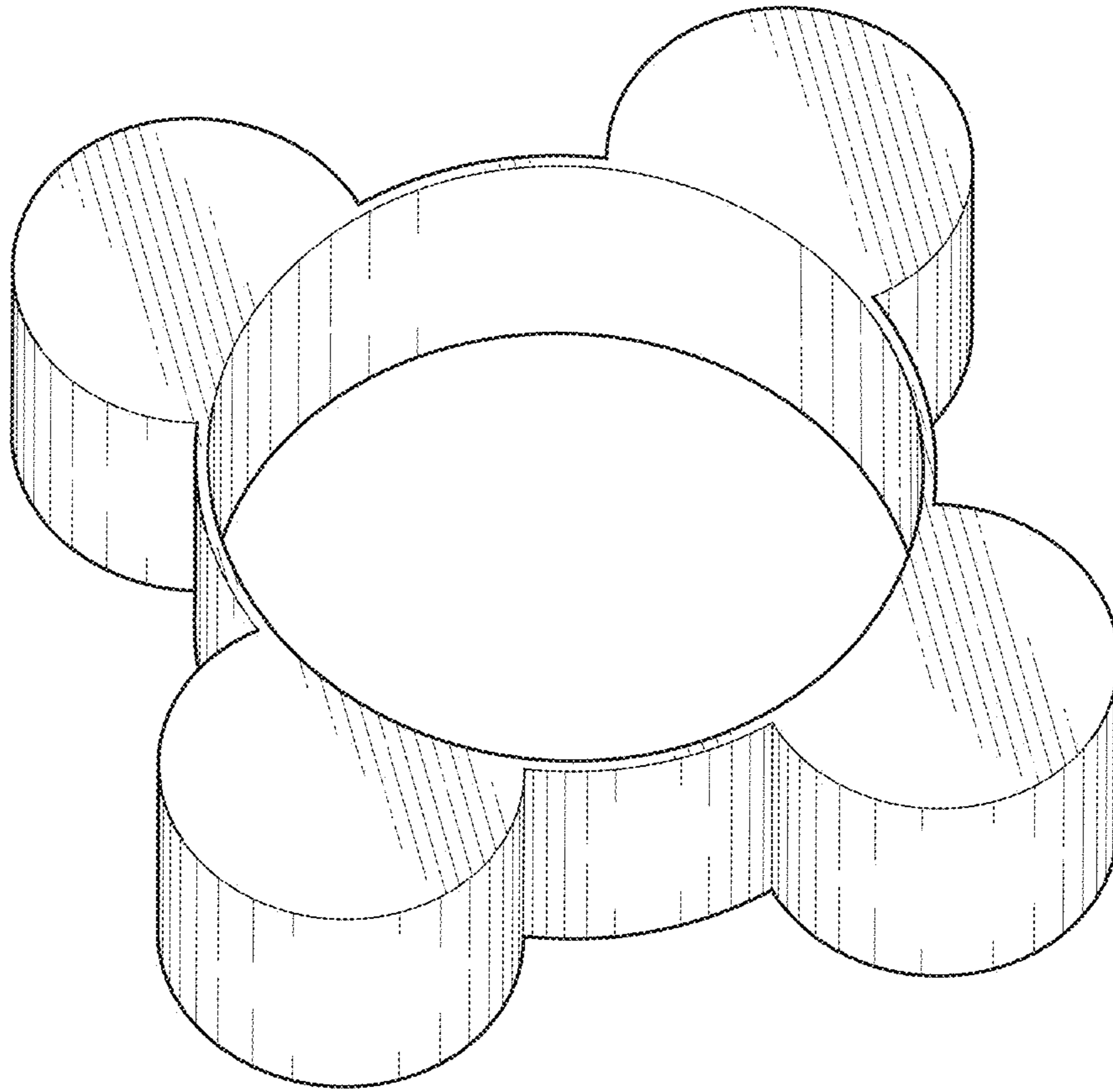

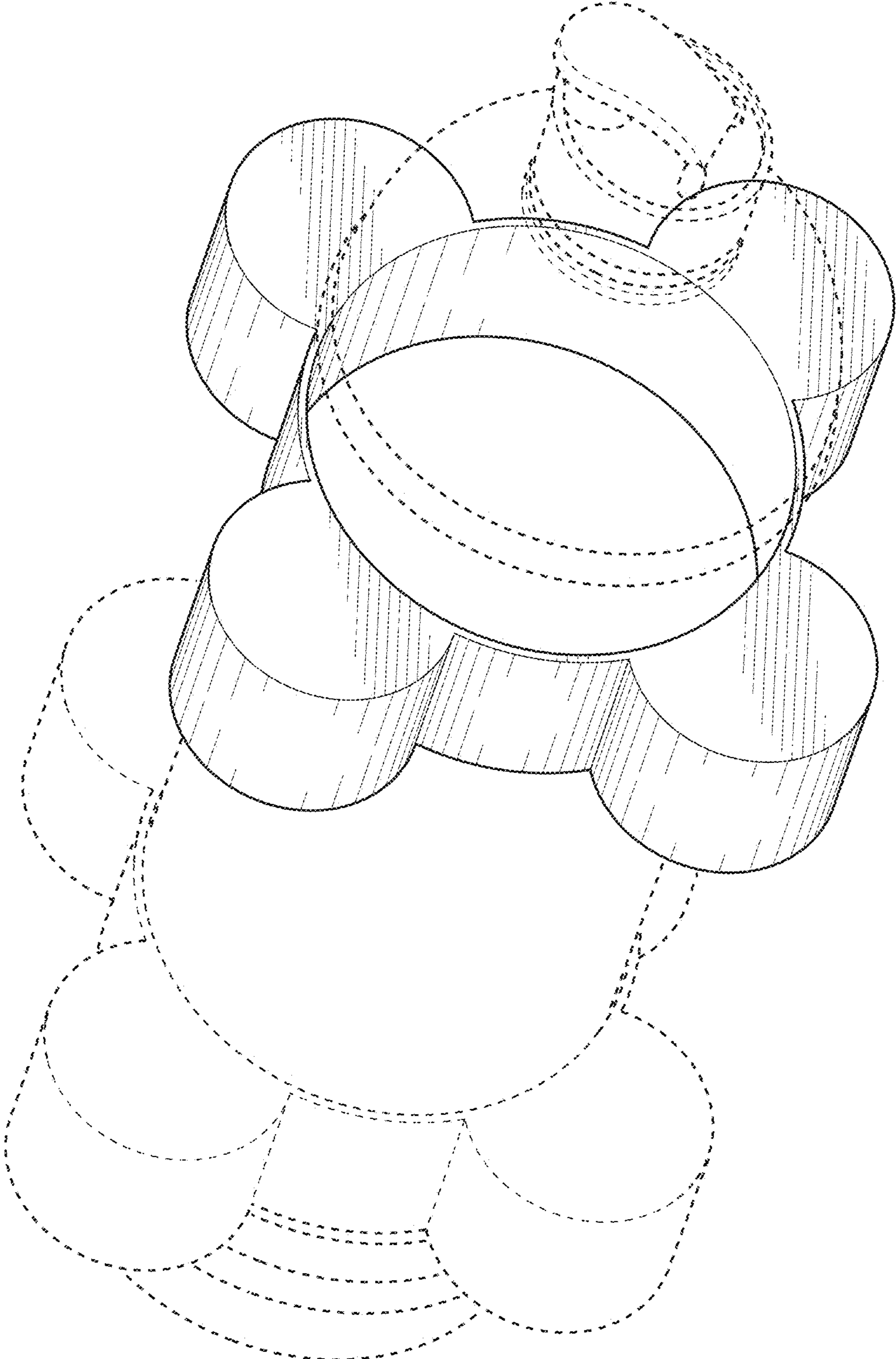

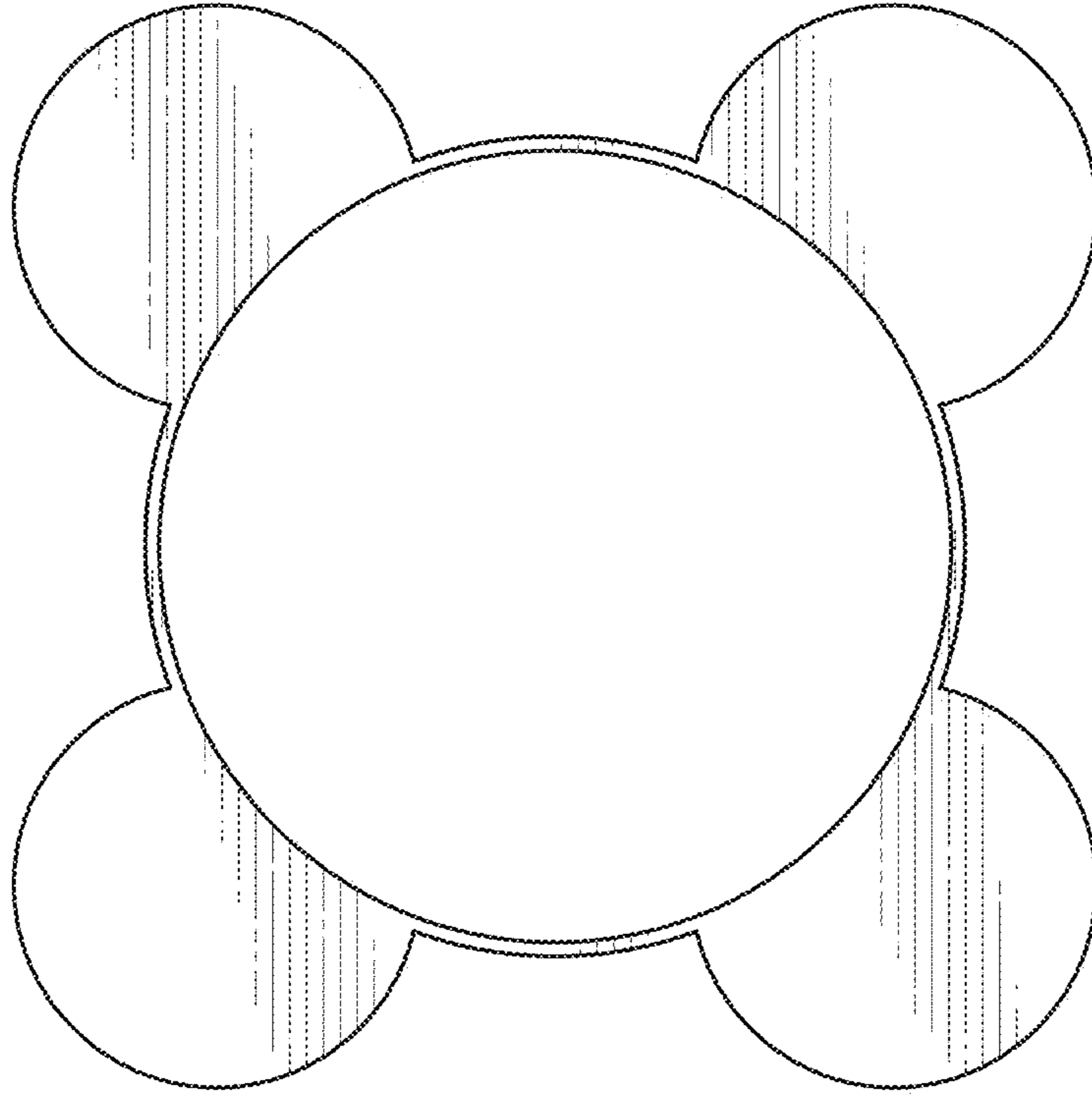

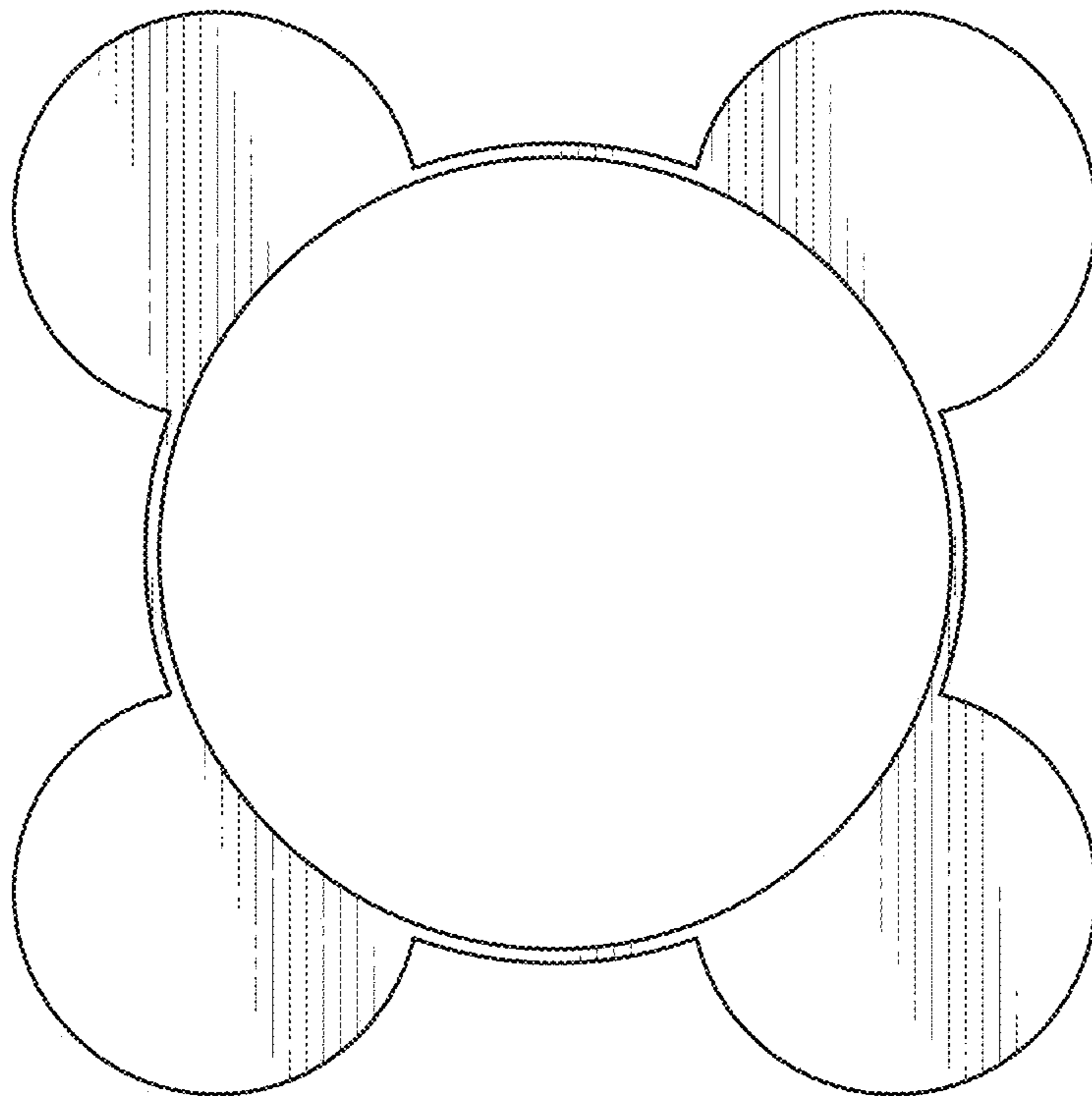

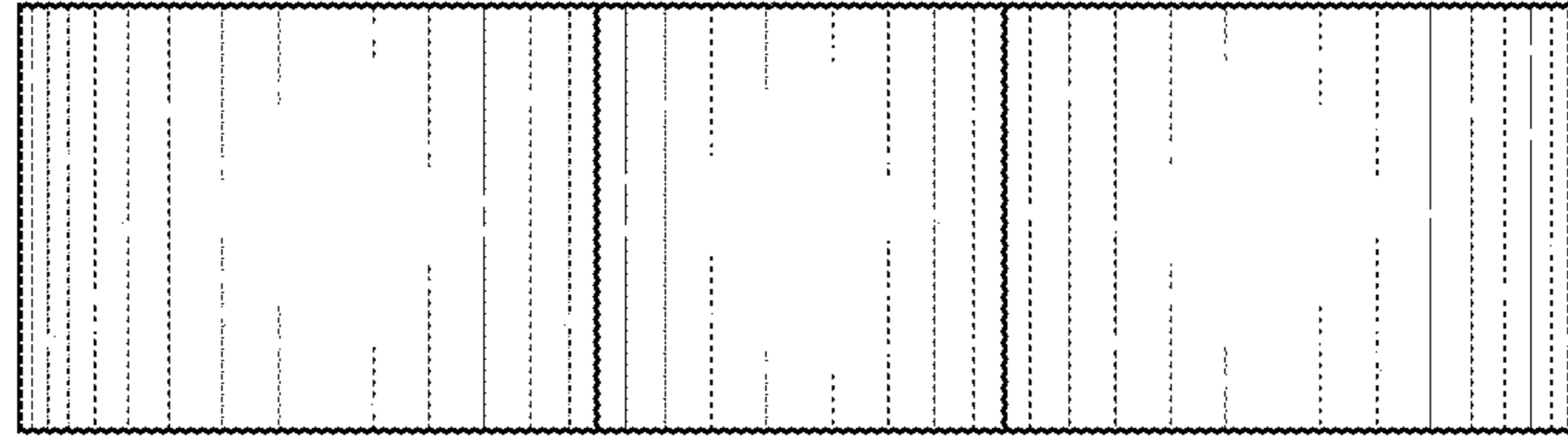

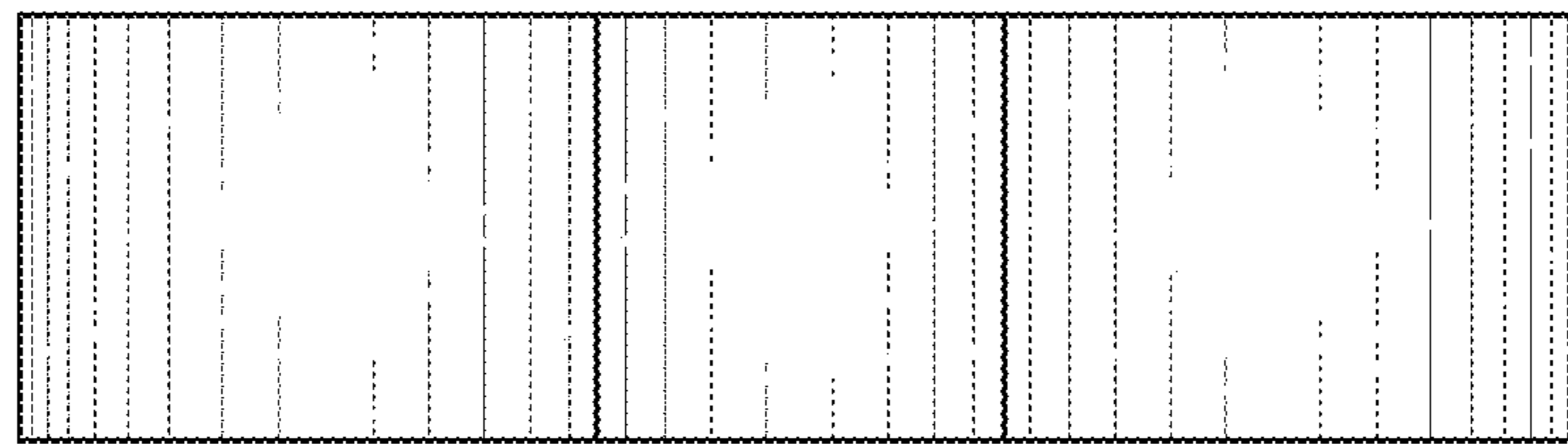

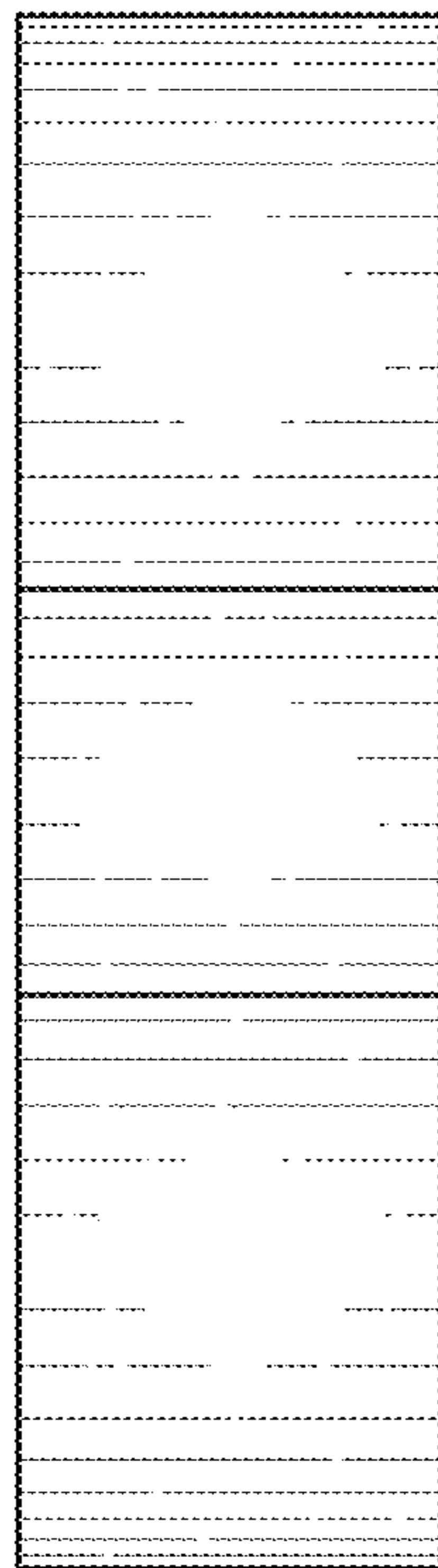

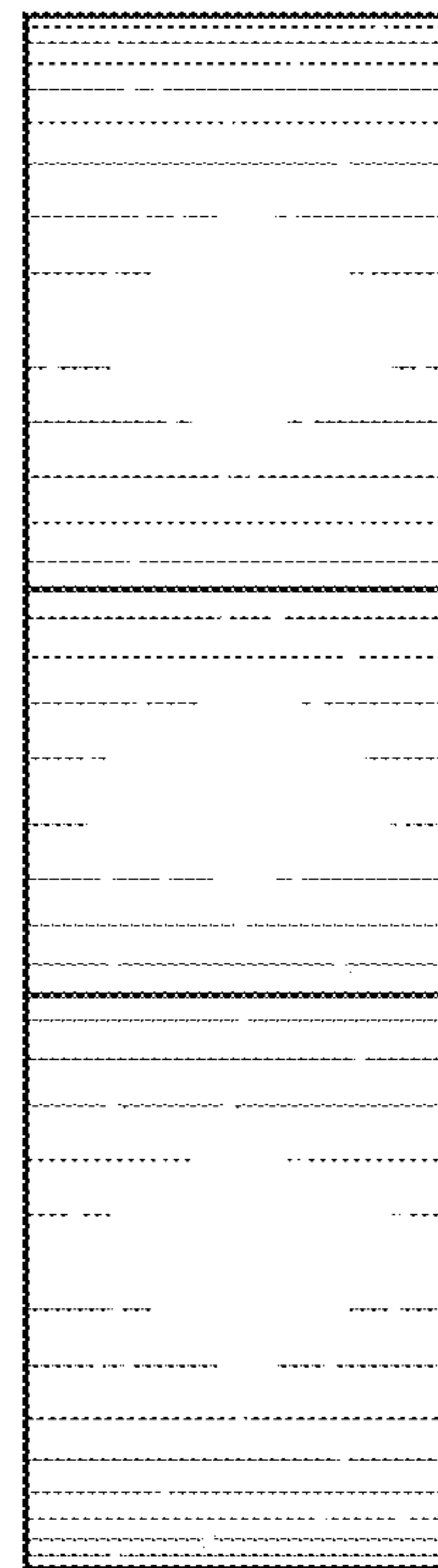
