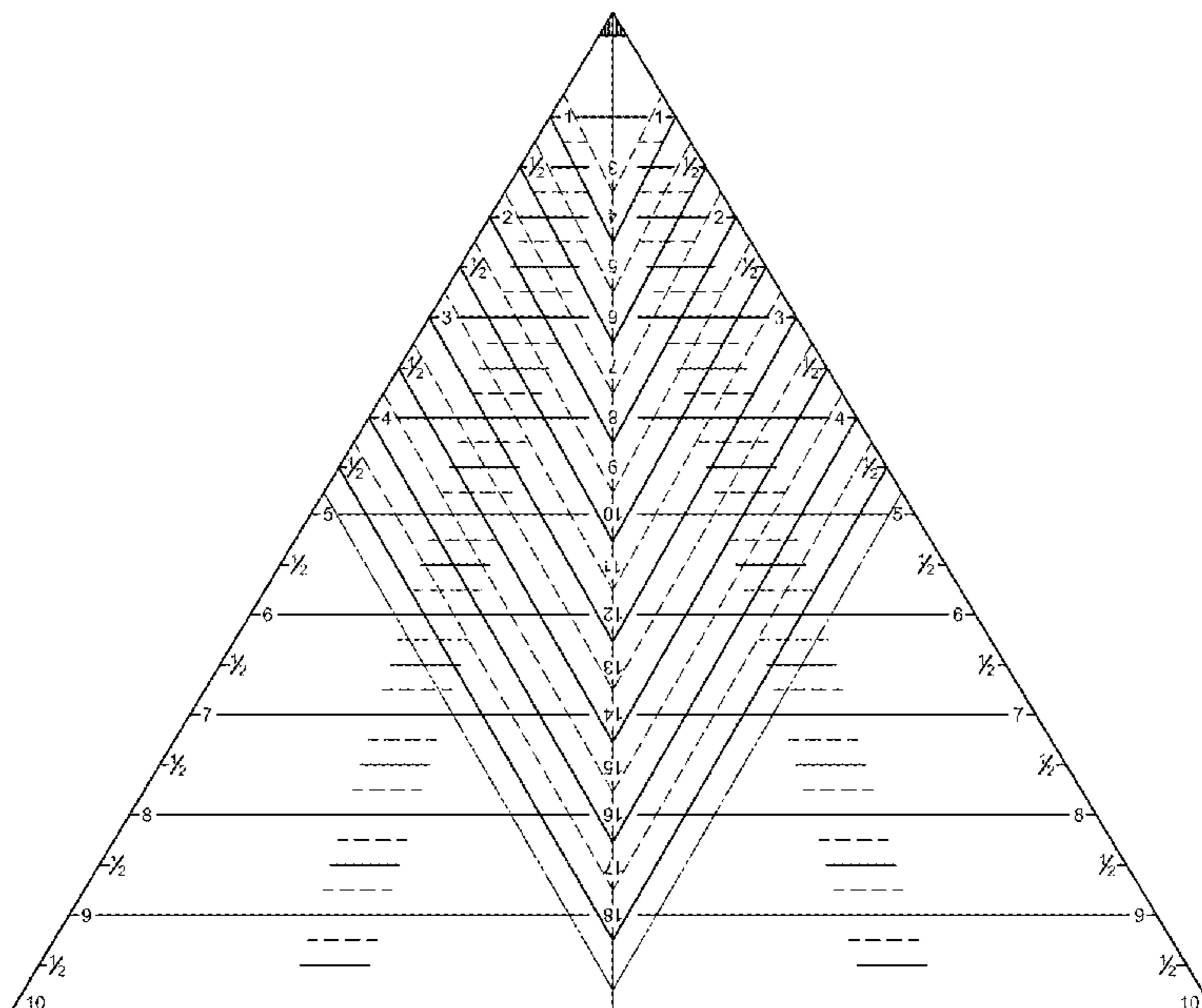
FIG. 1 is a top view of my quilt trimmer template showing my new design.

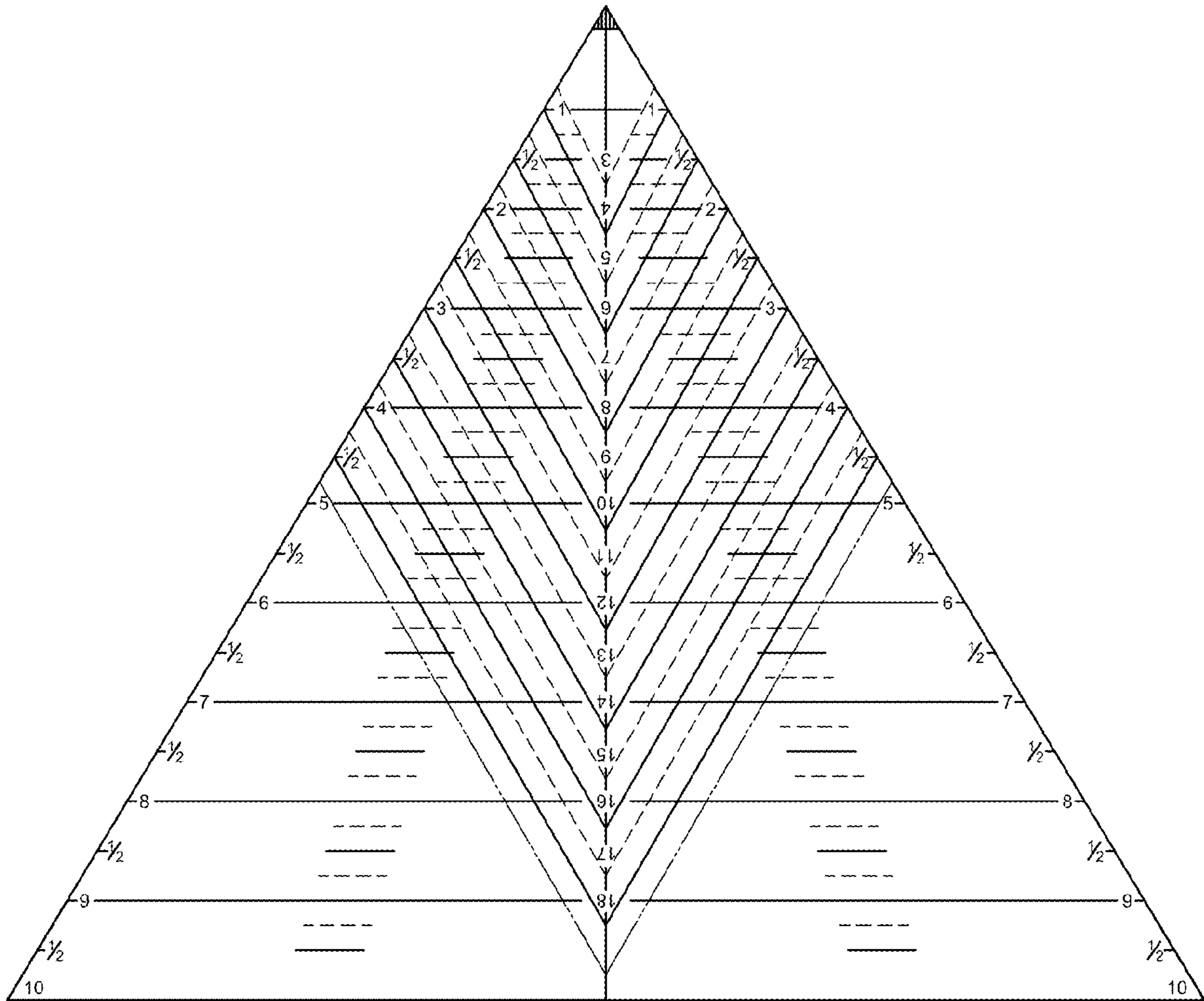

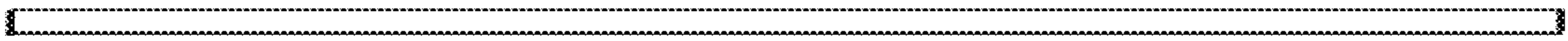

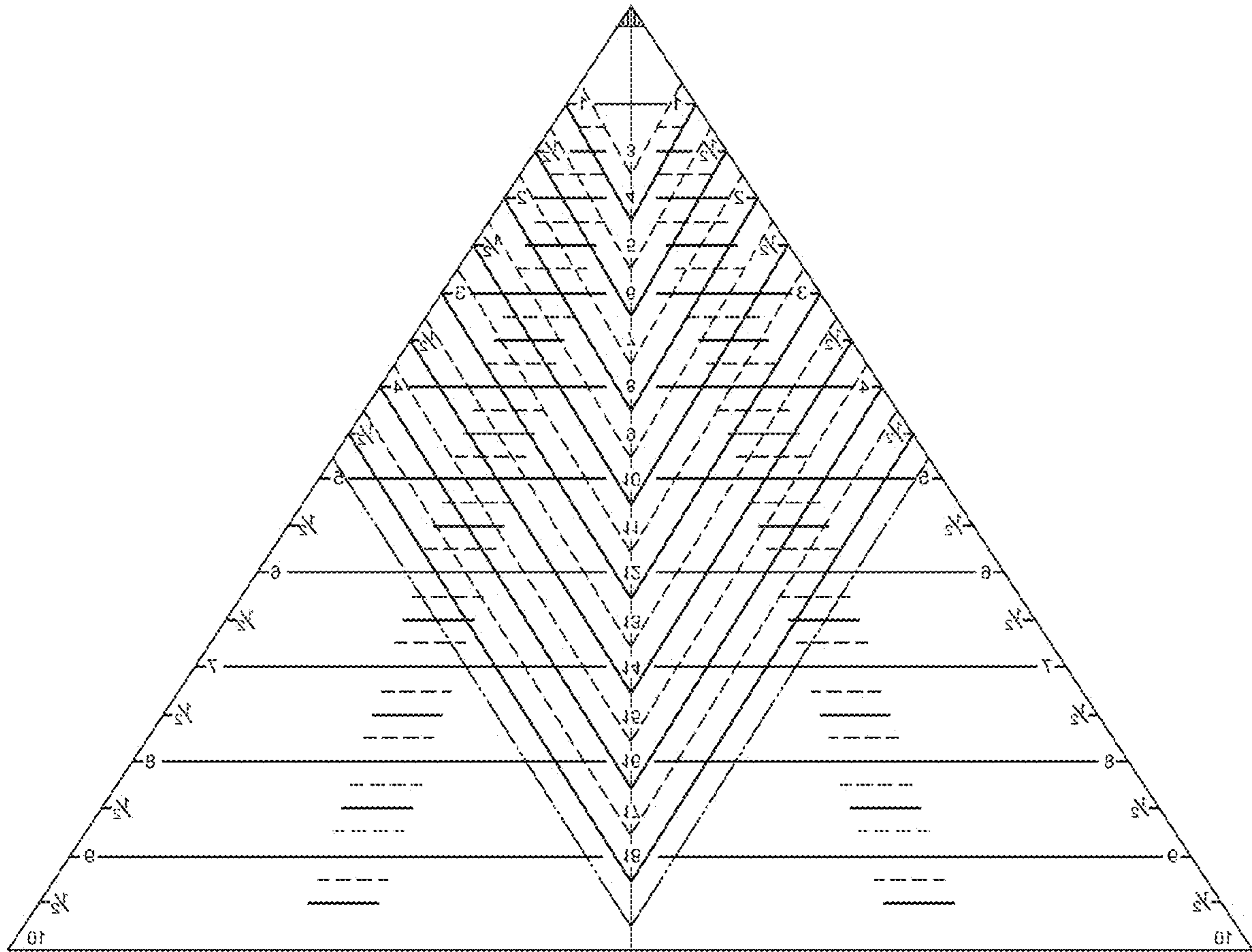
