(57) **CLAIM**

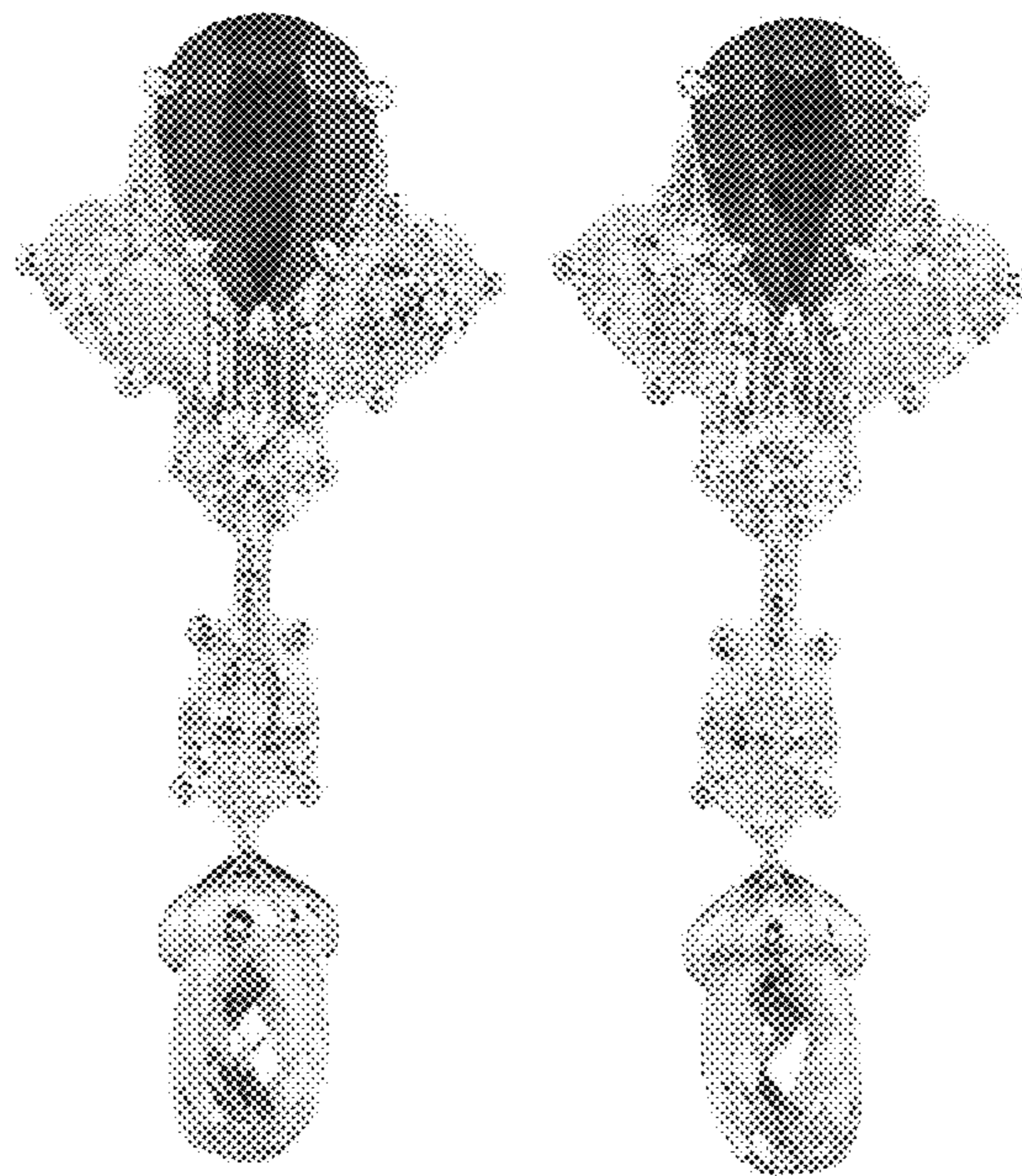
The ornamental design for a pair of earrings, as shown and described.

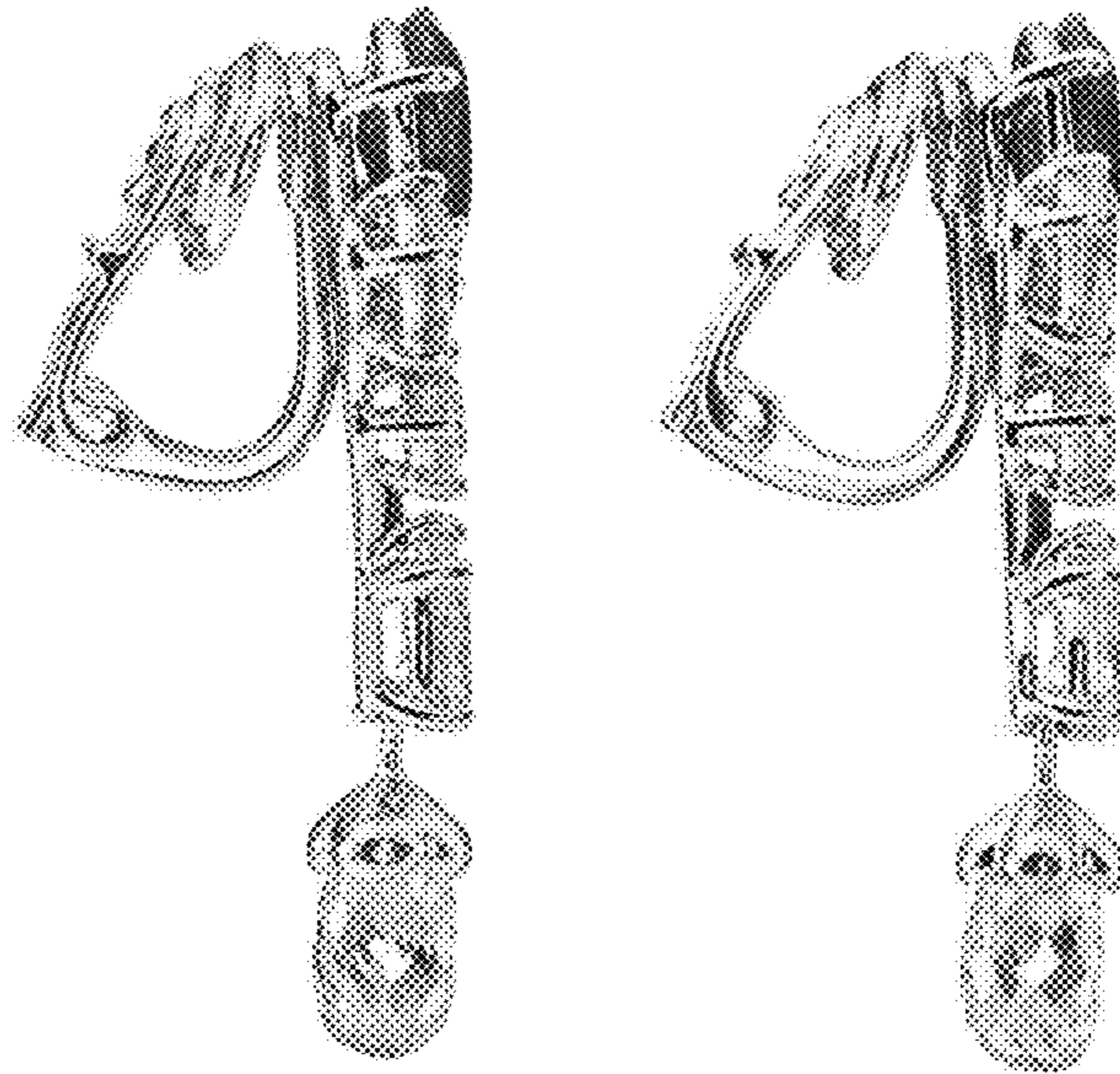

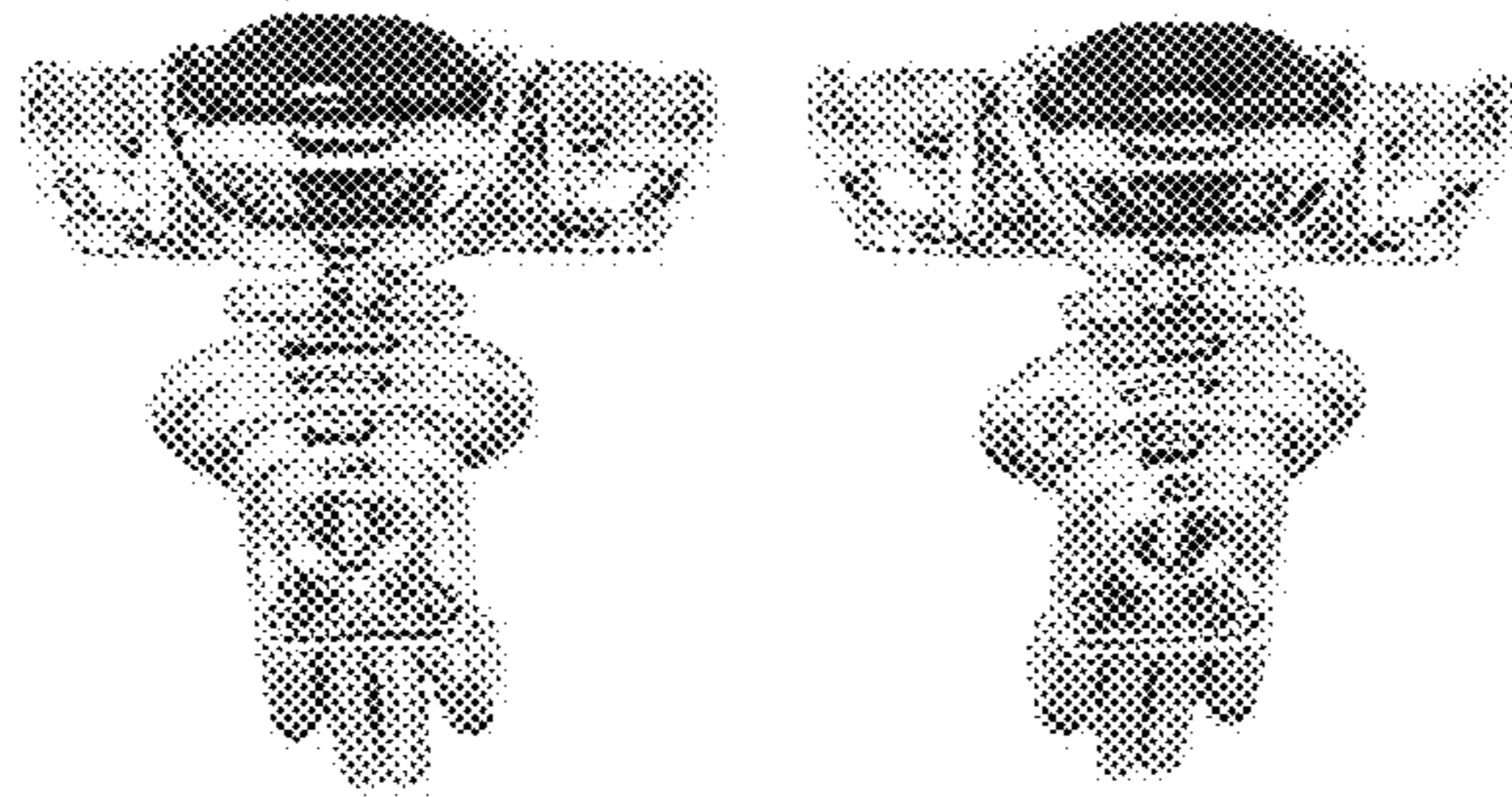

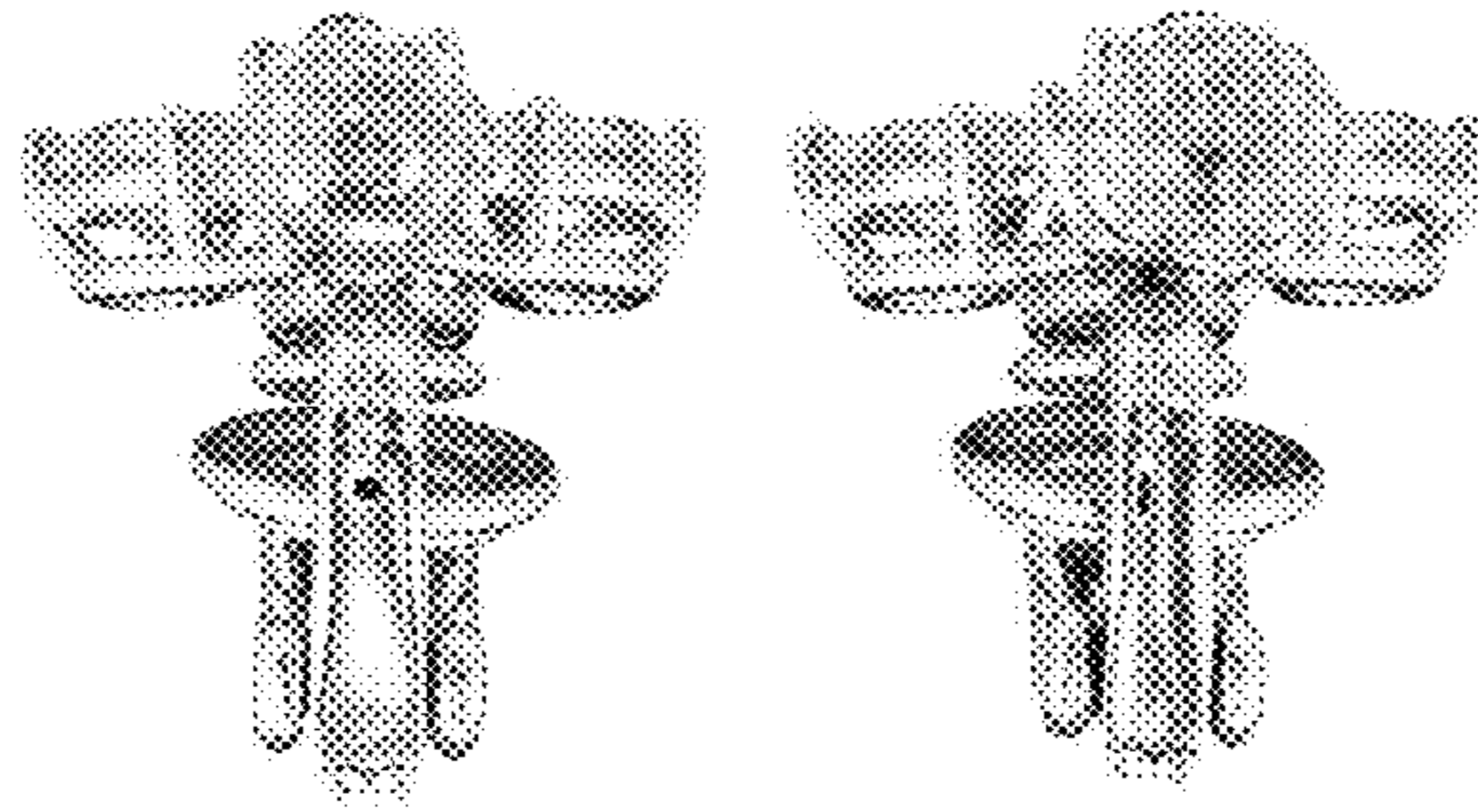

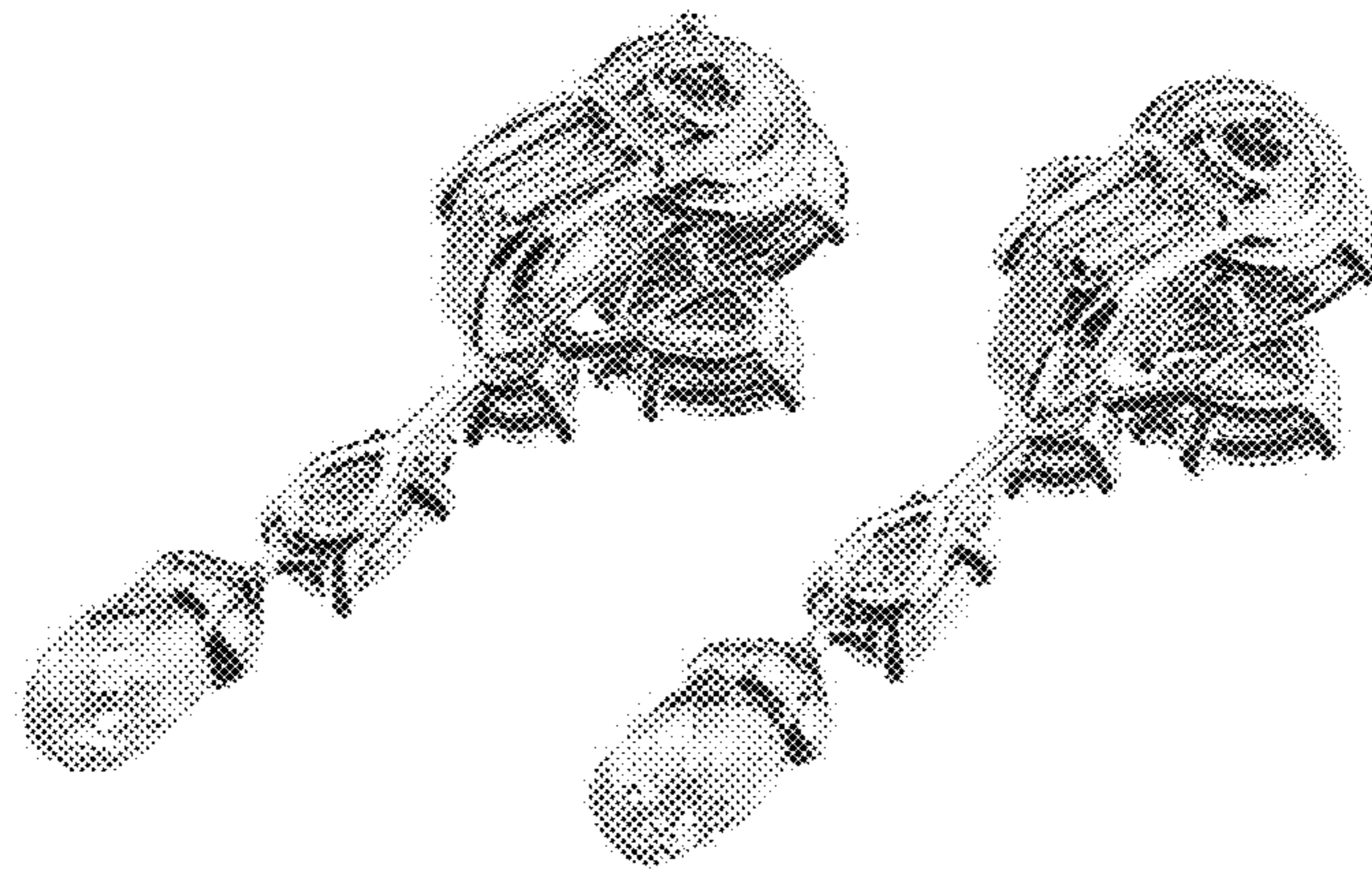
