(57) **CLAIM**

The ornamental design for a wheel for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wheel for automobile, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

The claimed design is indicated by the relatively dark portions in the figures, while the de-emphasized greyscale portions form no part of the claimed design.

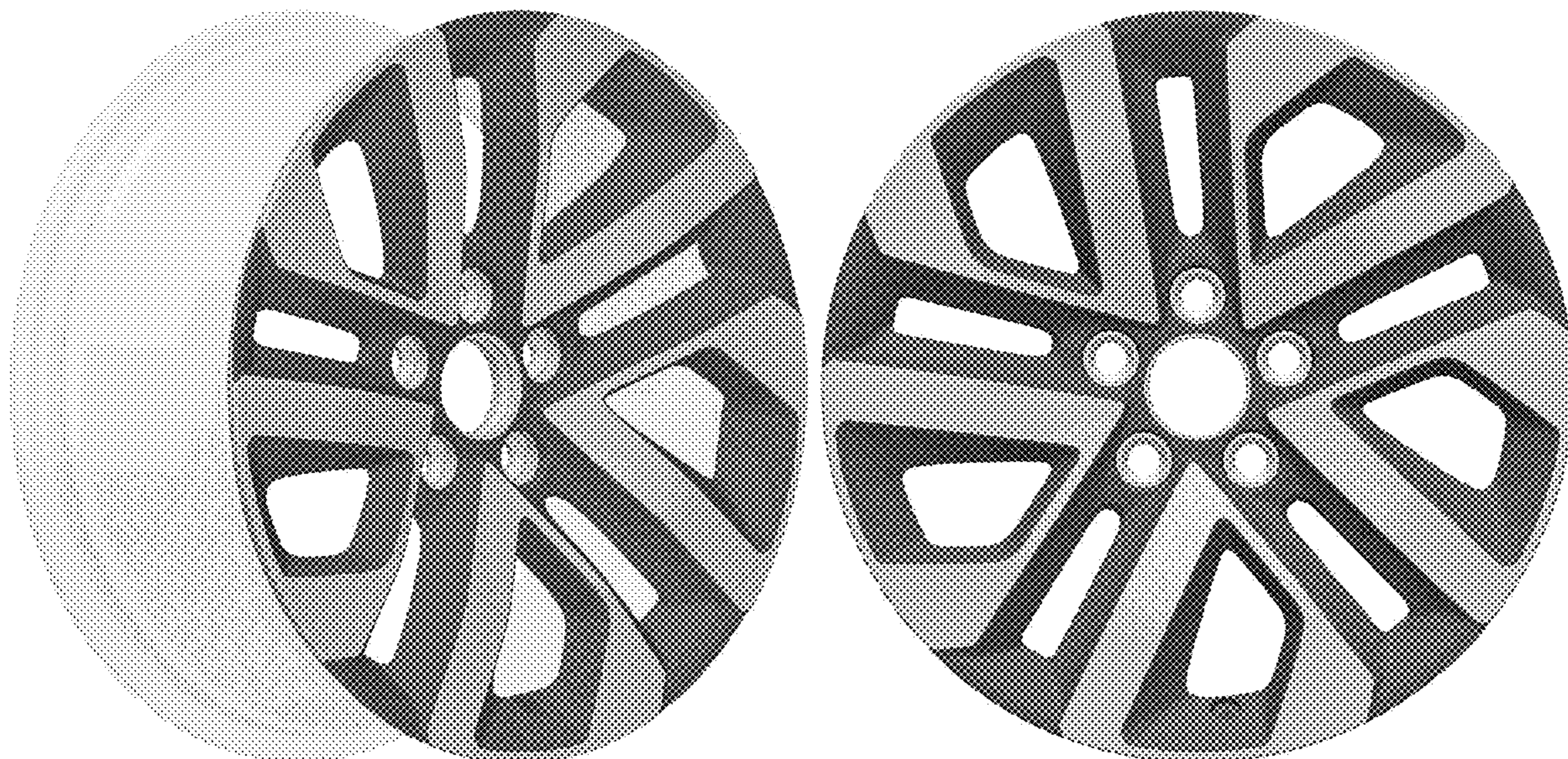

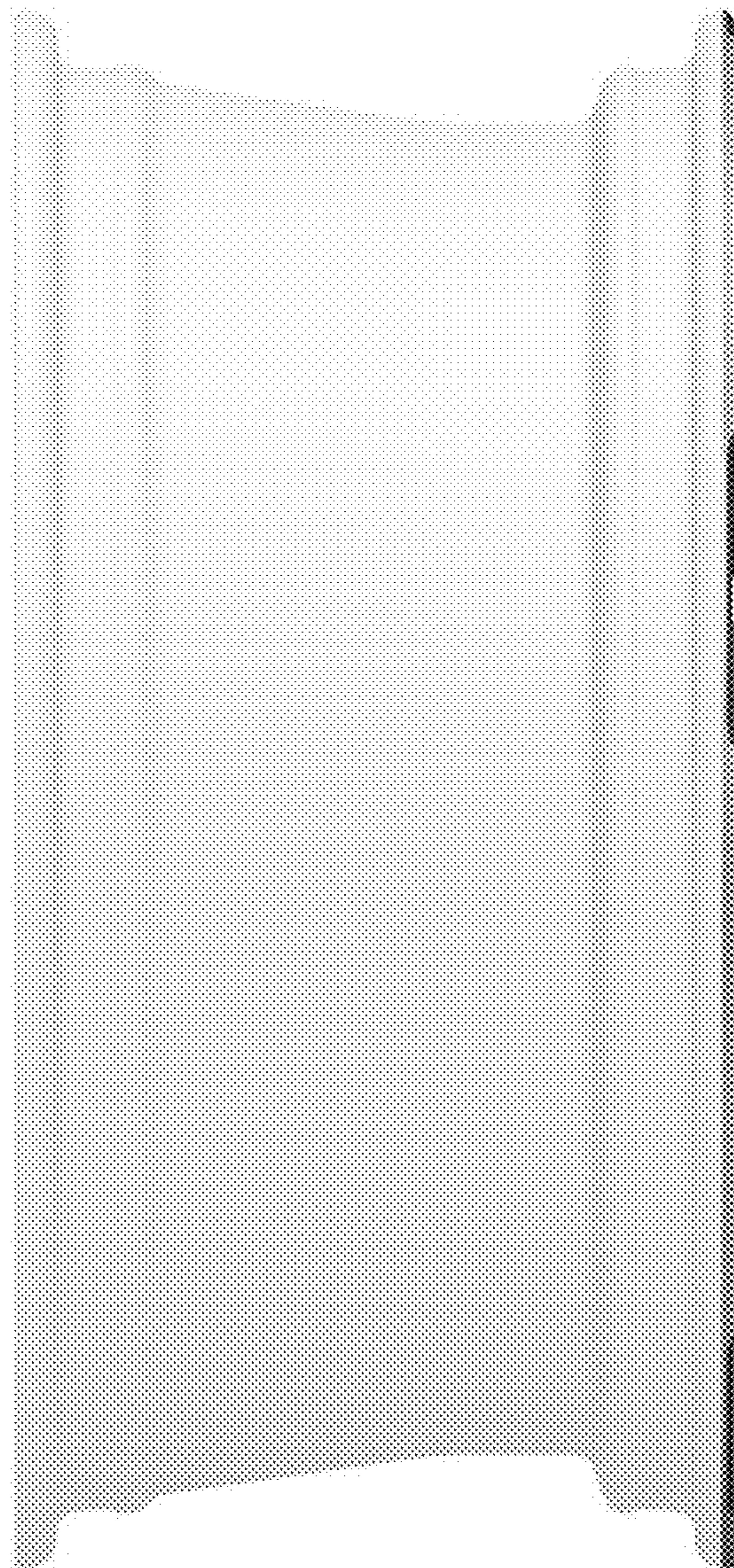

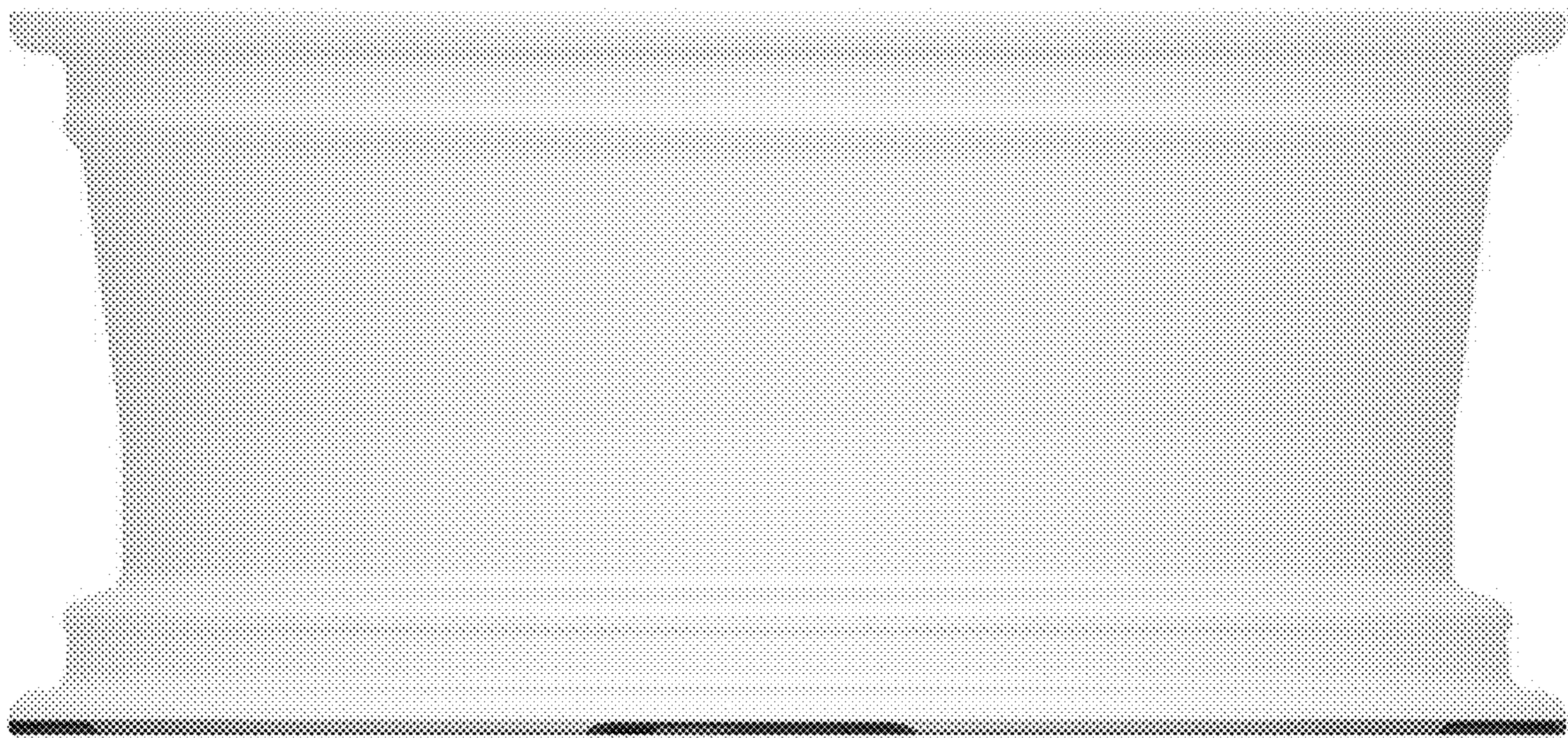
