(57) **CLAIM**

We claim the ornamental design for a rollable television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rollable television receiver showing the new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a left-side elevation view thereof;
 FIG. 5 is a right-side elevation view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a rear perspective view thereof; and,
 FIG. 9 is an enlarged view of portion 9 shown in FIG. 1. The broken lines encircling an enlargement portion of the design form no part of the claimed design.

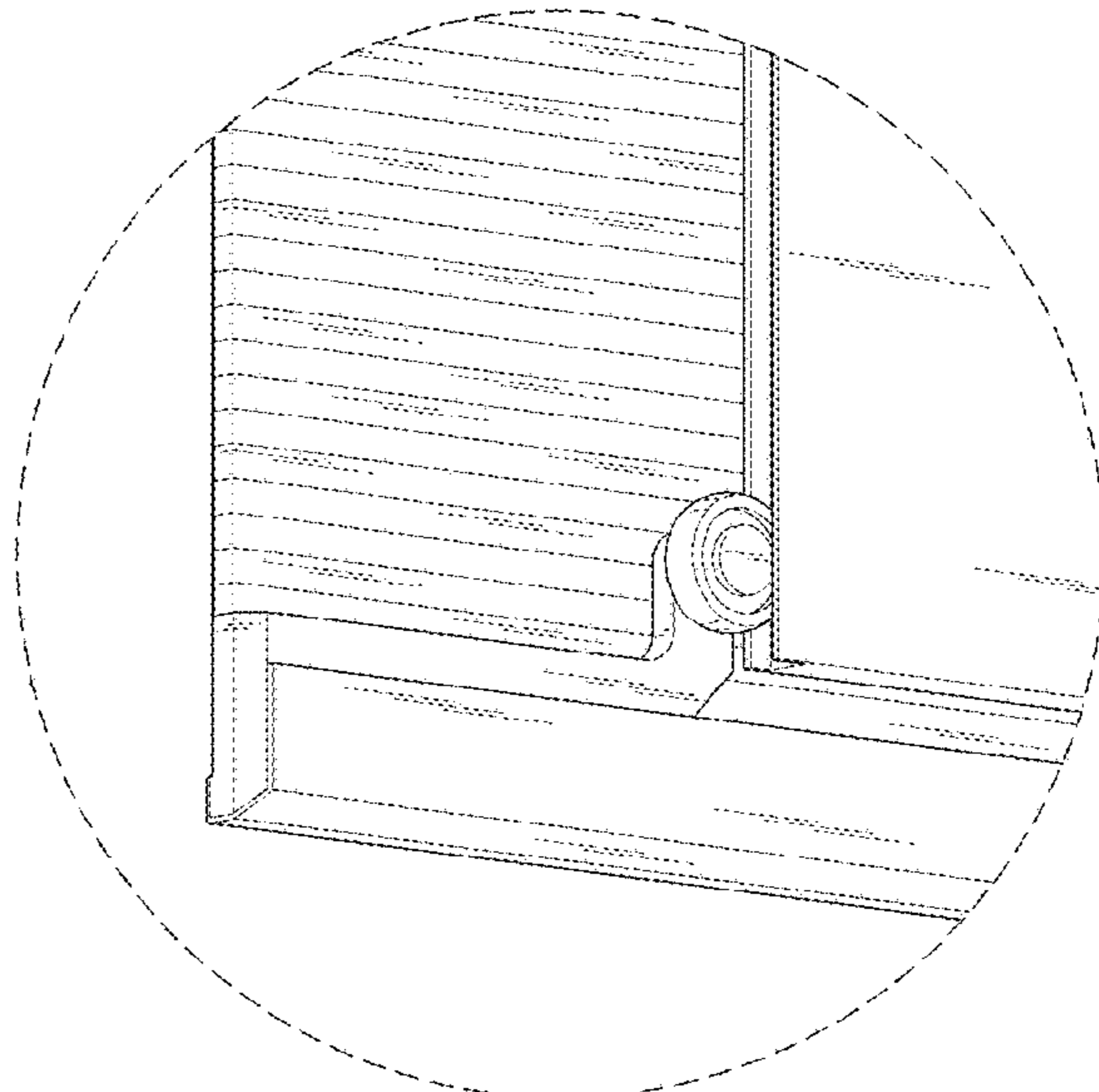
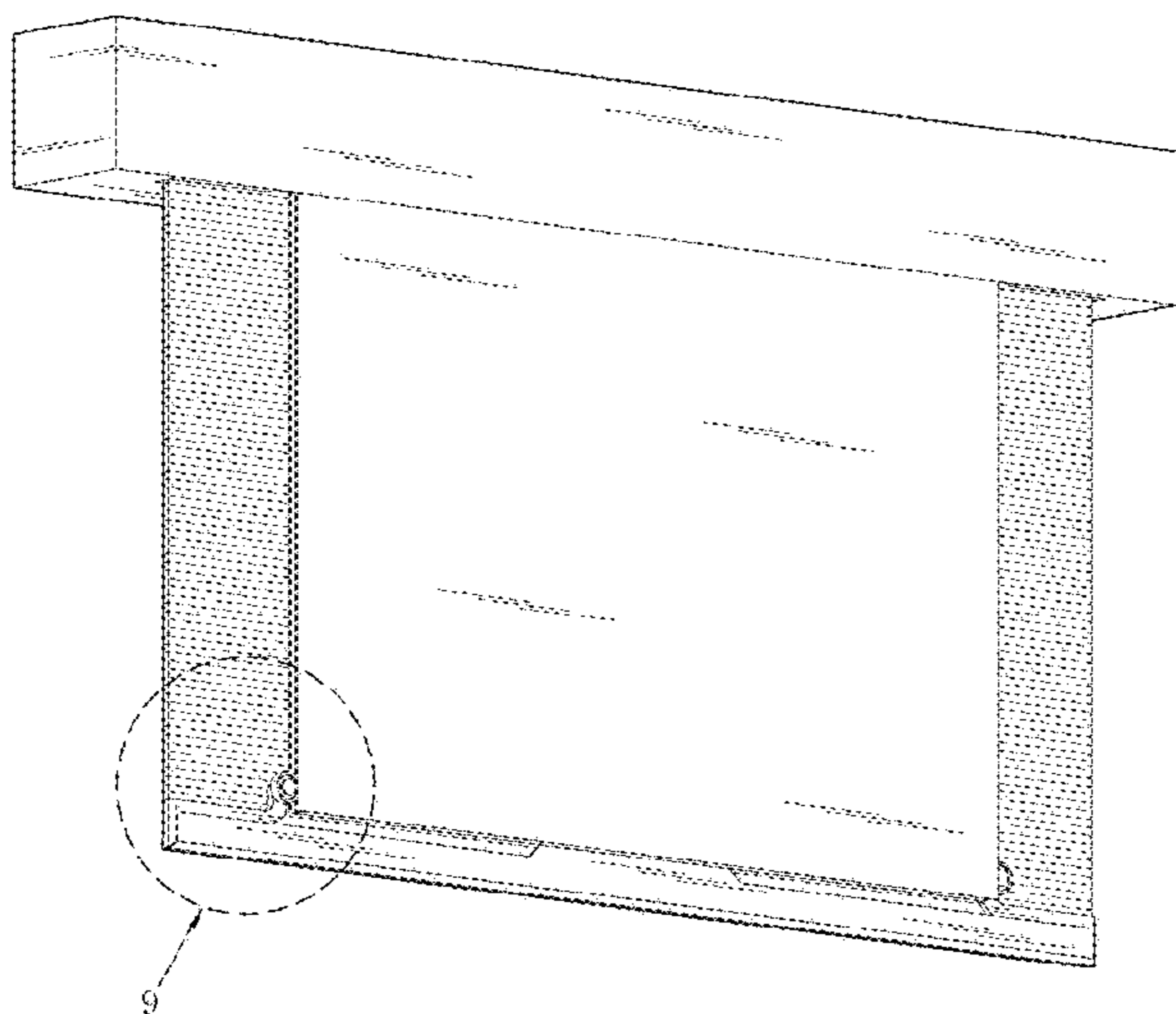

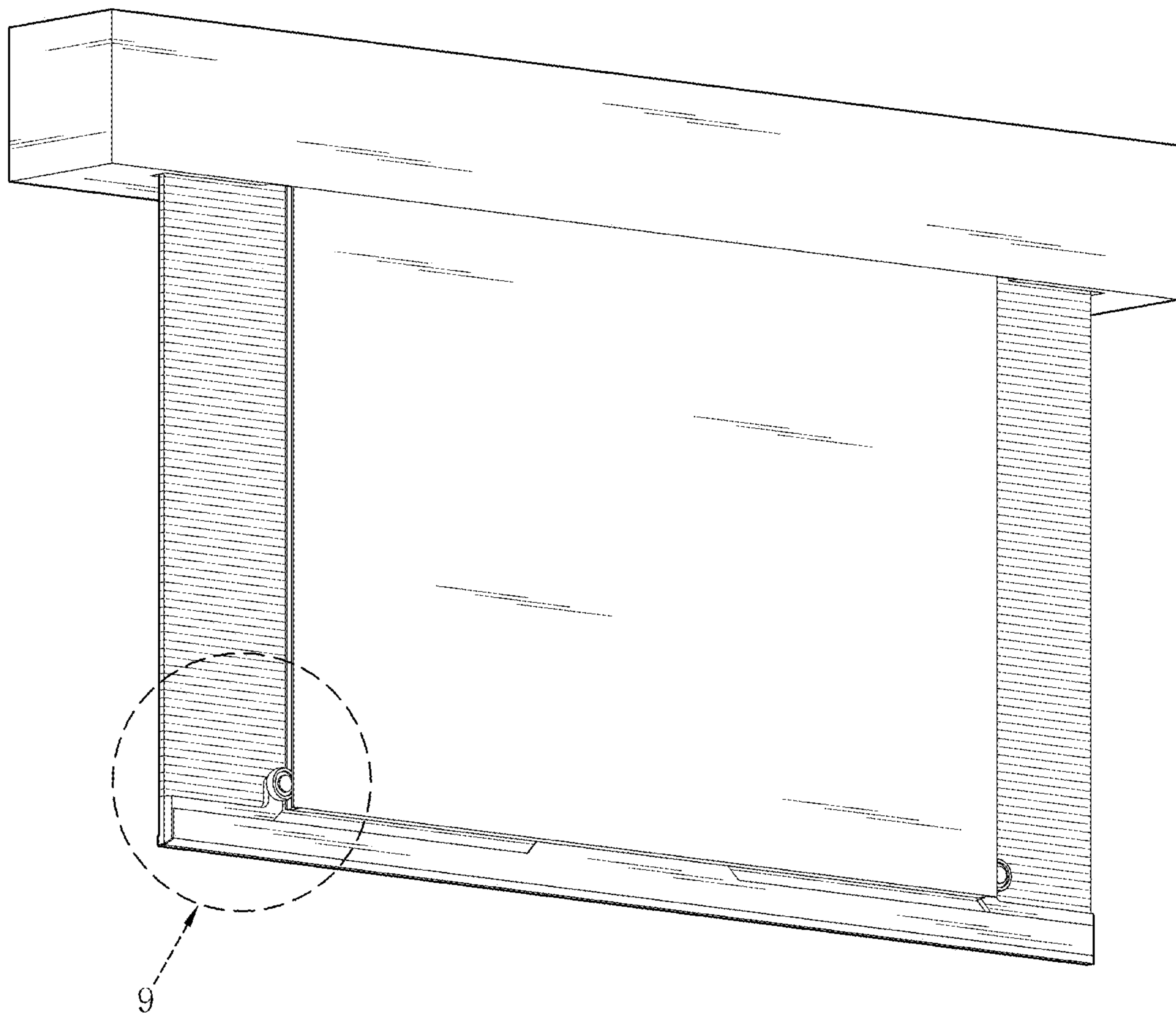

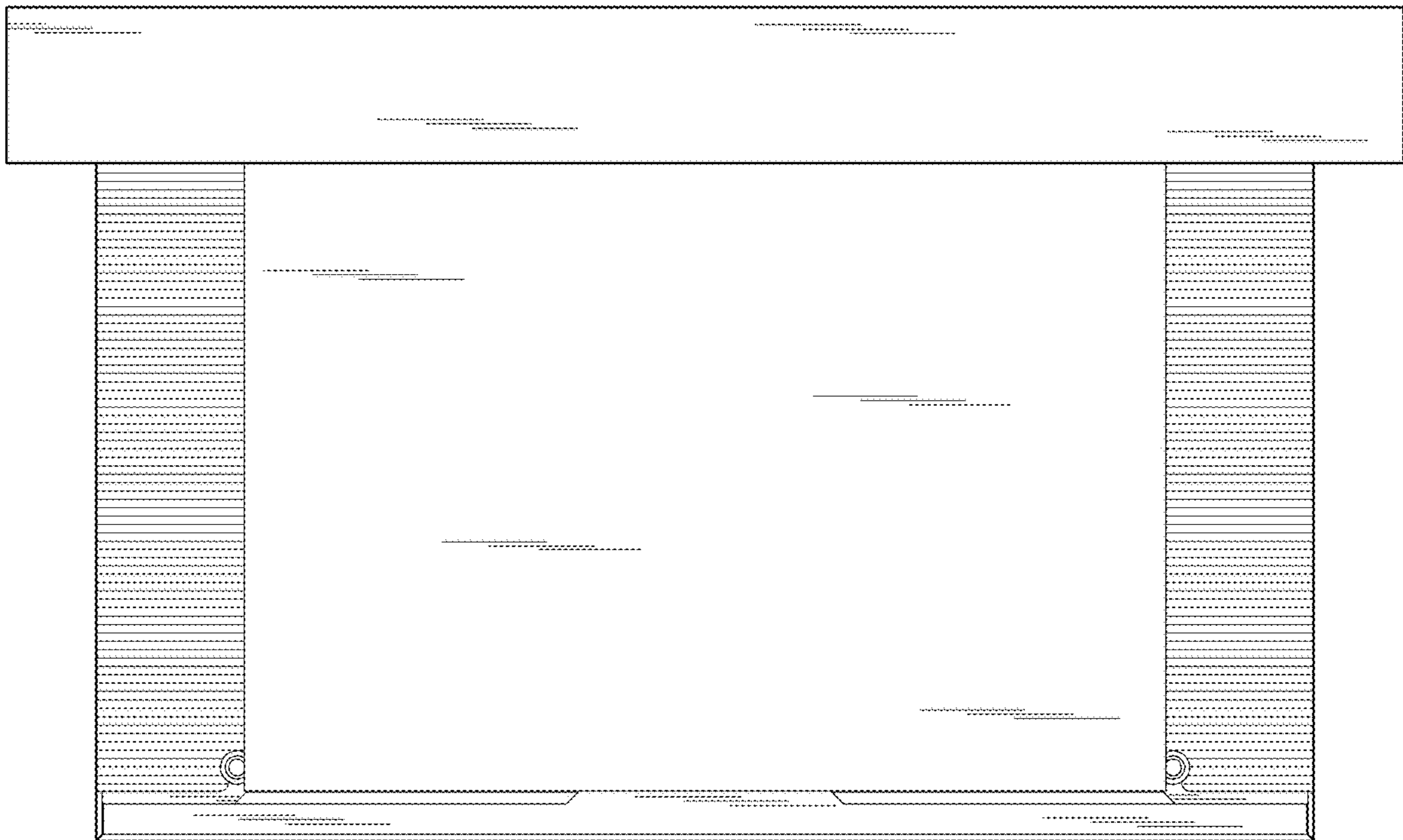

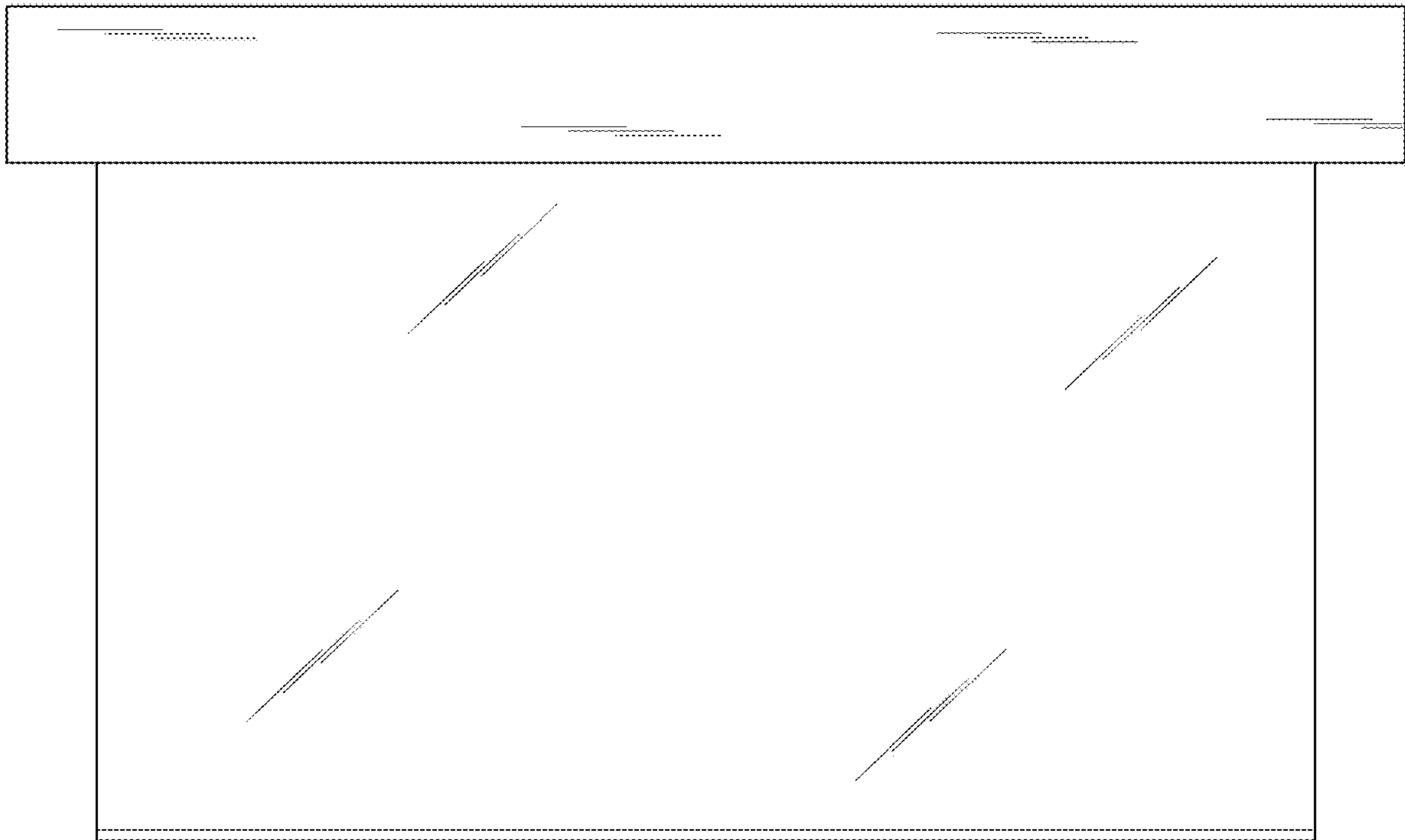

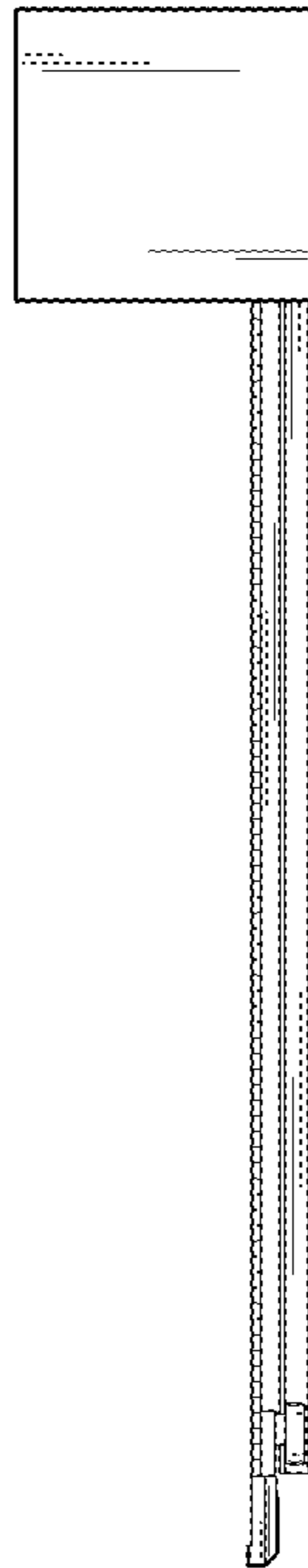

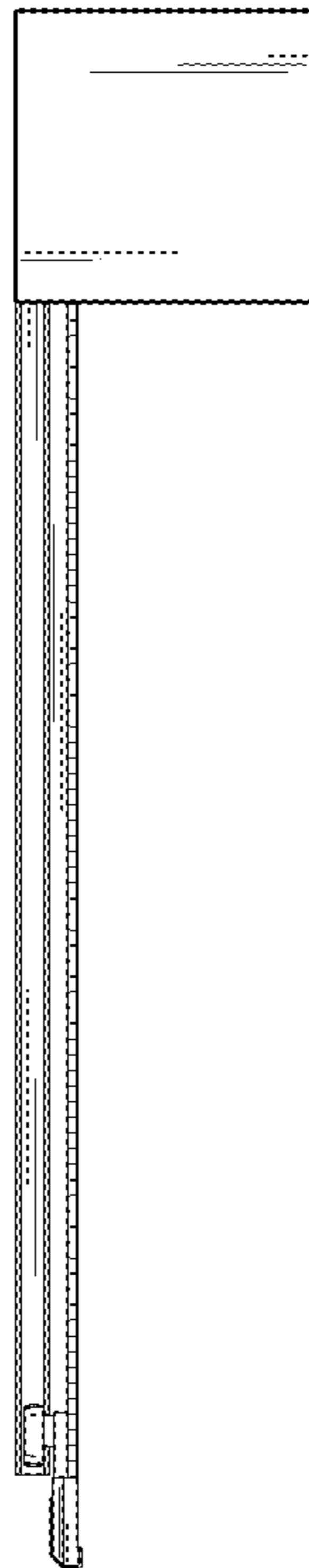

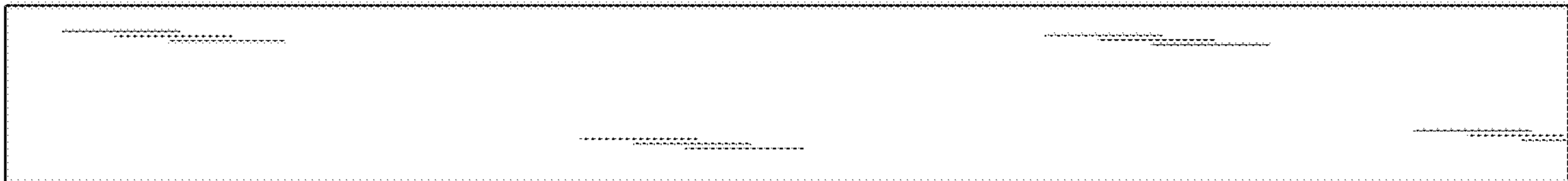

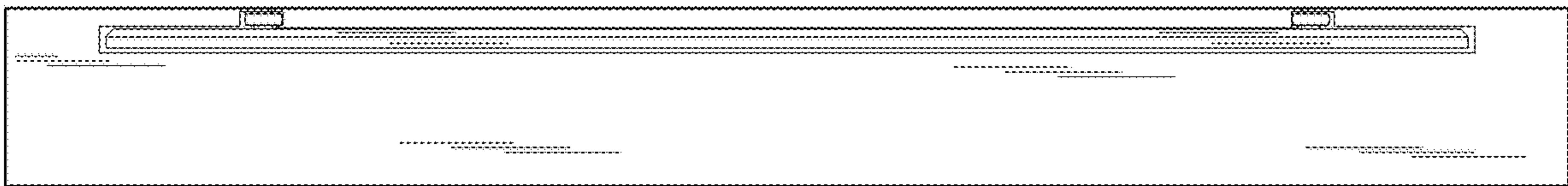

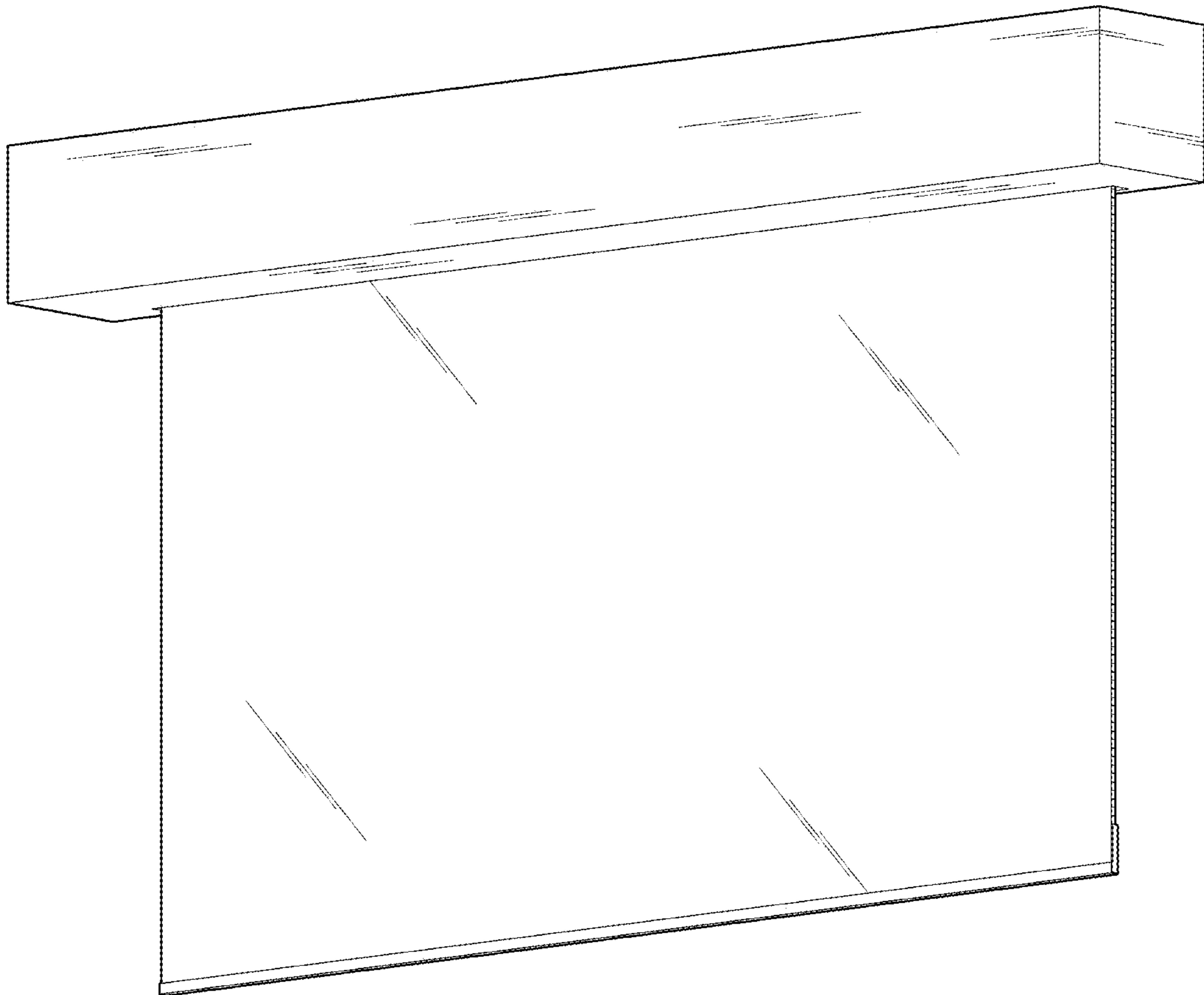
