(57) **CLAIM**

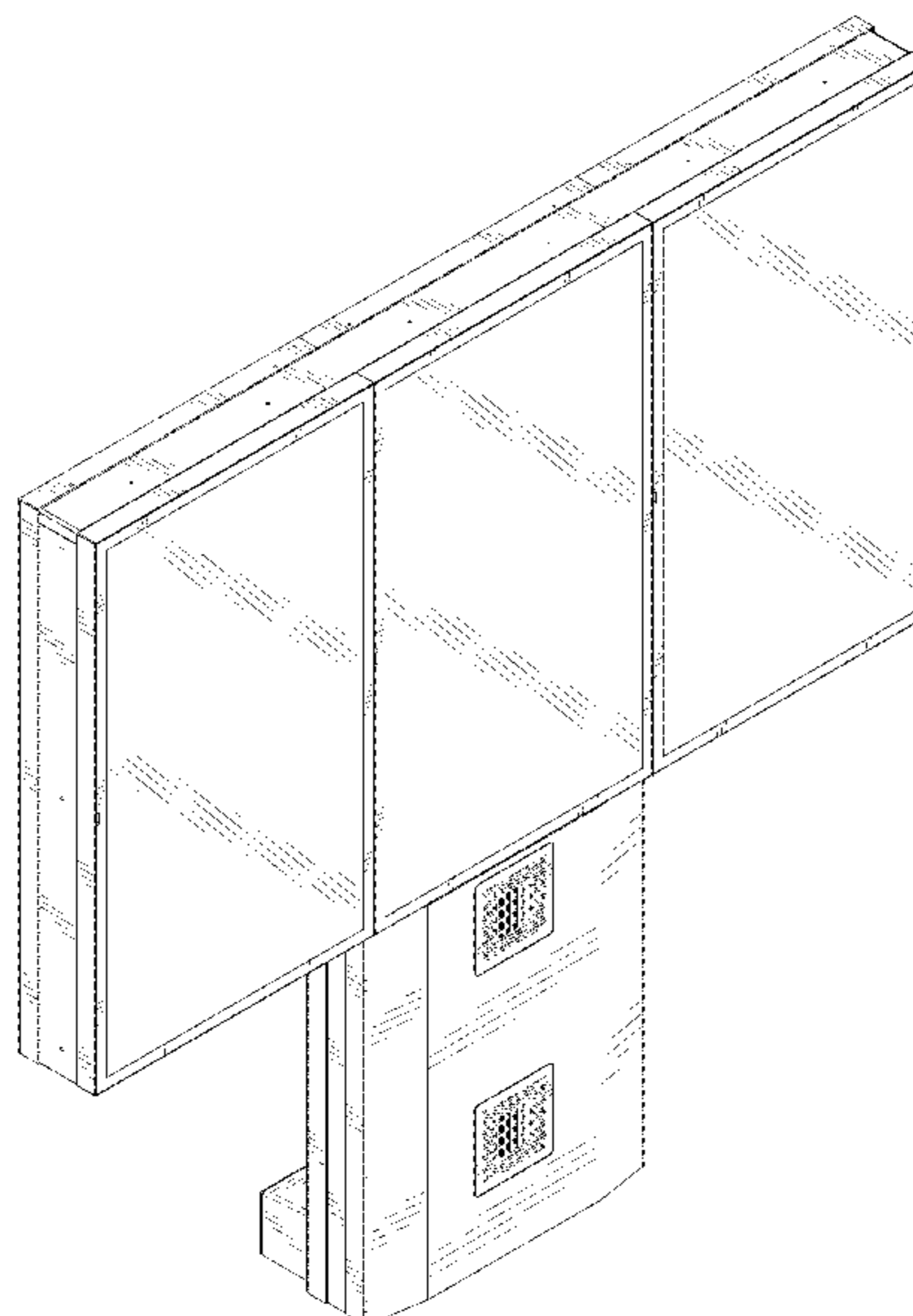
The ornamental design for a pedestal digital outdoor display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment thereof; FIG. 2 is a first side view of the embodiment of FIG. 1; FIG. 3 is a second side view of the embodiment of FIG. 1; FIG. 4 is a front view of the embodiment of FIG. 1; FIG. 5 is a back view of the embodiment of FIG. 1; FIG. 6 is a top view of the embodiment of FIG. 1; FIG. 7 is a bottom view of the embodiment of FIG. 1; FIG. 8 is a perspective view of a second embodiment thereof; and, FIG. 9 is a front view of the second embodiment viewed in FIG. 8.

First and second side views, a back view, and top and bottom views of the second embodiment viewed in FIG. 8 are not provided because they are the same as FIGS. 2, 3, 5, 6, and 7 respectively.

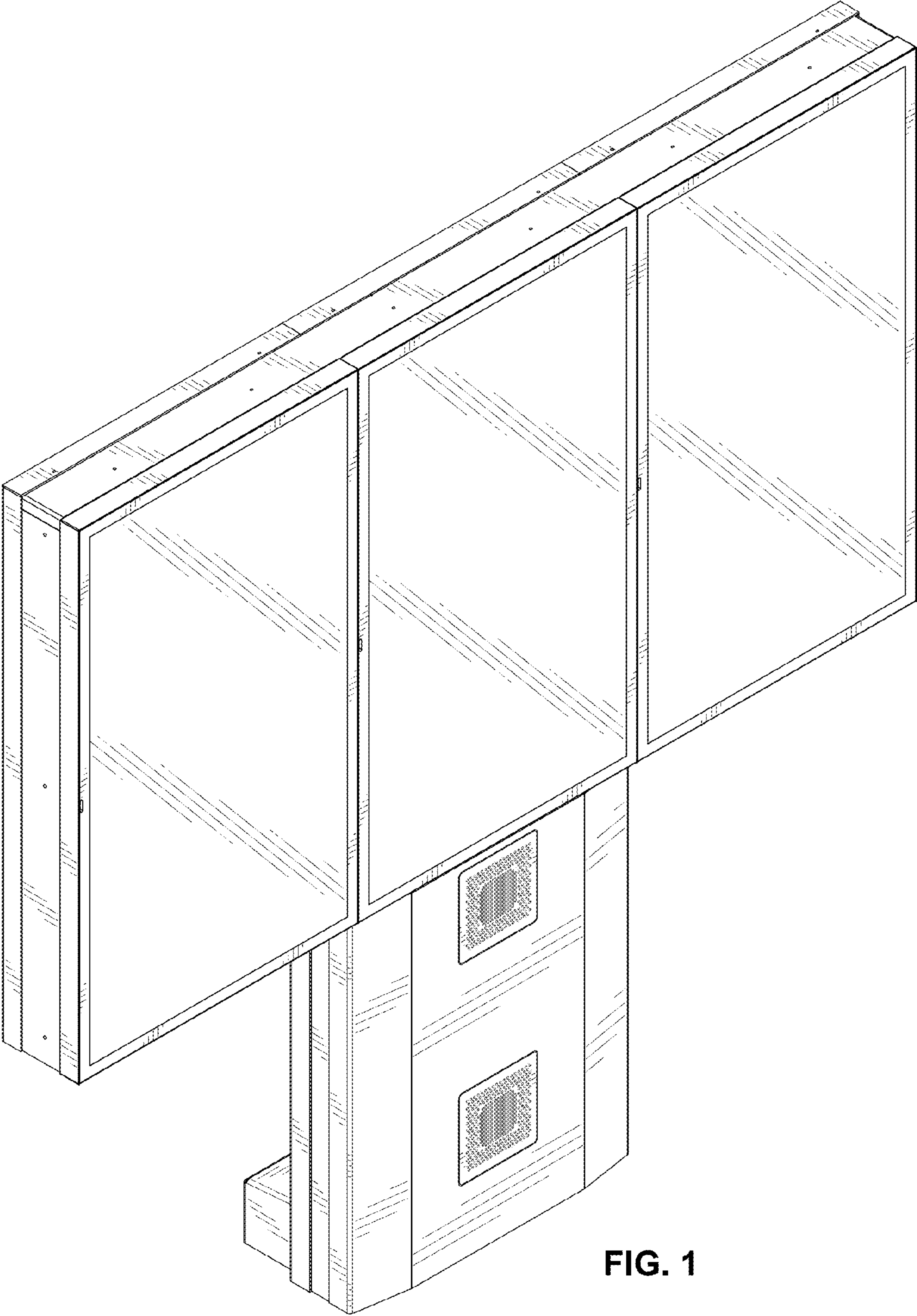

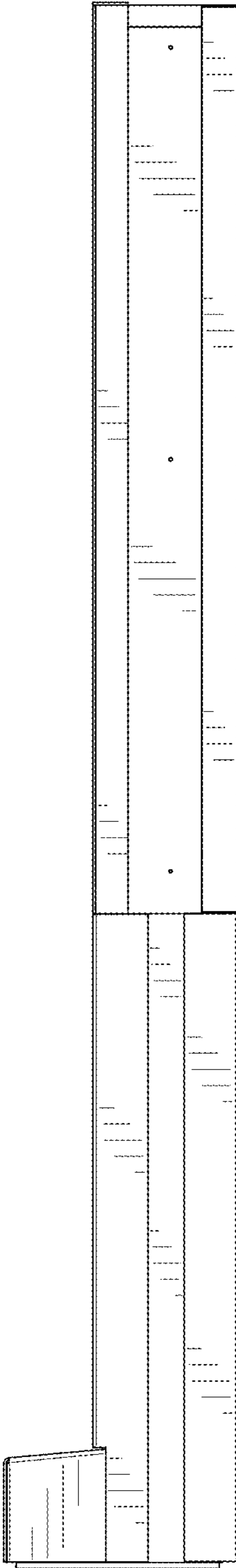

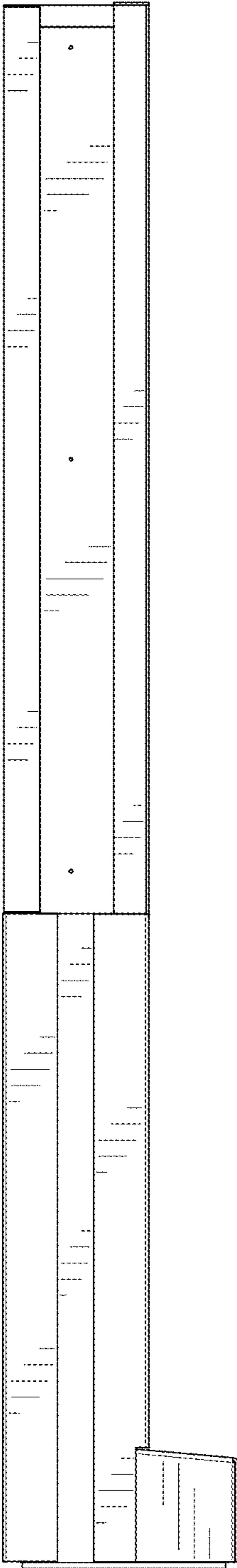

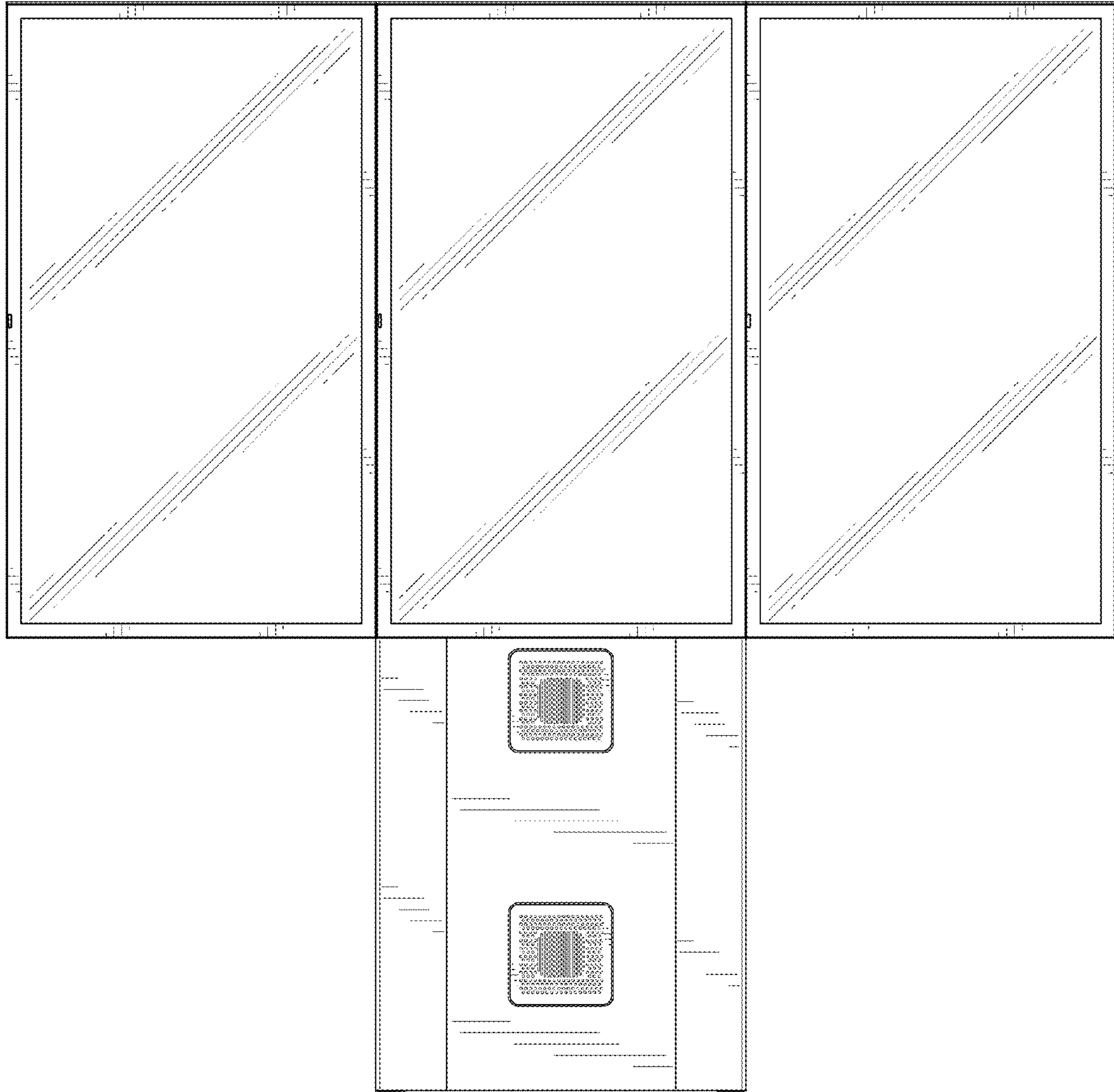

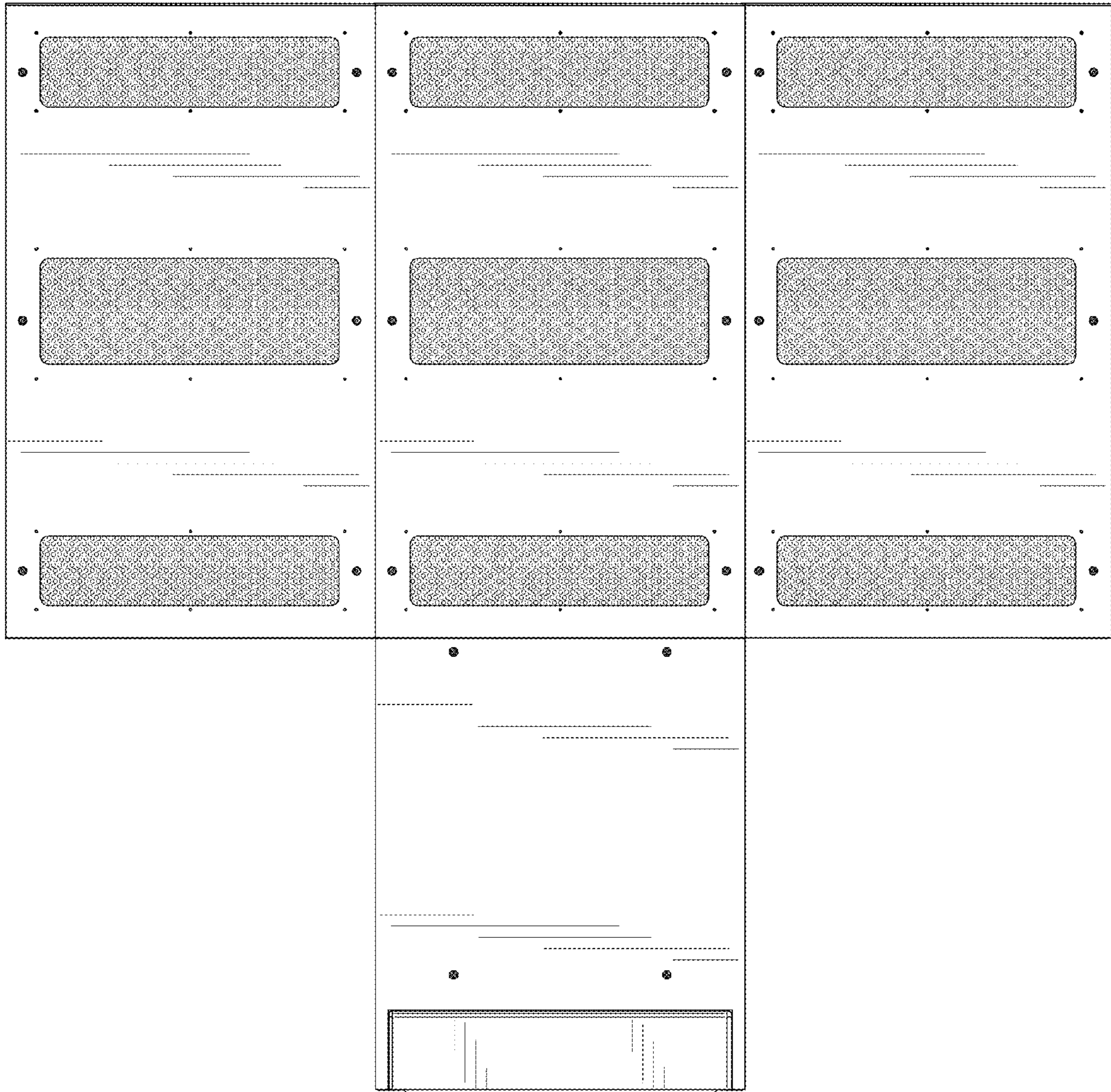

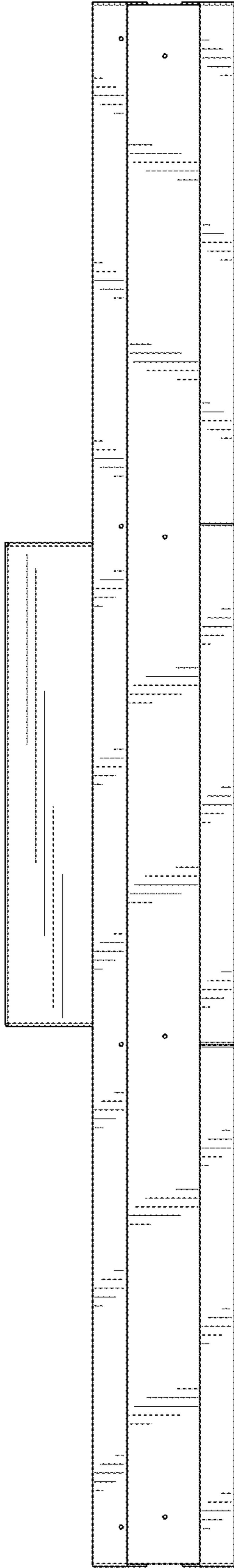

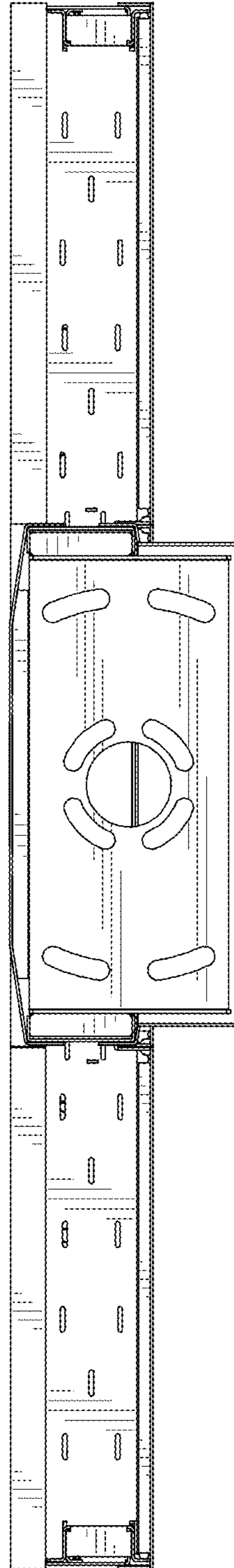

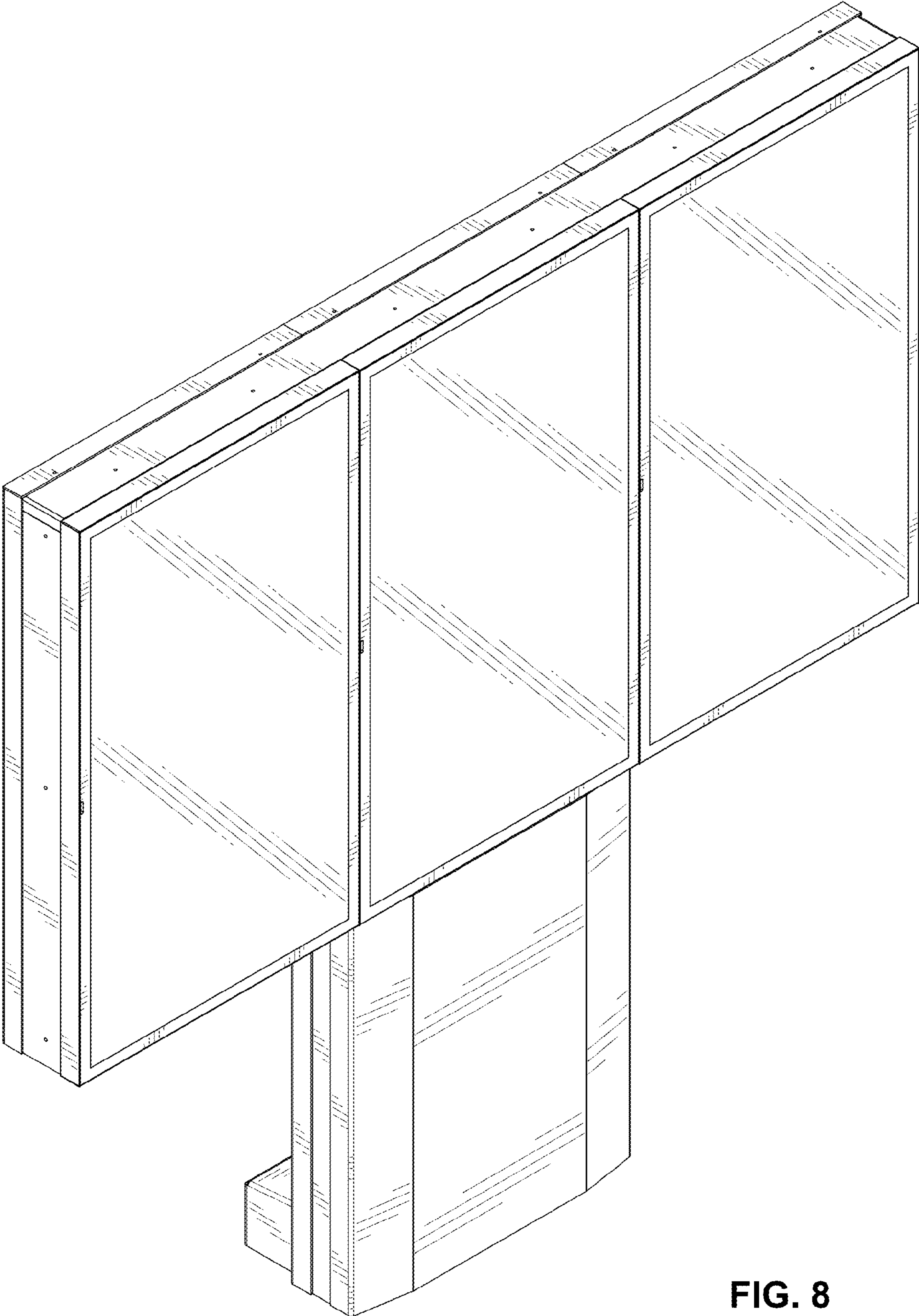

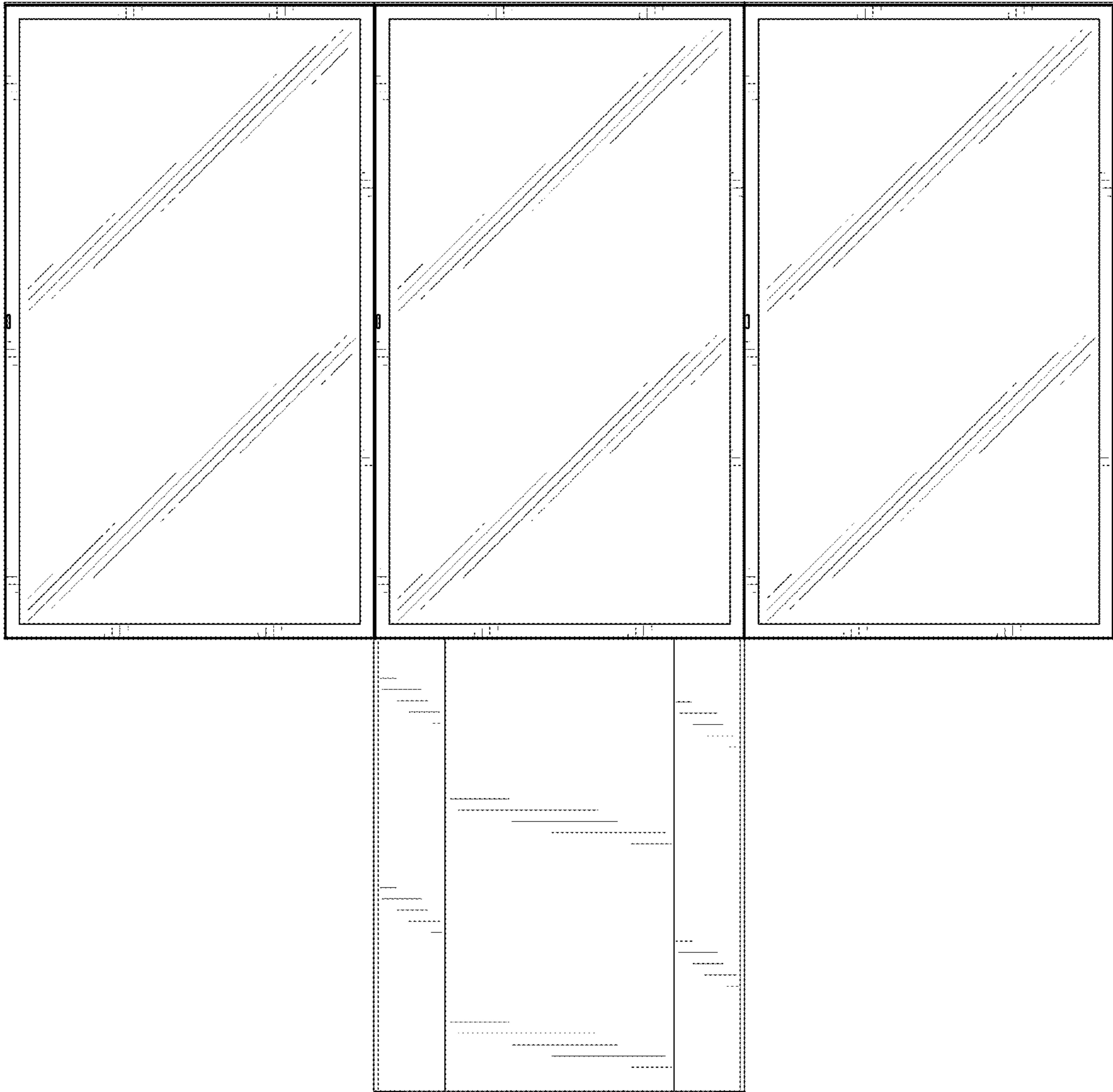
