(57) **CLAIM**

The ornamental design for a display device or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display device or portion thereof with animated graphical user interface showing a first image in a sequence;

FIG. 2 is a second image thereof;

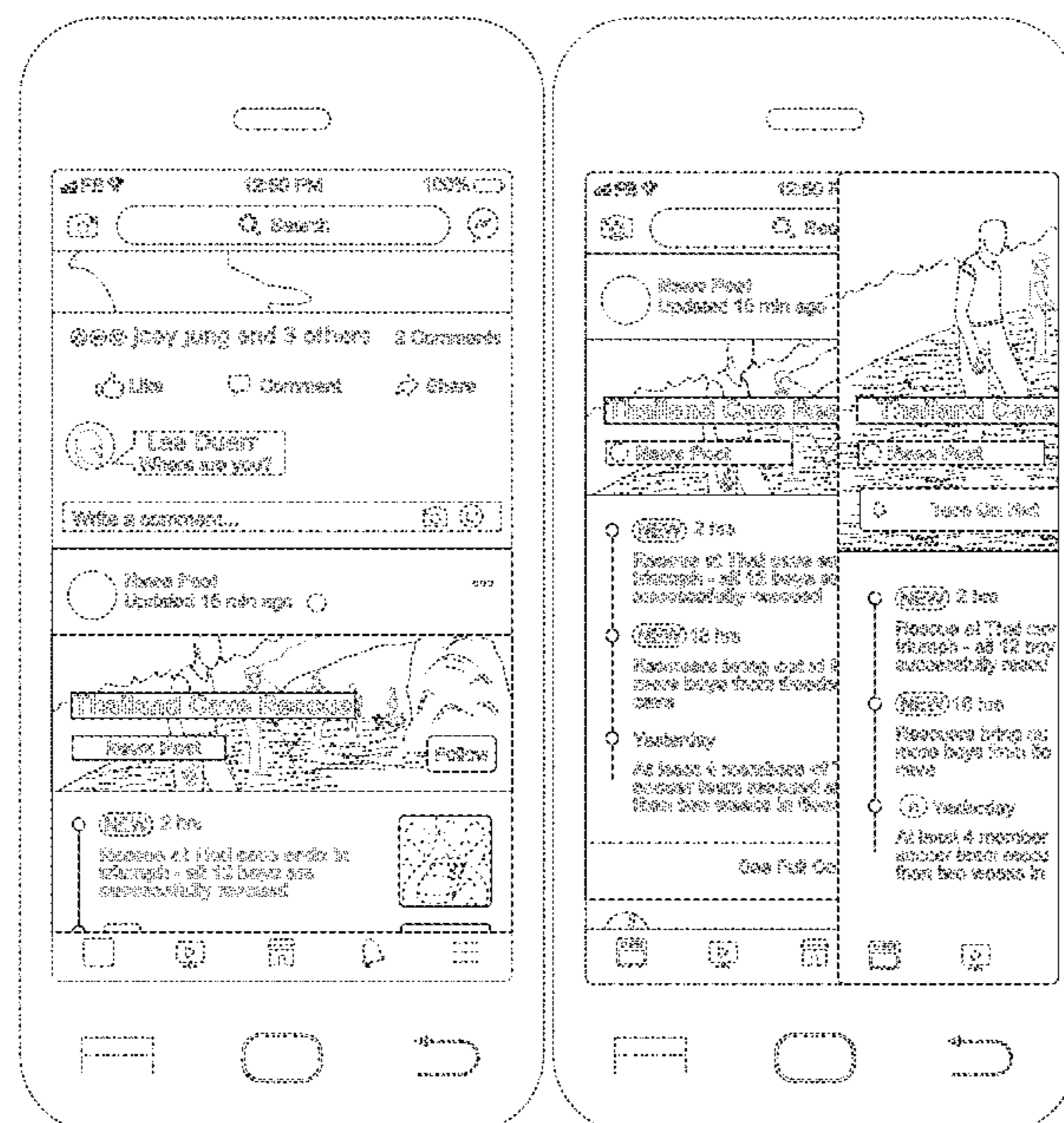
FIG. 3 is a third image thereof; and,

FIG. 4 is a fourth image thereof.

The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 1-4. The process or period in which an image transitions to another forms no part of the claimed design.

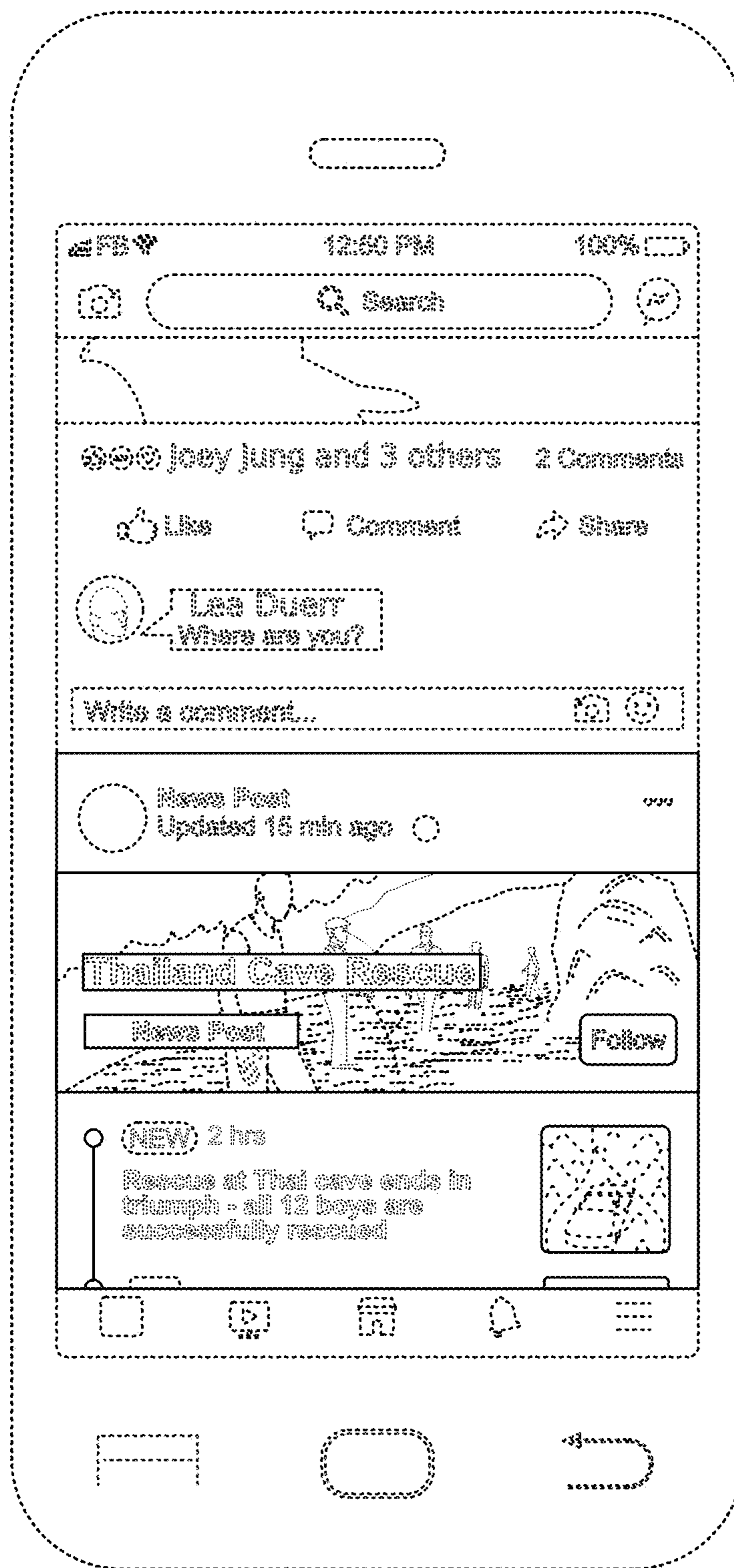
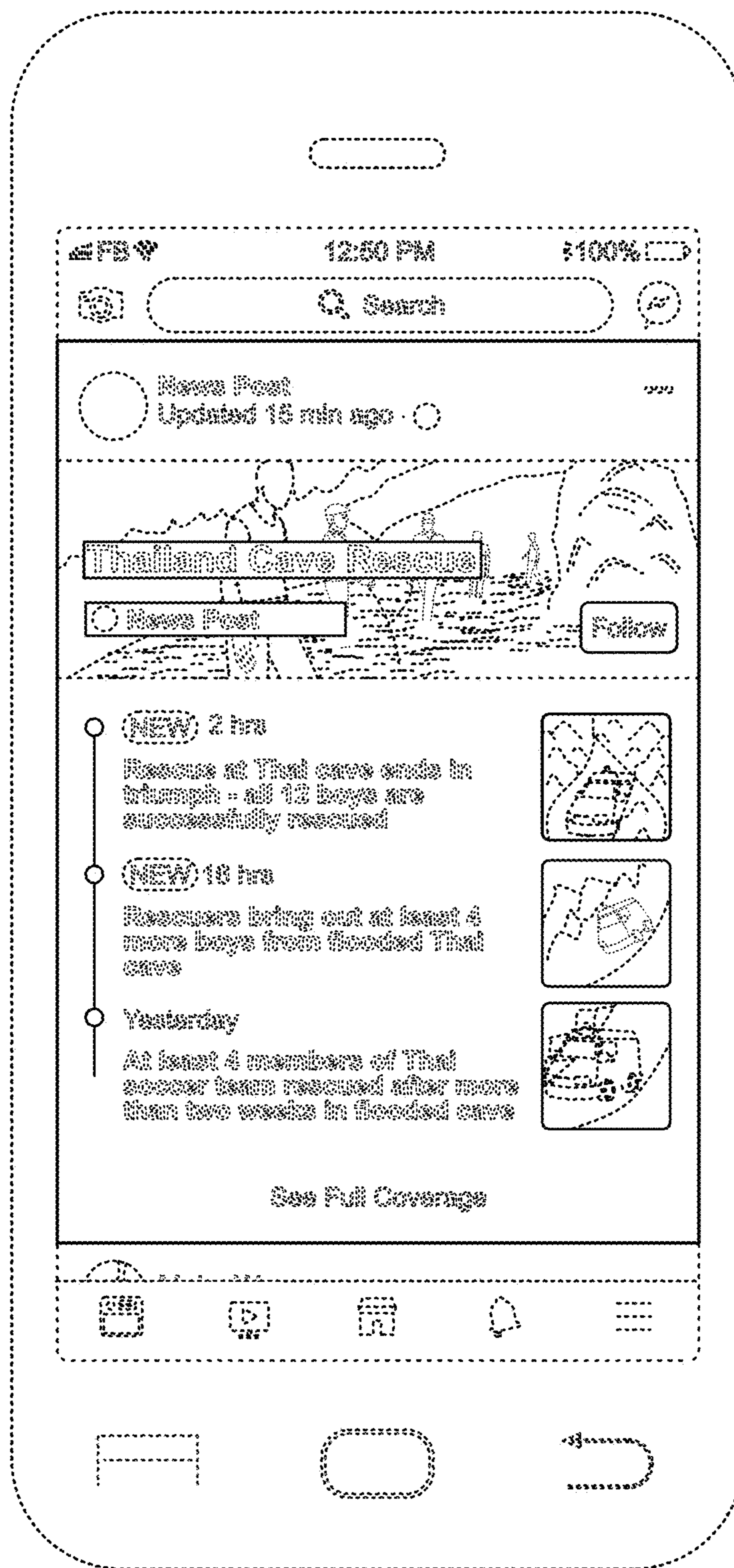

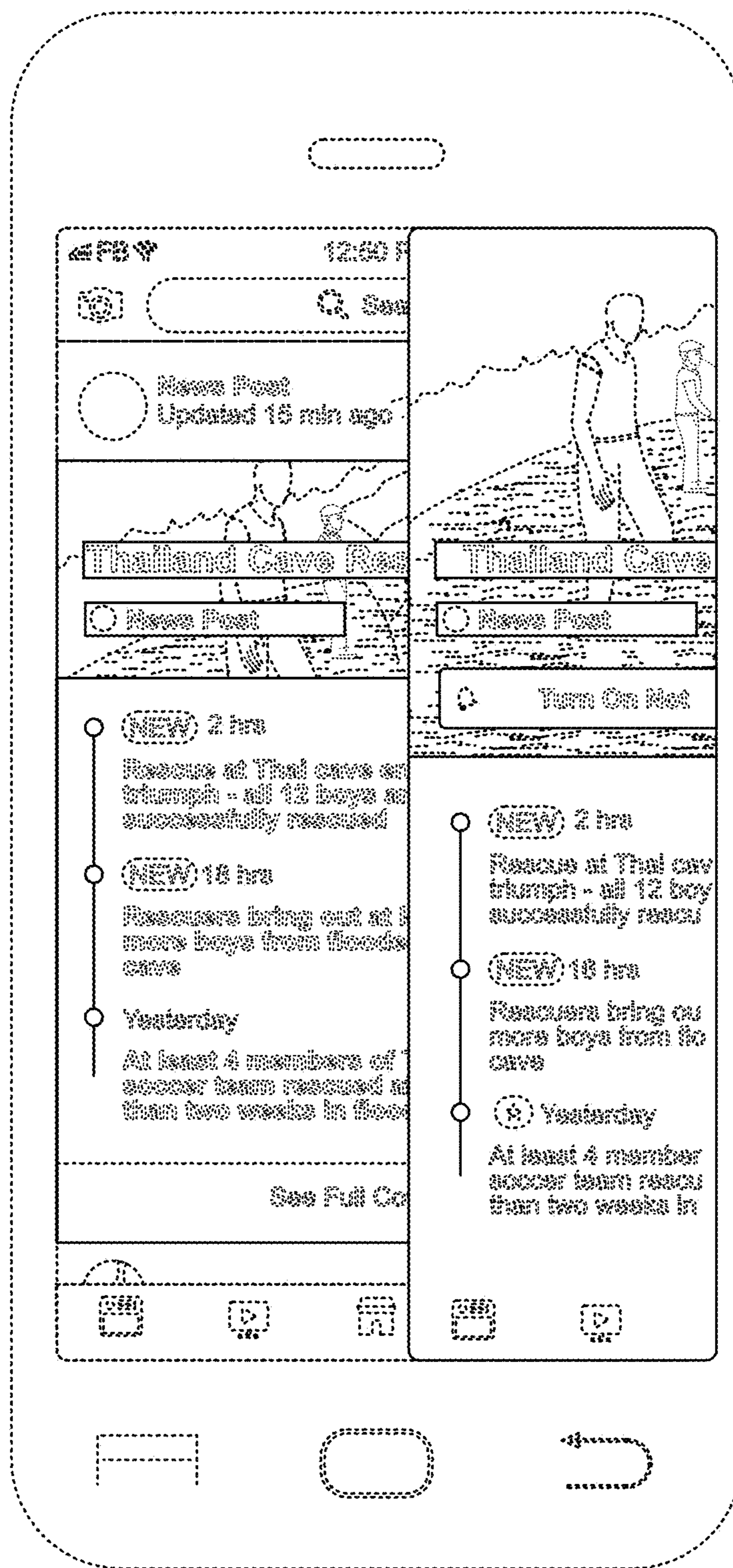

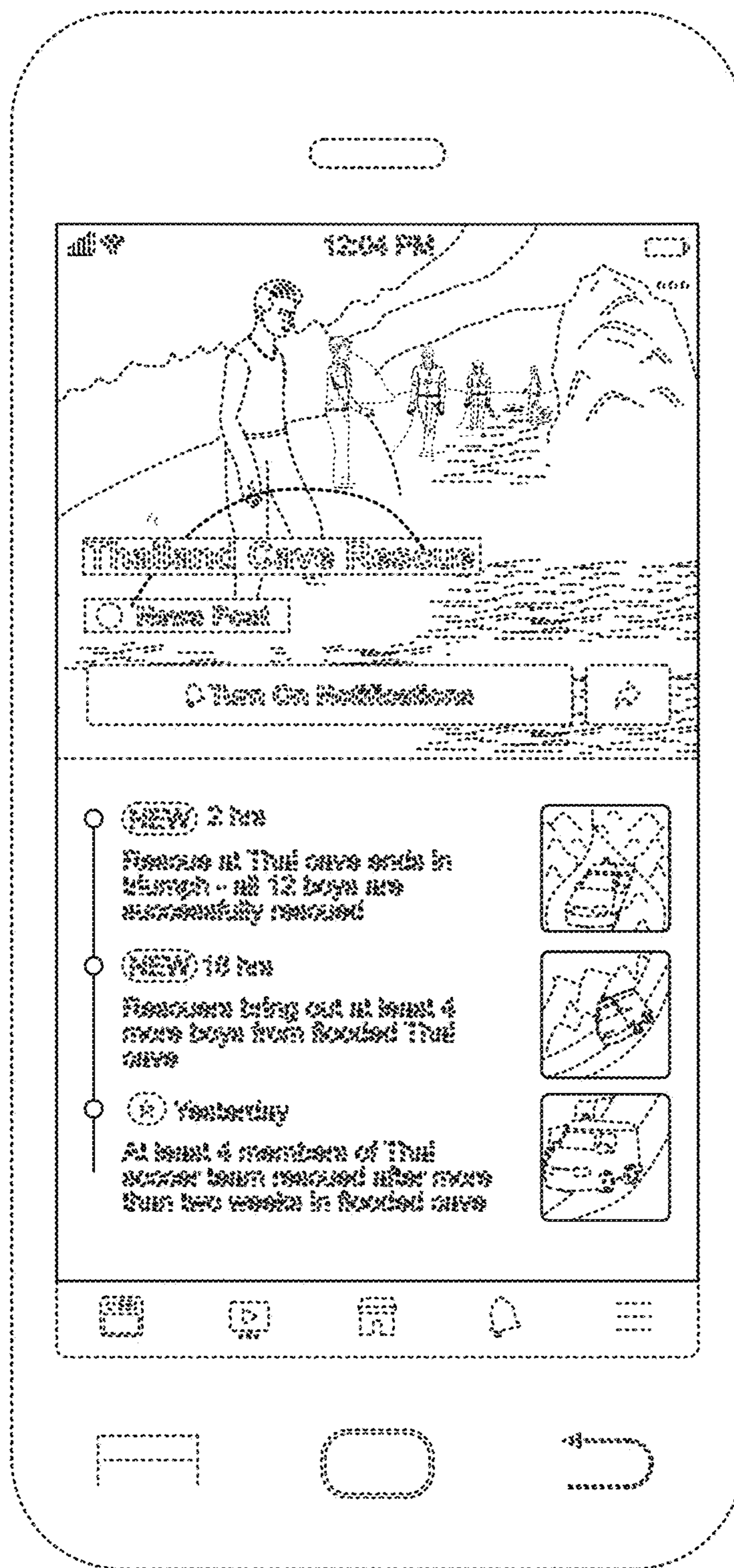
