FIG. 11 is a fourth image thereof;

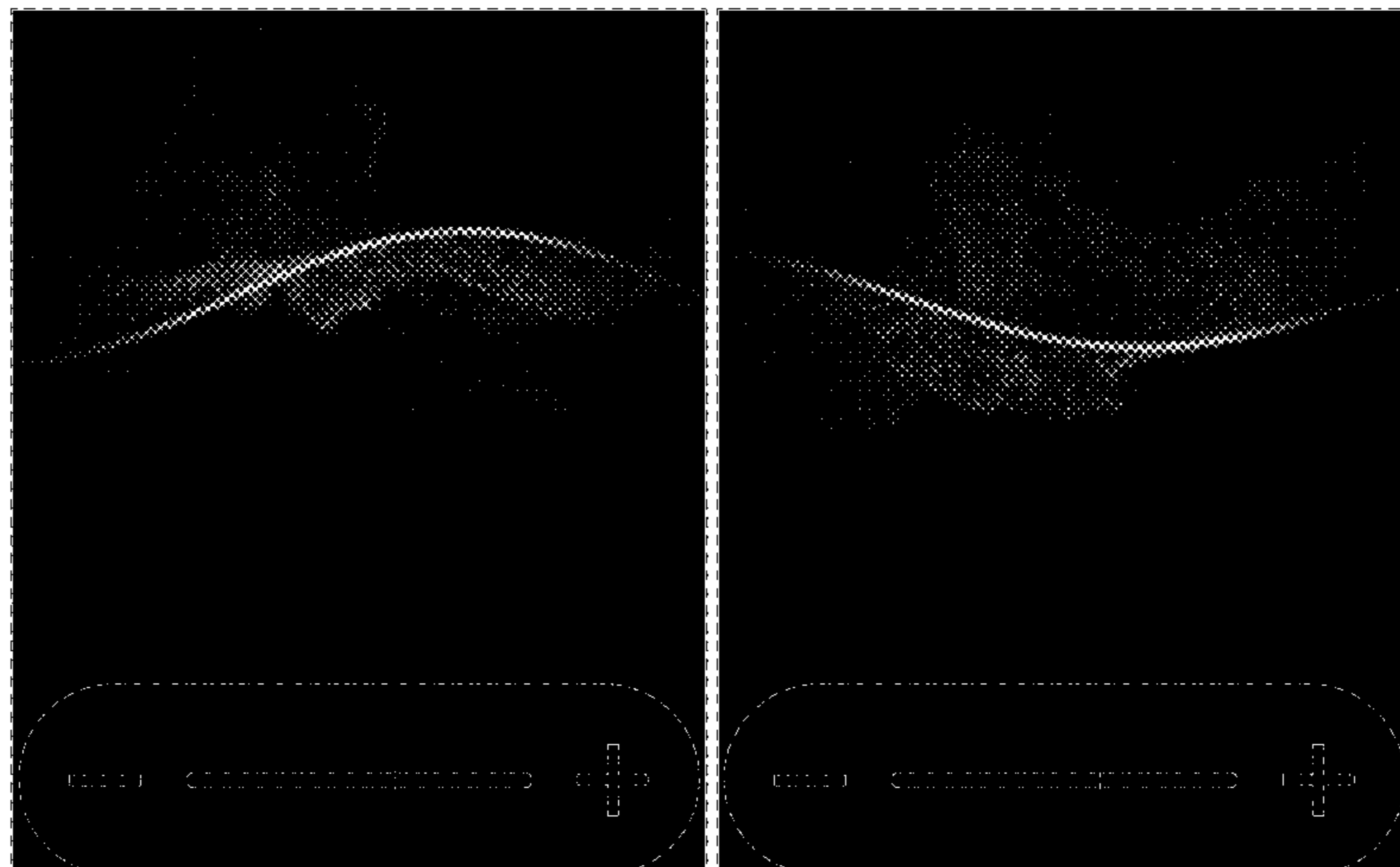

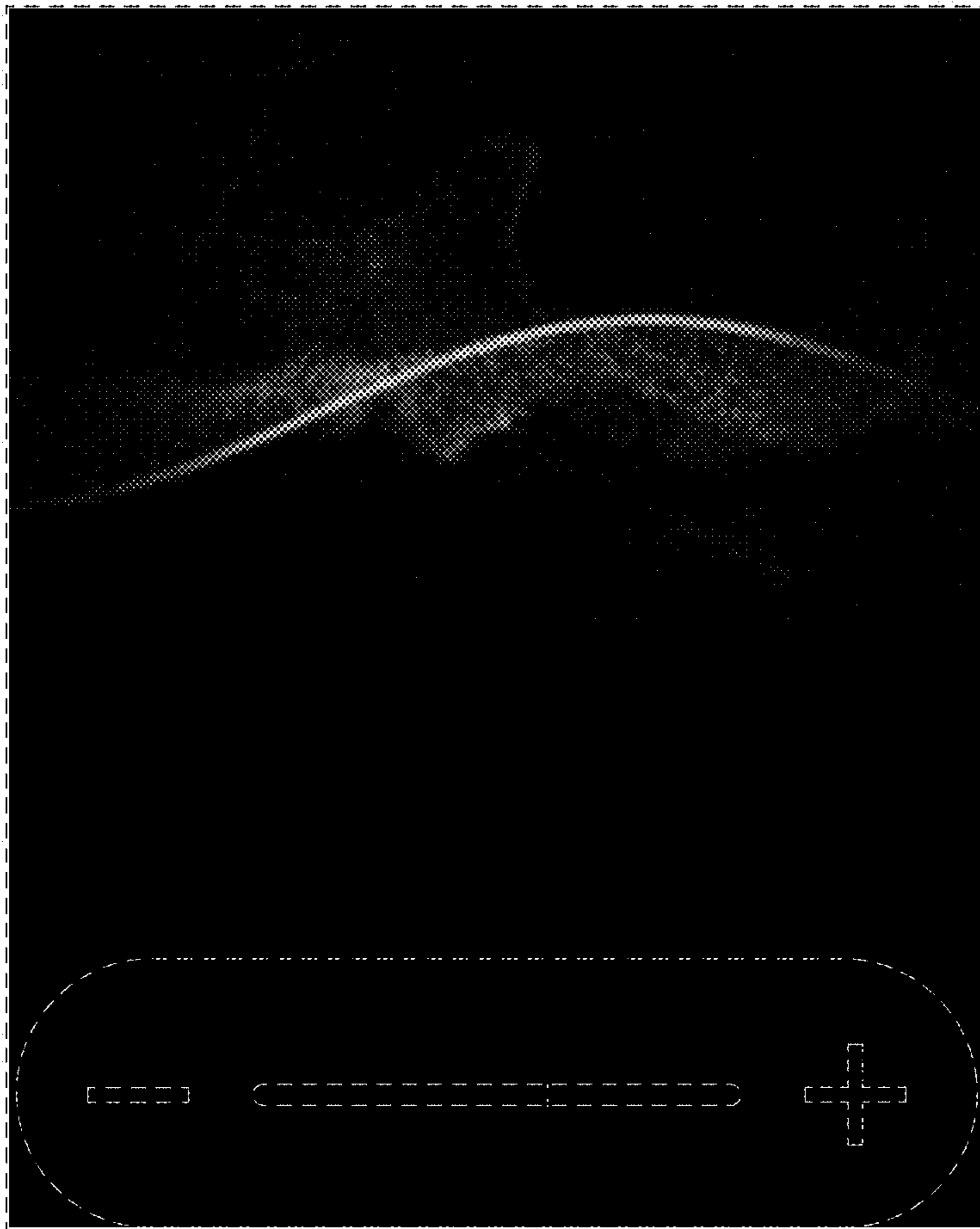

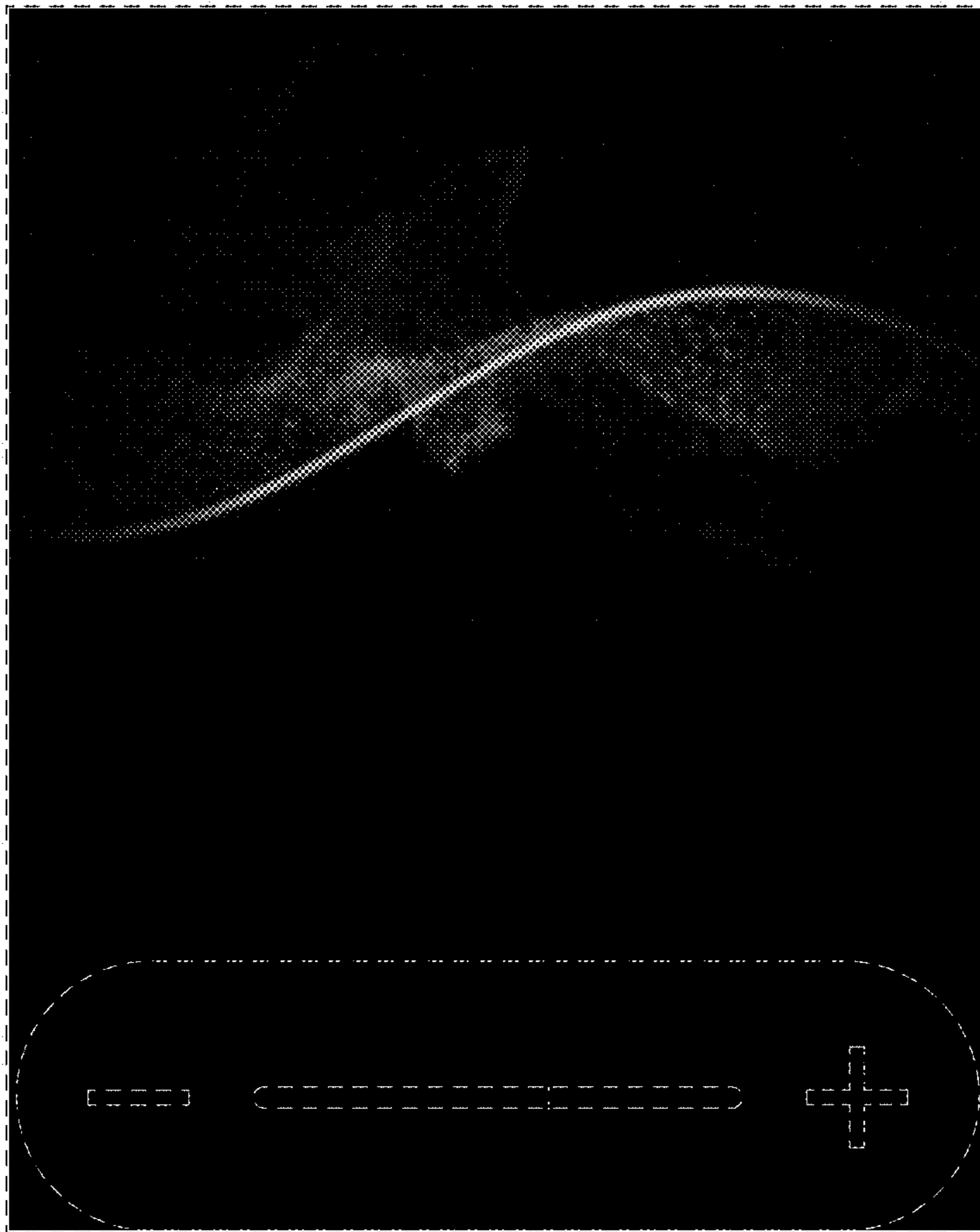

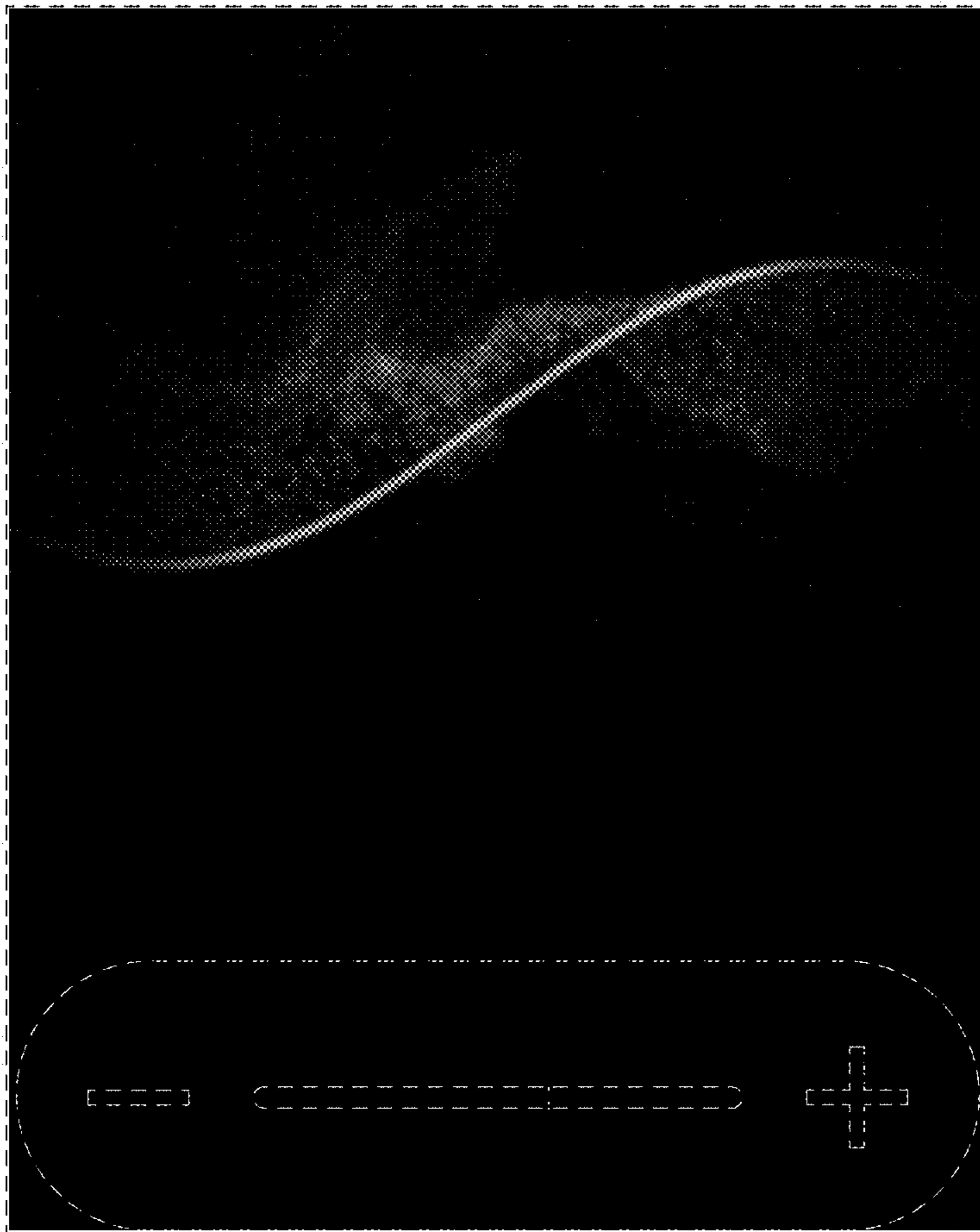

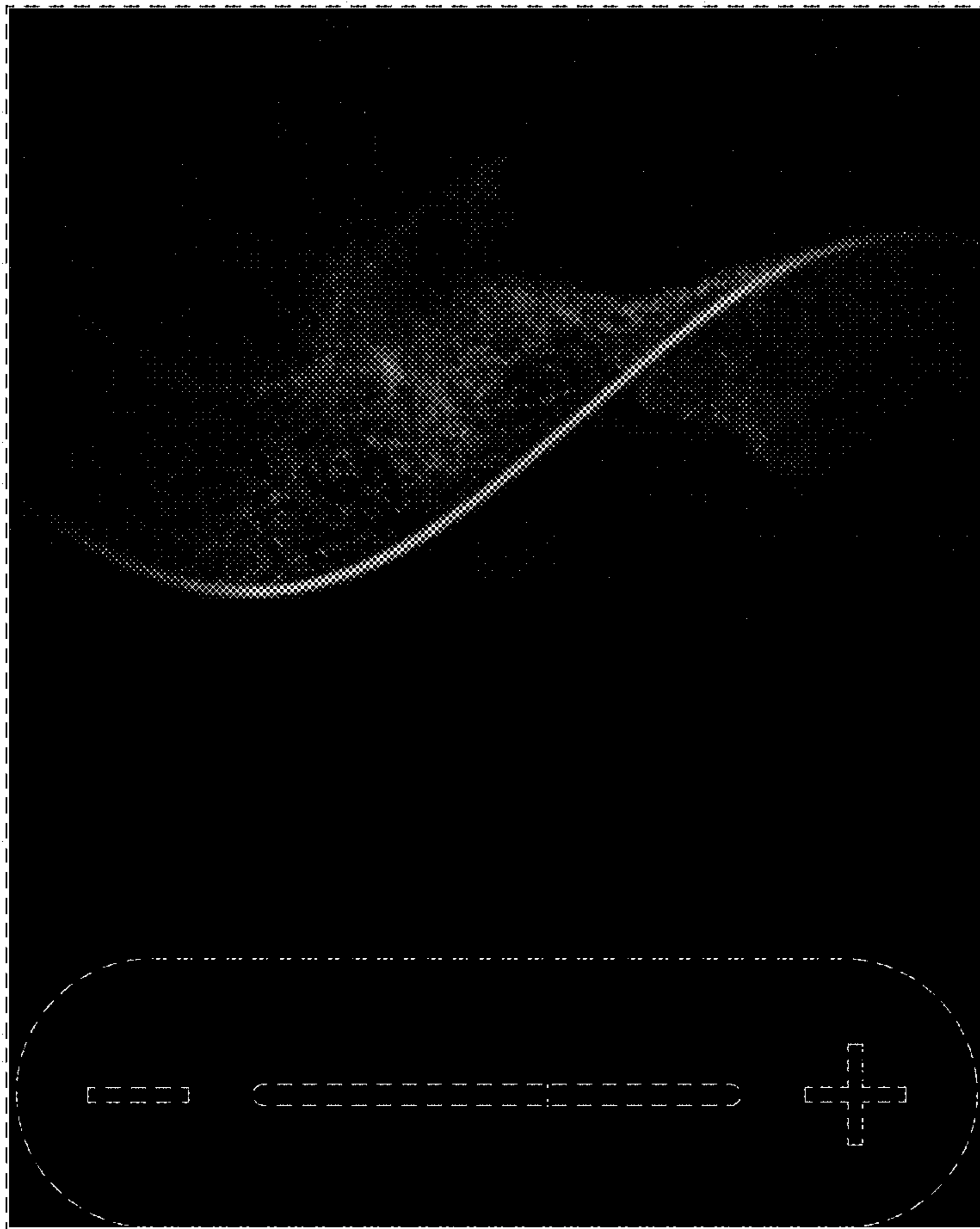

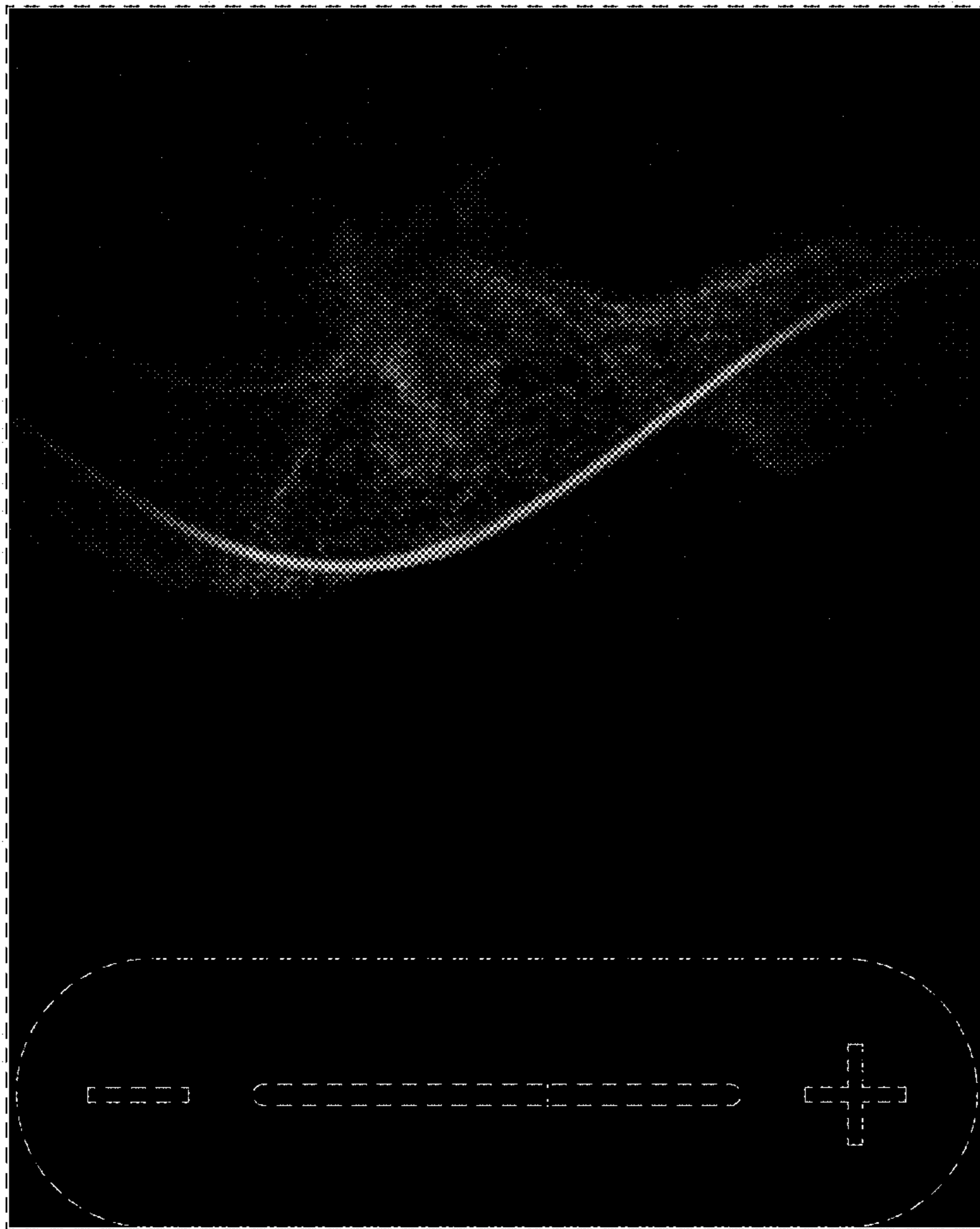

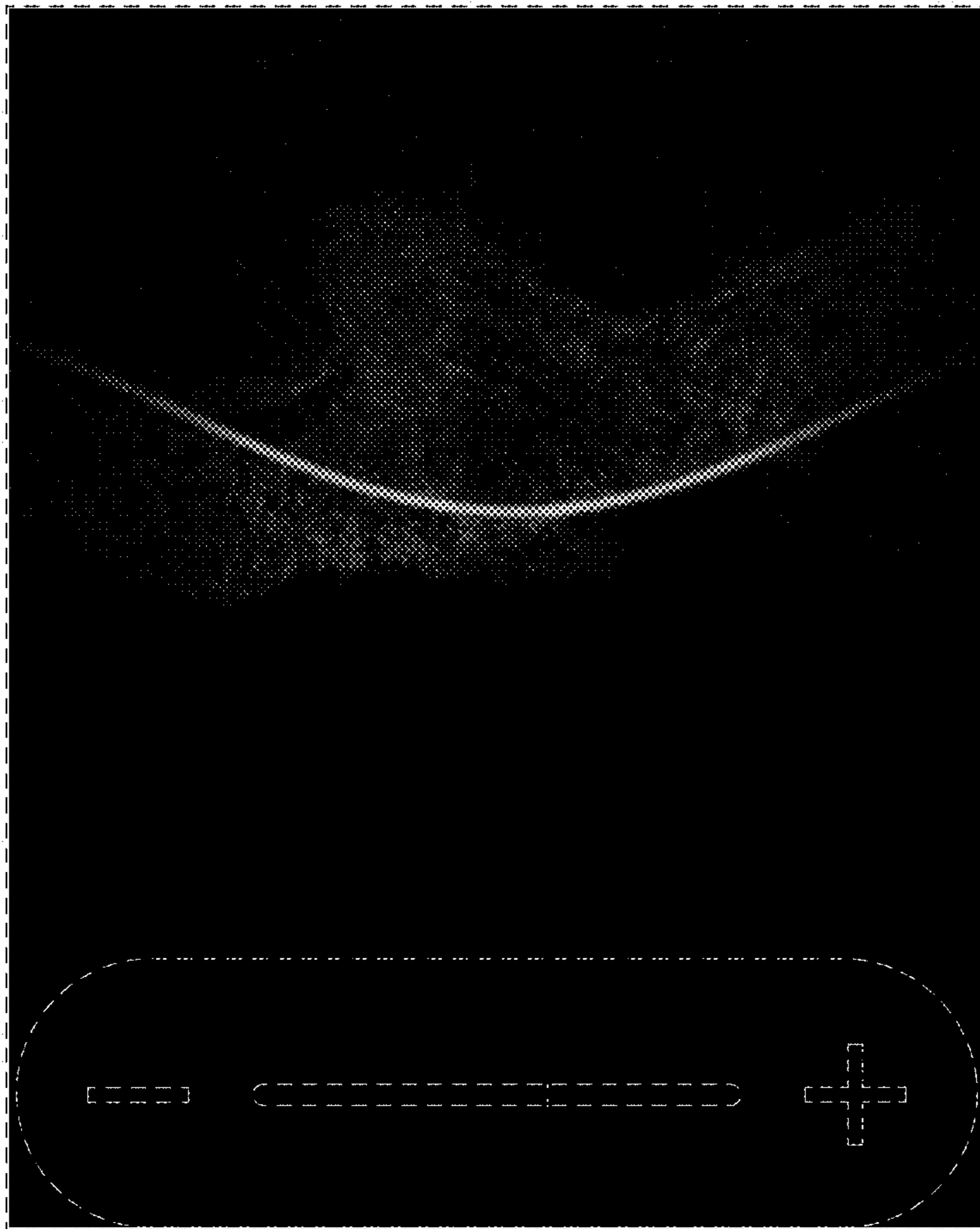

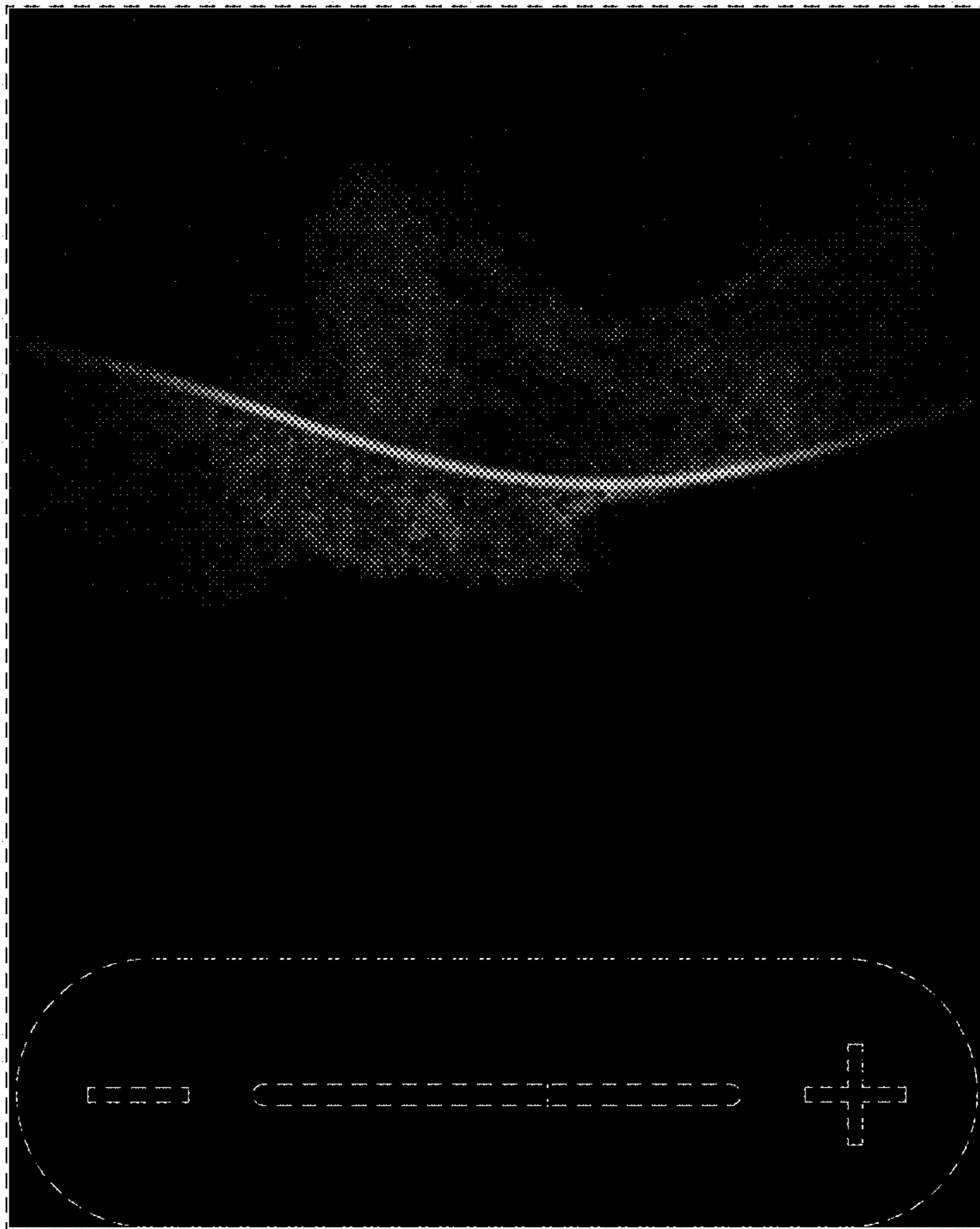

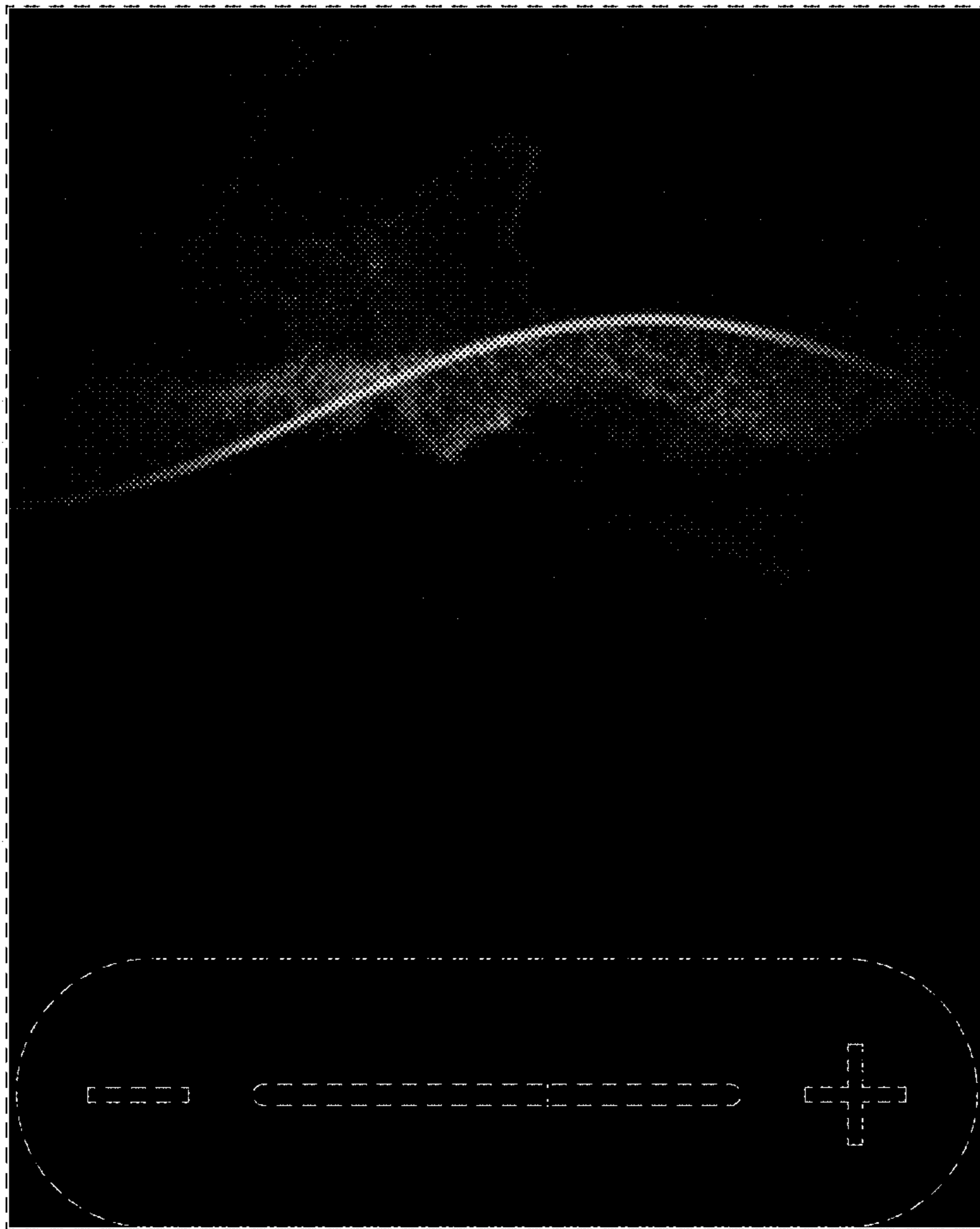

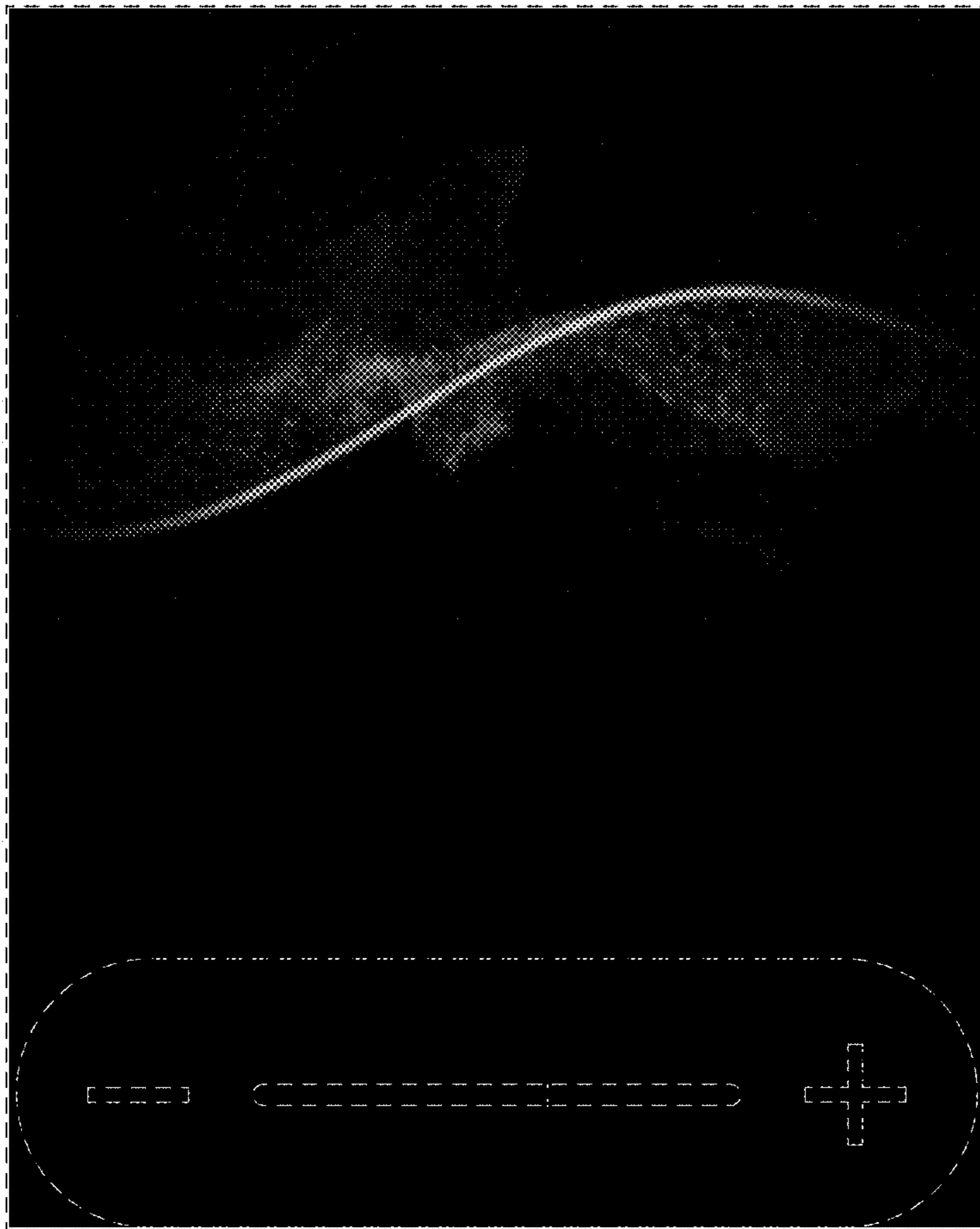

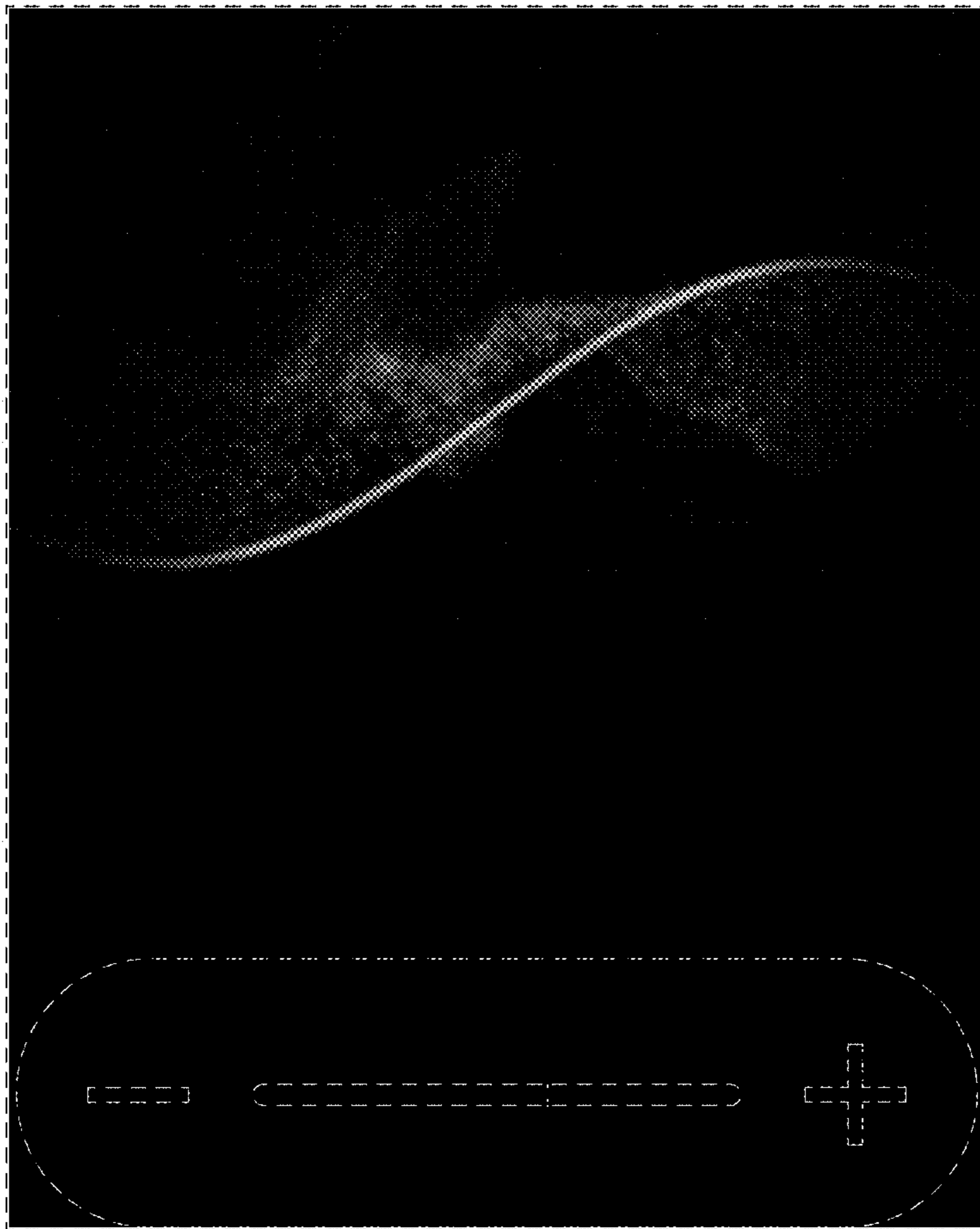

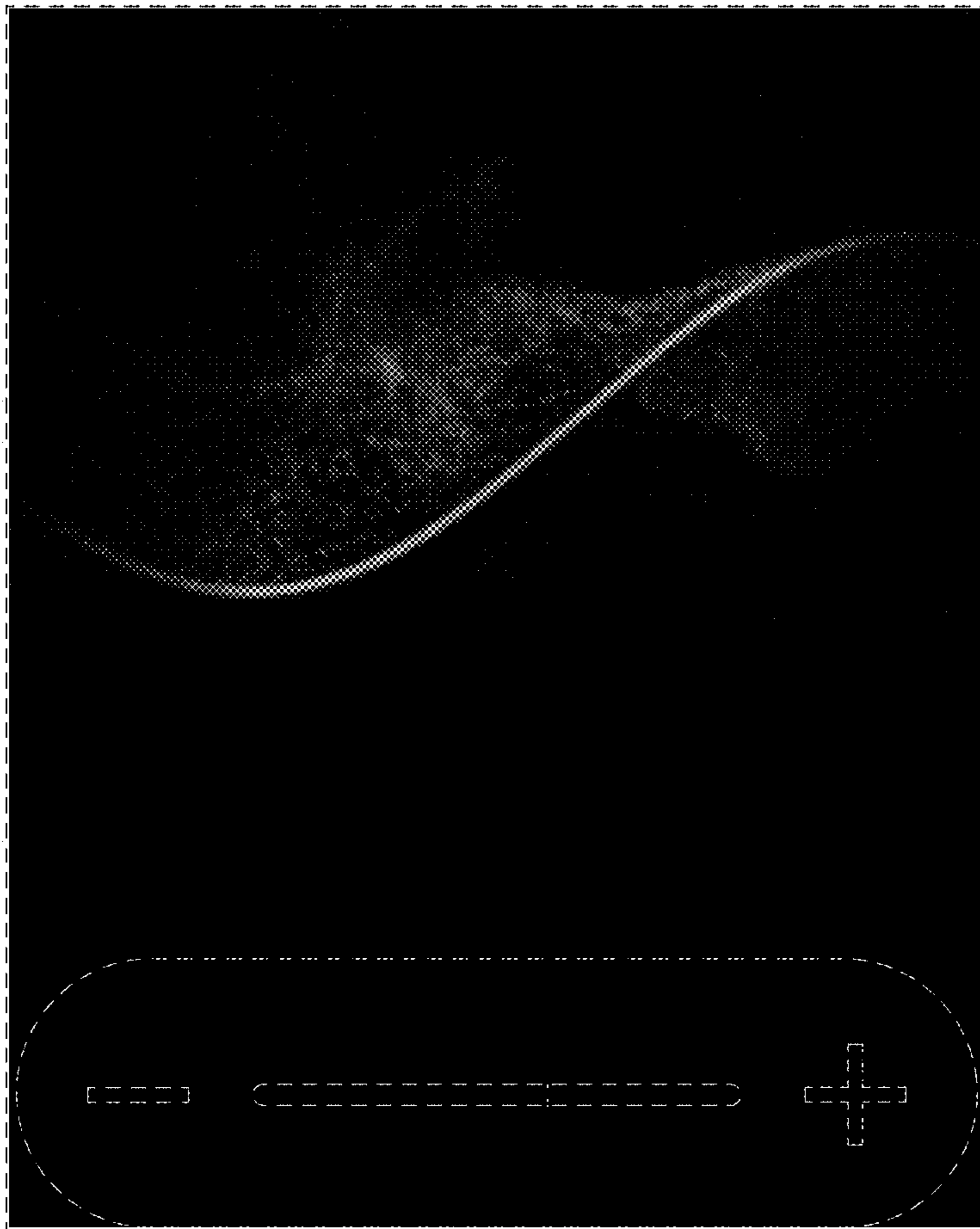

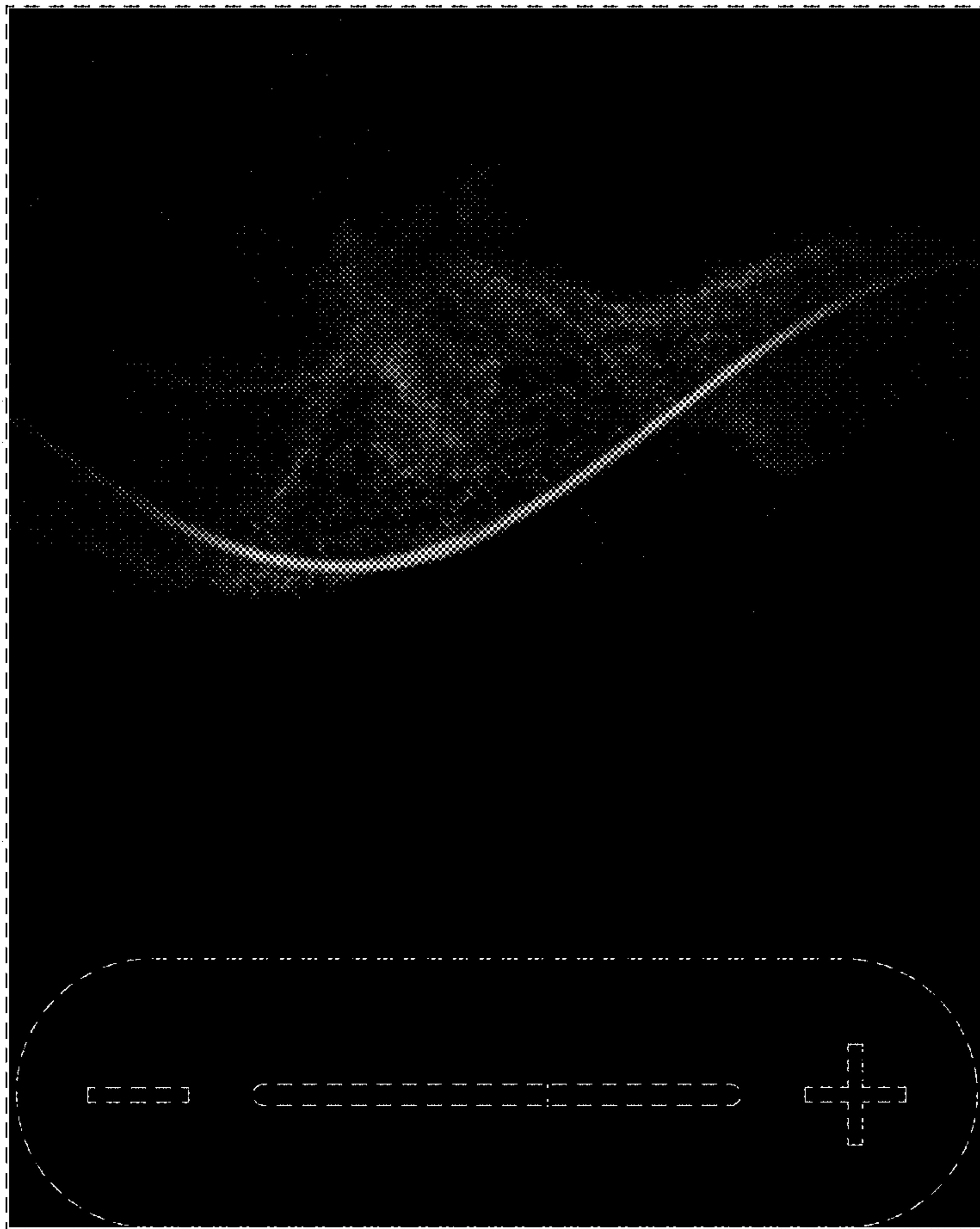

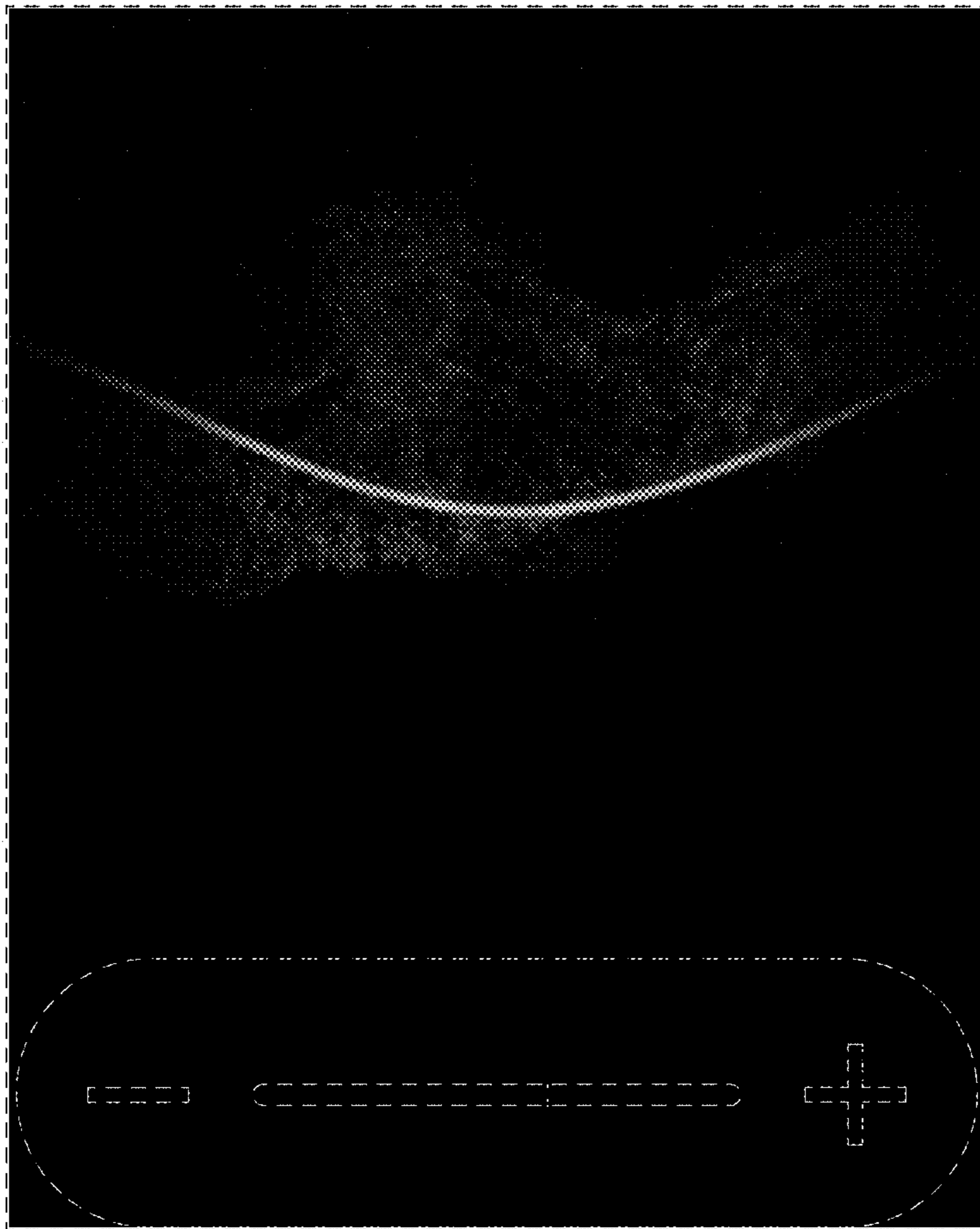

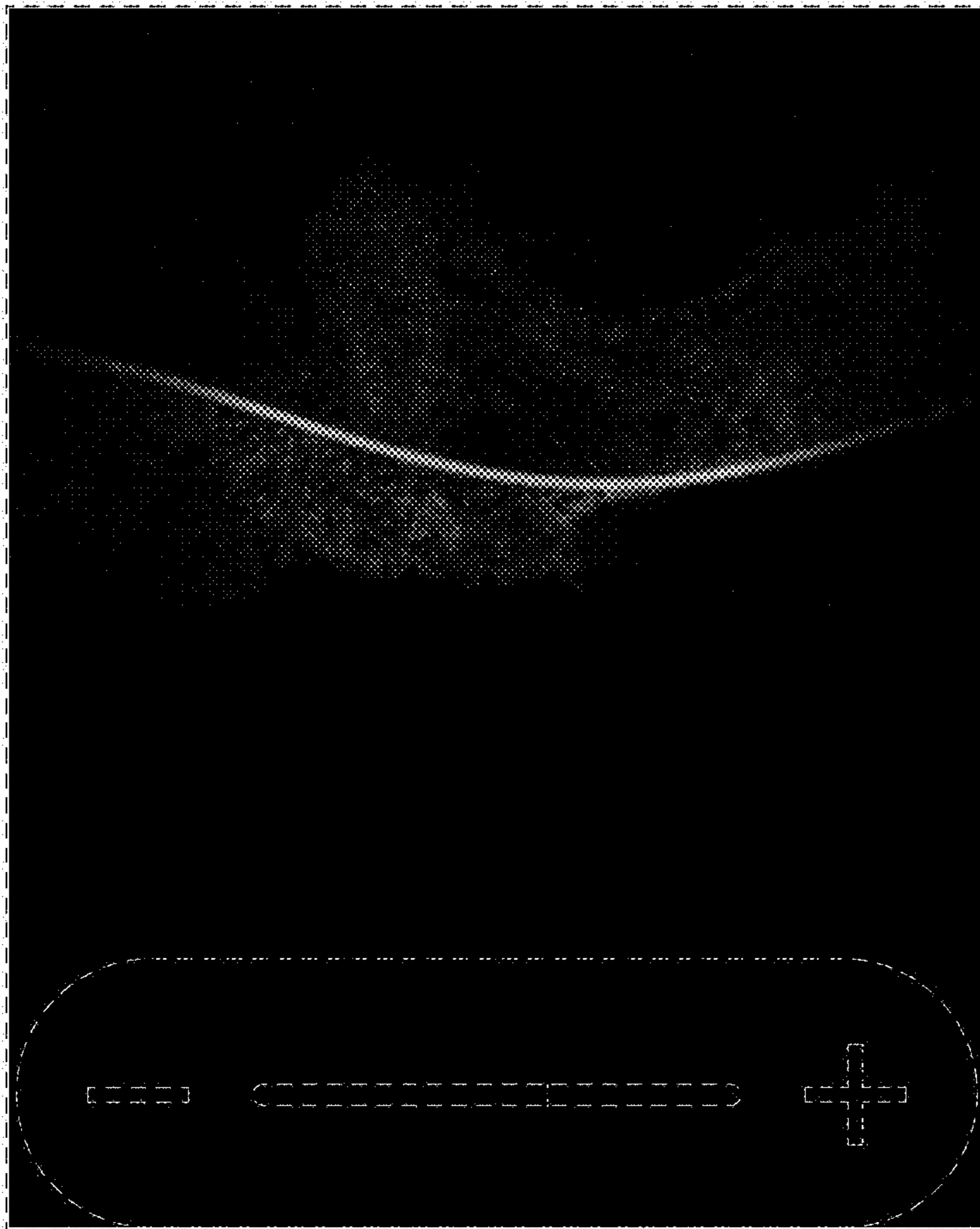
