The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

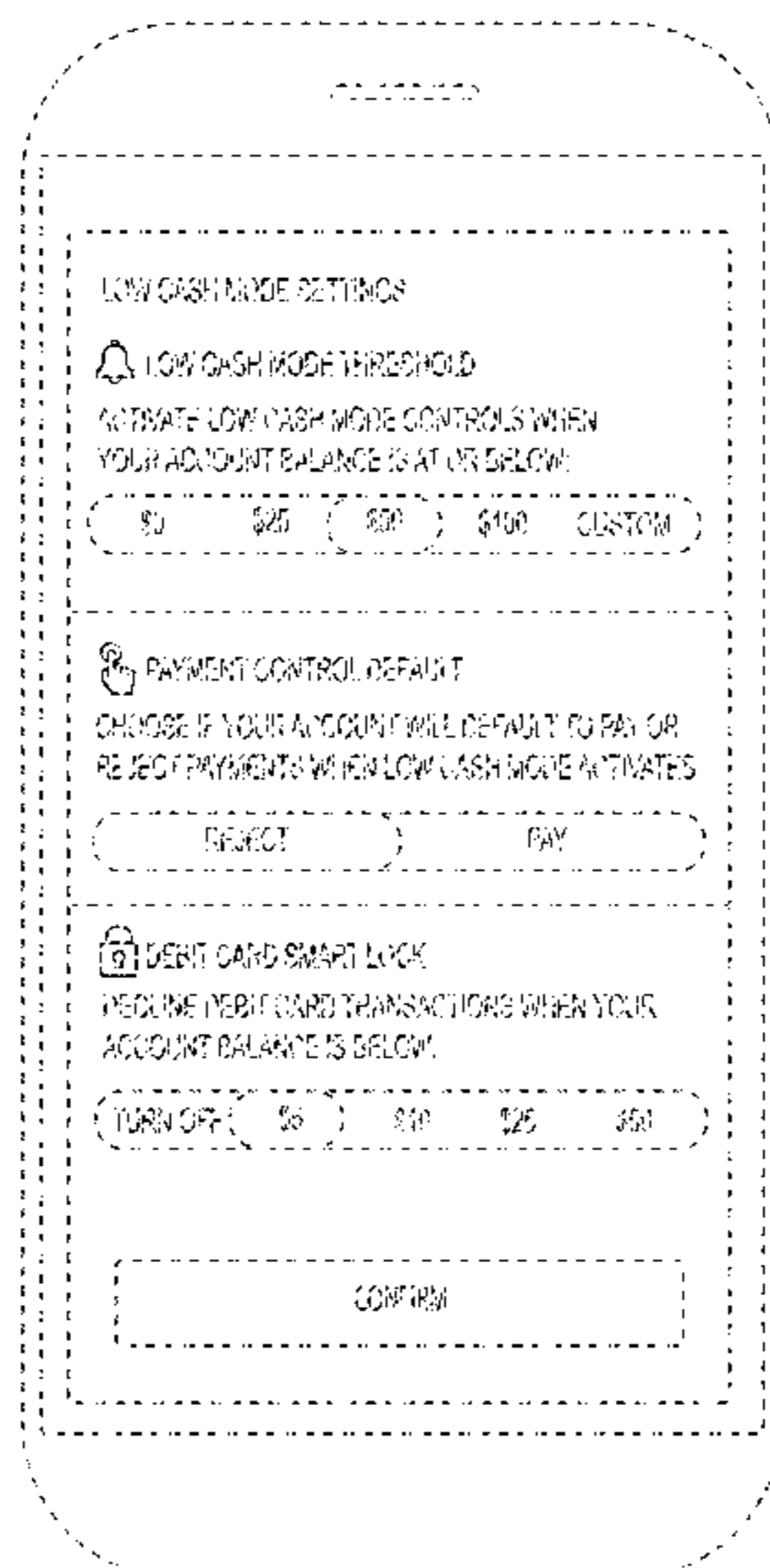
DESCRIPTION

The sole FIGURE is a front view of an electronic device with display screen with graphical user interface showing the claimed design.

The outermost sharp-cornered broken-line rectangle in the FIGURE shows the perimeter of a display screen and forms no part of the claimed design. The broken lines outside this perimeter illustrate portions of an electronic device and form no part of the claimed design.
