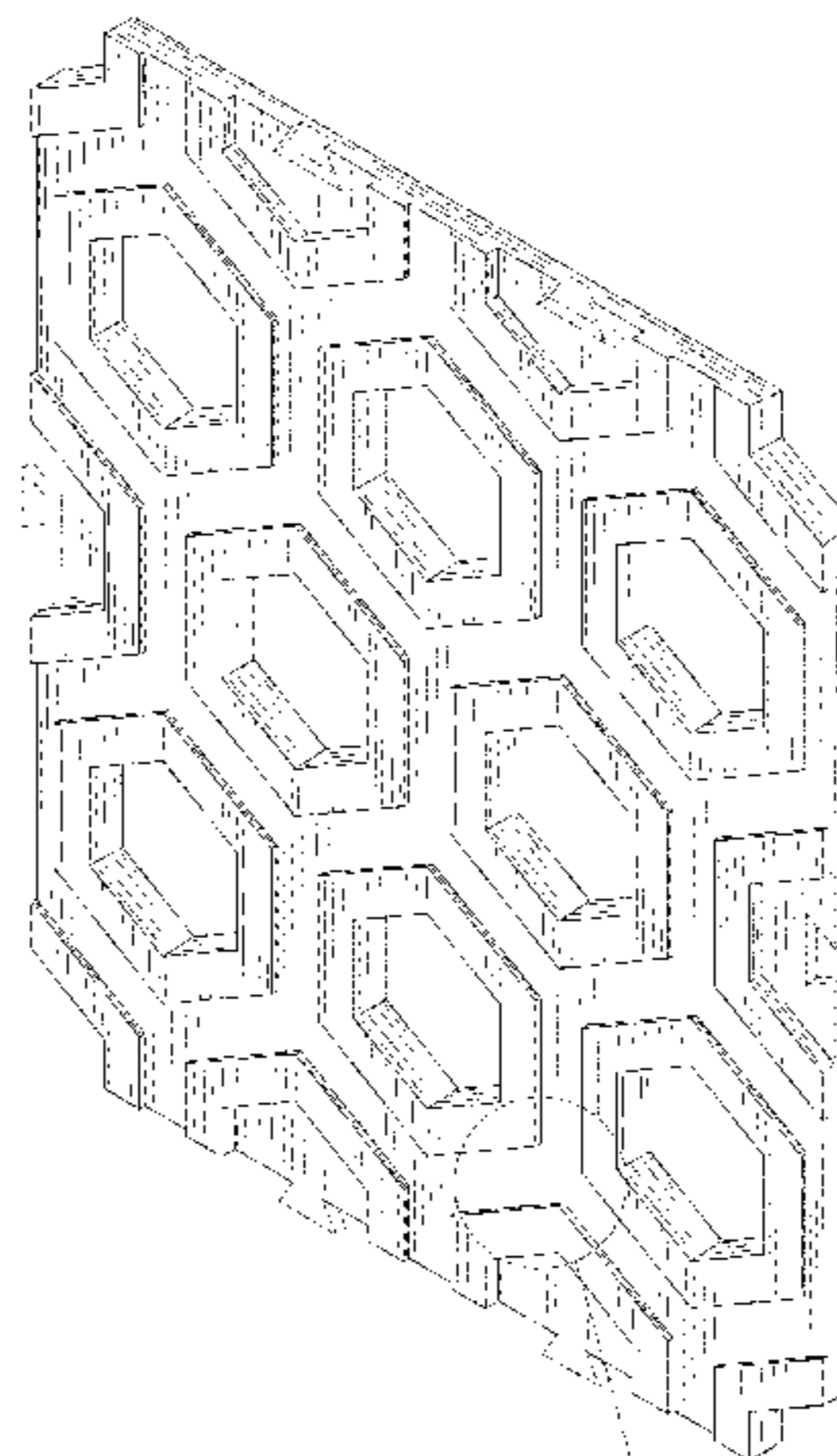
(57) **CLAIM**

The ornamental design for a game board panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a game board panel showing my new design;  
FIG. 2 is a magnified view of the plurality of crevices on the top surface of the game board panel of FIG. 1;  
FIG. 3 is a bottom perspective view thereof;  
FIG. 4 is a front view thereof, showing the plane upon which a cross-sectional view is taken and shown in FIG. 10;  
FIG. 5 is a back view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is a left view thereof;  
FIG. 9 is a right view thereof; and,  
FIG. 10 is a horizontal cross-sectional view thereof taken along line 10-10 of FIG. 4.  
The broken lines showing of recessions and protrusions in FIG. 1, FIG. 3-10 are included for the purpose of showing environmental structure and form no part of the claimed design.

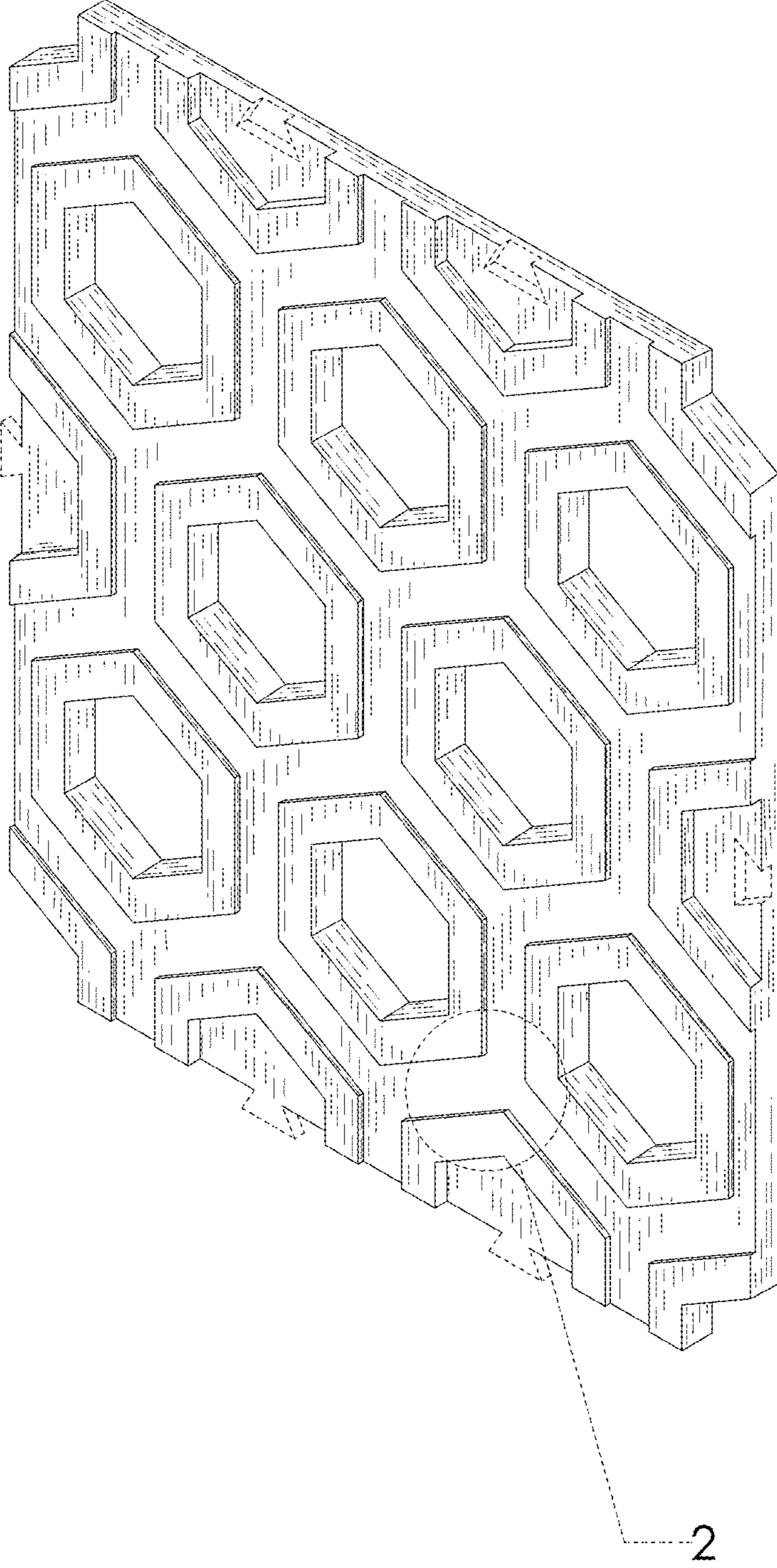

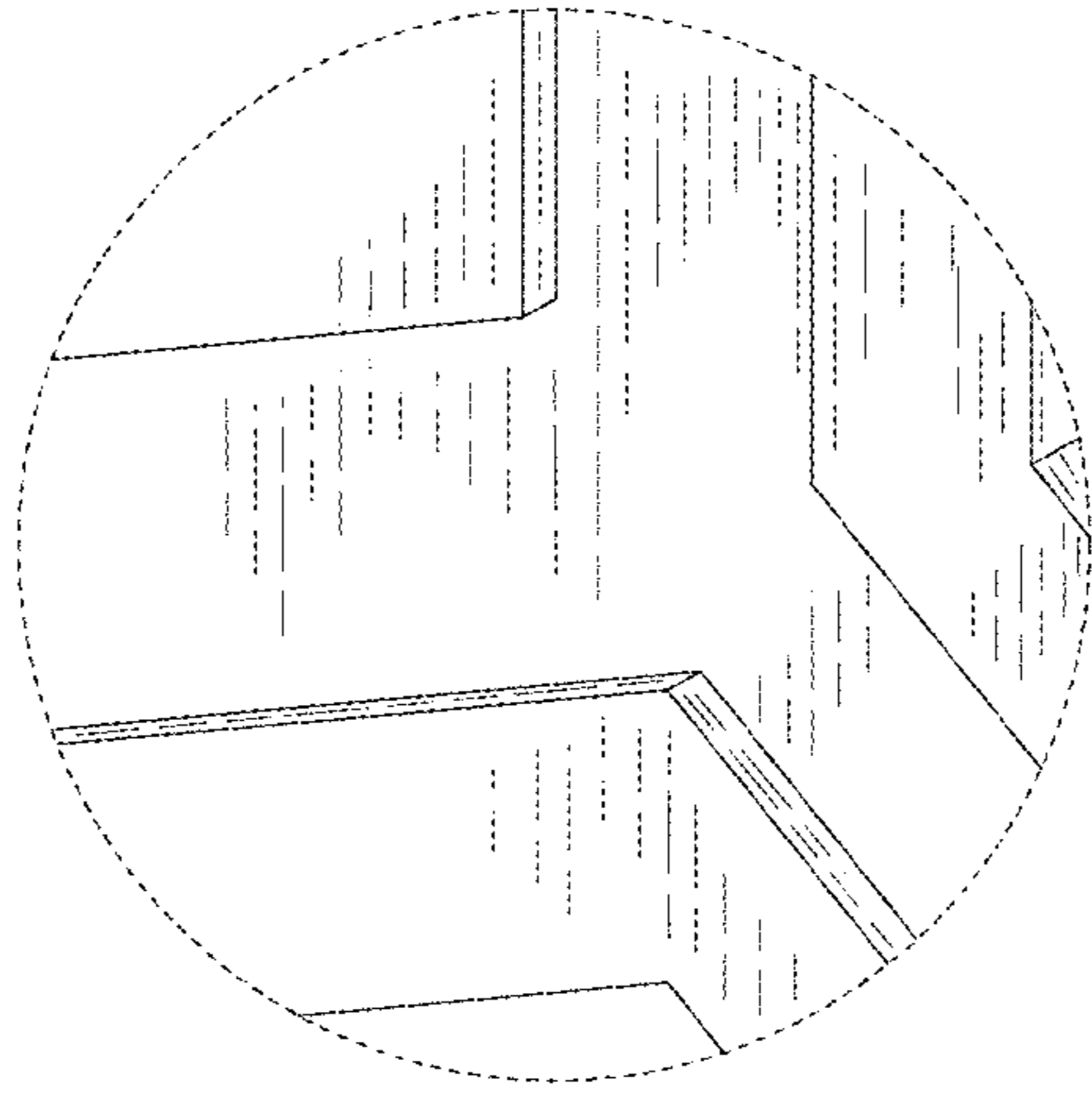

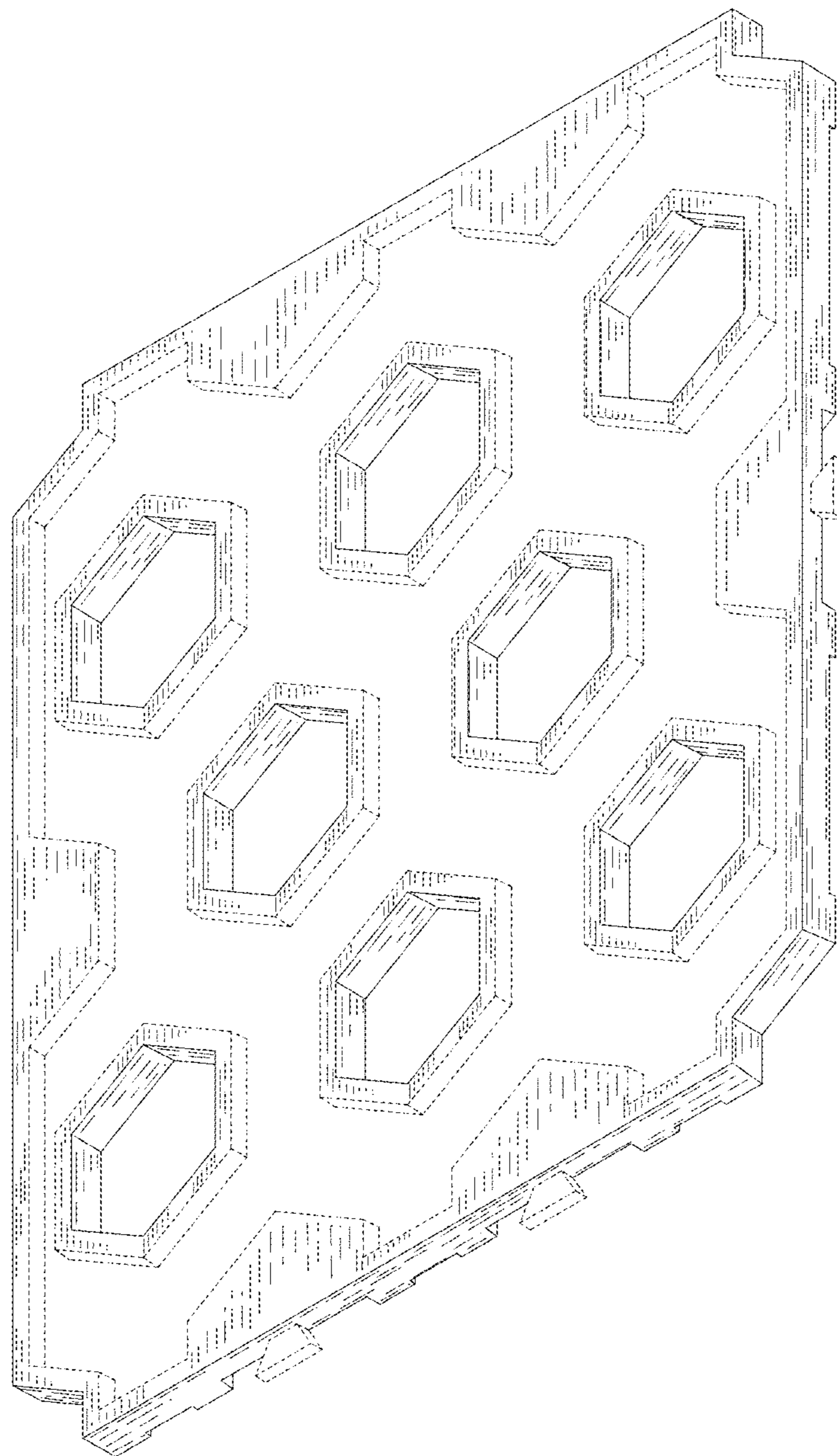

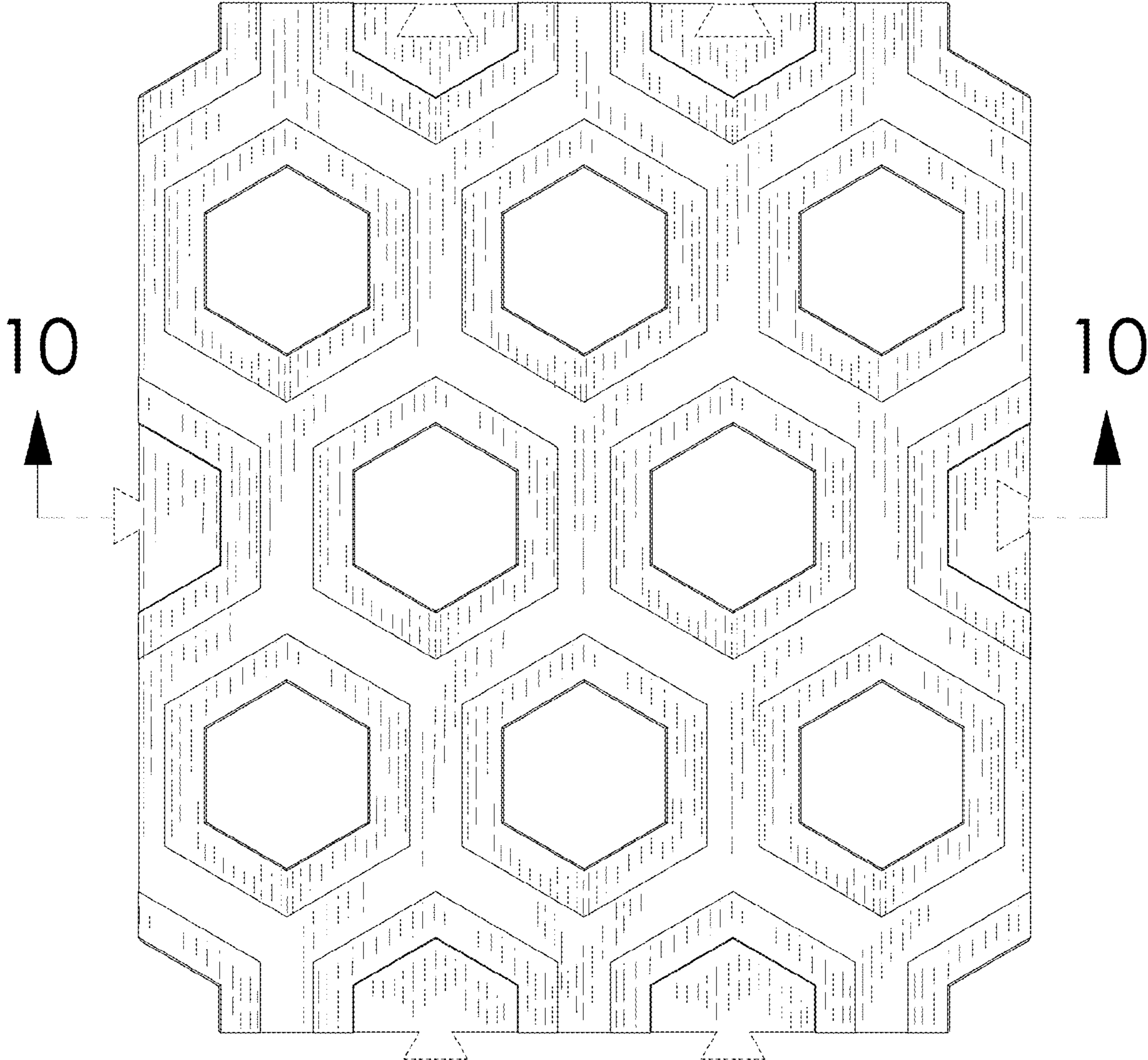

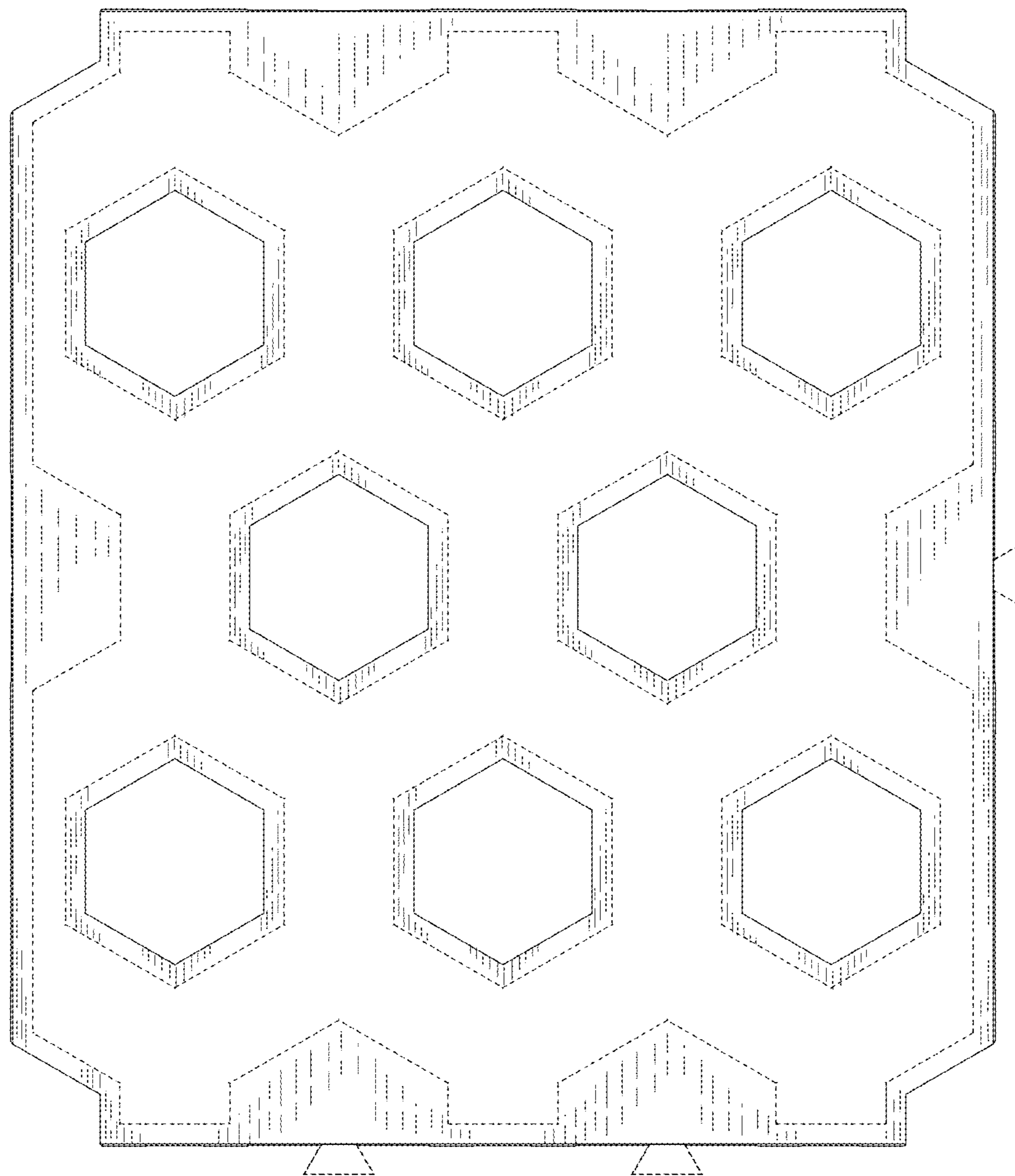

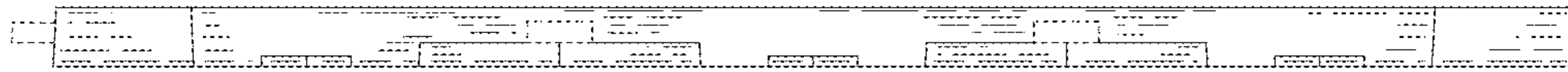

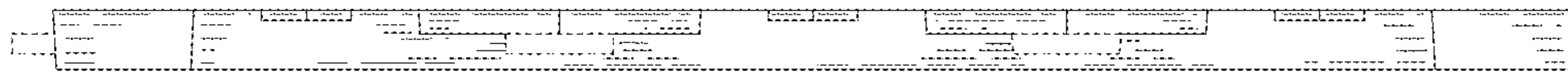

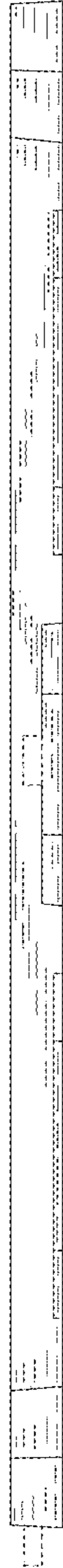

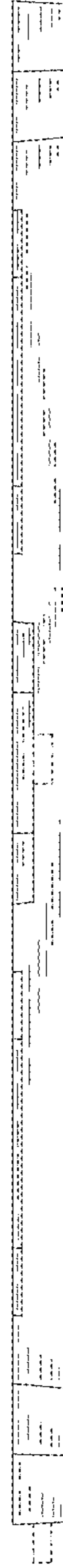

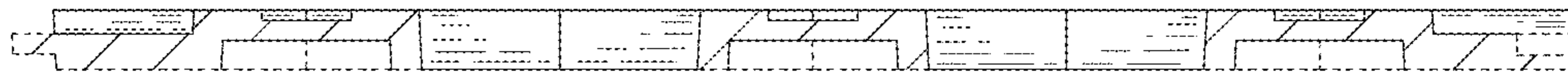
