FIG. 1 is a perspective game ball according to the present application.

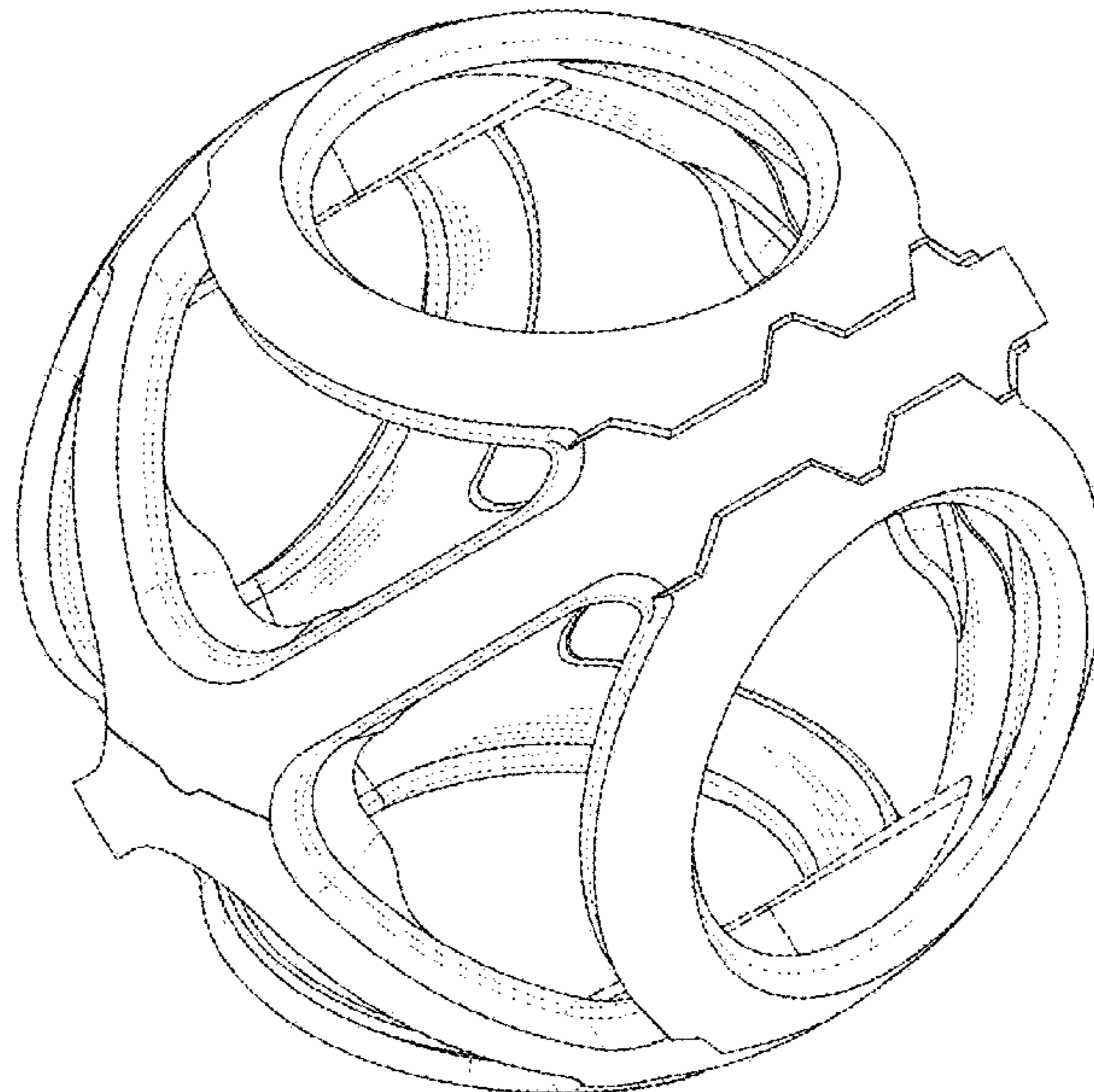
FIG. 2 is a front view of the game ball.

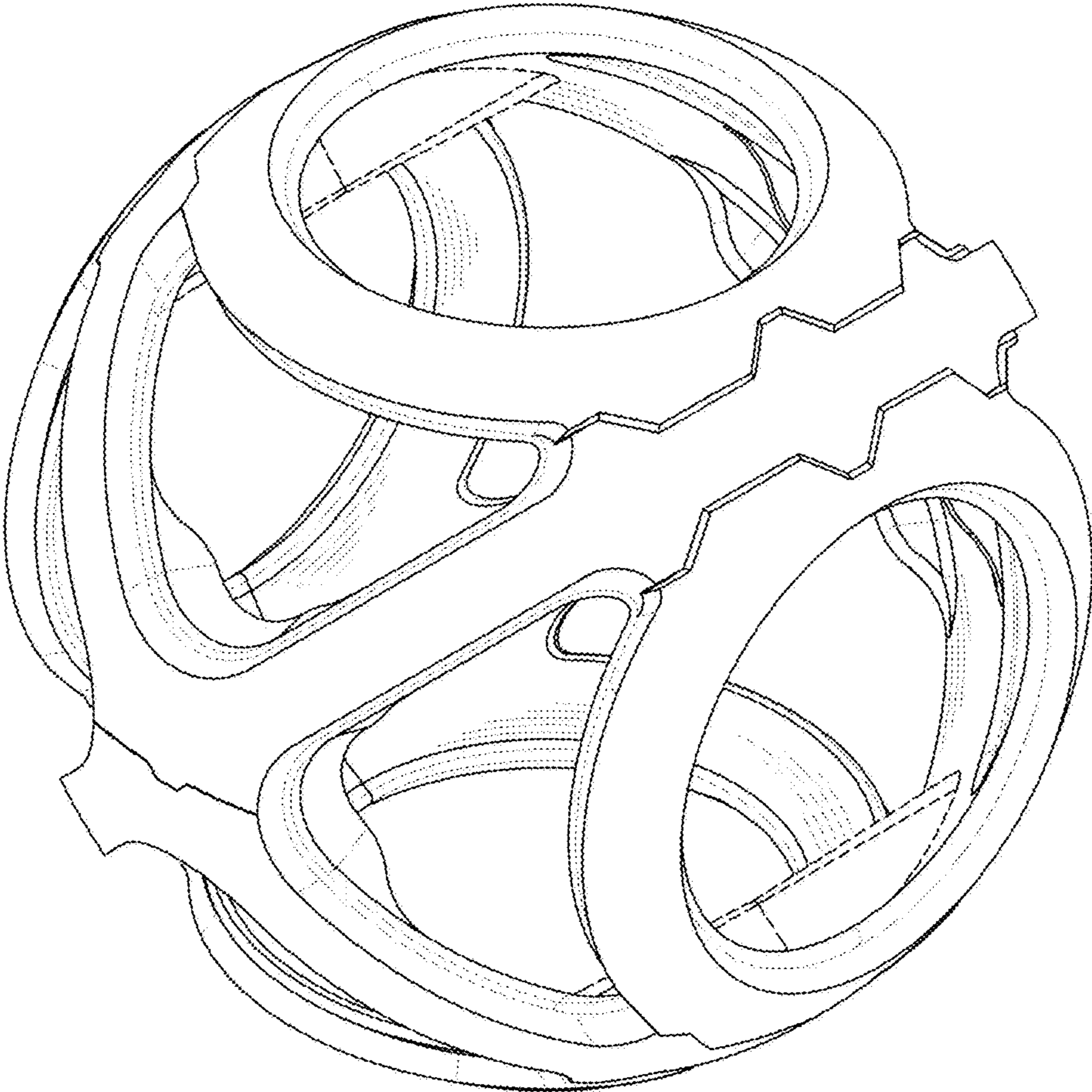

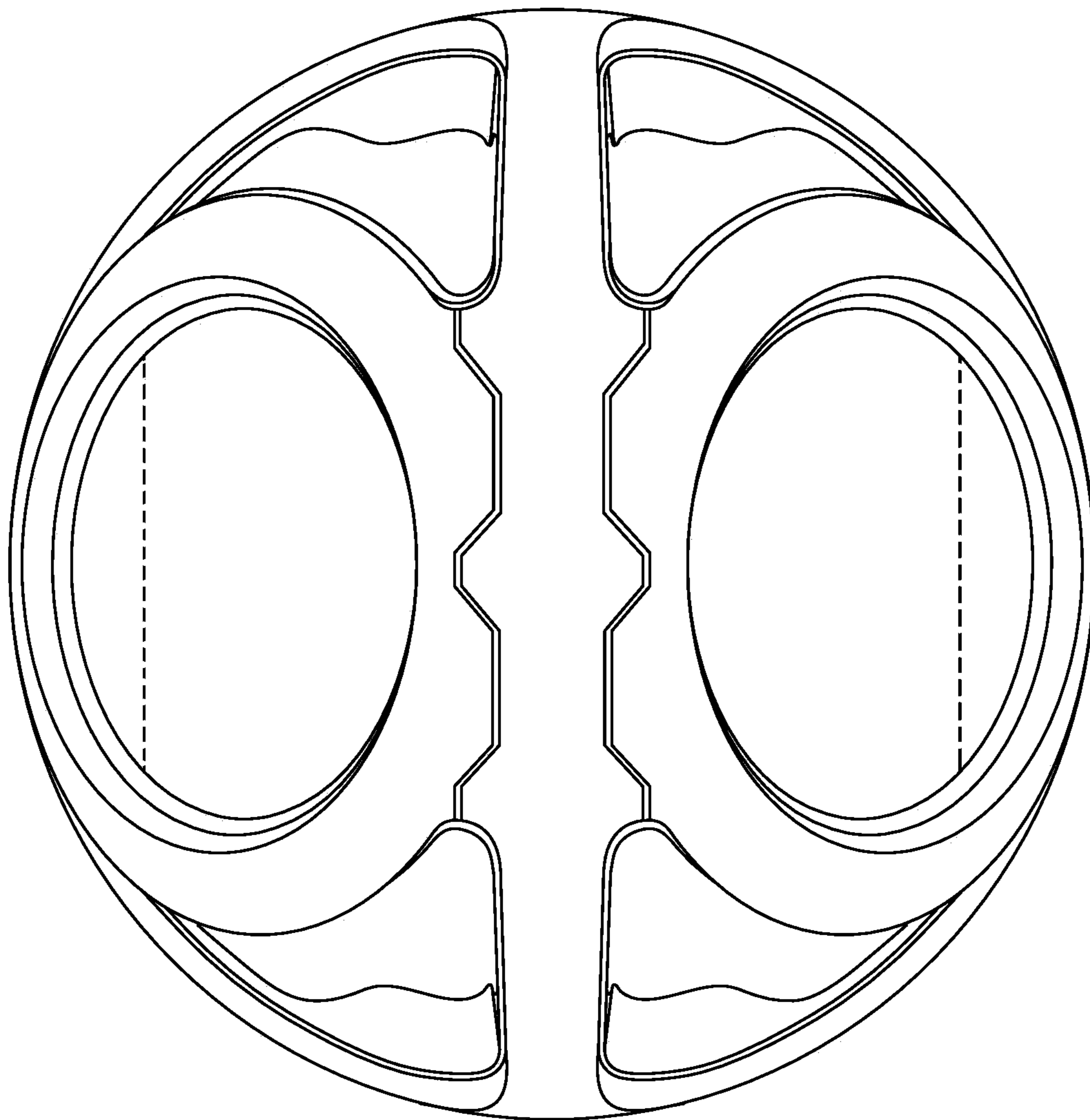

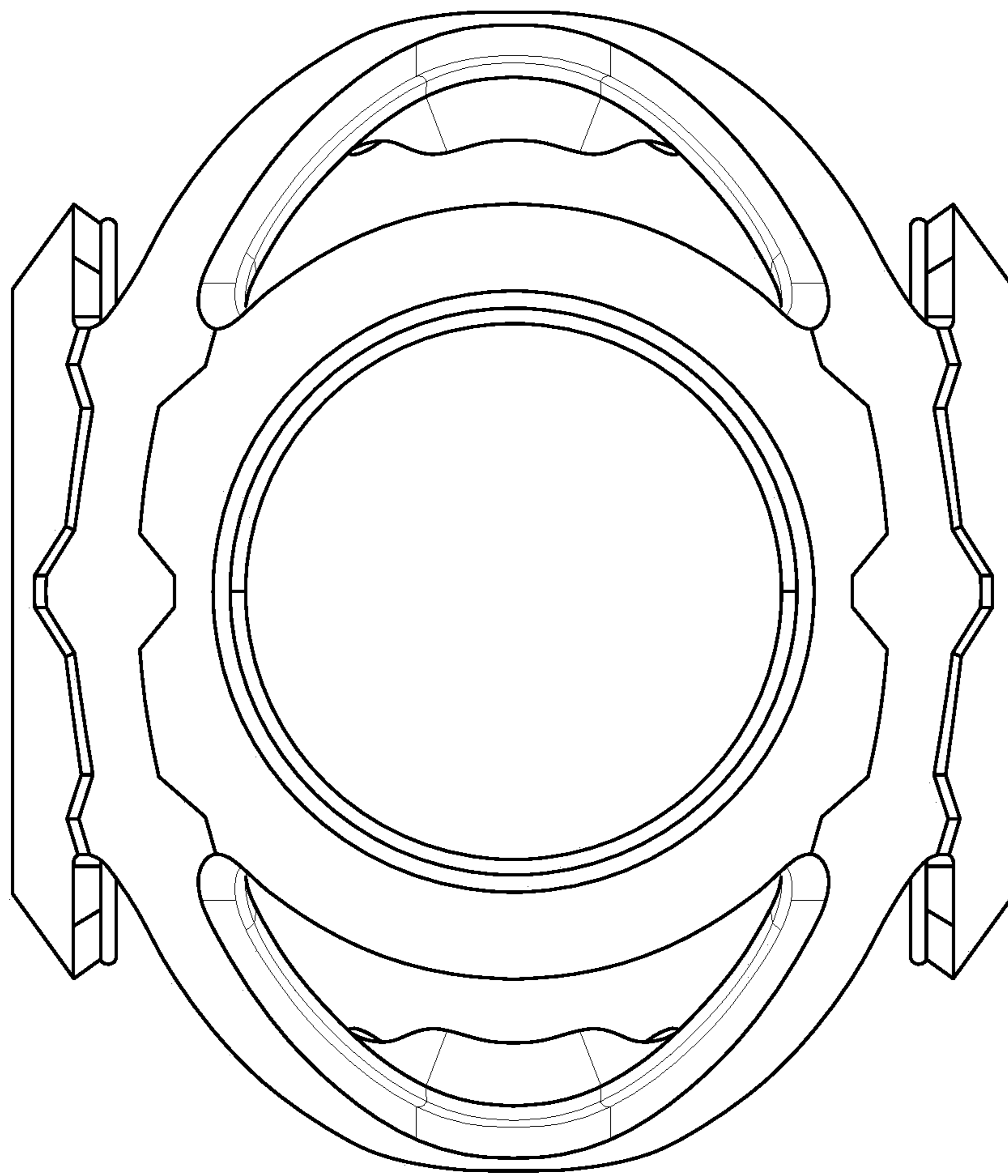

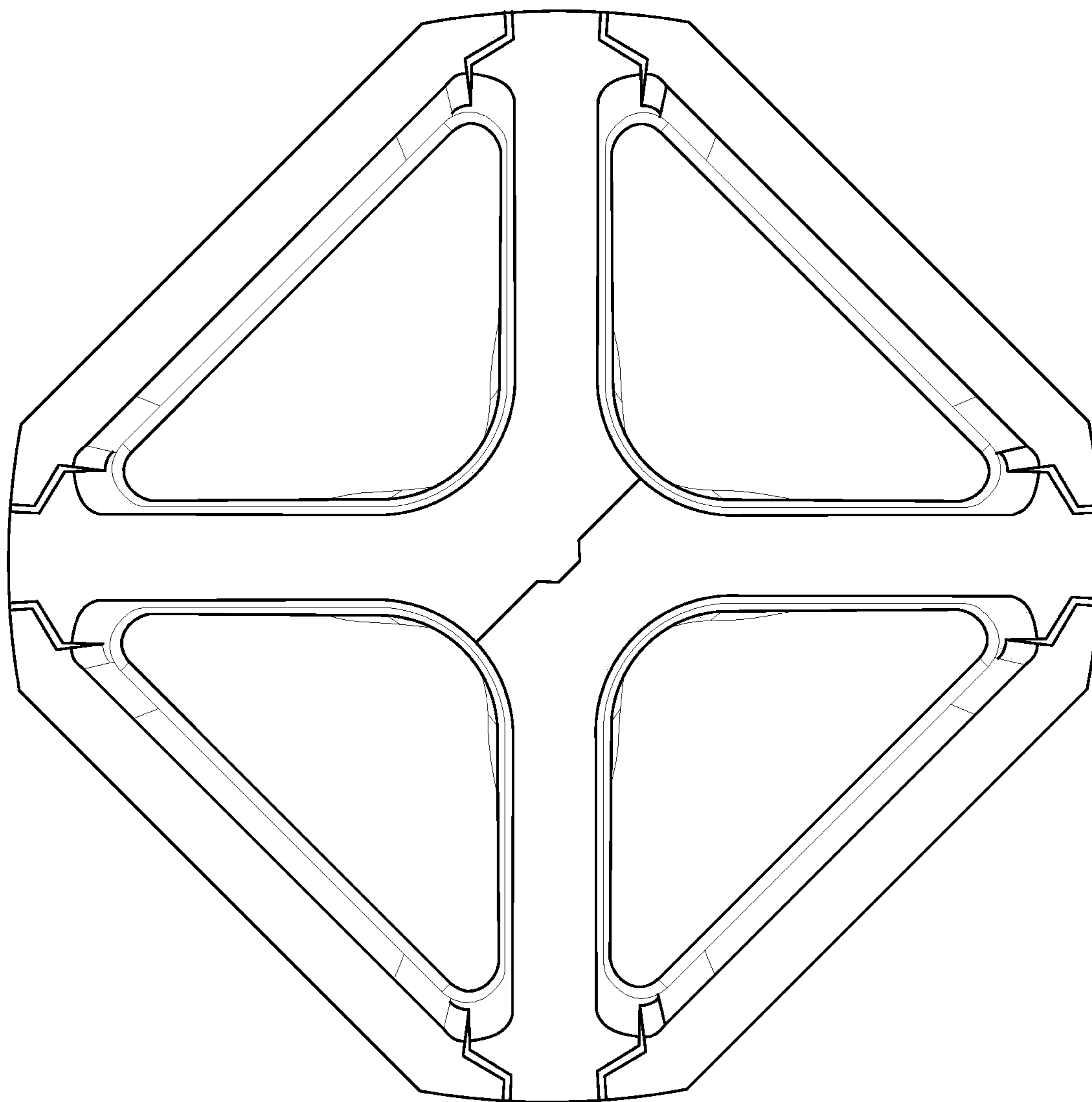
