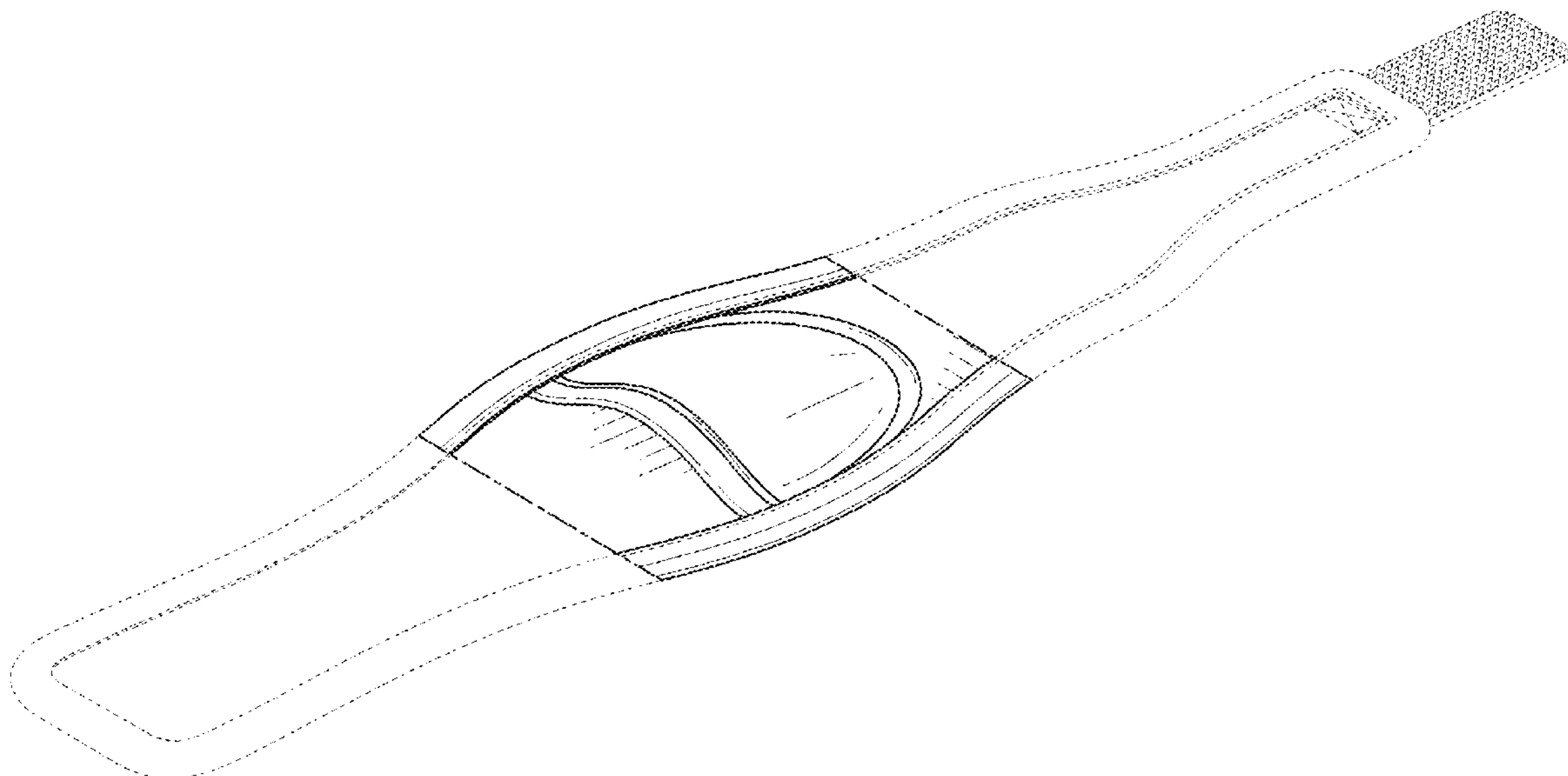
(57) **CLAIM**

The ornamental design for a foot arch support wrap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a foot arch support wrap; FIG. 2 is a front view of a foot arch support wrap; FIG. 3 is a back view of a foot arch support wrap; FIG. 4 is a top view of a foot arch support wrap; FIG. 5 is a bottom view of a foot arch support wrap; FIG. 6 is a right side view of a foot arch support wrap; and, FIG. 7 is a left side view of a foot arch support wrap. The broken lines in the drawings, including those shown on the majority of the back of the foot arch support wrap in FIG. 3, are for the purpose of illustrating portions of the article that form no part of the claimed design. Further, the dash-dot-dash lines represent boundaries of the claimed design that form no part thereof.

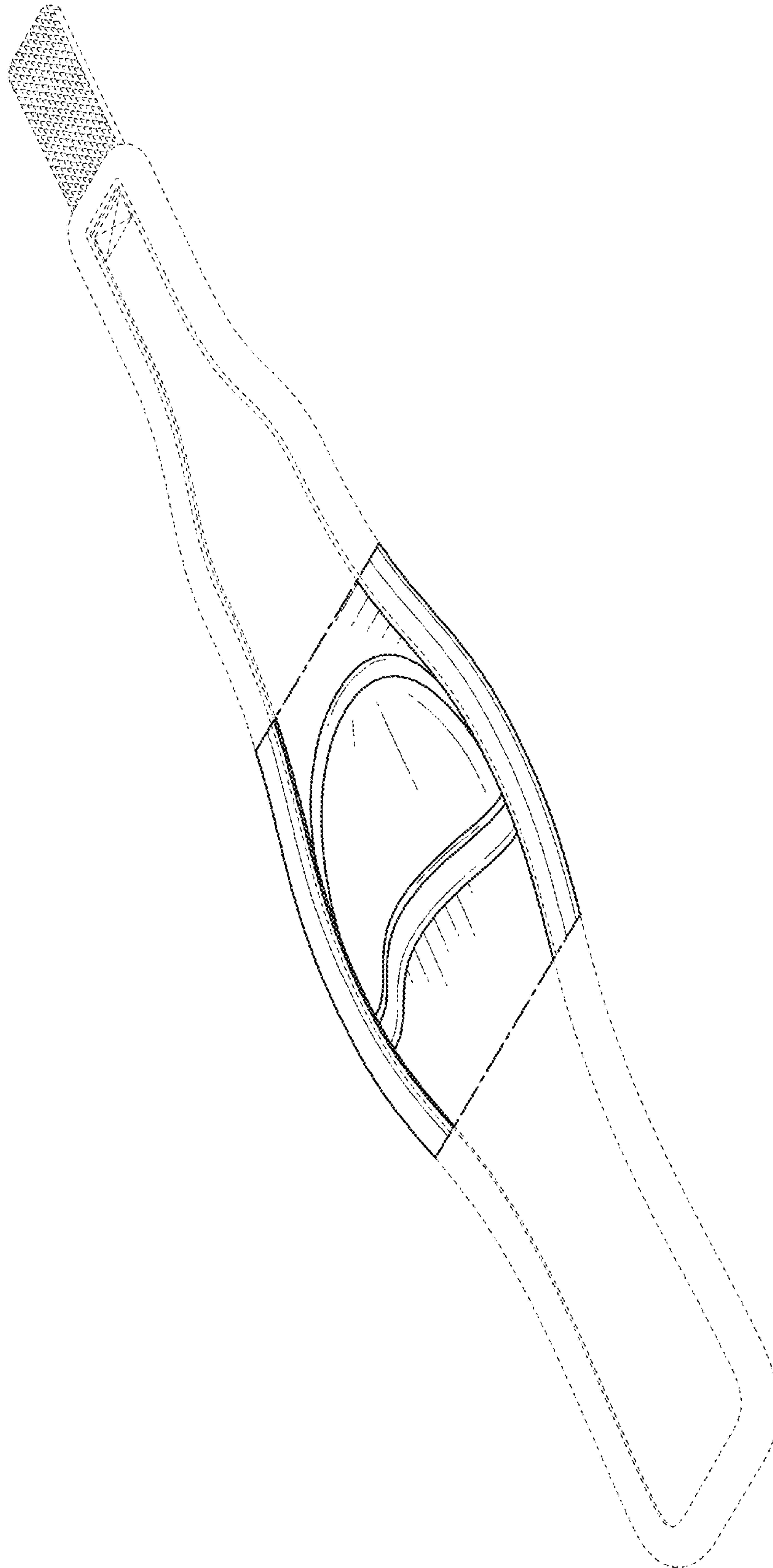

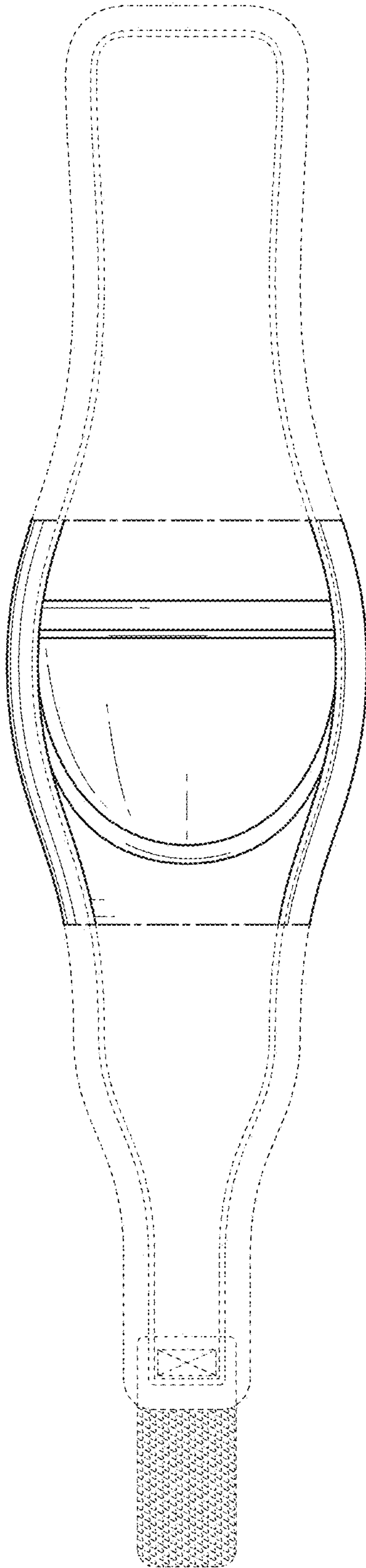

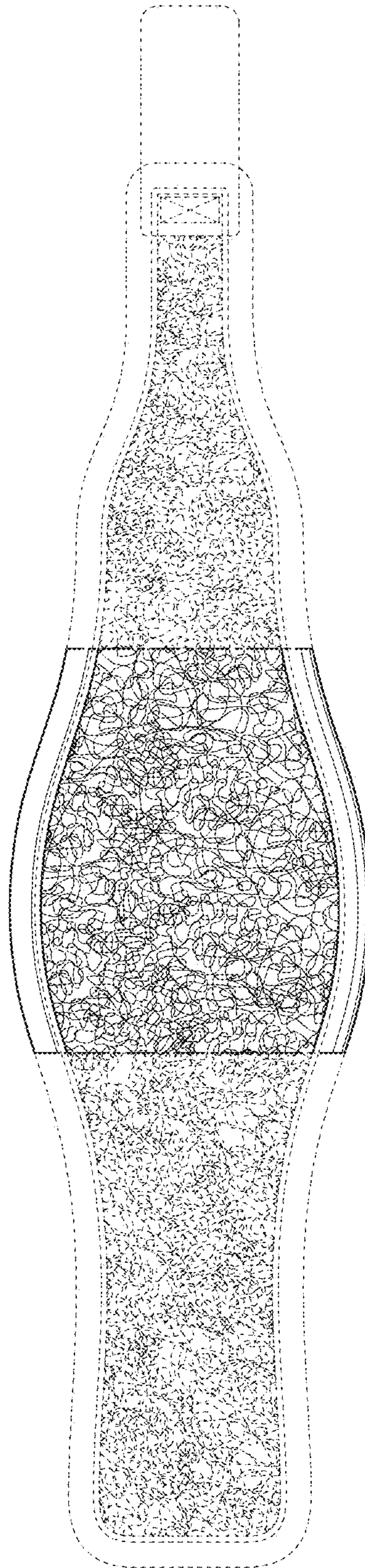

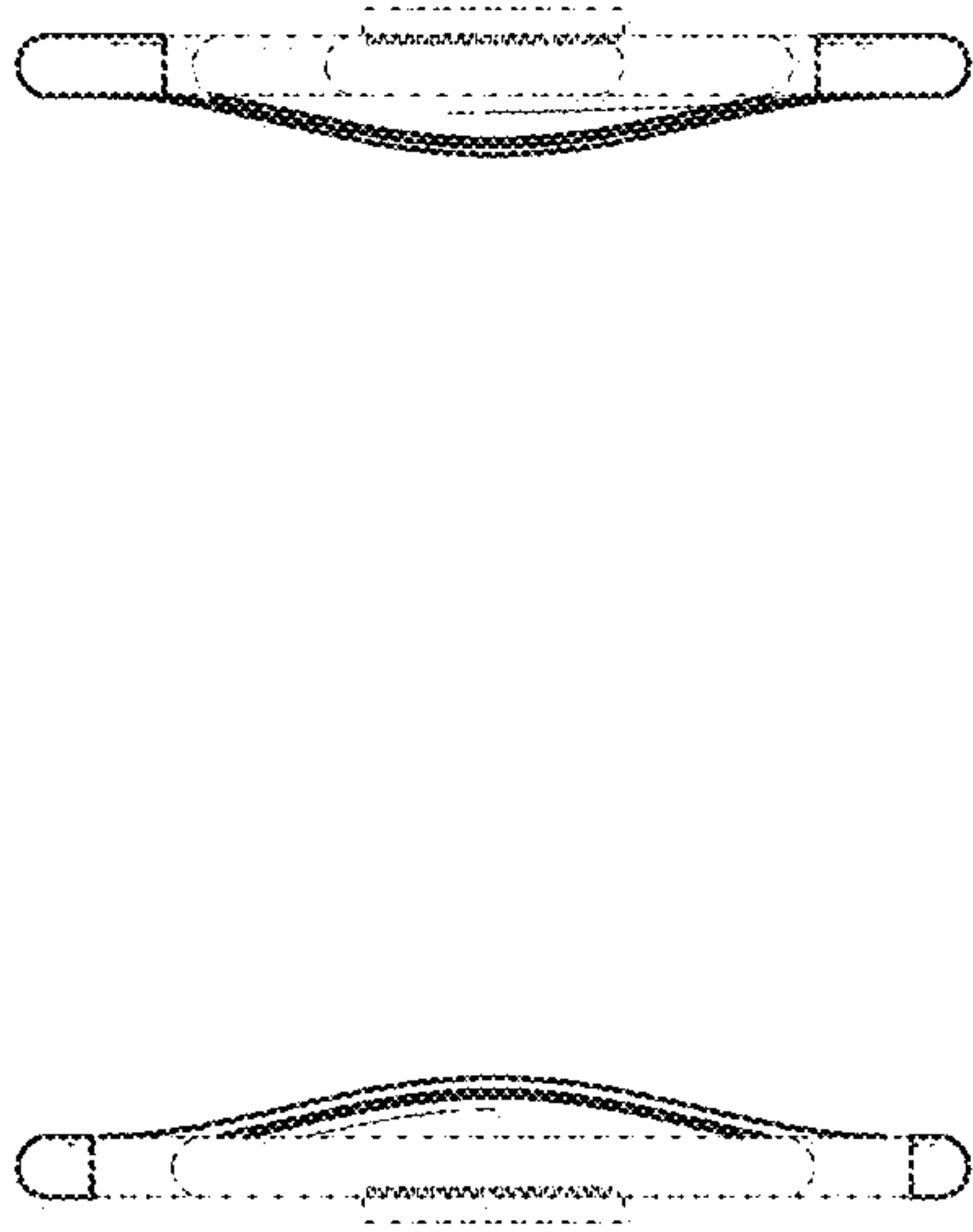

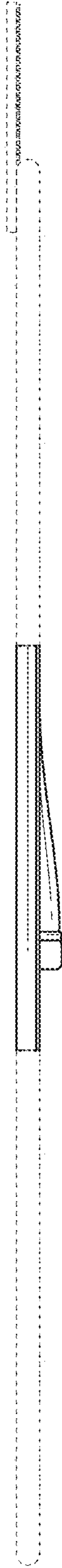

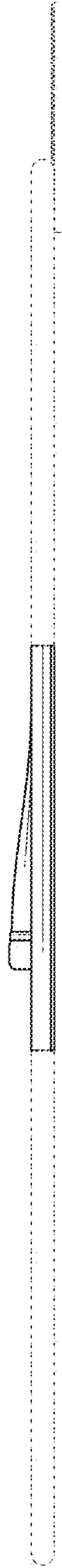
