The ornamental design for a facial beauty device, as shown and described.

FIG. 5 is a rear view of the facial beauty device;

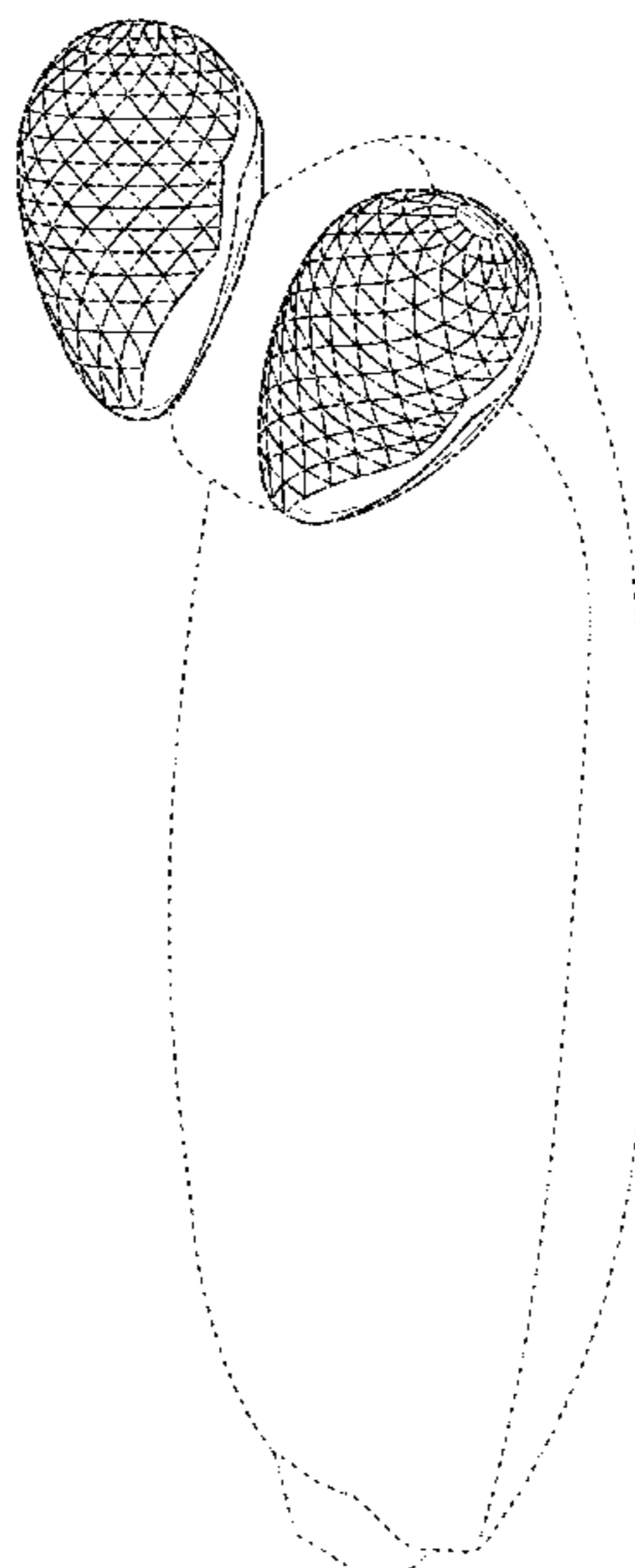
FIG. 6 is a left side view of the facial beauty device; and,

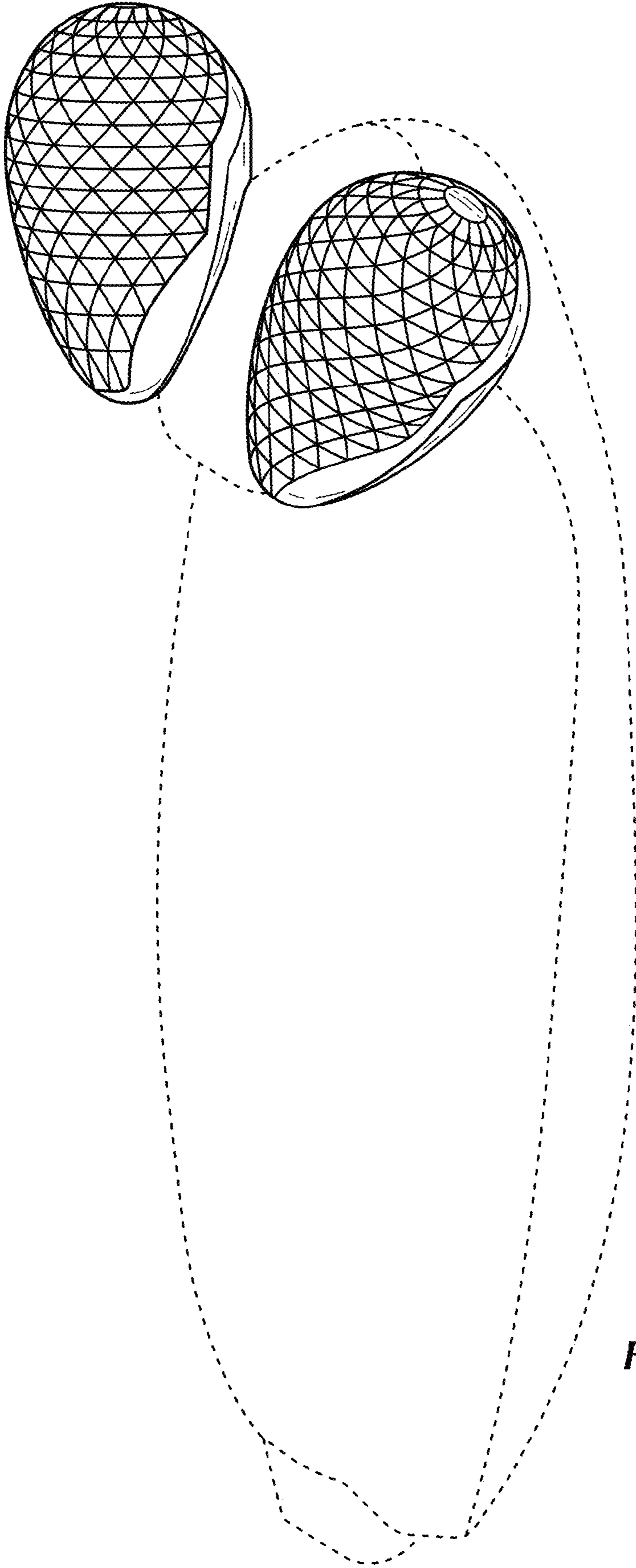
FIG. 7 is a right side view of the facial beauty device.

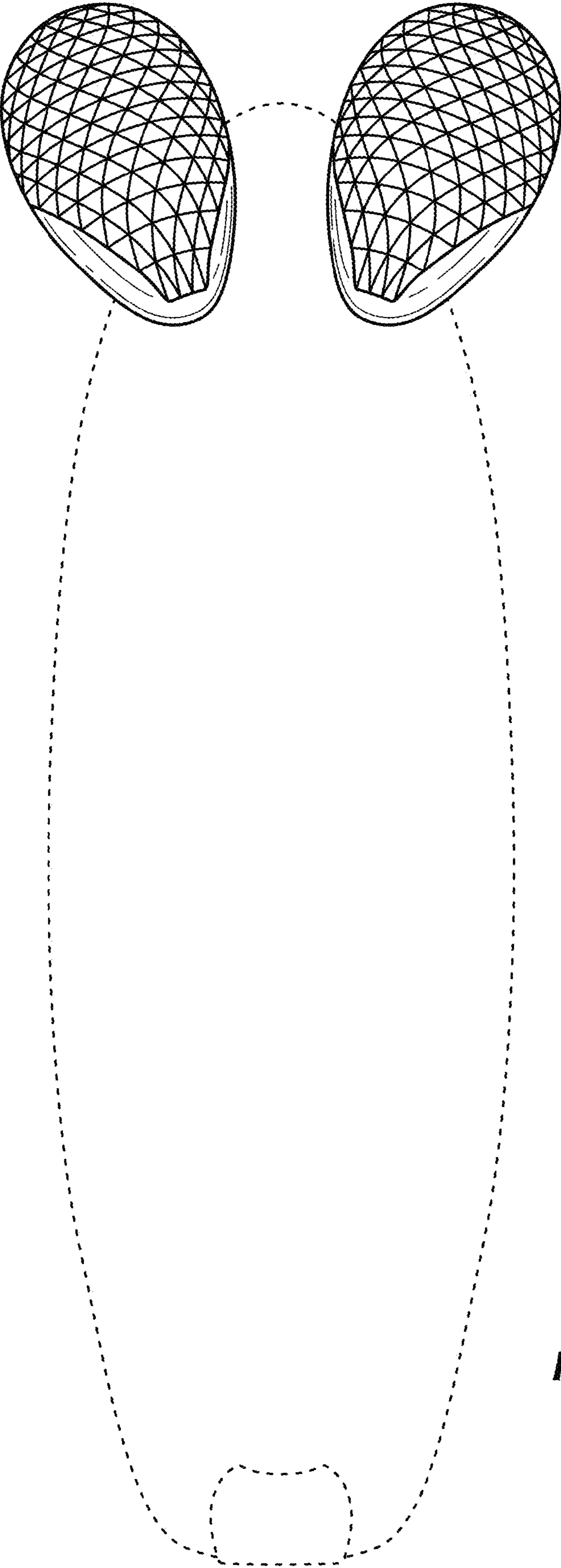

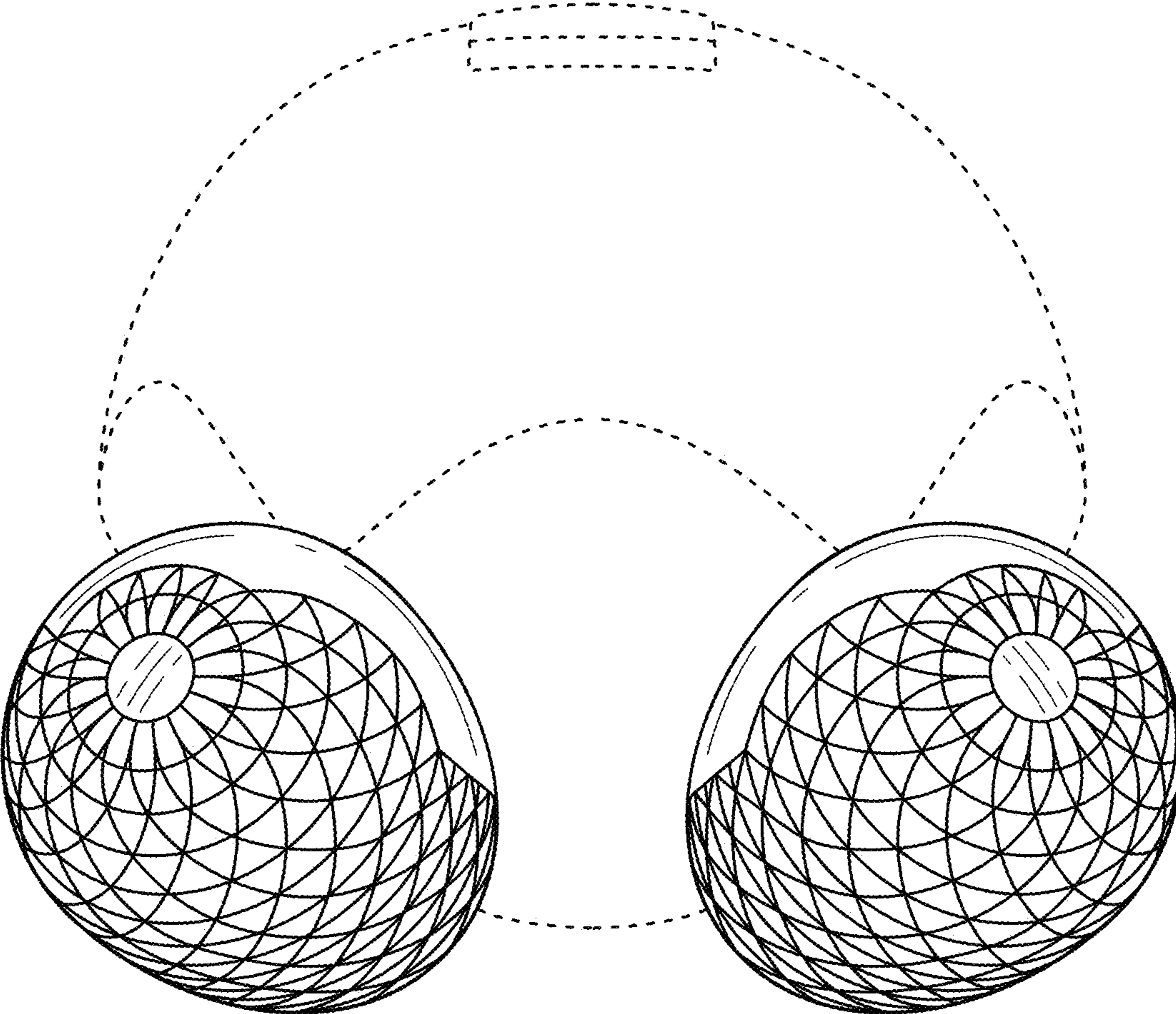

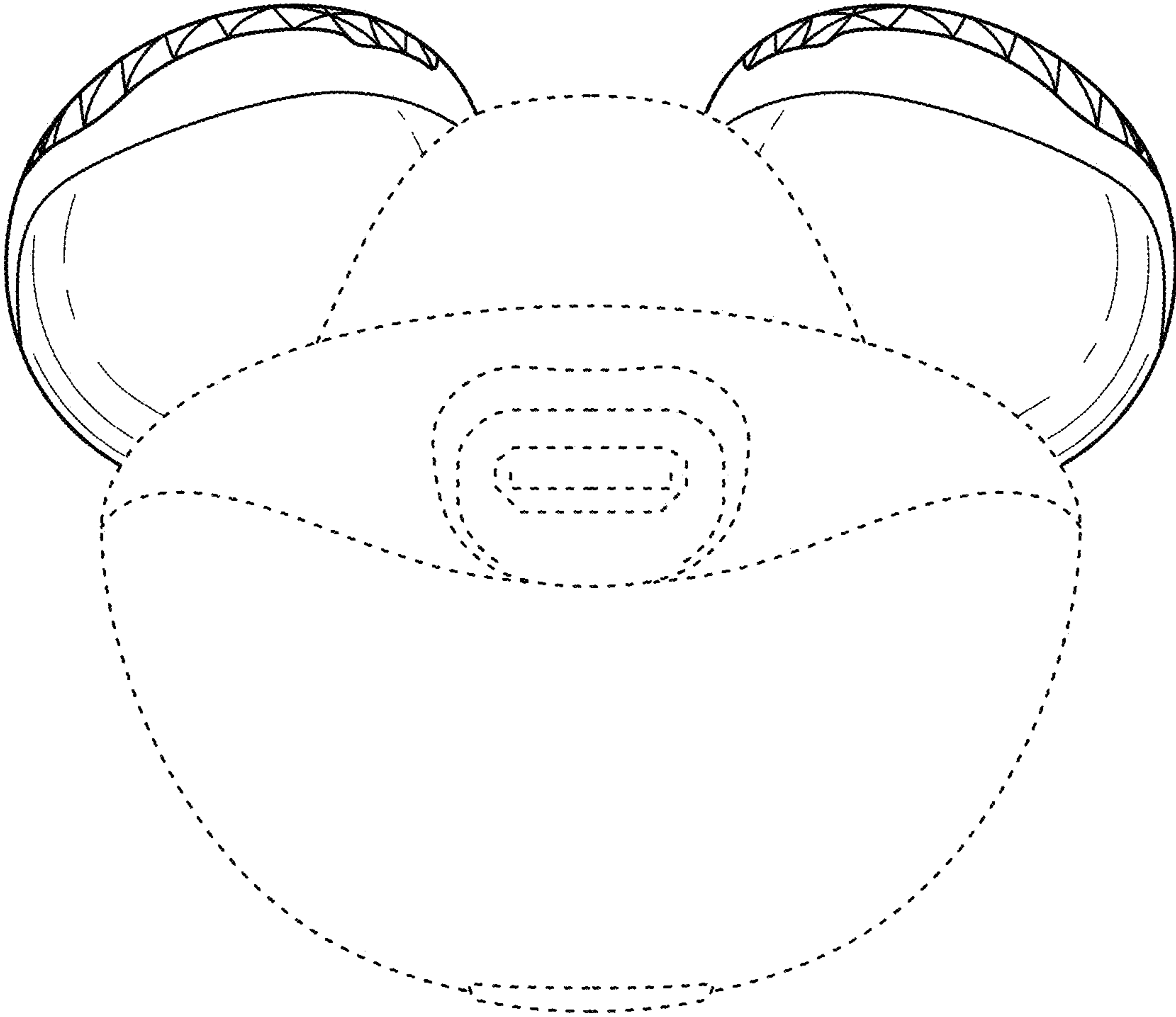
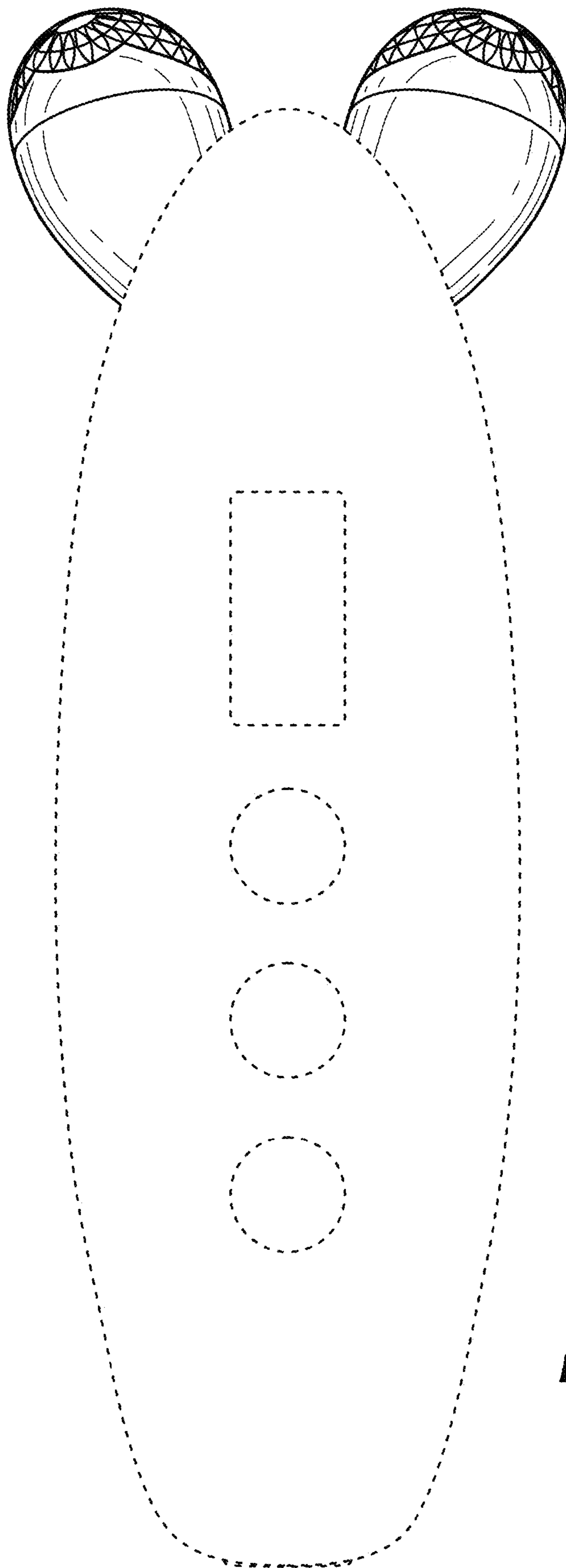
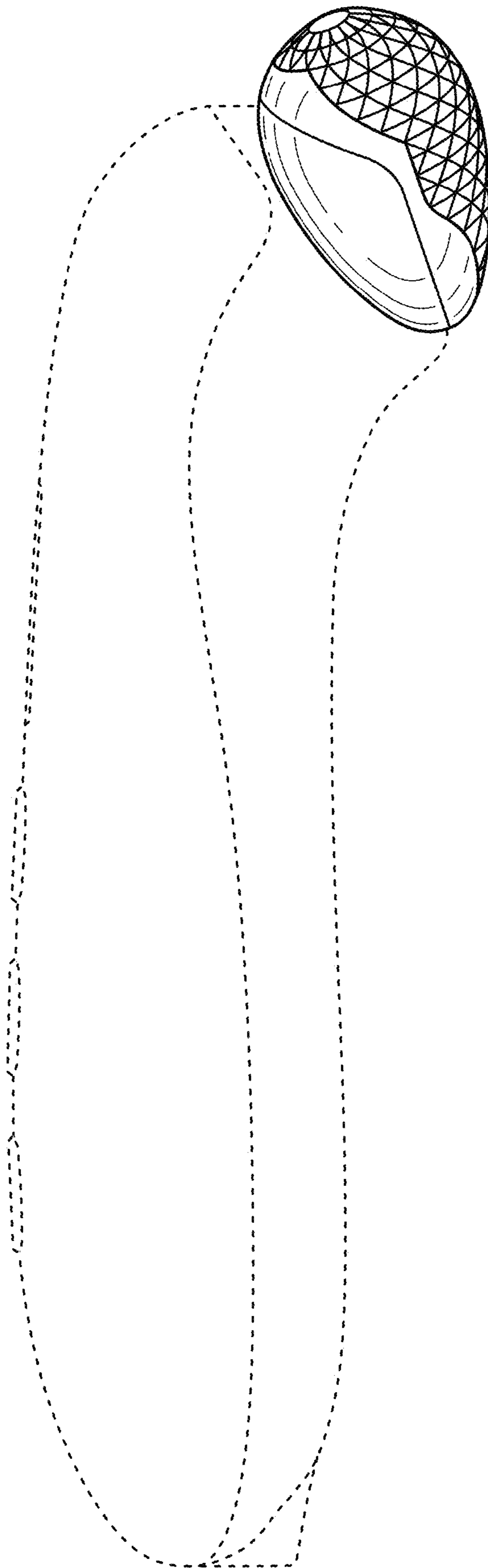


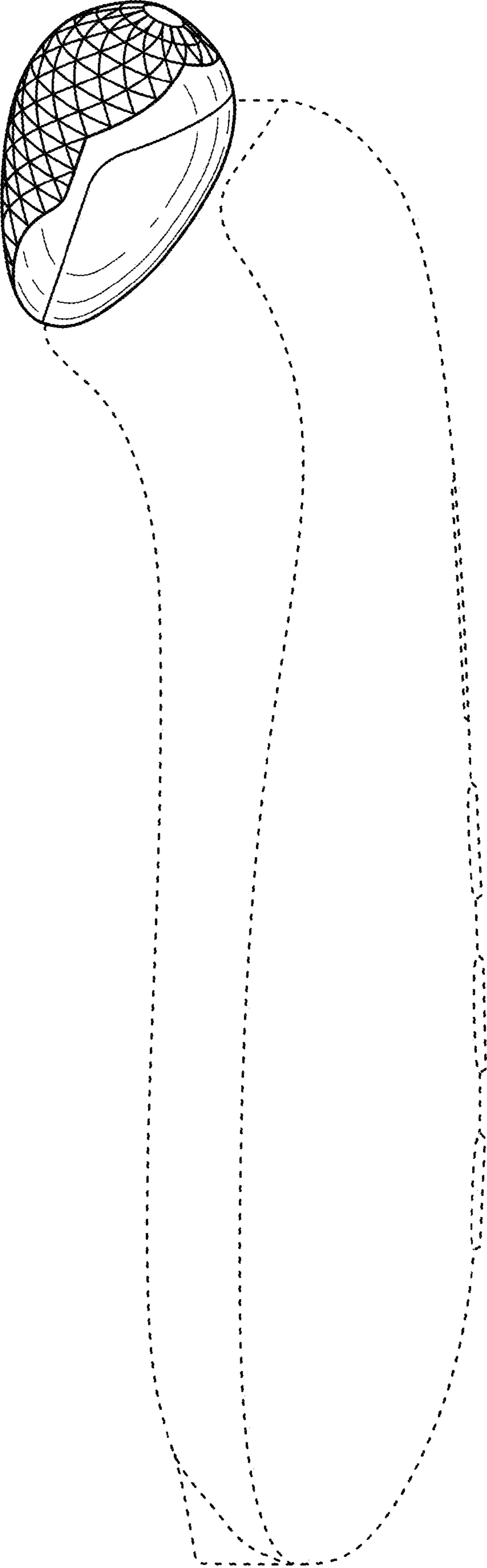
