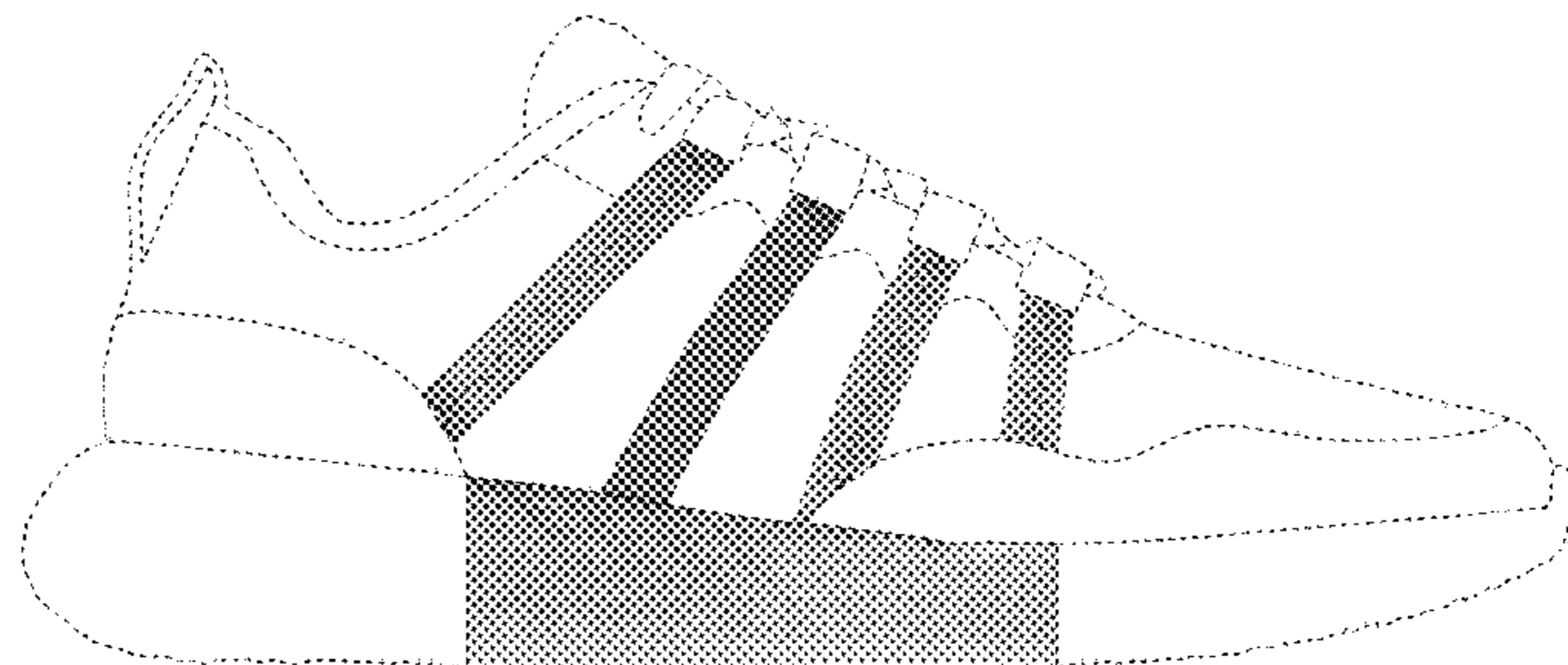
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of shoe showing our new design;
FIG. 2 is a left side view thereof;
FIG. 3 is a front view thereof; and,
FIG. 4 is a top view thereof.
The broken lines immediately adjacent the photographic areas represent unclaimed boundaries of the design and form no part of the claimed design. The broken lines showing the remainder of the shoe represent environment that form no part of the claimed design. Color forms no part of the claimed design. The stitching shown on the claimed bands of the shoe upper form no part of the claimed design.

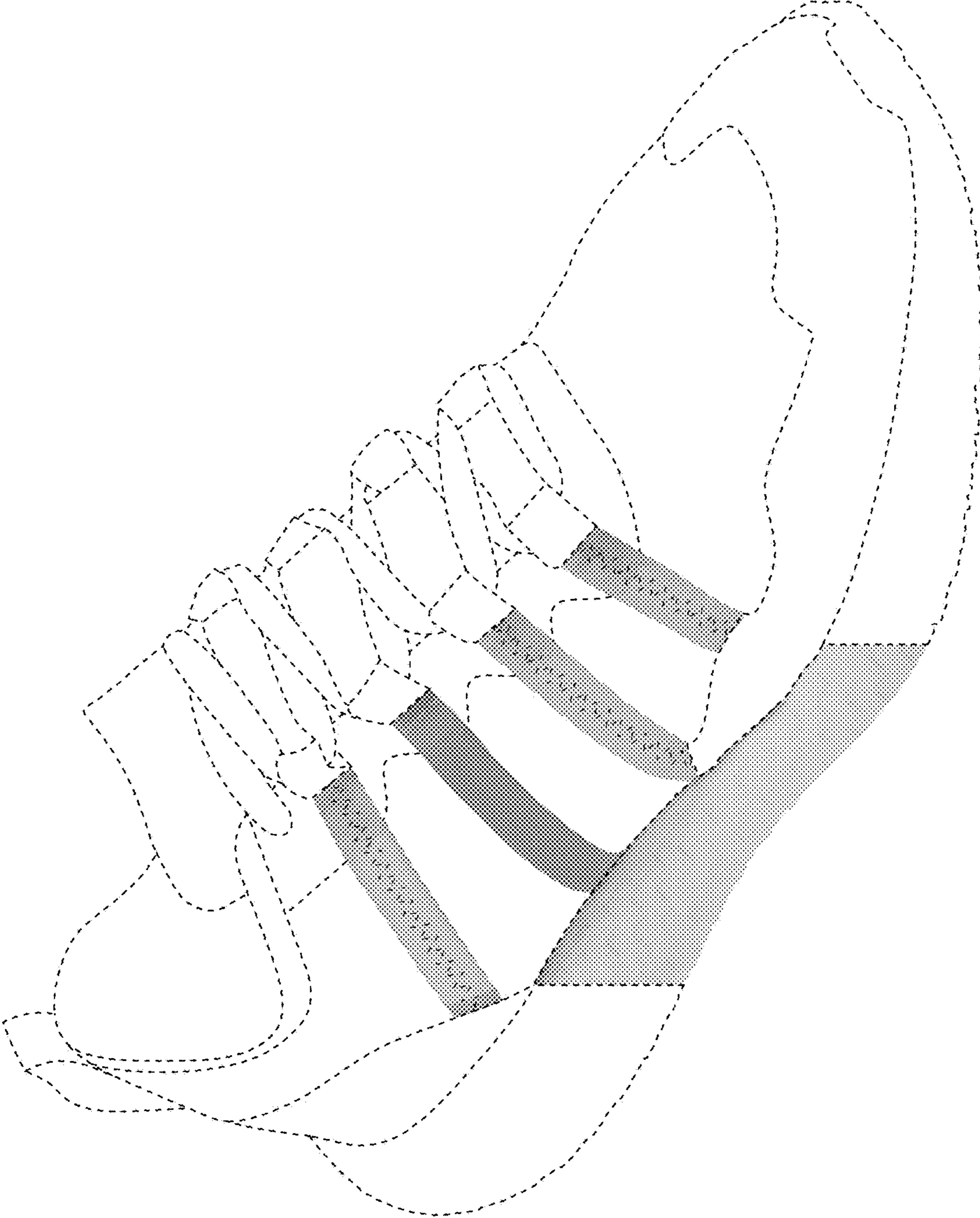

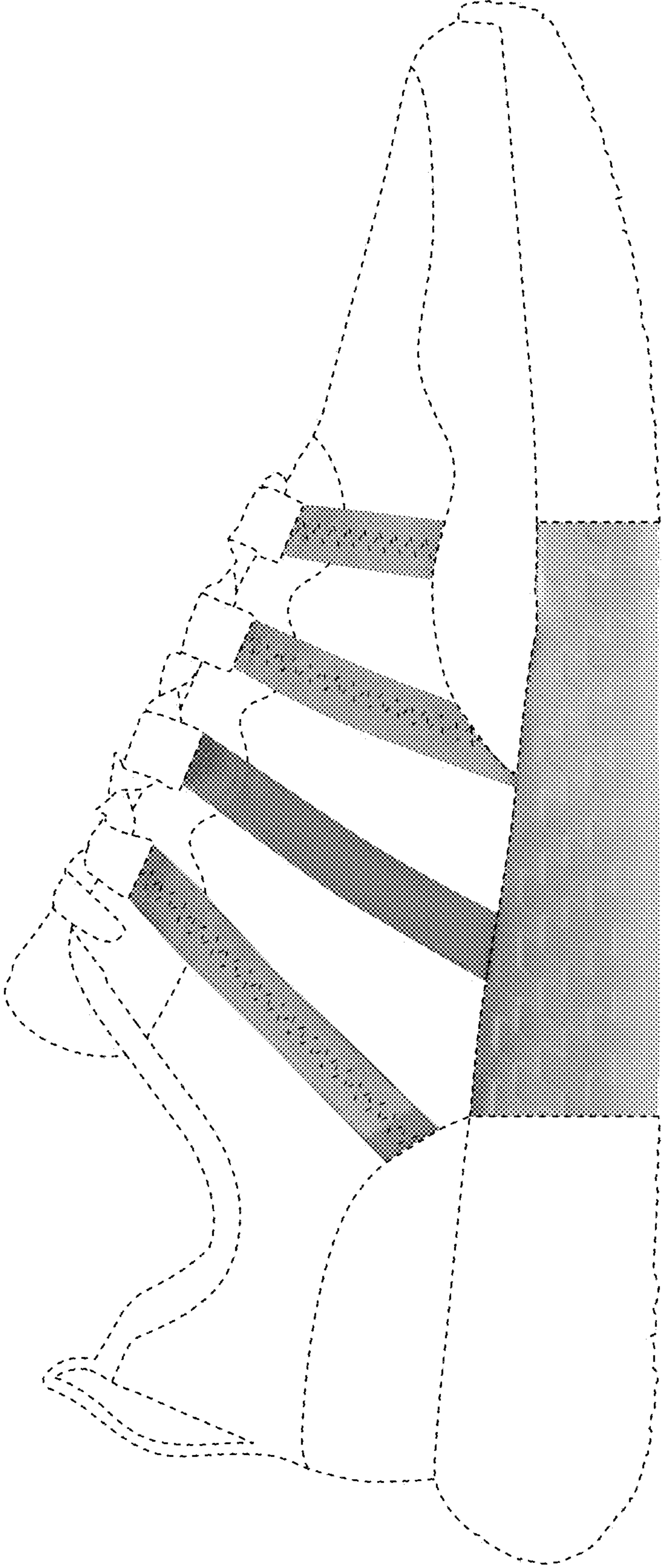

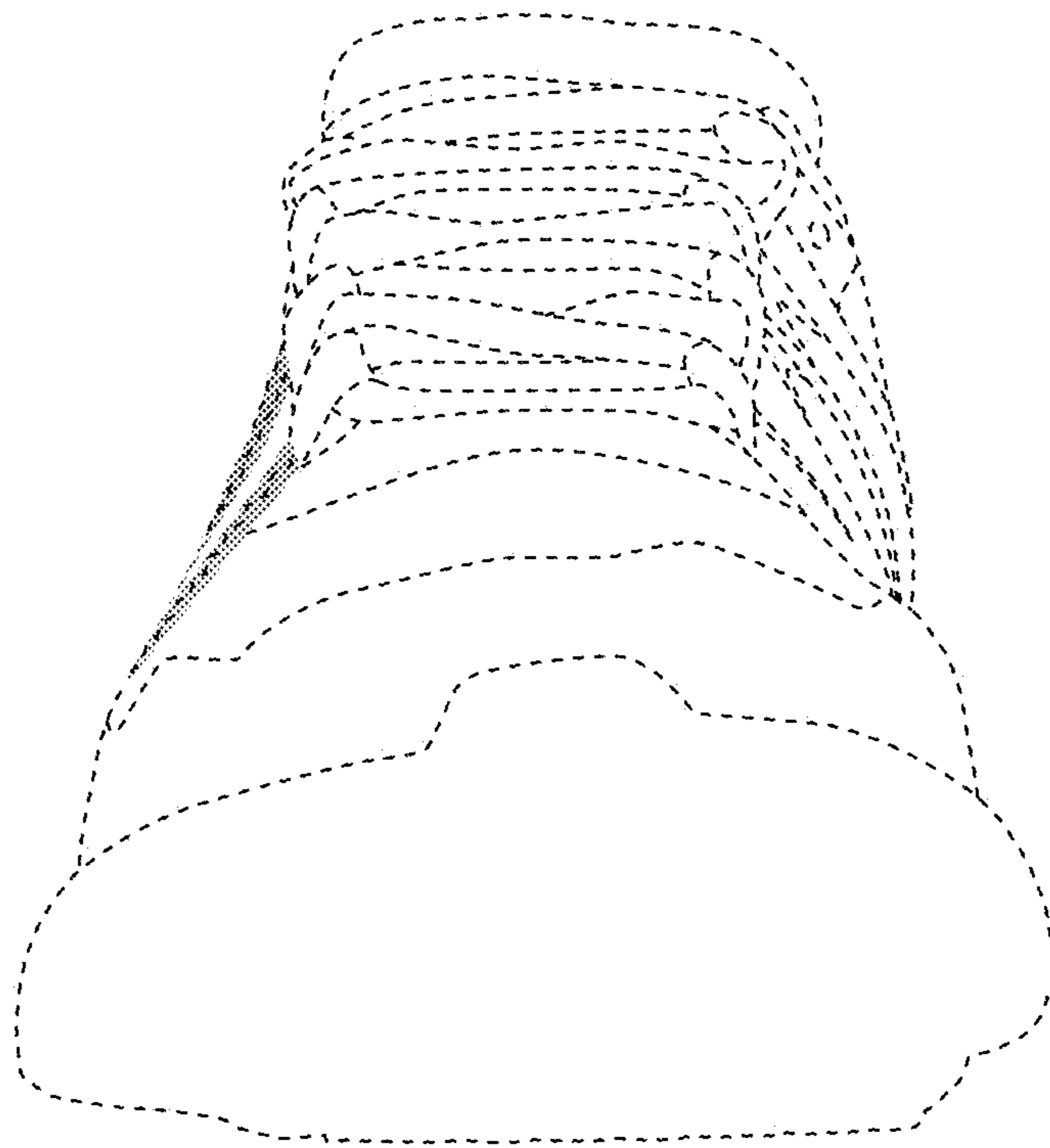

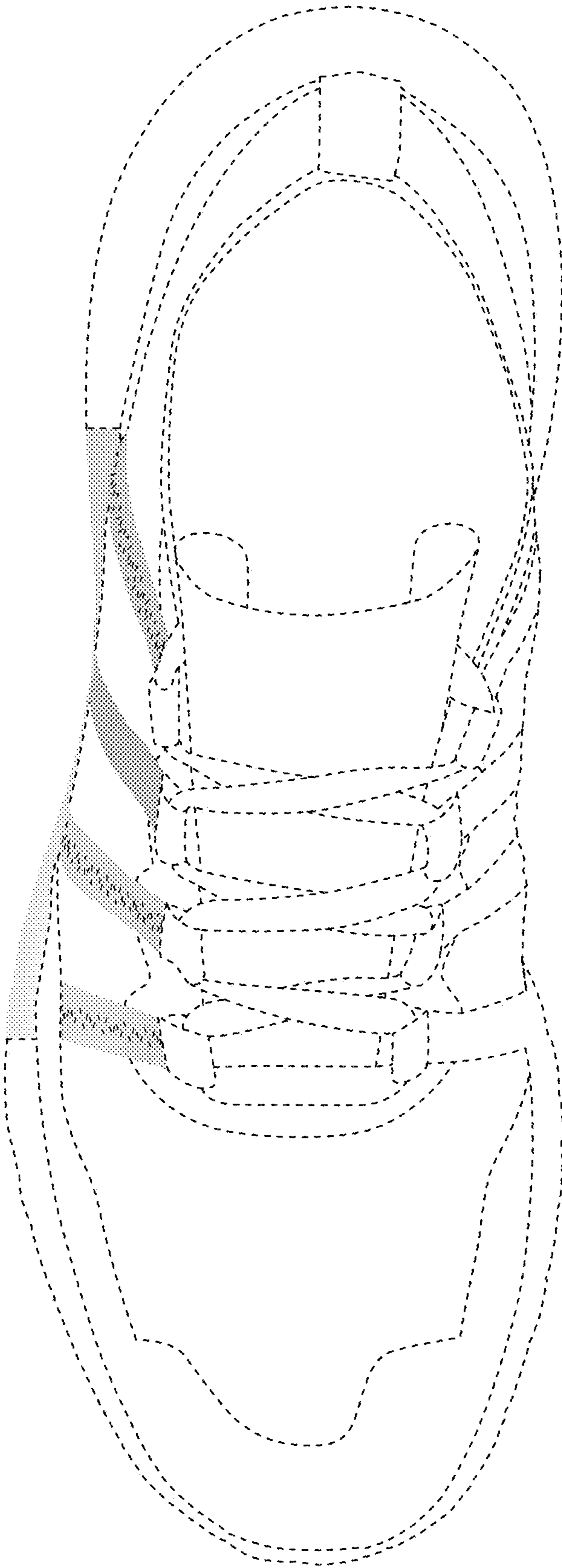
