(57) **CLAIM**

The ornamental design for a pocket configuration for luggage, bags, backpacks and the like, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a pocket configuration for luggage, bags, backpacks and the like showing my new design; and, FIG. 2 is a perspective view thereof.
