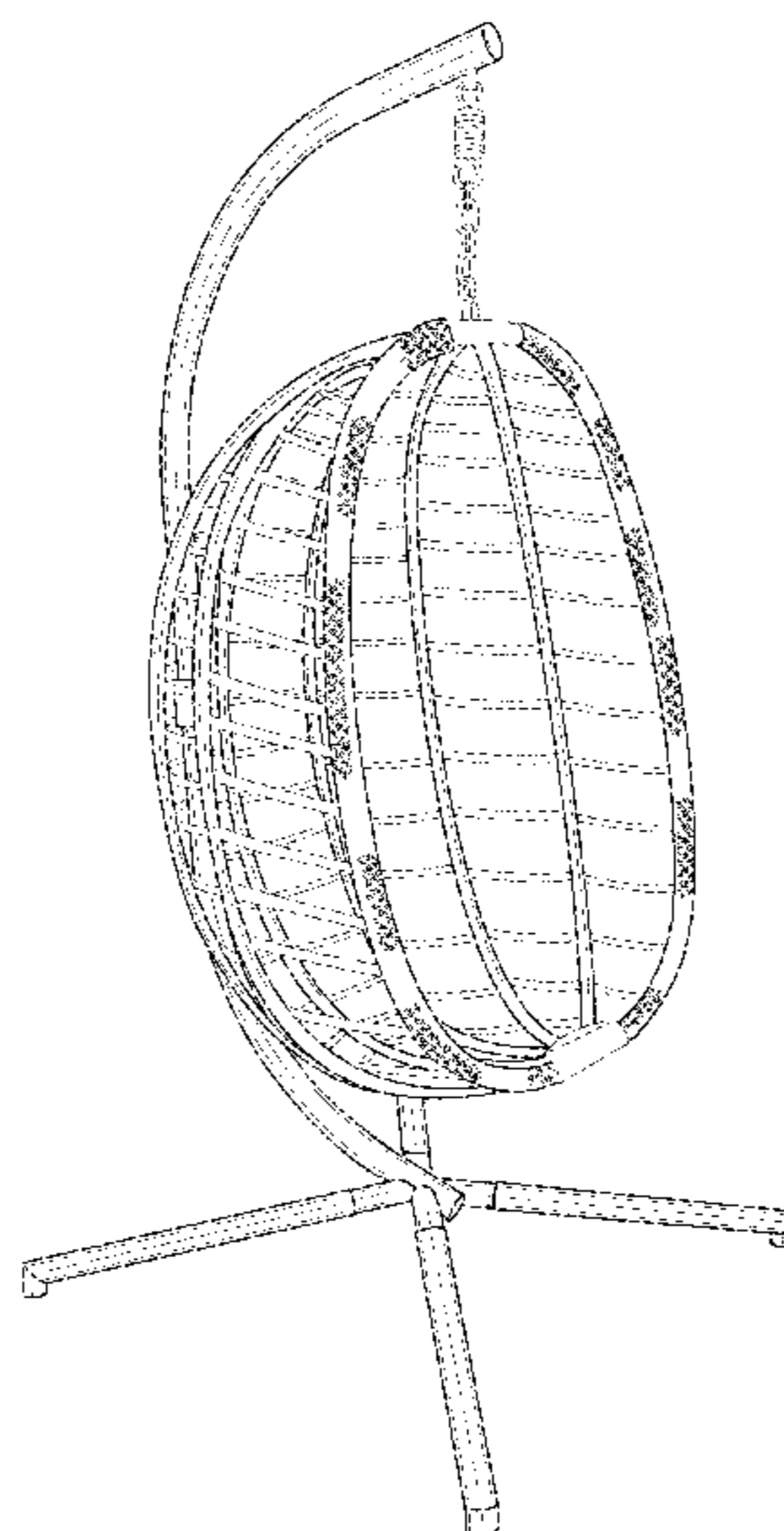
The ornamental design for a swing chair, as shown and described.

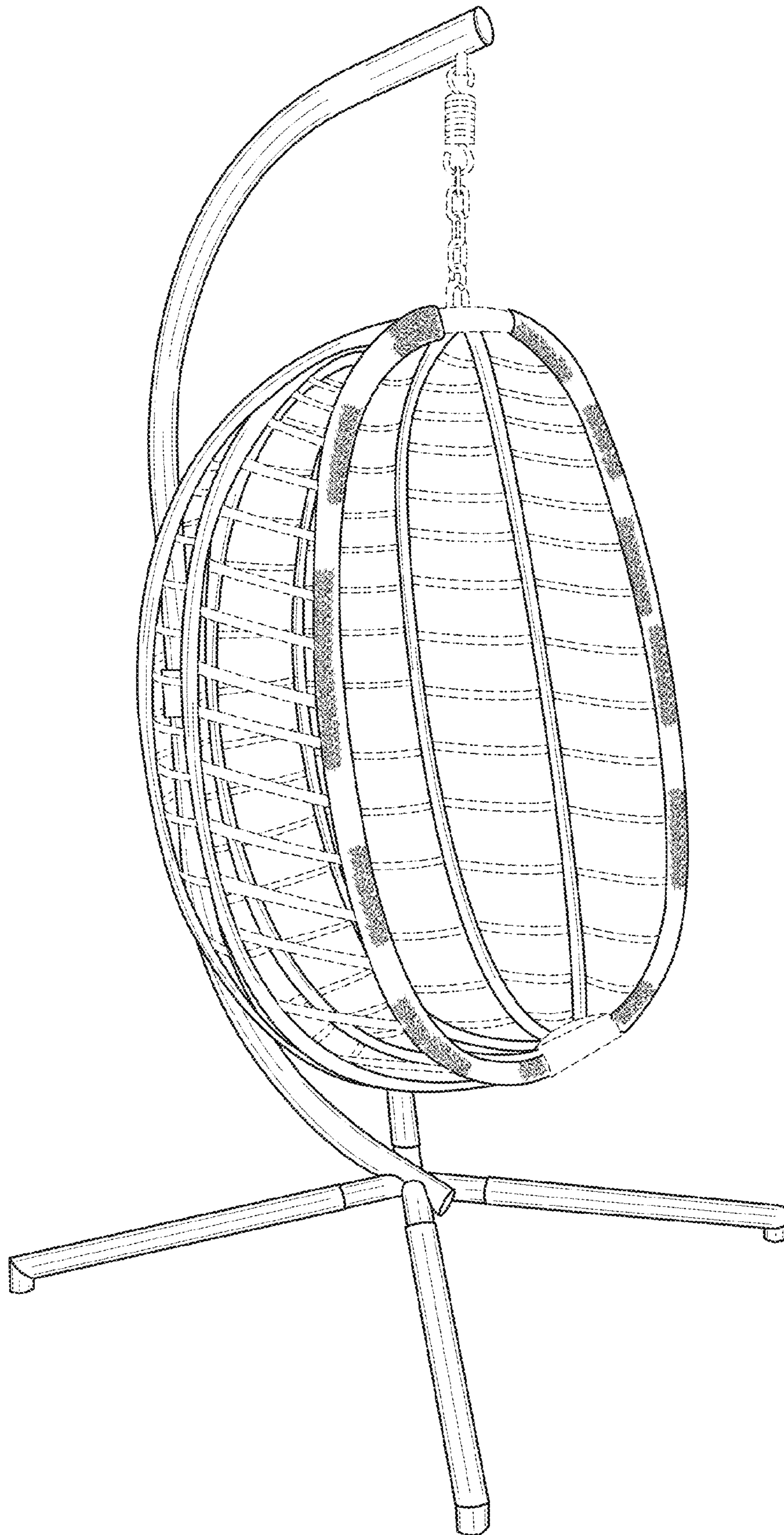

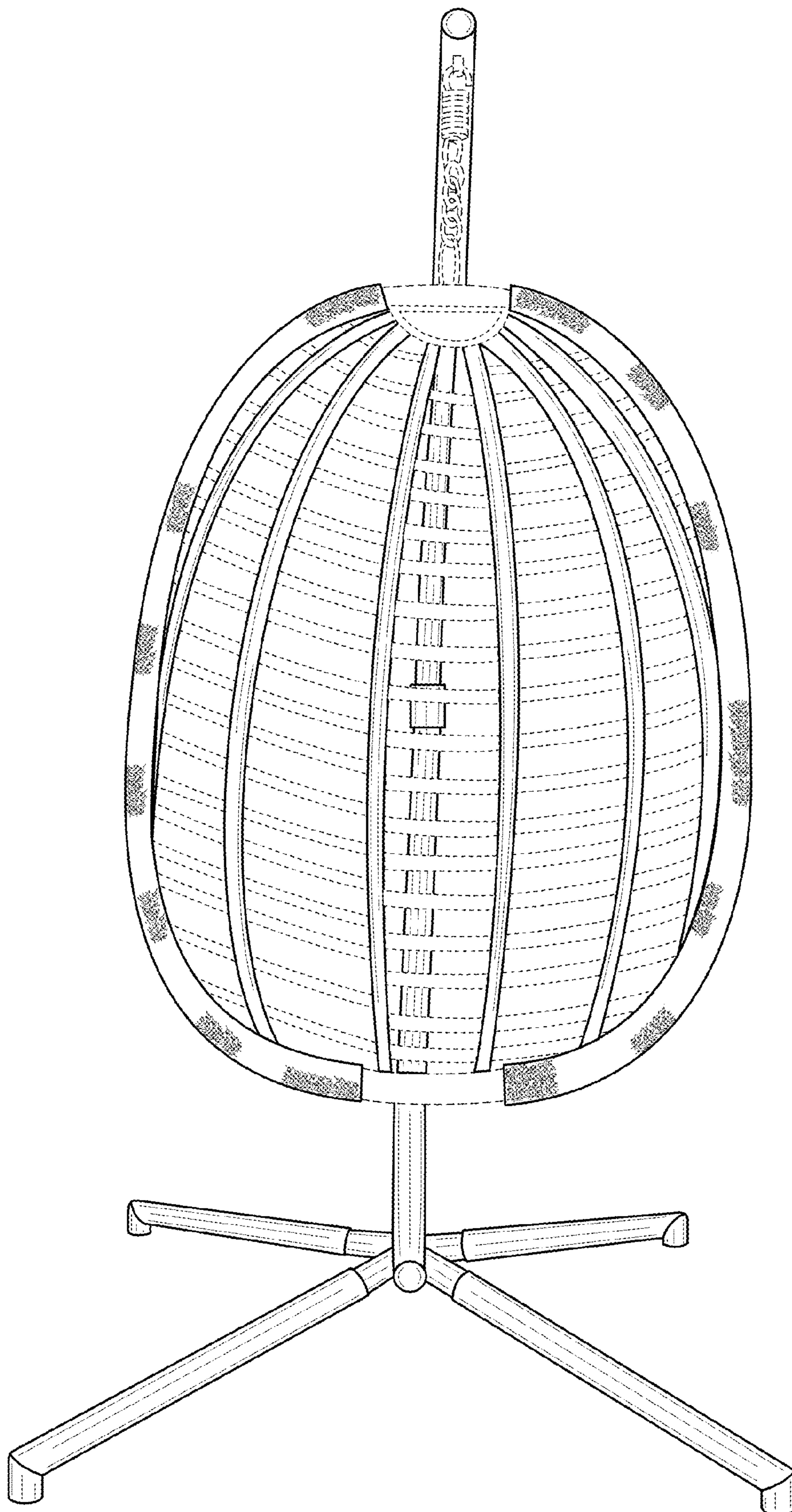

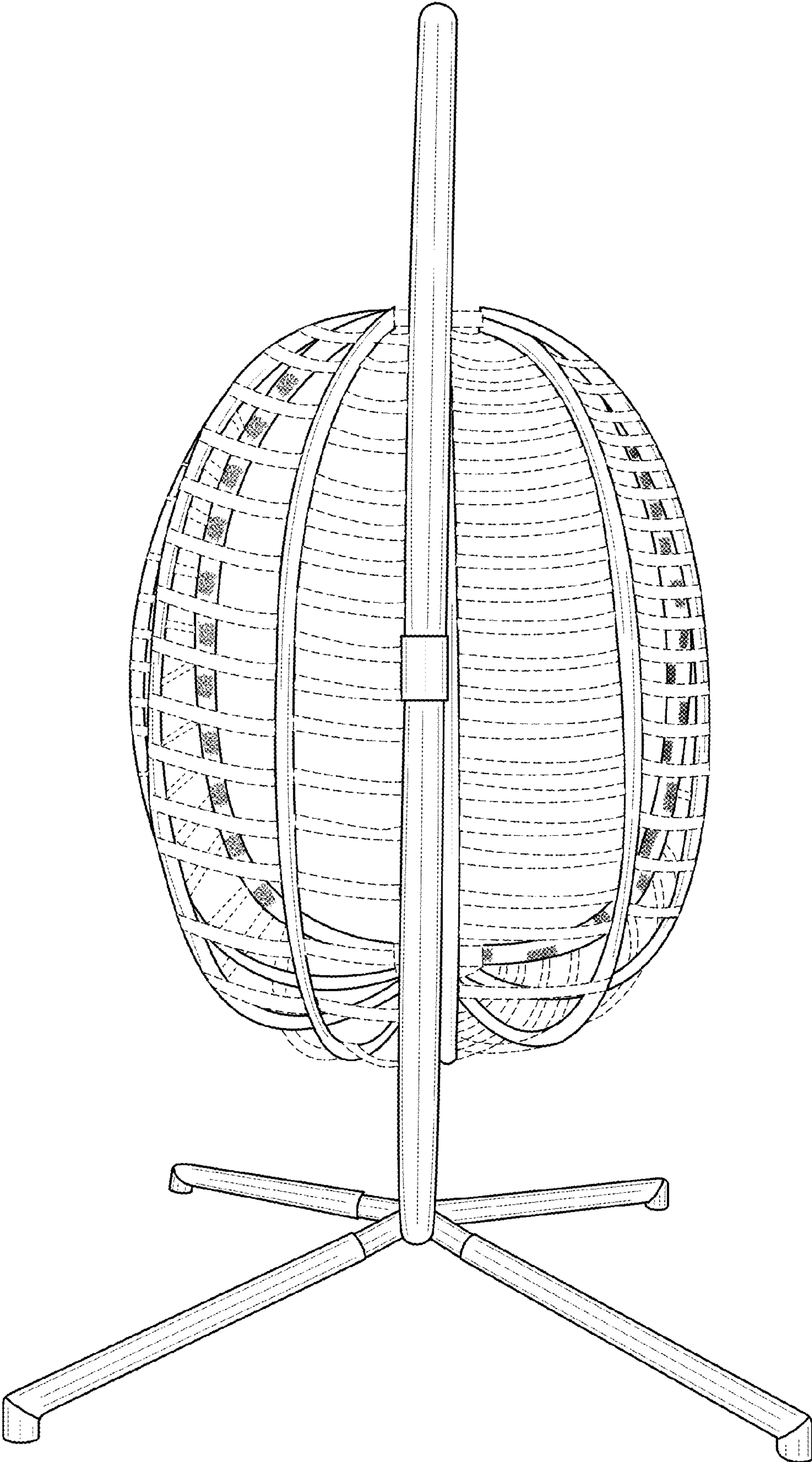

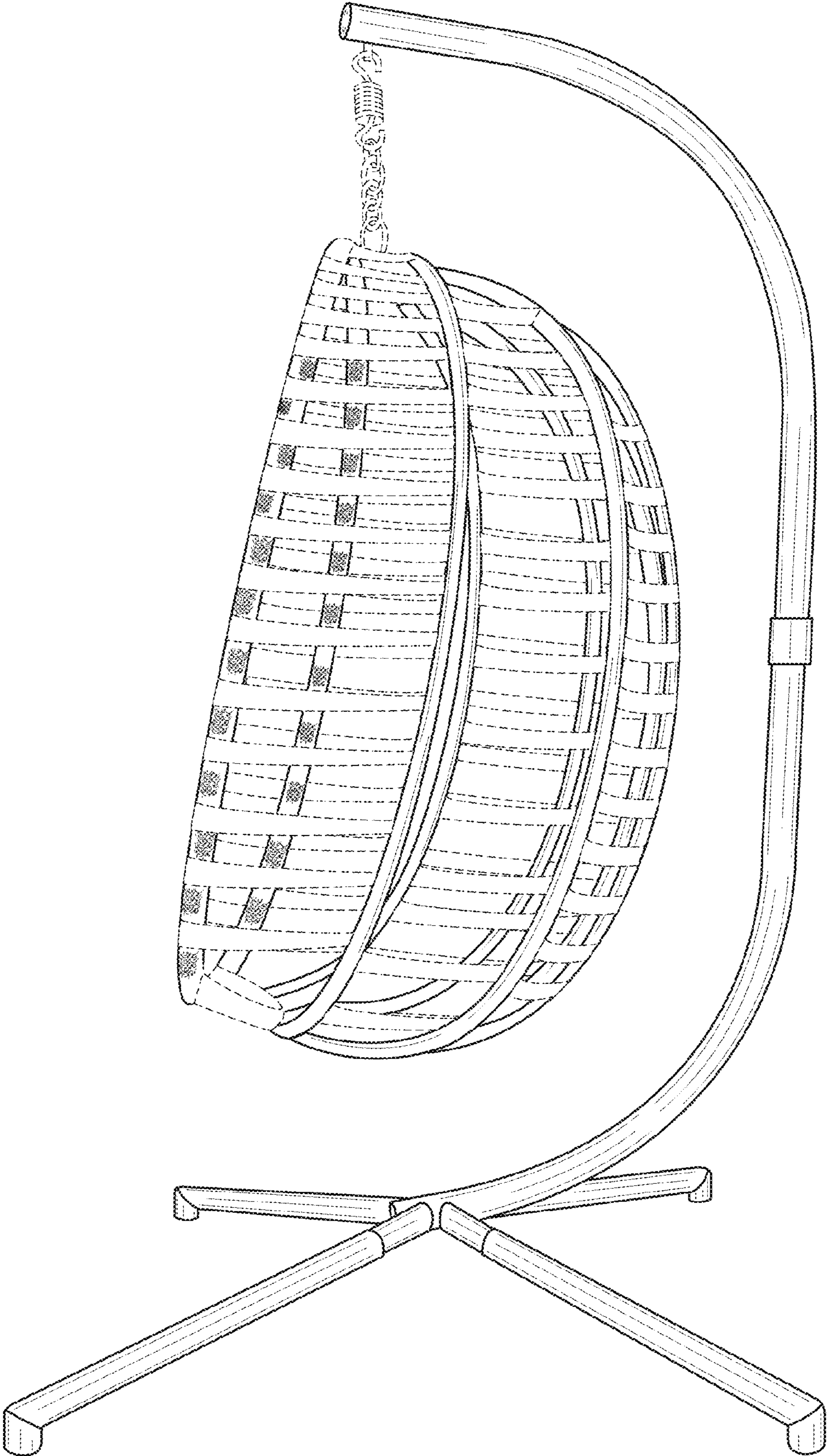

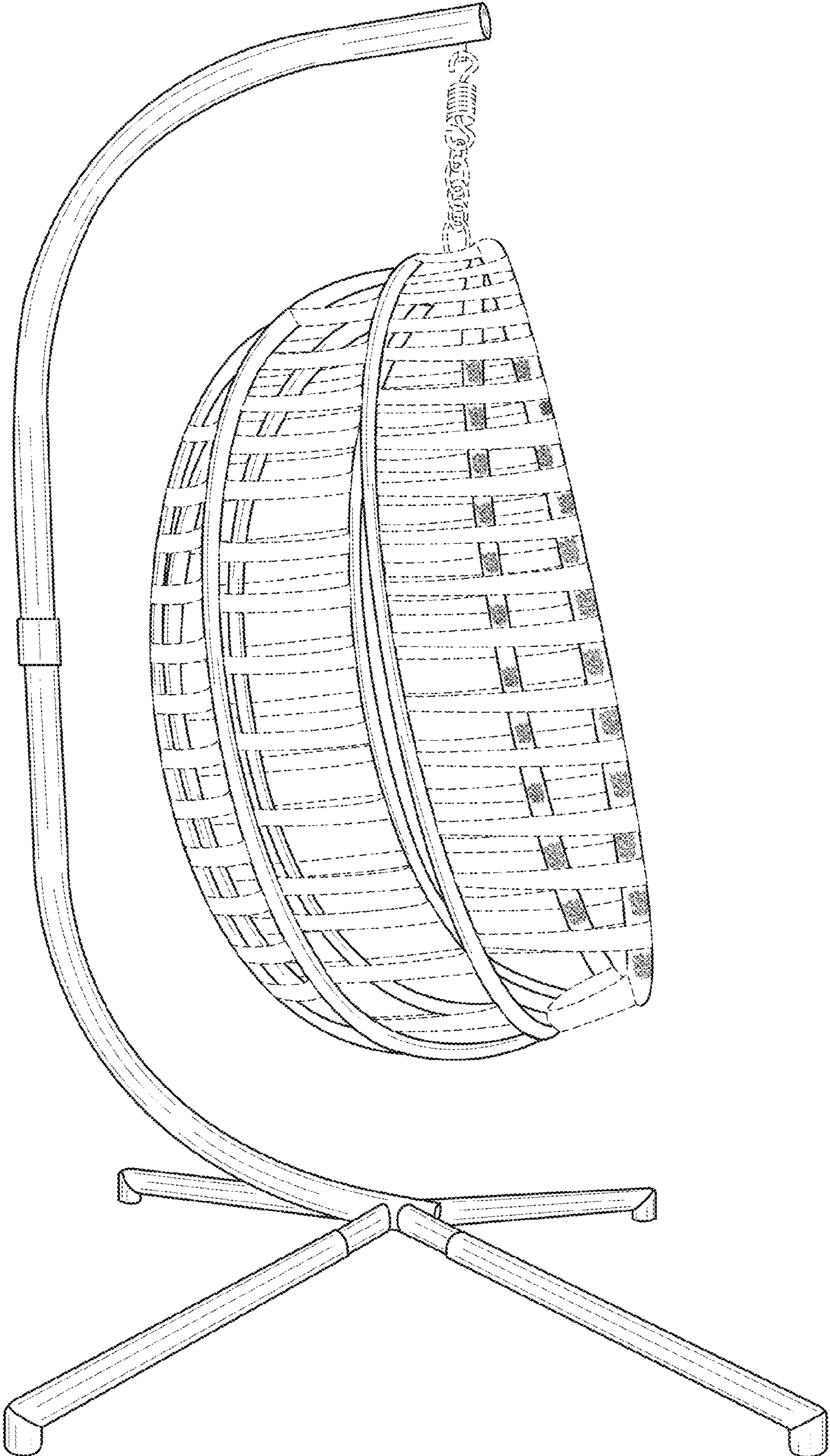

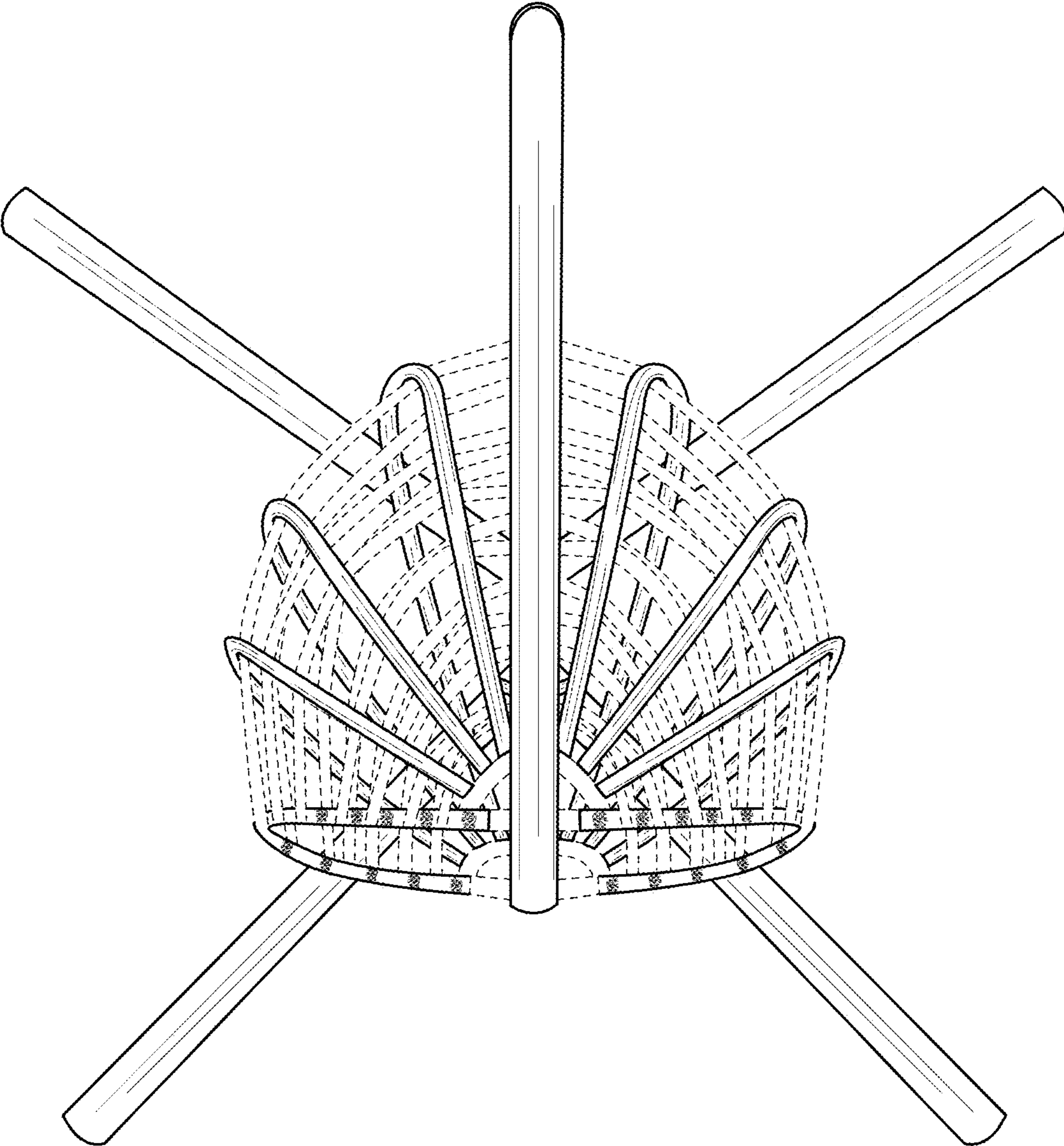

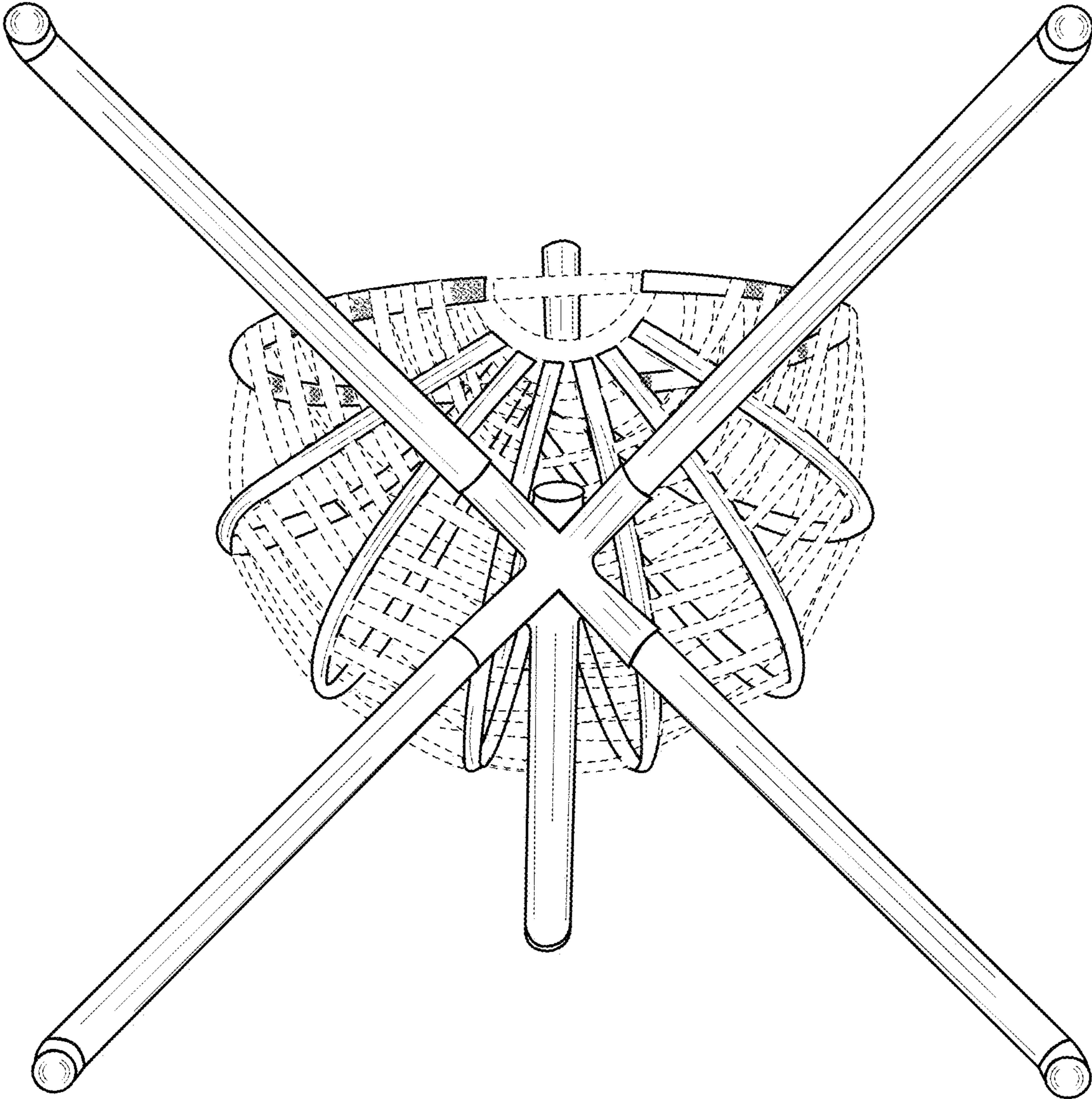
