(57) **CLAIM**

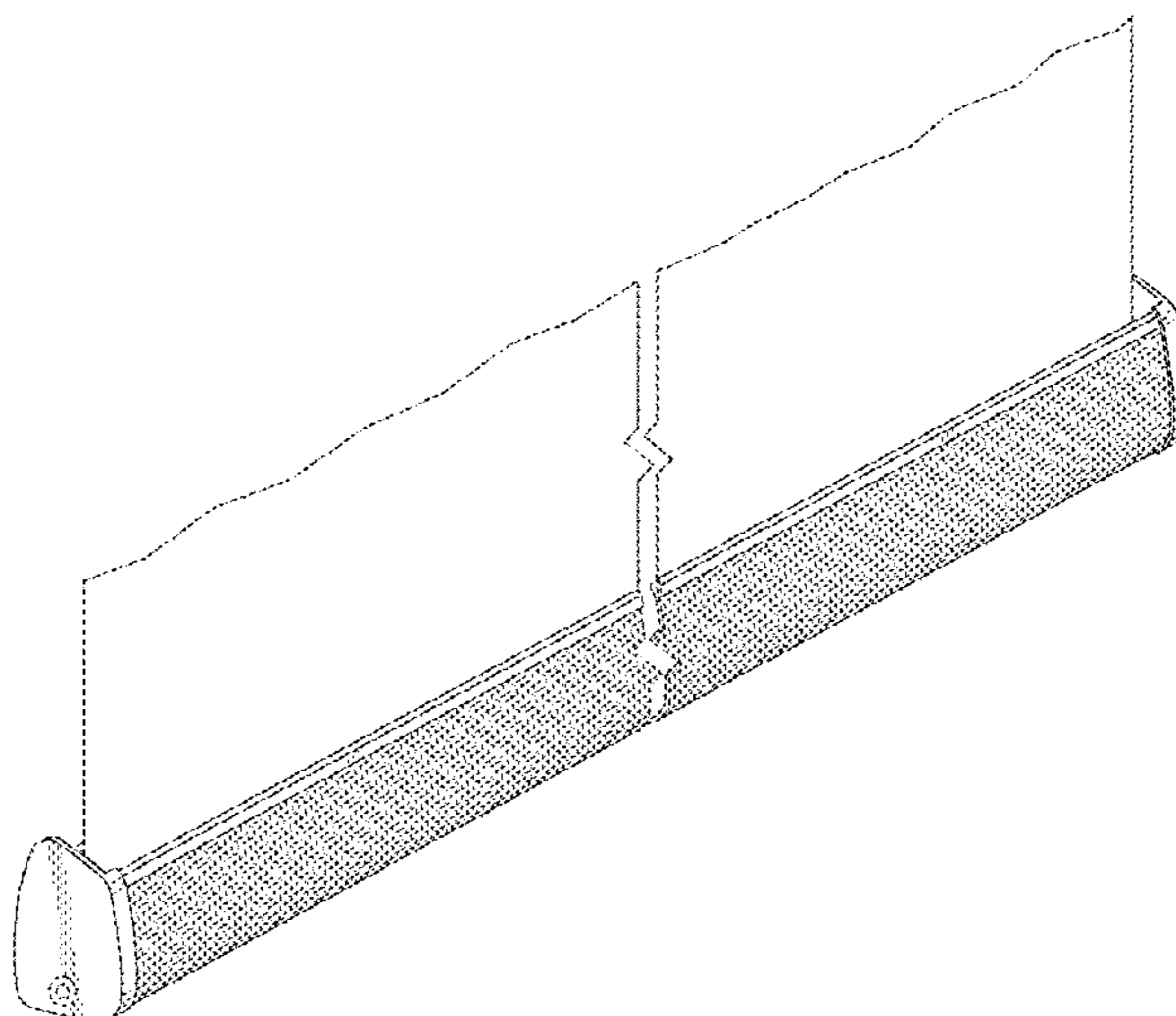
The ornamental design for a bottom rail for a window covering, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the bottom rail for a window covering;
FIG. 2 is a rear view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side view thereof; and,
FIG. 7 is a right side view thereof.
The window covering material shown in broken line in FIGS. 1-4 and 6-7 form no part of the claimed design. The fastener shown in broken line in FIGS. 1, 6 and 7 form no part of the claimed design. The break lines shown in FIGS. 1-5 symbolize breaks in the length of the article in which the claimed design is embodied. The appearance of any portion of the article between the break lines forms no part of the claimed design.

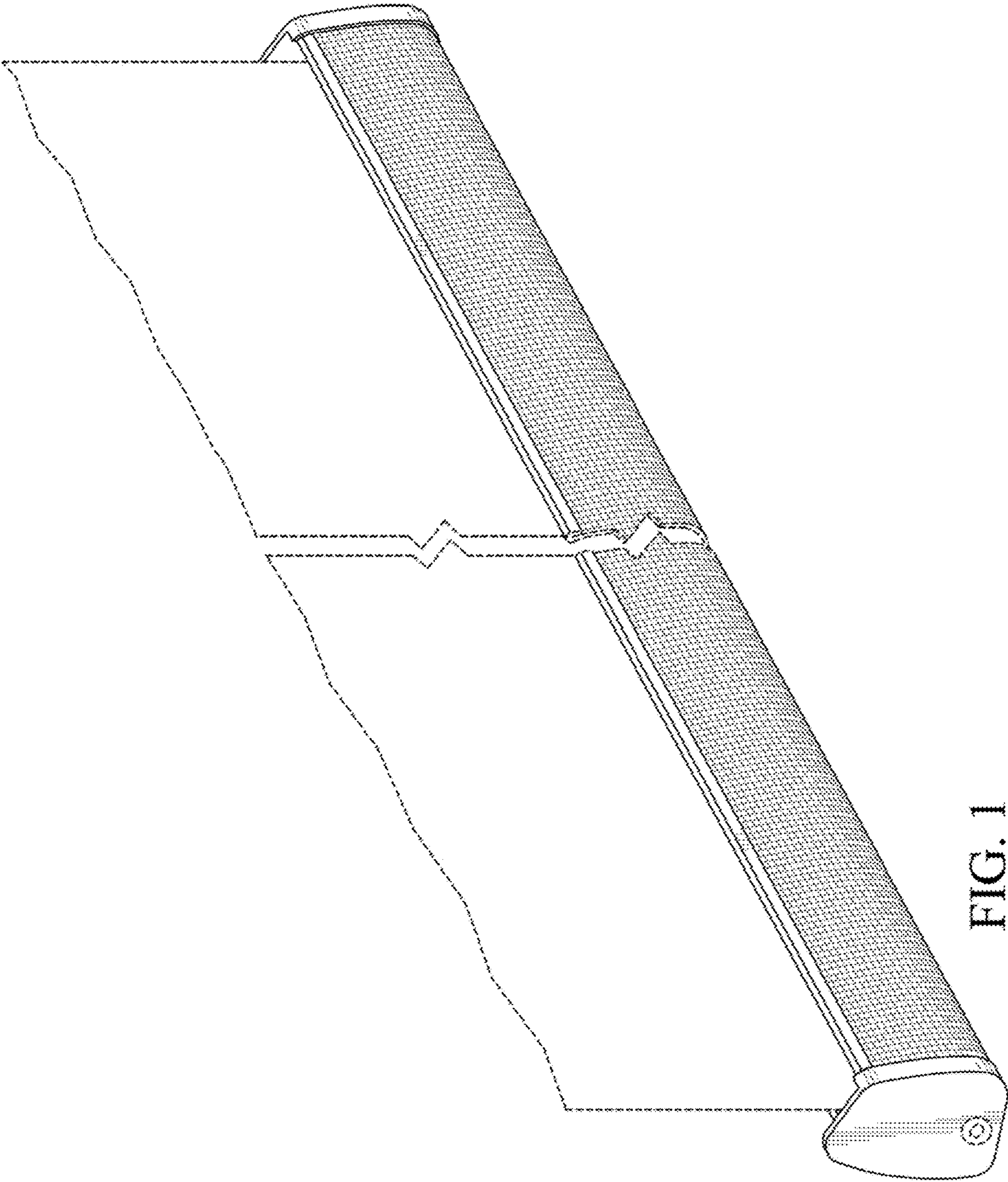

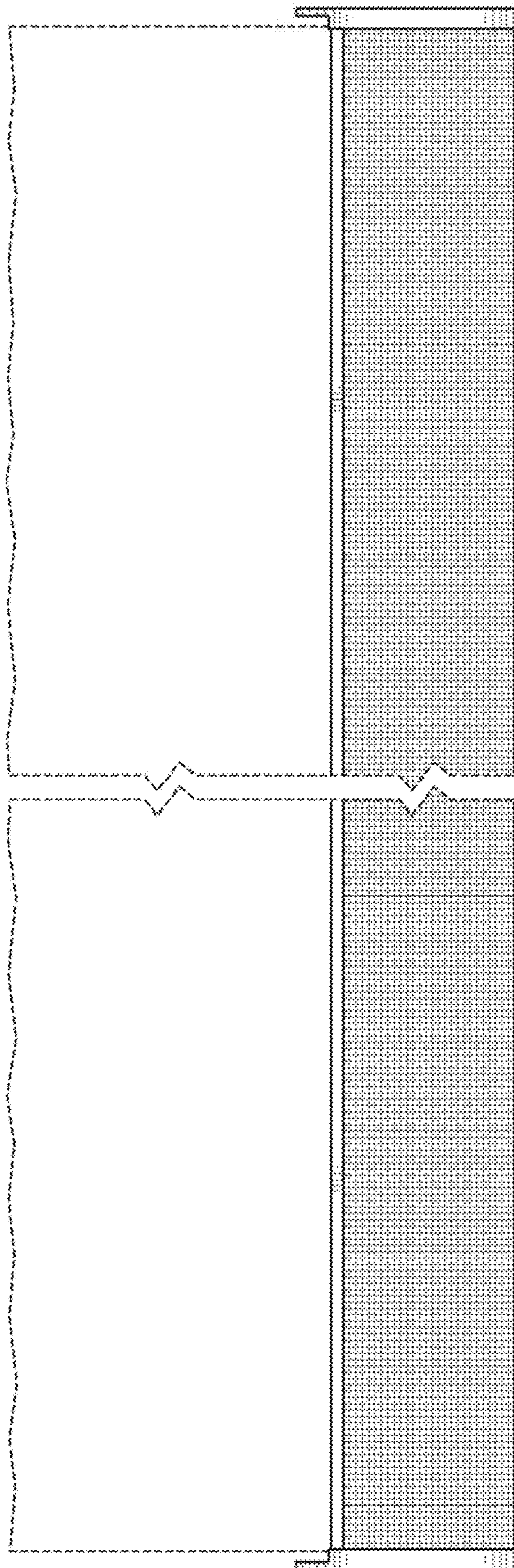

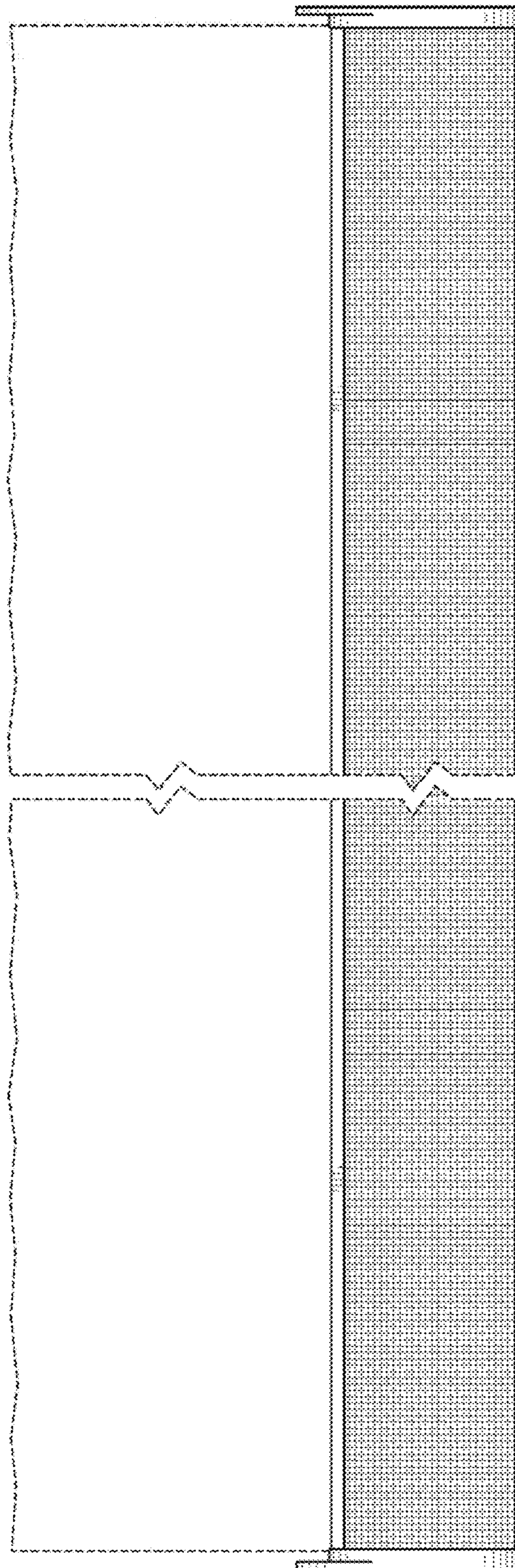

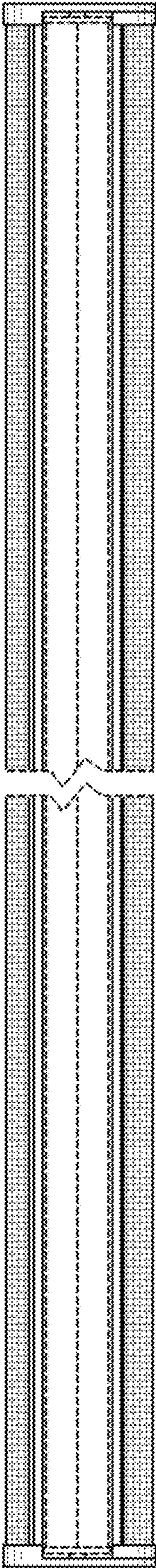

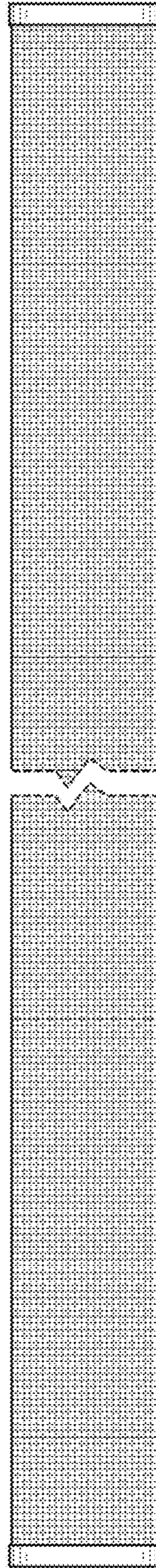

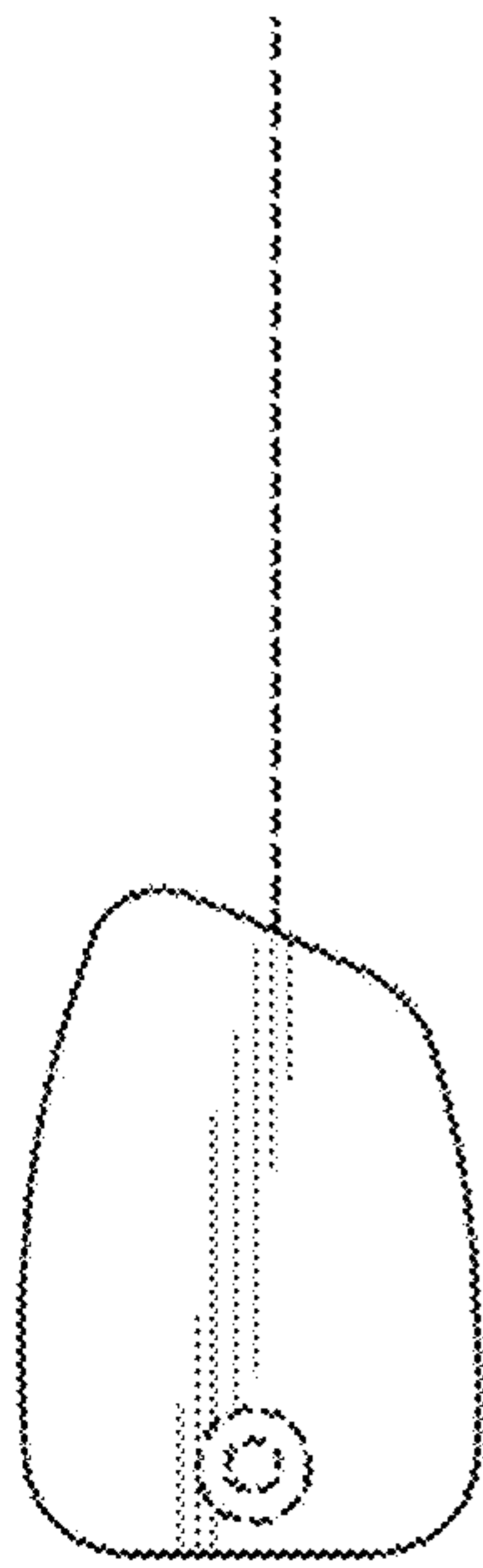

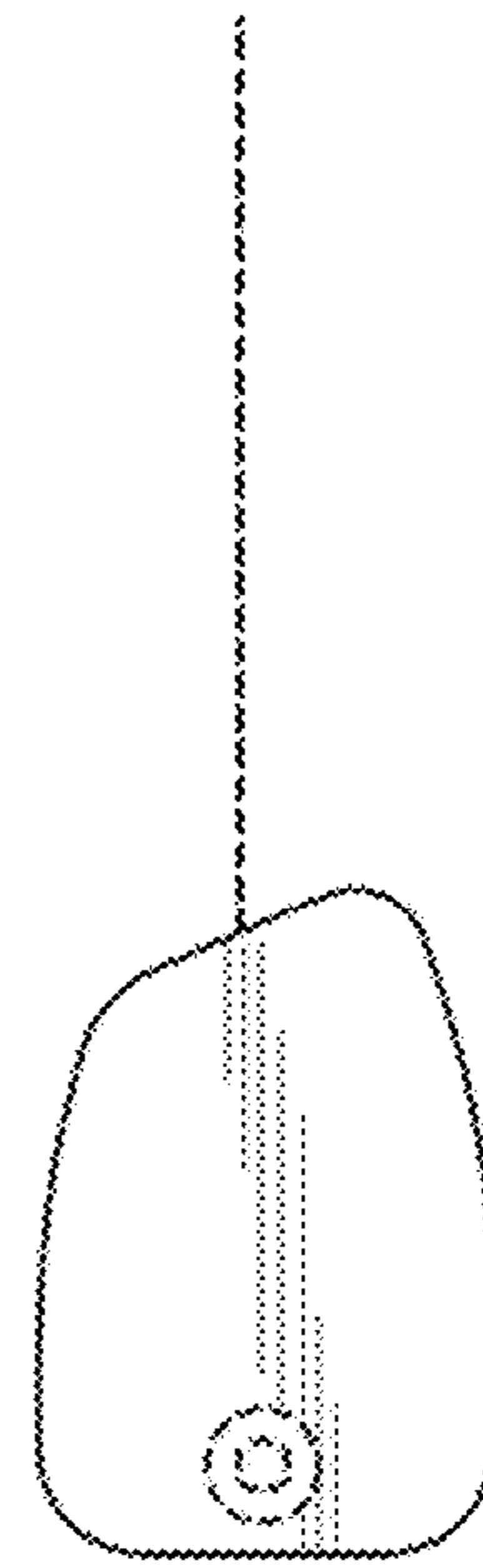
