(57) **CLAIM**

I claim the ornamental design for the pillow with pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and left side perspective view of part of a pillow with pocket, with a closed laptop or tablet computer shown in broken lines being held inside of the pillow apparatus, in accordance with an embodiment of the present invention;

FIG. 2 is a front elevational view of the pillow with pocket of FIG. 1, with the closed laptop or tablet computer shown in broken lines being held inside of the pillow apparatus;

FIG. 3 is a rear elevational view of the pillow with pocket of FIG. 1;

FIG. 4 is a left side elevational view of the pillow with pocket of FIG. 1;

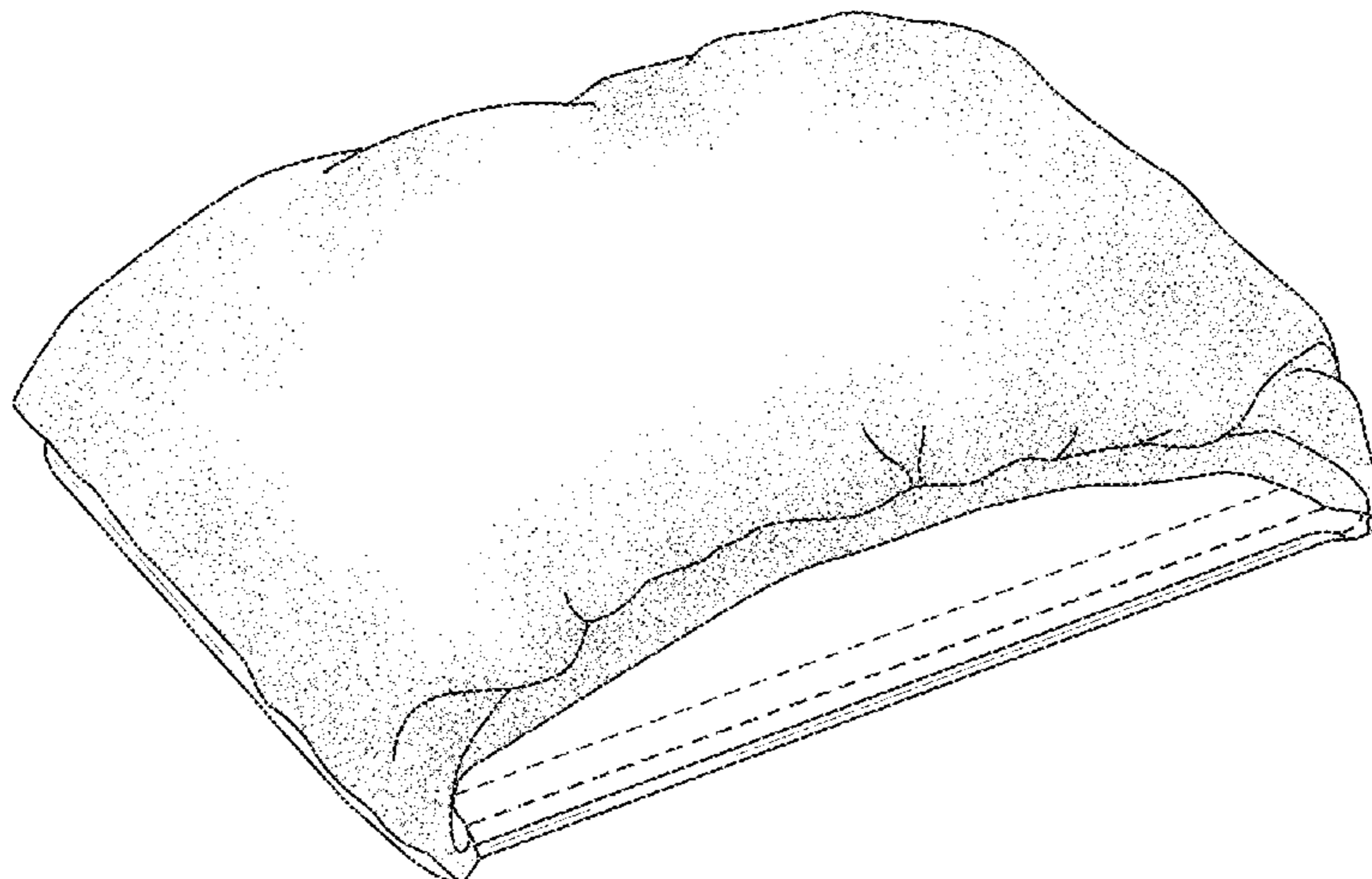
FIG. 5 is a right side elevational view of the pillow with pocket of FIG. 1;

FIG. 6 is a top elevational view of the pillow with pocket of FIG. 1, with part of the closed laptop or tablet computer shown in broken lines; and,

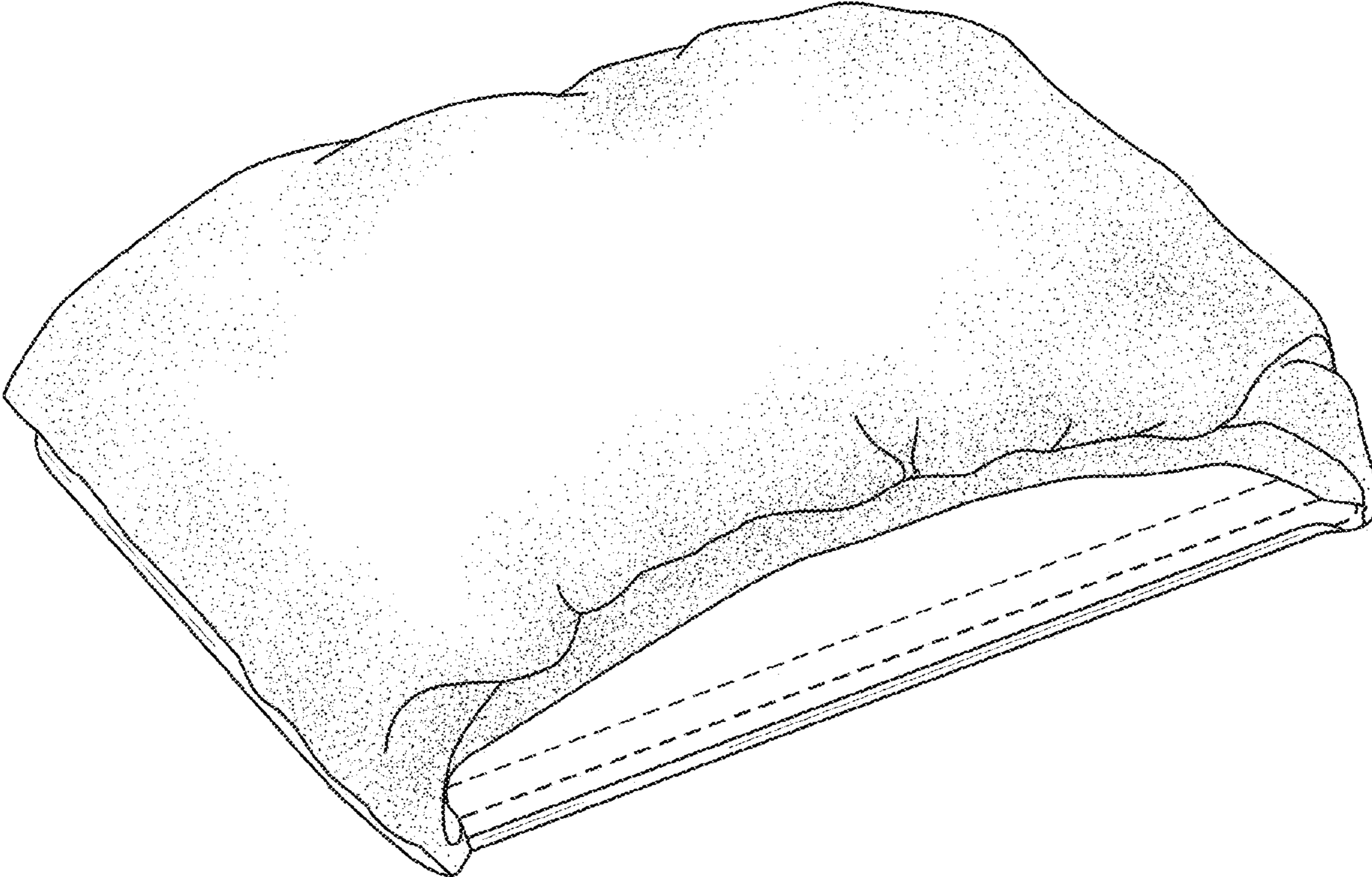

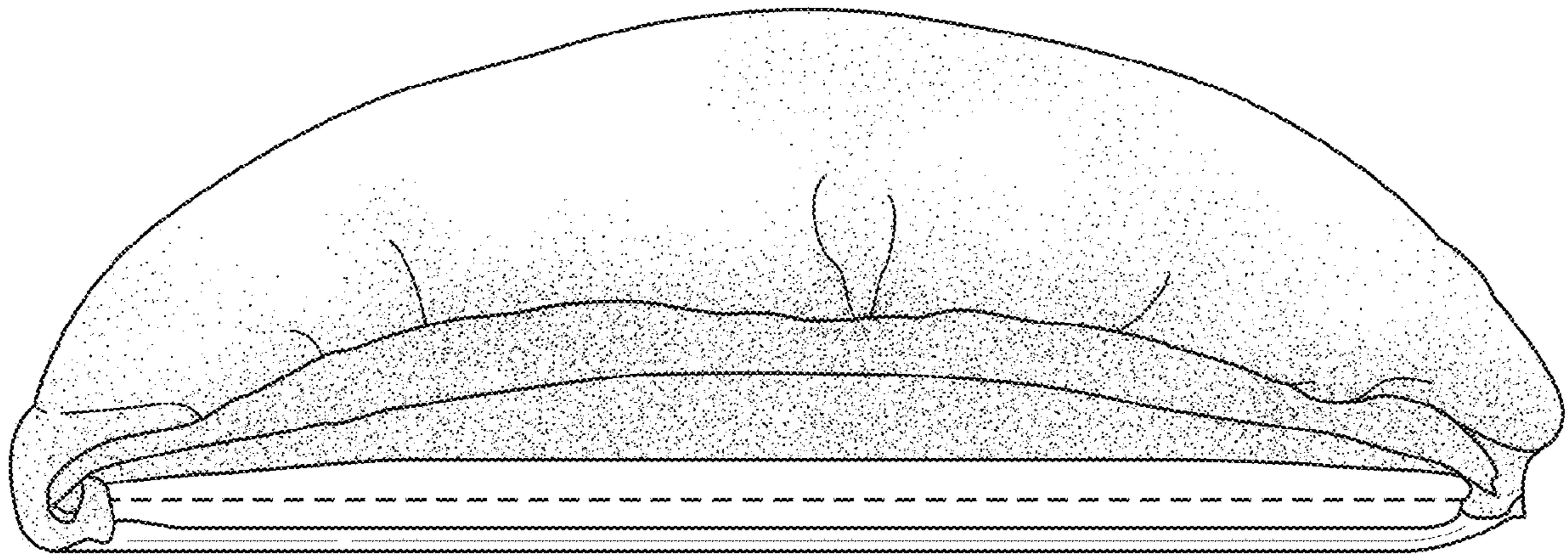

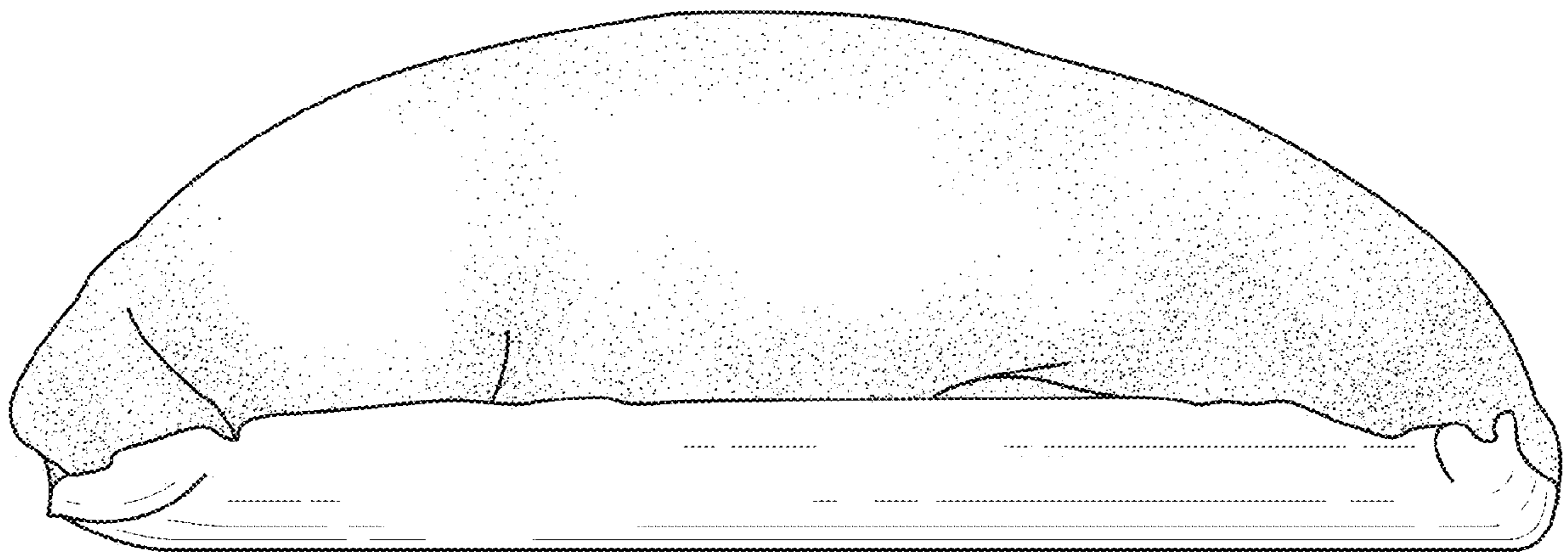

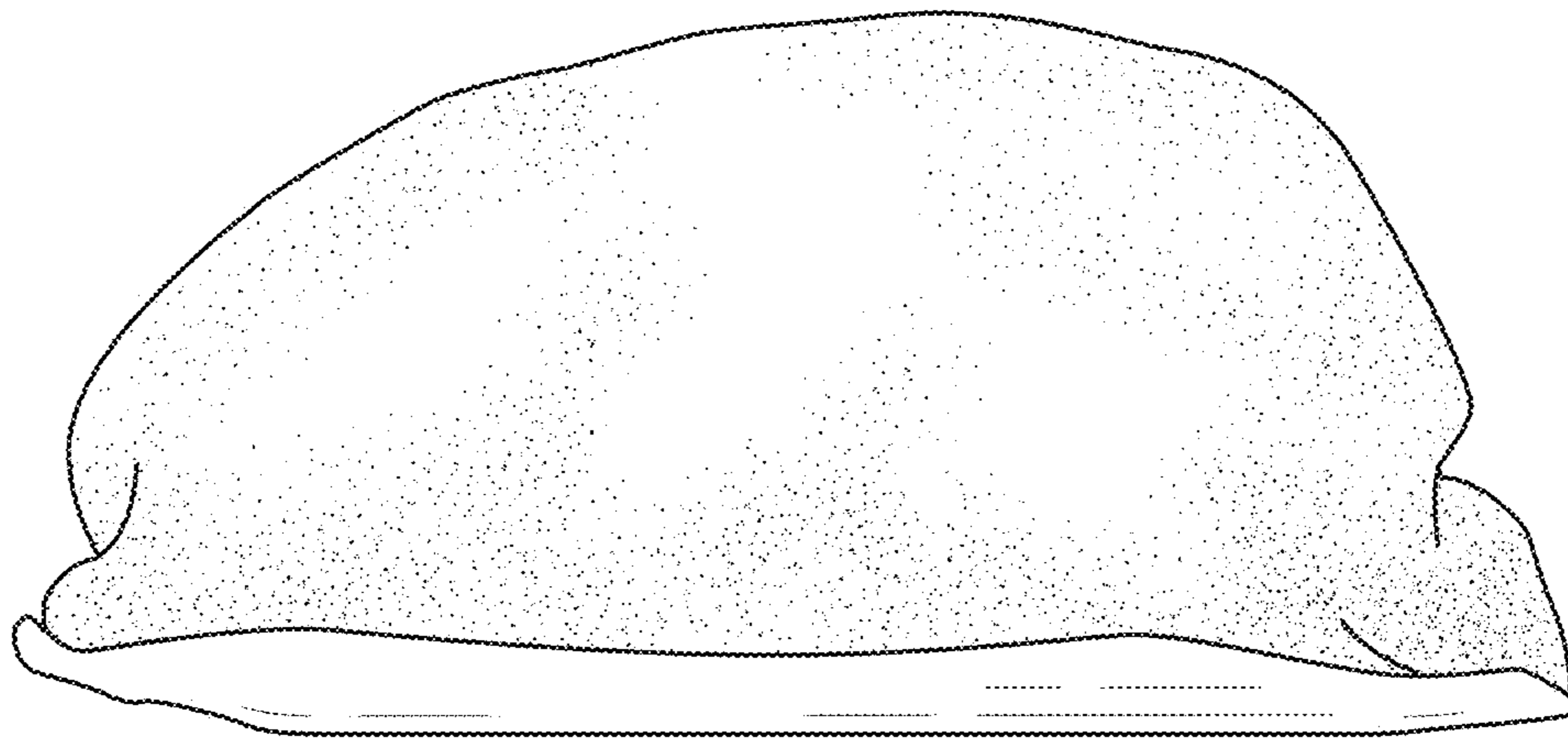

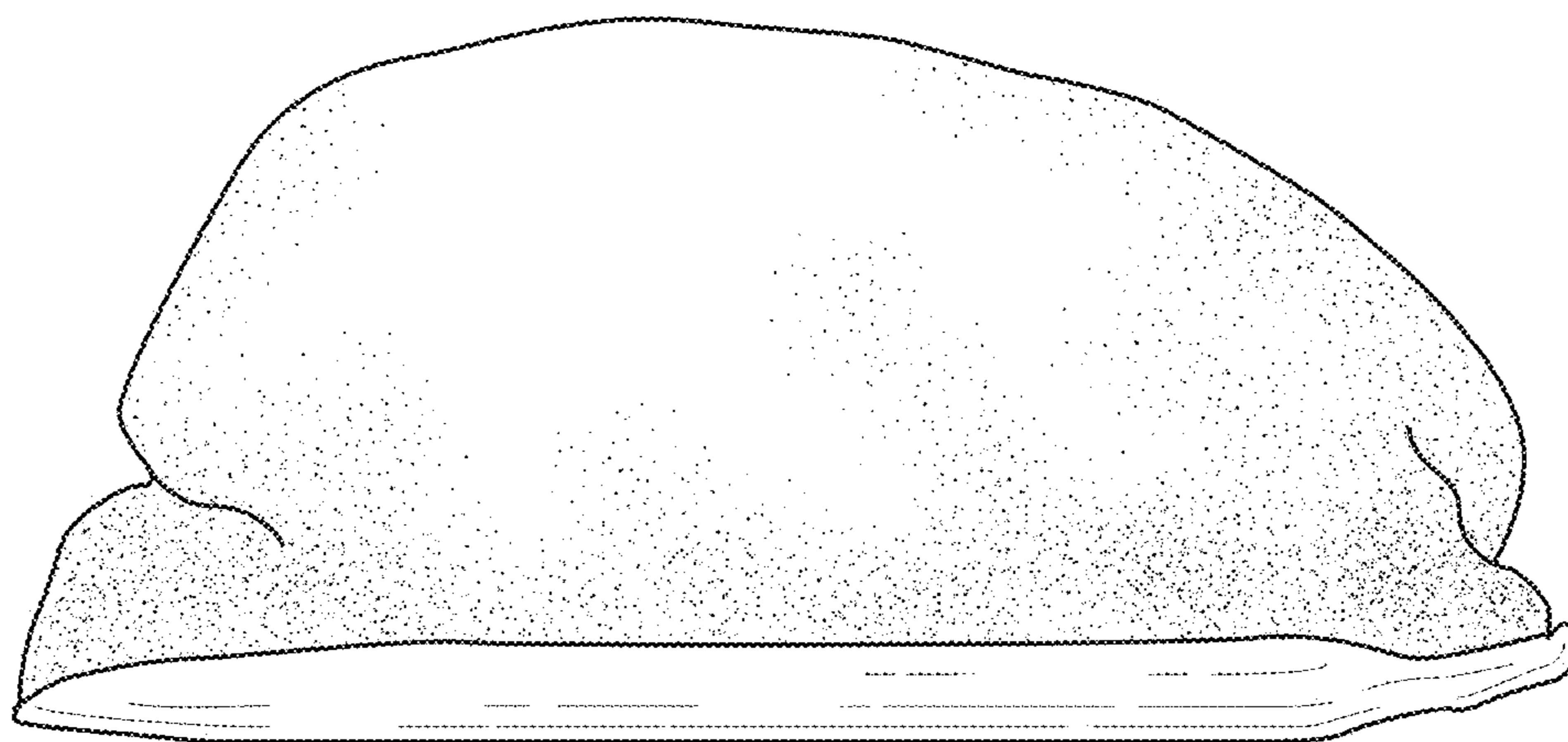

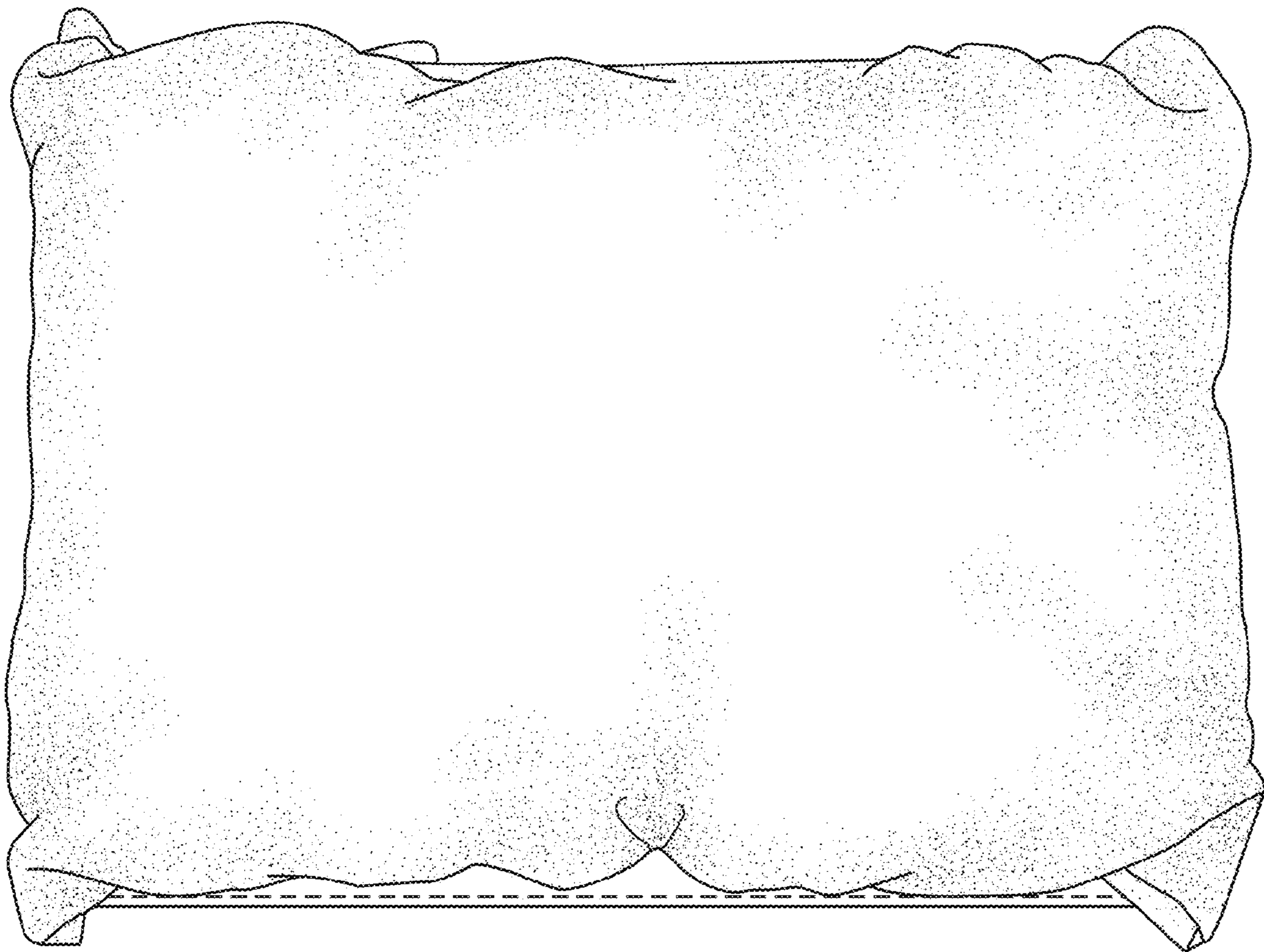

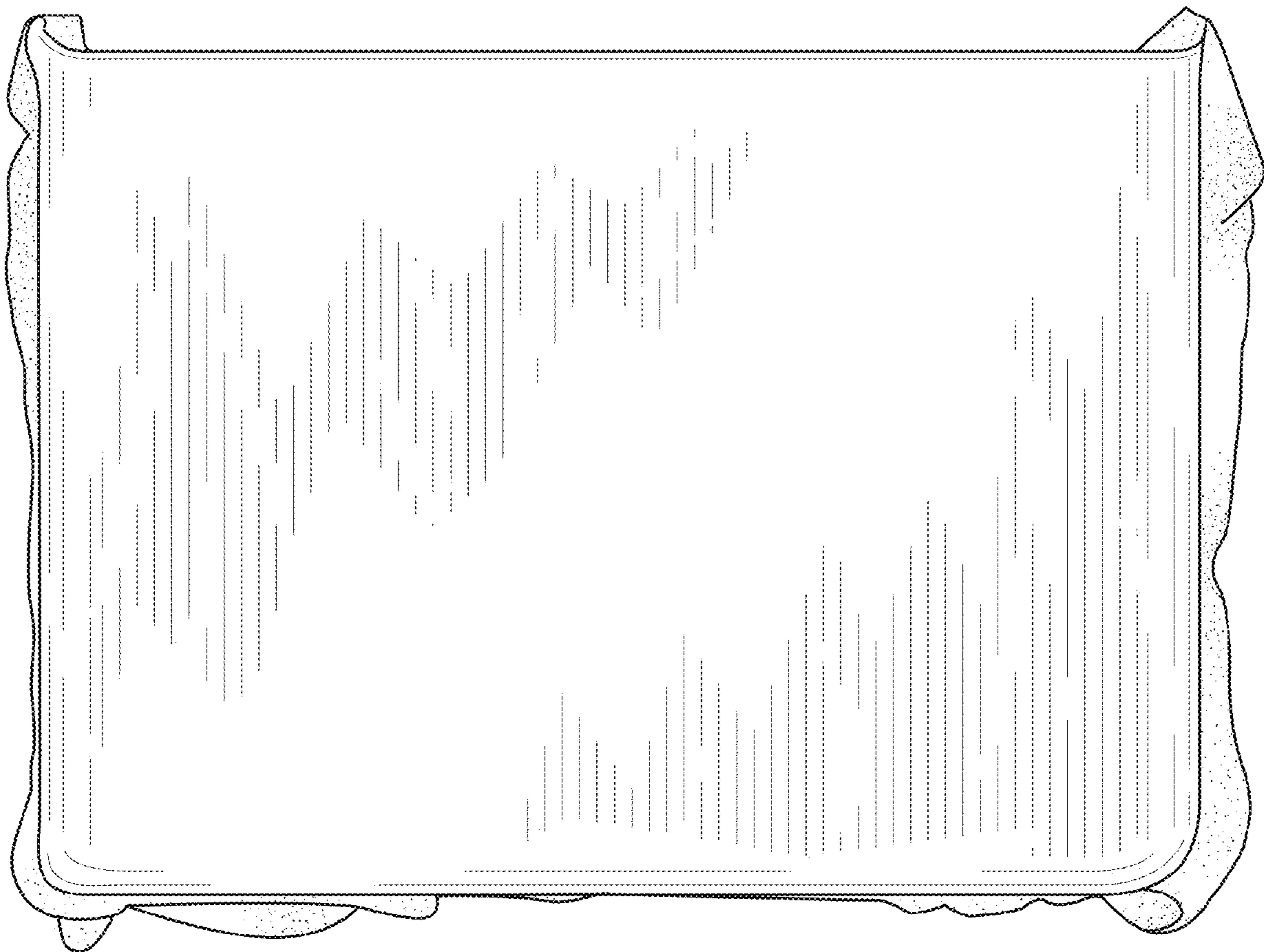
