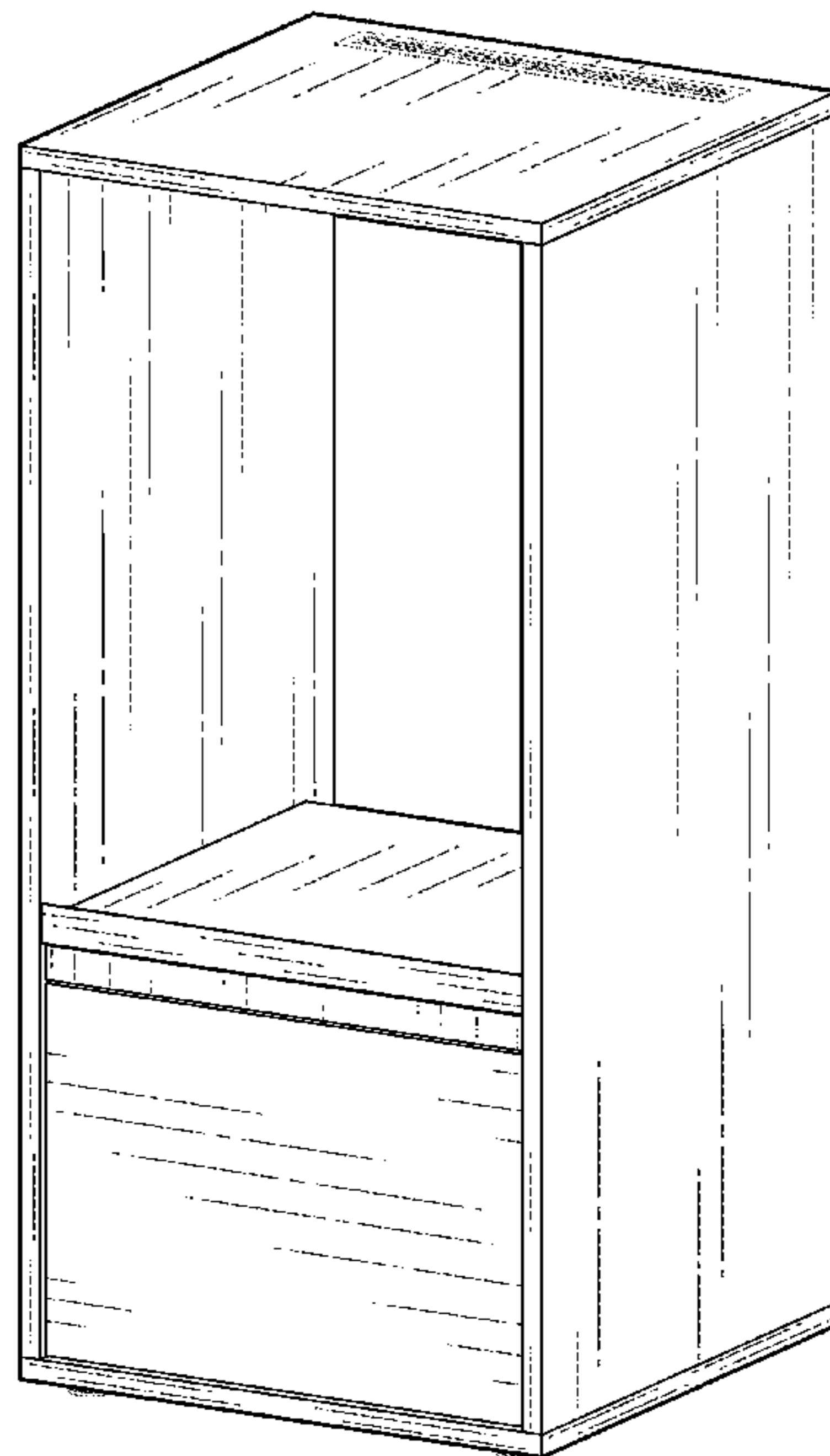

The ornamental design for a furniture, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a furniture, showing my new design;
FIG. 2 is a top, front, left side perspective view thereof;
FIG. 3 is a top, rear, right side perspective view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a cross-section view thereof taken along line 7-7 in FIG. 4.

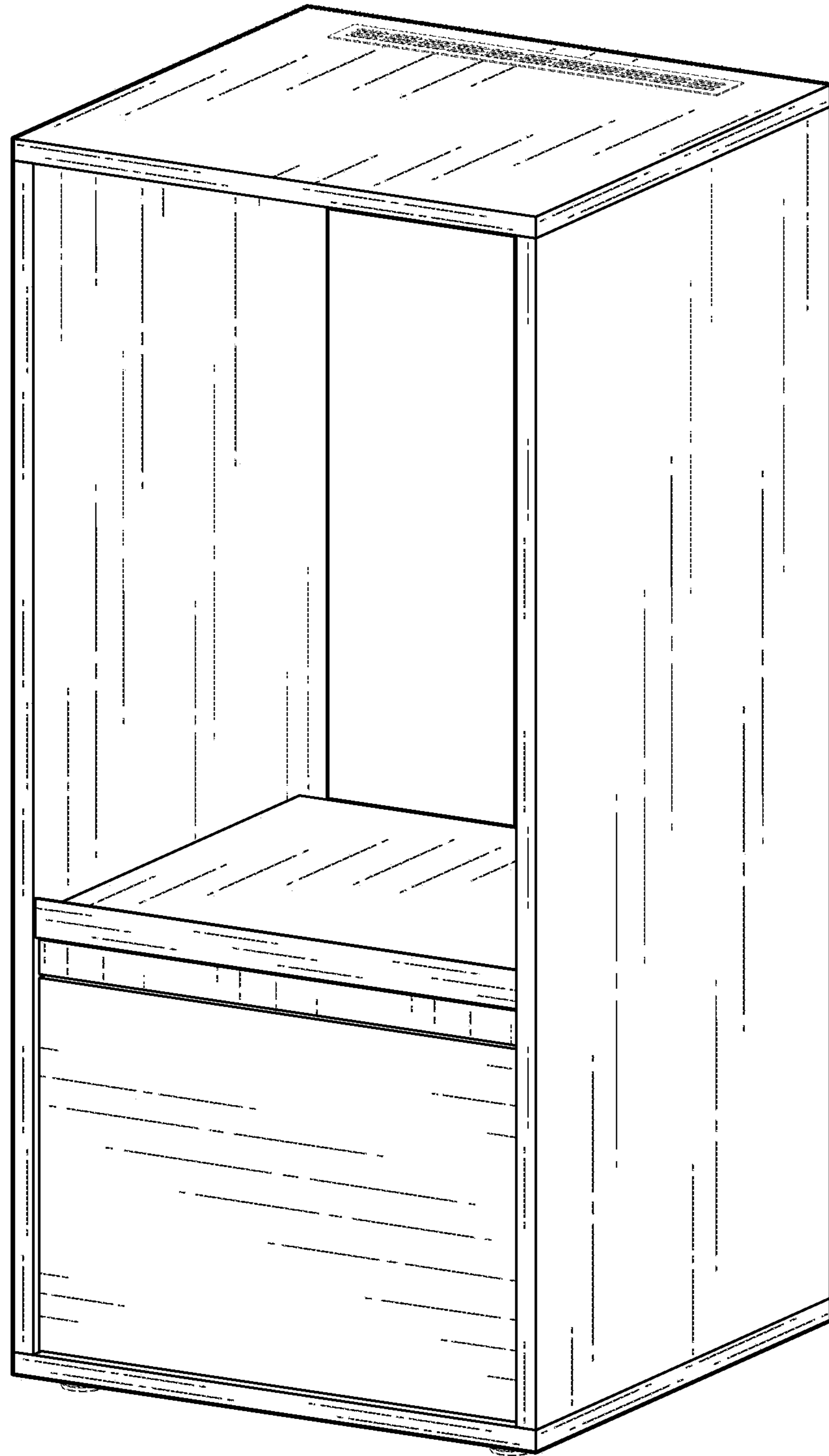

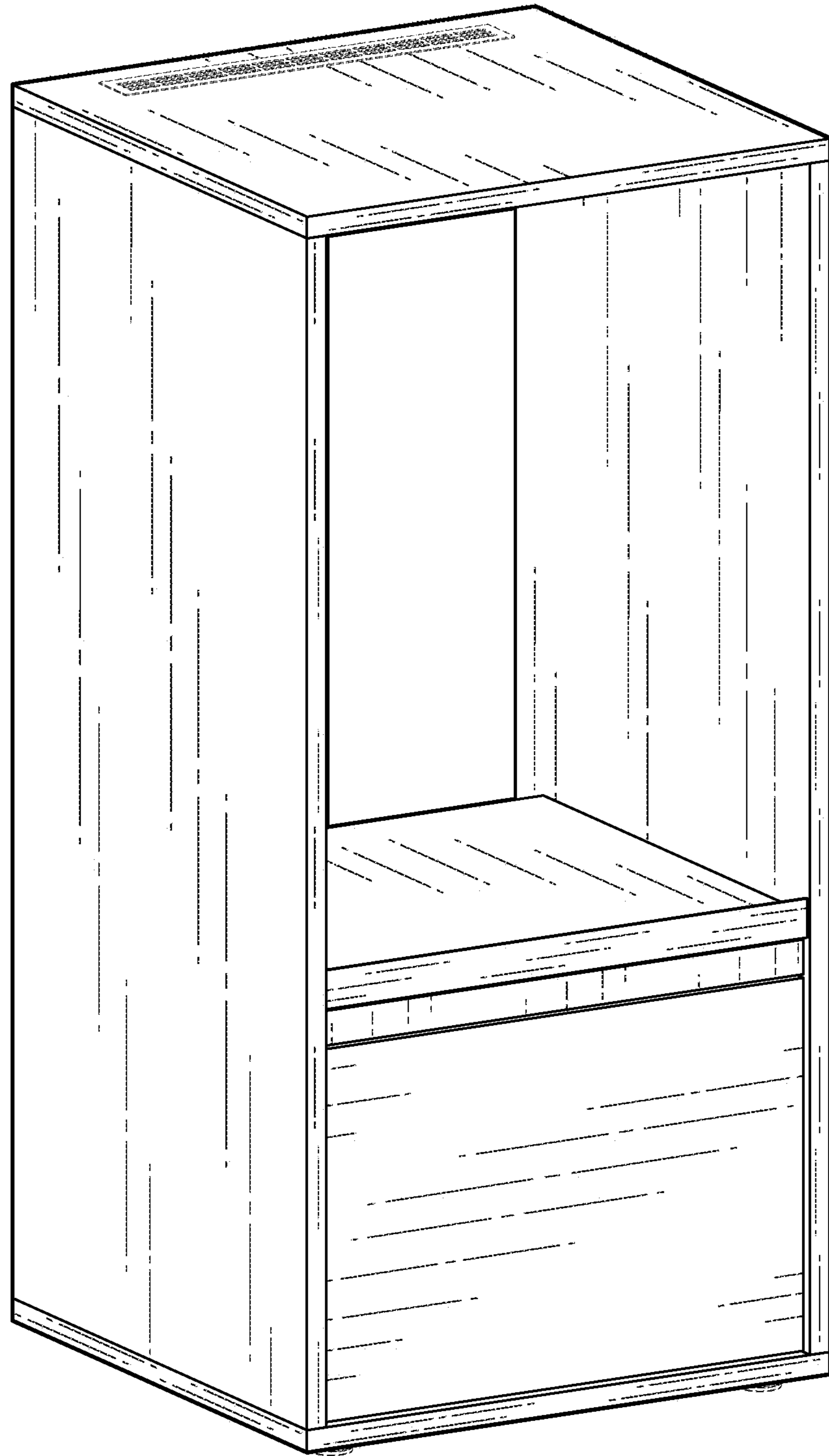

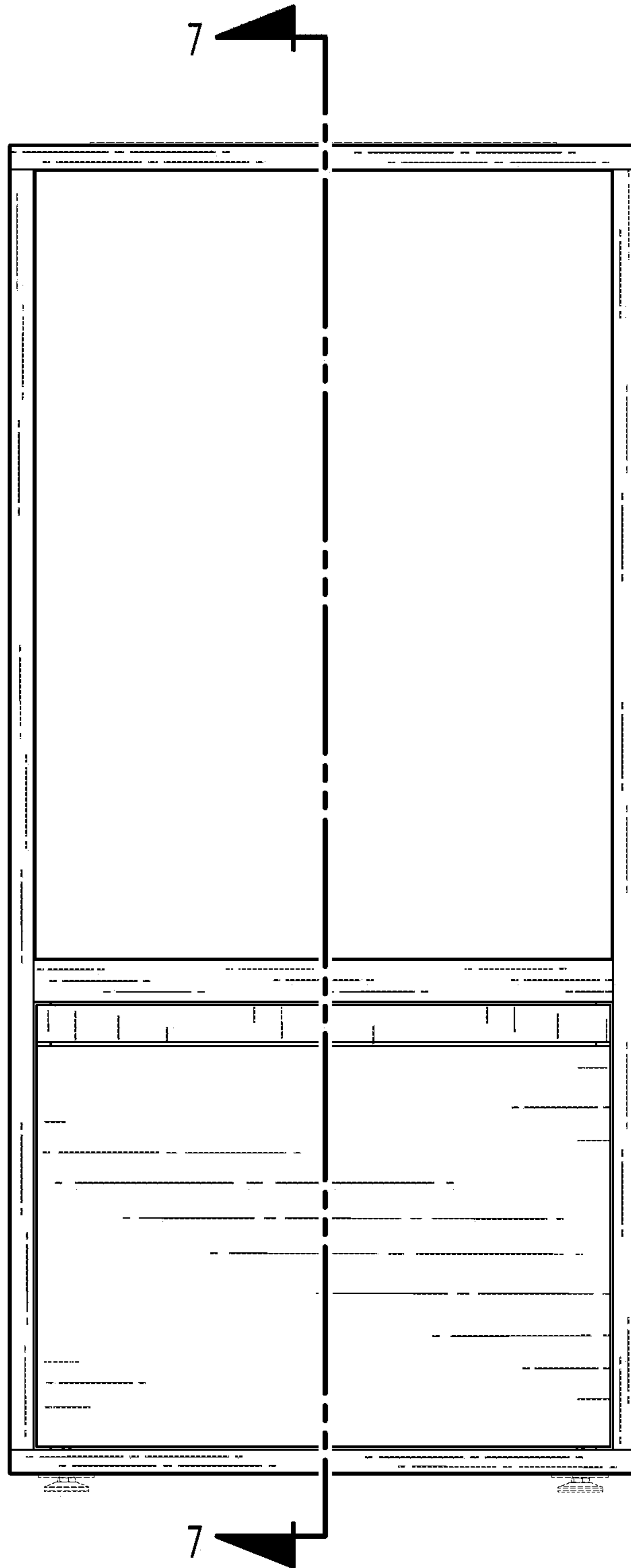

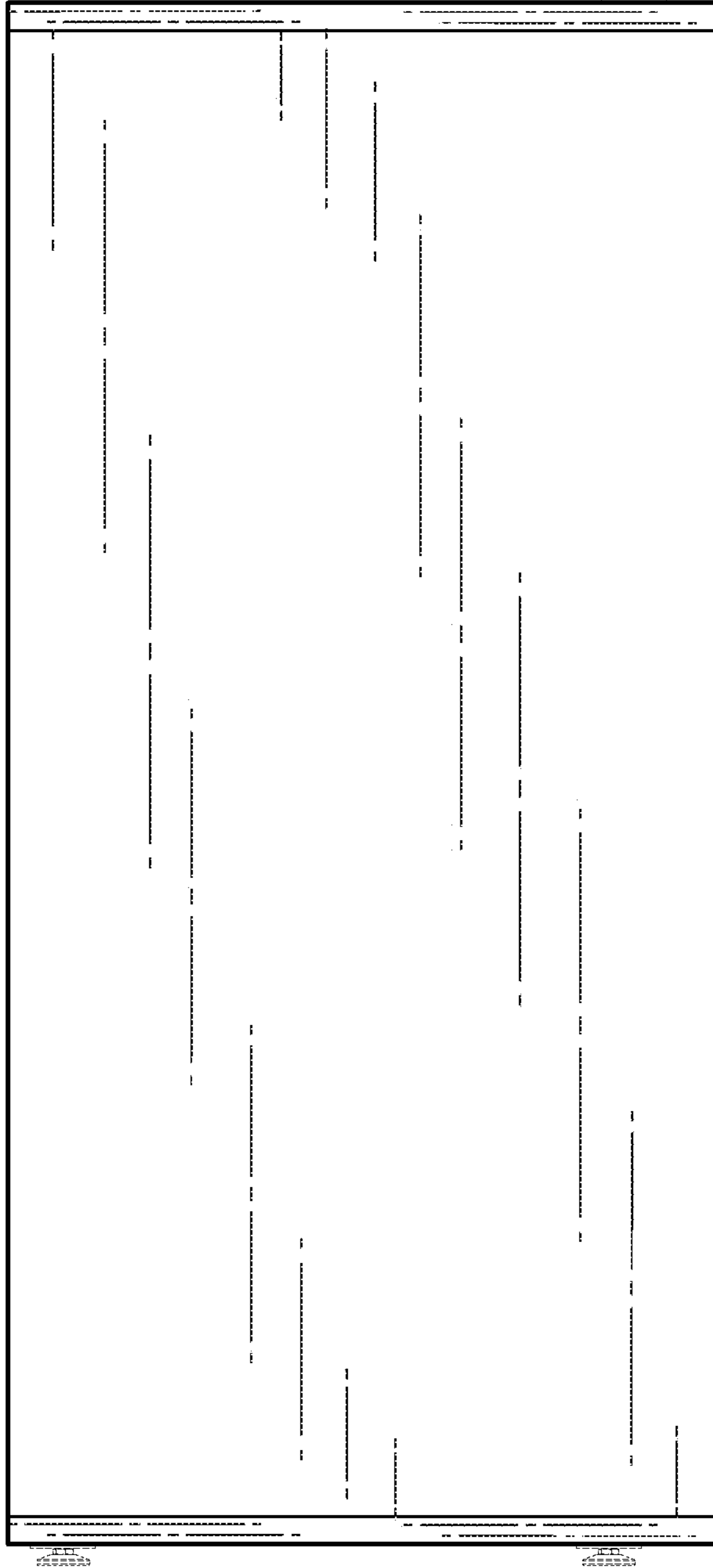

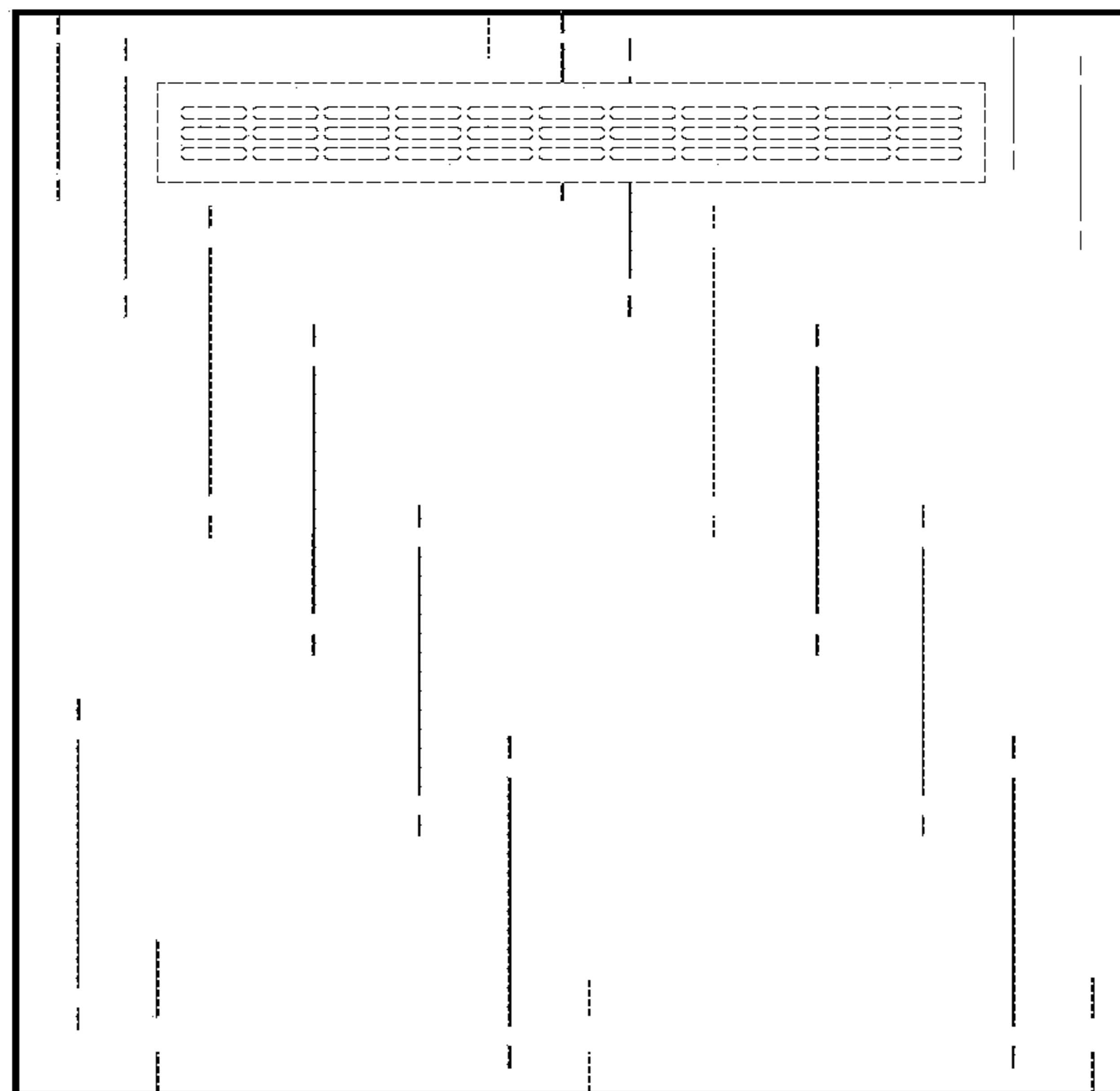

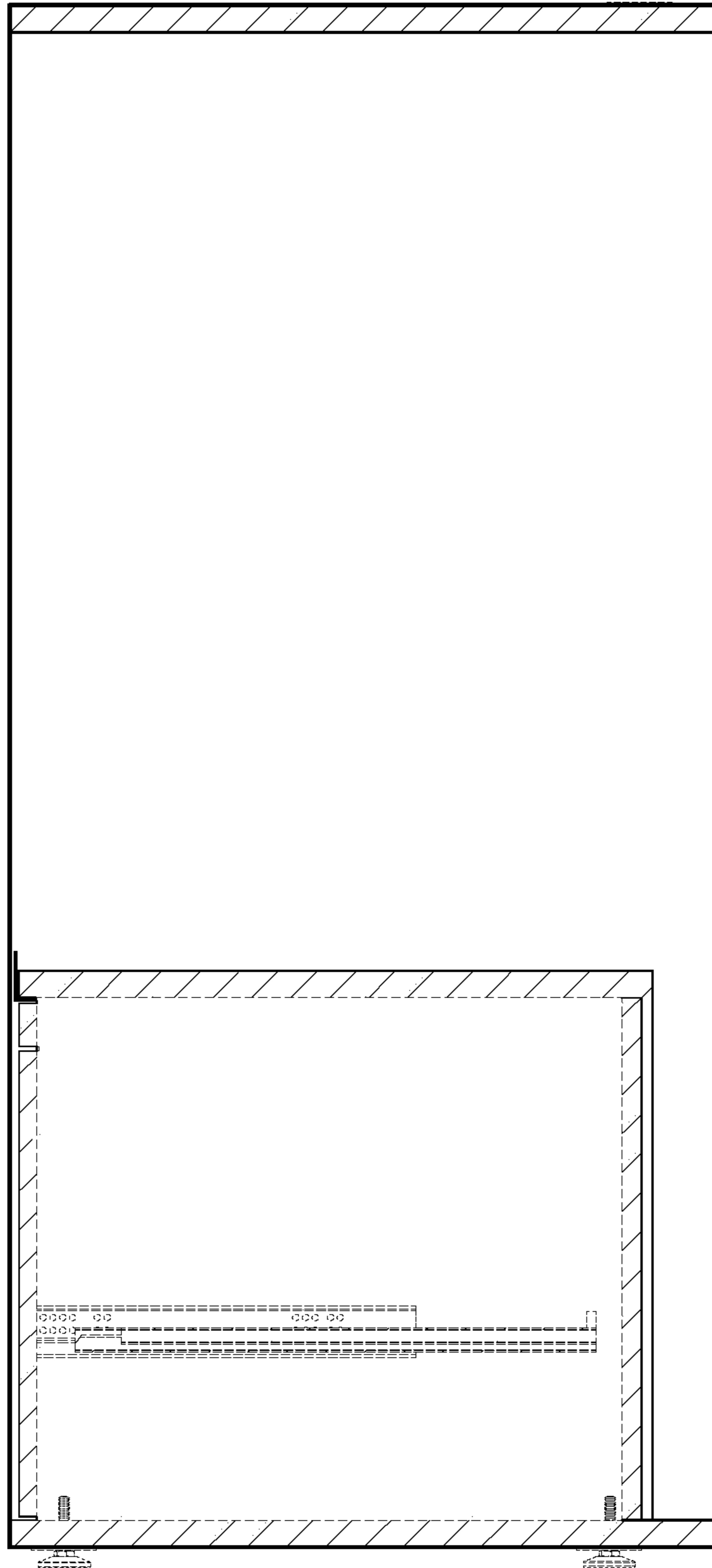
