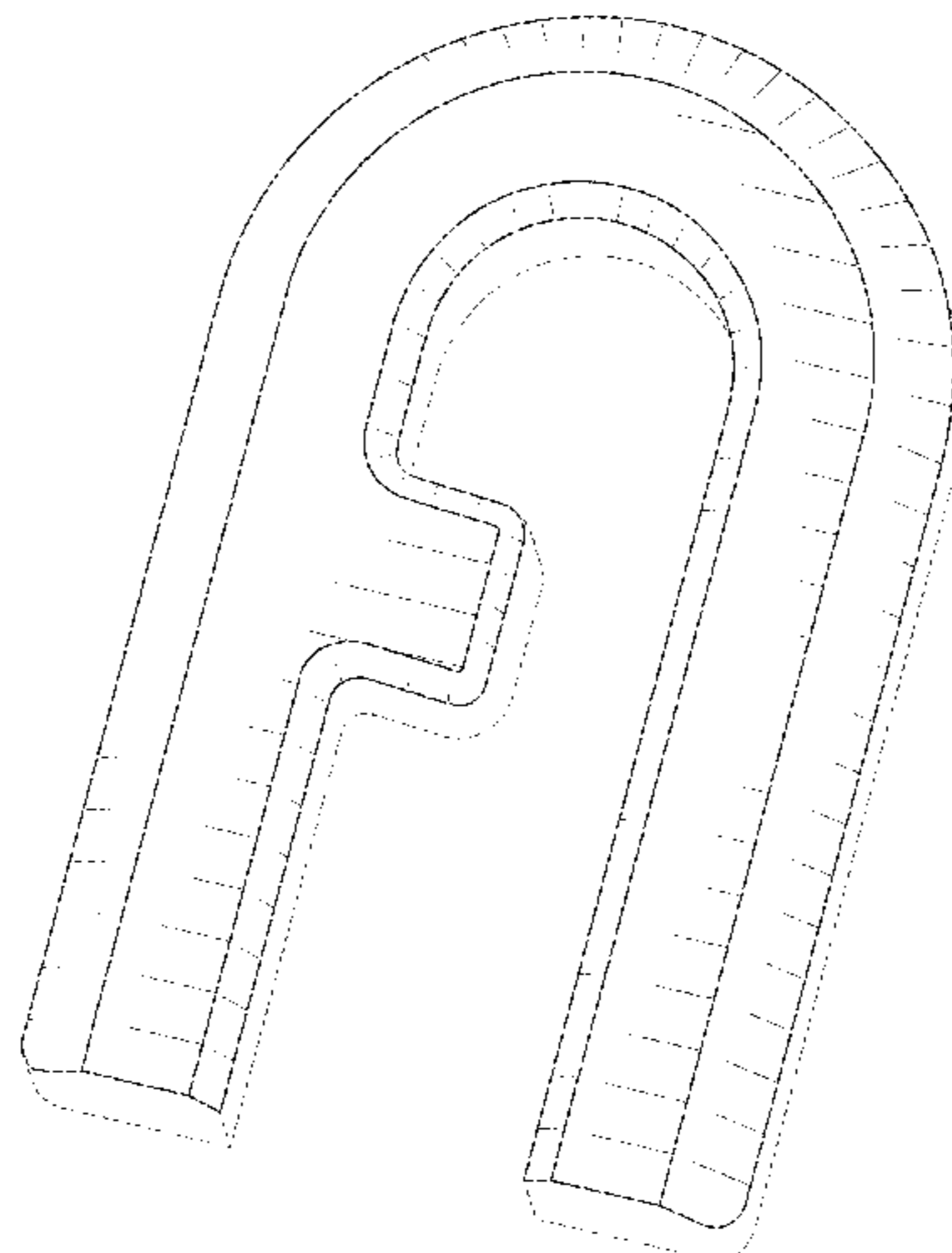

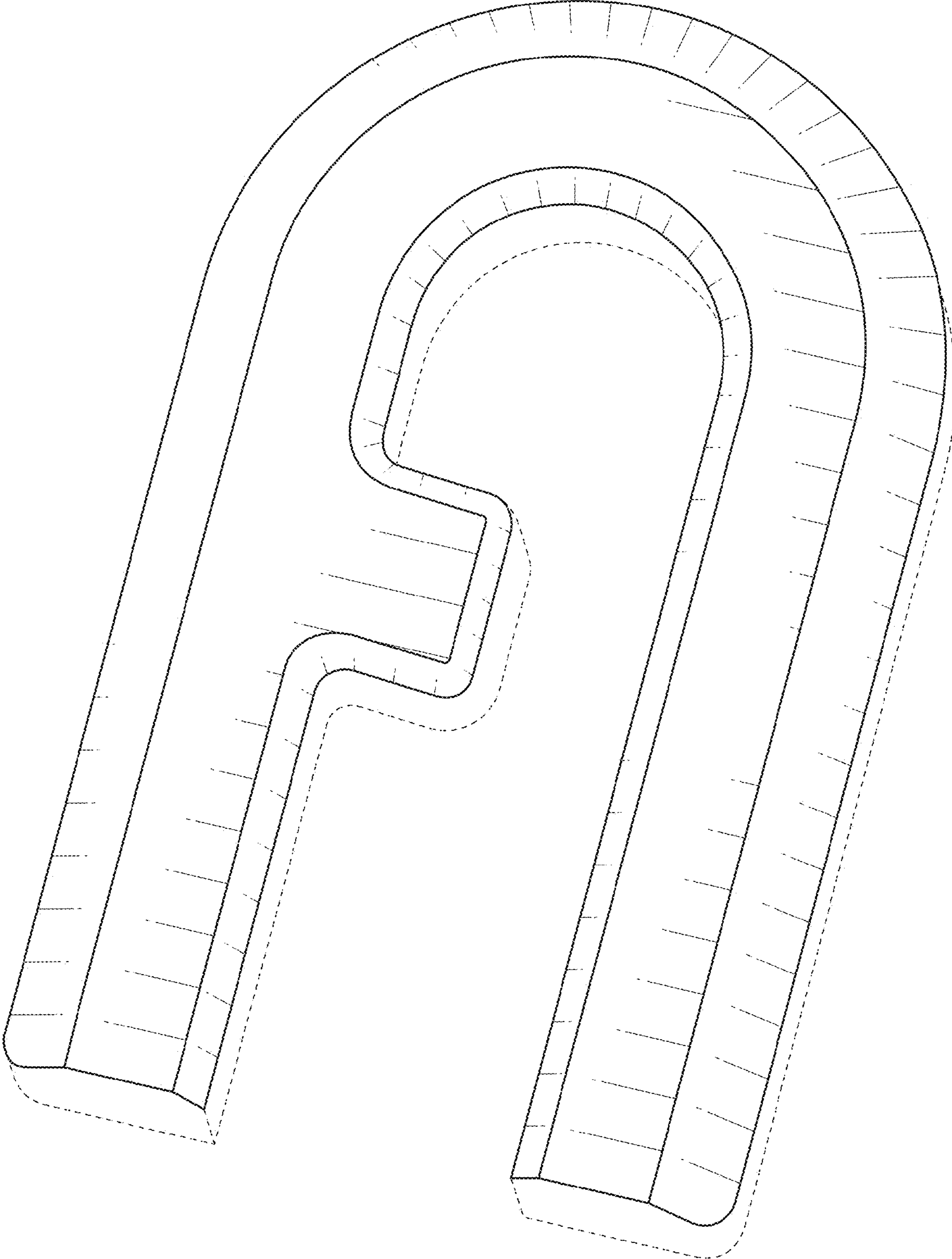

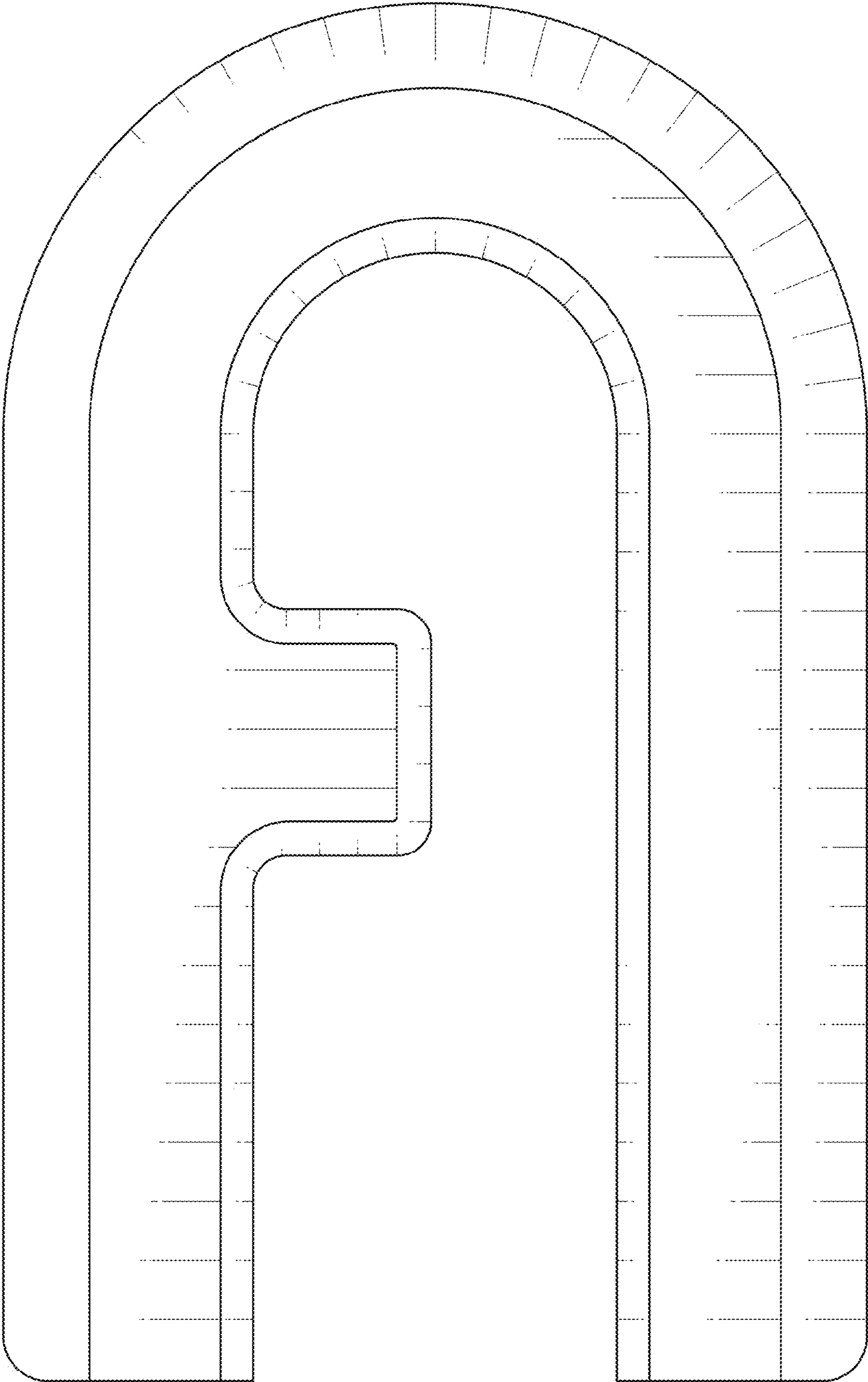

- 1.7 : Bottom

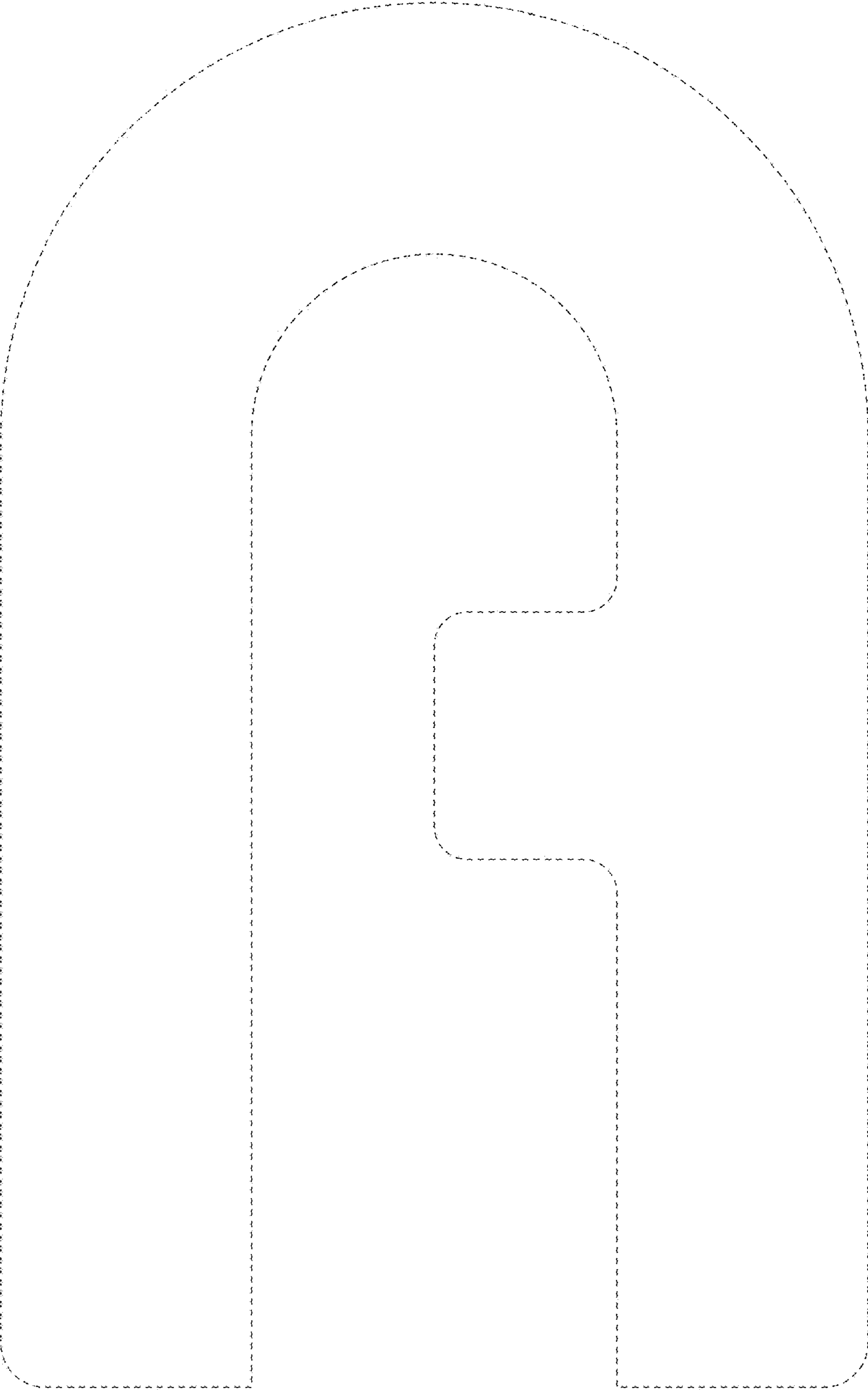
The dashed broken lines in the views depict portions of the buckle which form no part of the claim.

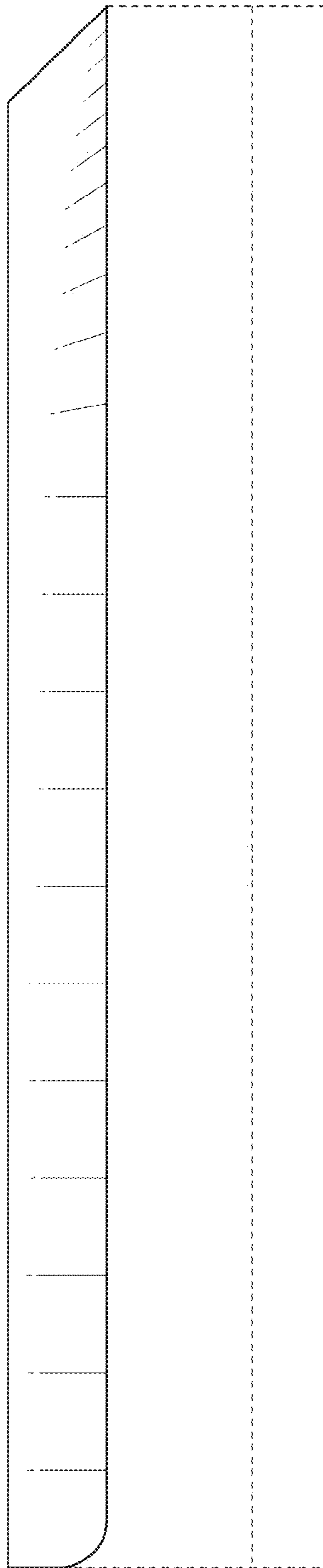

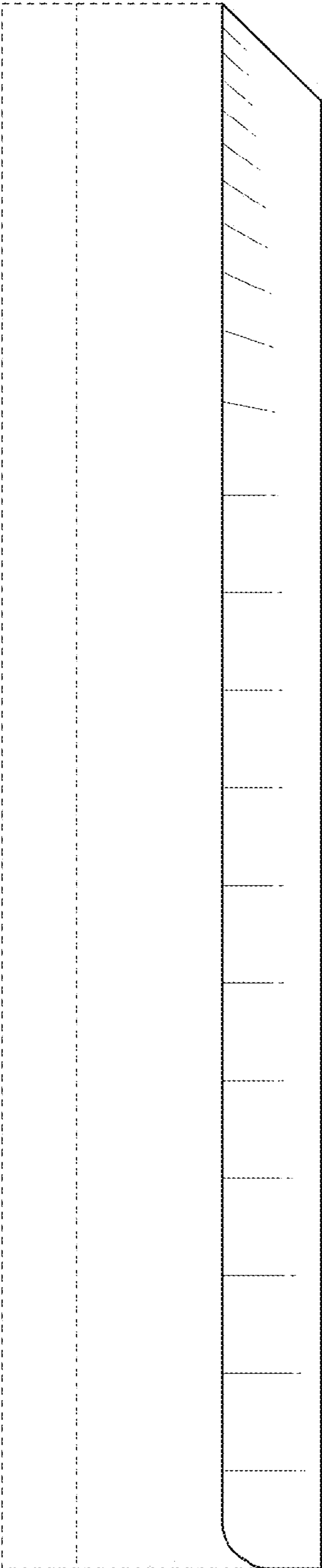


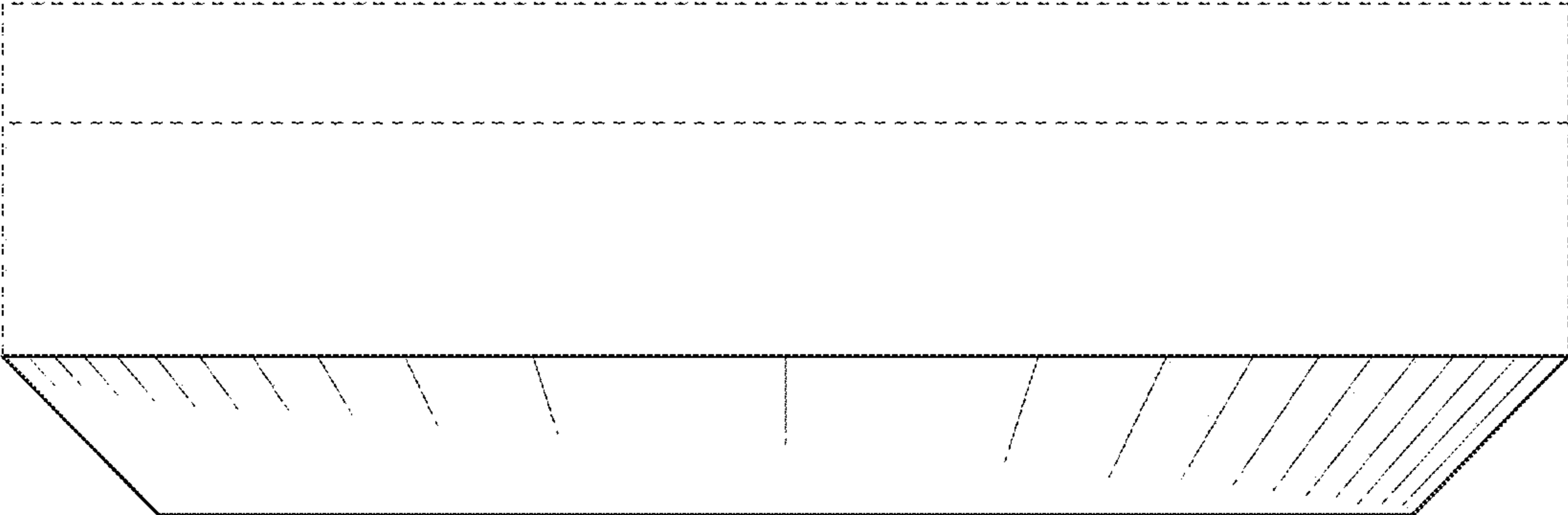




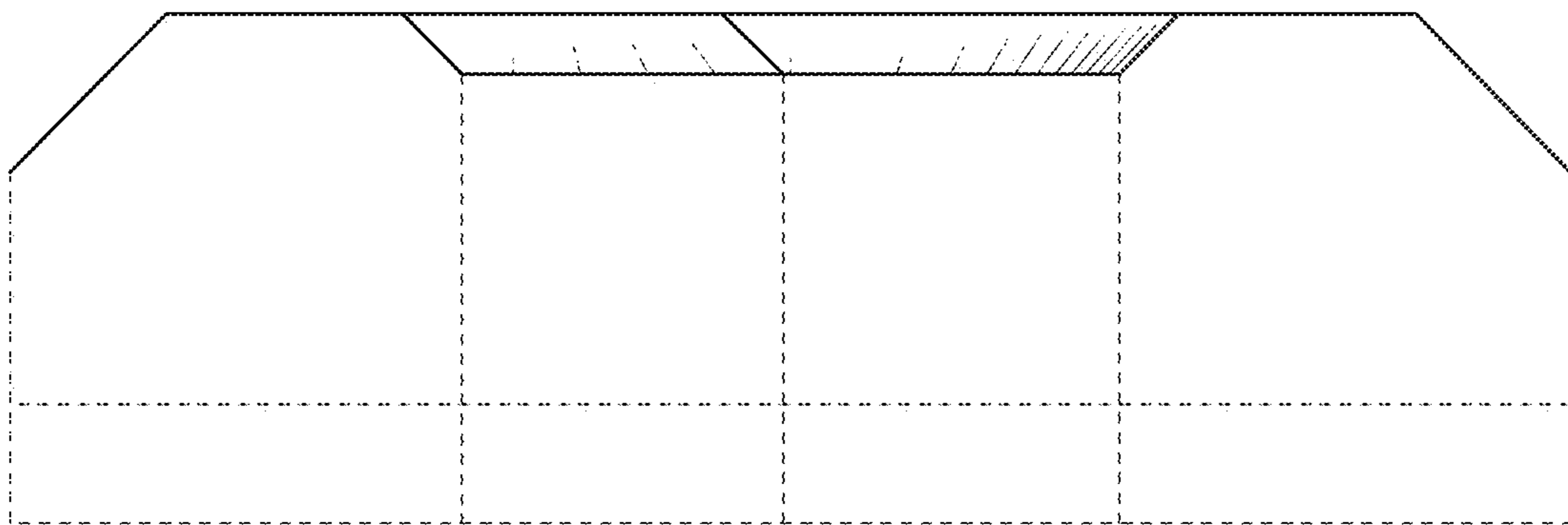
