(57) **CLAIM**

I claim the ornamental design for a wheel for an automobile, as shown and described.

**DESCRIPTION**

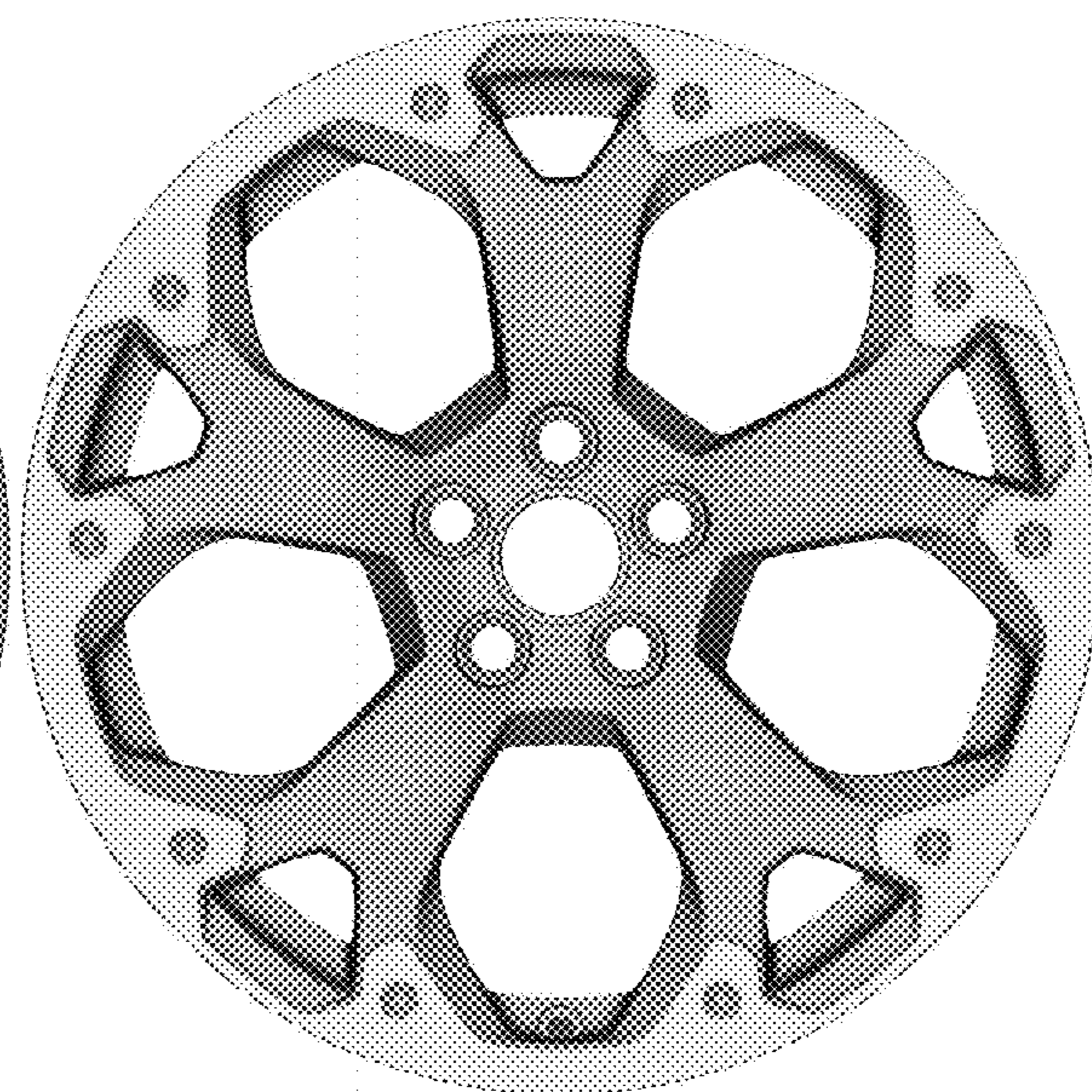

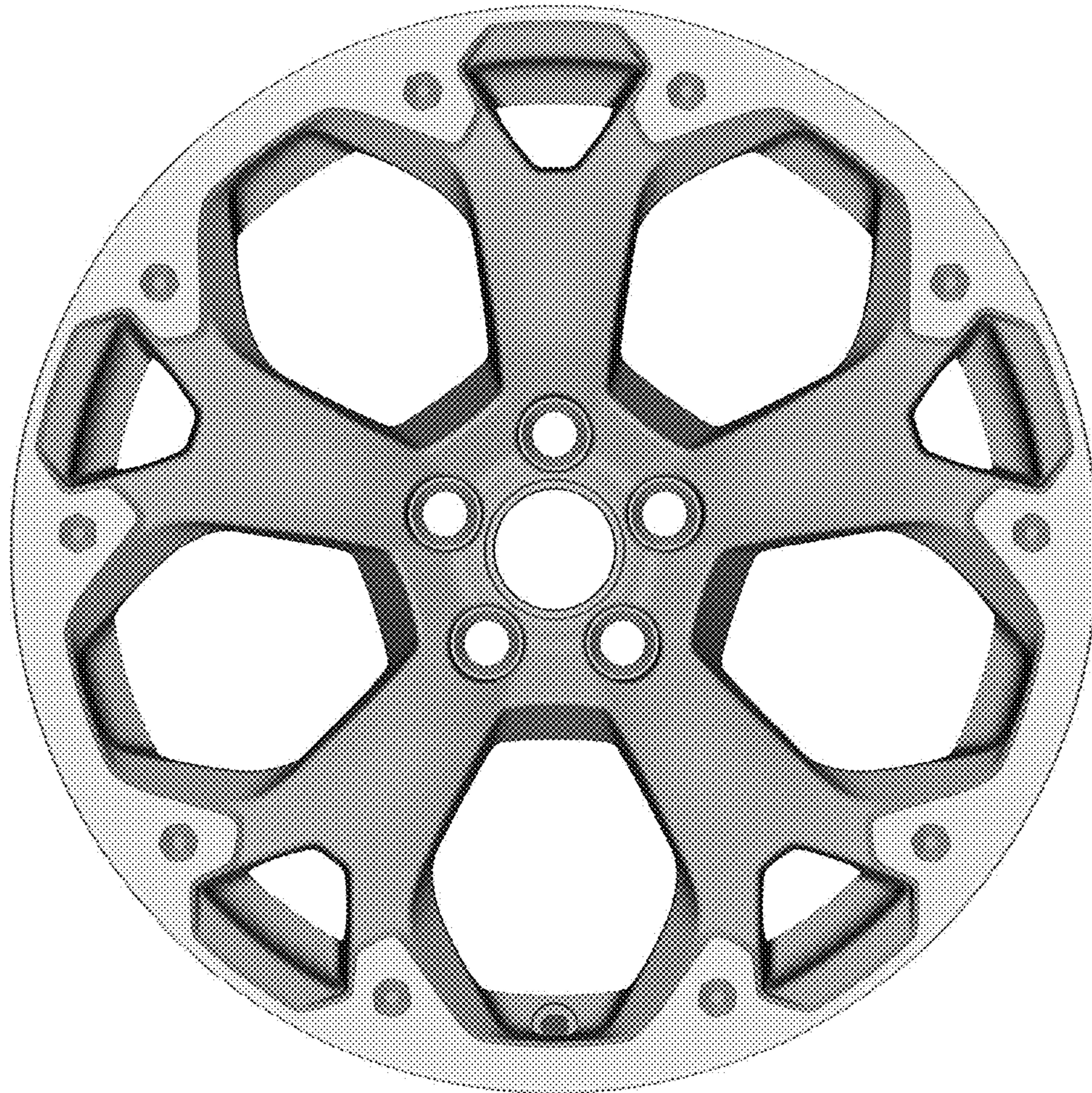

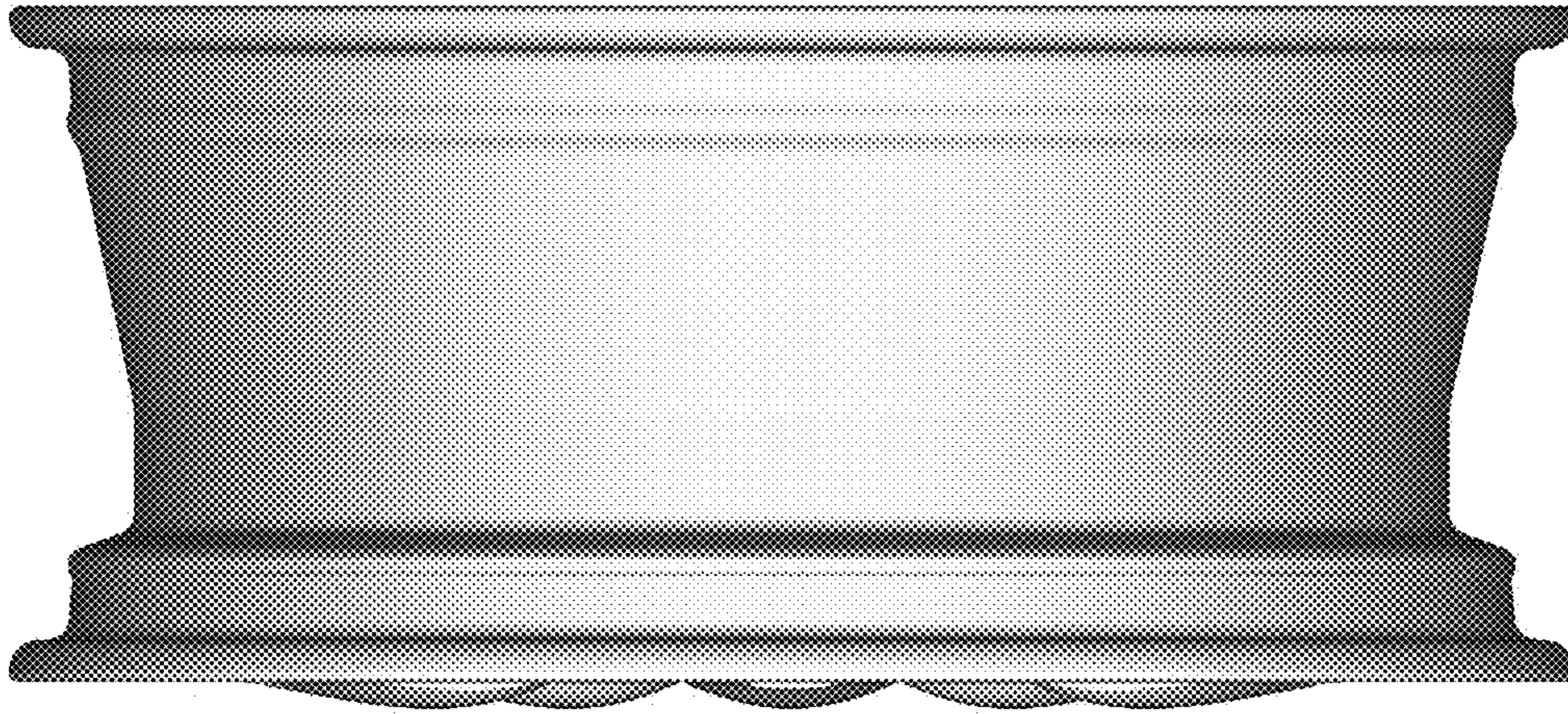

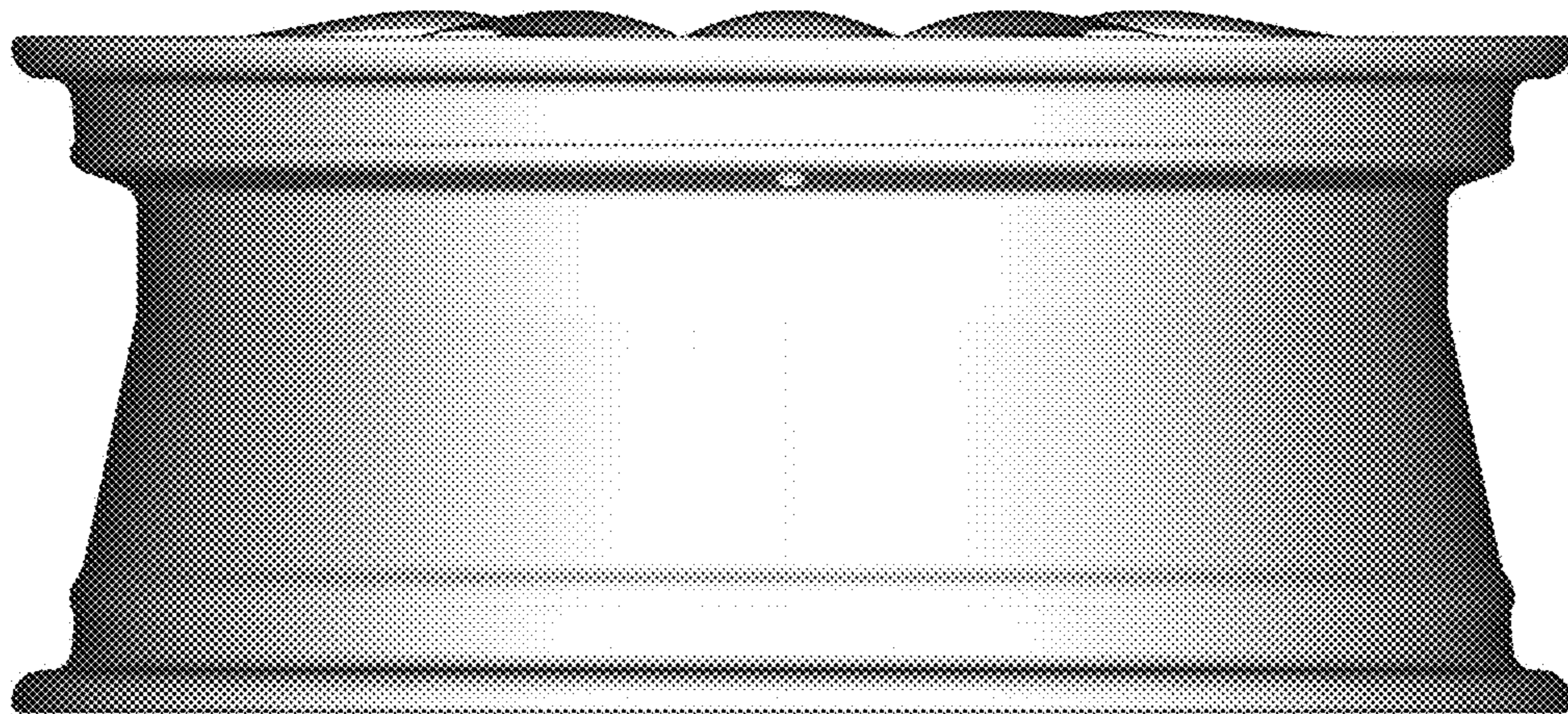

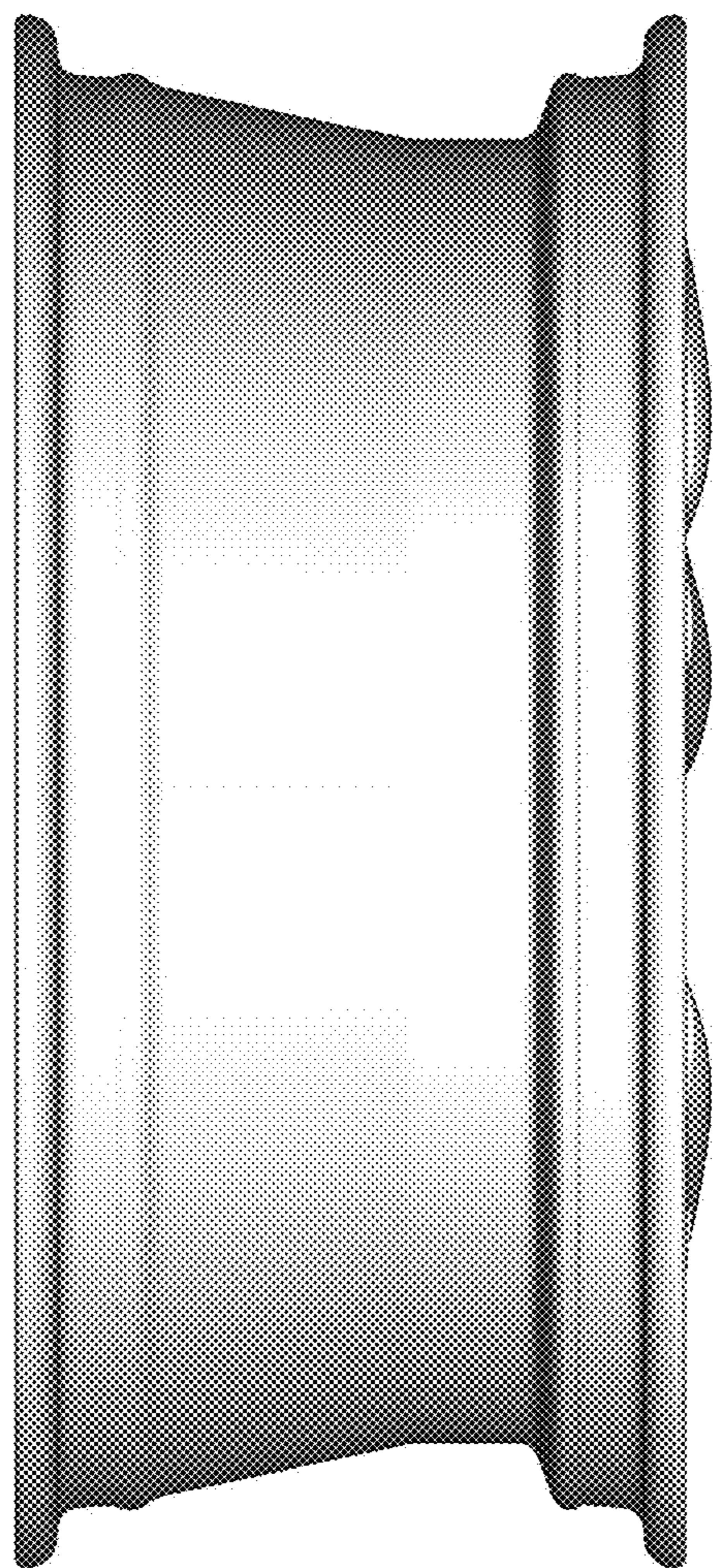
