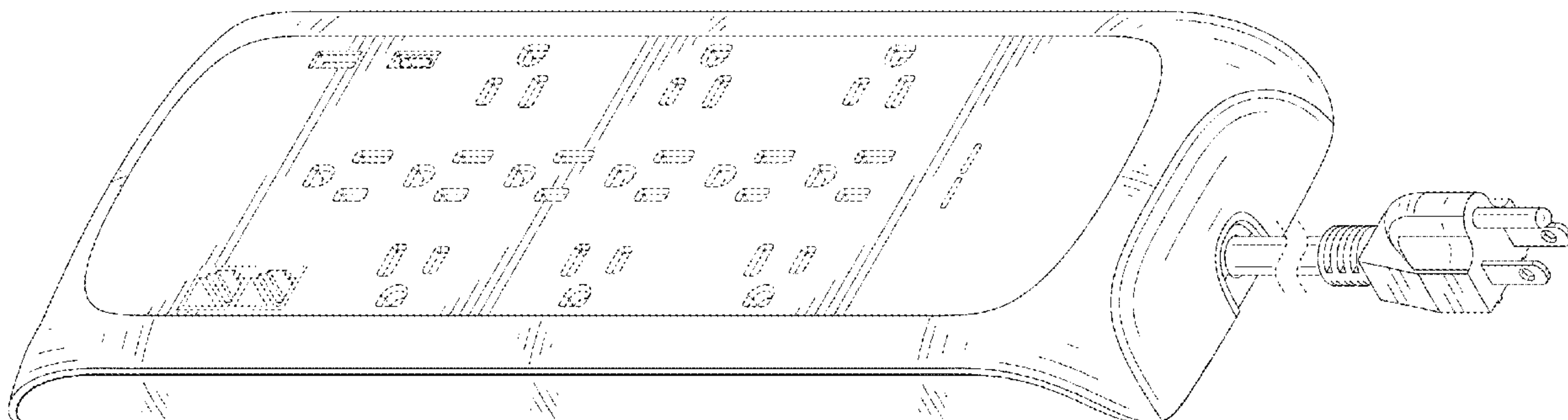
(57) **CLAIM**

I claim the ornamental design for a socket, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a right end of a socket in accordance with the present design;  
FIG. 2 is a top perspective view of a left end of the socket of FIG. 1;  
FIG. 3 is a bottom perspective view of the left end of the socket of FIG. 1;  
FIG. 4 is a top plan view of the socket of FIG. 1;  
FIG. 5 is a bottom plan view of the socket of FIG. 1;  
FIG. 6 is a back side elevational view of the socket of FIG. 1;  
FIG. 7 is a front side elevational view of the socket of FIG. 1;  
FIG. 8 is a right end elevational view of the socket of FIG. 1; and,  
FIG. 9 is a left end elevational view of the socket of FIG. 1. The broken away symbols shown in the drawings indicate that the appearance of any portion of the article between the break lines forms no part of the claimed design.

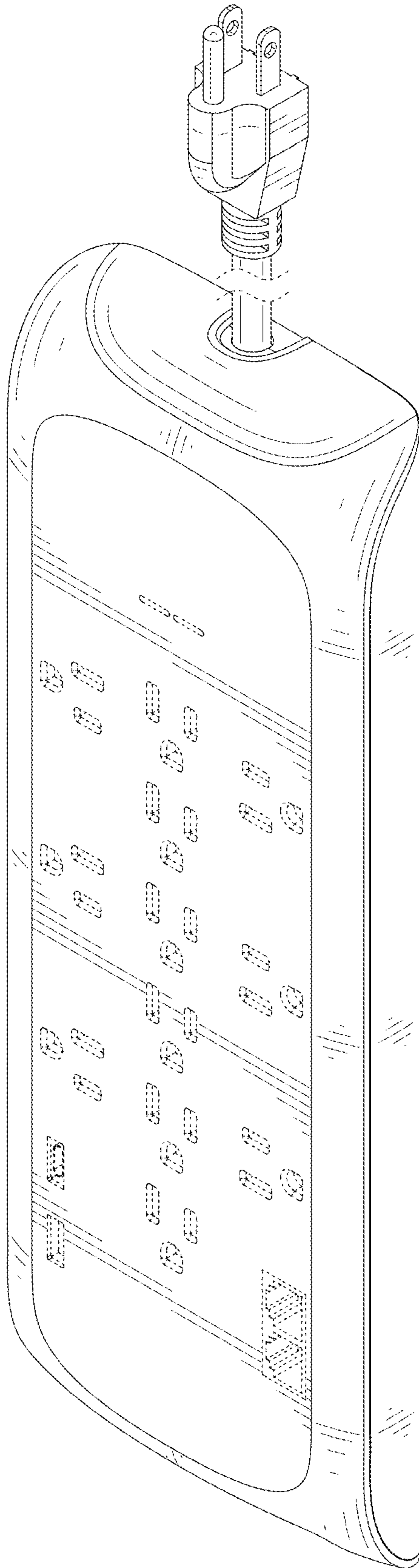

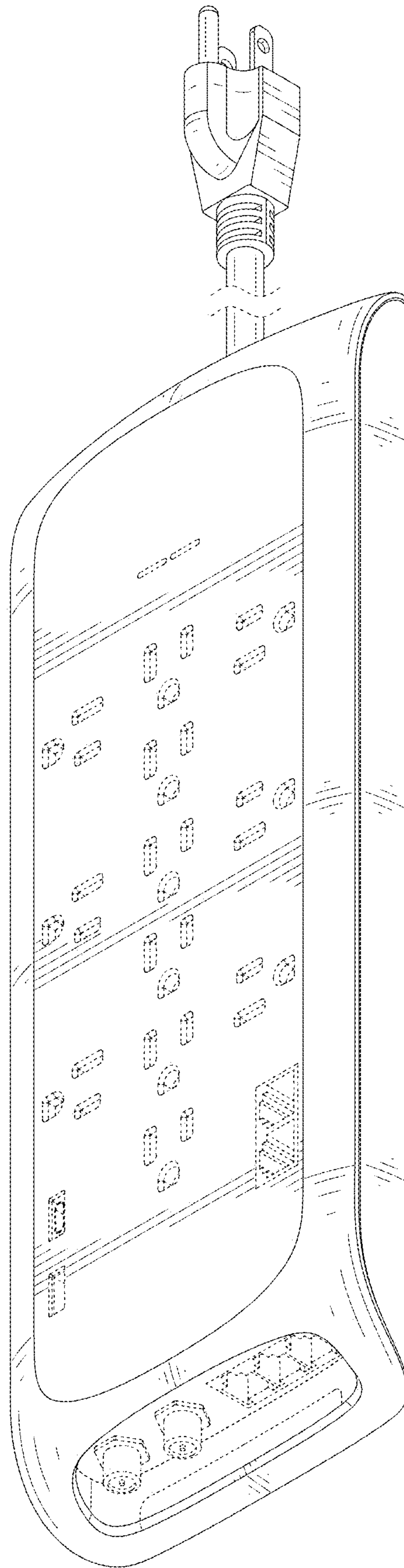

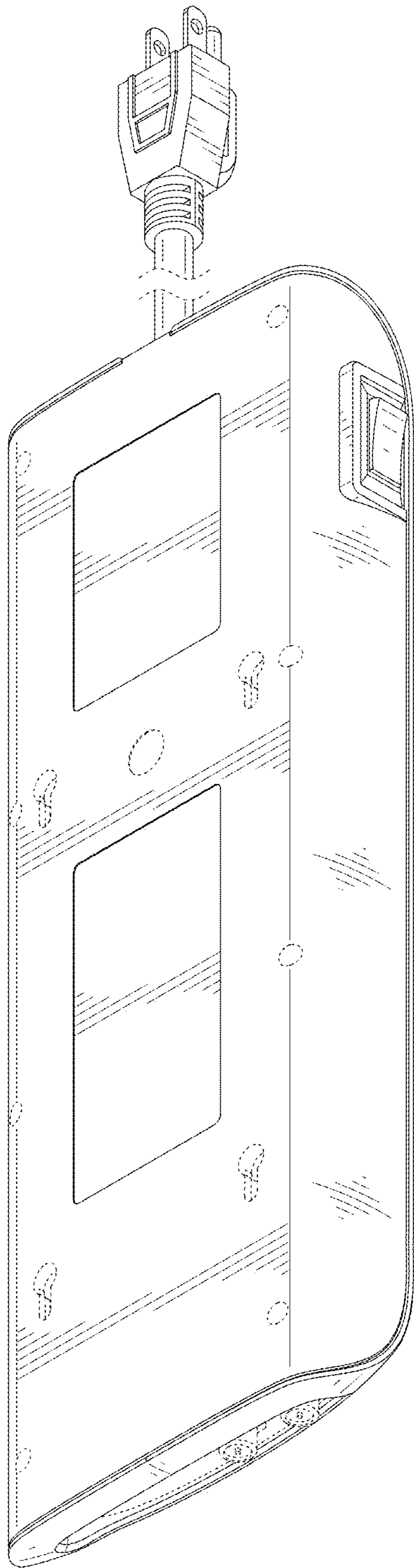

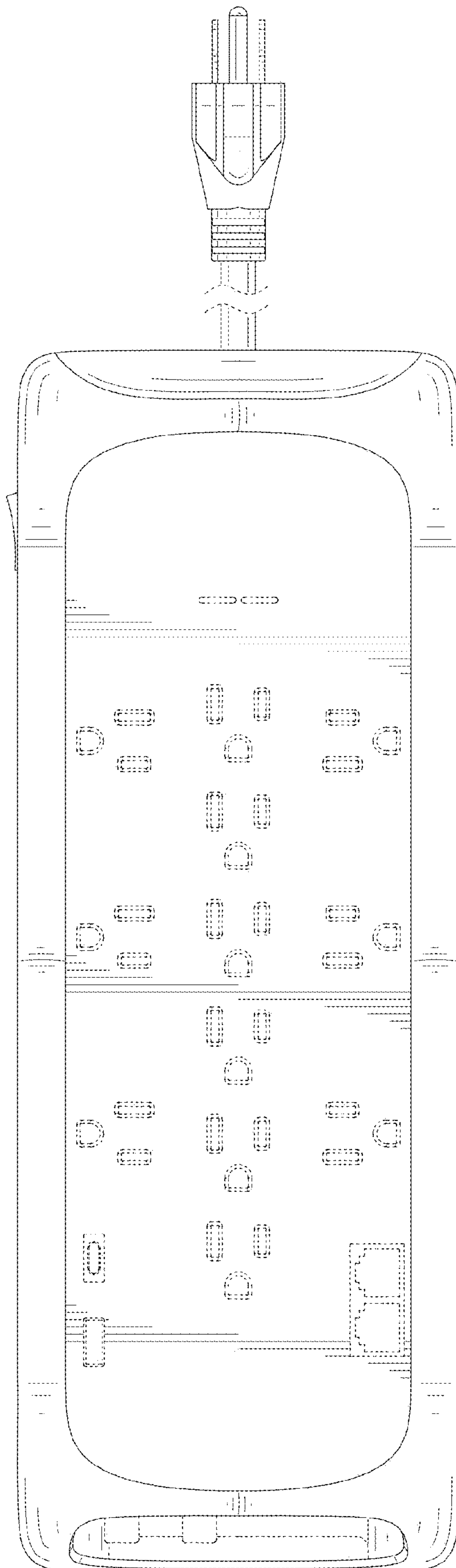

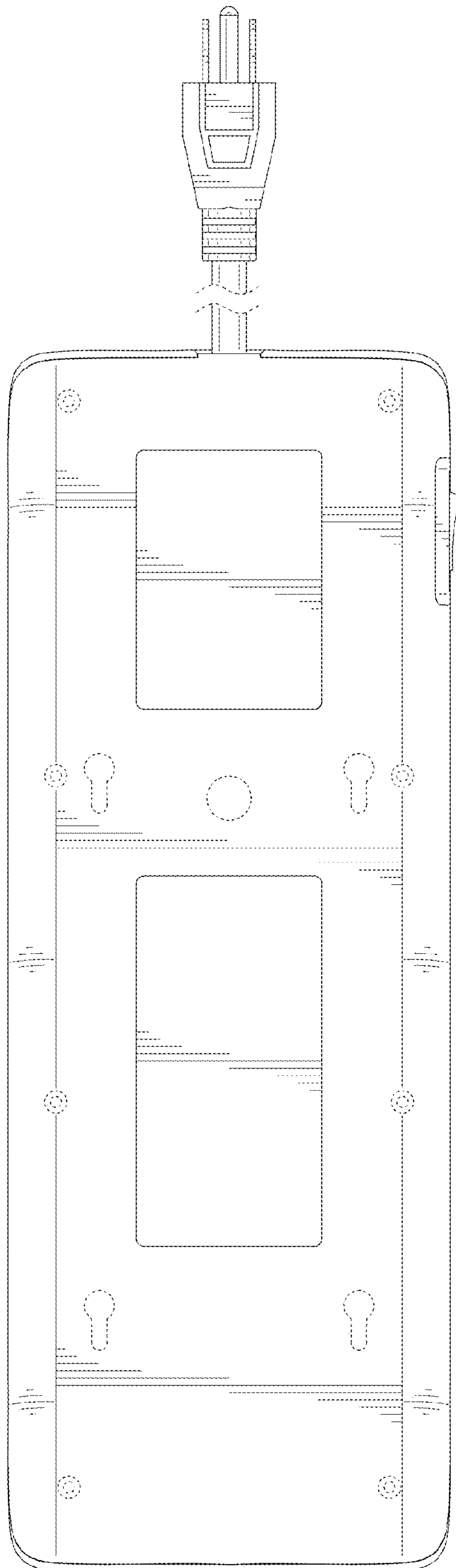

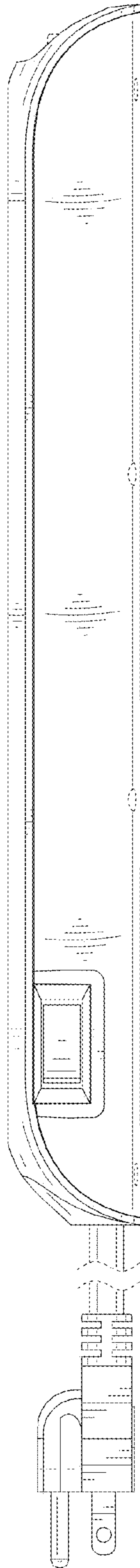

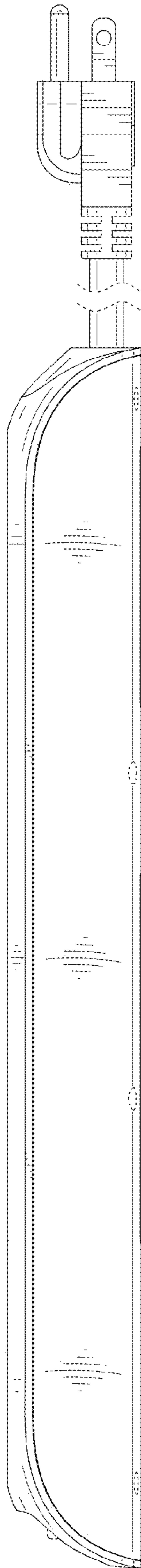

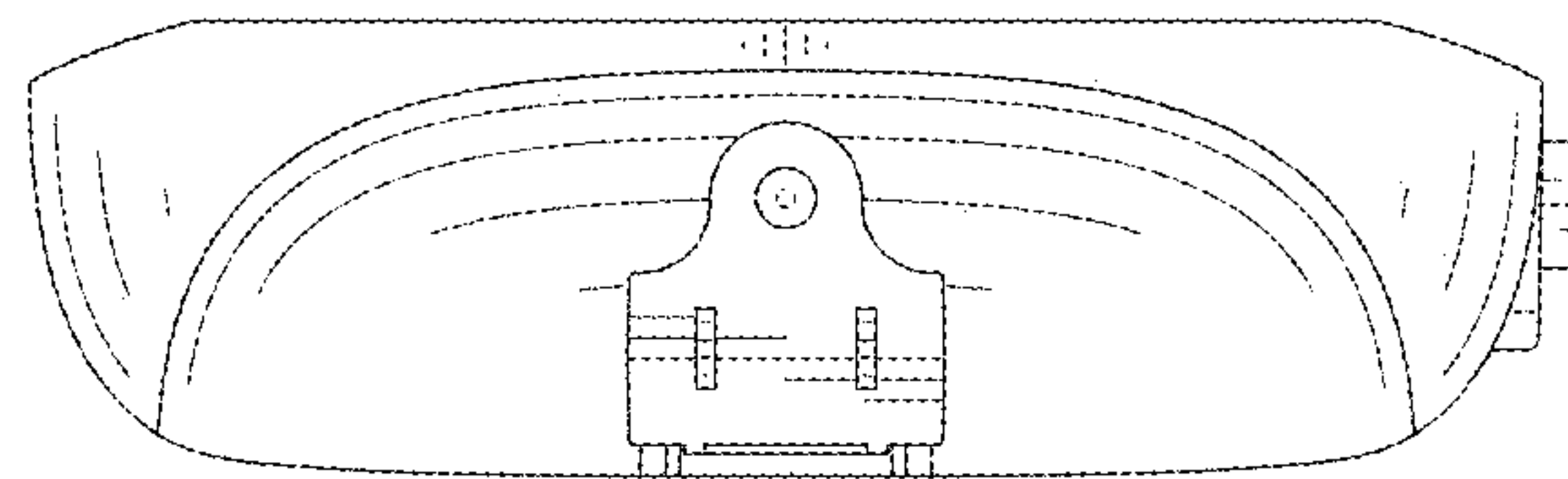

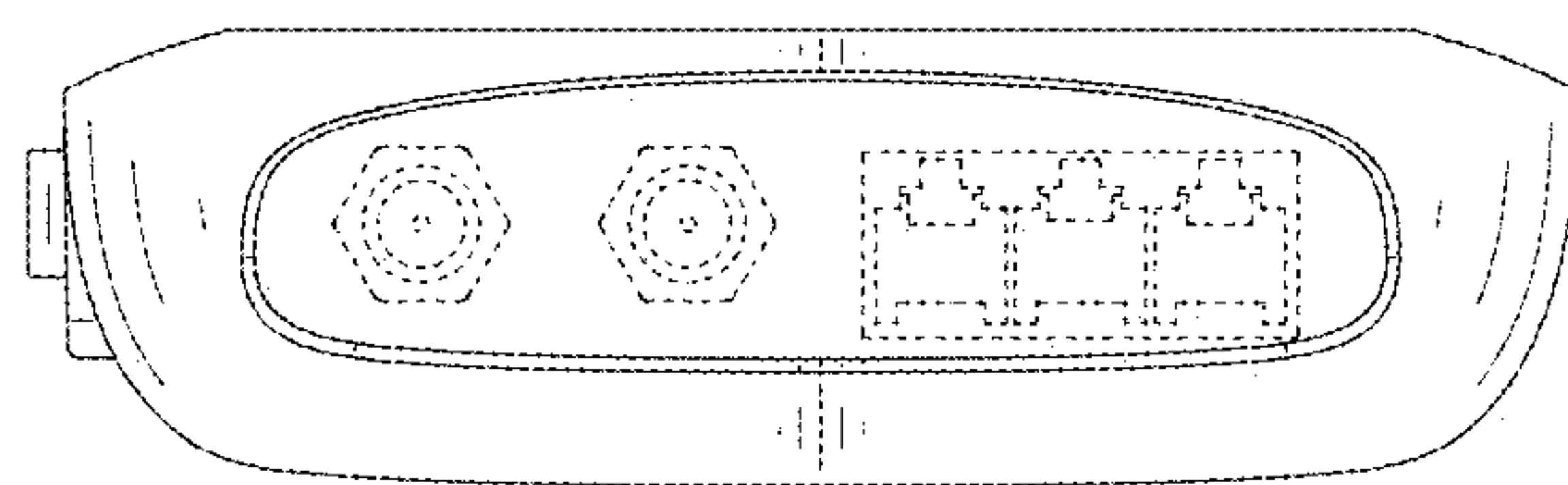
