(57) **CLAIM**

The ornamental design for a thermally protected metal oxide varistor, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a thermally protected metal oxide varistor showing the new design; FIG. 2 is a rear and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a rear elevational view thereof.

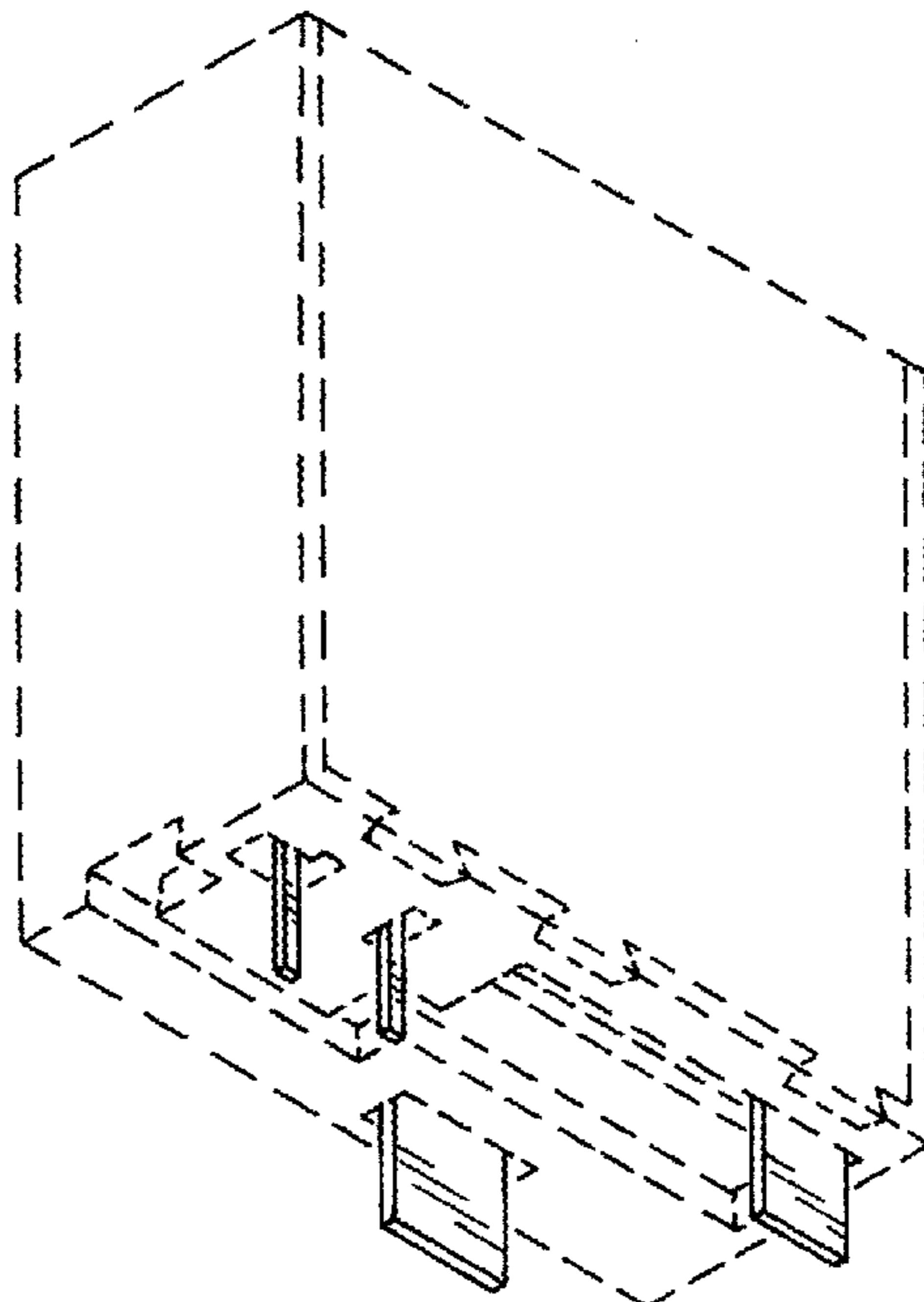
The broken lines in the drawings illustrate portions of the thermally protected metal oxide varistor that form no part of the claimed design.

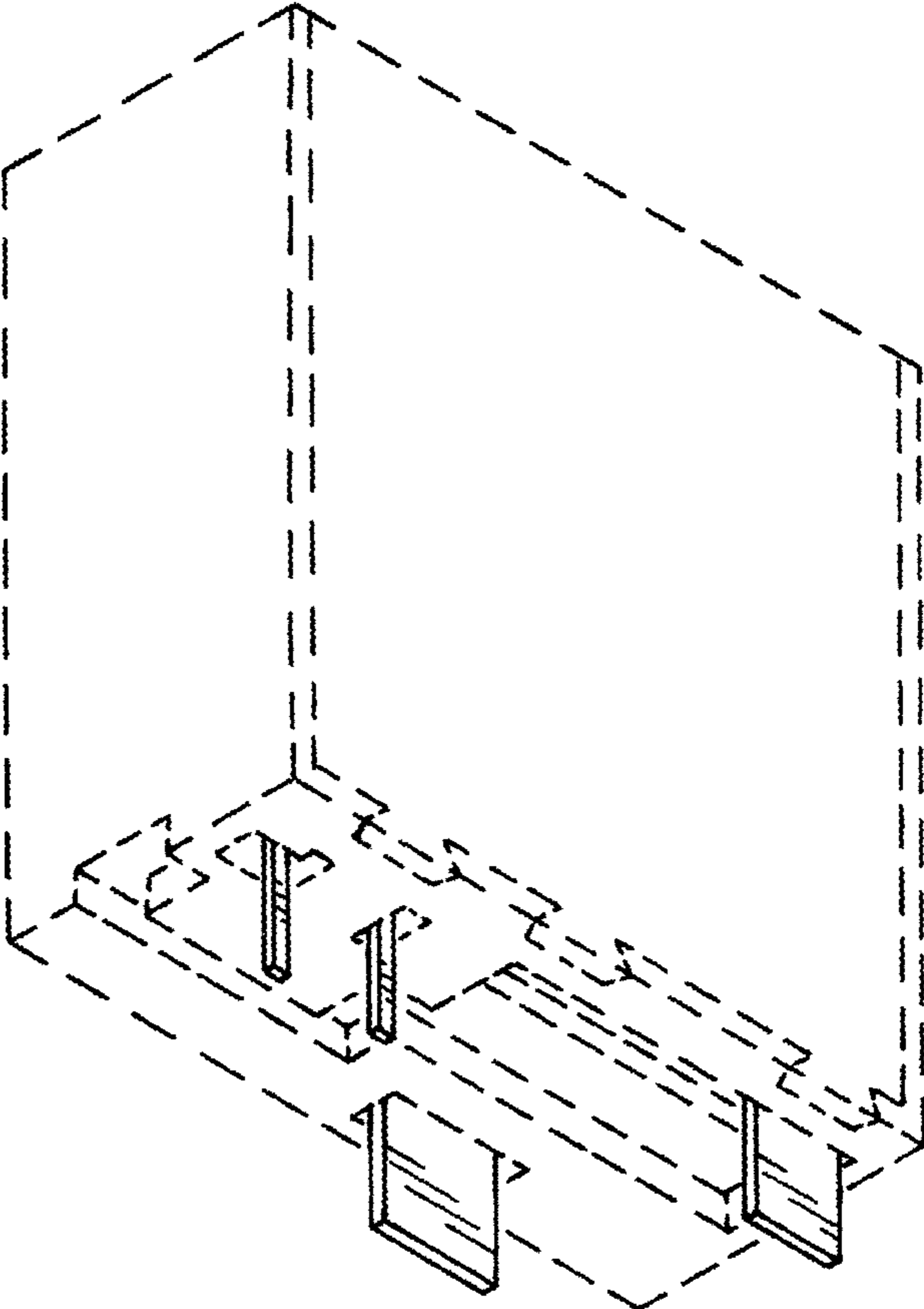

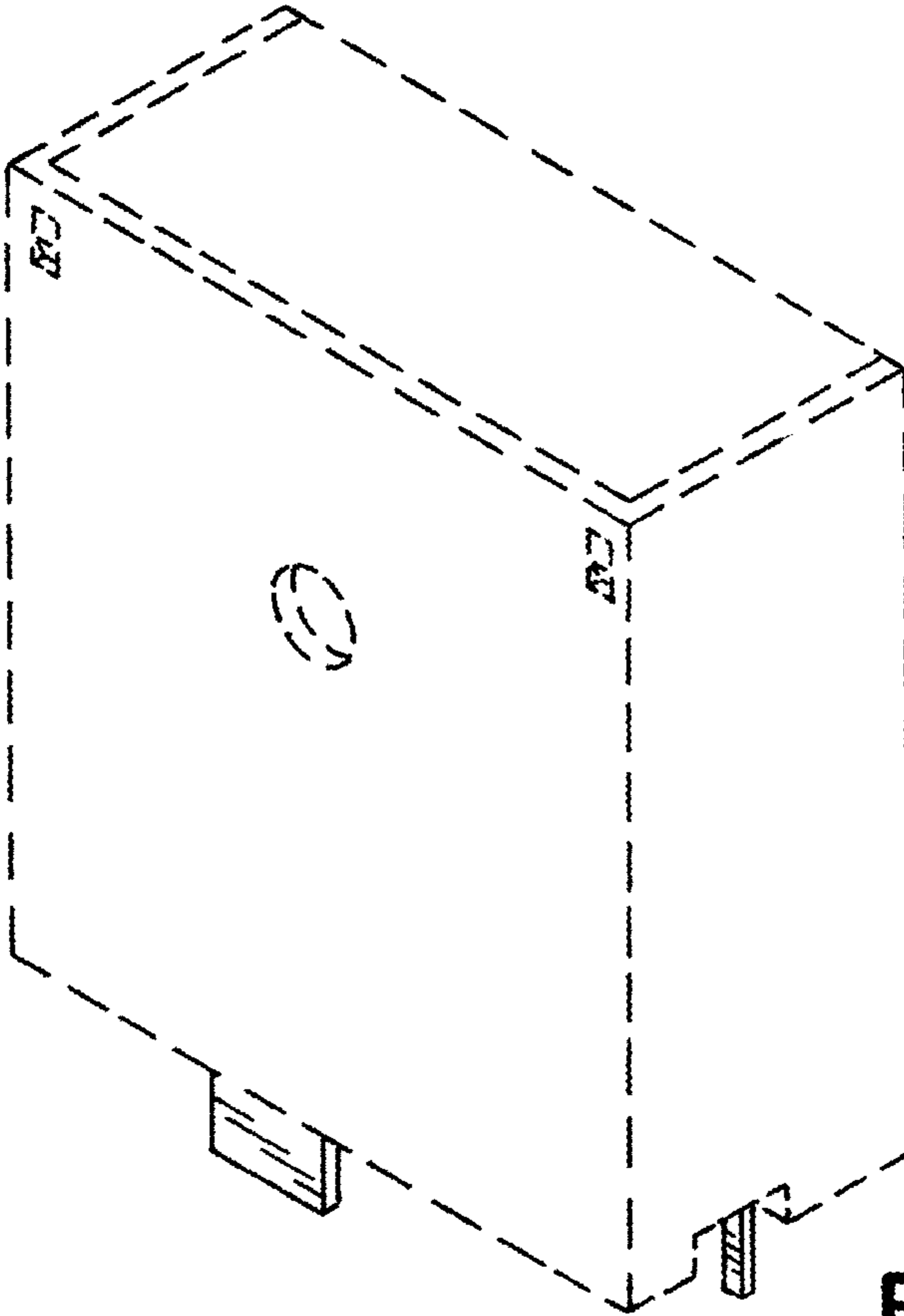

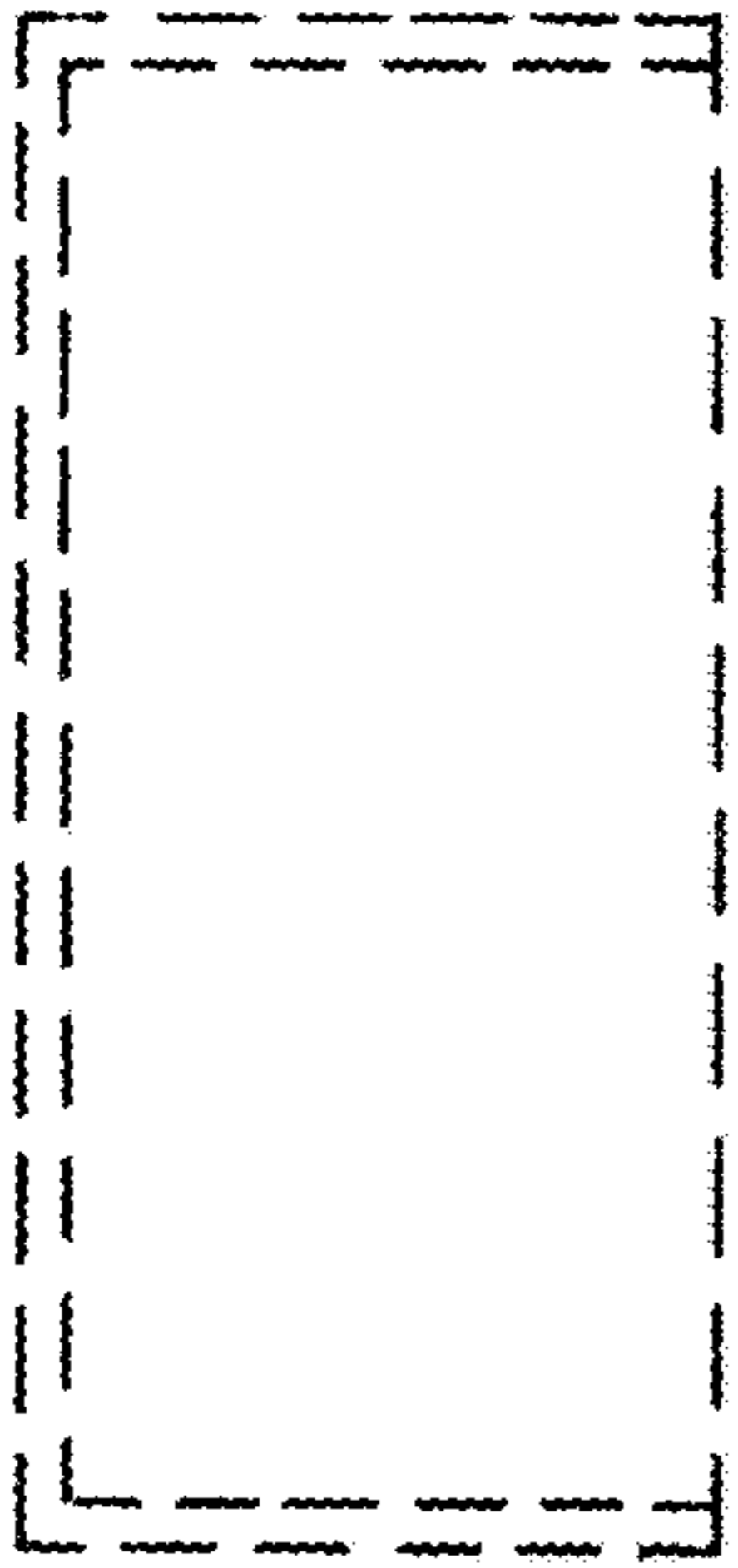

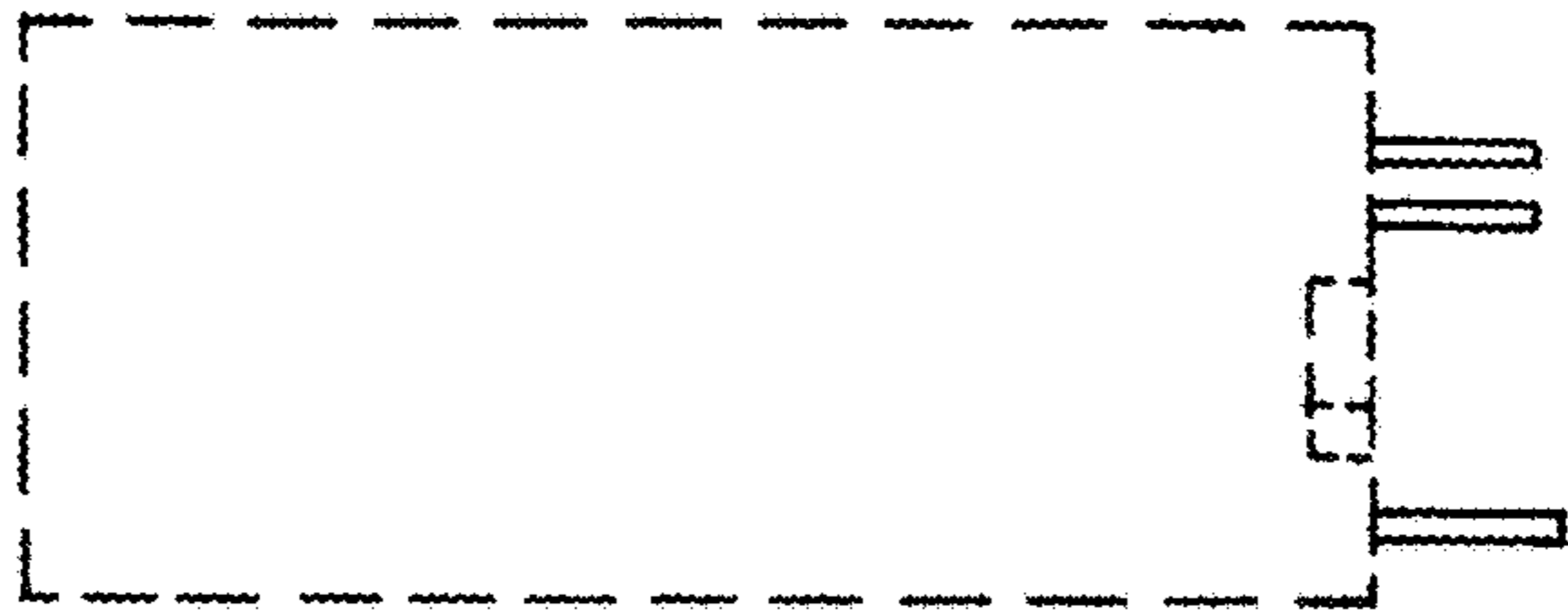

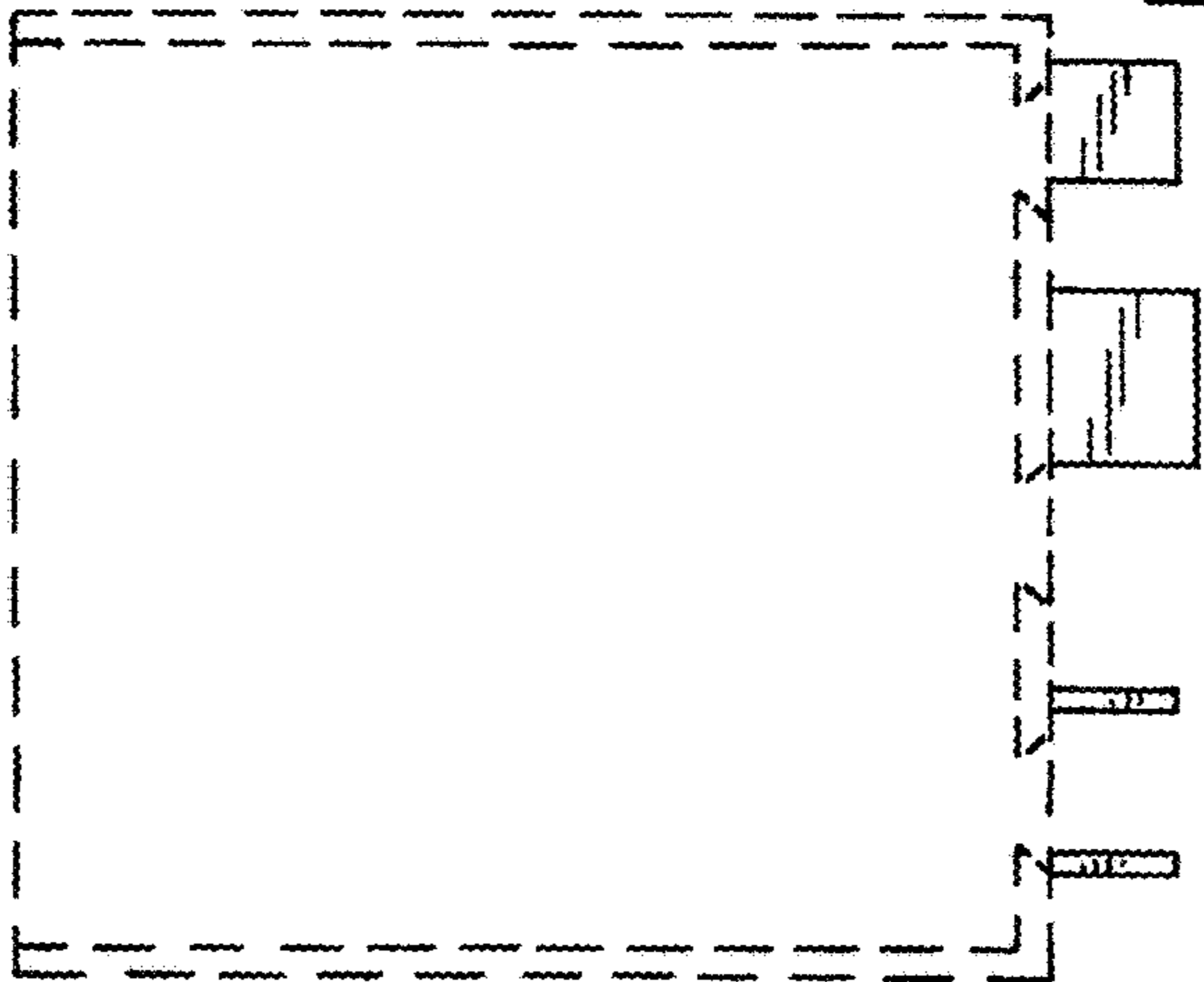

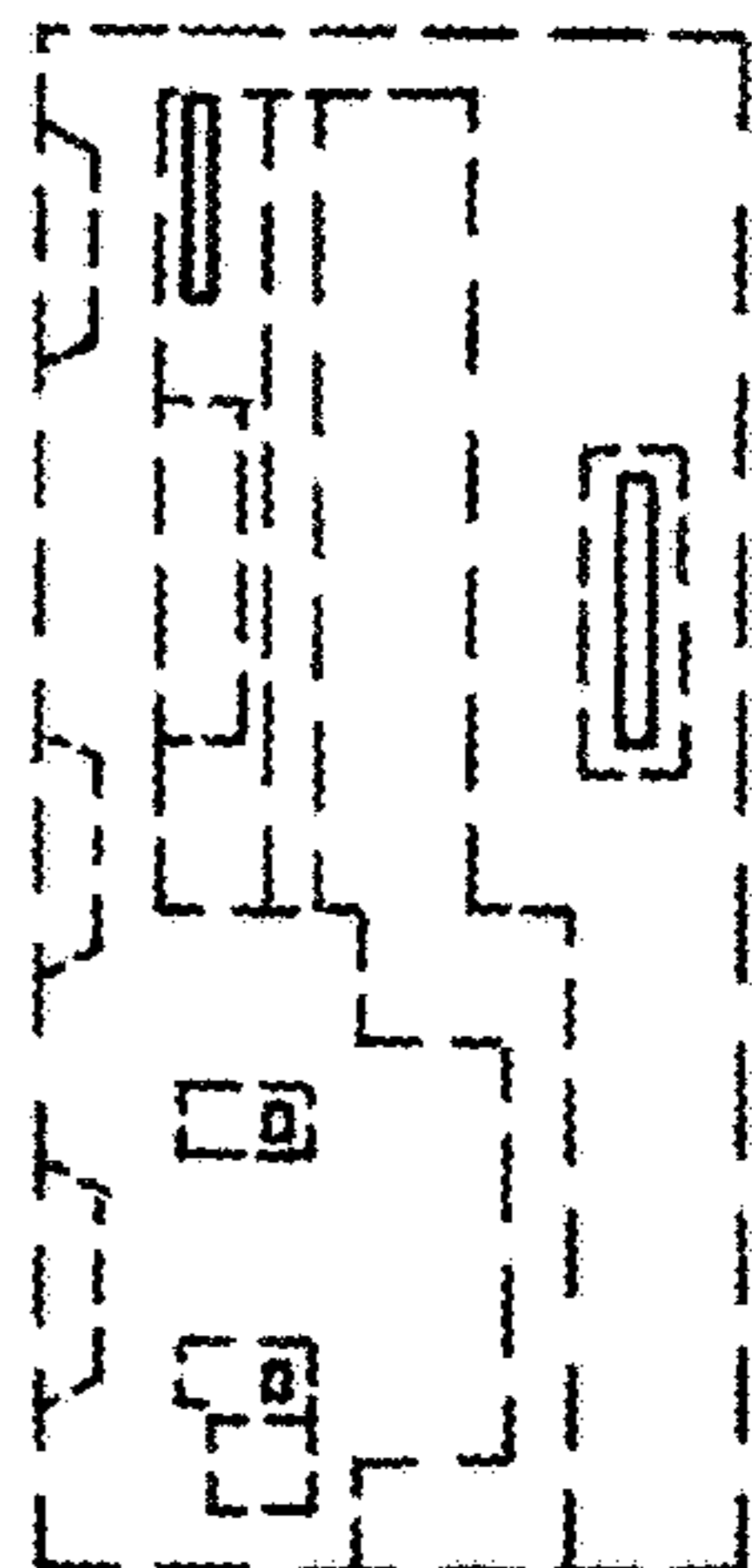

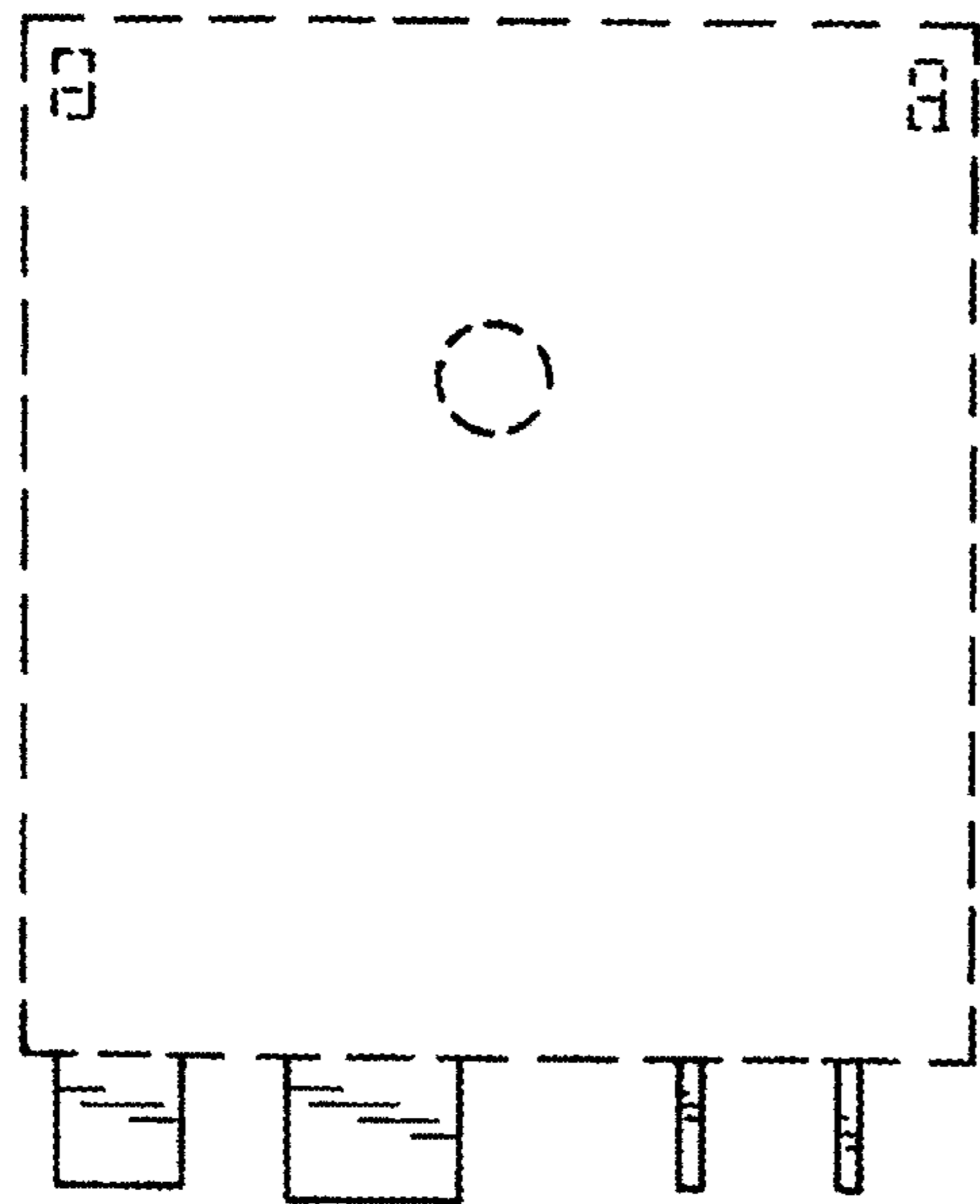
