(57) **CLAIM**

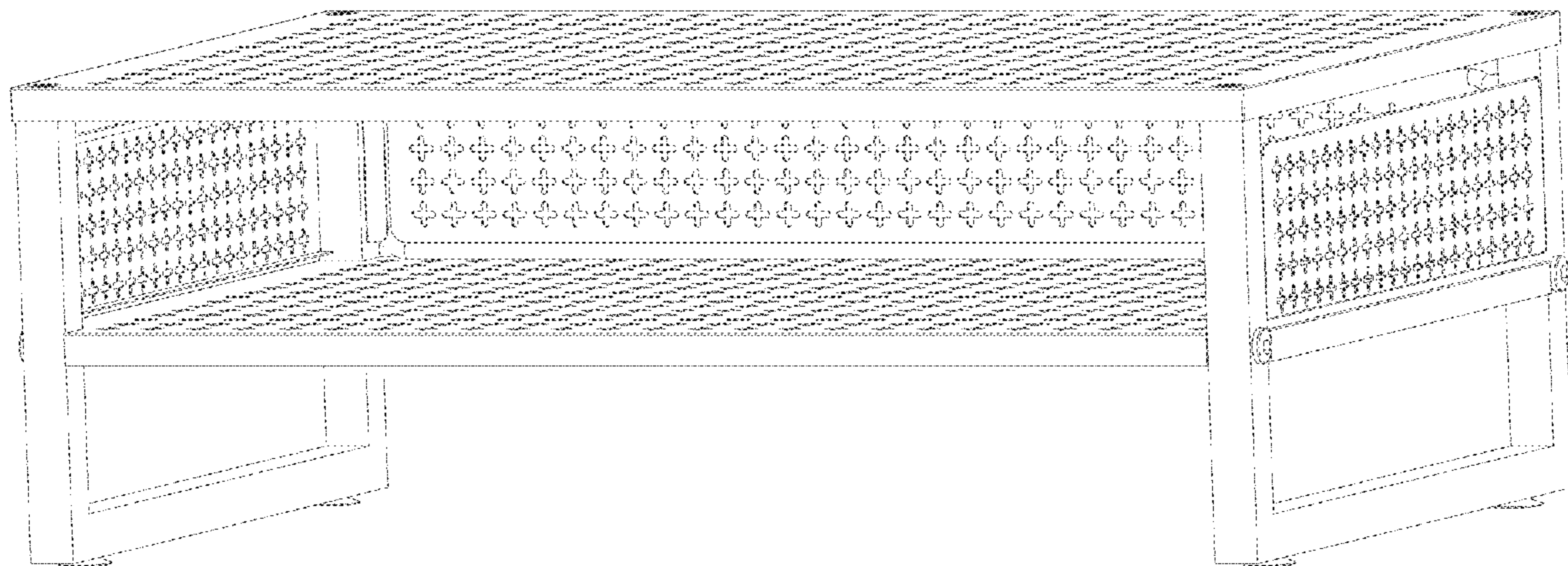
The ornamental design for a two-tier monitor stand riser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two-tier monitor stand riser showing my new design;

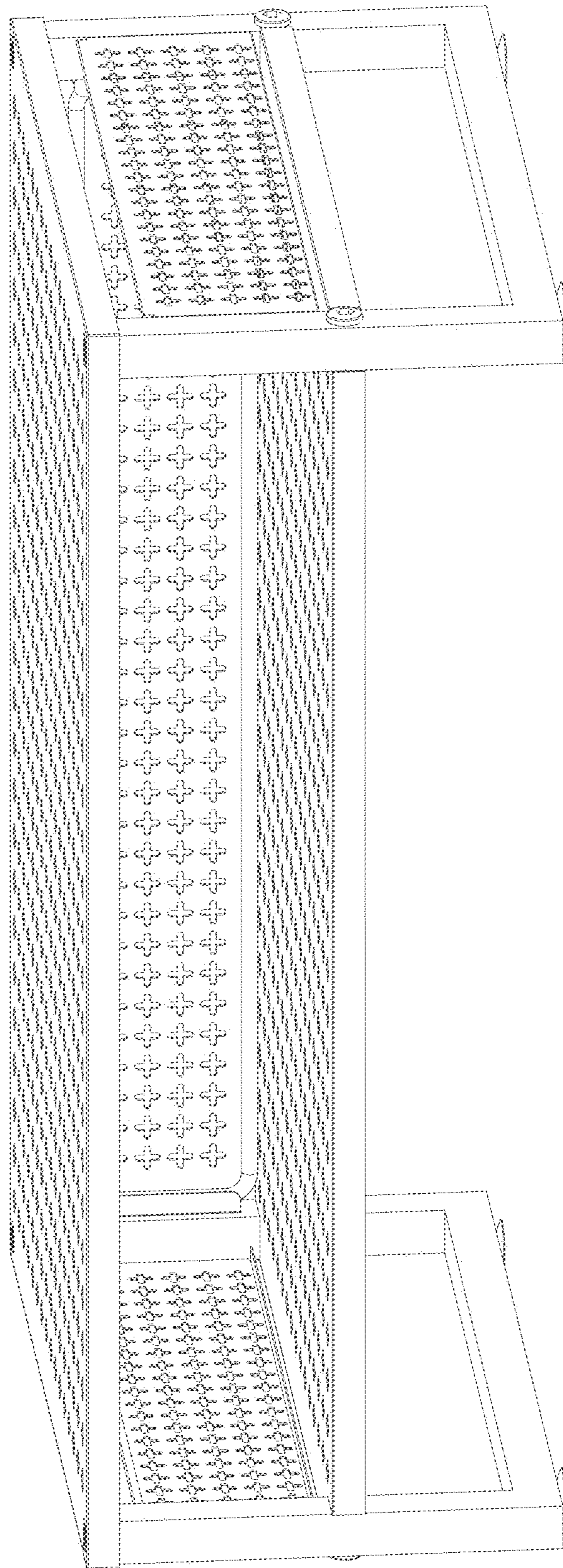

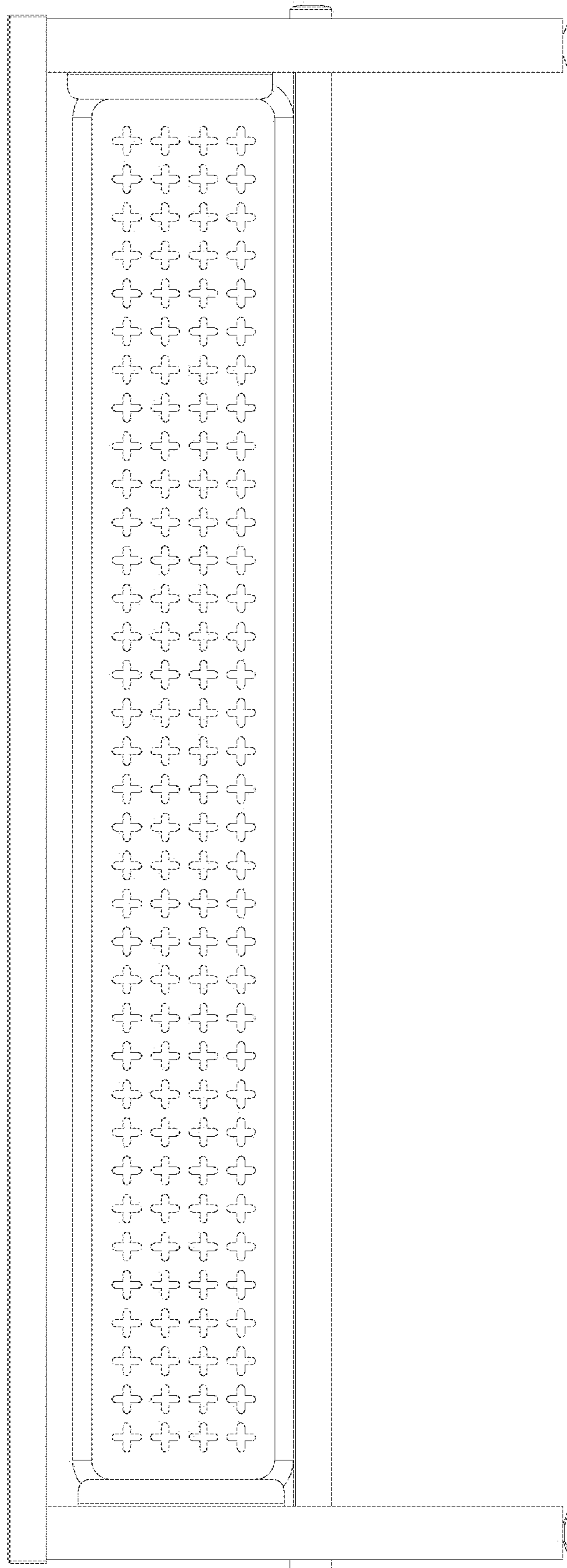

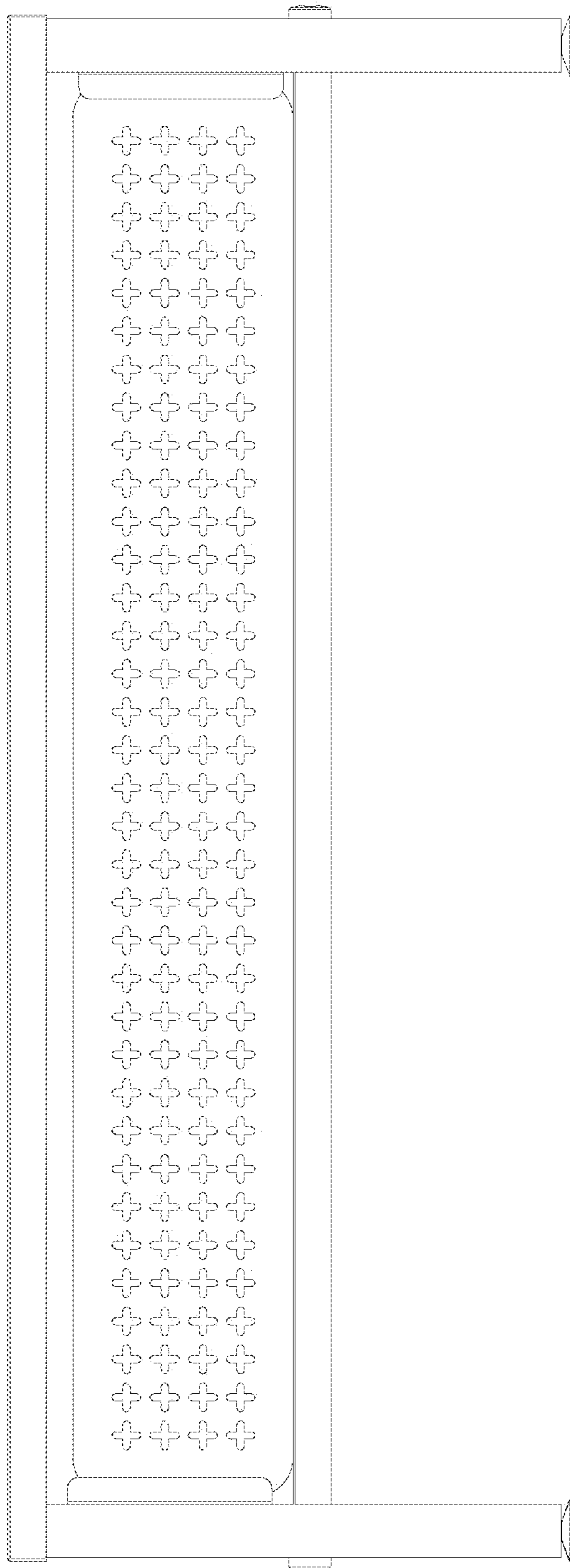

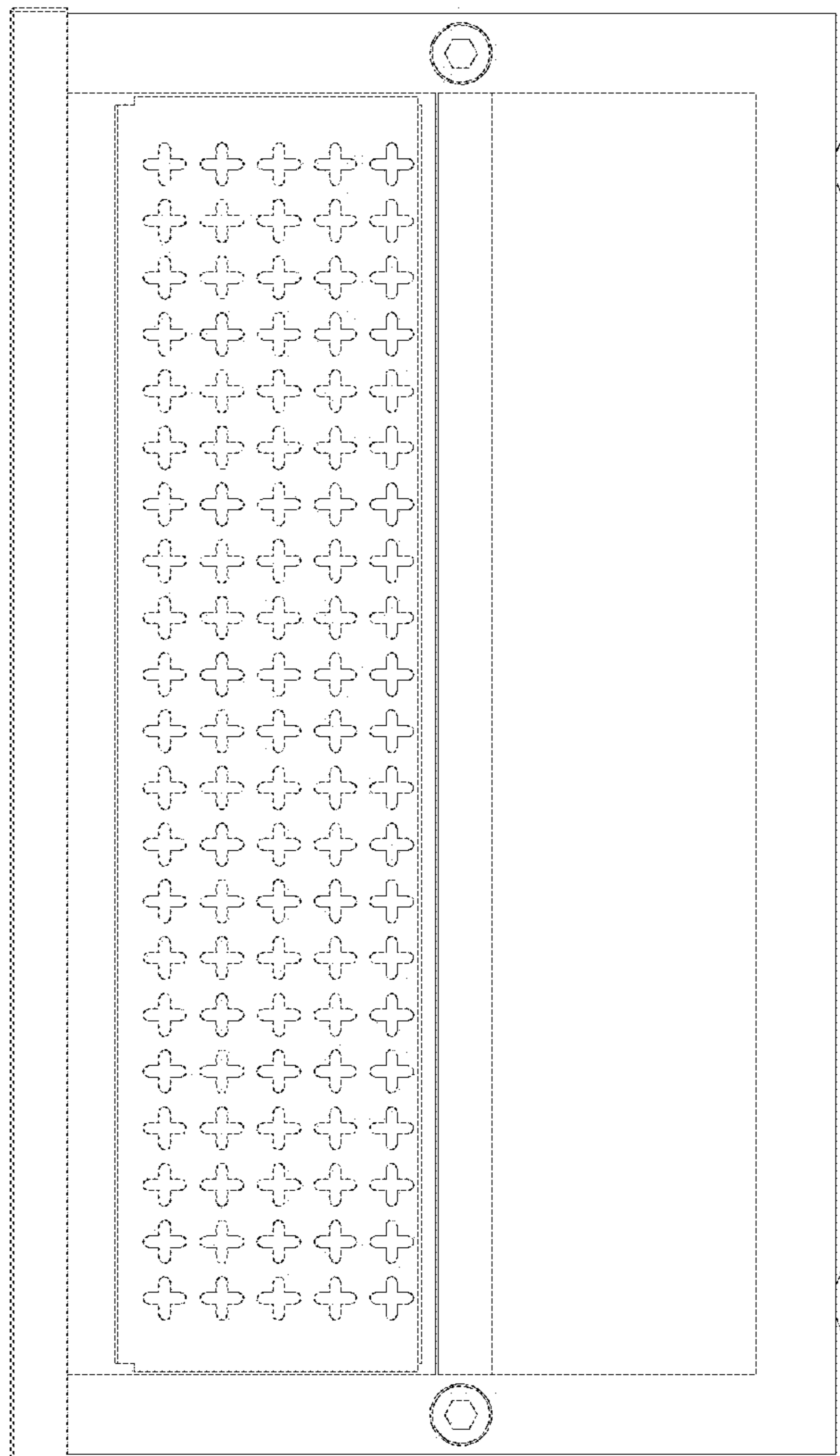

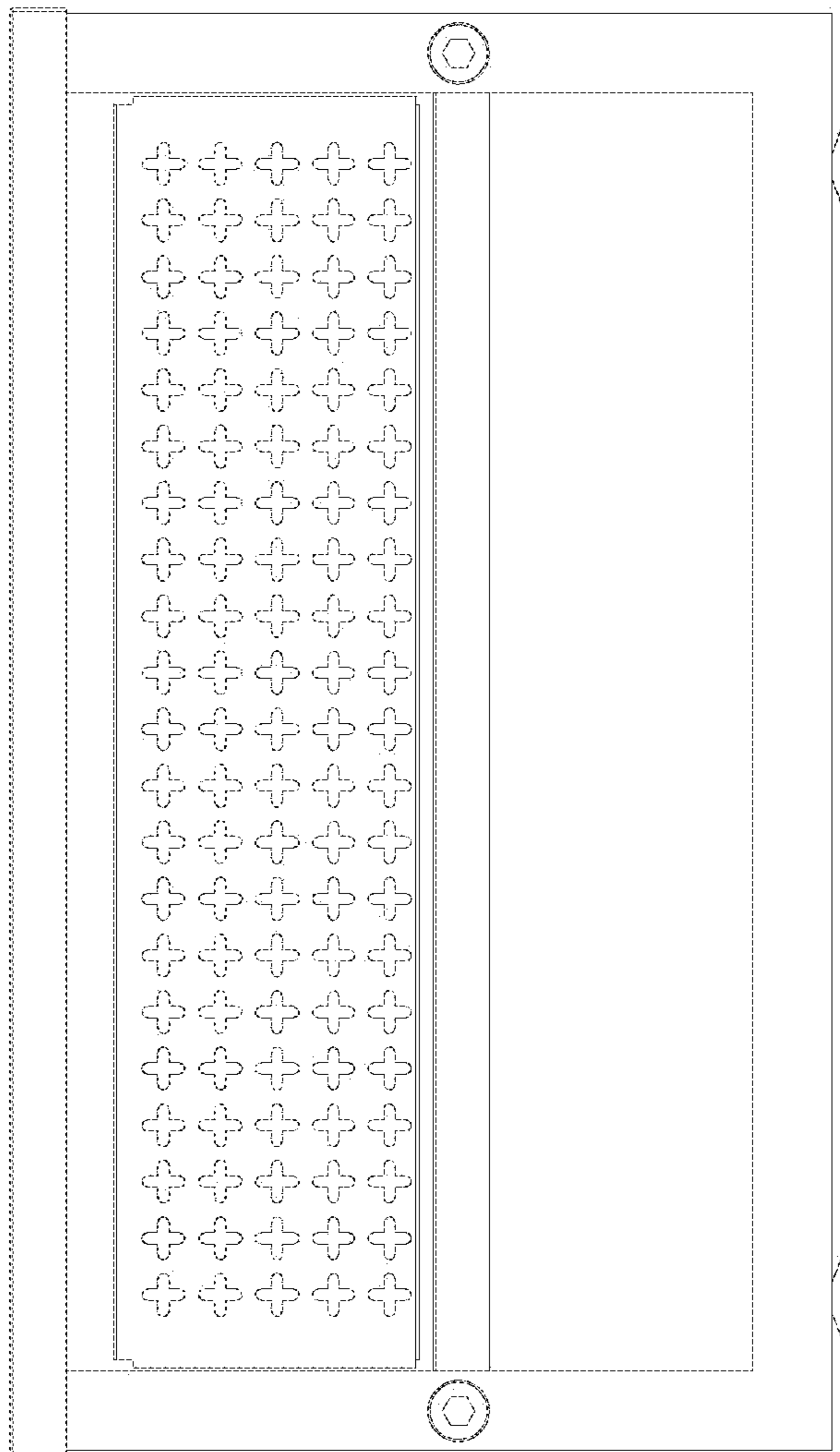

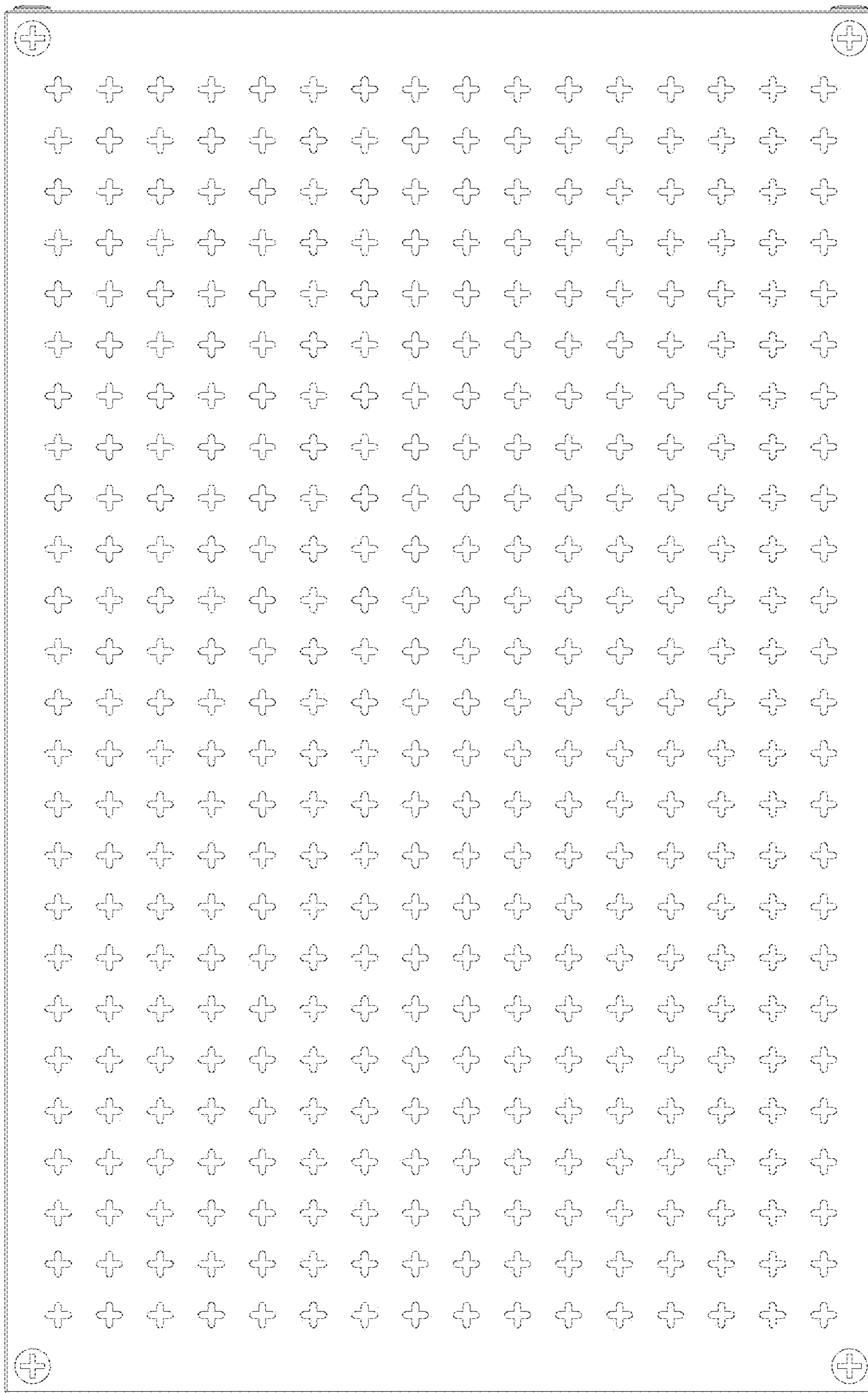

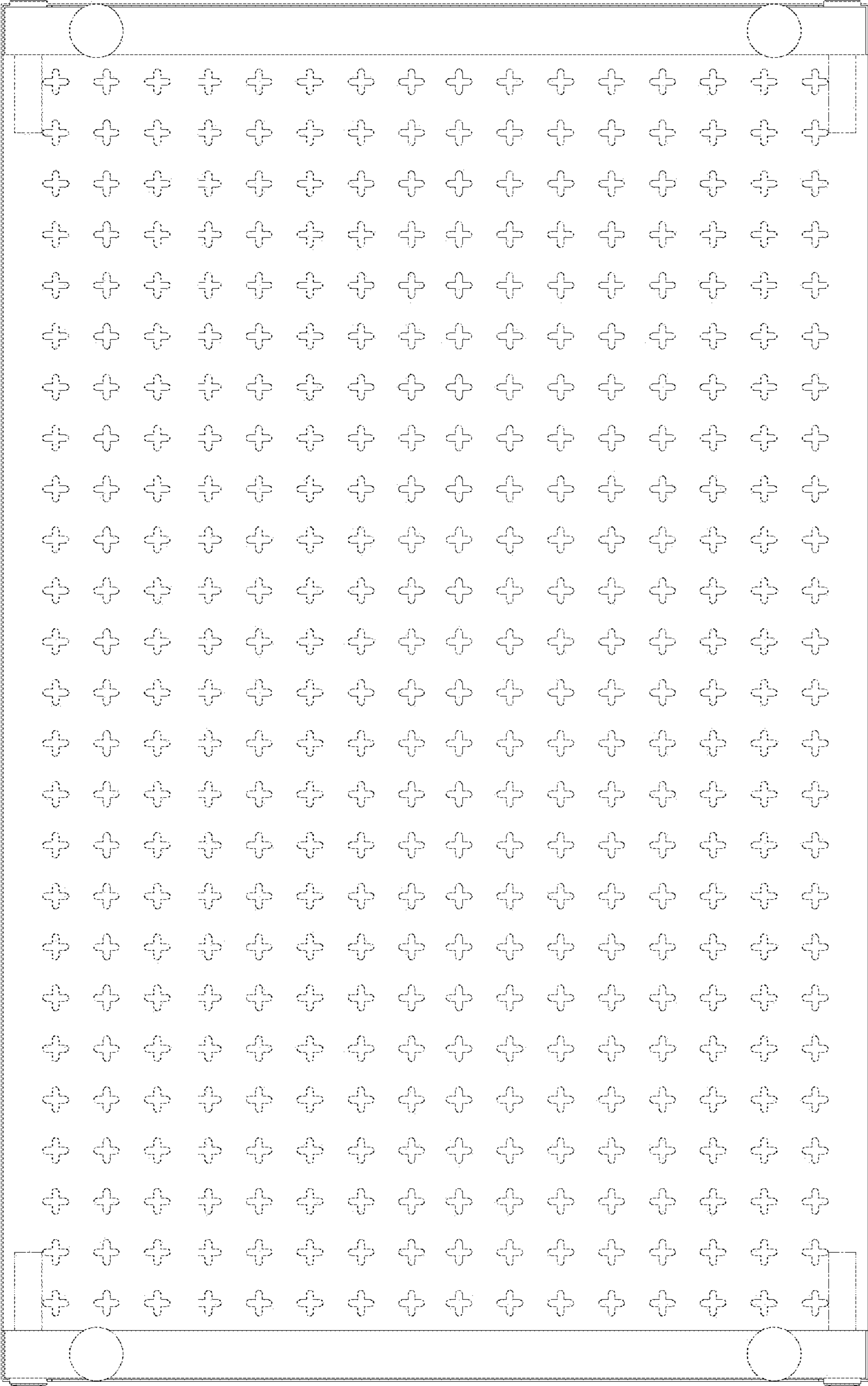
